DESCRIPTION

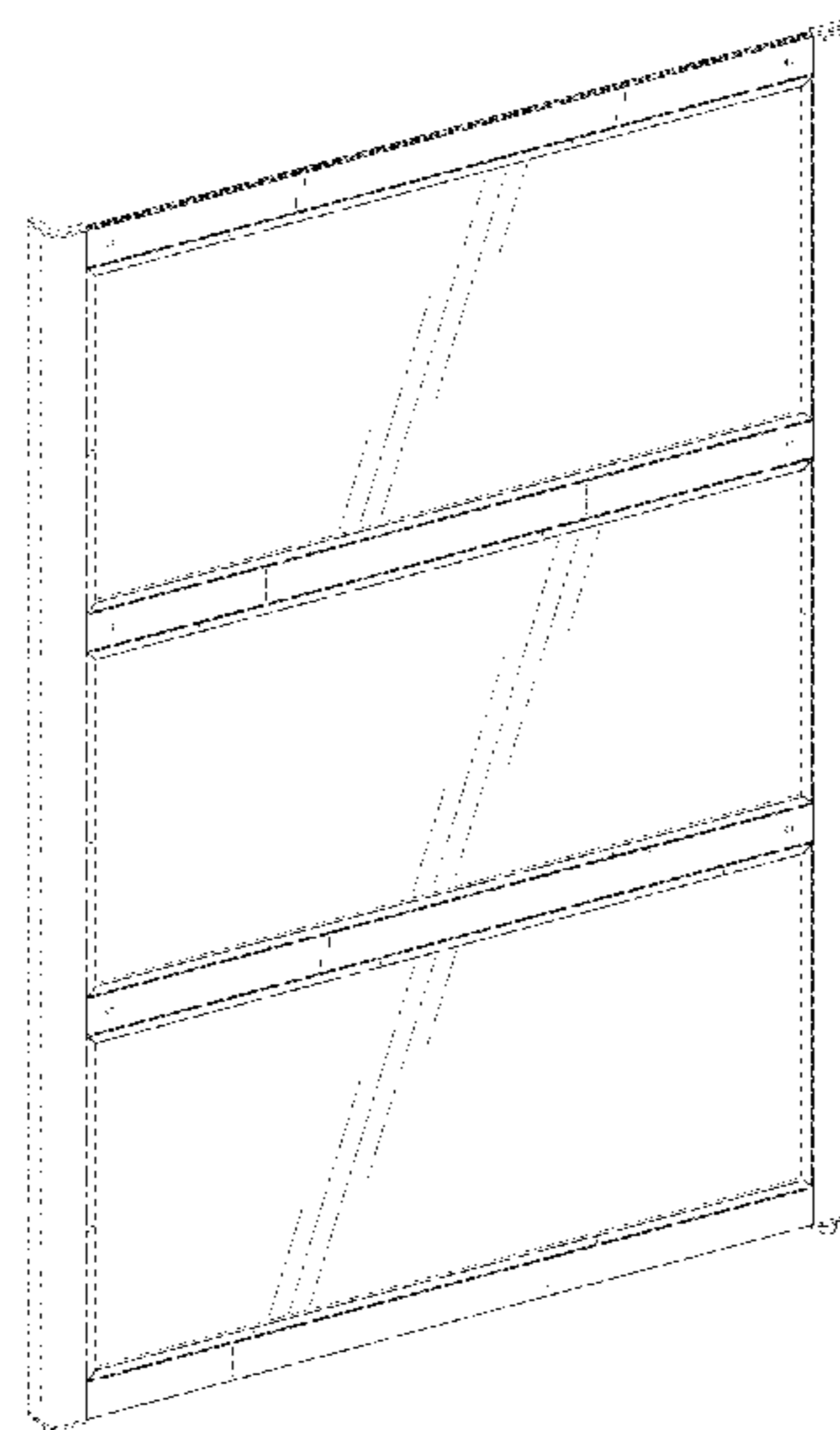
FIG. 1 is a perspective view of a modular wall assembly.

FIG. 5 is a right elevation view of the modular wall assembly of FIG. 1.

FIG. 7 is a bottom plan view of the modular wall assembly of FIG. 1.

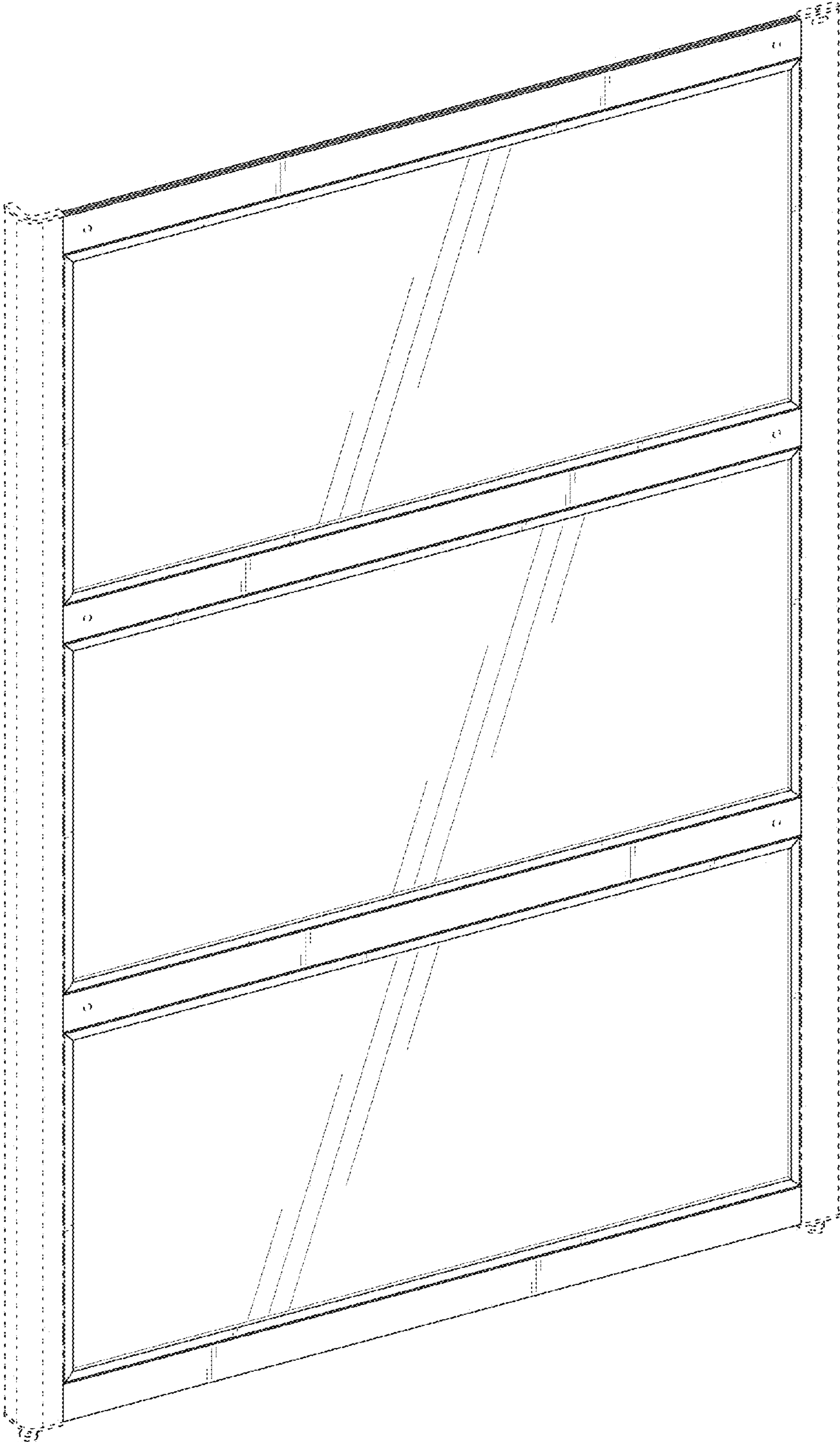

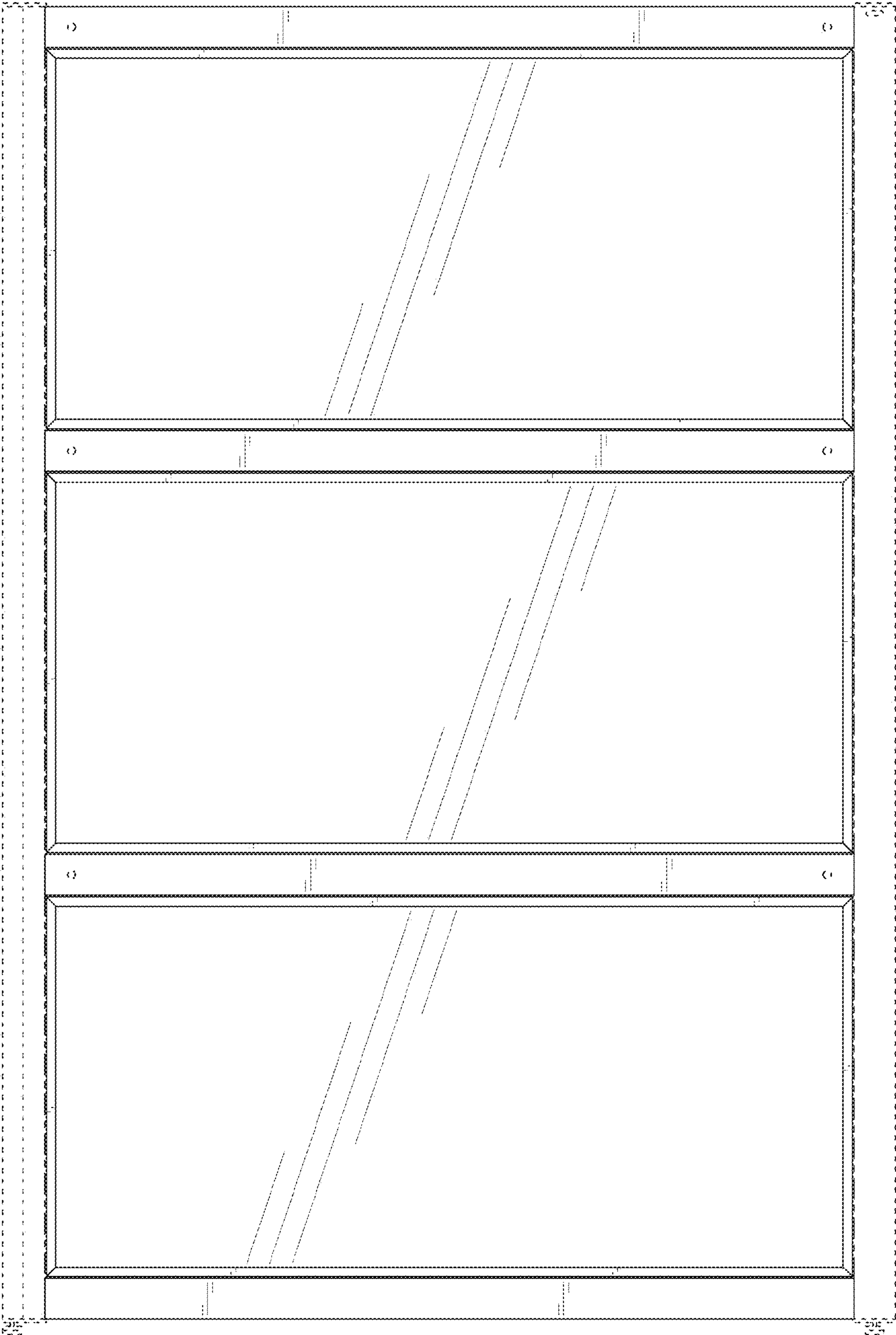

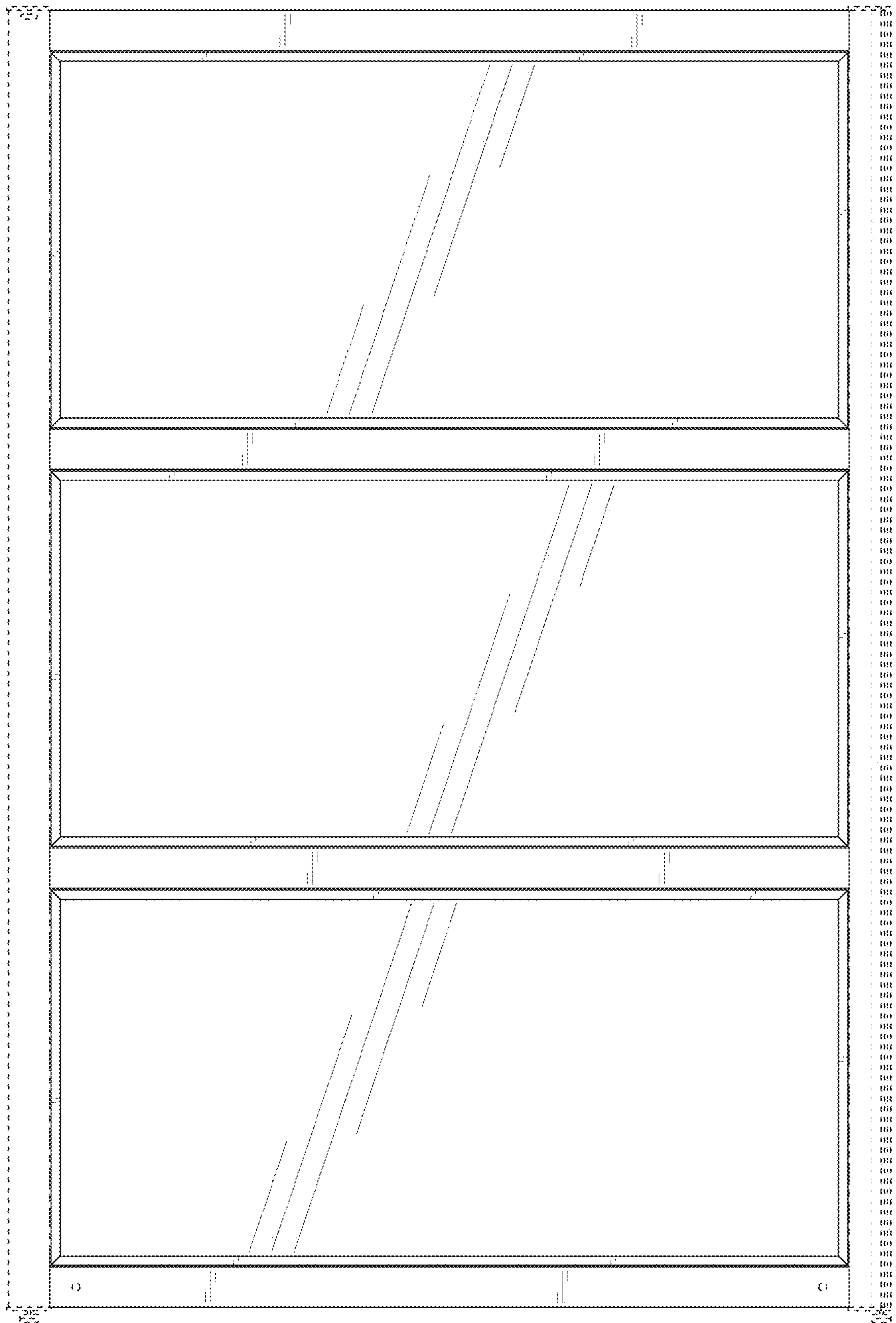

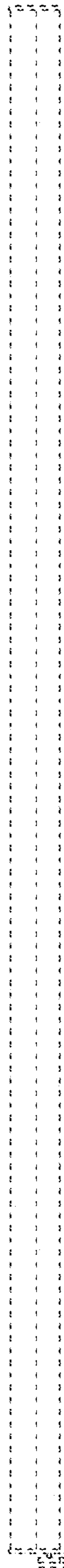

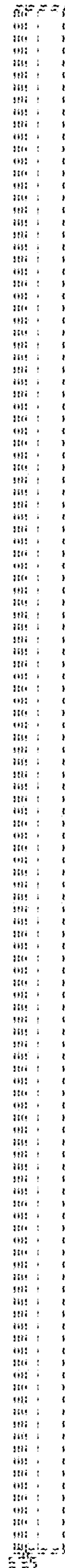

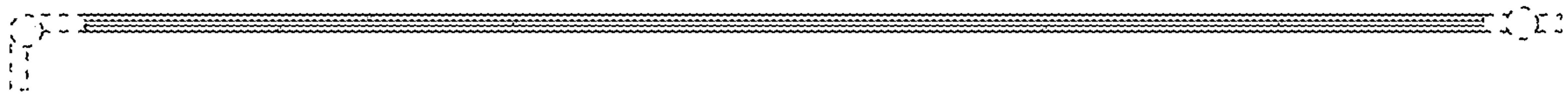
