(57) **CLAIM**

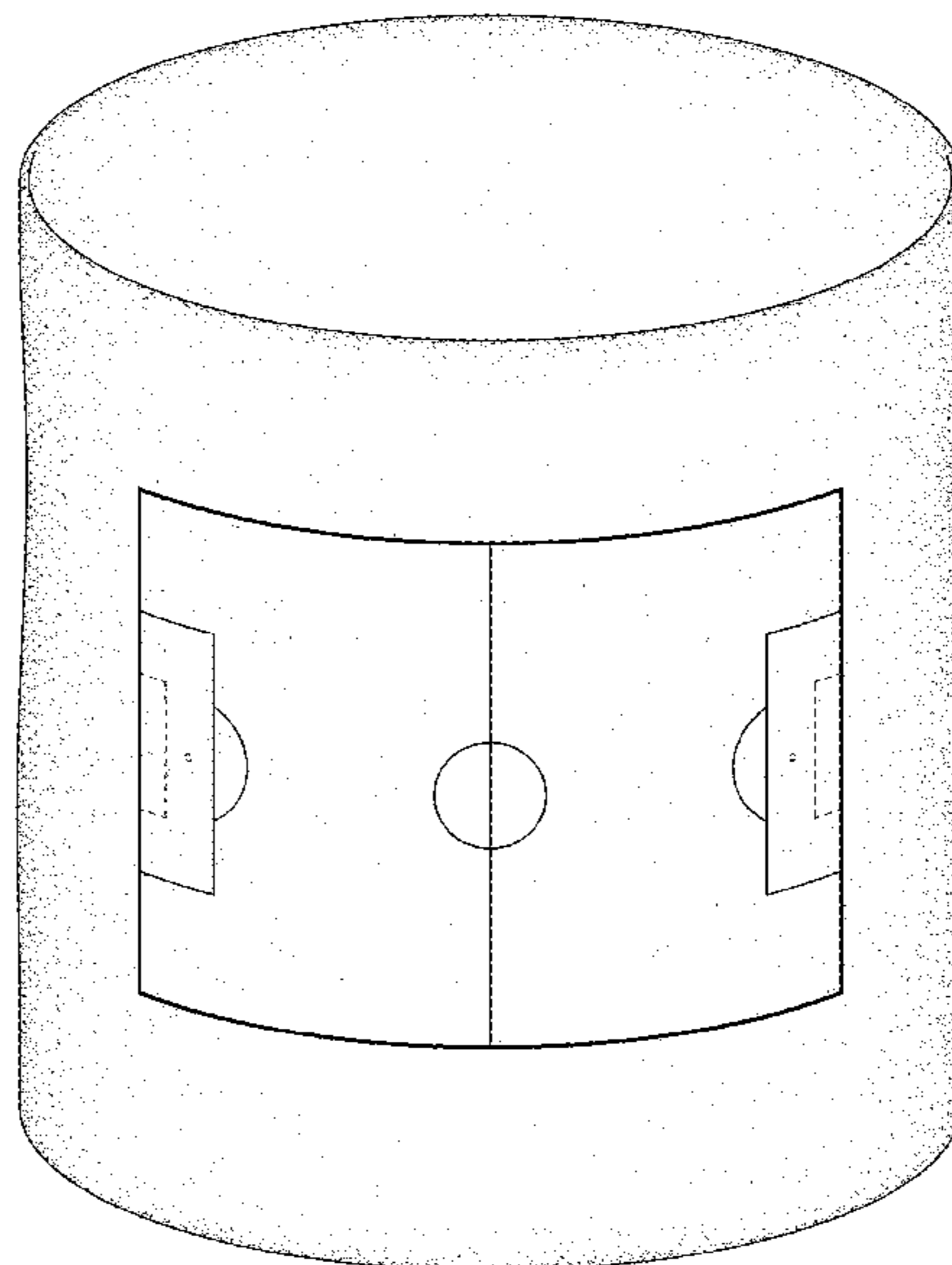
The ornamental design for a wrist band, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wrist band showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a back view thereof;
FIG. 4 is a first side view thereof;
FIG. 5 is an opposite second side view thereof;
FIG. 6 is a top plan view, with the bottom plan view being a mirror image thereof; and,
FIG. 7 is a perspective view thereof, shown in a configuration of use.

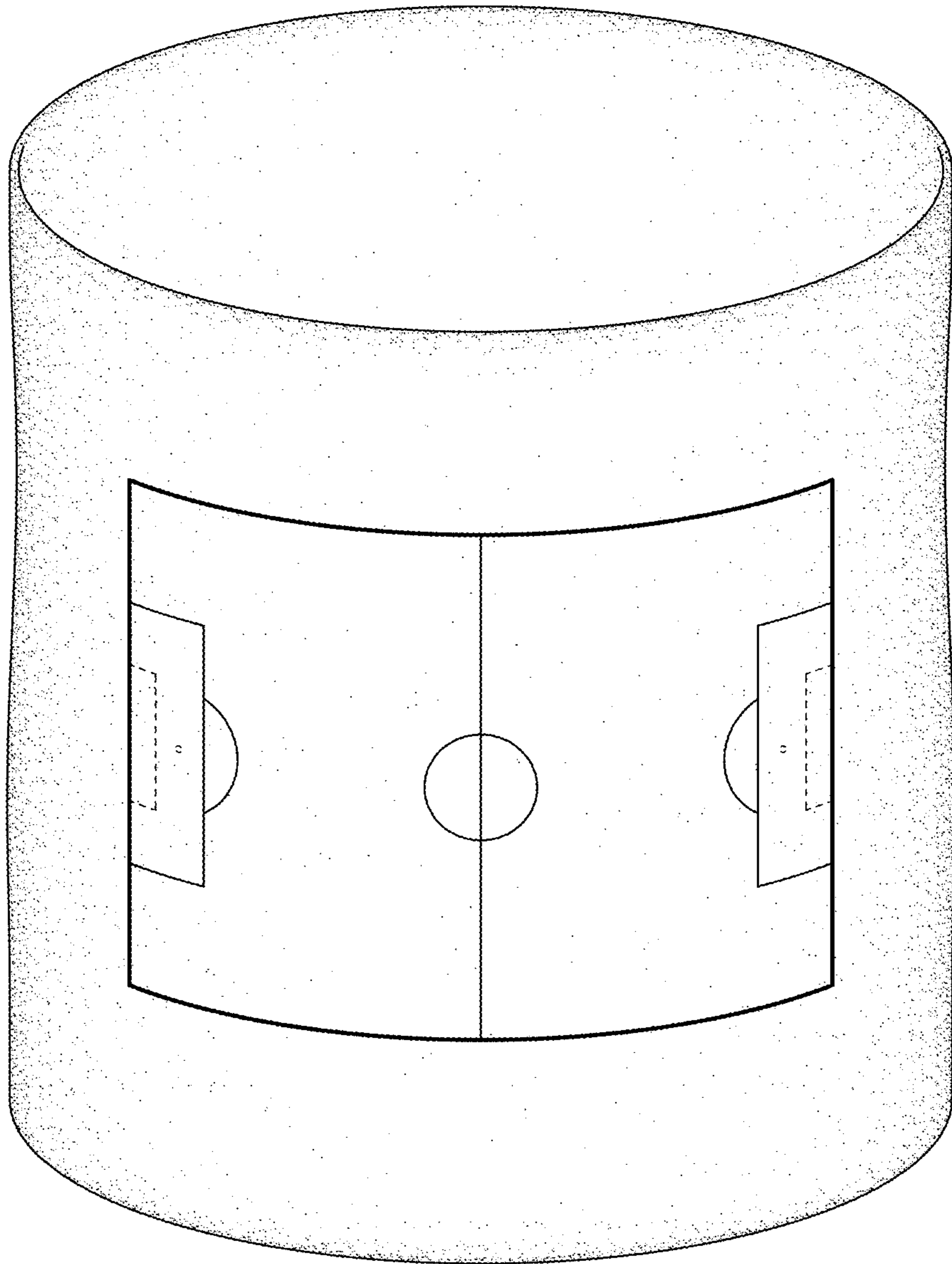

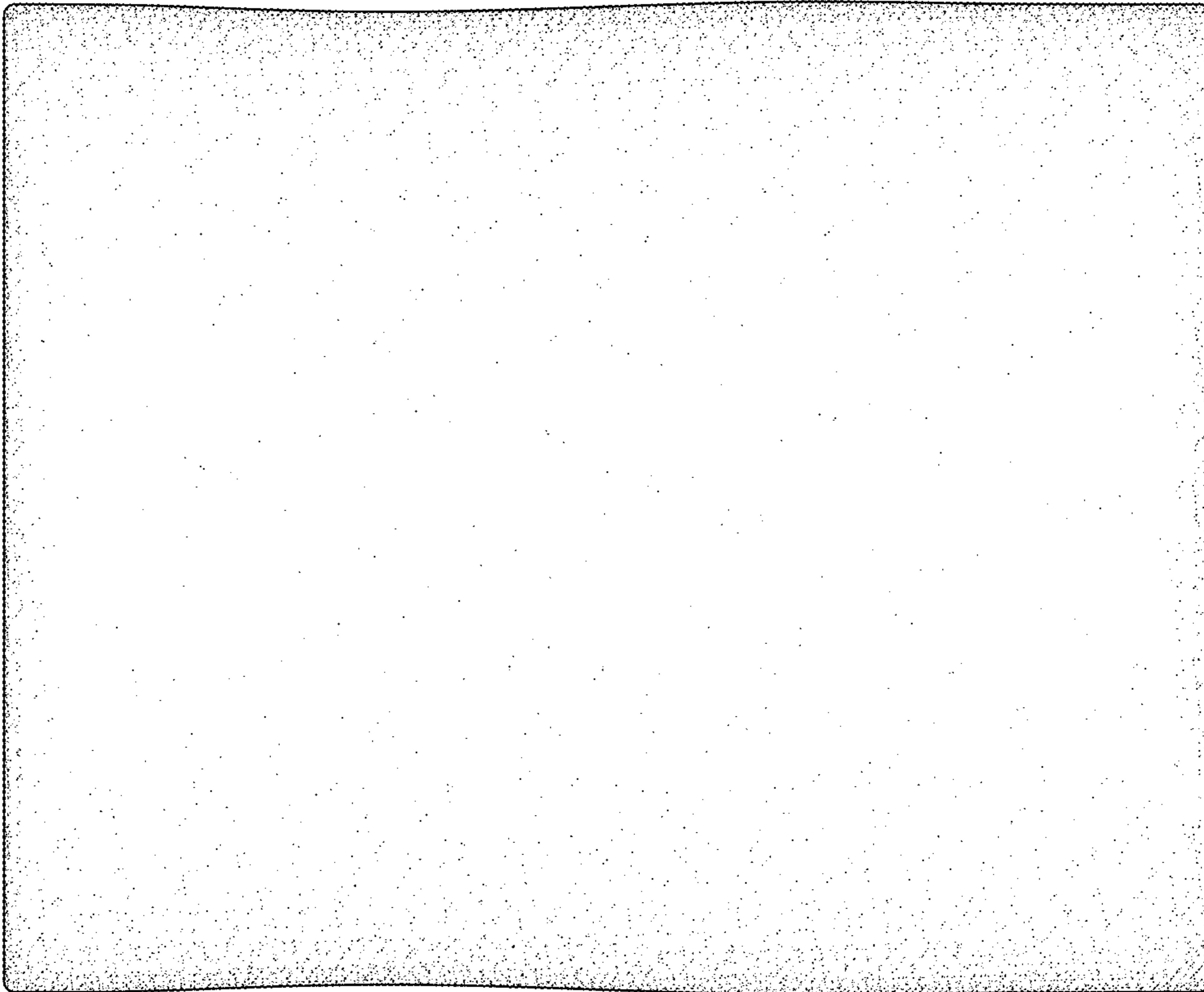

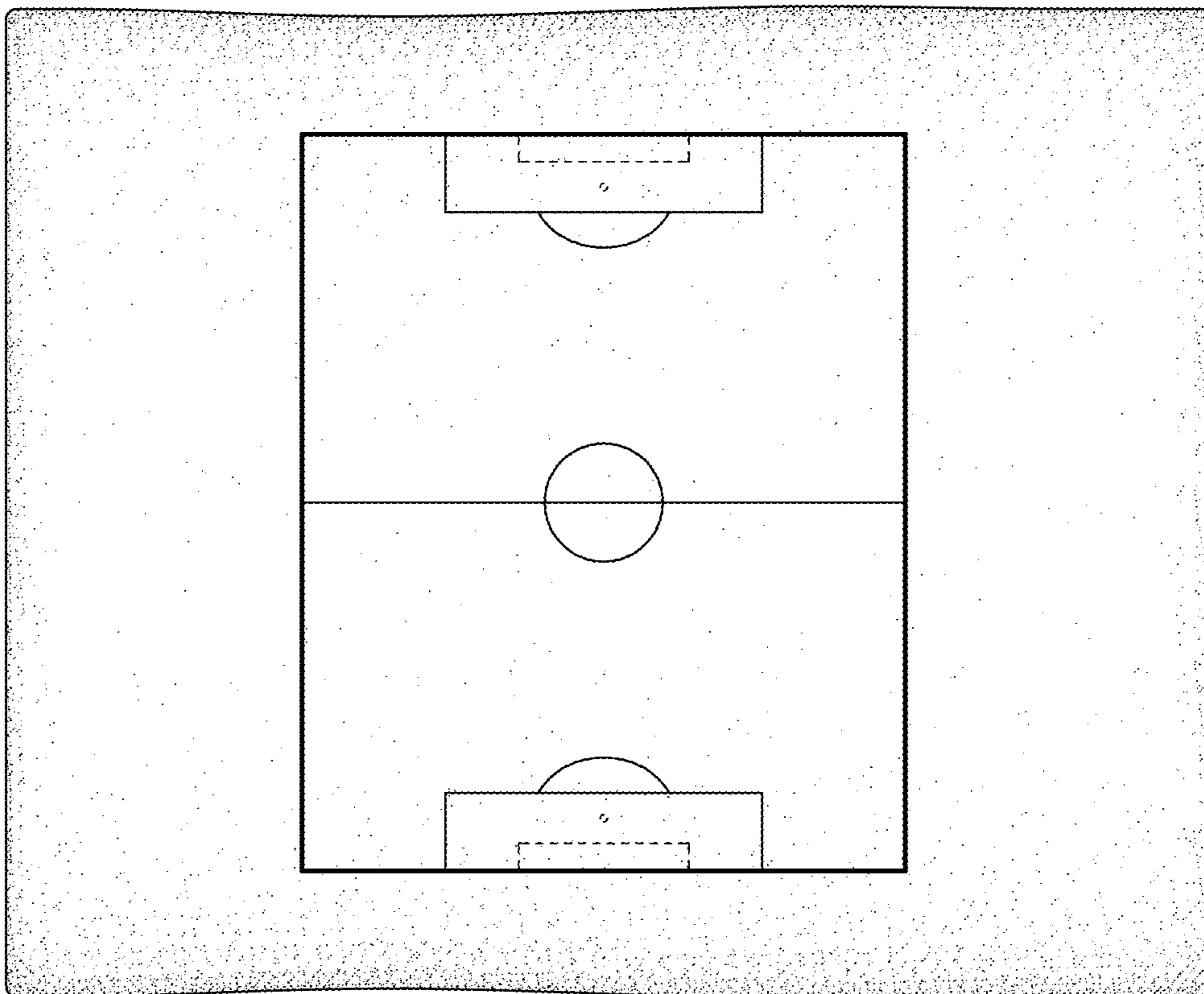

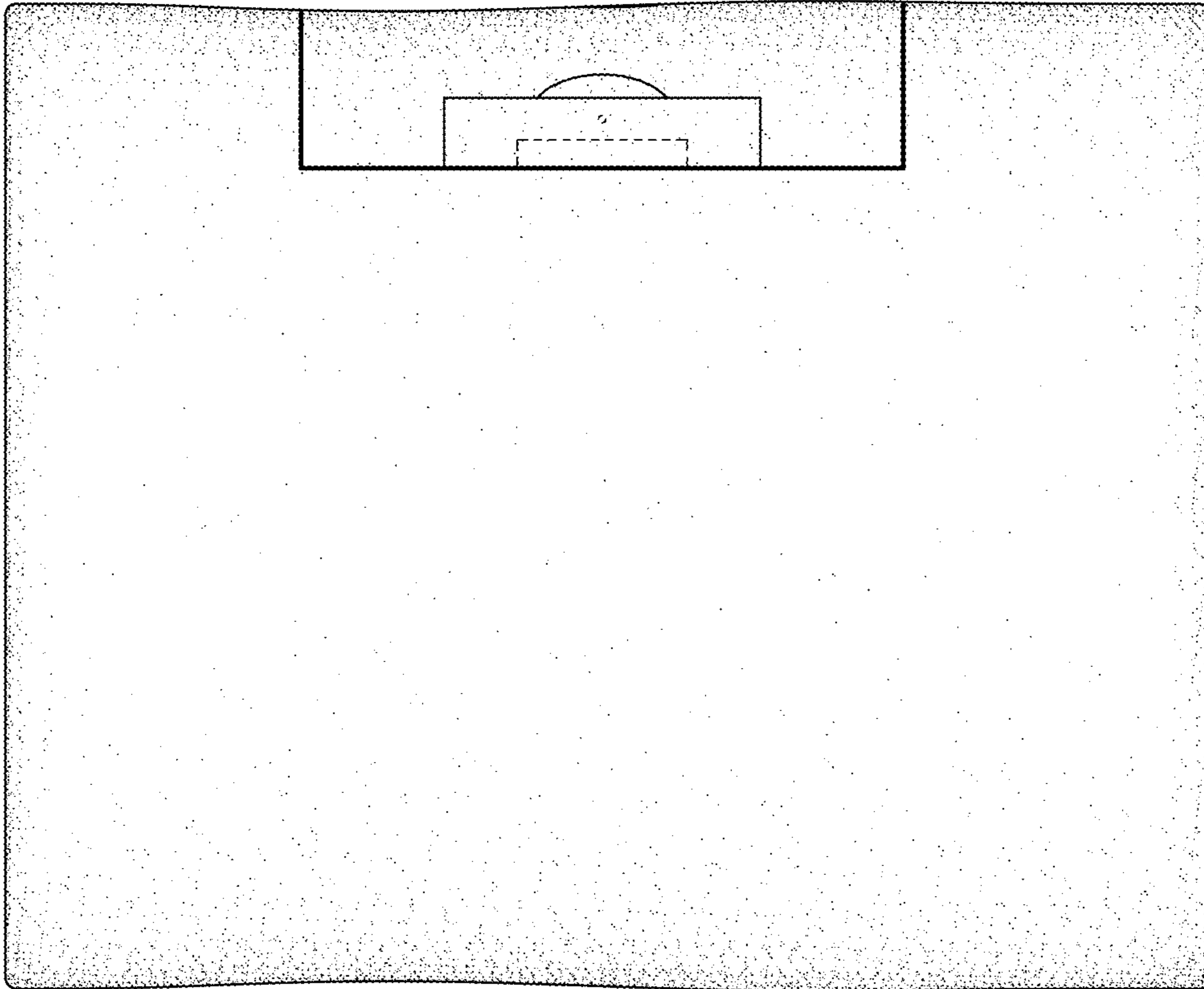

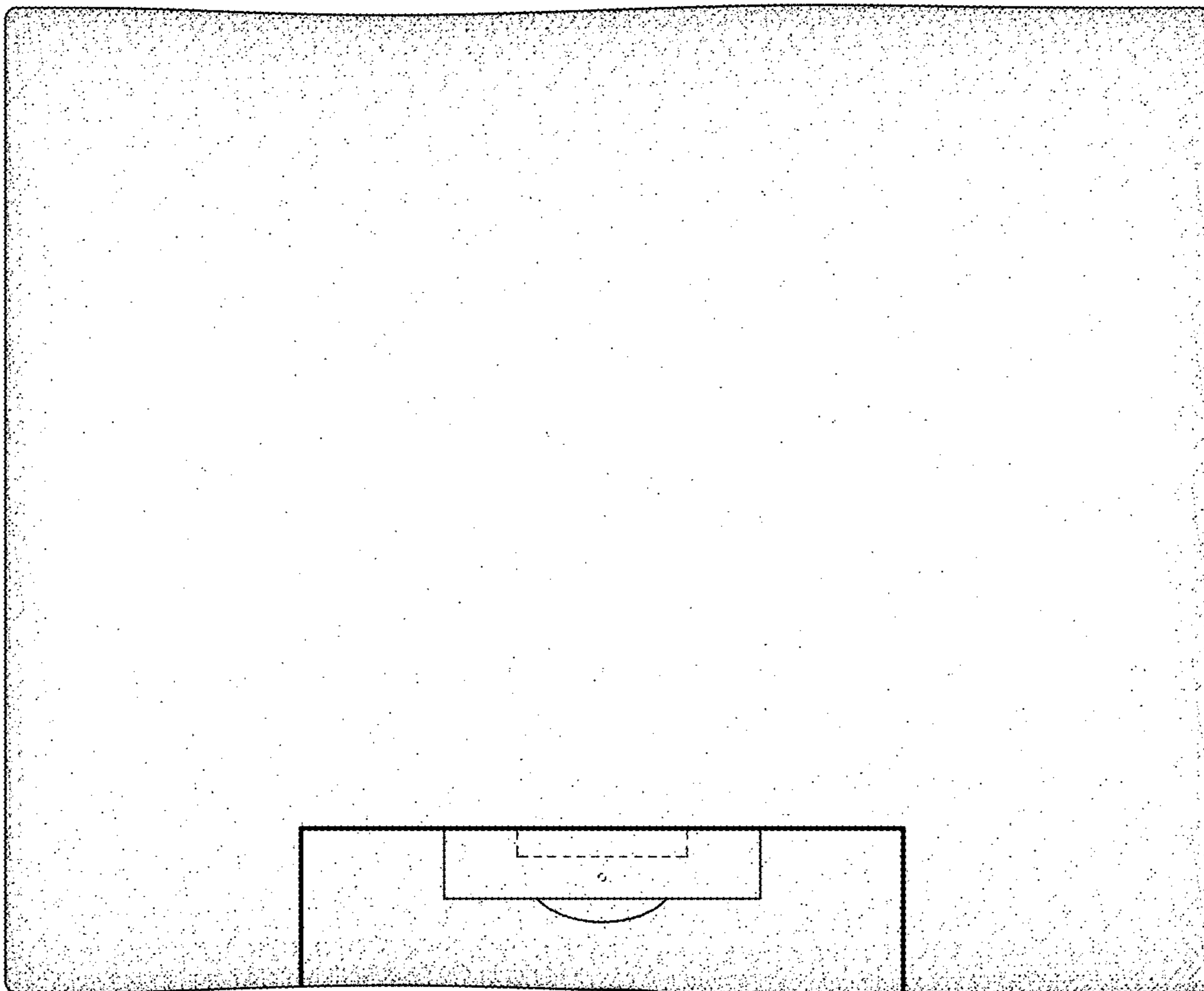

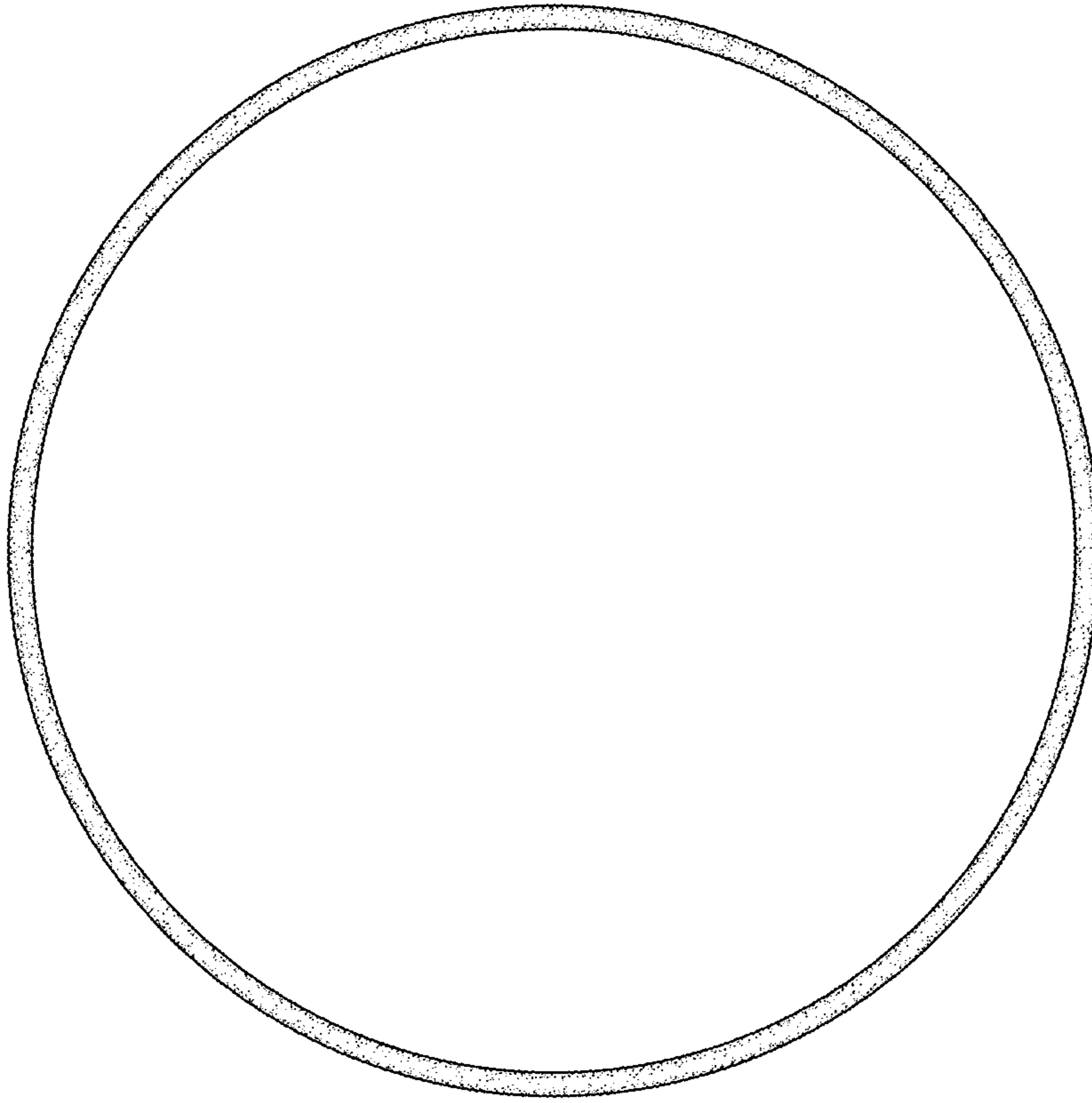

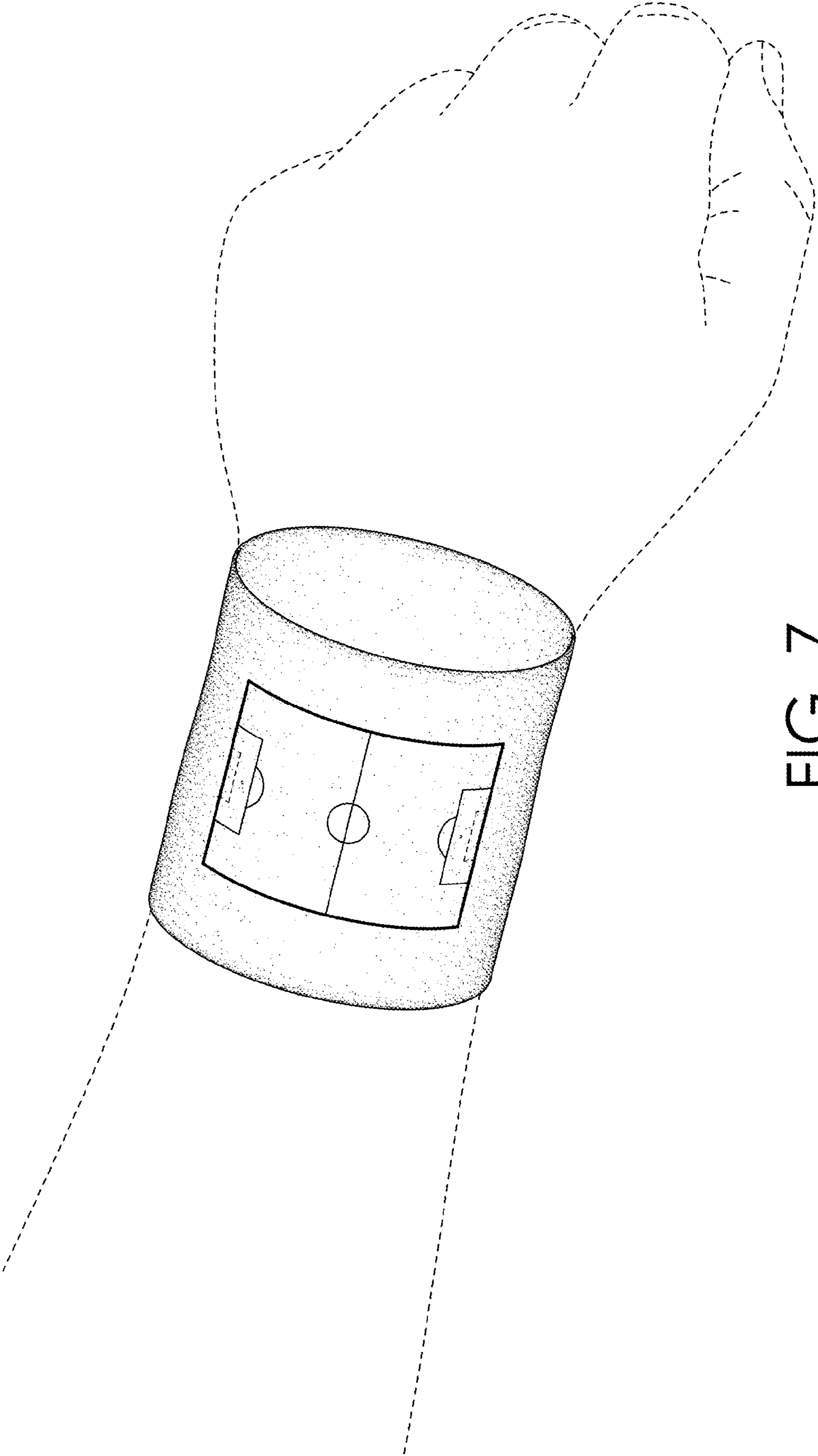
