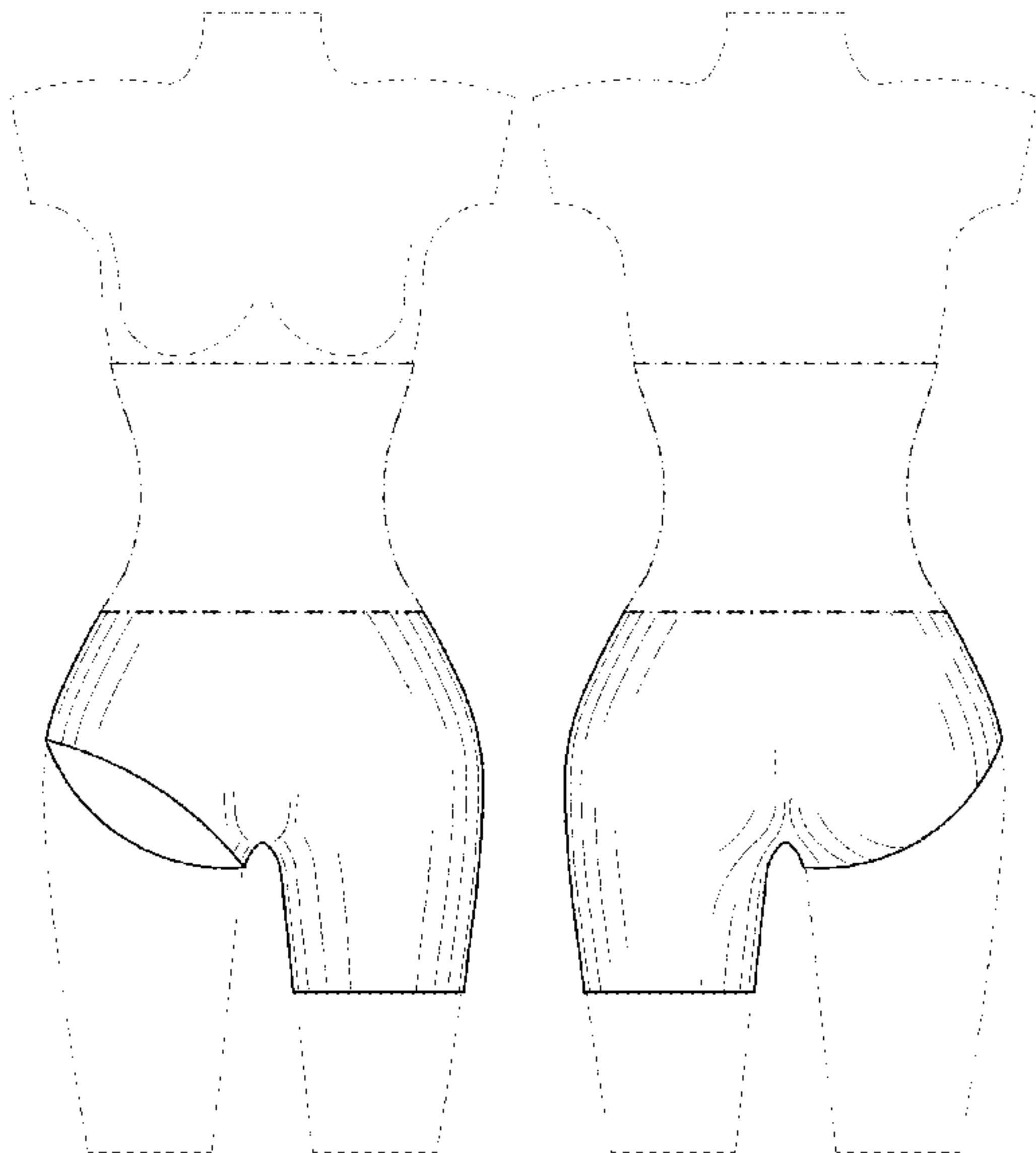
(57) CLAIM

The ornamental design for a short garment, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a short garment showing a first embodiment of the present invention, where the short garment can be made of an elastic, form fitting material; FIG. 2 is a front view; FIG. 3 is a rear view; FIG. 4 is a right side view; FIG. 5 is a left side view; FIG. 6 is a top view; and FIG. 7 is a bottom view. FIG. 8 is a perspective view of a short garment showing a second embodiment of the present invention, where the short garment can be made of an elastic, form fitting material; FIG. 9 is a front view; FIG. 10 is a rear view; FIG. 11 is a left side view; FIG. 12 is a right side view; FIG. 13 is a top view; and, FIG. 14 is a bottom view. Broken lines in the drawings representing a female form depict environment only and form no part of the claimed design. Dot-dash lines in the drawings represent portion(s) of the short garment that are unclaimed and thus form no part of the claimed design.

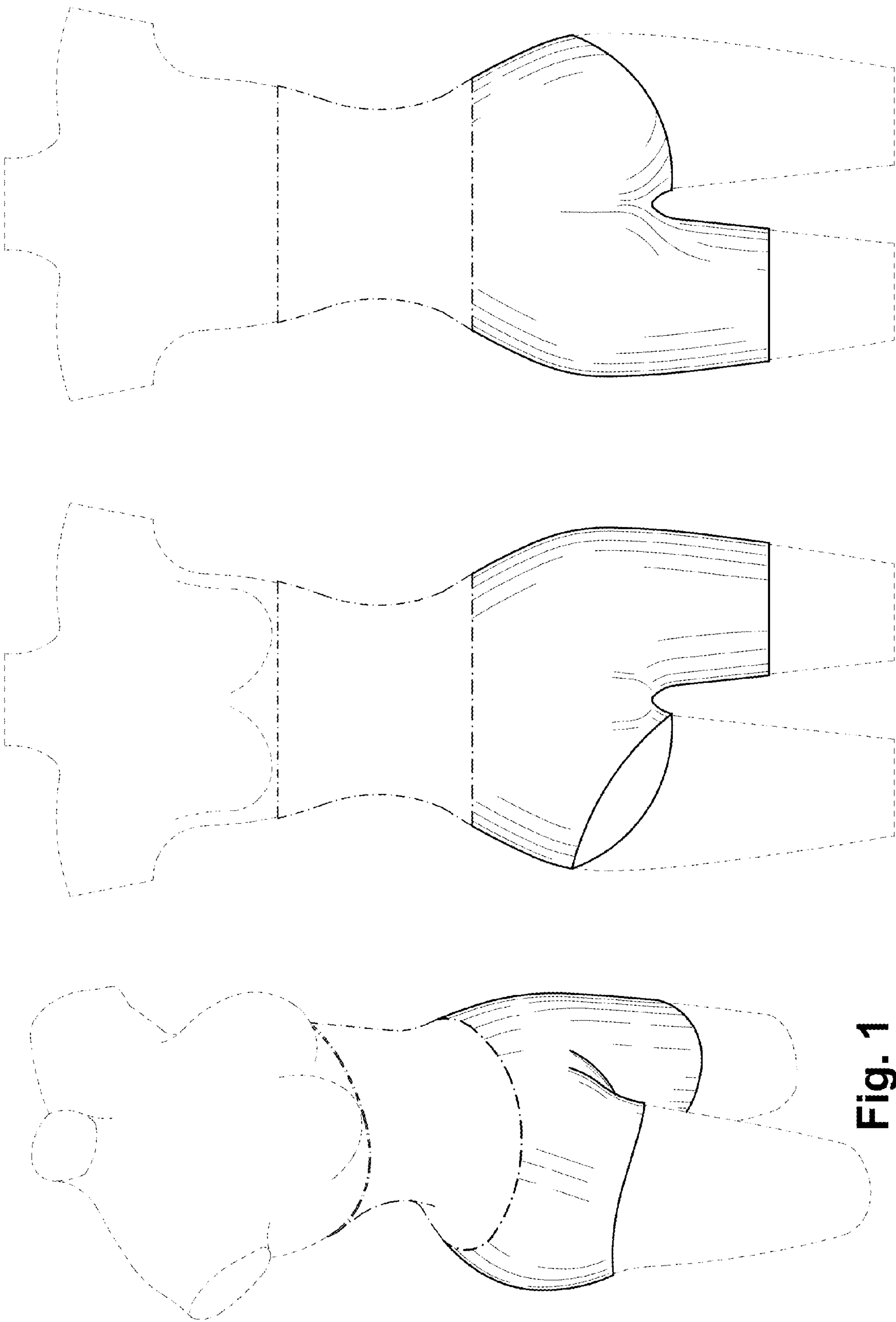

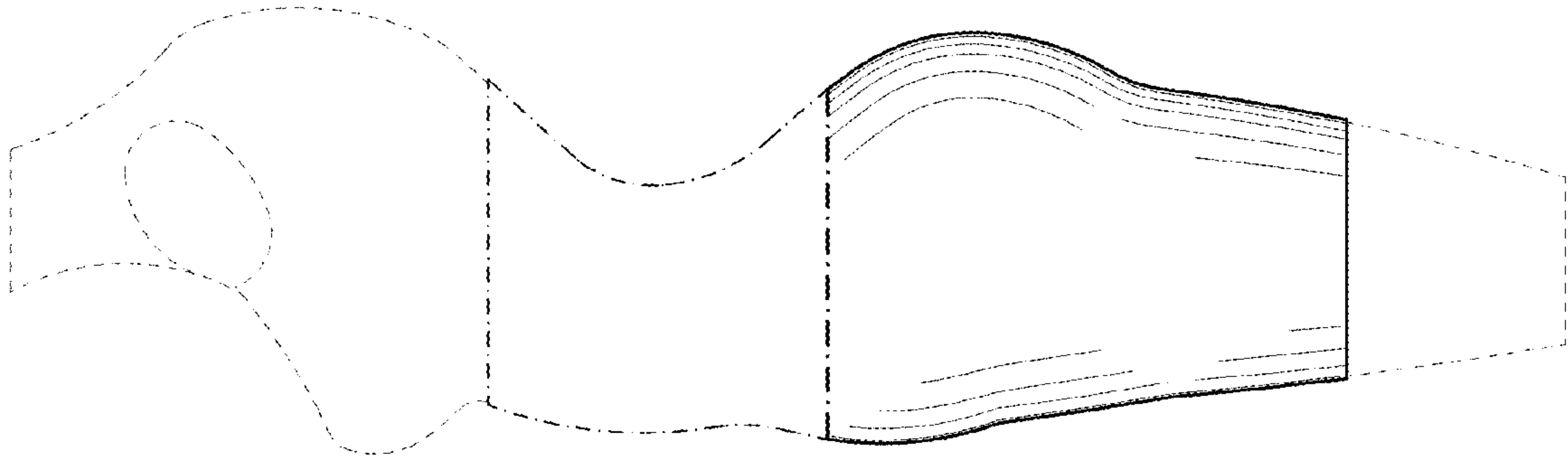

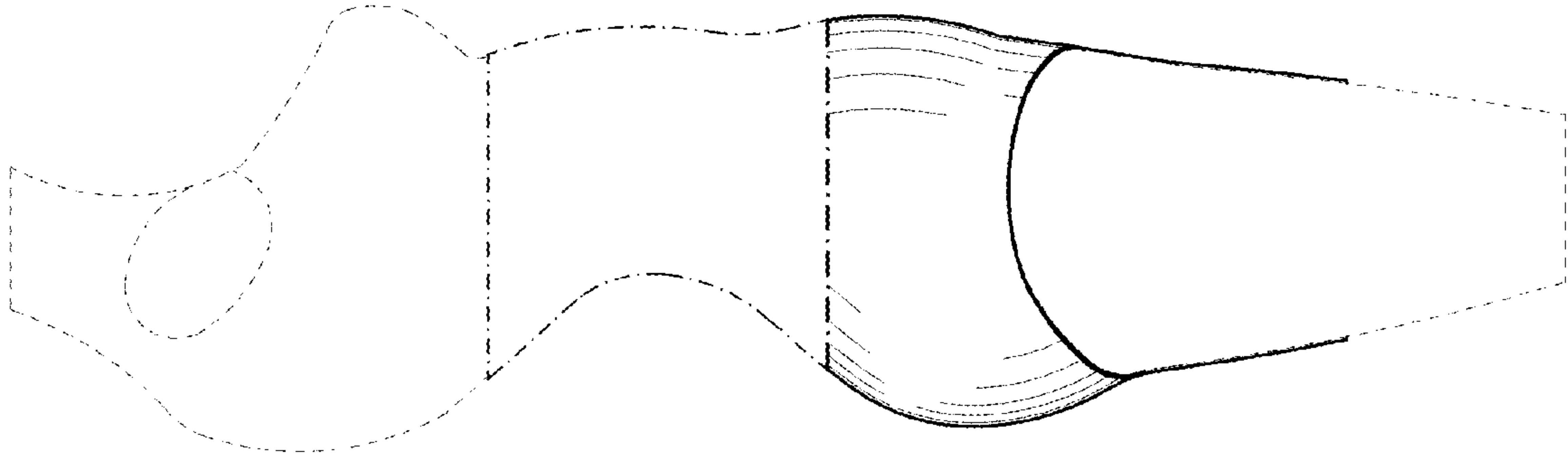

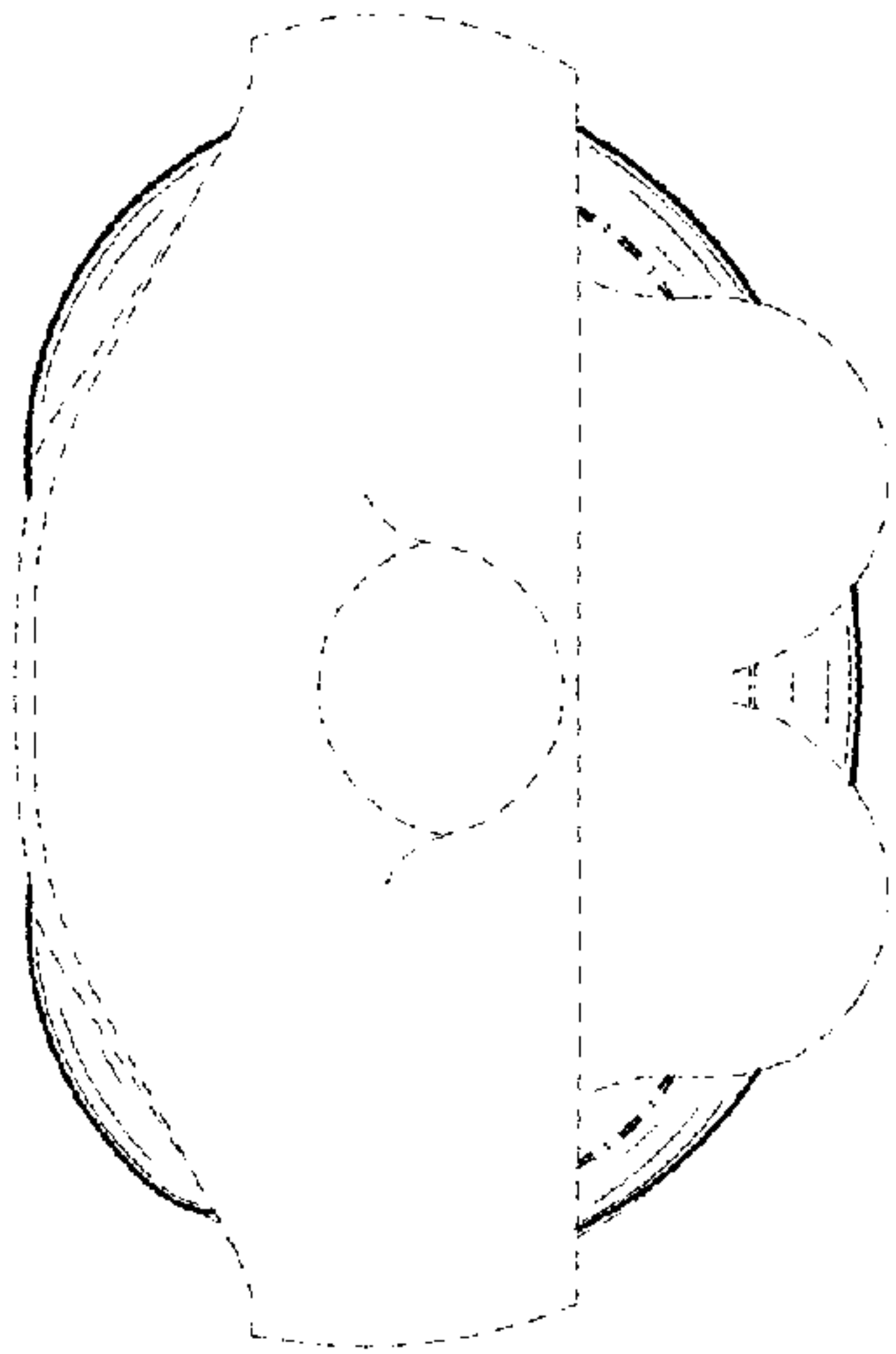

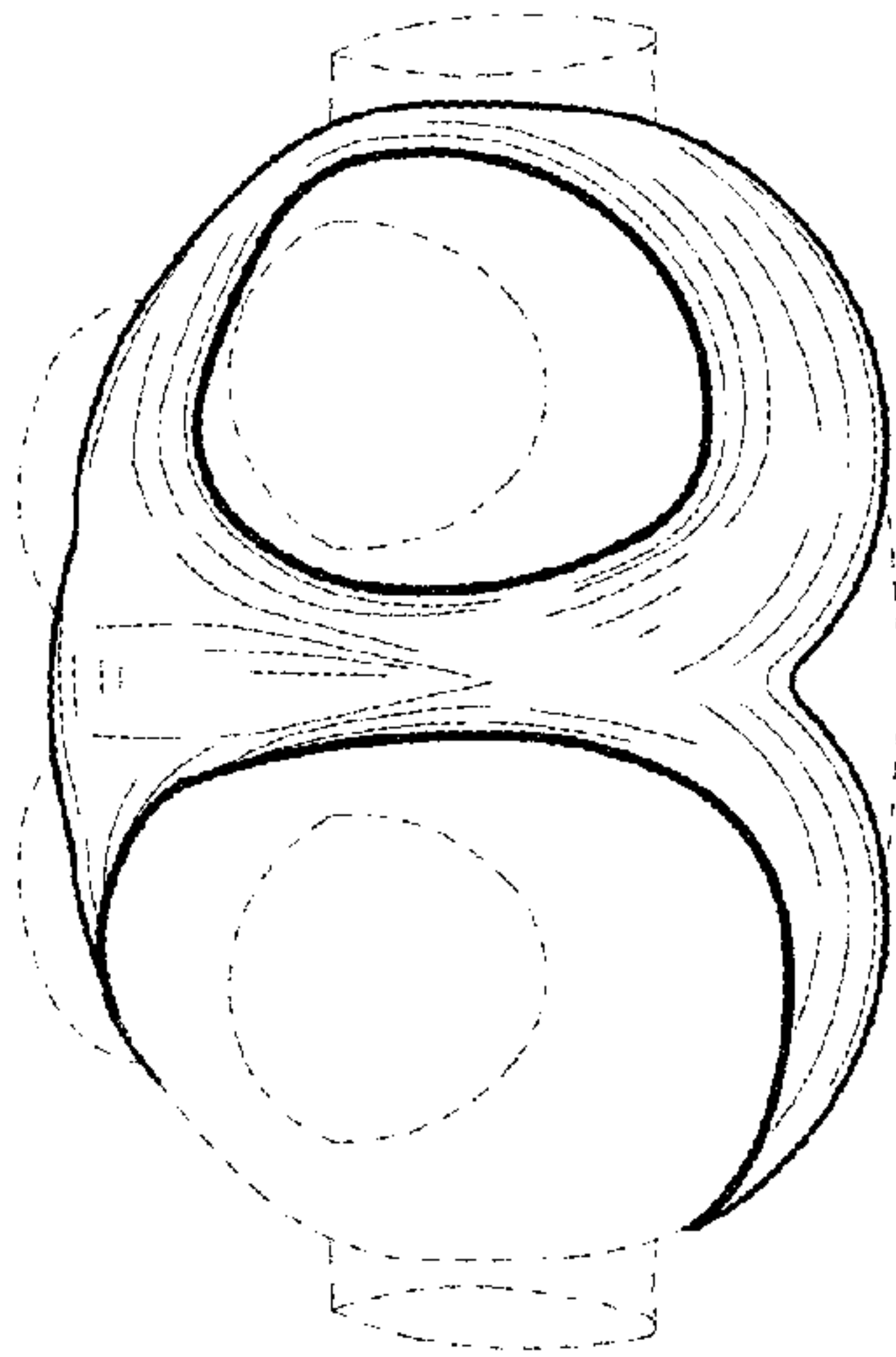

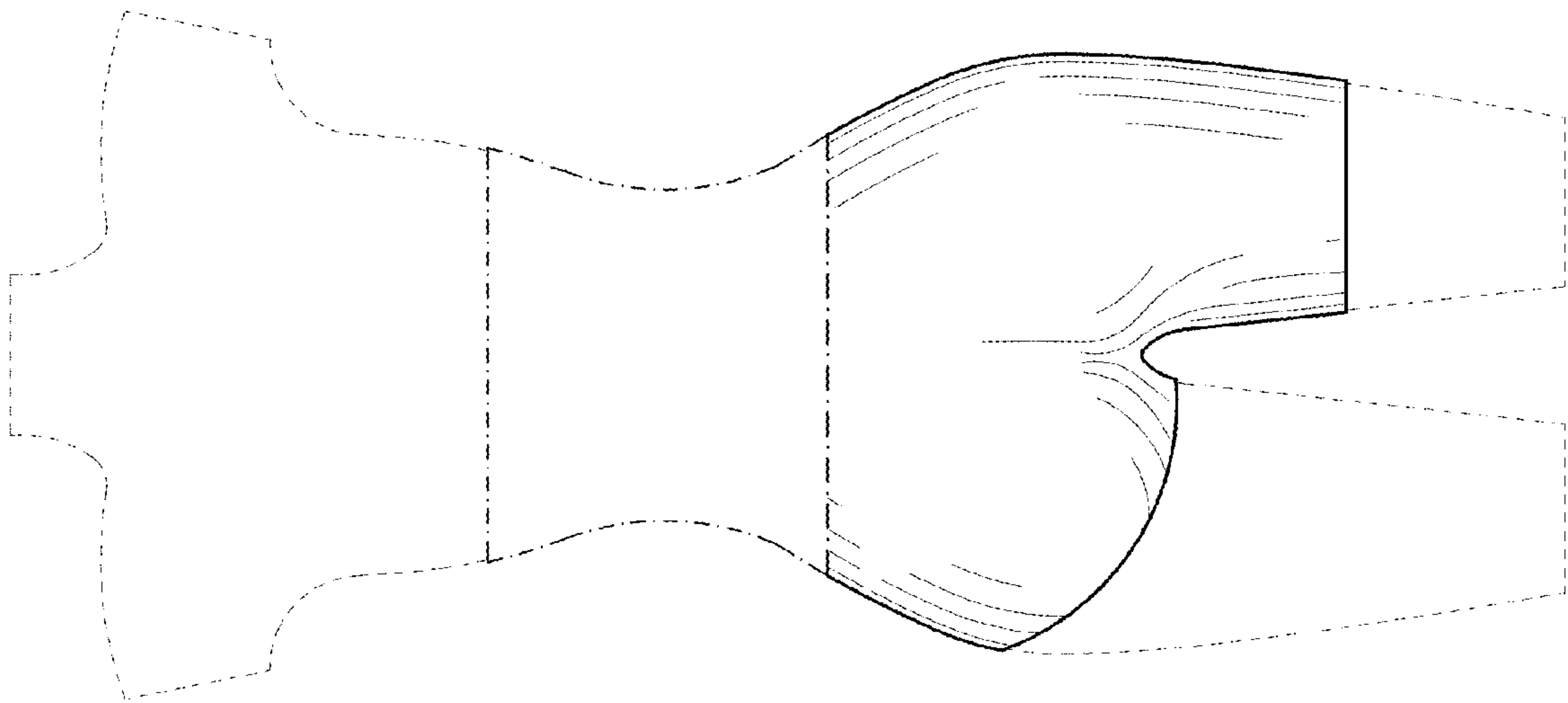

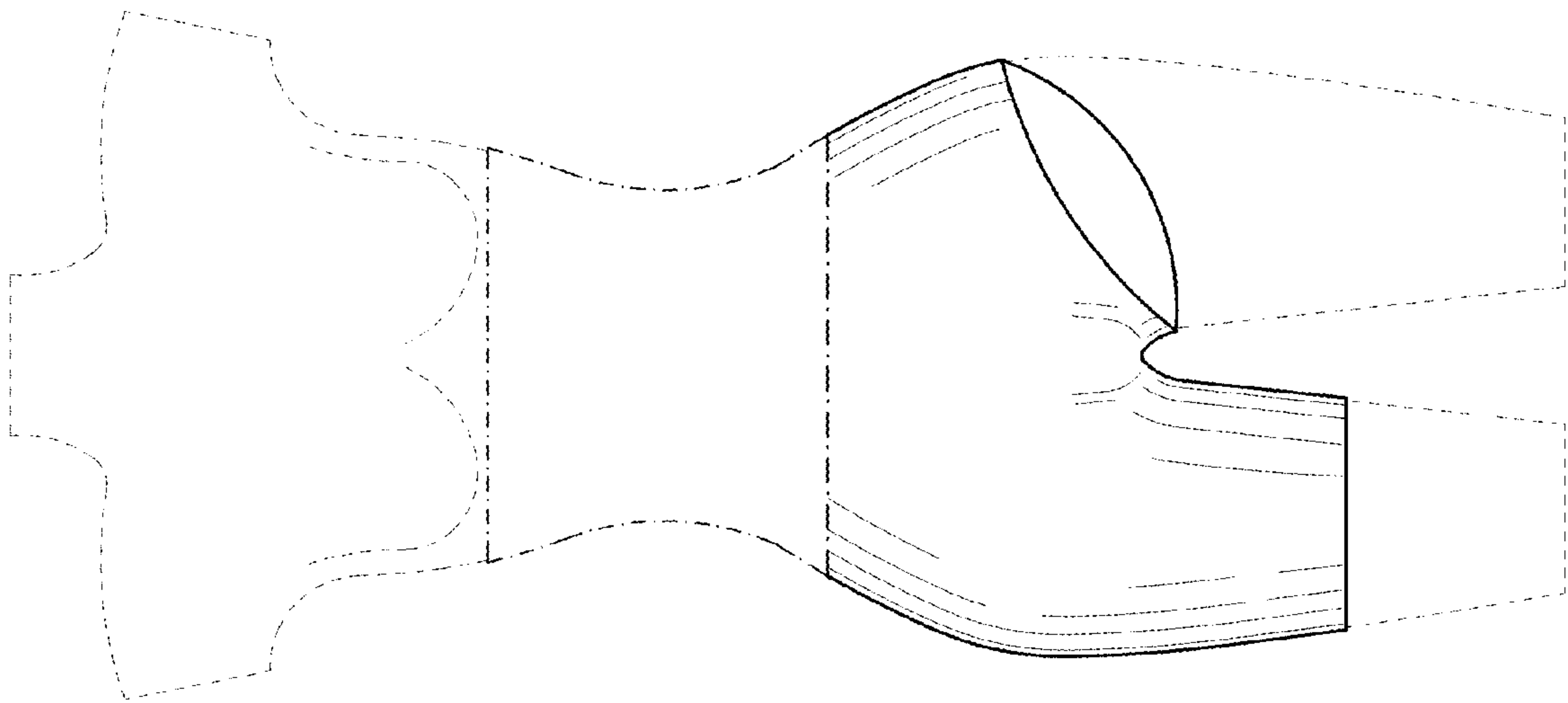

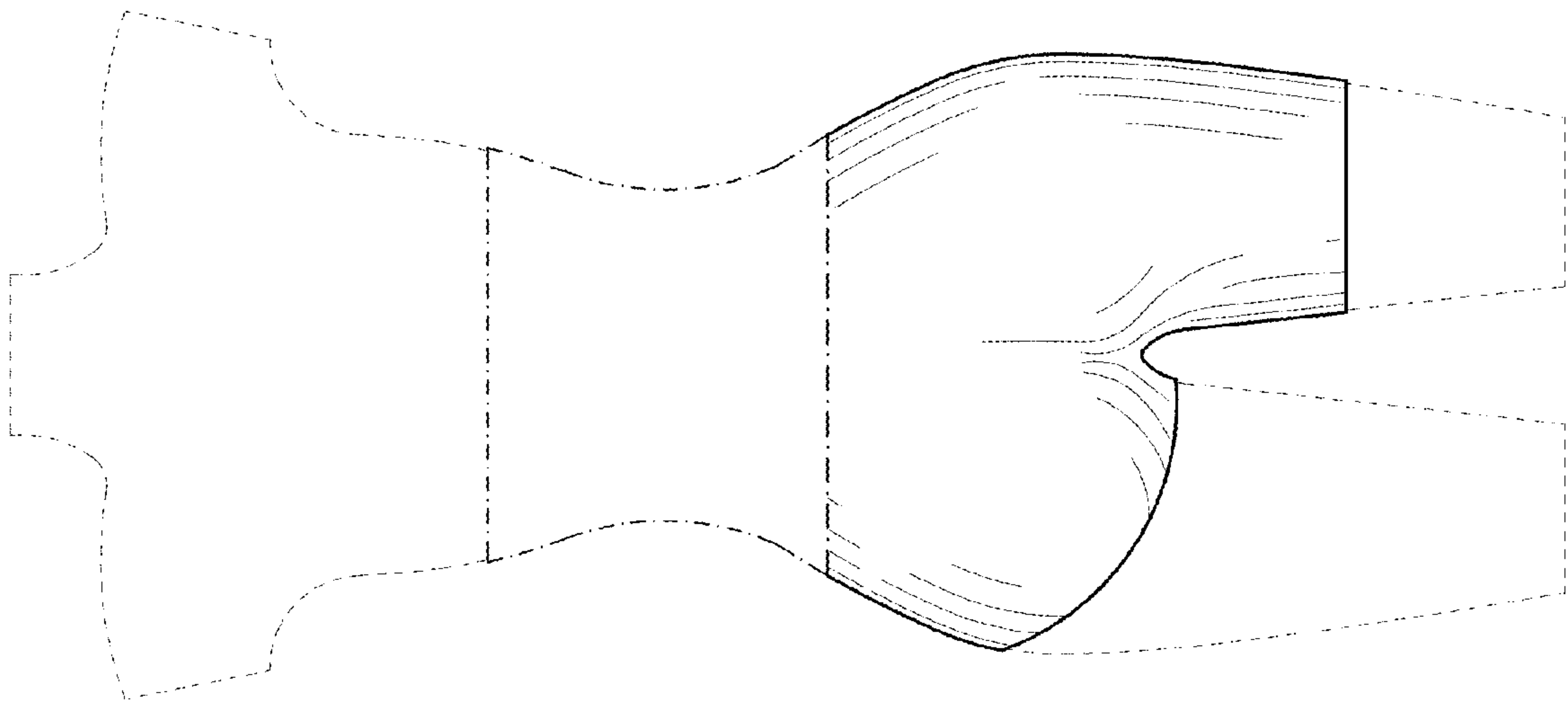

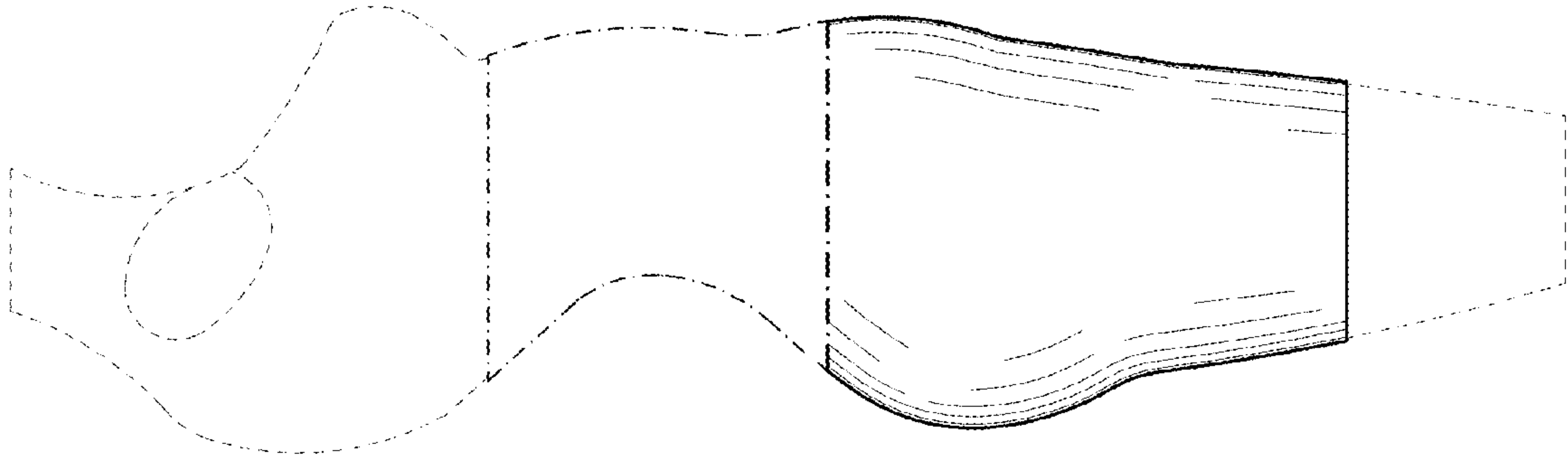

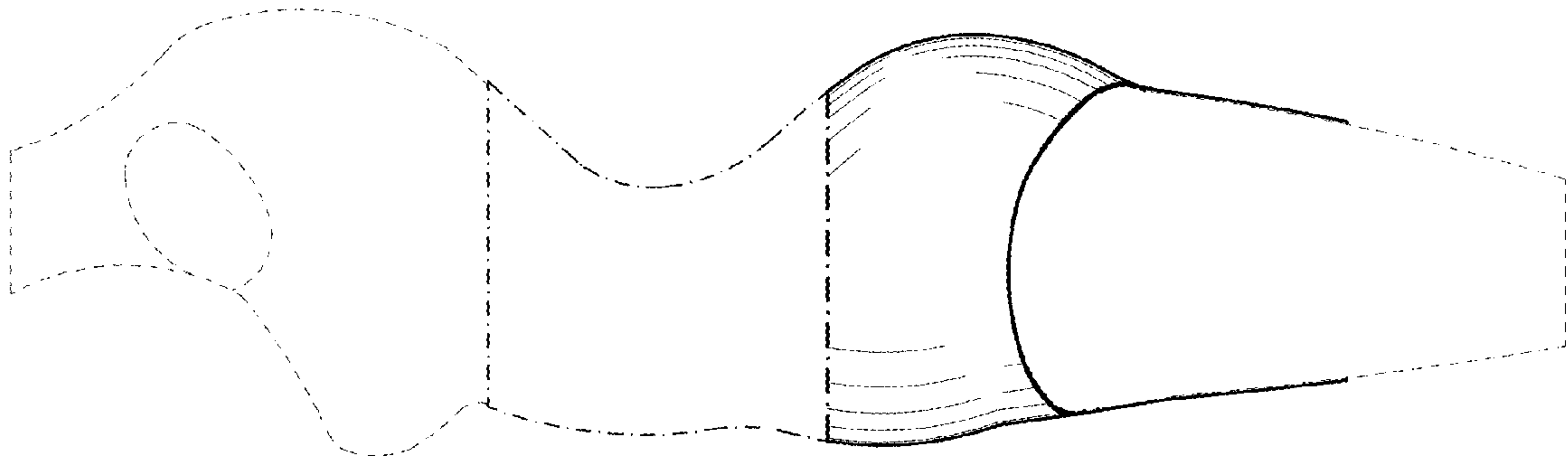

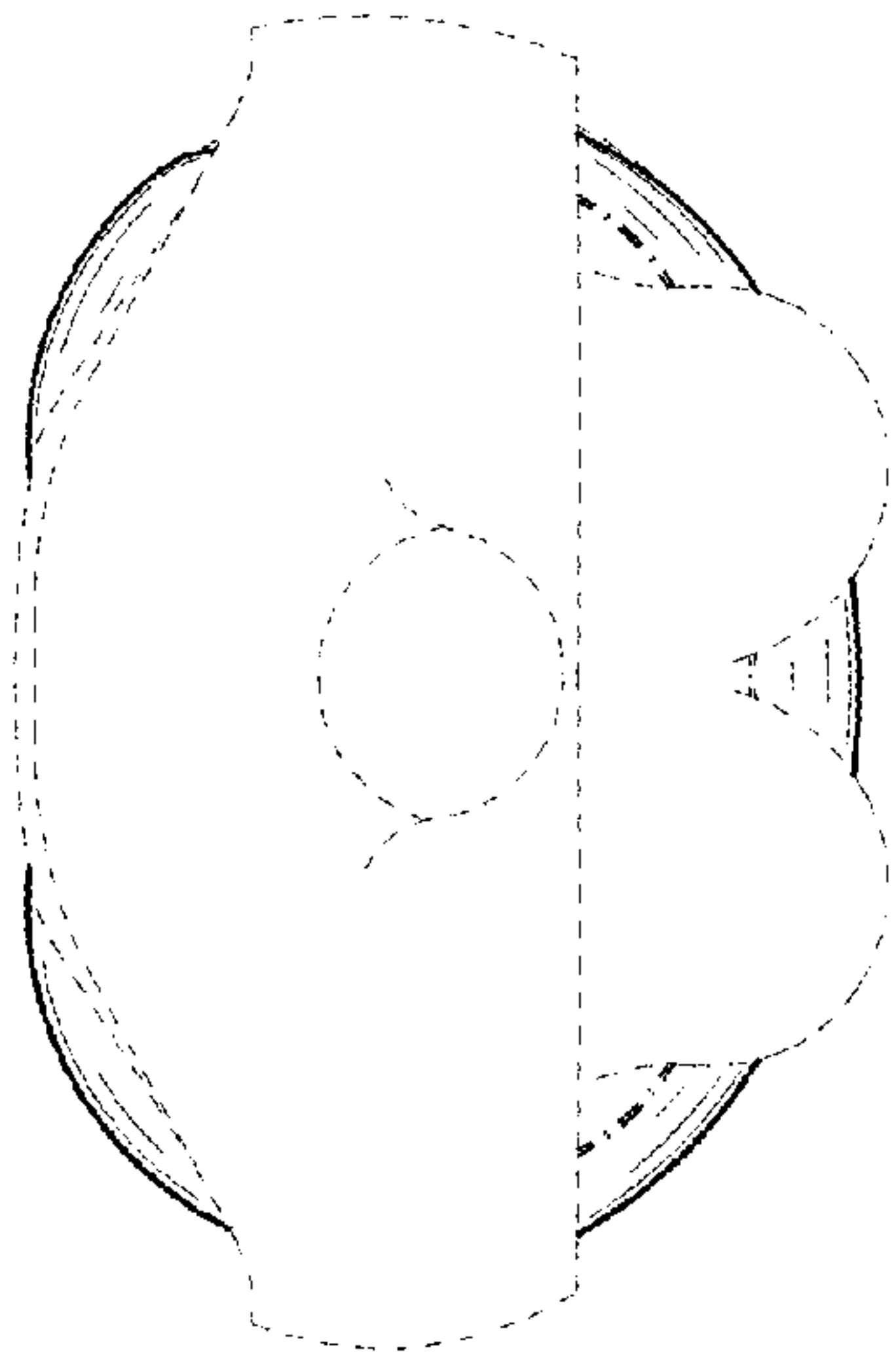

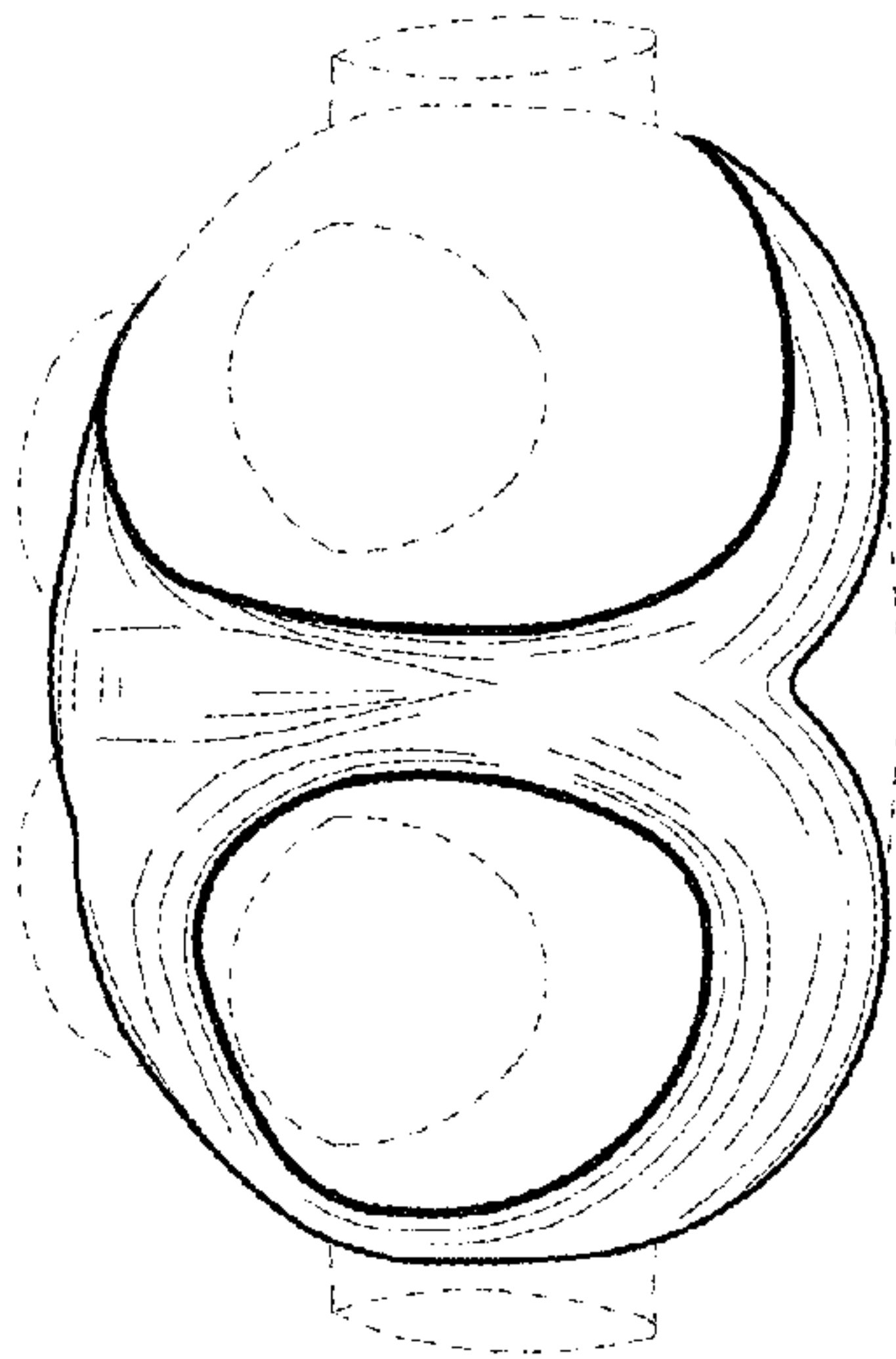
