DESCRIPTION

FIG. 1 is a front perspective view of the mule showing my new design;

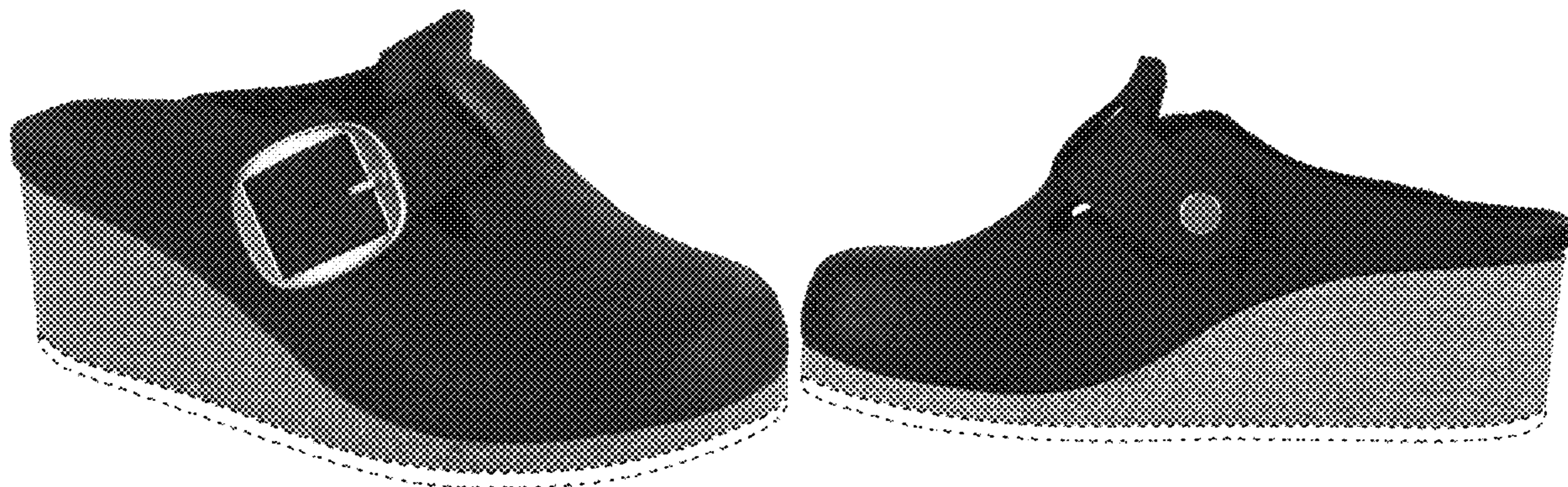

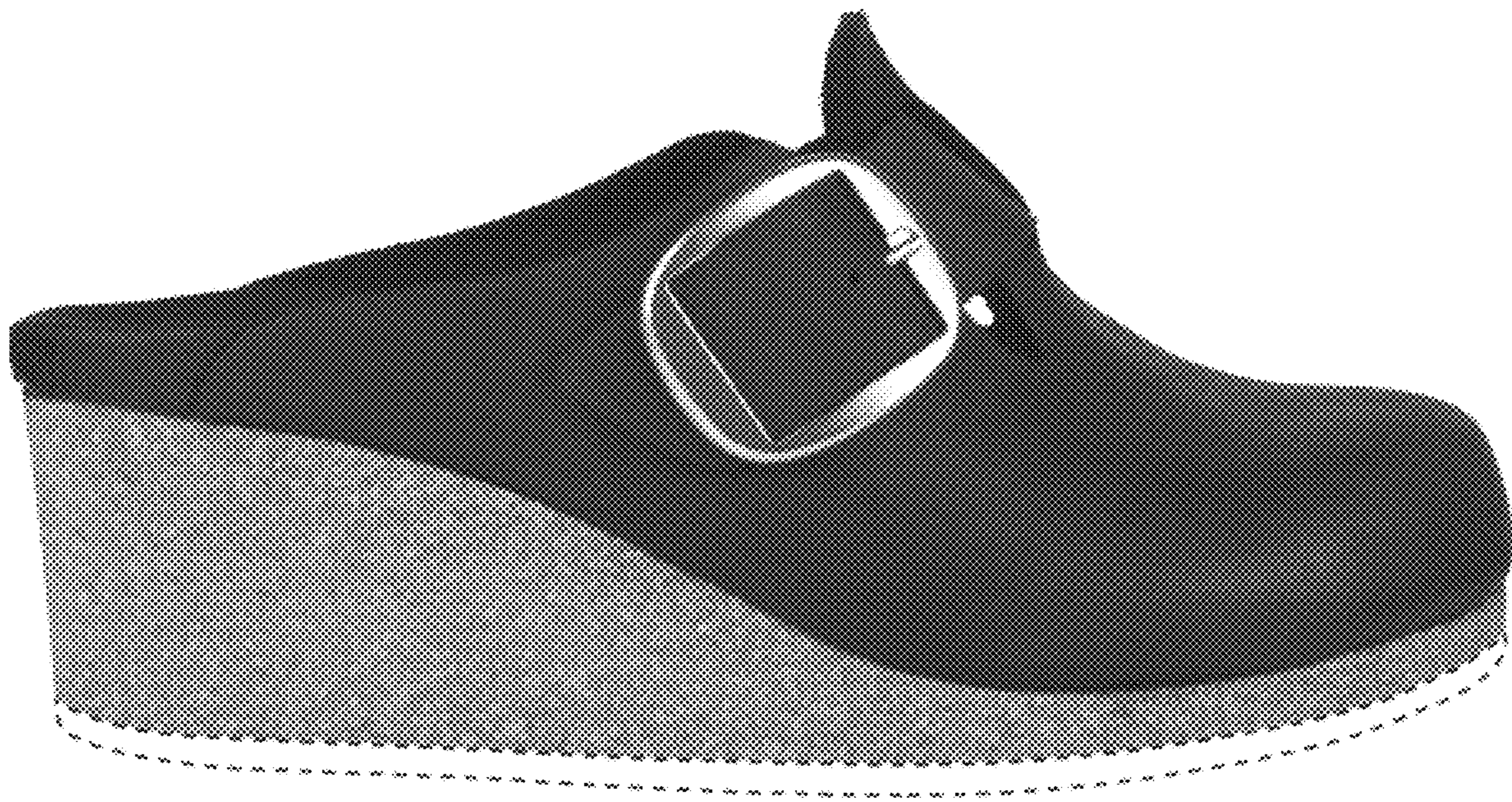

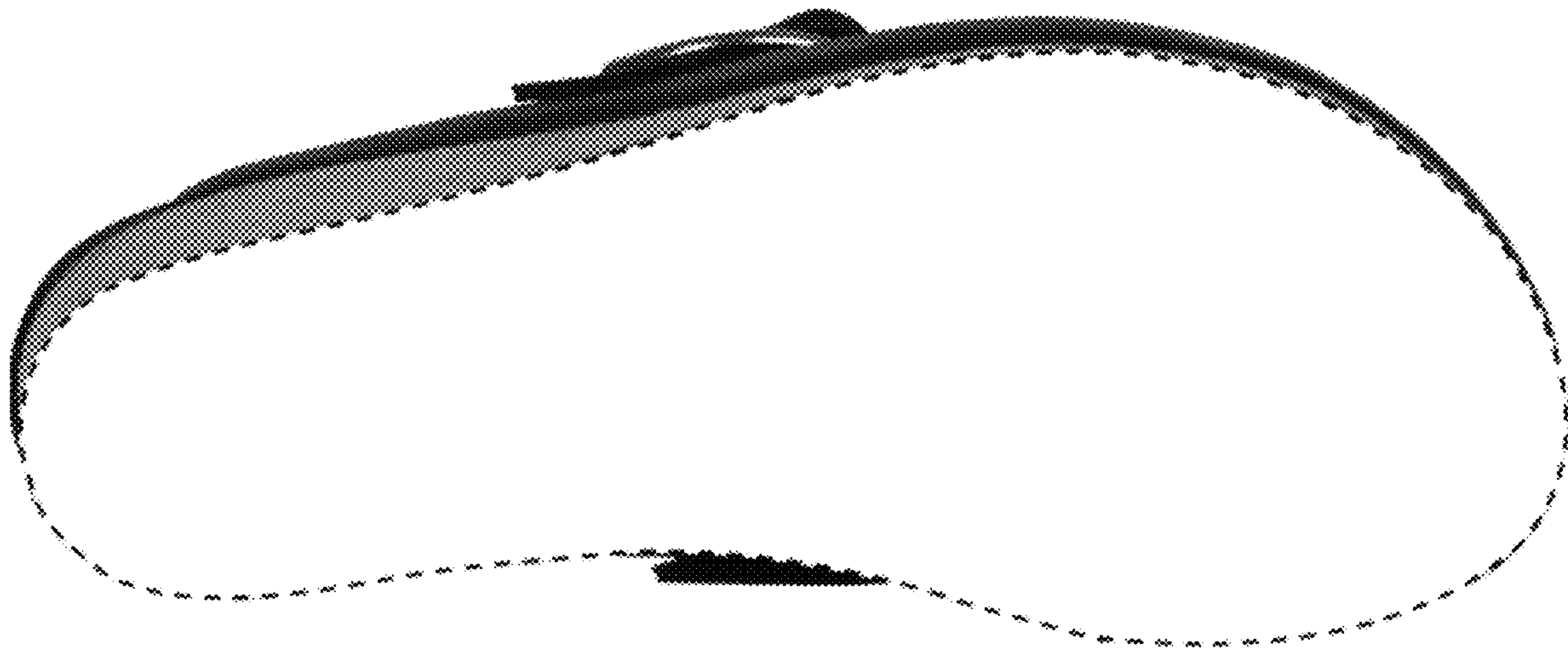
