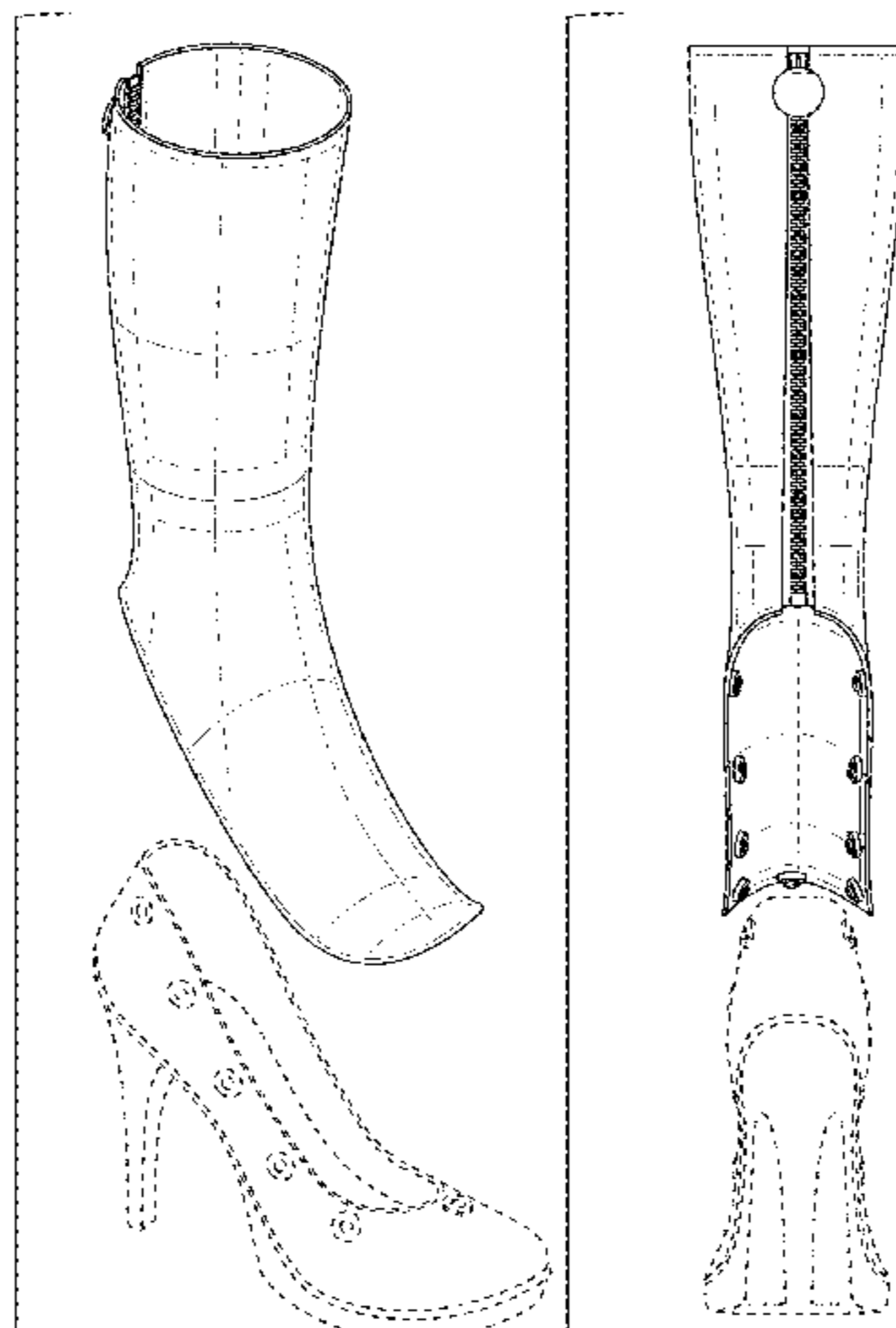


FIG. 13 is an exploded first side view of the convertible heel with a detachable leg cover of FIG. 1.

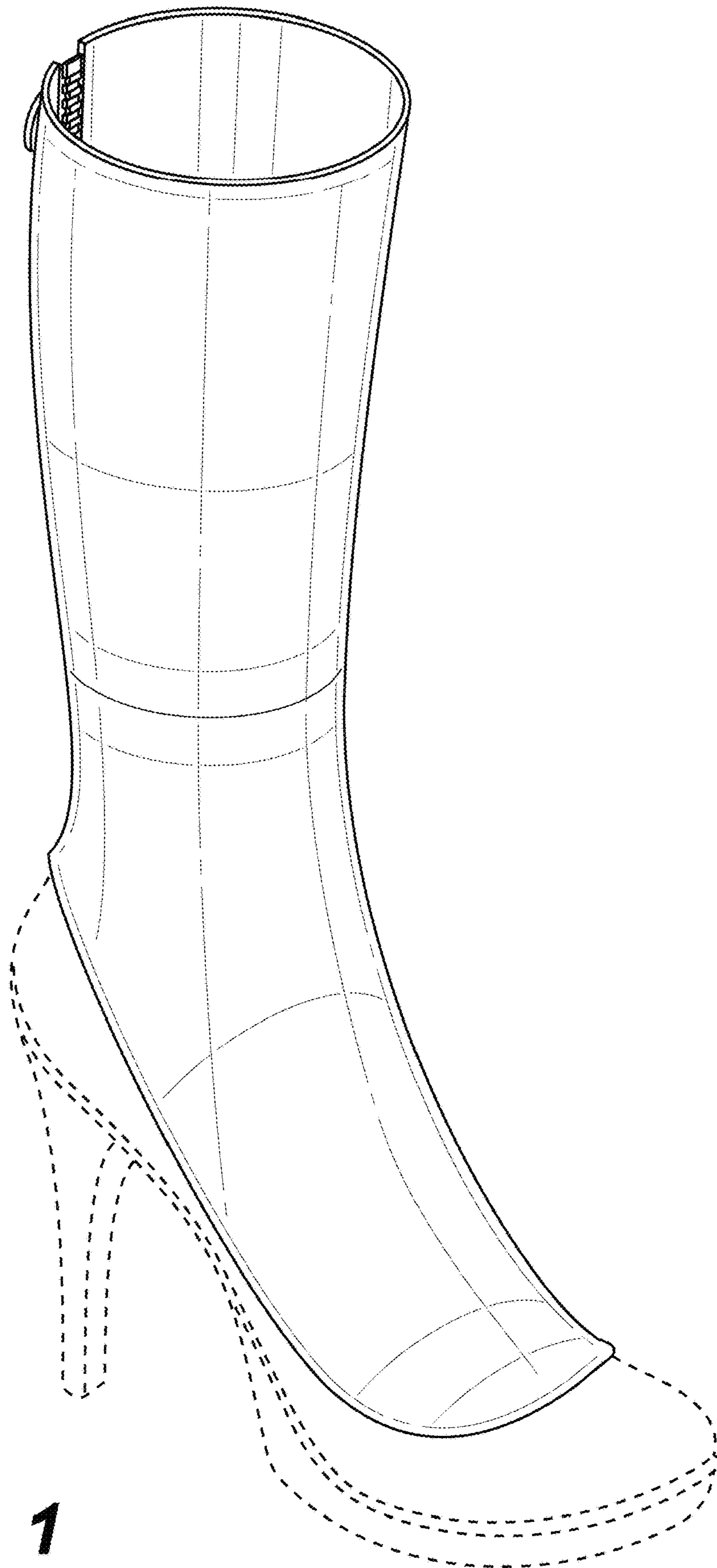

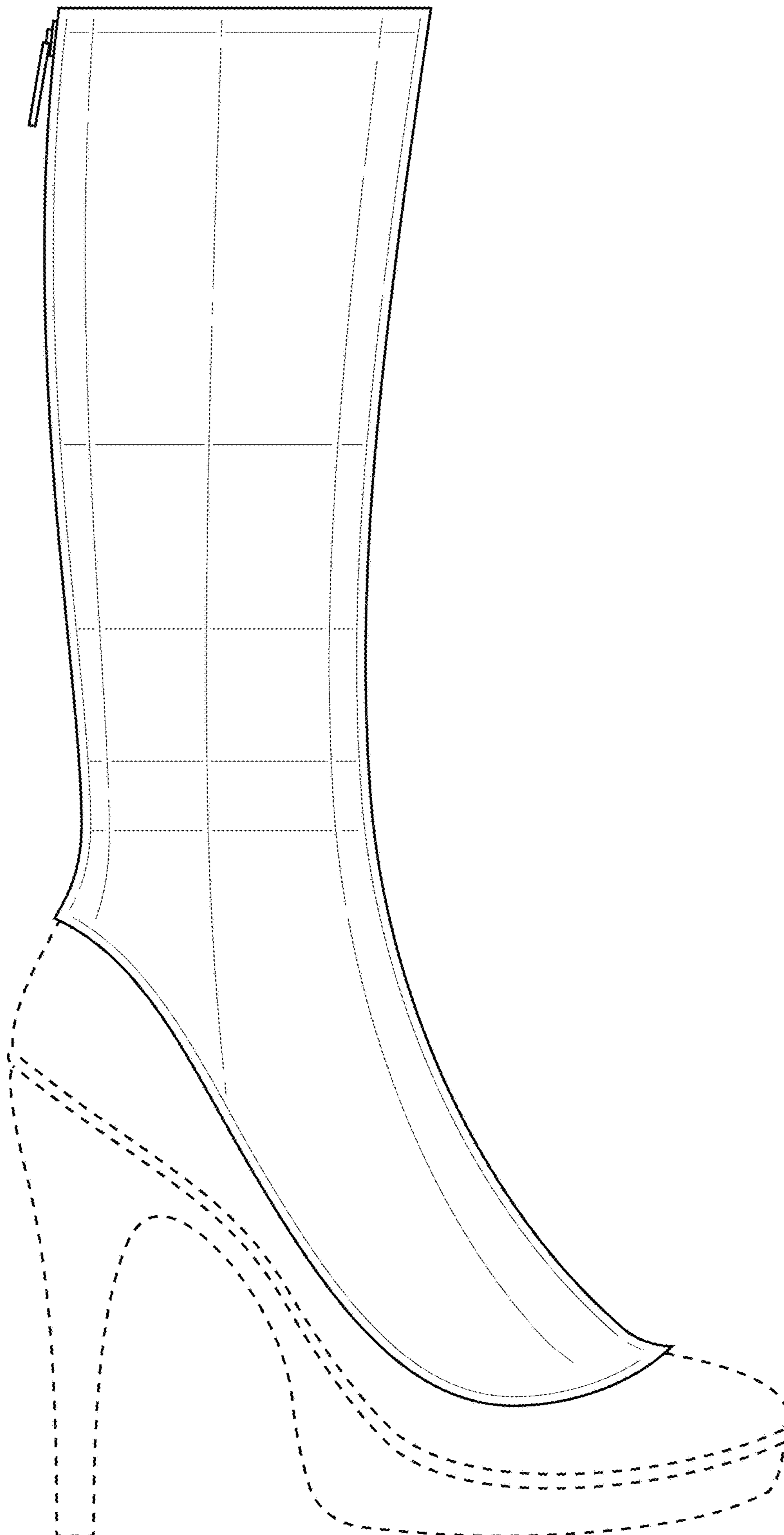

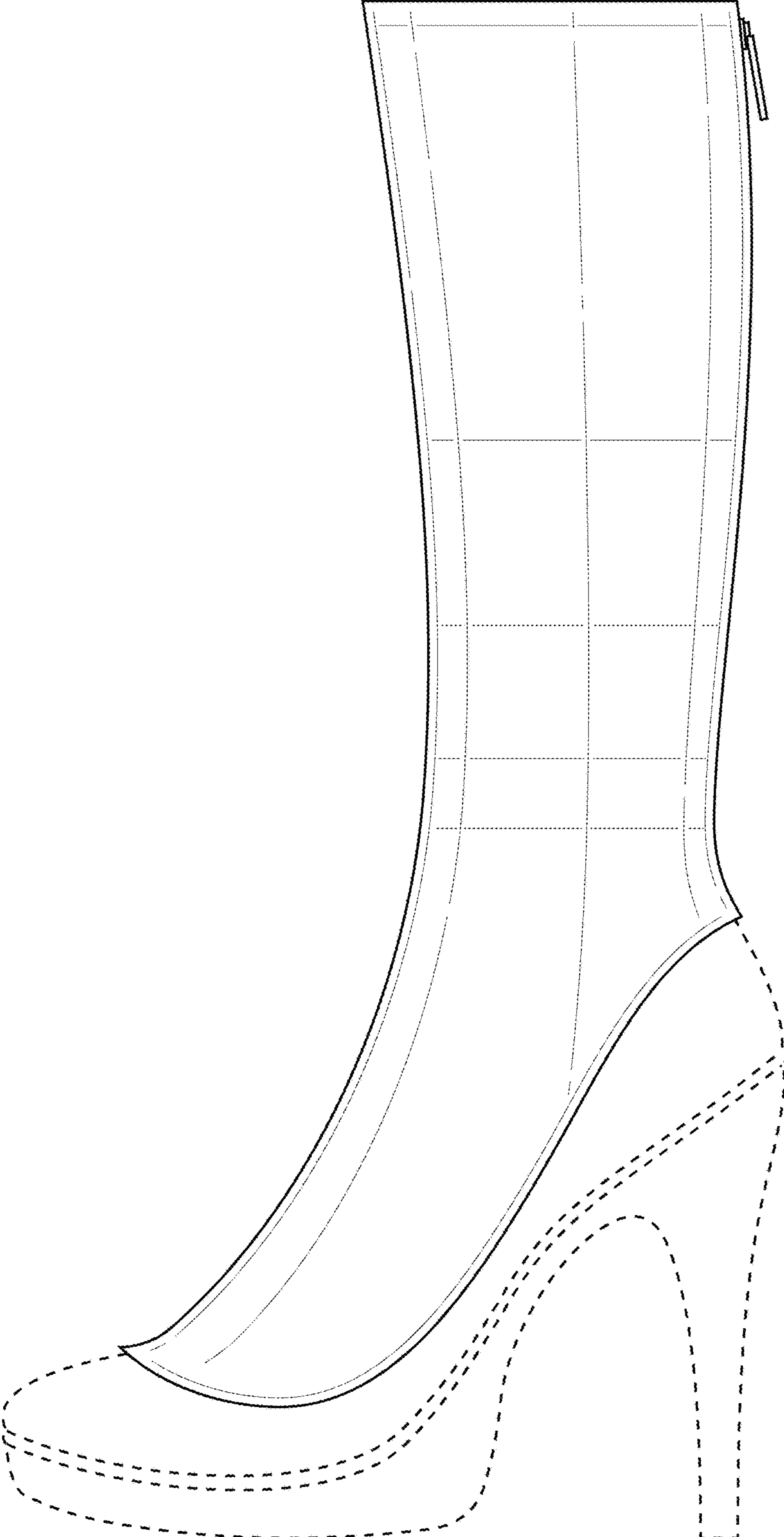

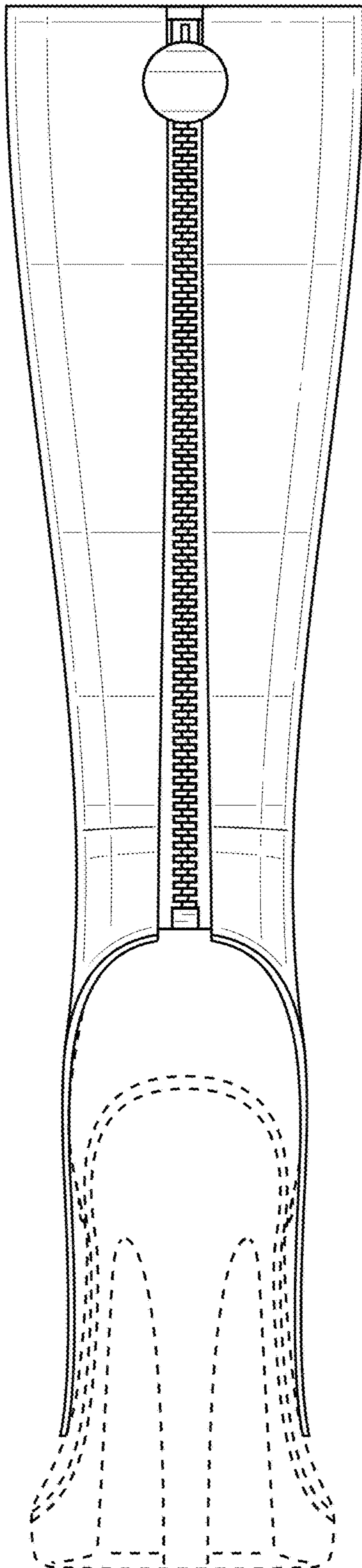

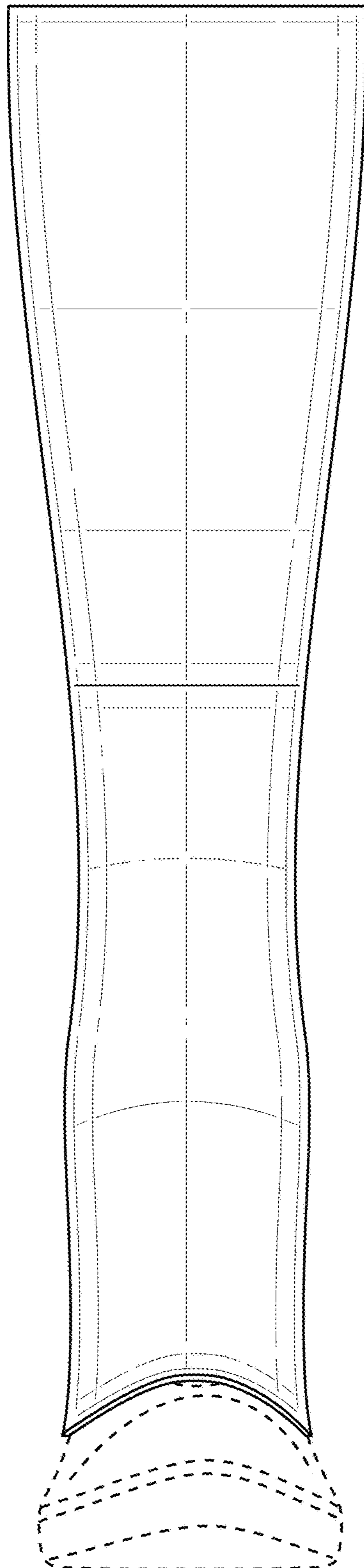

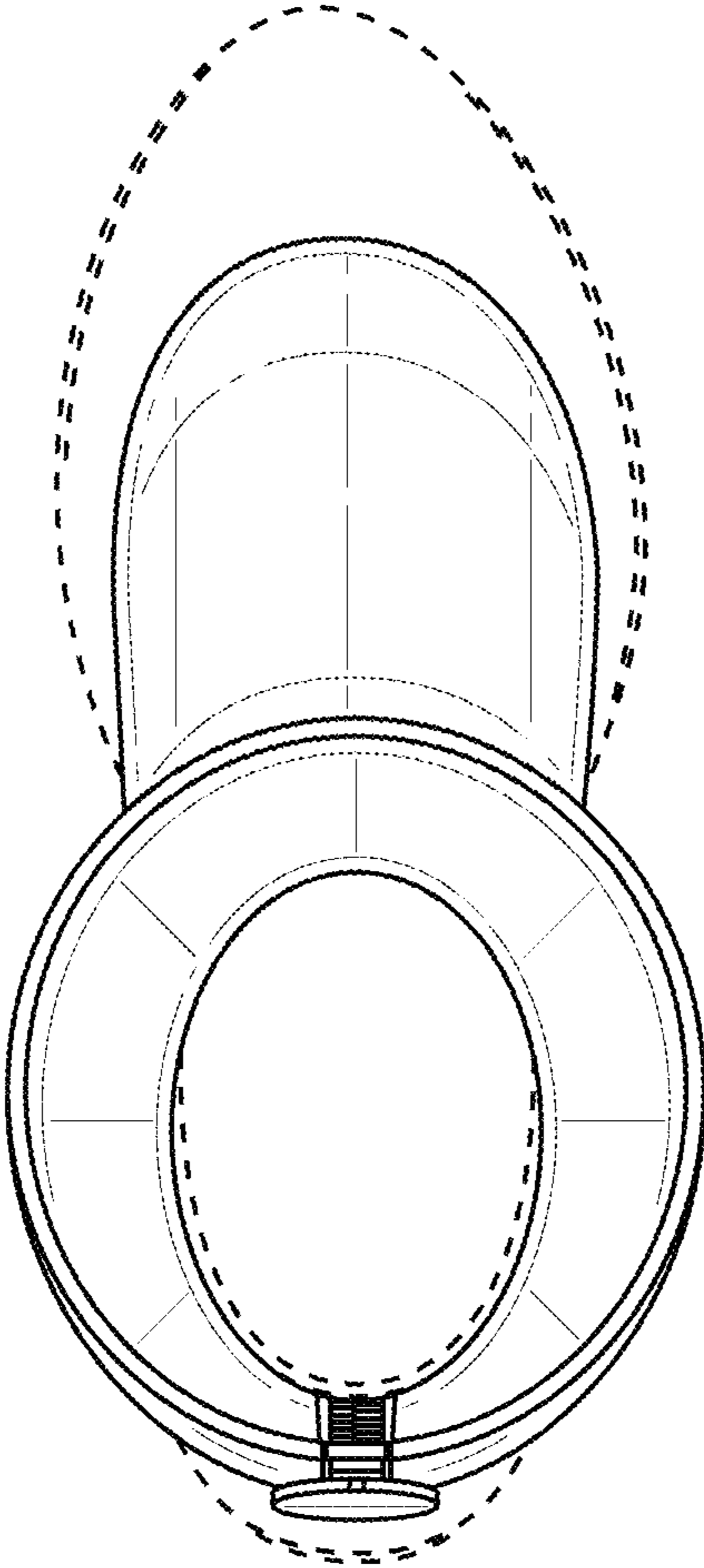

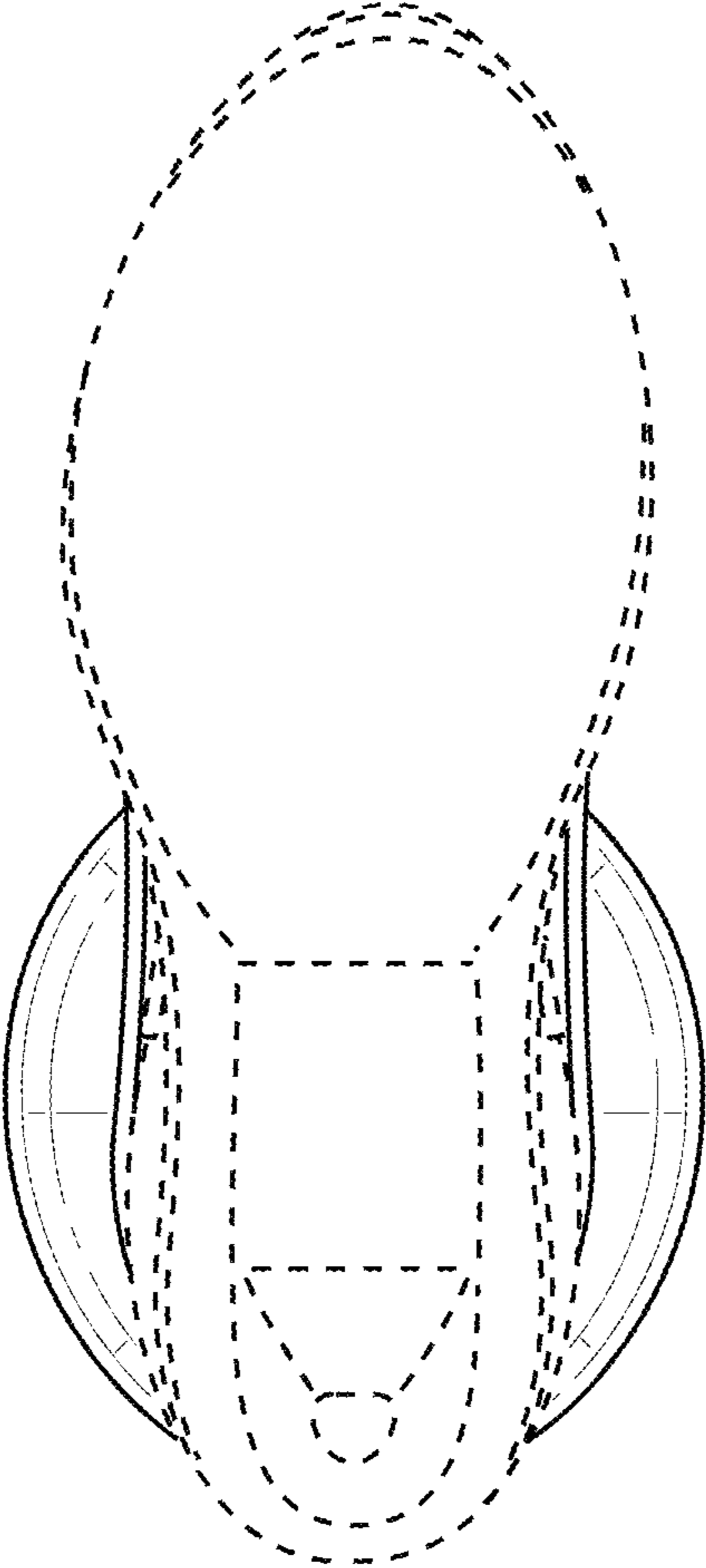

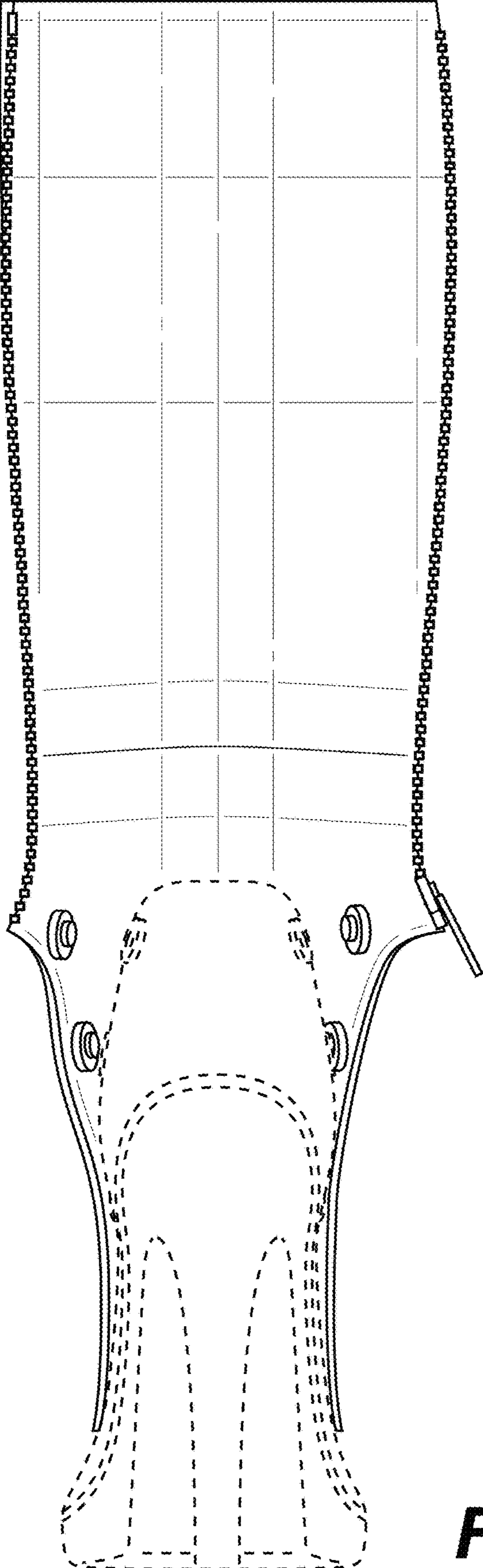

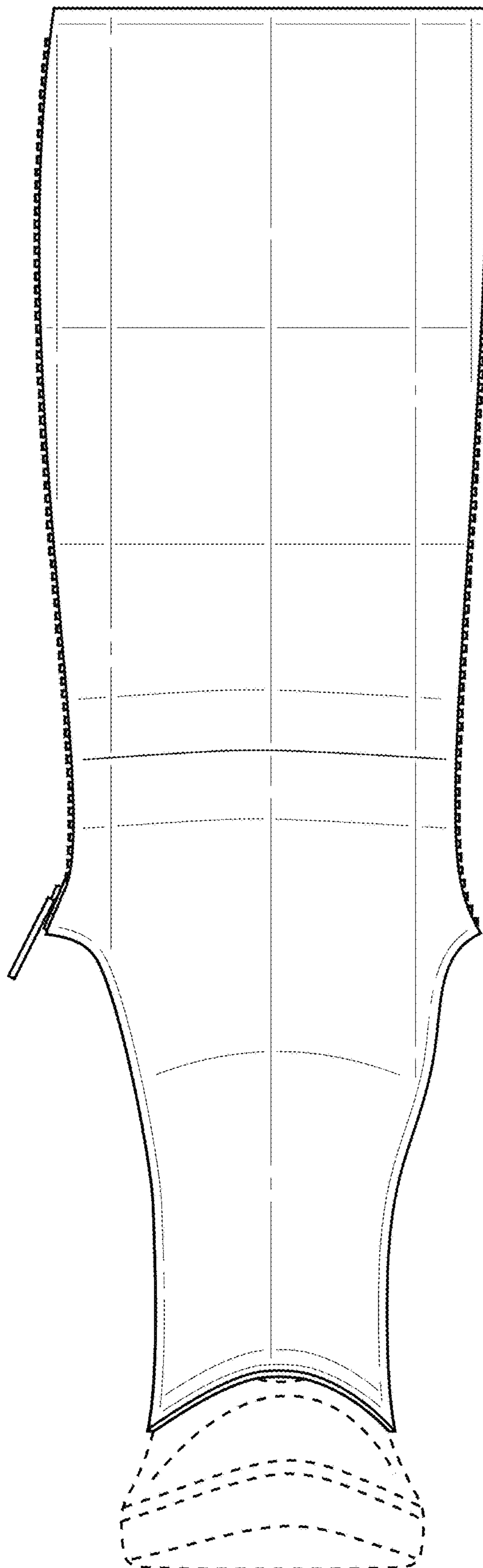

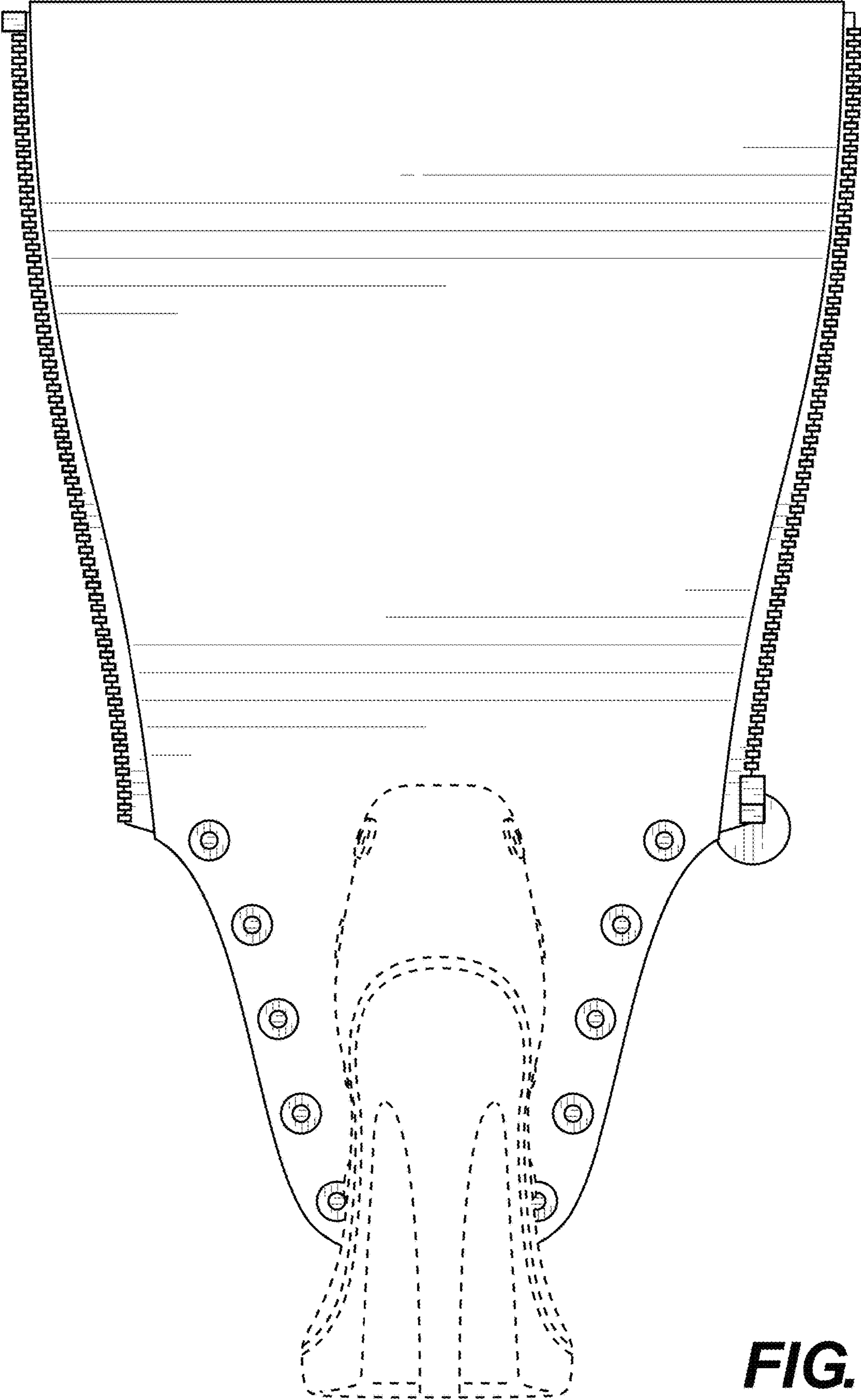

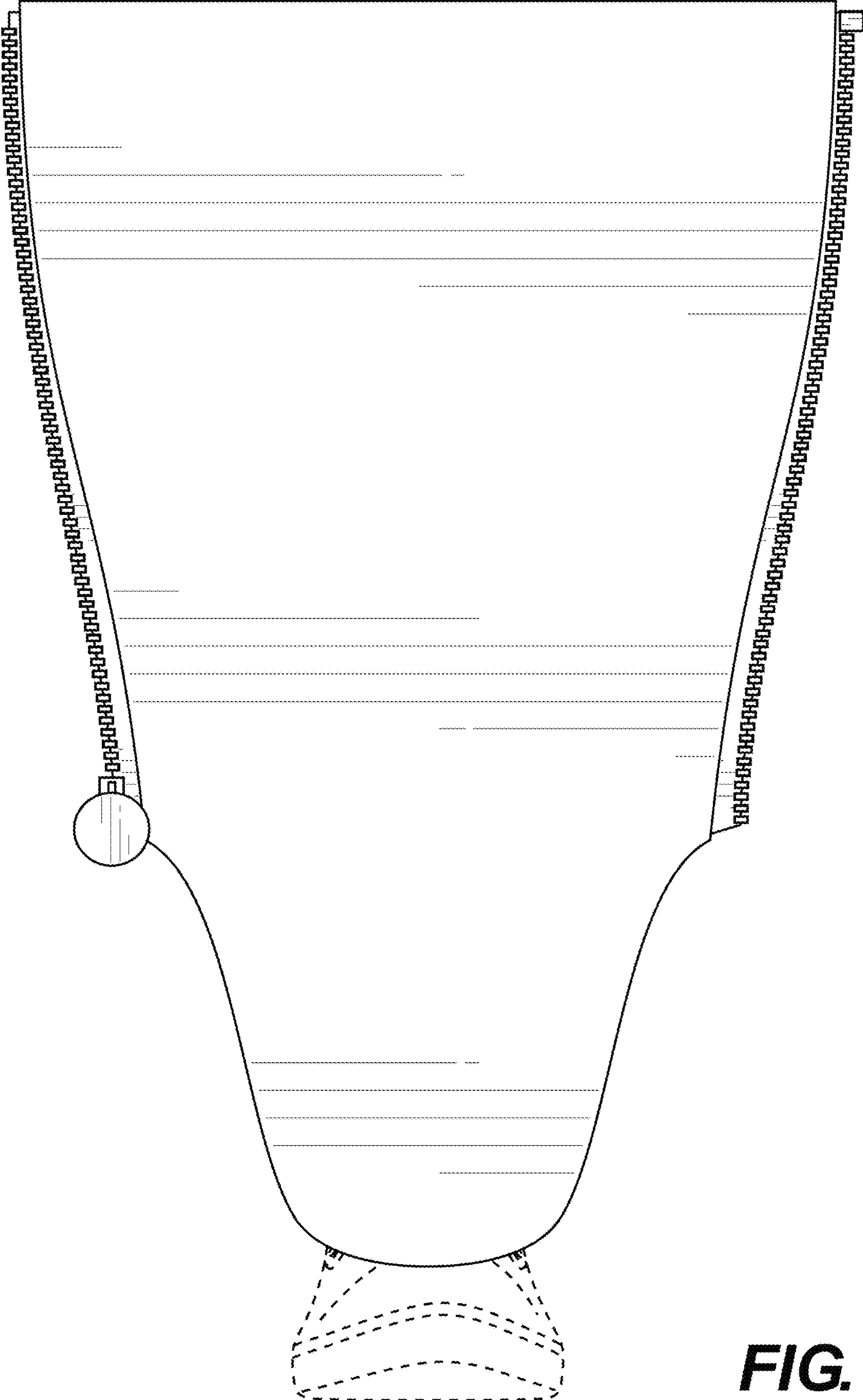

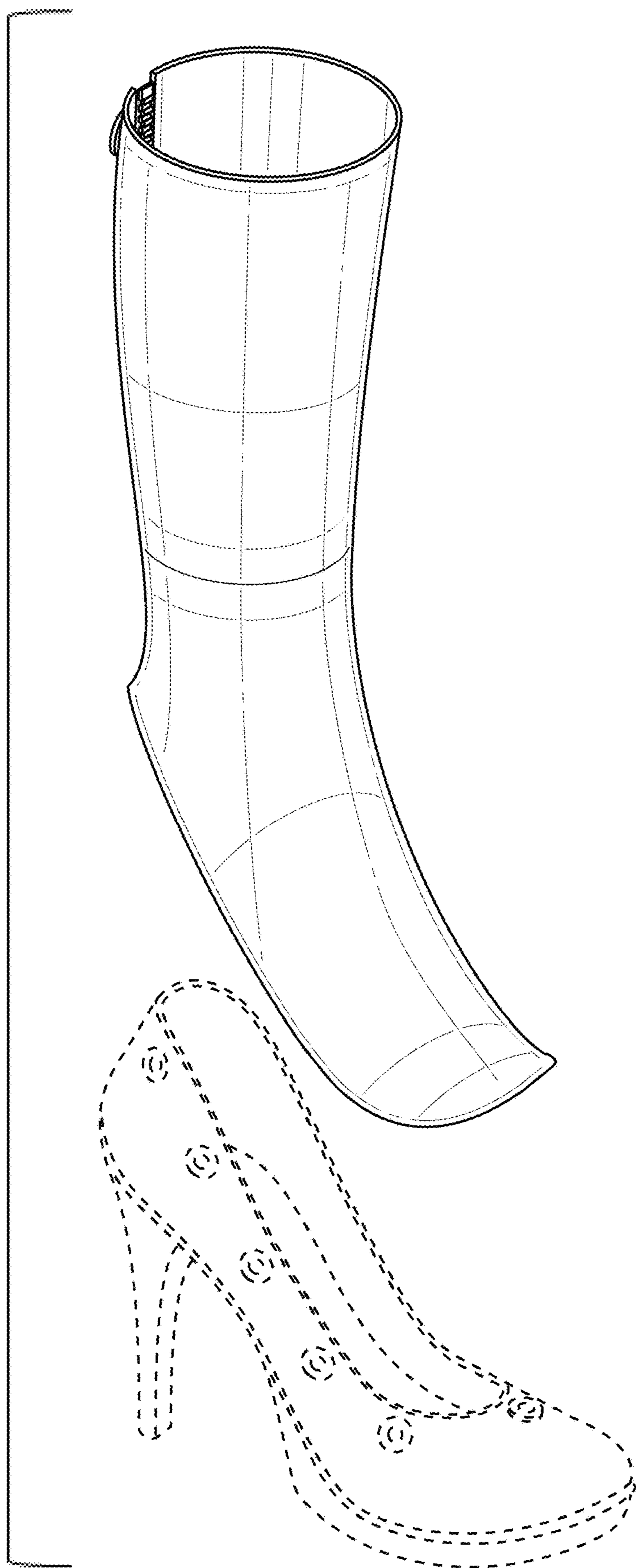

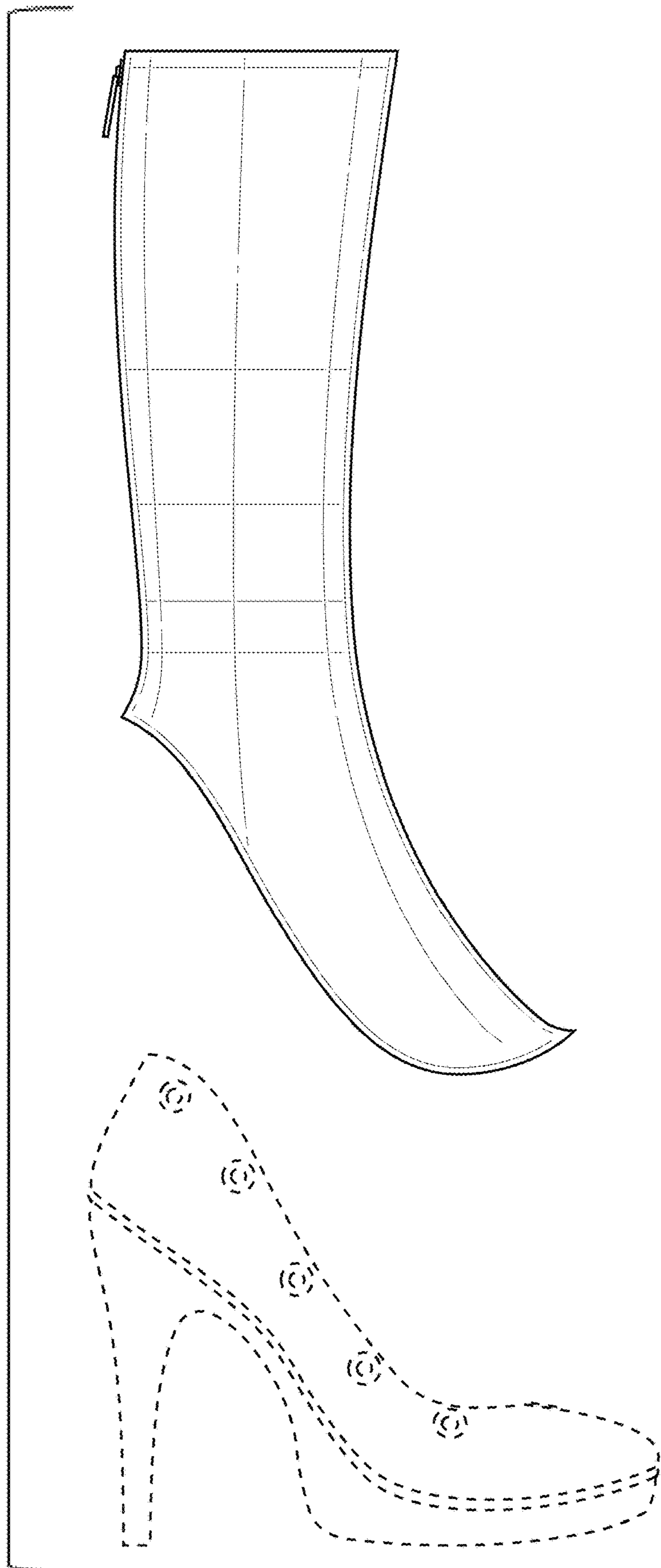

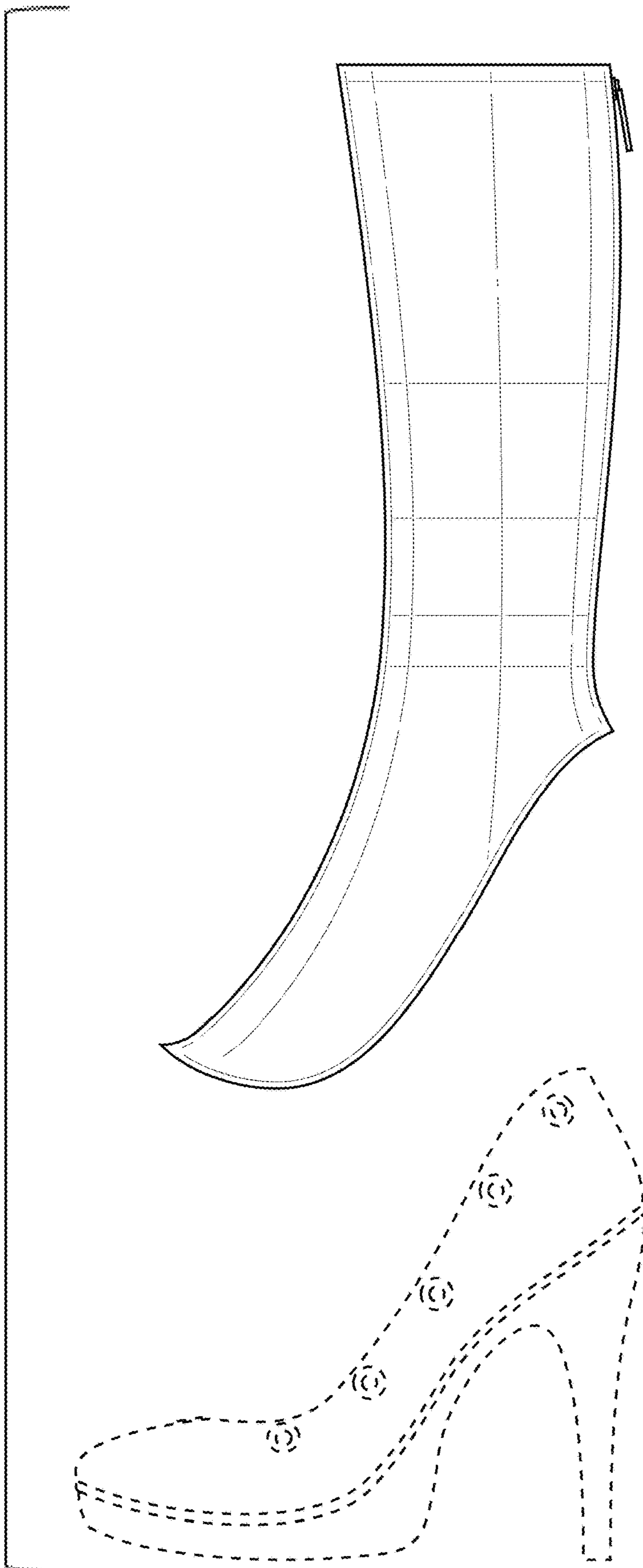

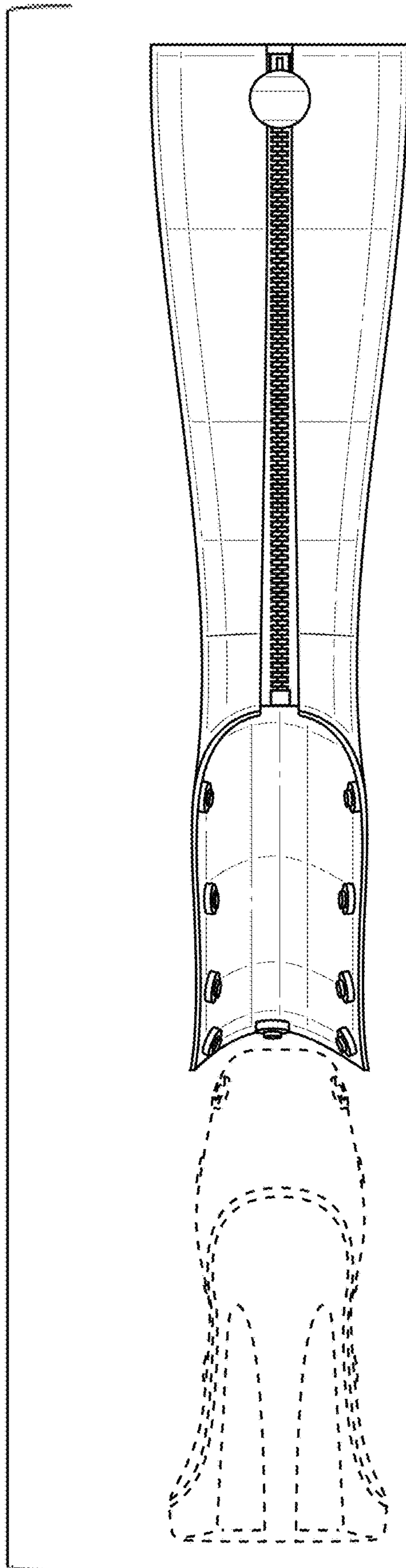

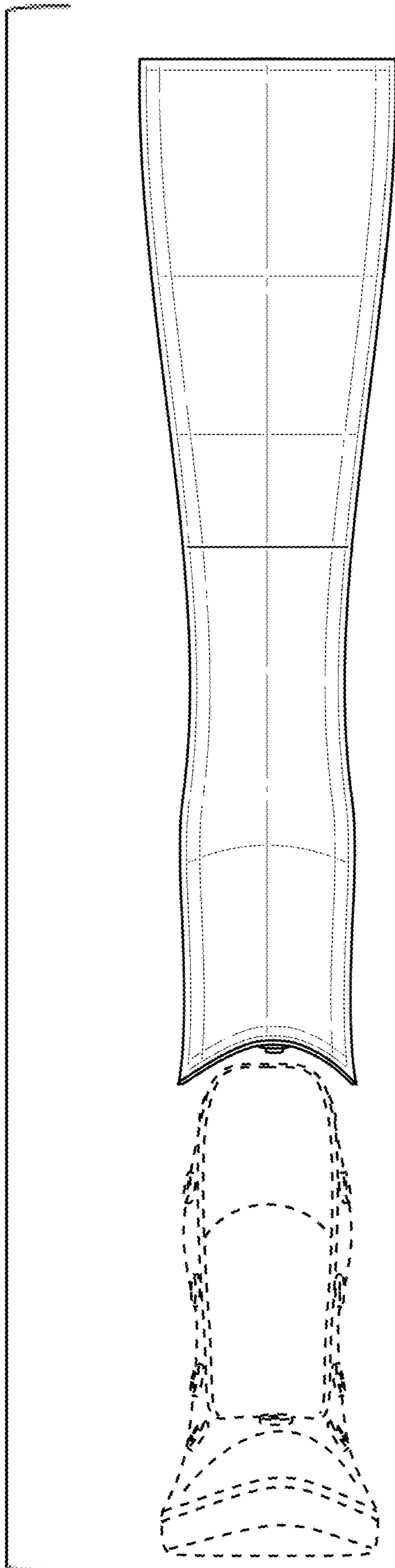

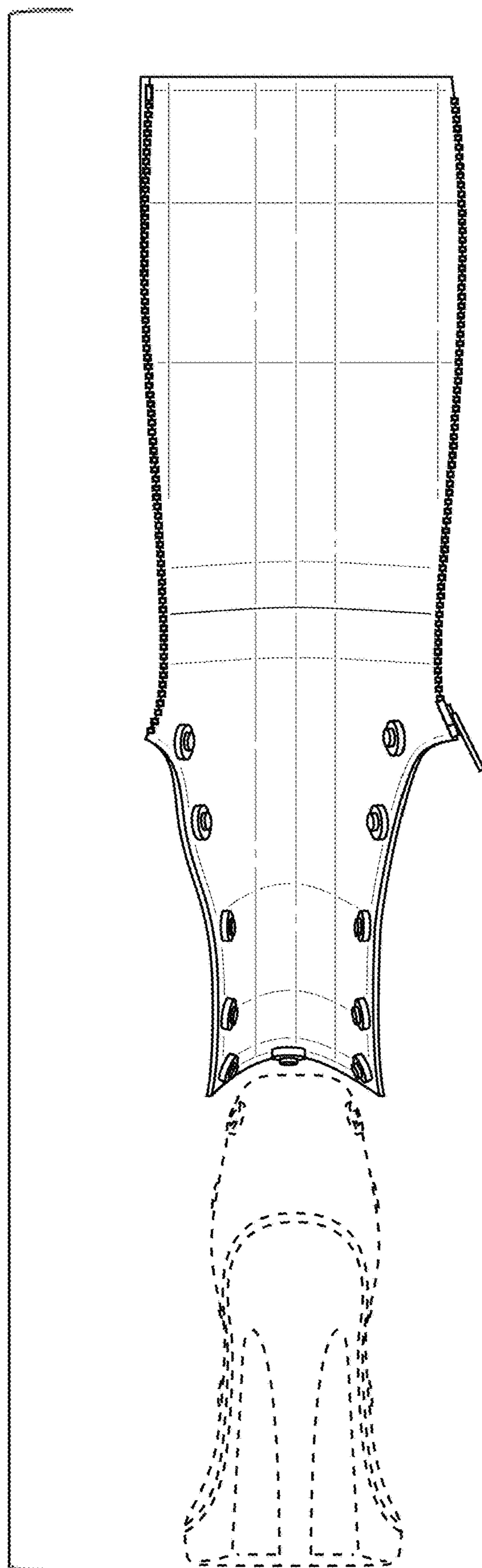

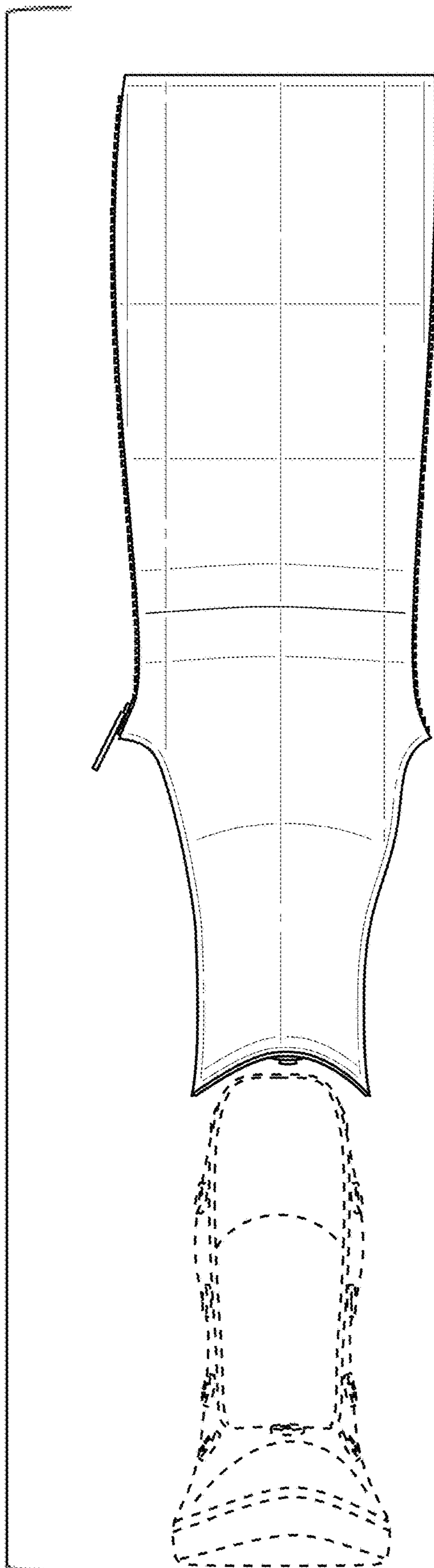
