(57) **CLAIM**

The ornamental design for an toothbrush handle thereof, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and left side perspective view of a toothbrush handle according to a first embodiment of the new design;

FIG. 13 is a left side elevation view thereof;

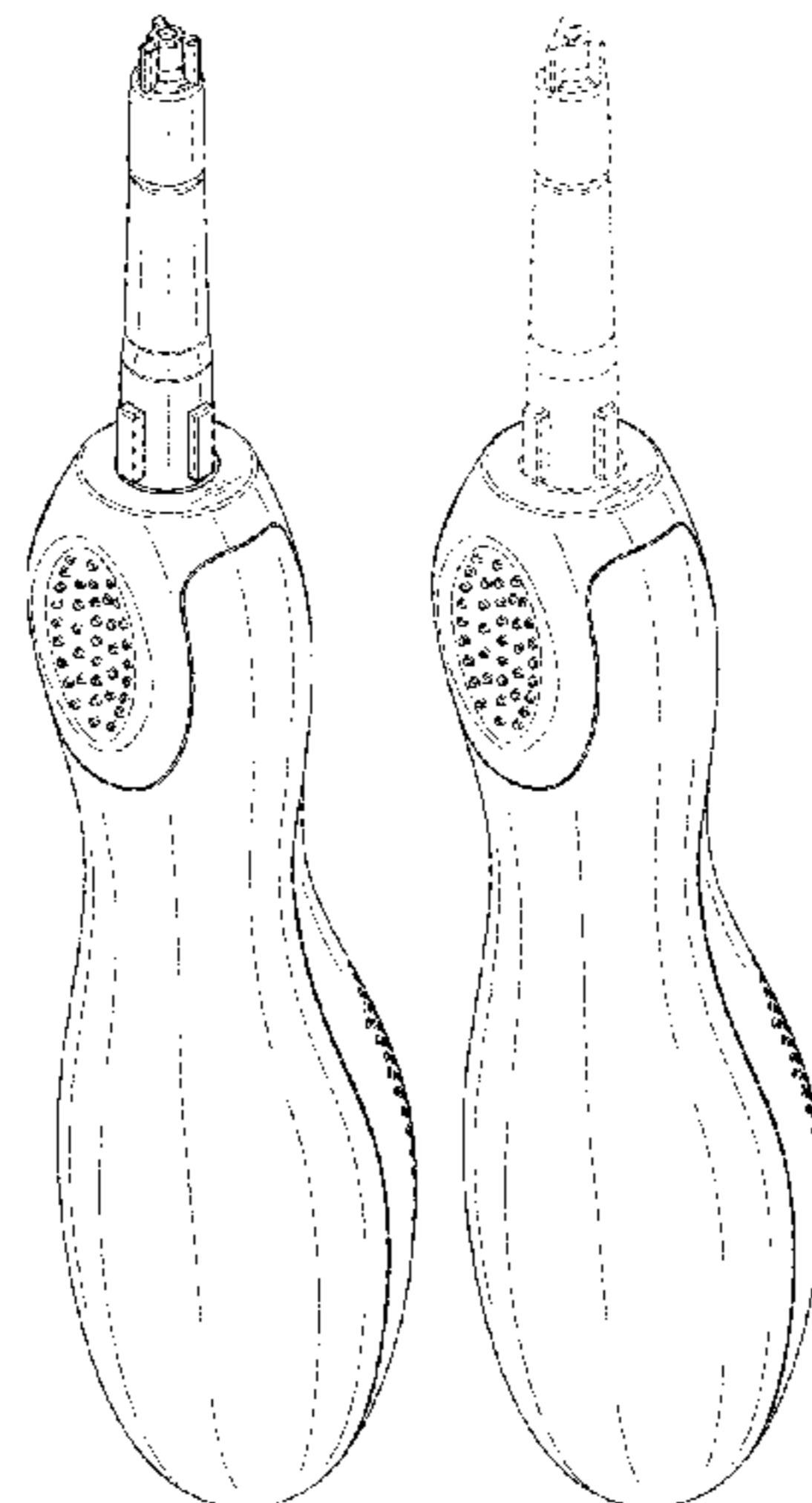
FIG. 14 is a right side elevation view thereof;

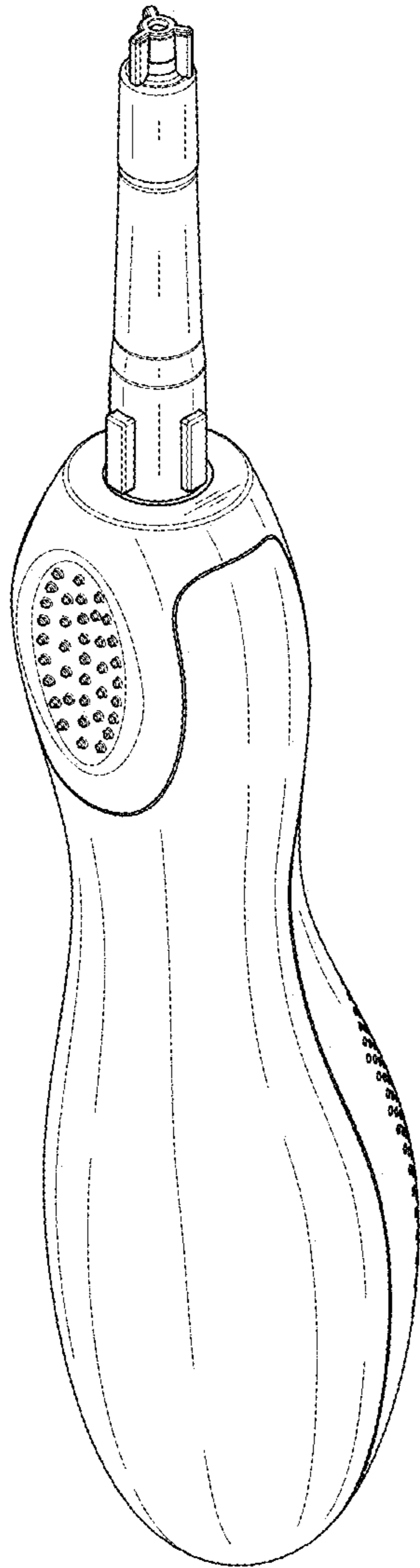

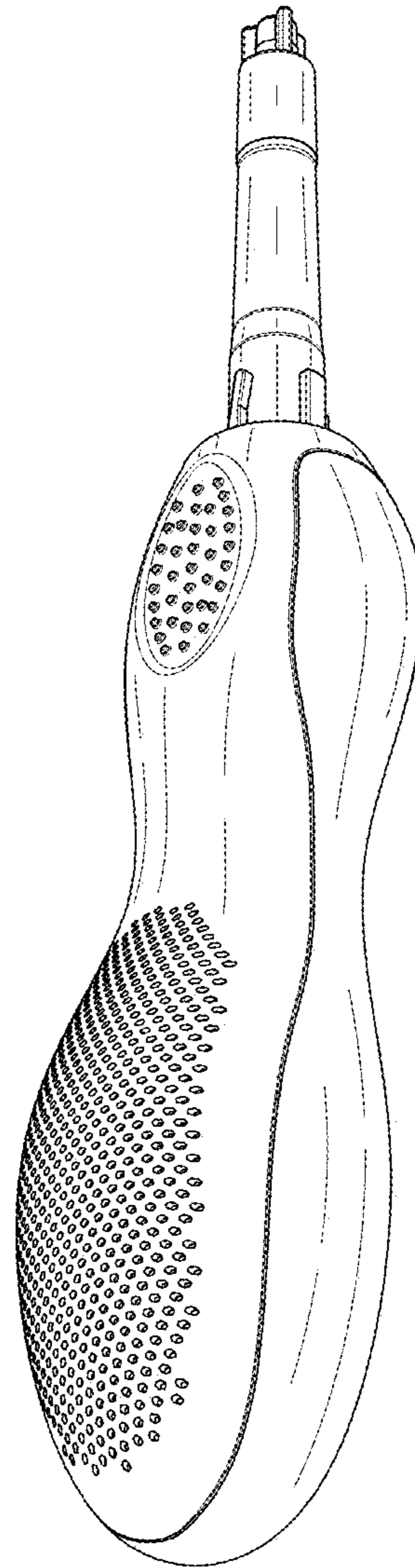

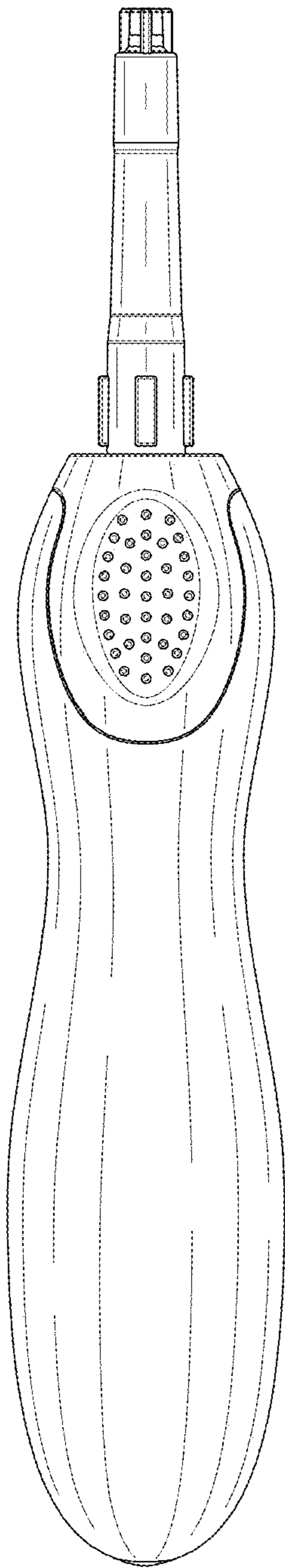

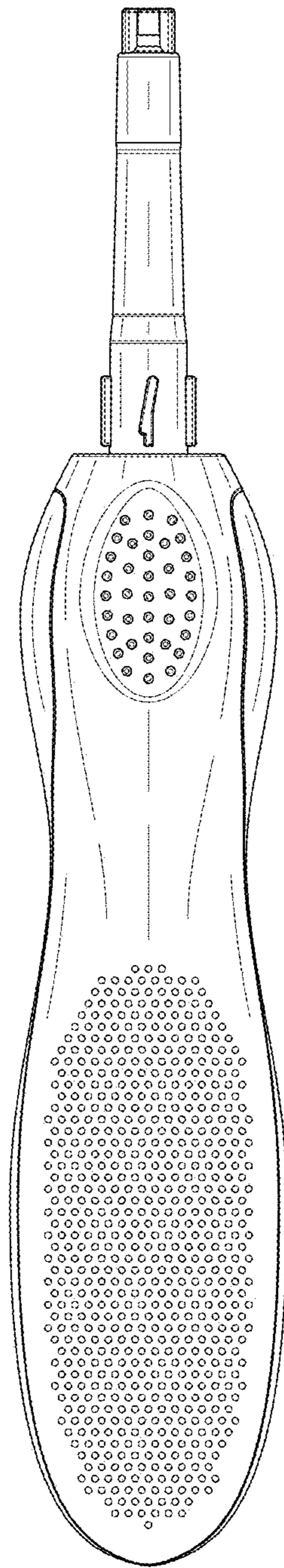

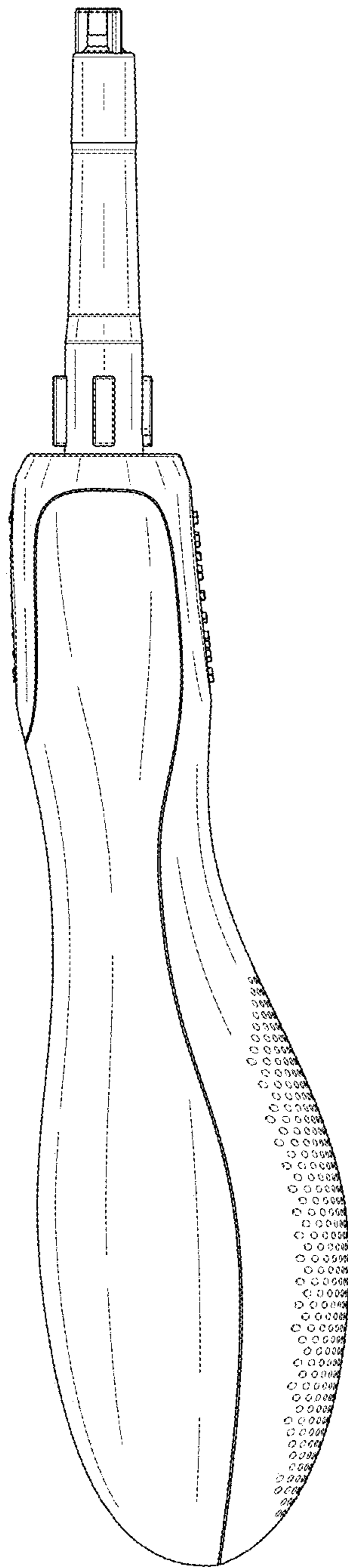

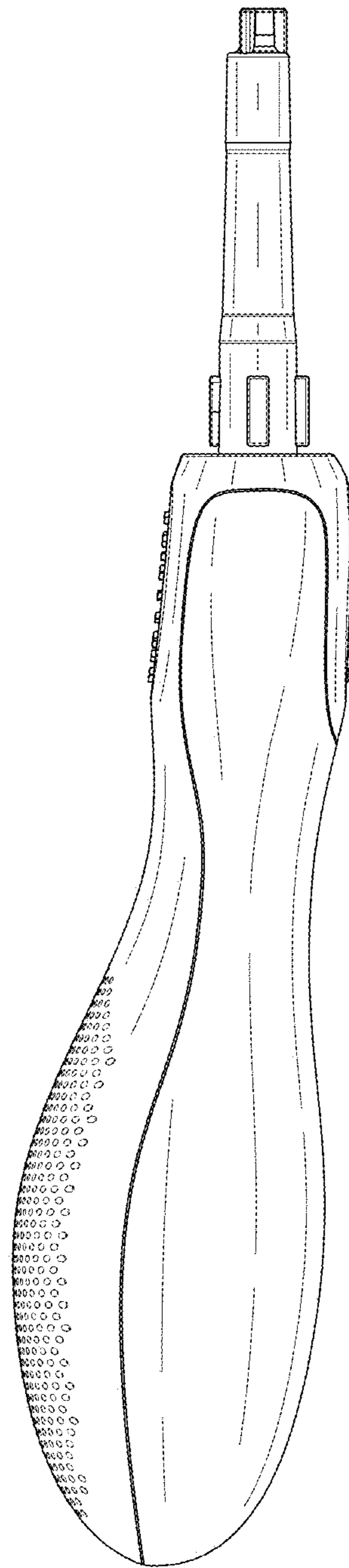

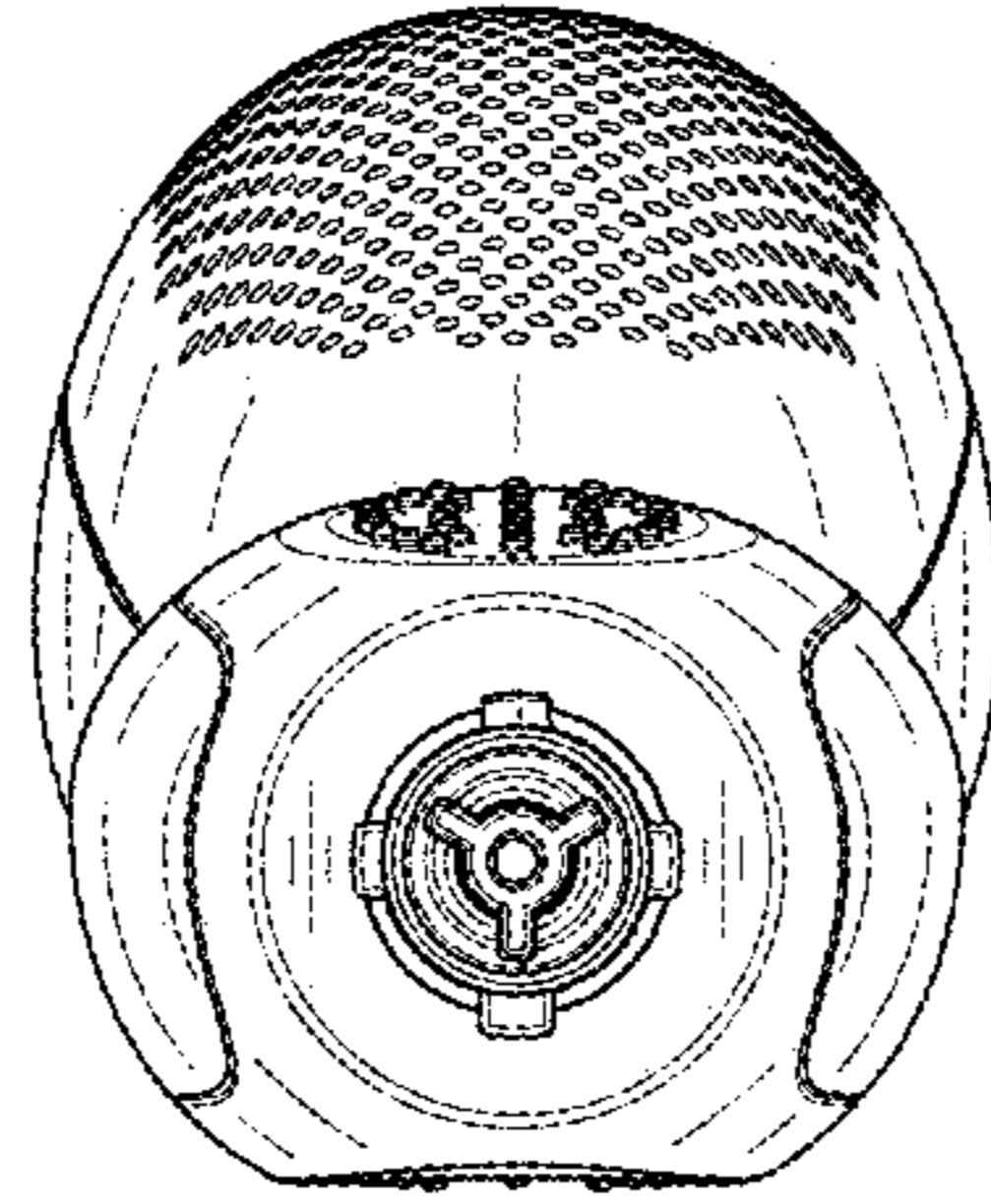

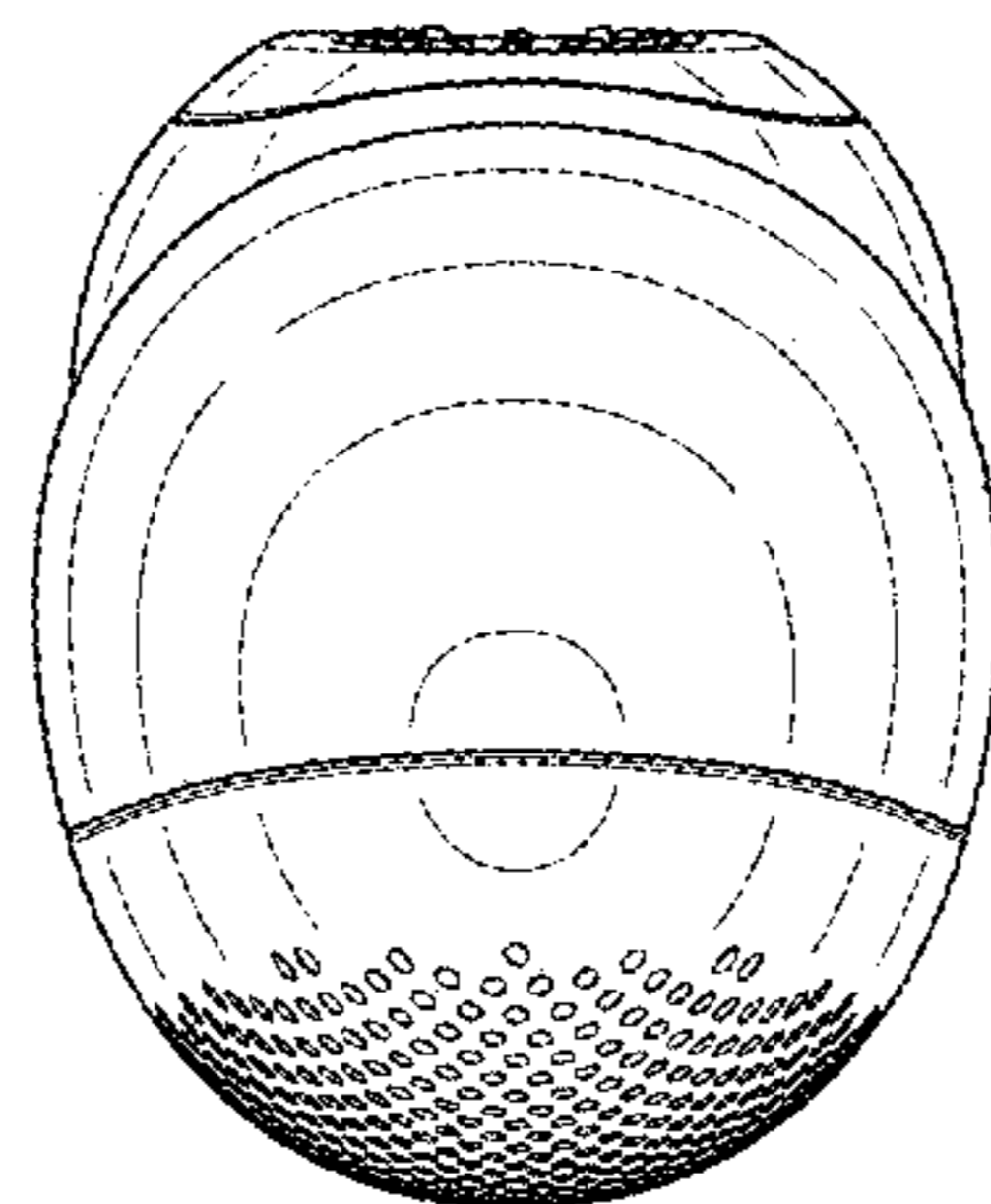

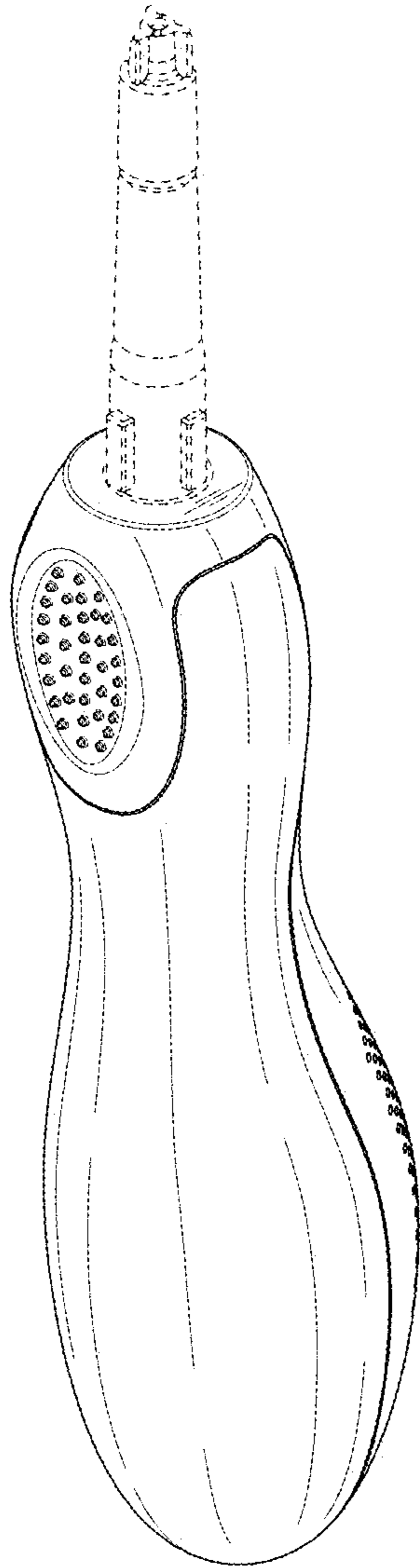

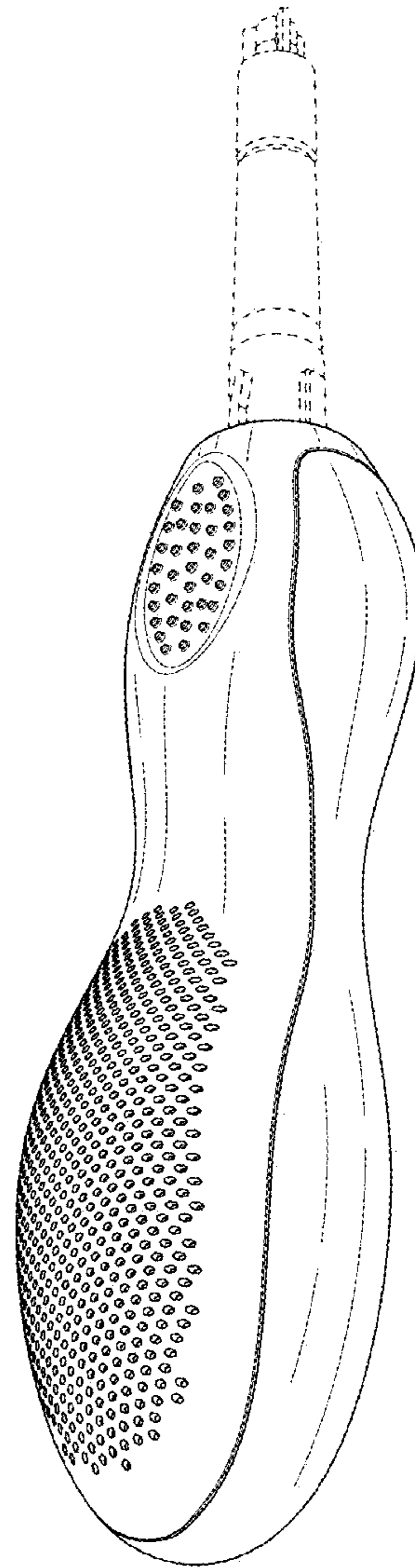

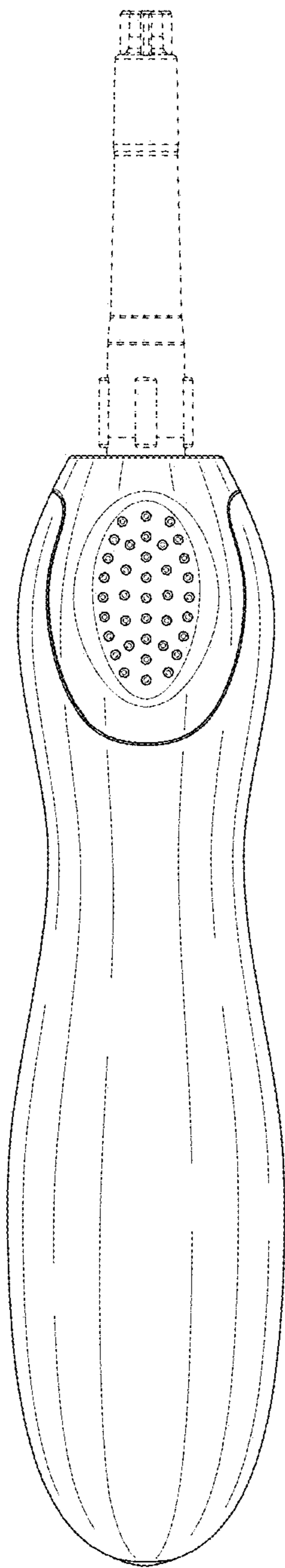

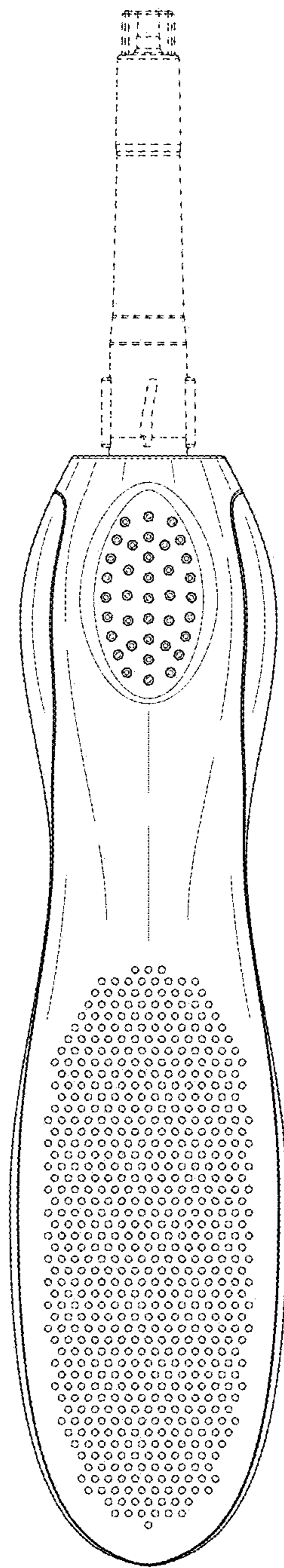

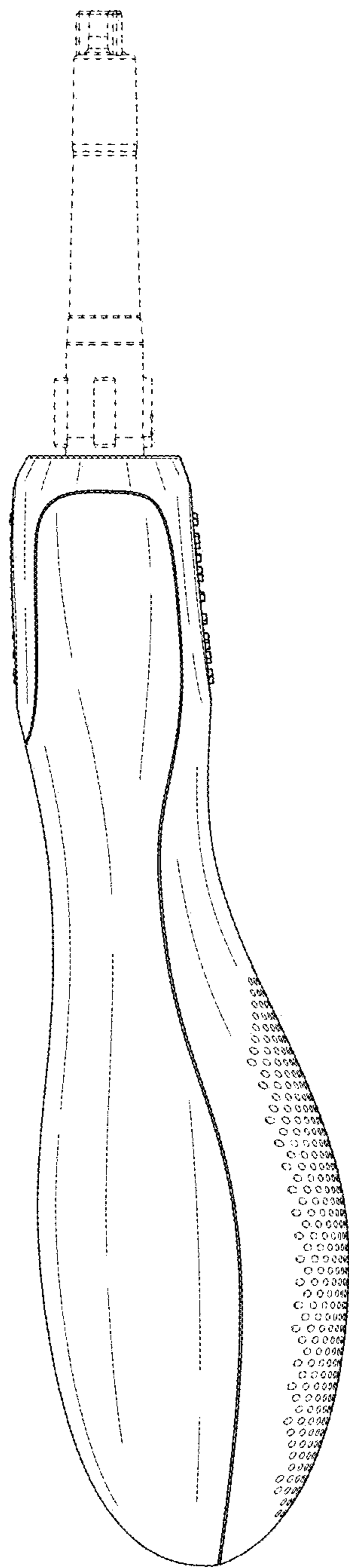

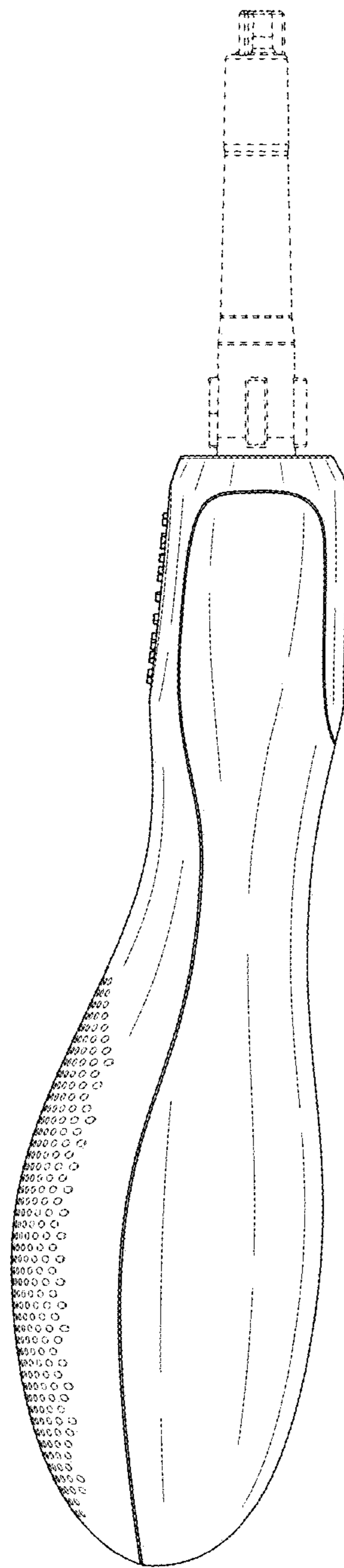

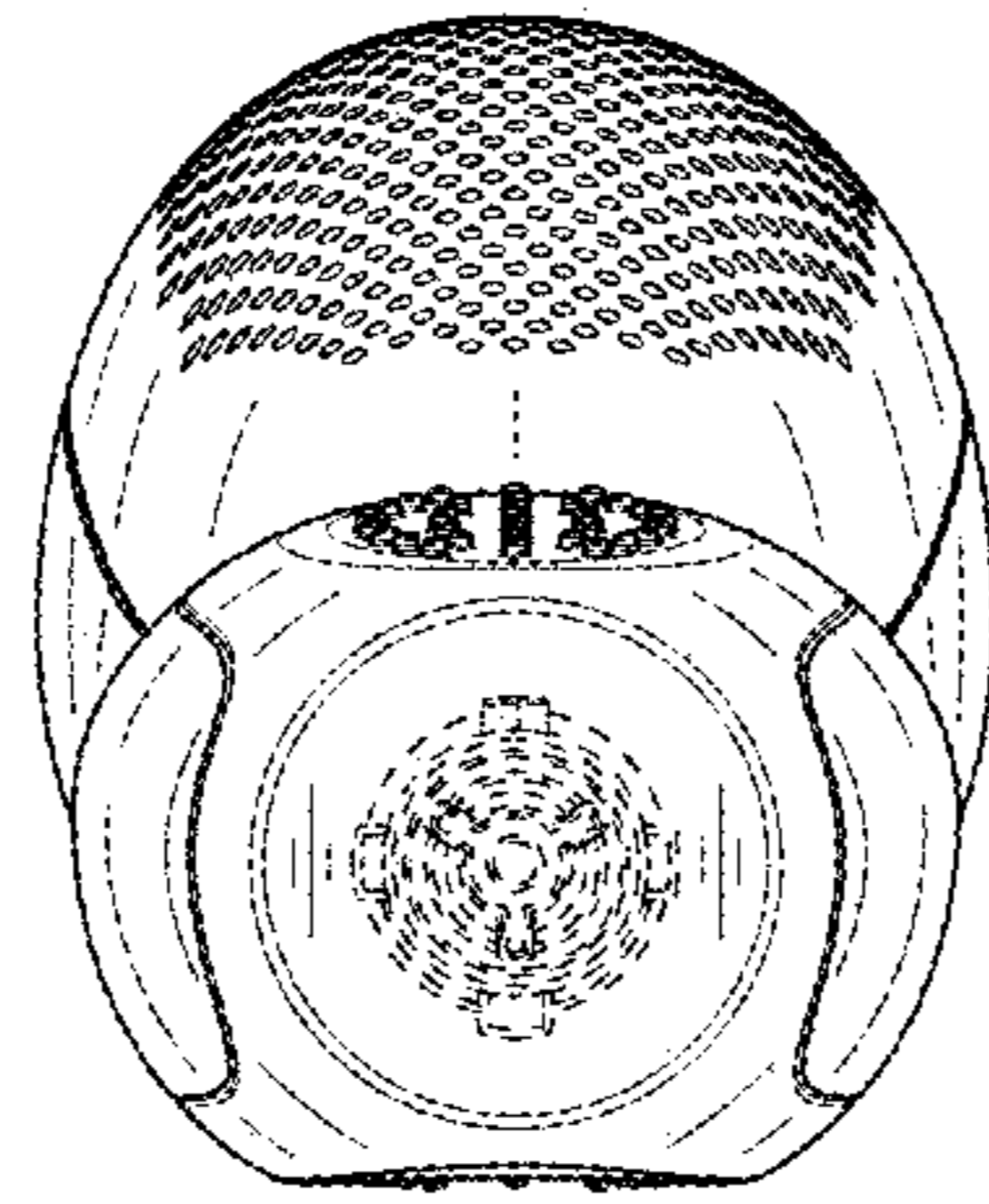

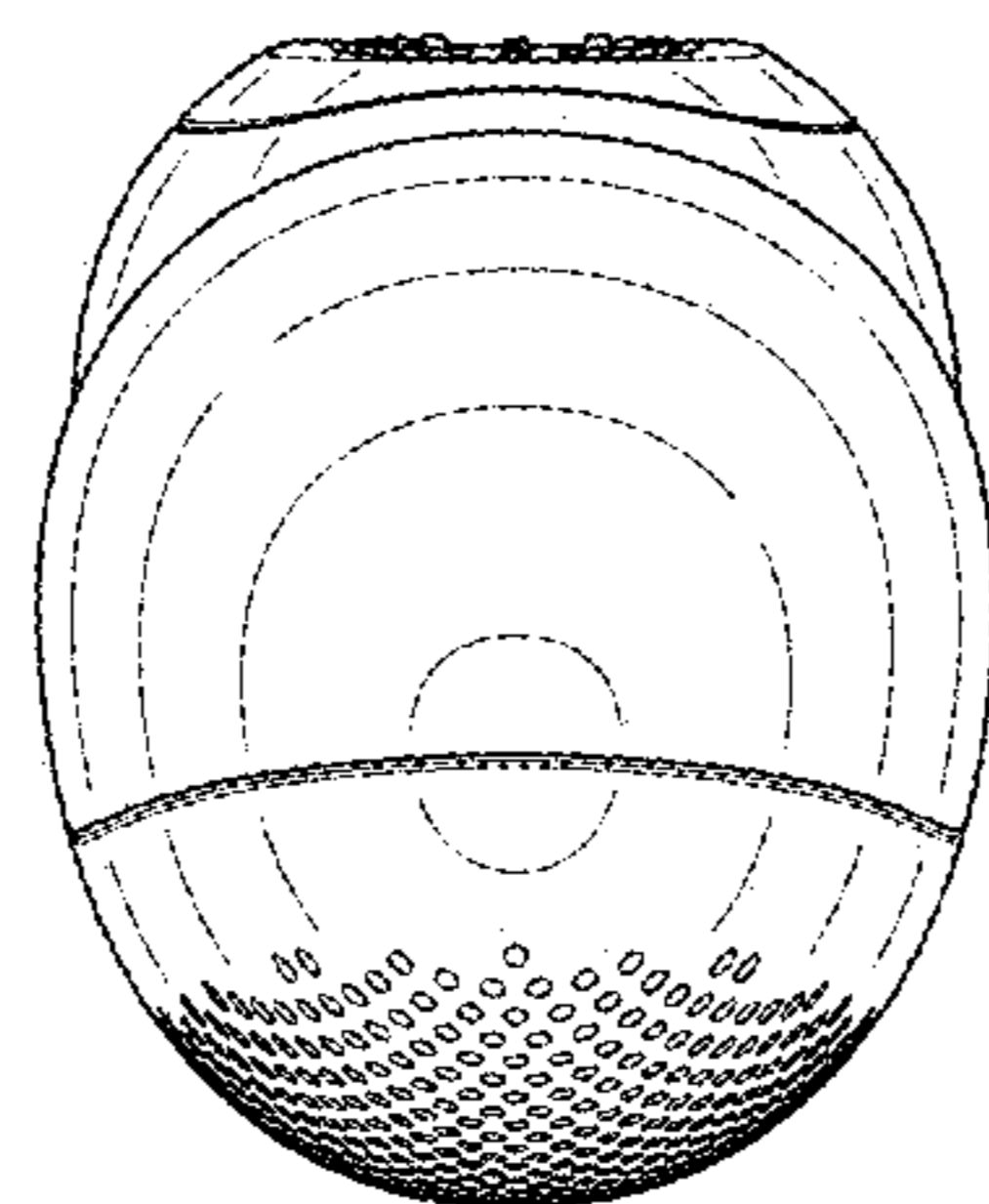
