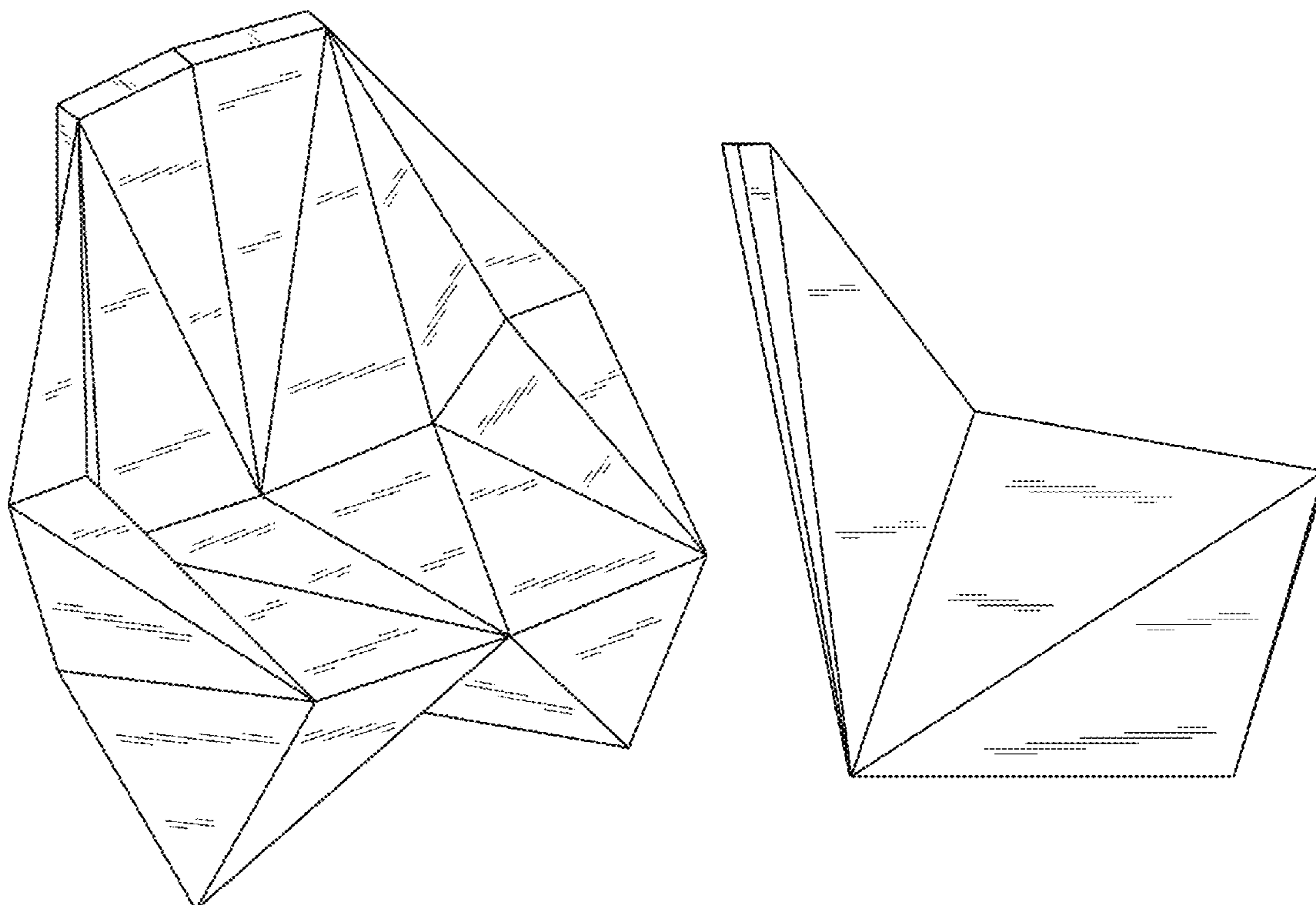
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of a lounge chair according to the present invention;  
FIG. 2 is a front elevational view thereof;

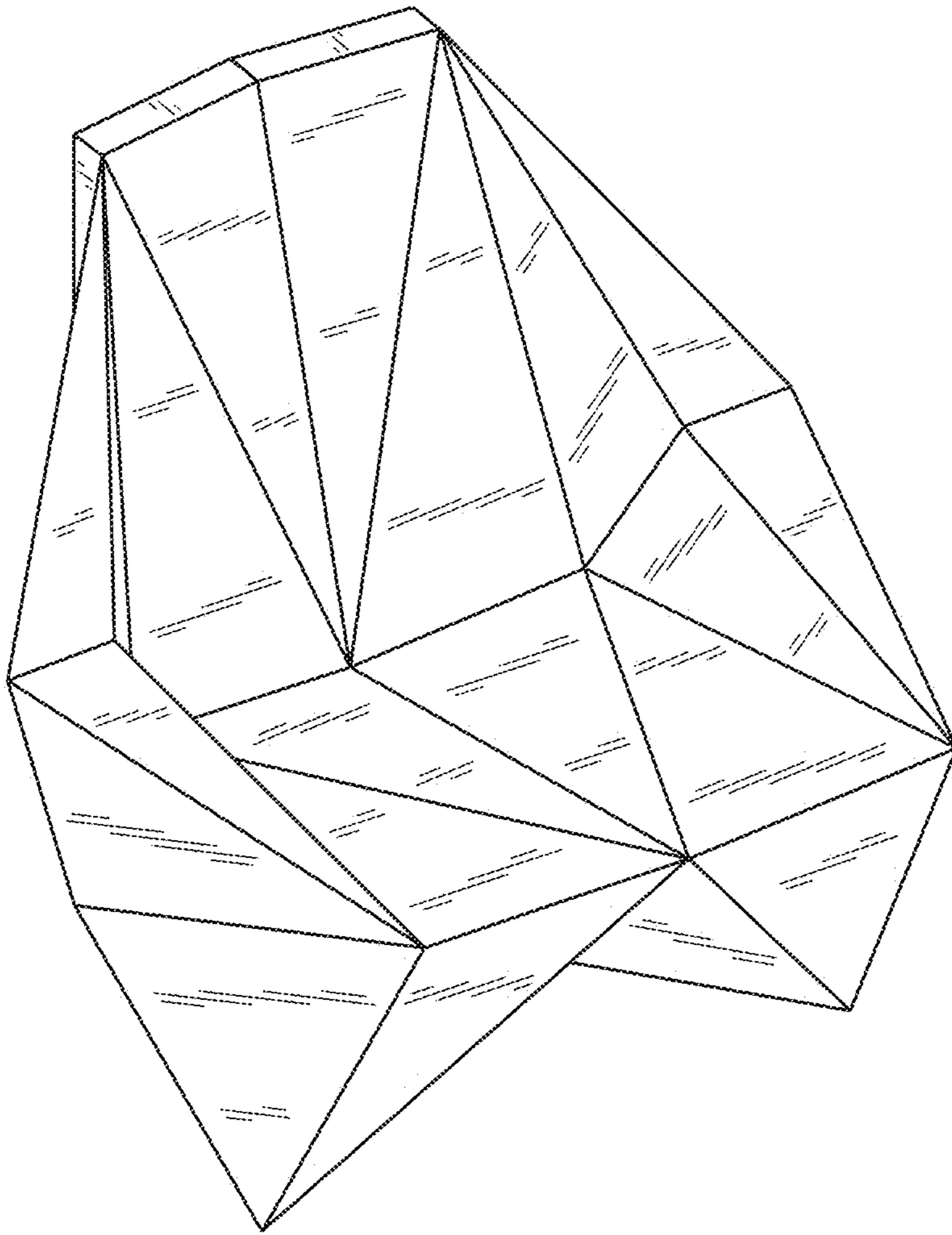

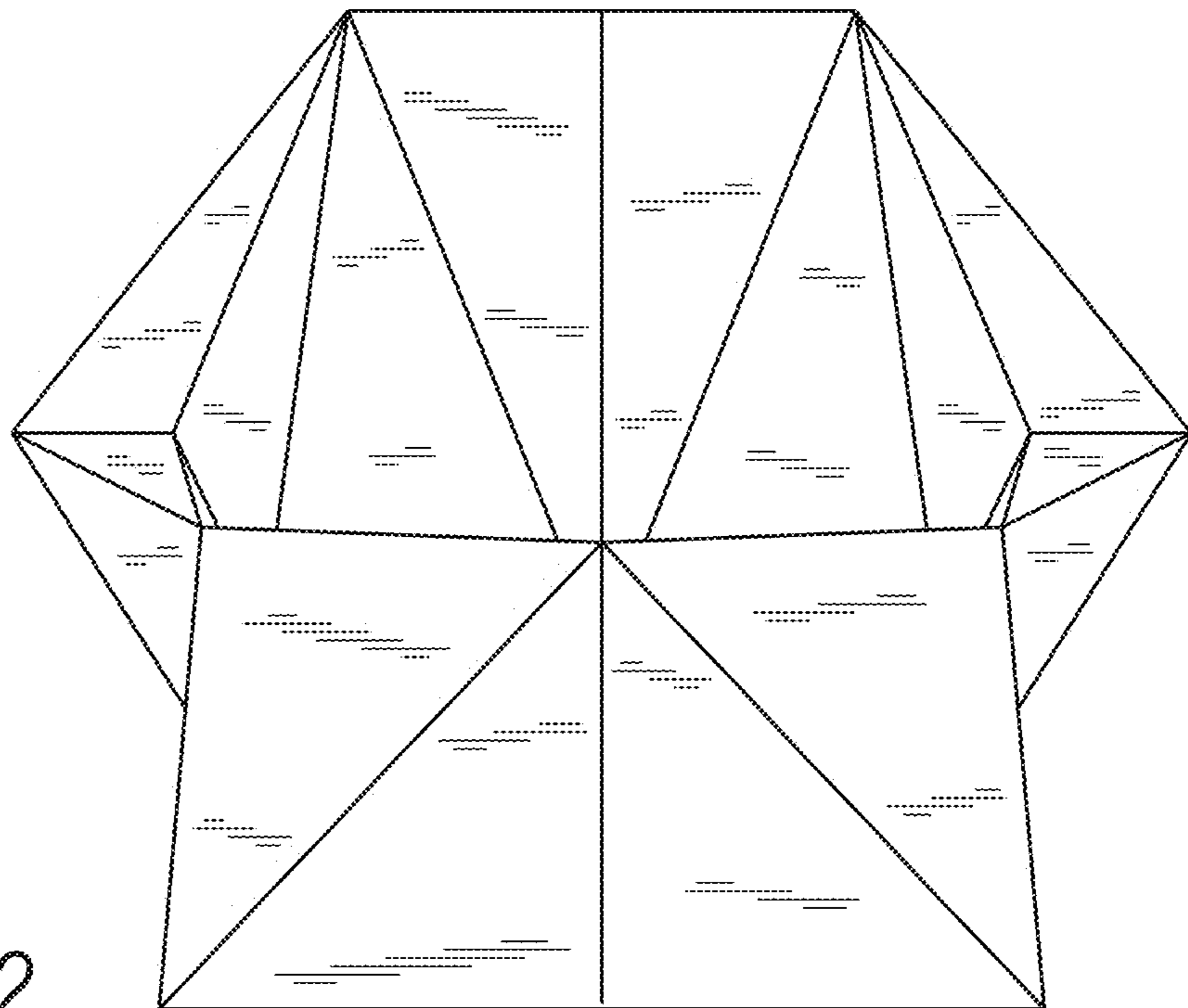

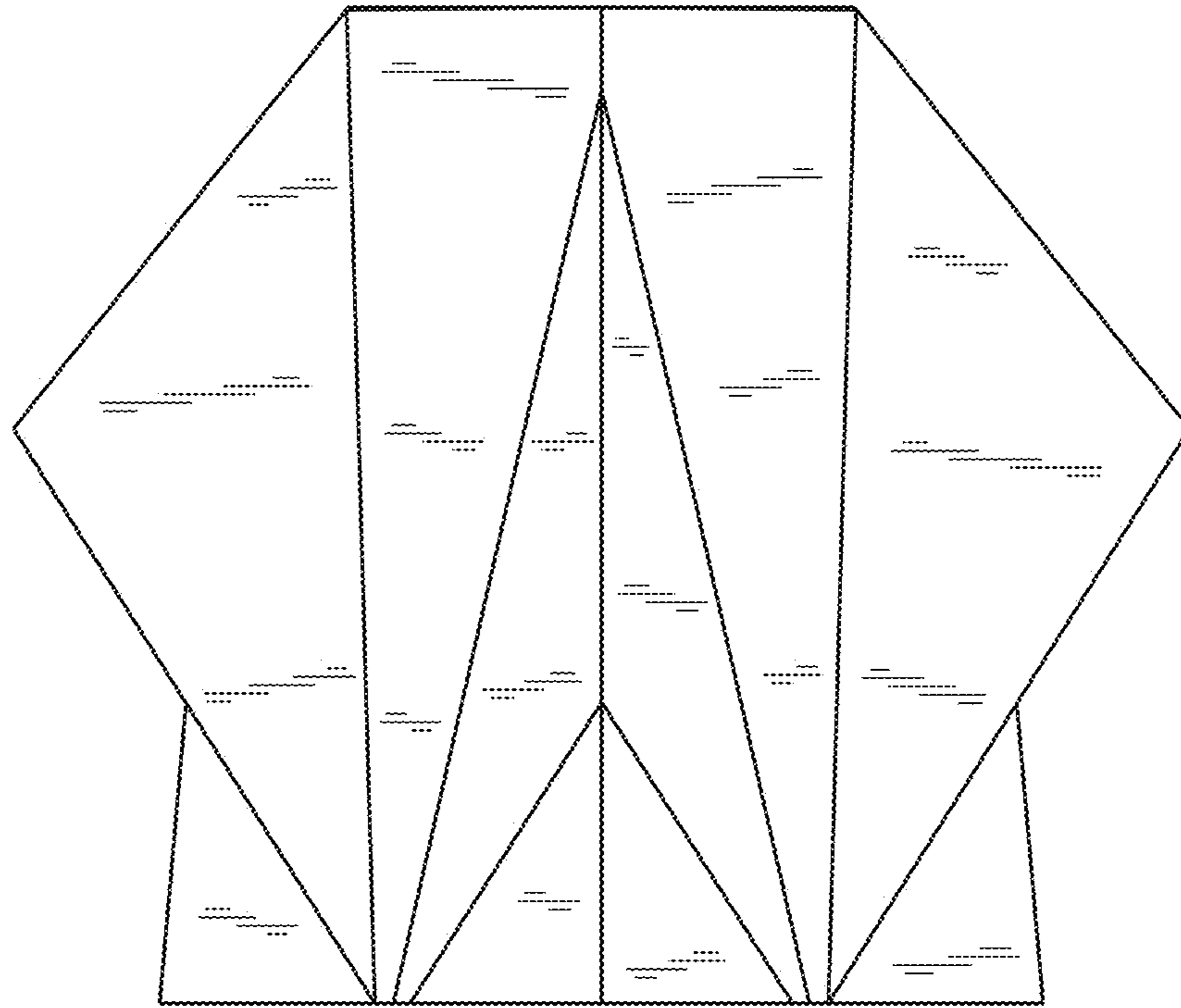

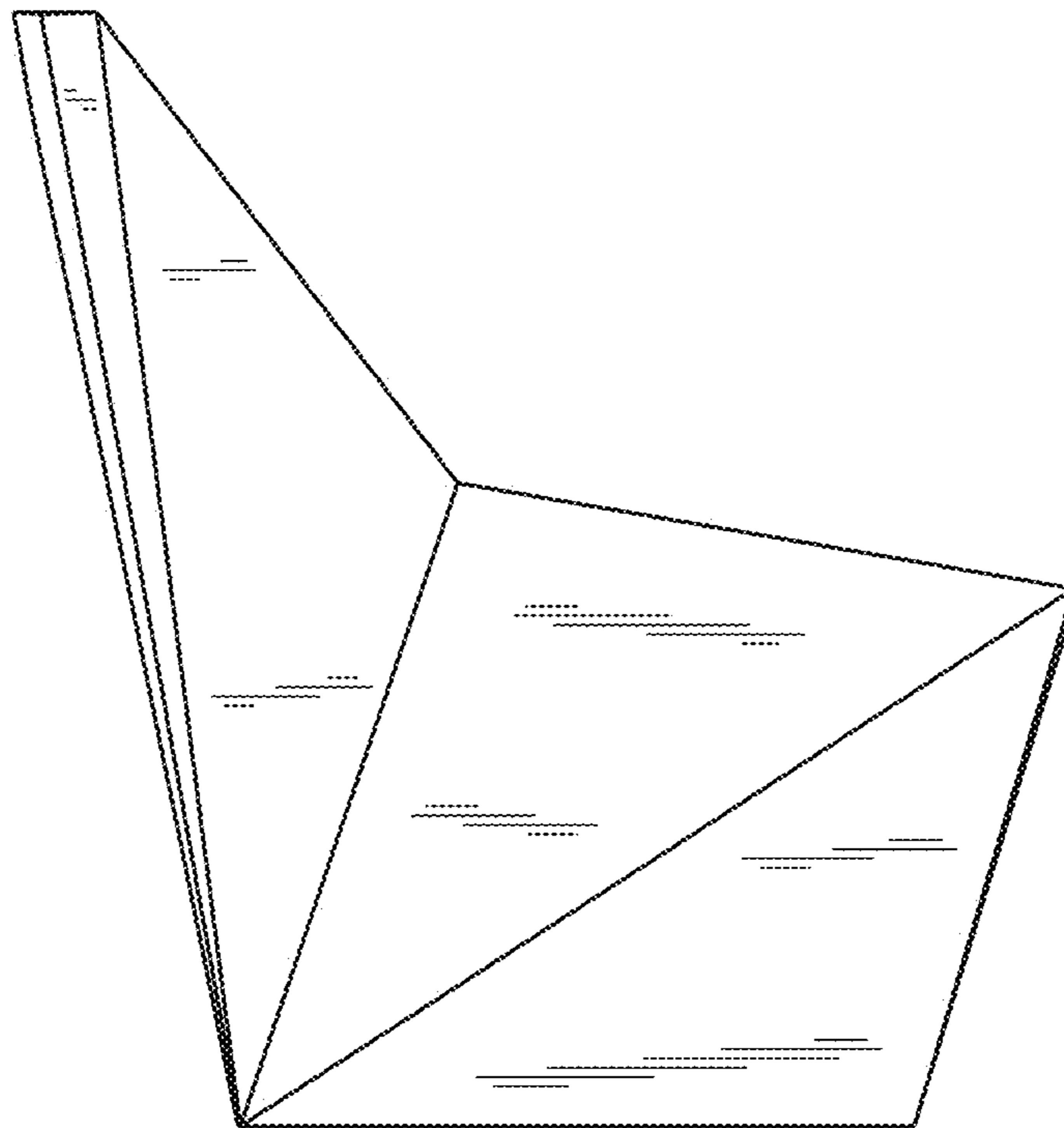

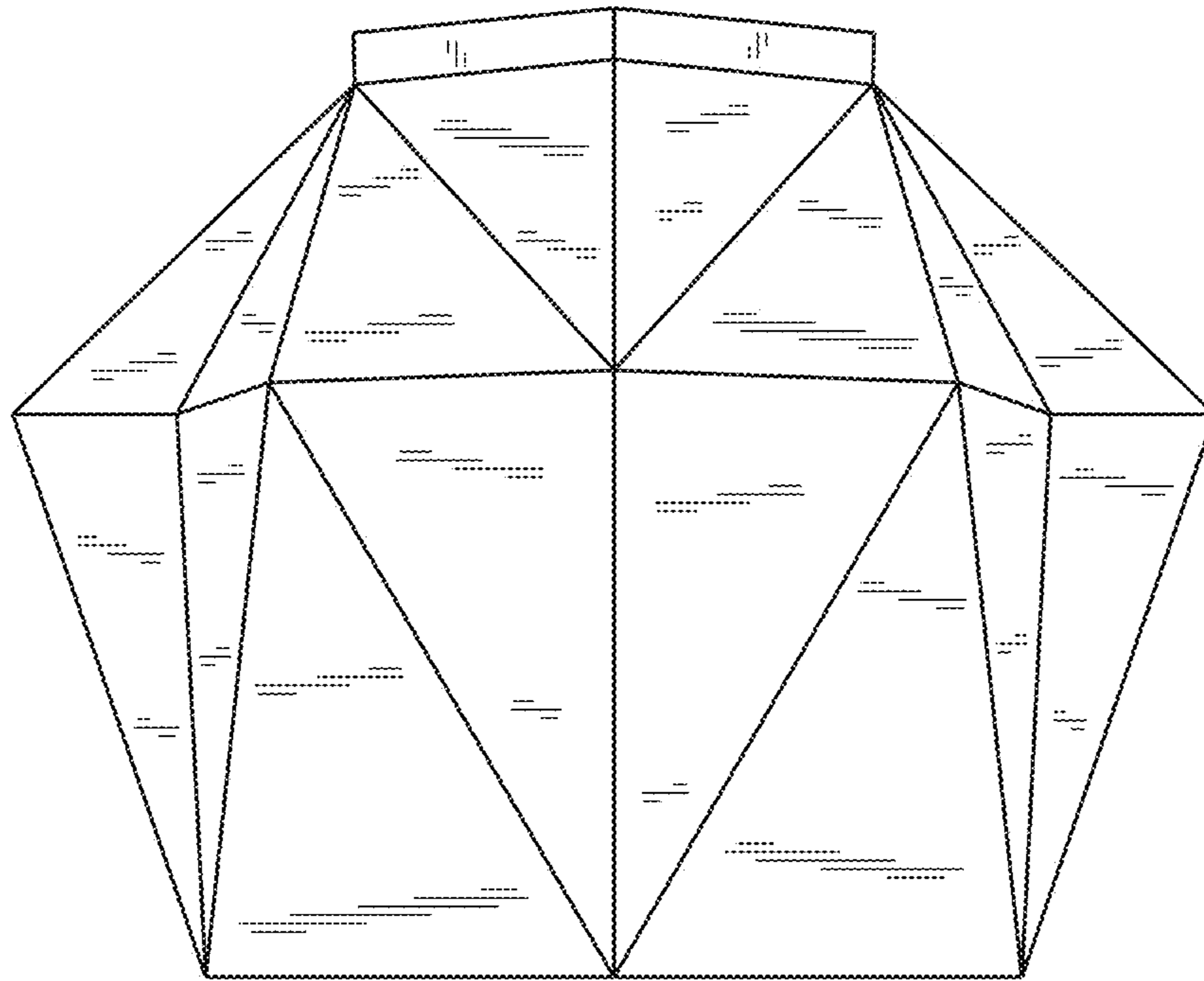

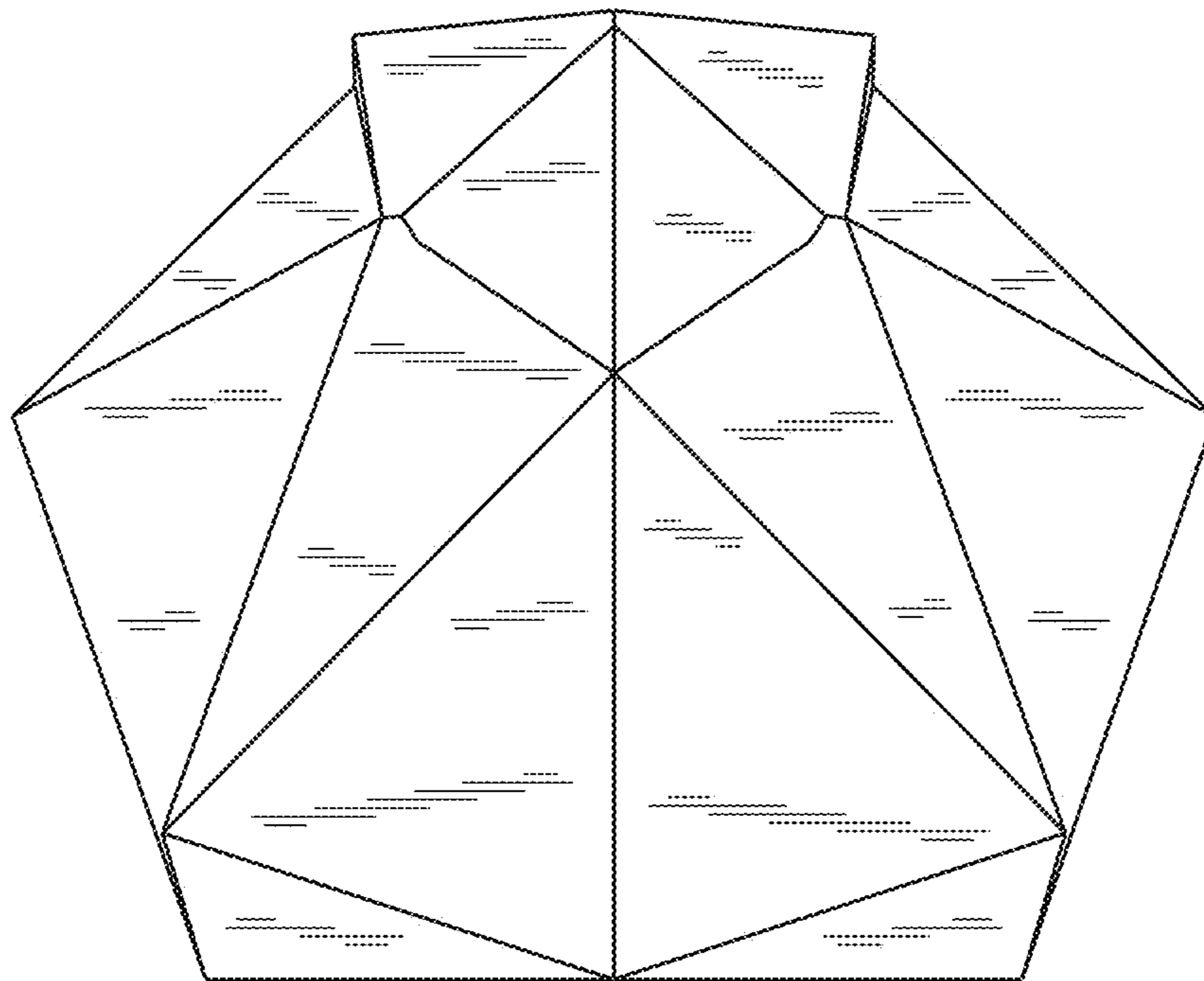
