DESCRIPTION

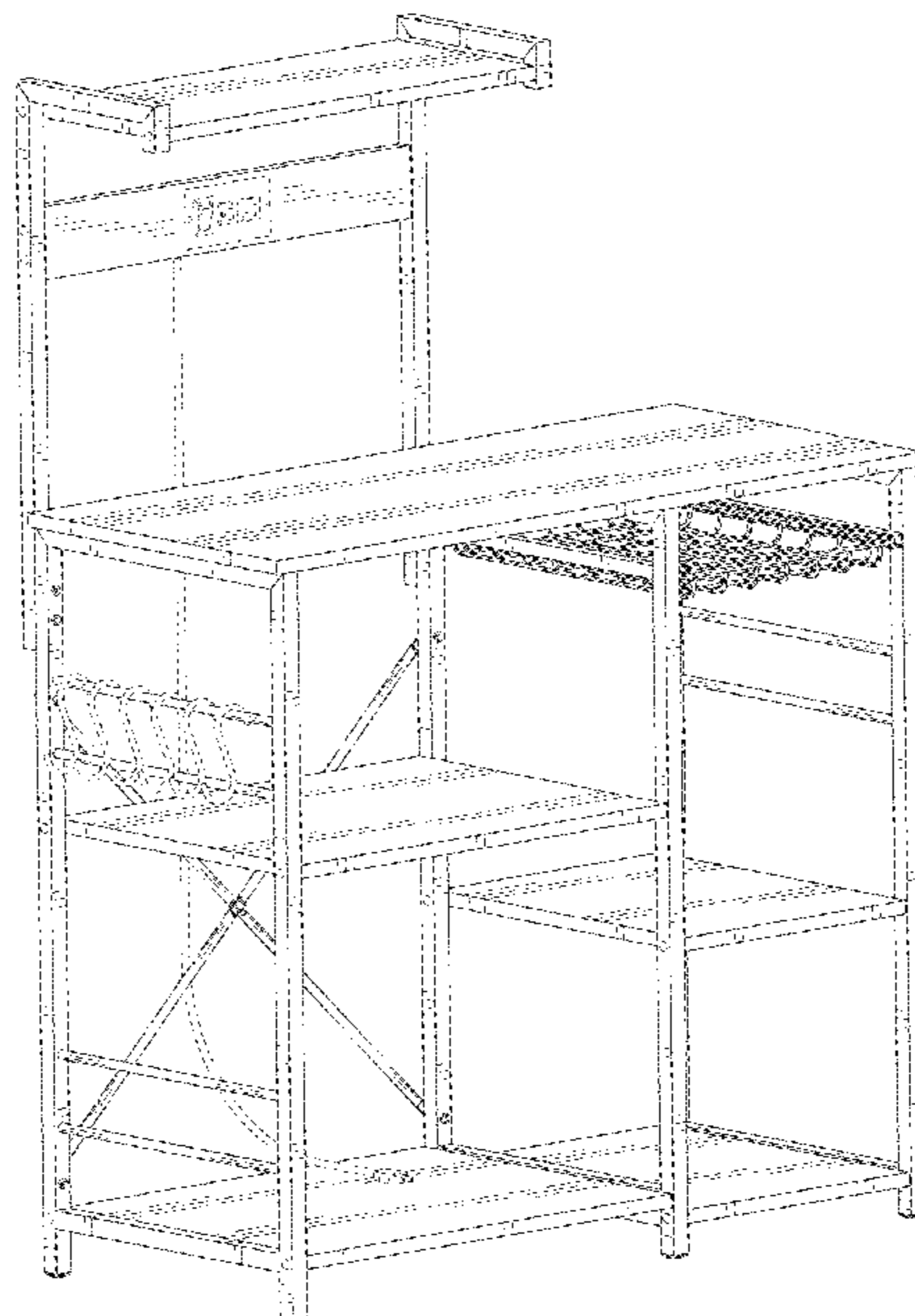
FIG. 1 is a front, left perspective view of a baker's rack showing my new design;

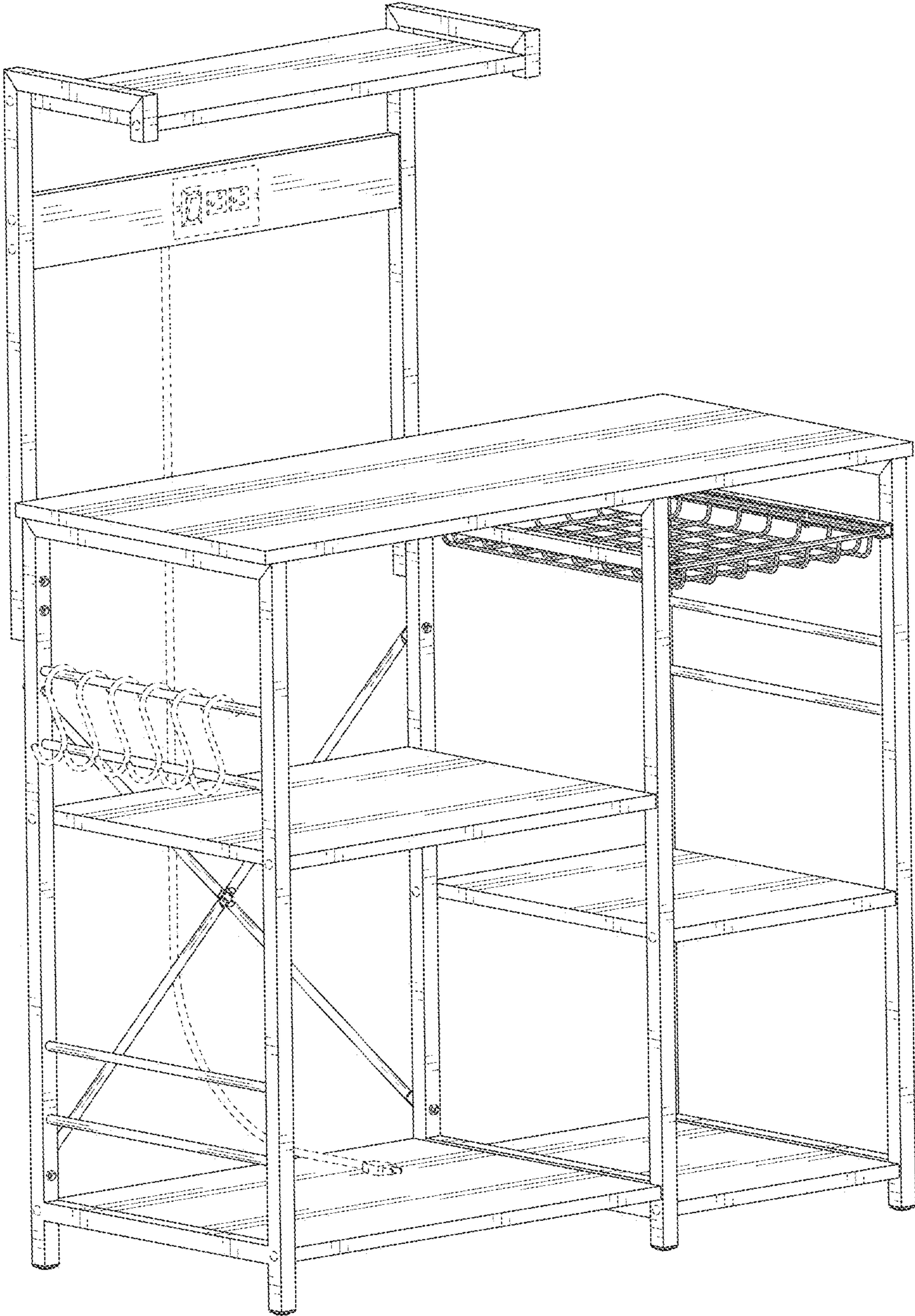

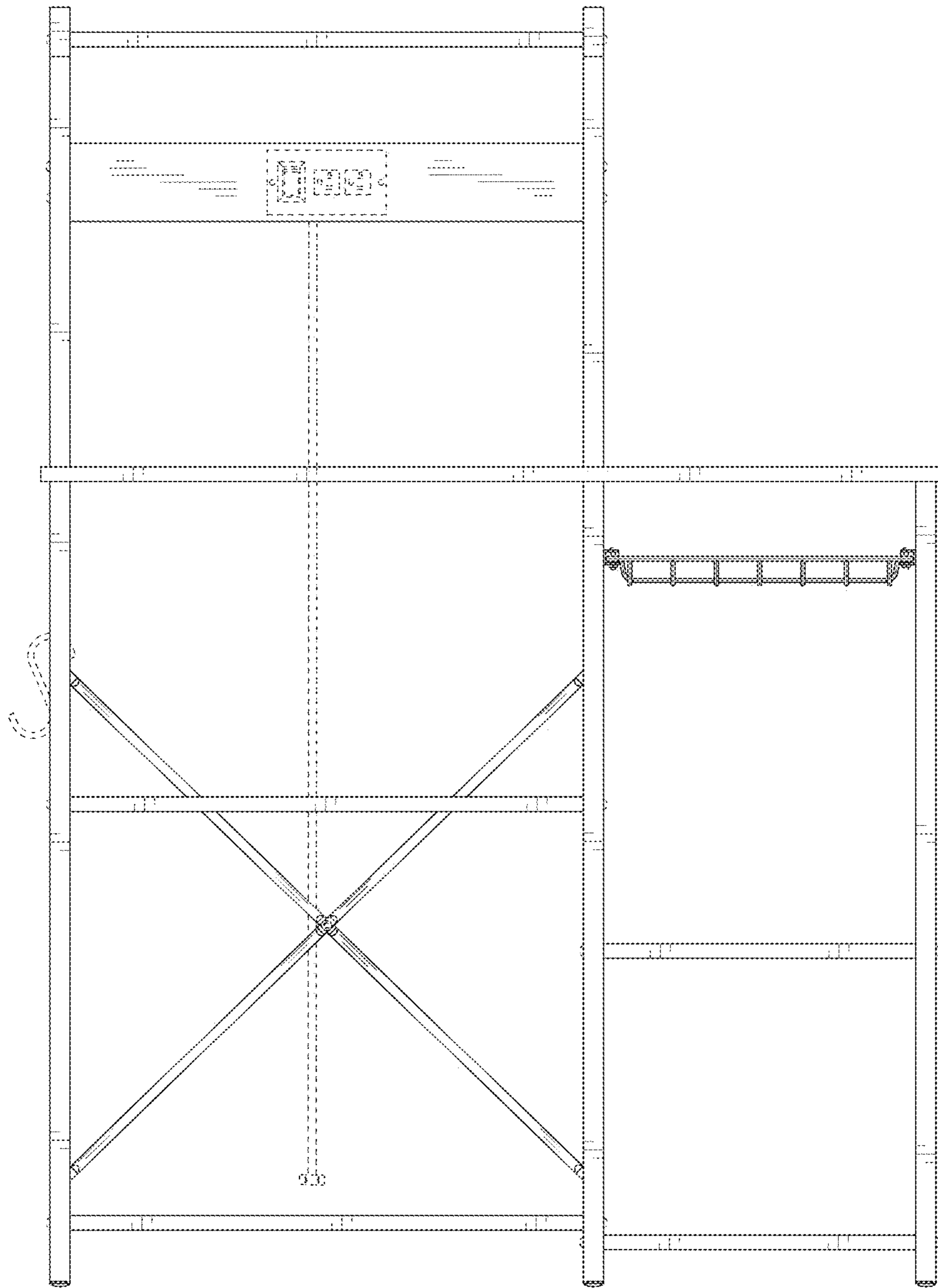

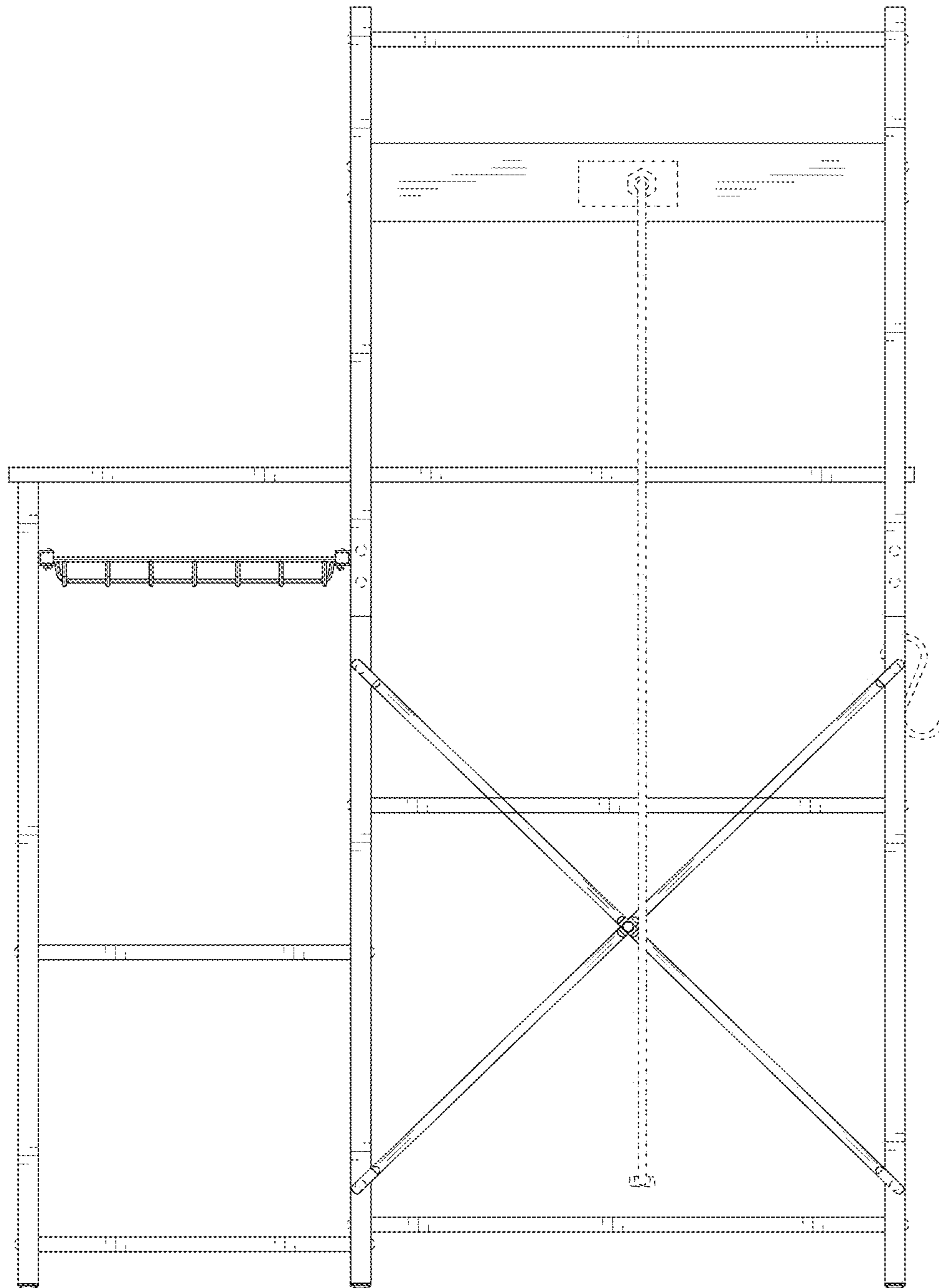

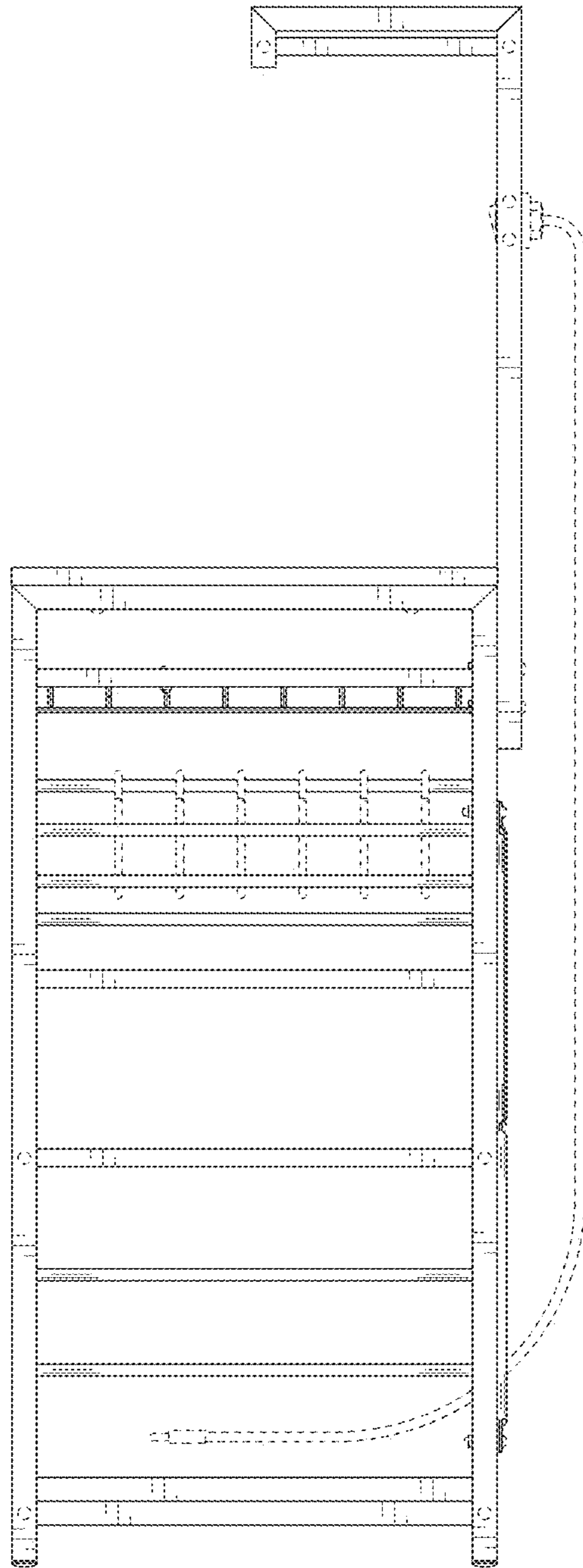

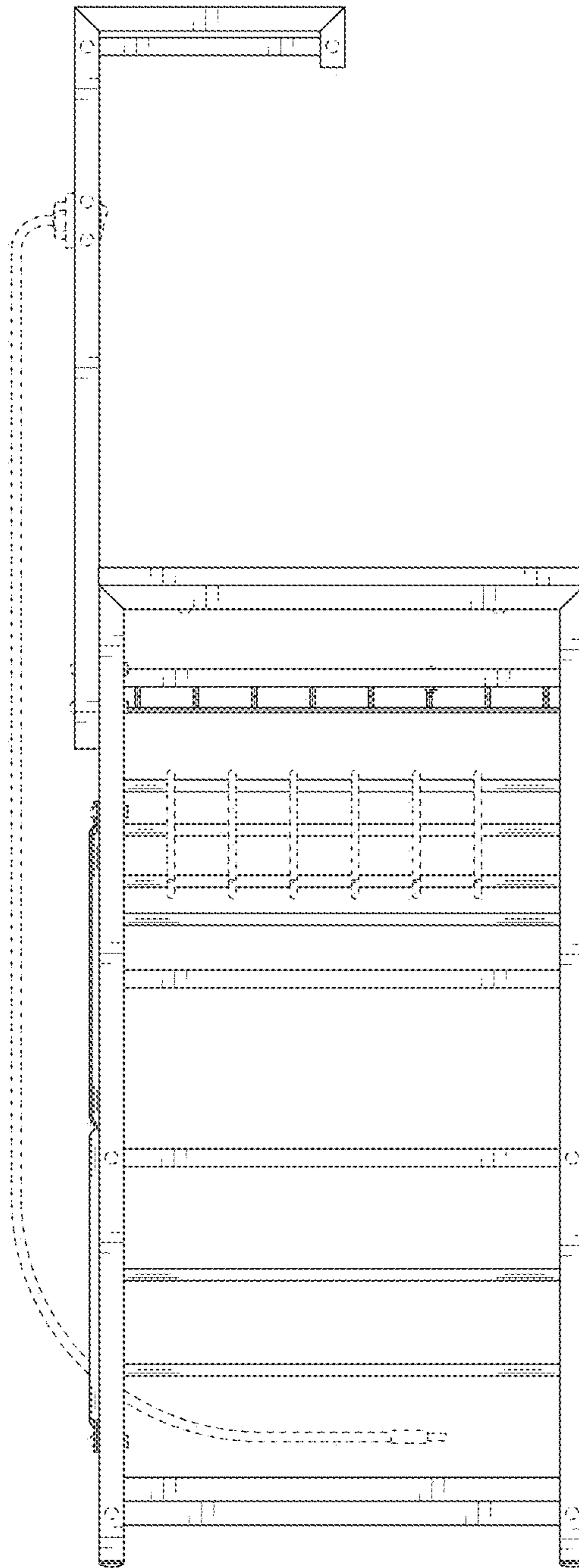

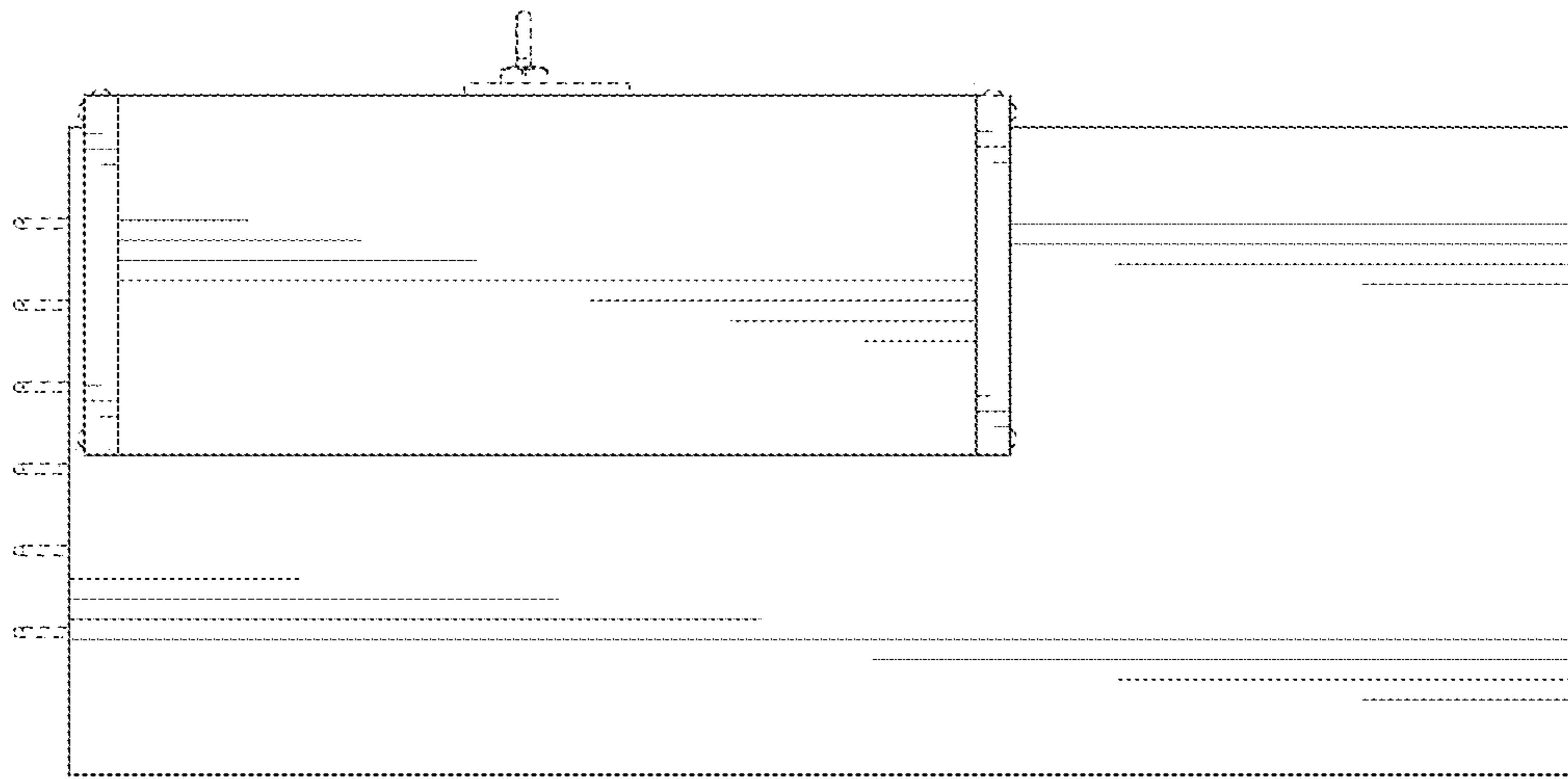

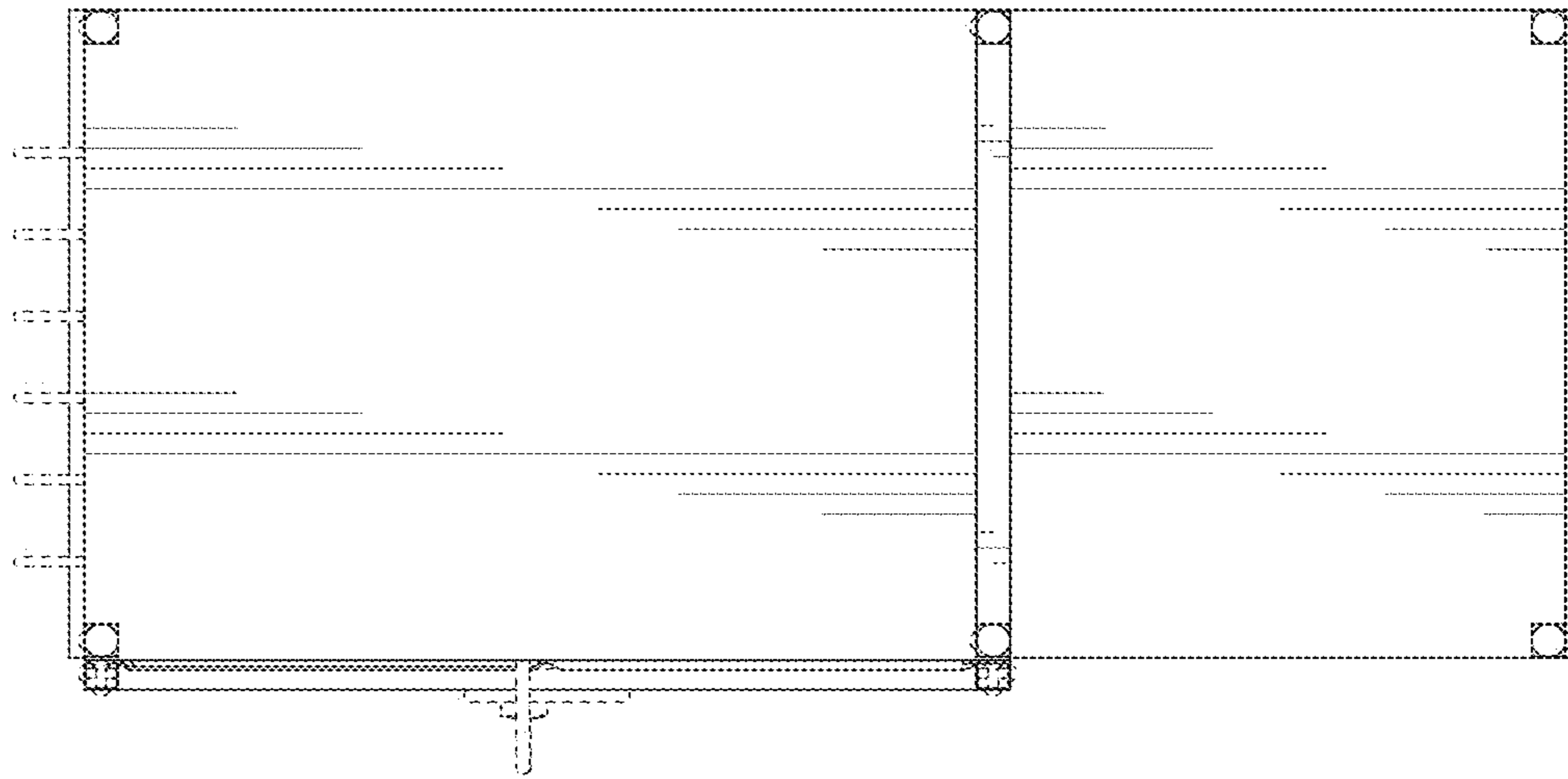
