DESCRIPTION

FIG. 1 is a top perspective view of the tumbler of the present
invention;

FIG. 2 is a front view of the tumbler of FIG. 1, the opposing
back view being a mirror image thereof;

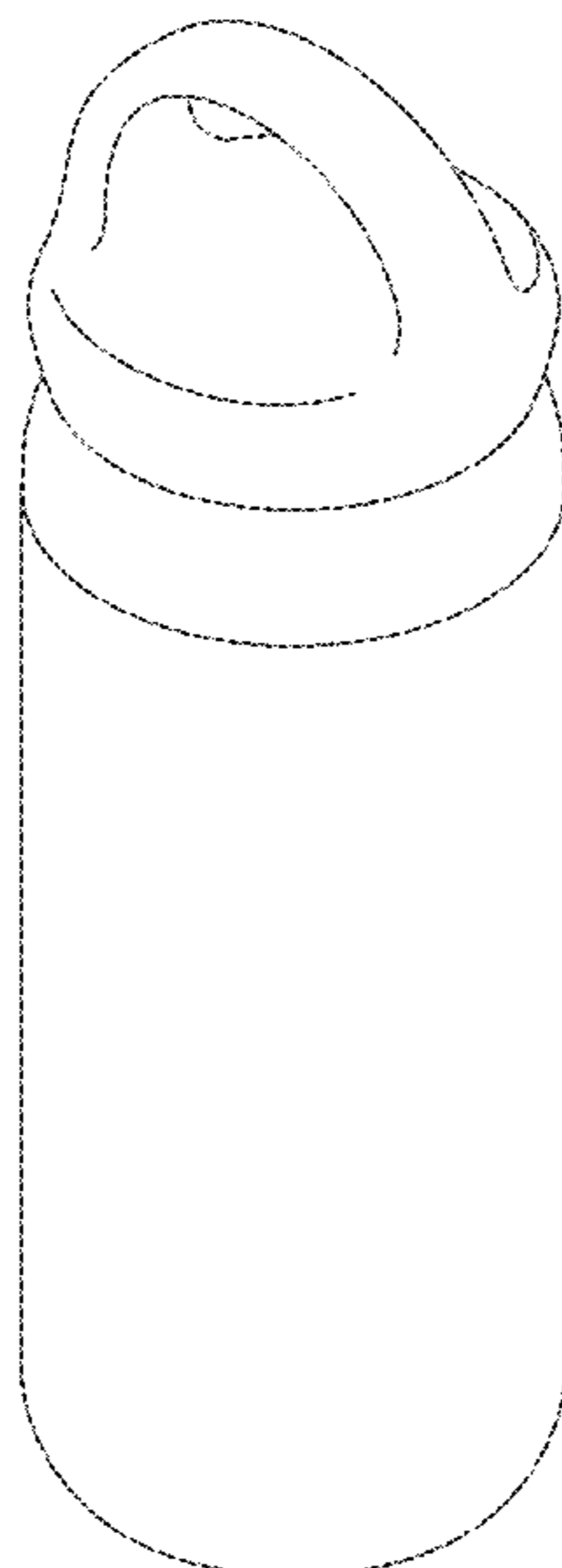
FIG. 3 is a top view of the tumbler of FIG. 1;

FIG. 4 is a bottom view of the tumbler of FIG. 1; and,

FIG. 5 is a side view of the tumbler of FIG. 1, the opposing
side view being a mirror image thereof.

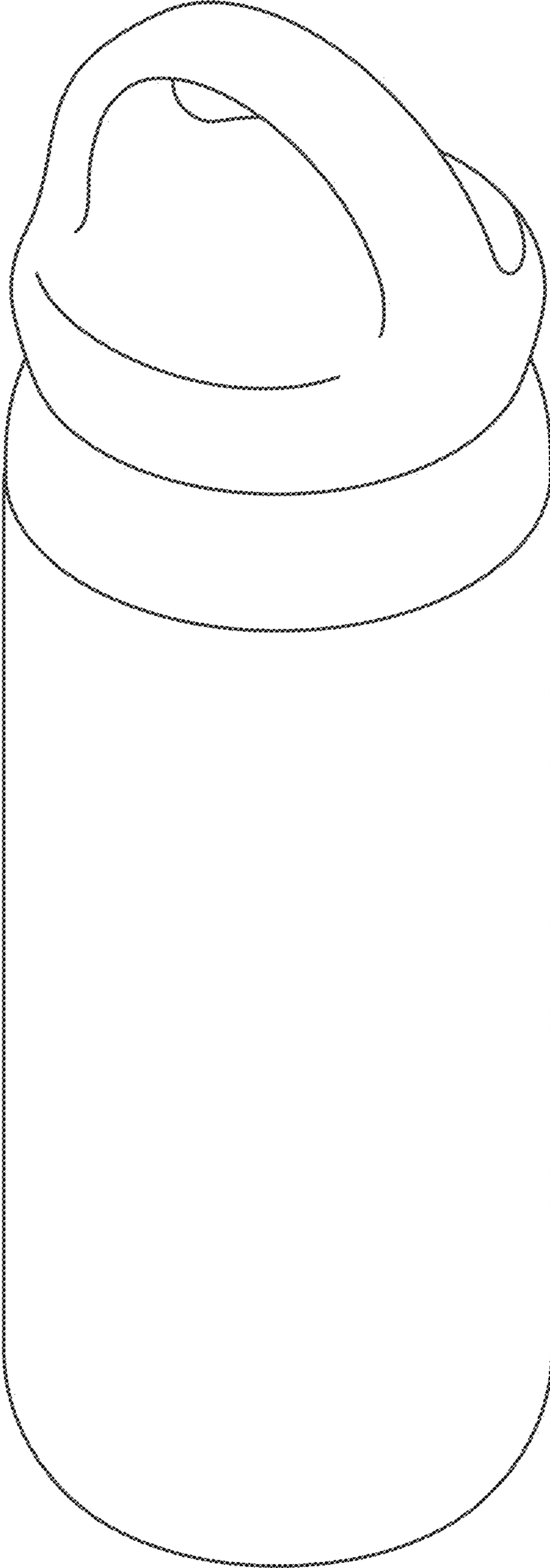

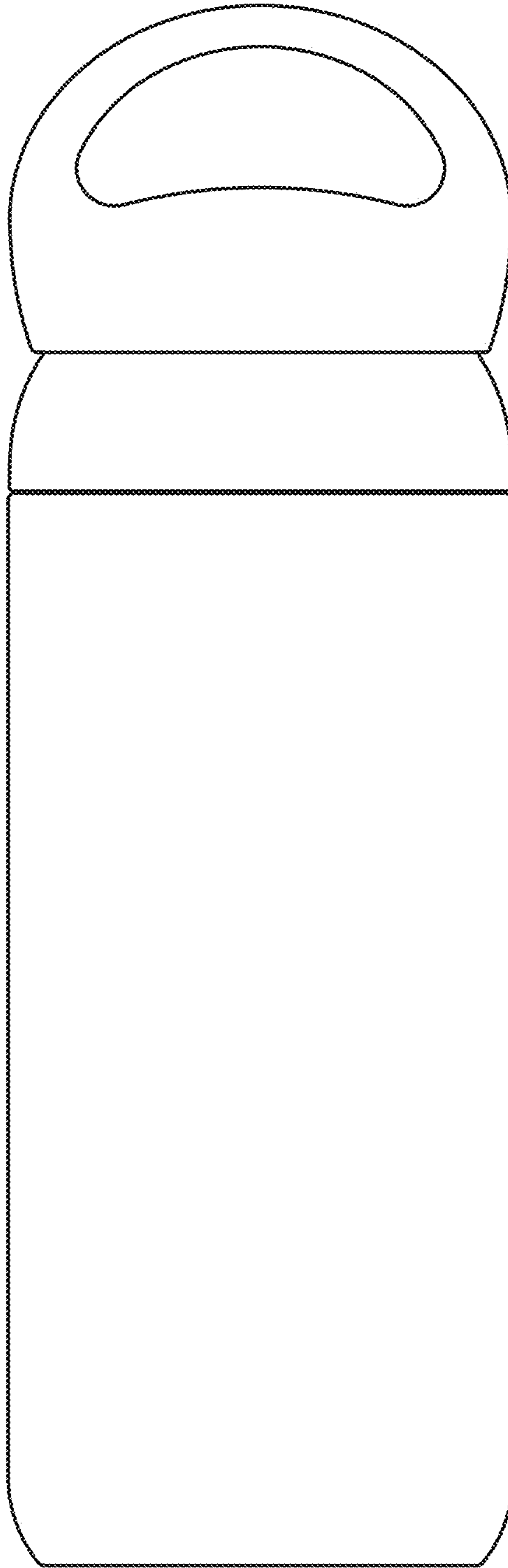

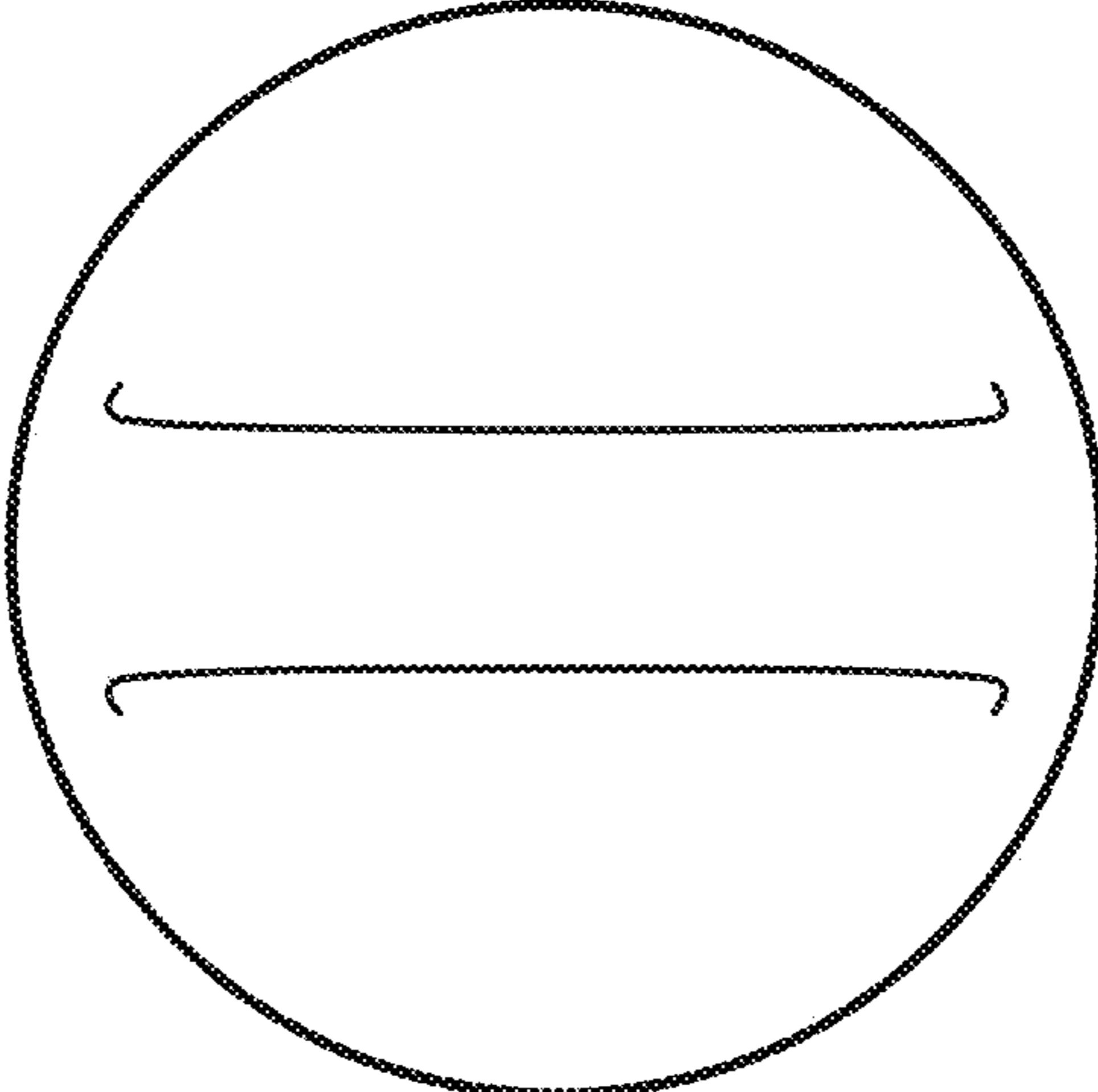

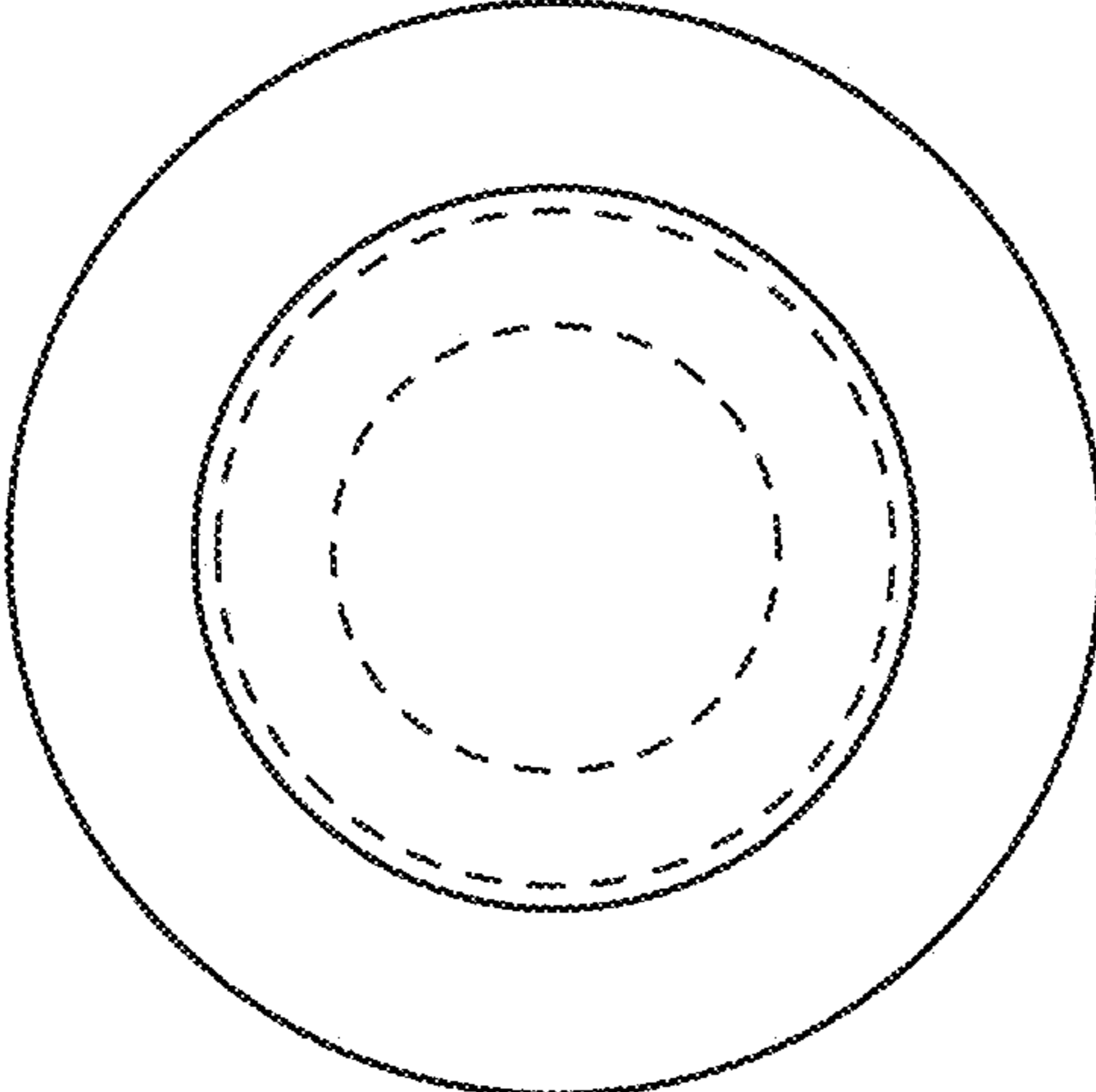

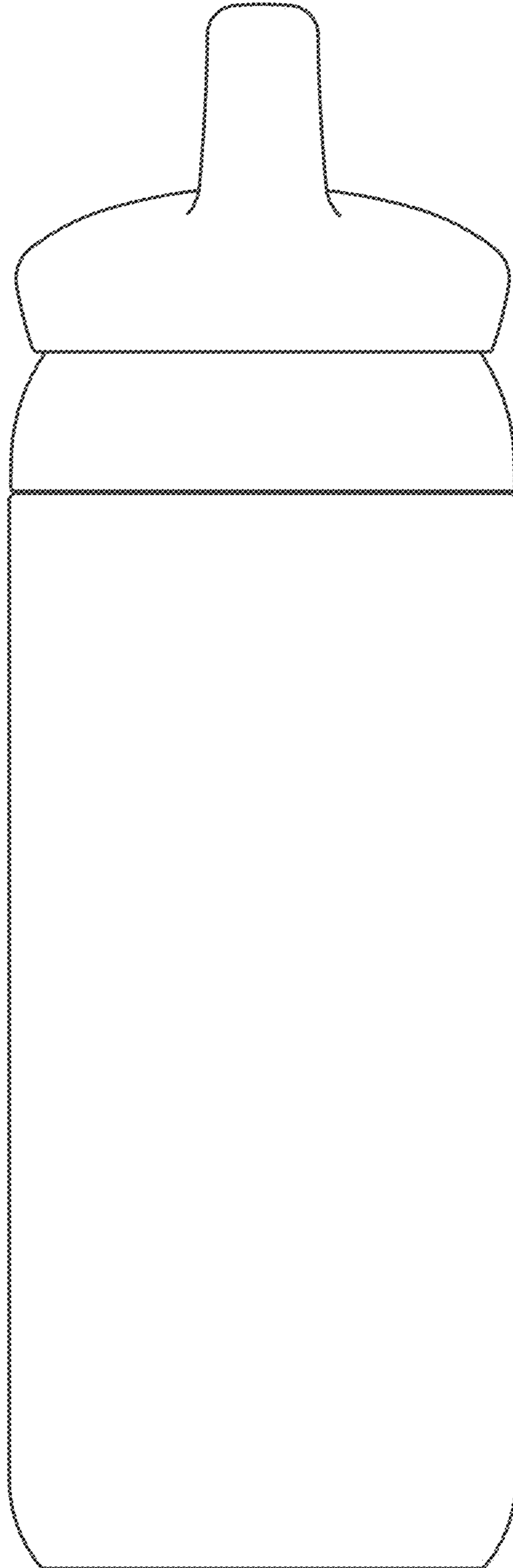
