**DESCRIPTION**

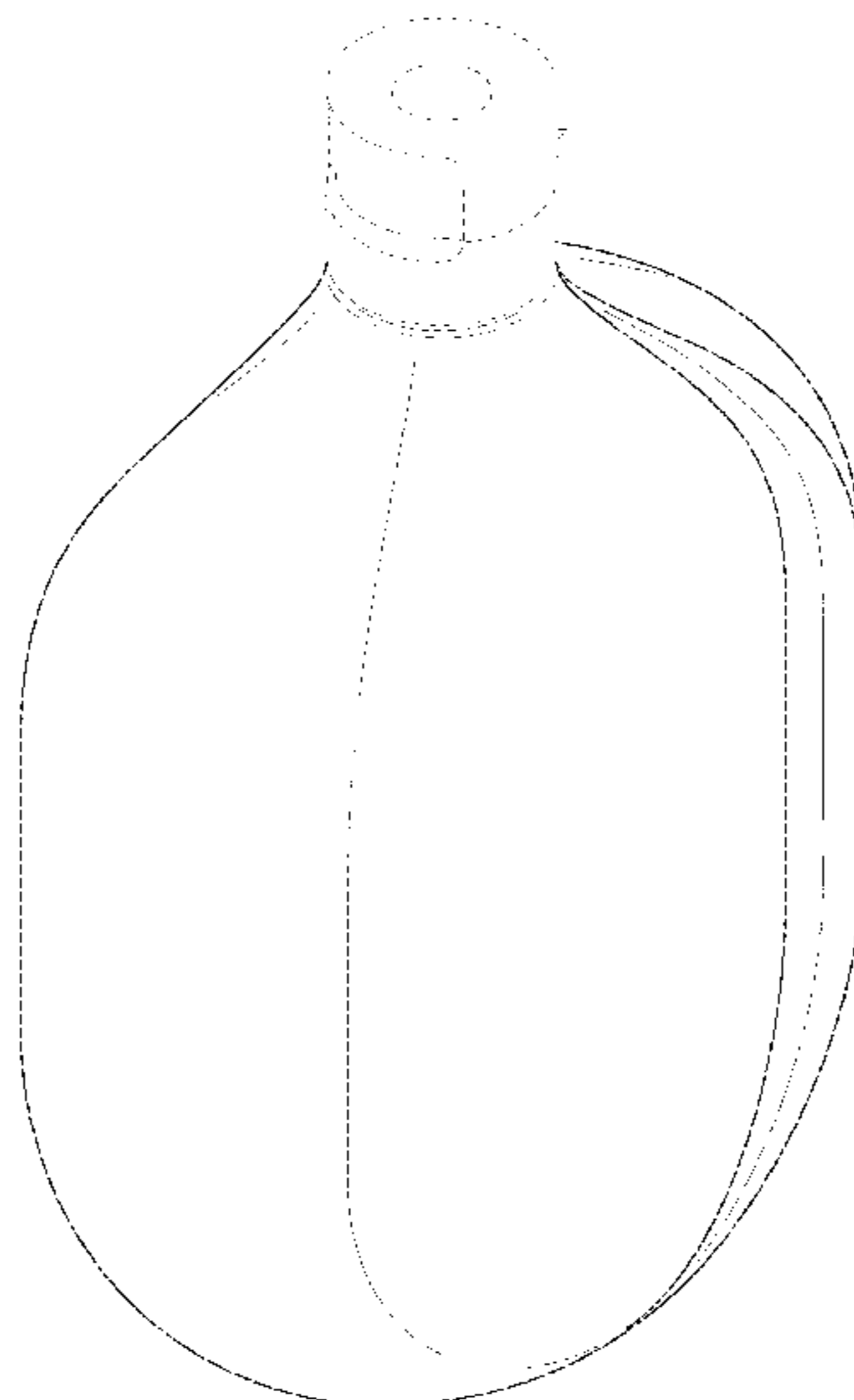
FIG. 1 is a top perspective view of a bottle showing the claimed design;

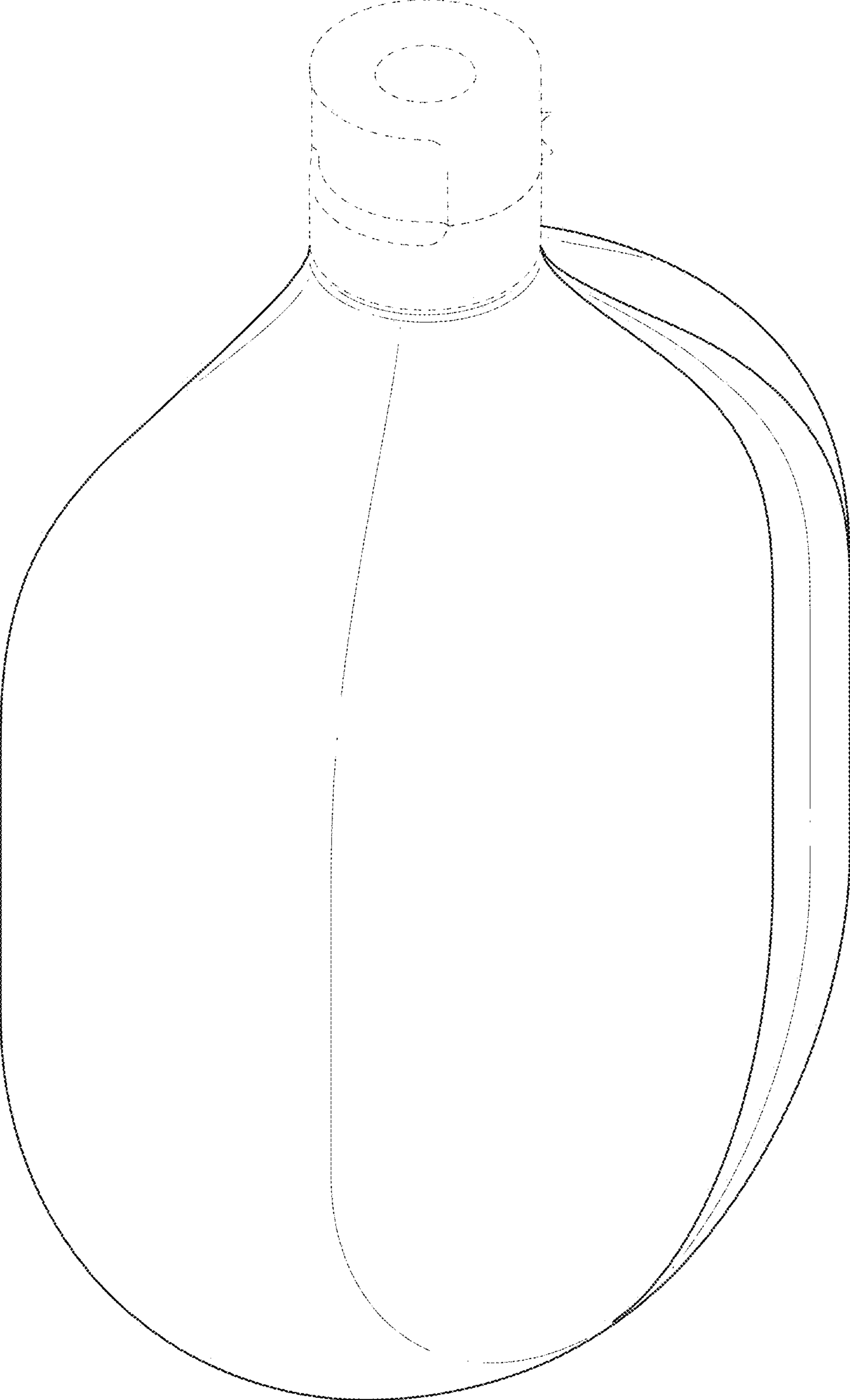

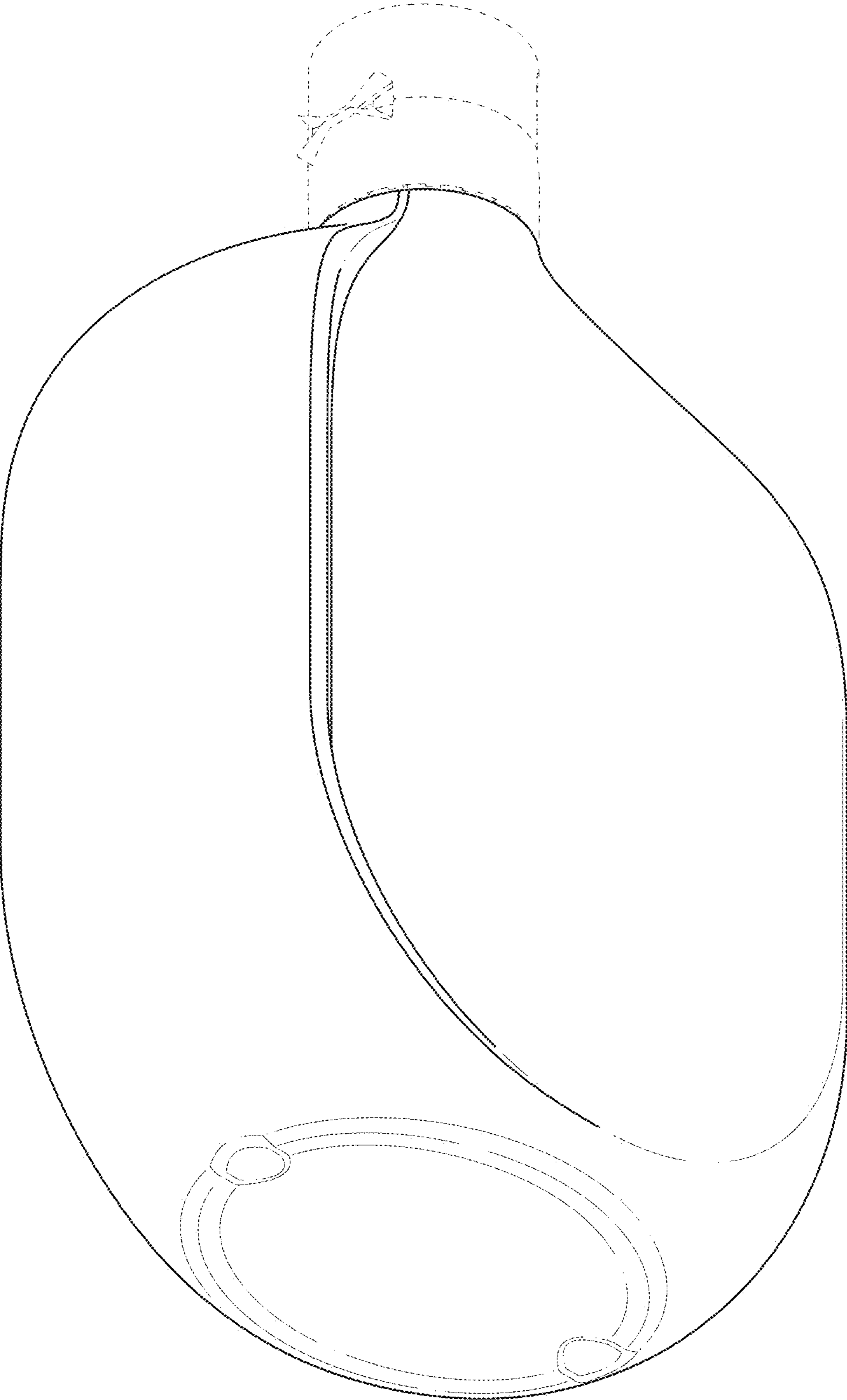
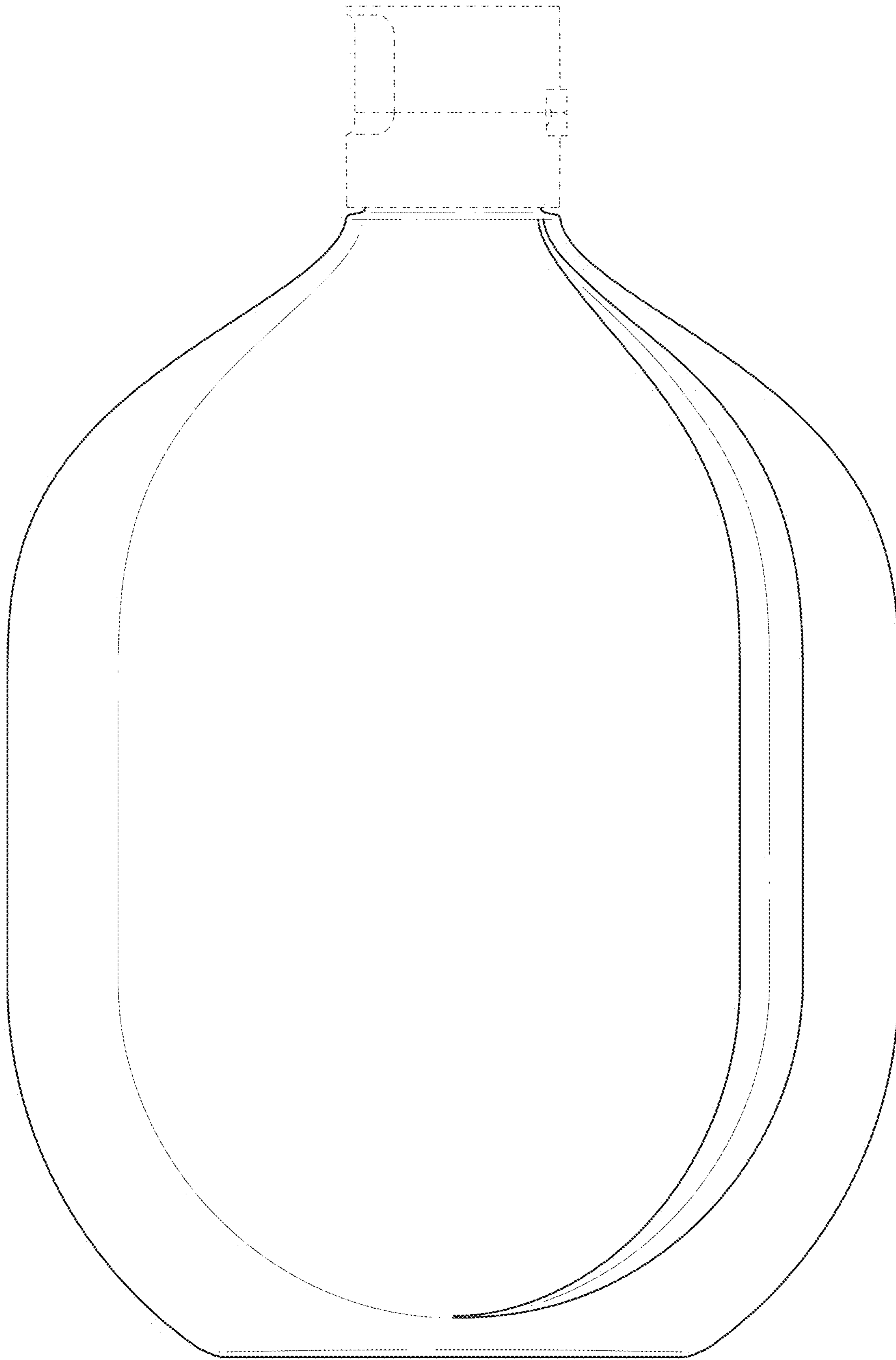

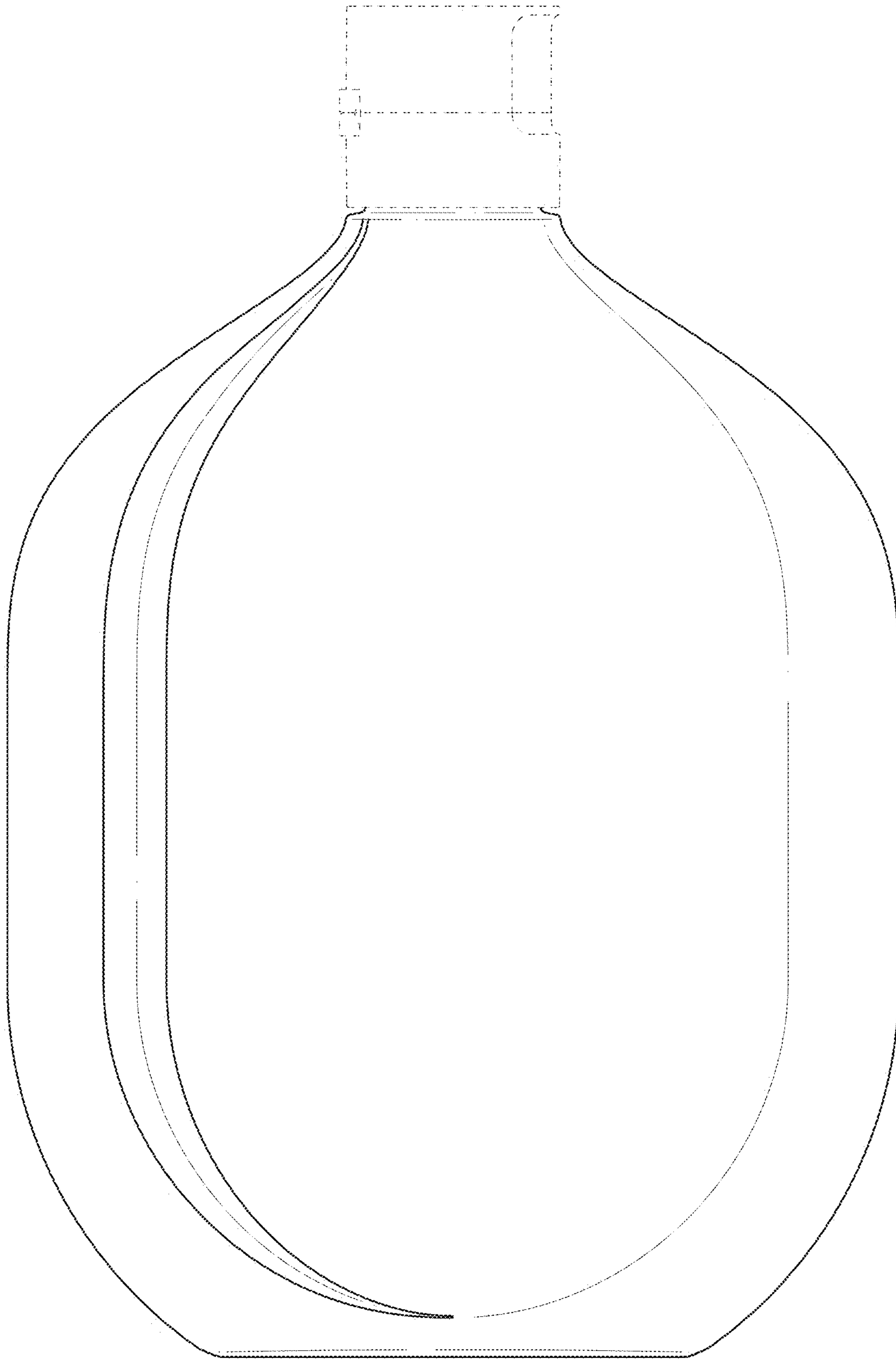

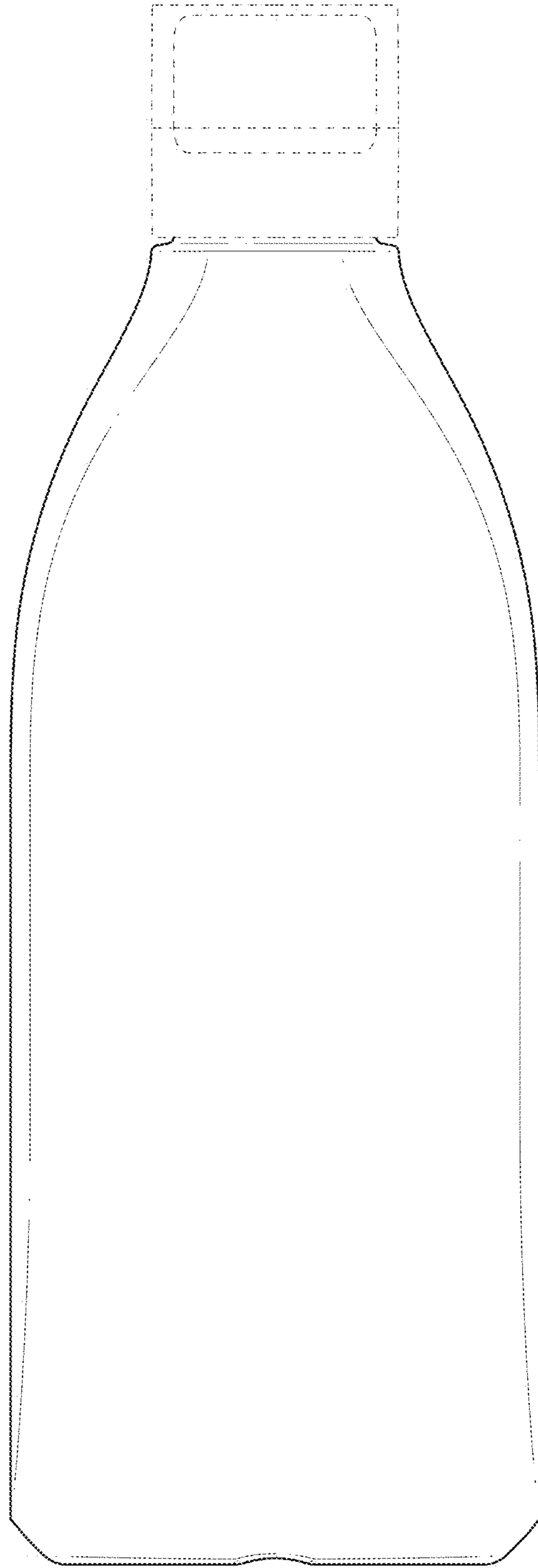

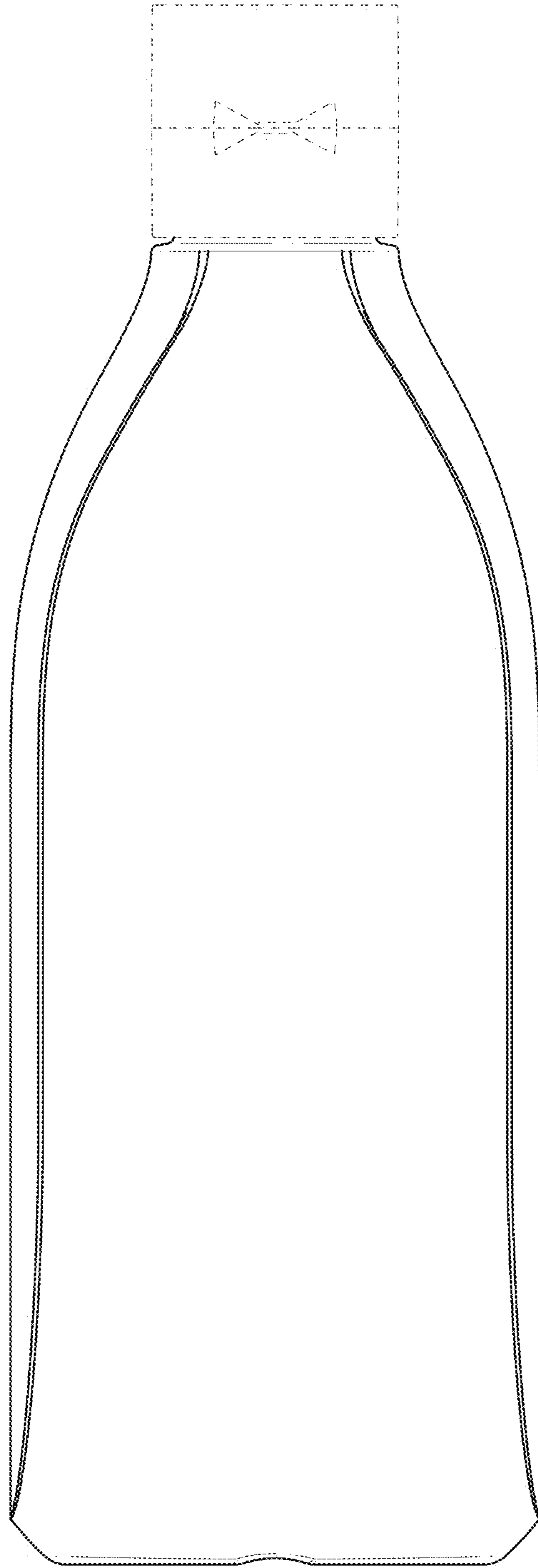

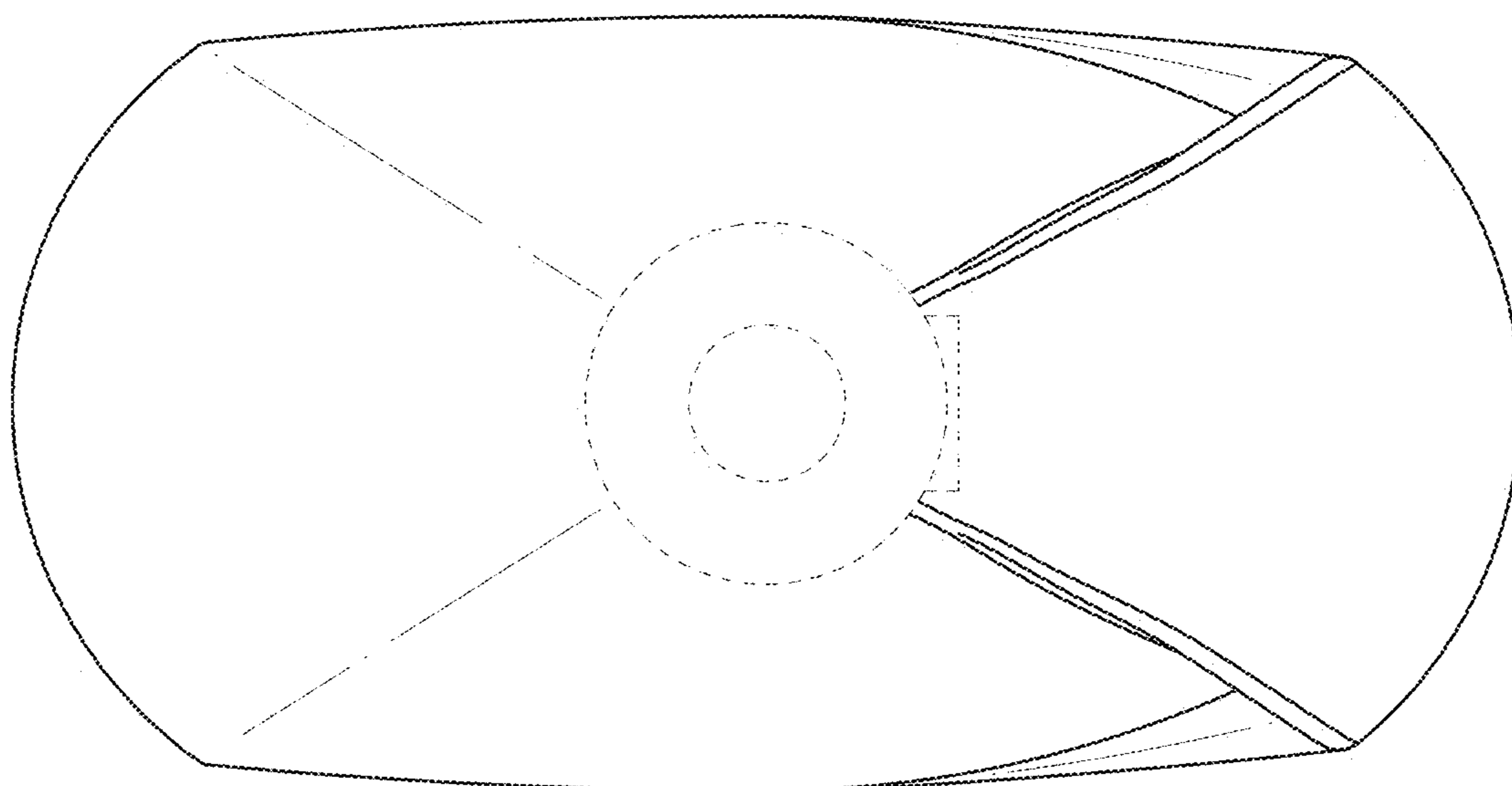

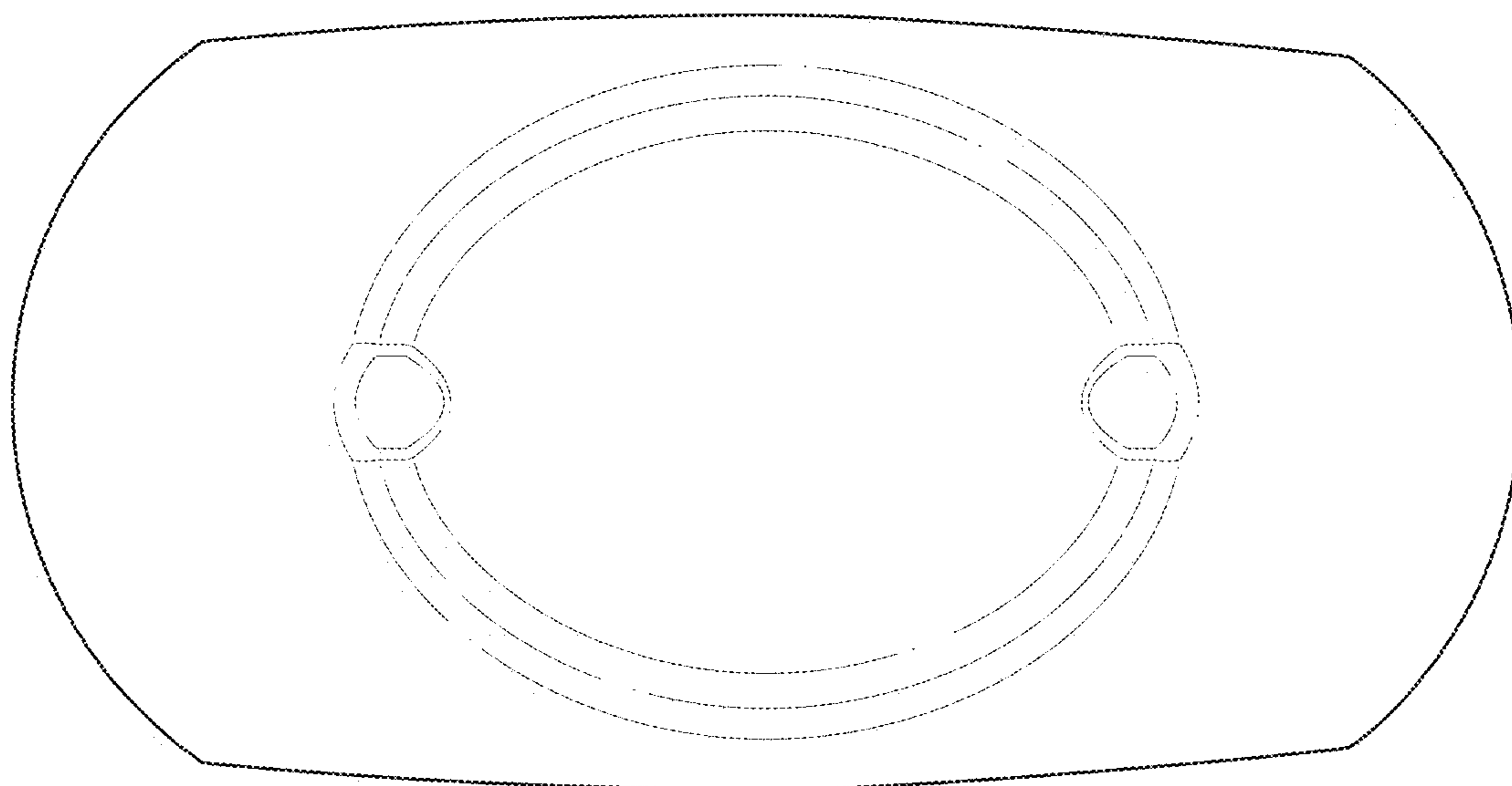
