FIG. 8 is a rear view of the fragrance bottle of FIG. 7;

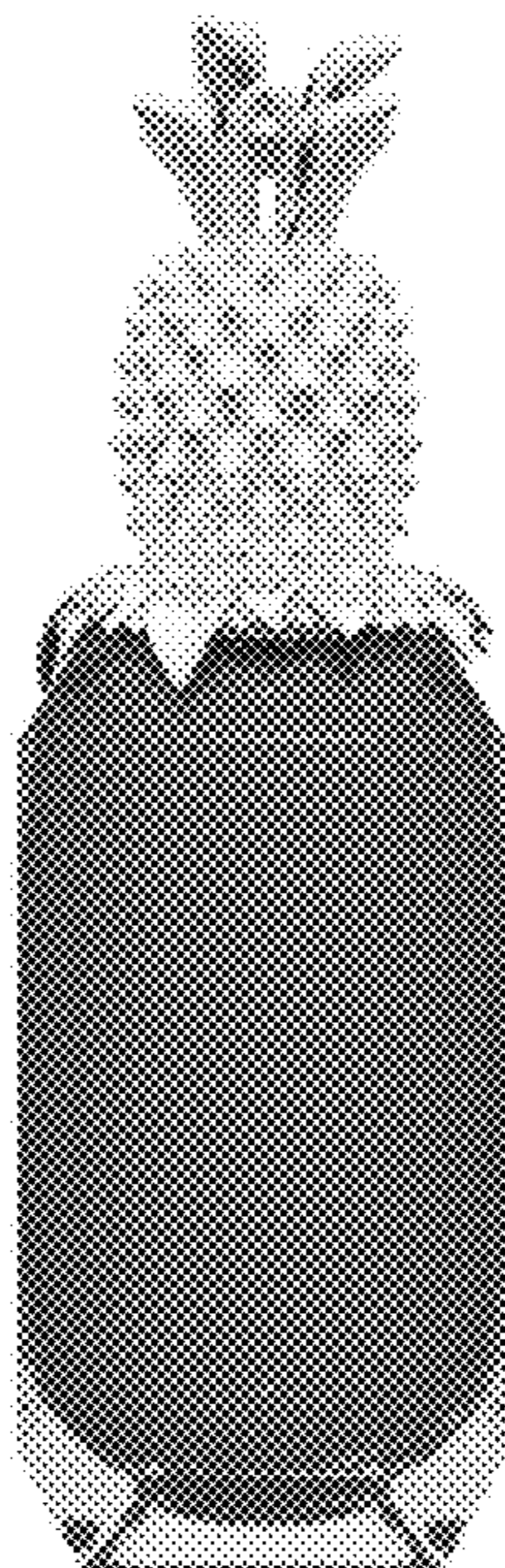
FIG. 9 is a right side view of the fragrance bottle of FIG. 7;

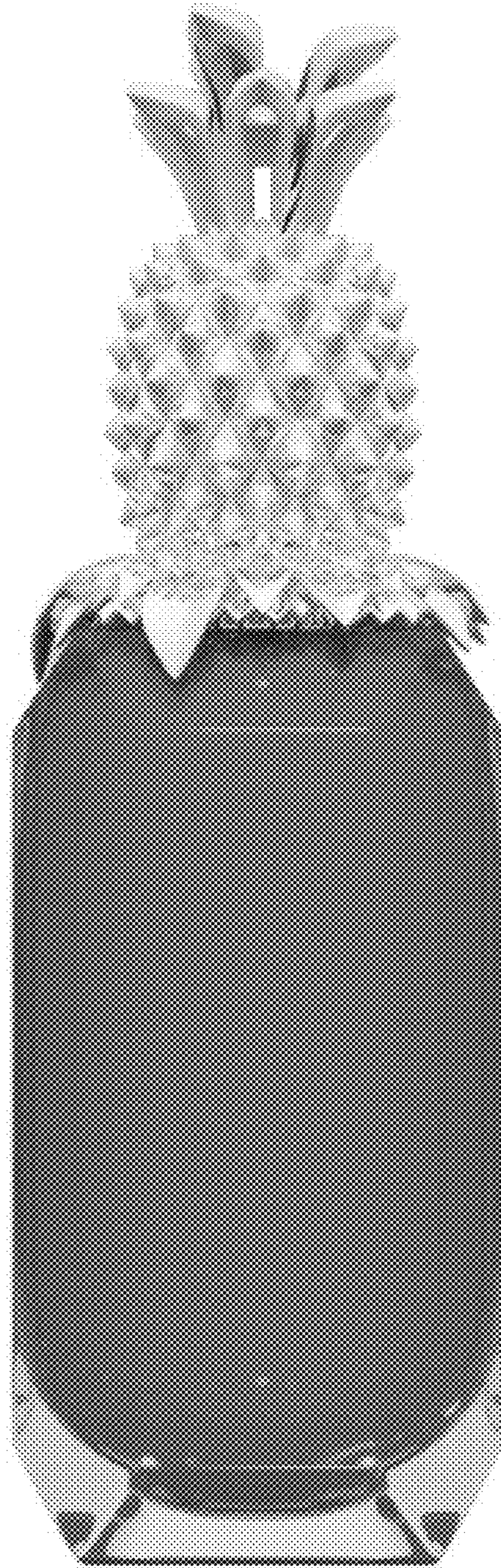

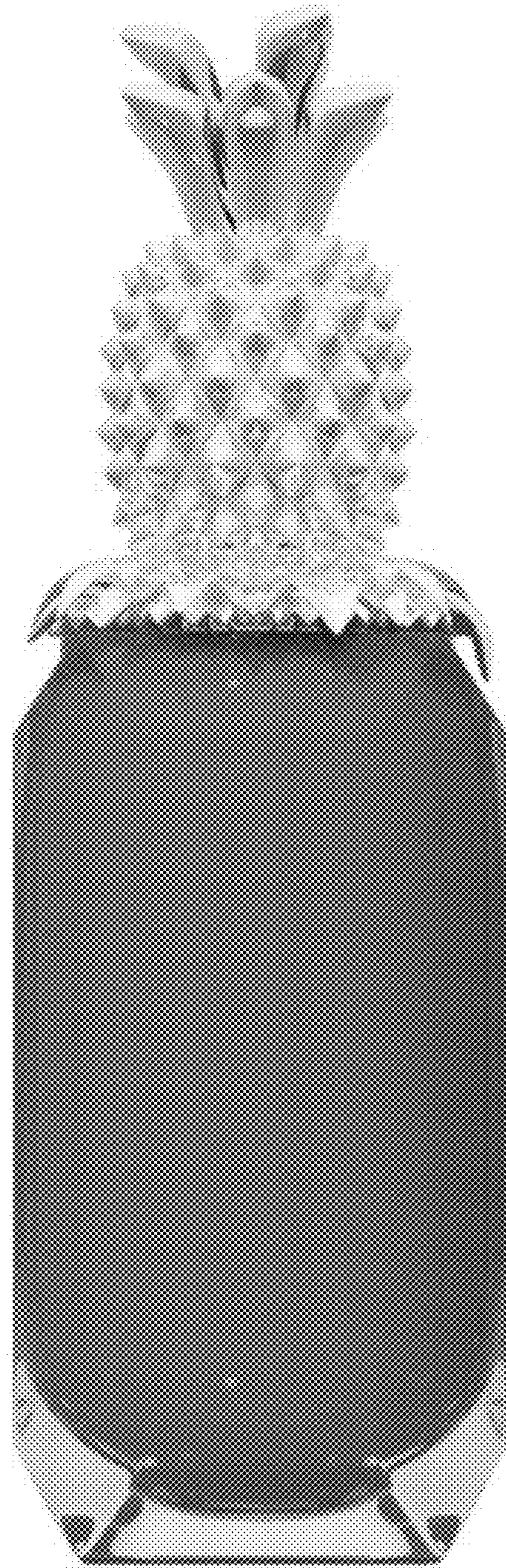

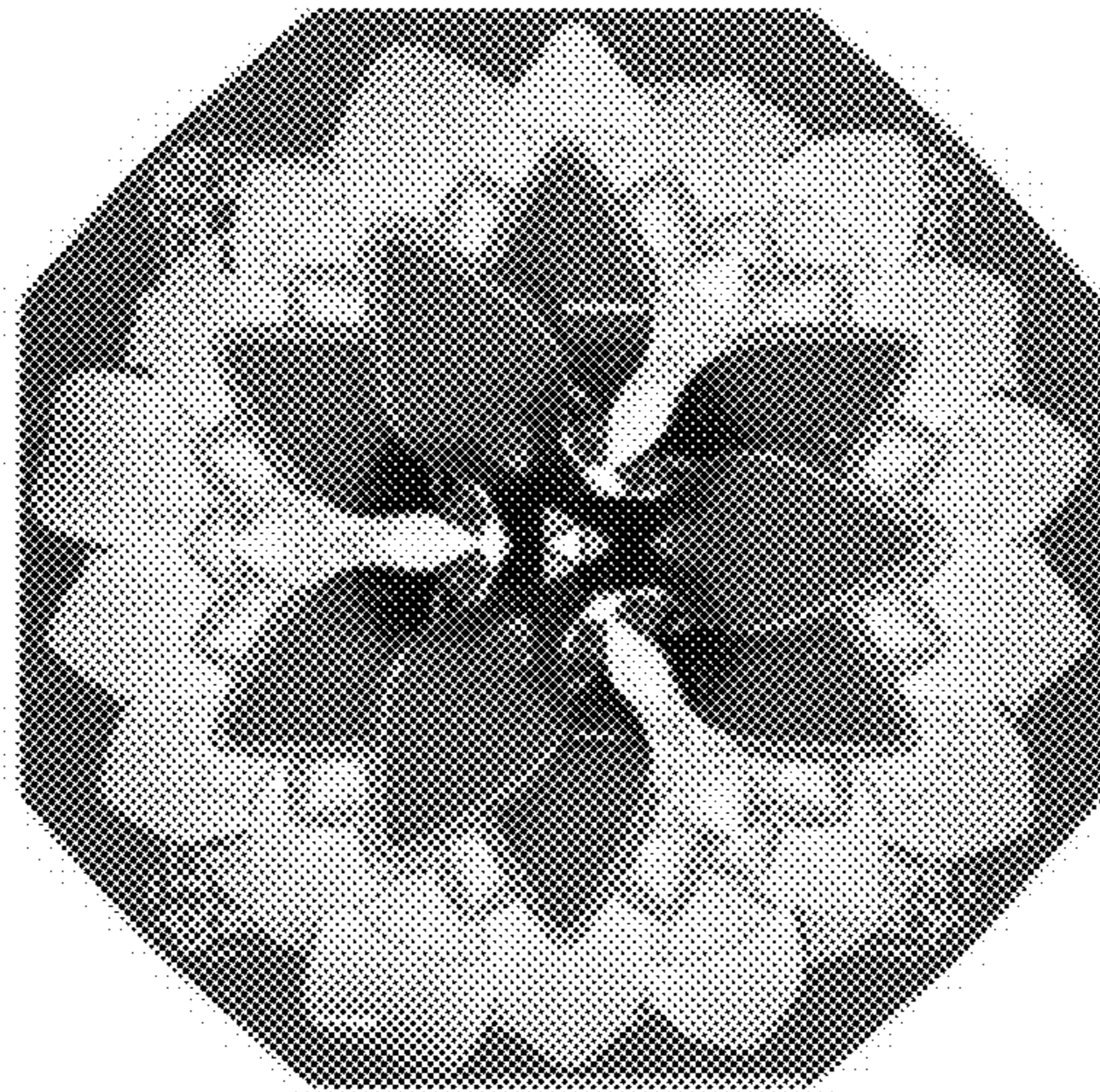

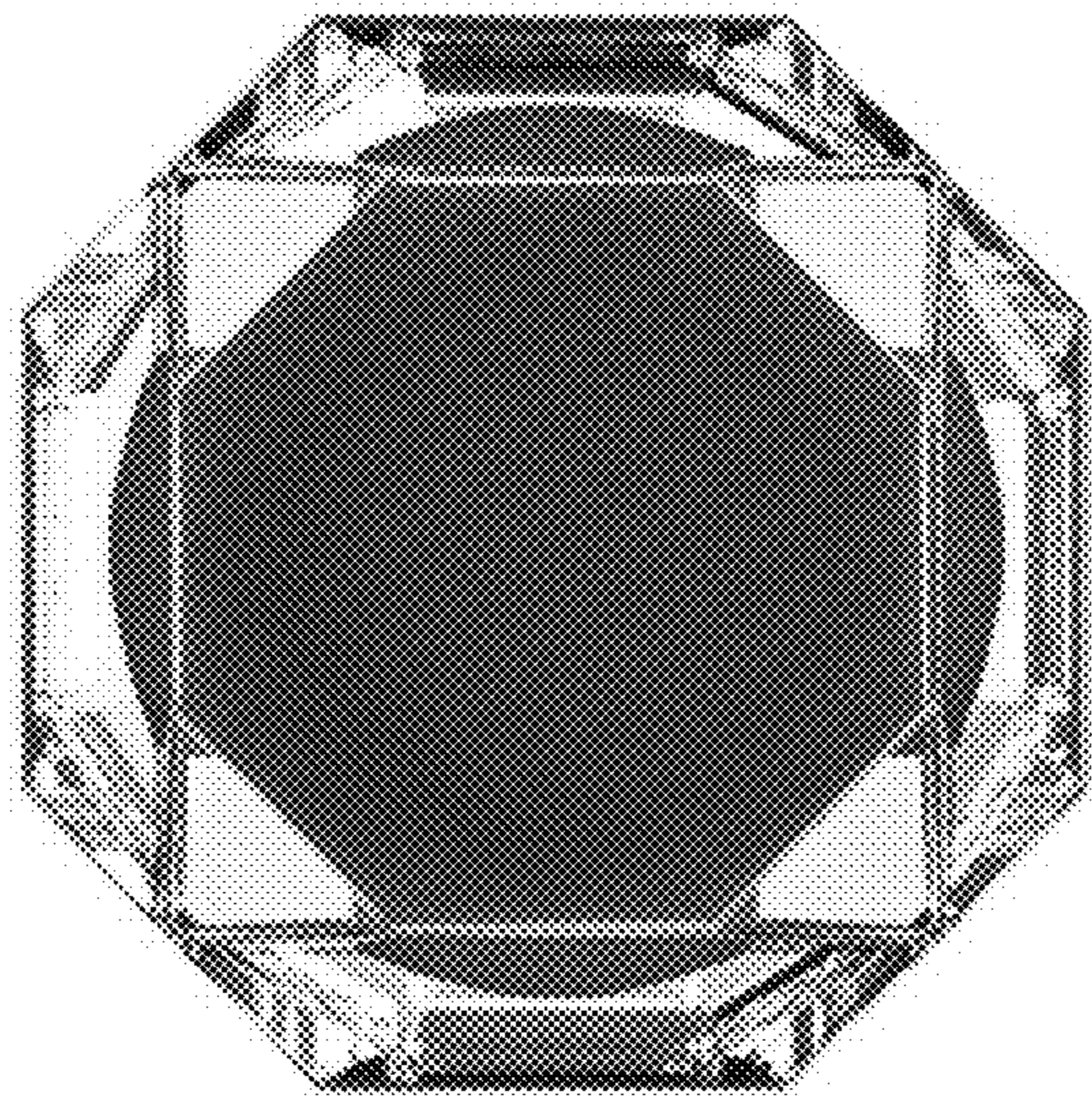

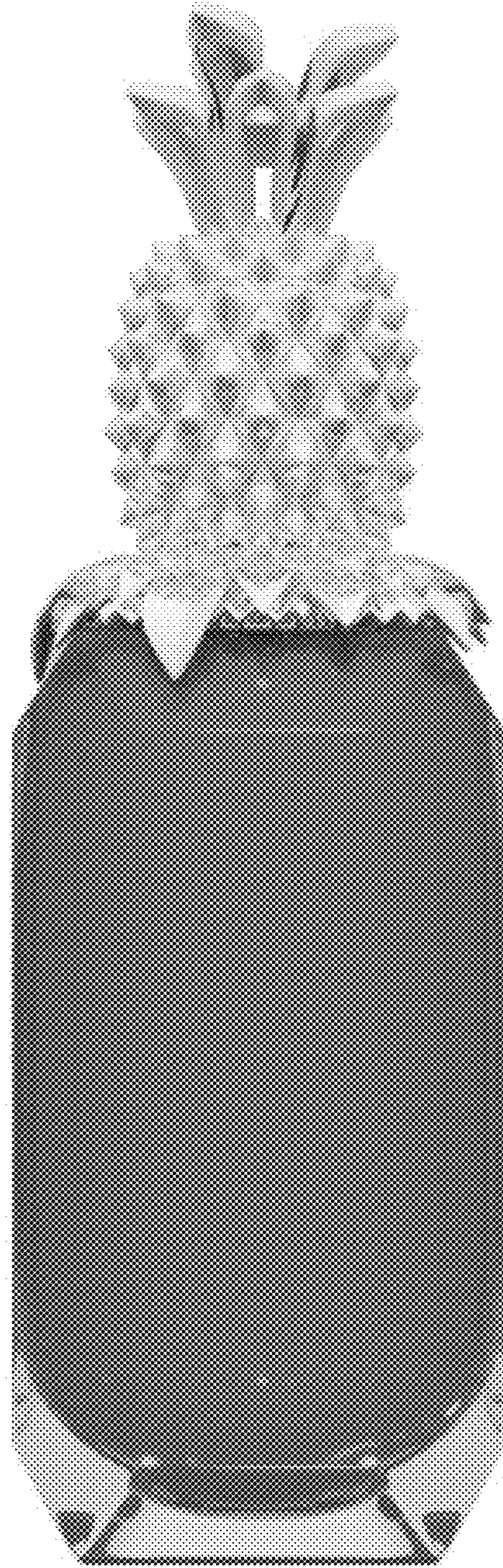

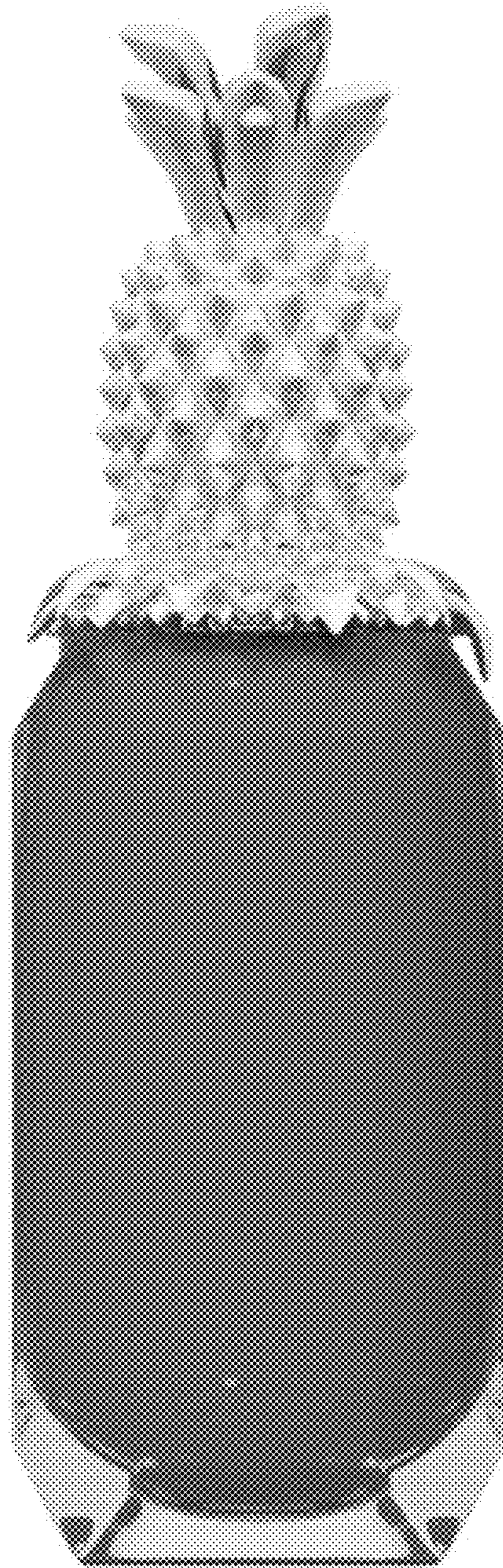

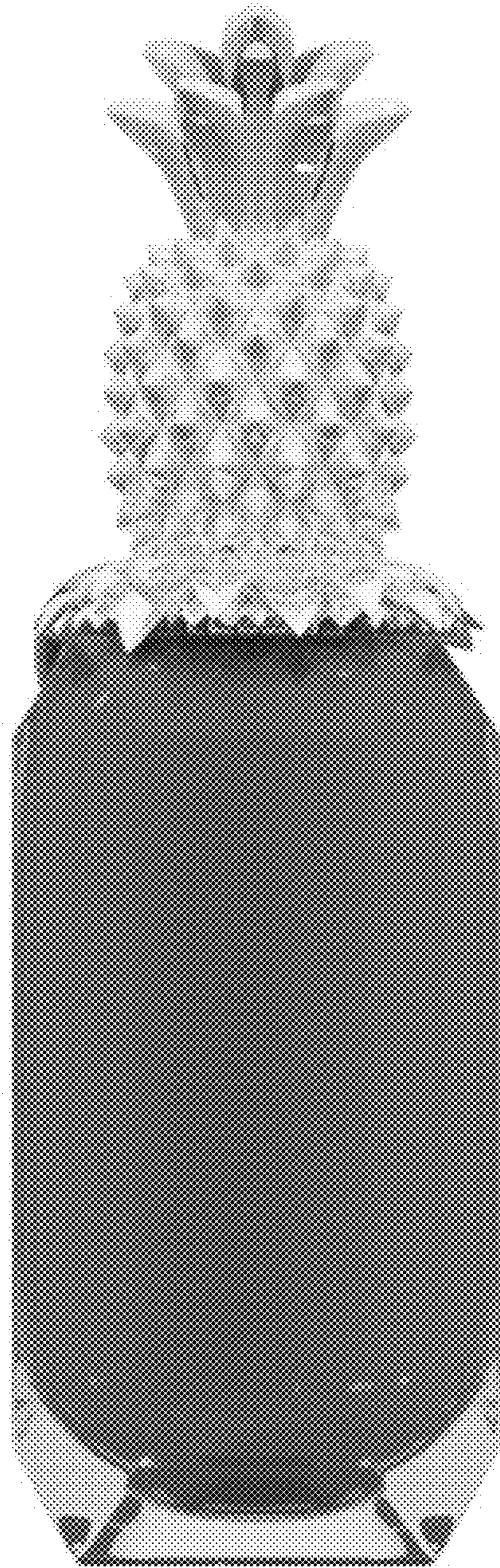

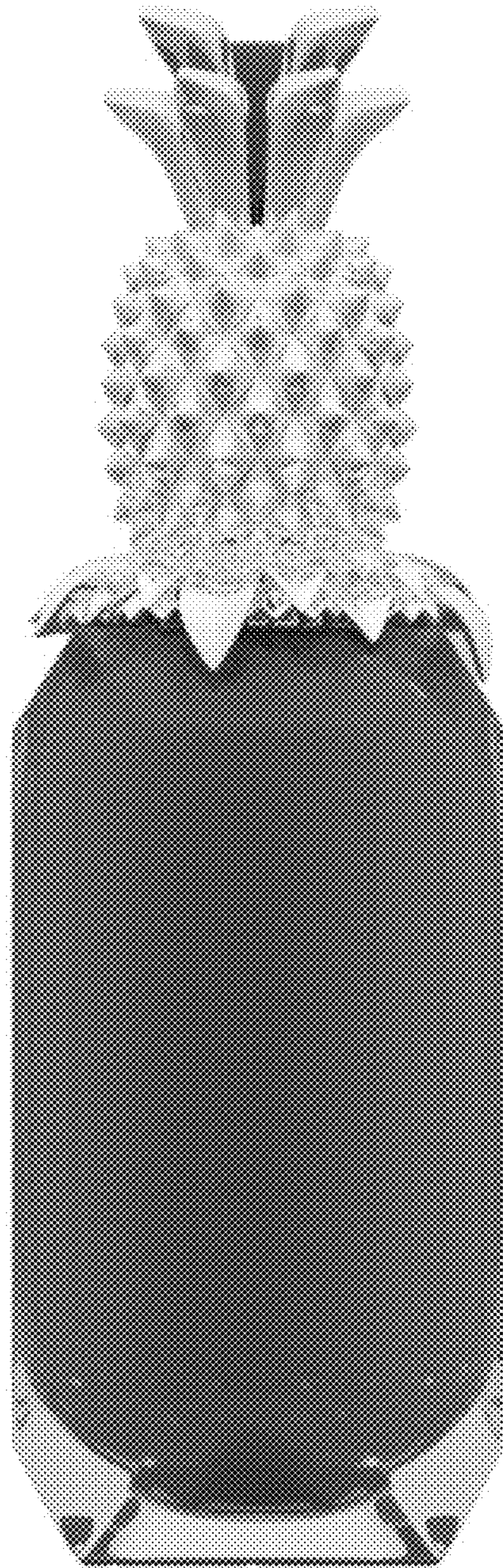

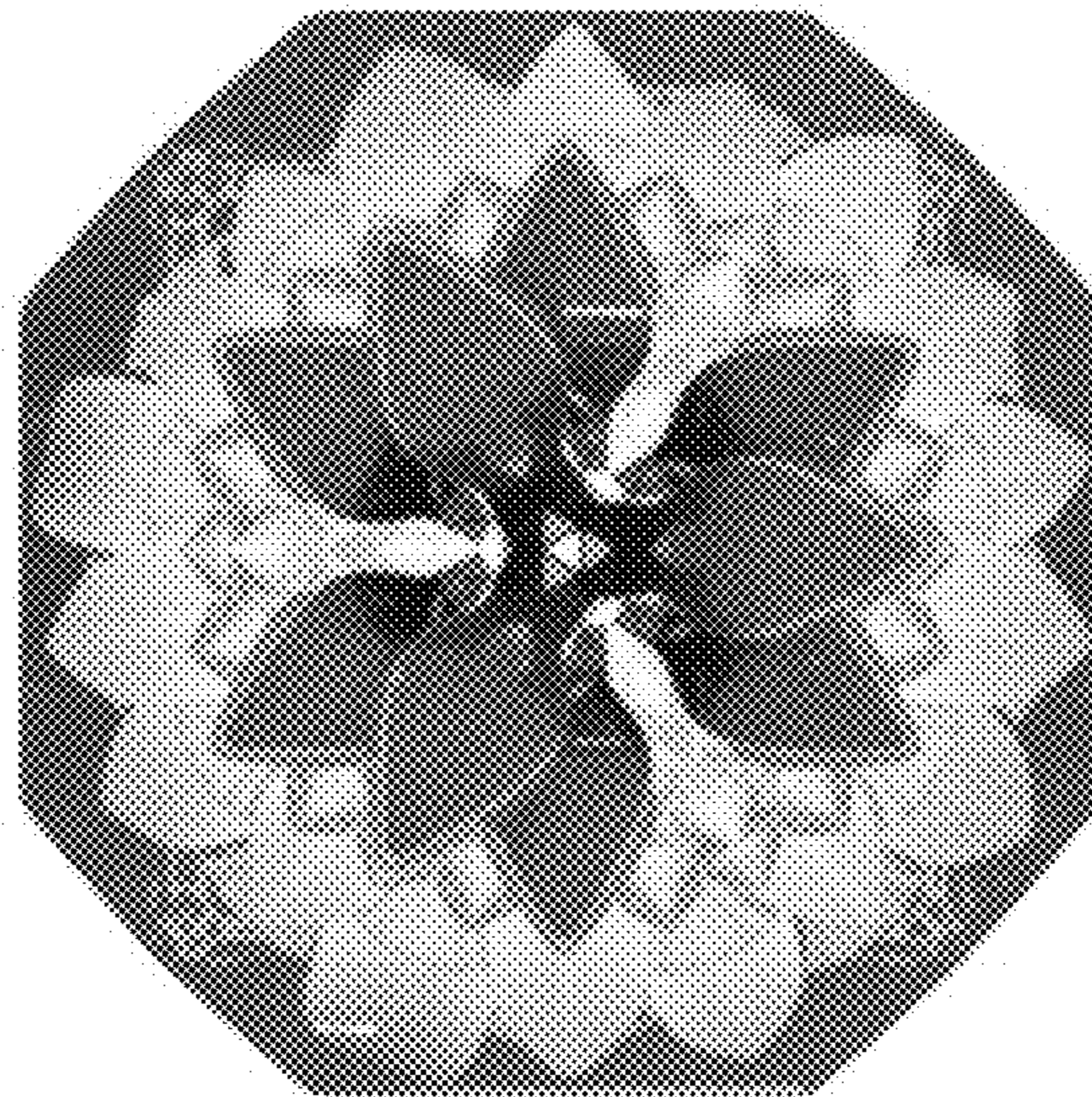

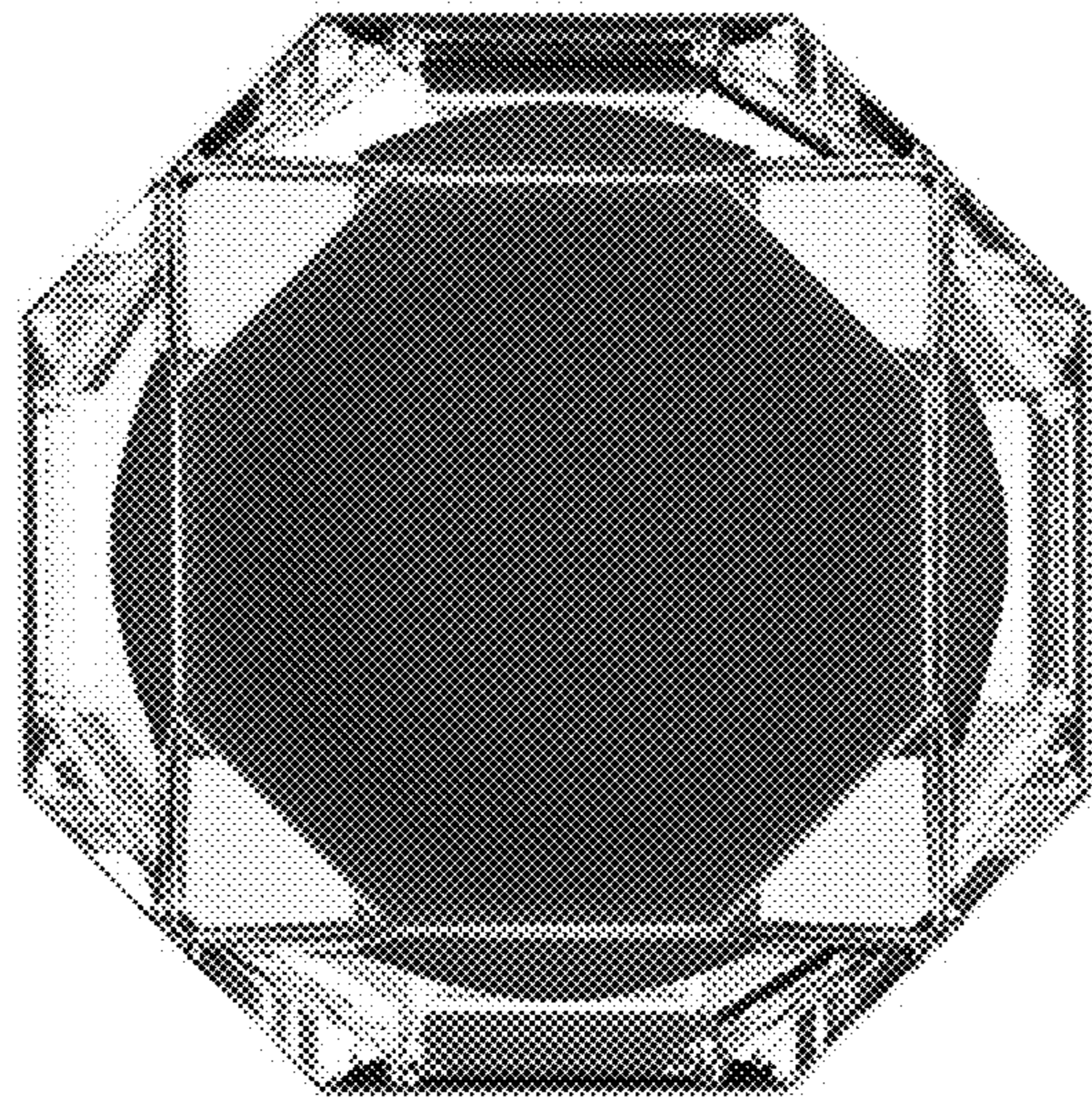
