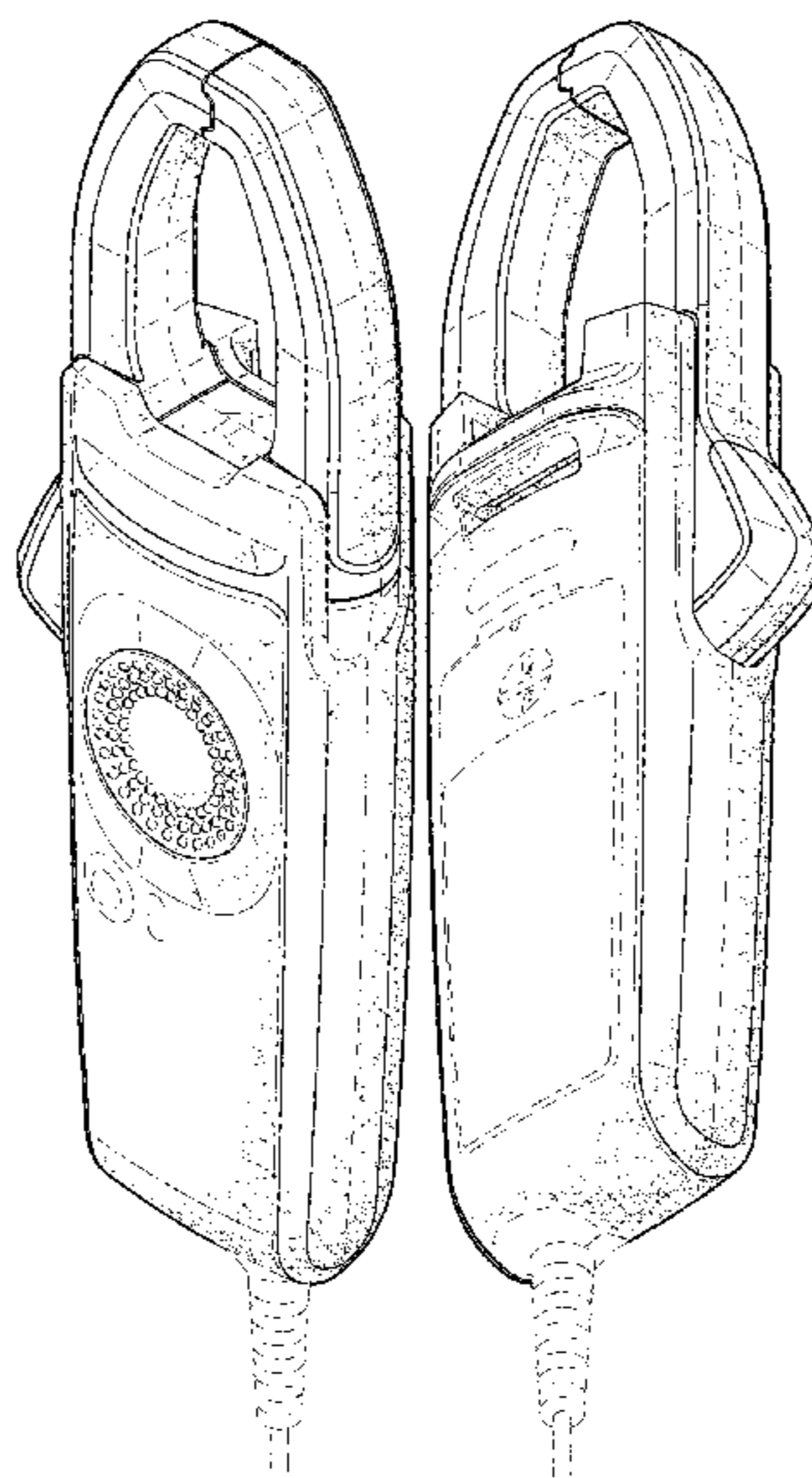
(57) **CLAIM**

The ornamental design for a clamp meter, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right side perspective view of a clamp meter showing our new design.  
FIG. 2 is a bottom, rear, left side perspective view thereof.  
FIG. 3 is a front elevation view thereof.  
FIG. 4 is a left side elevation view thereof.  
FIG. 5 is a right side elevation view thereof.  
FIG. 6 is a rear elevation view thereof.

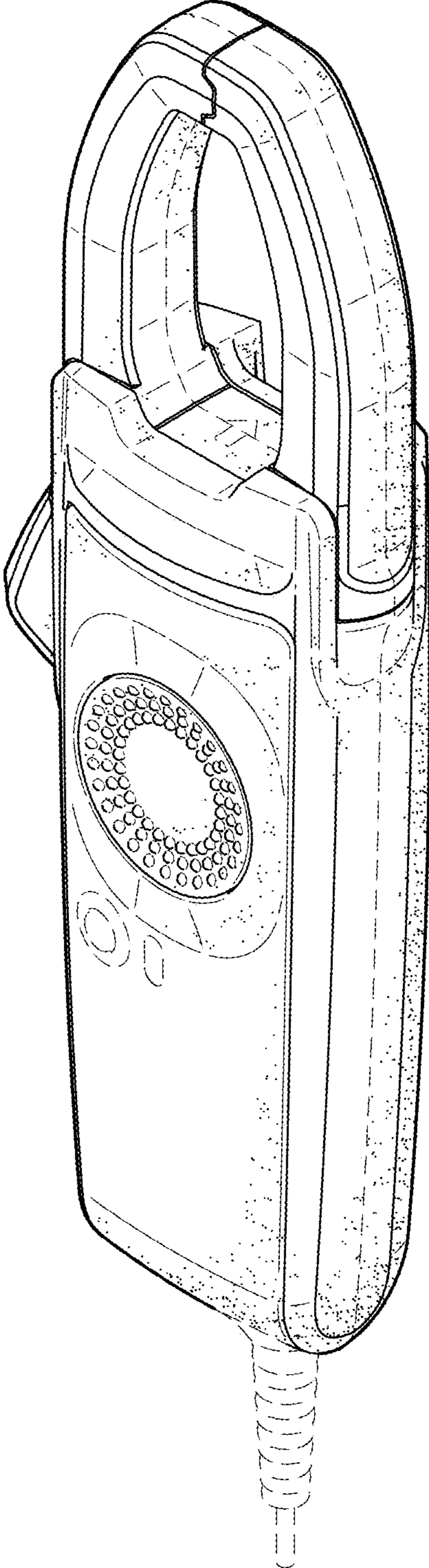

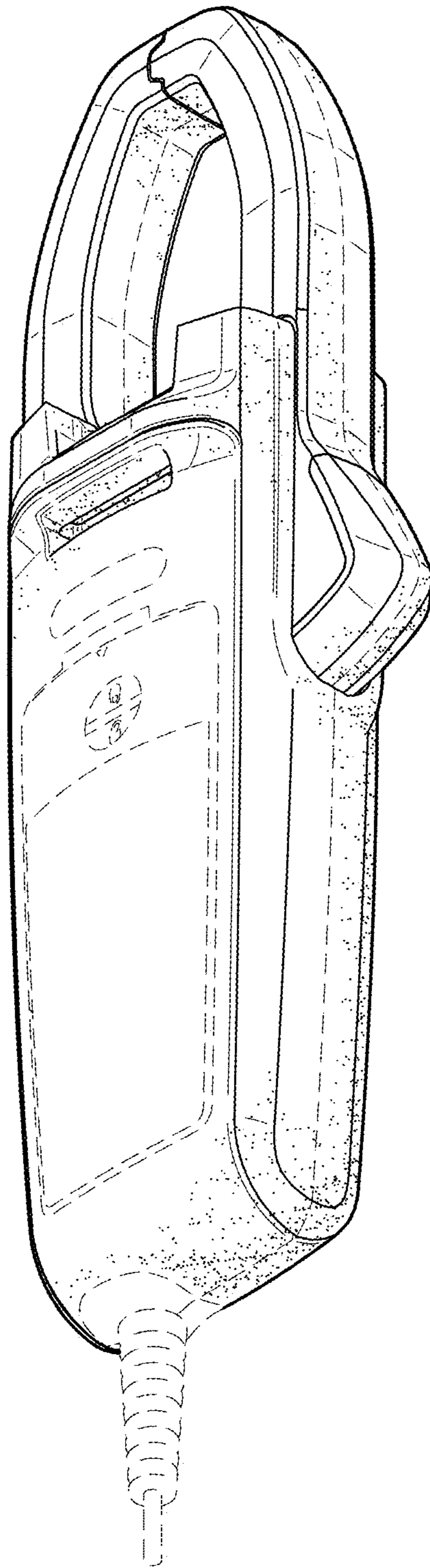

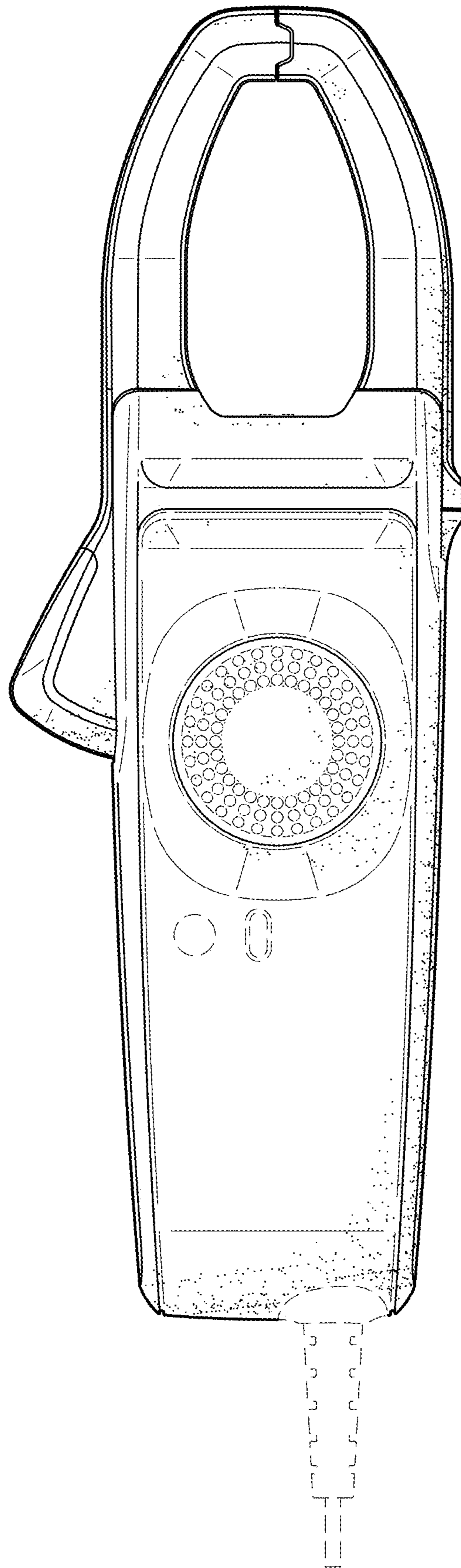

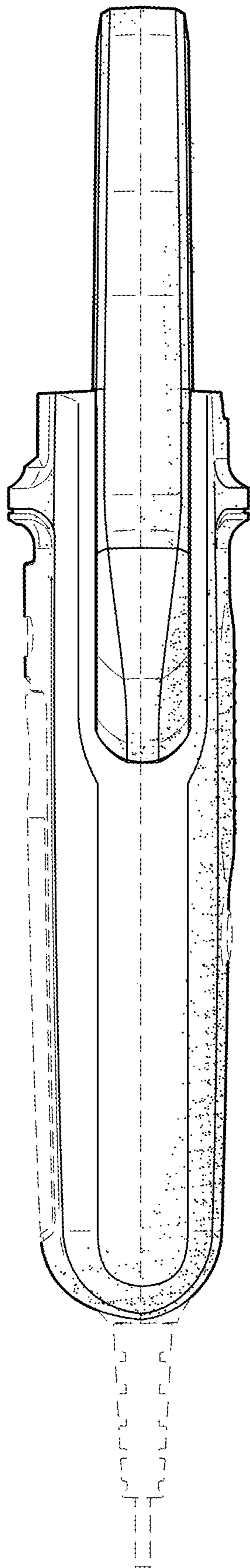

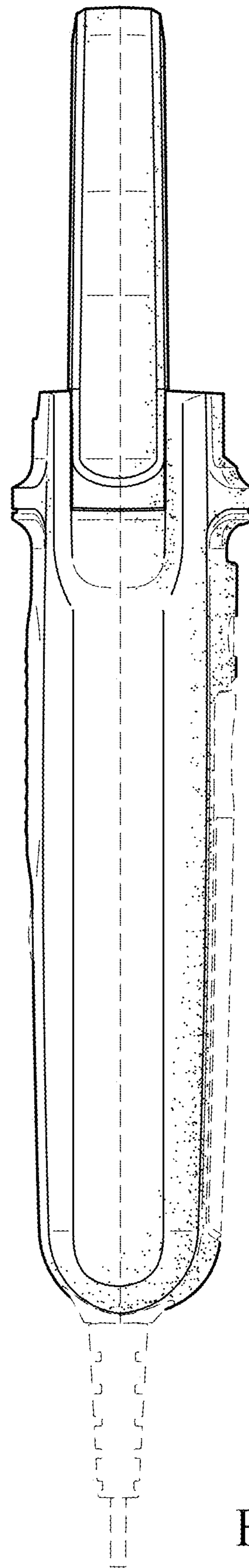

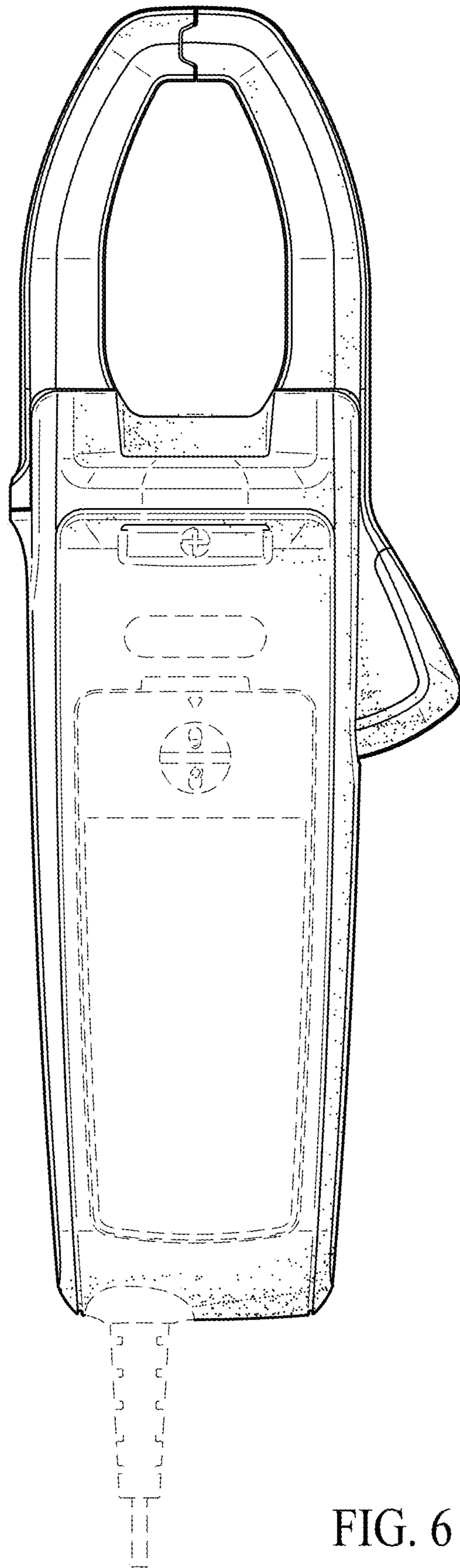

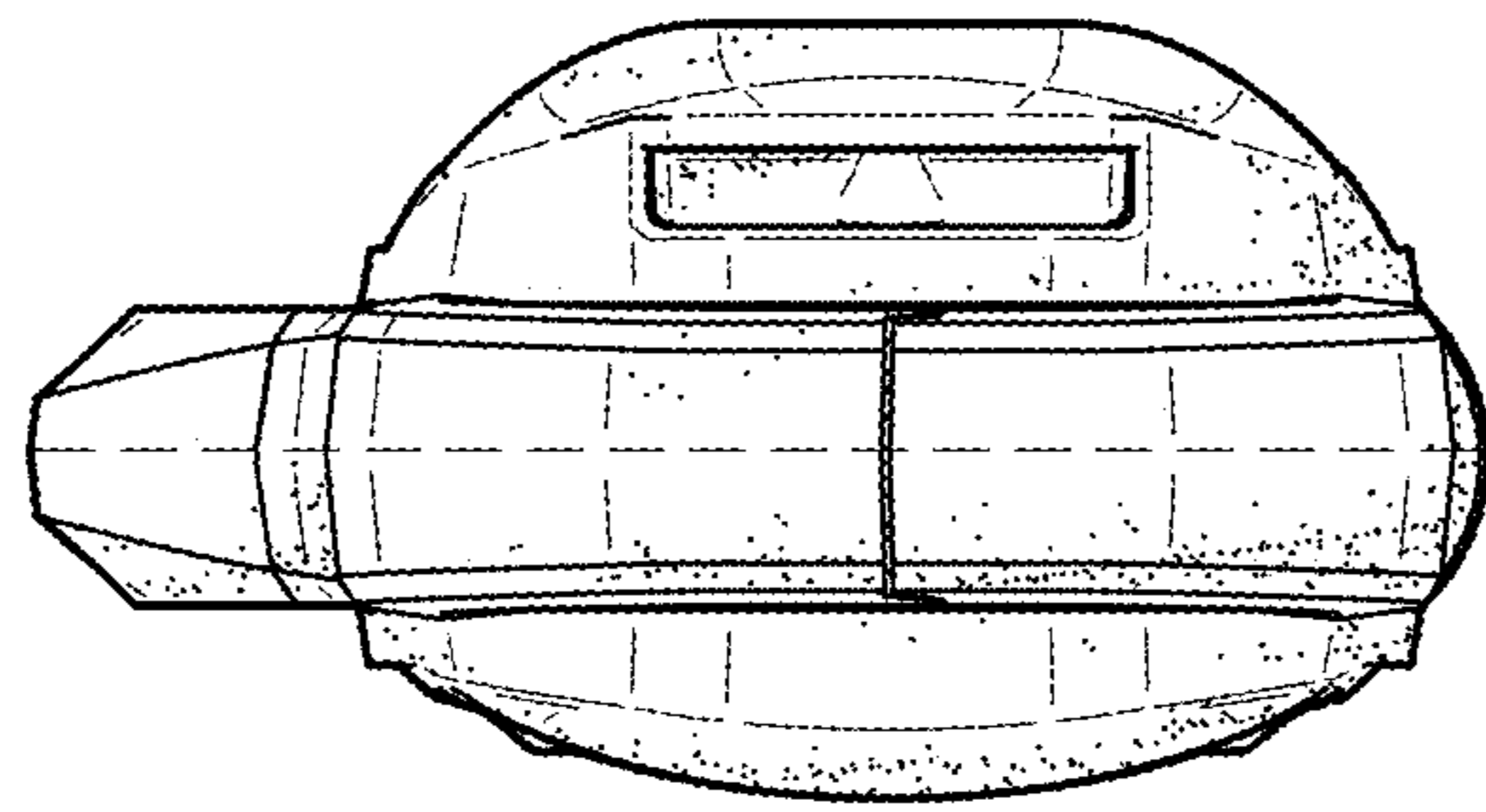

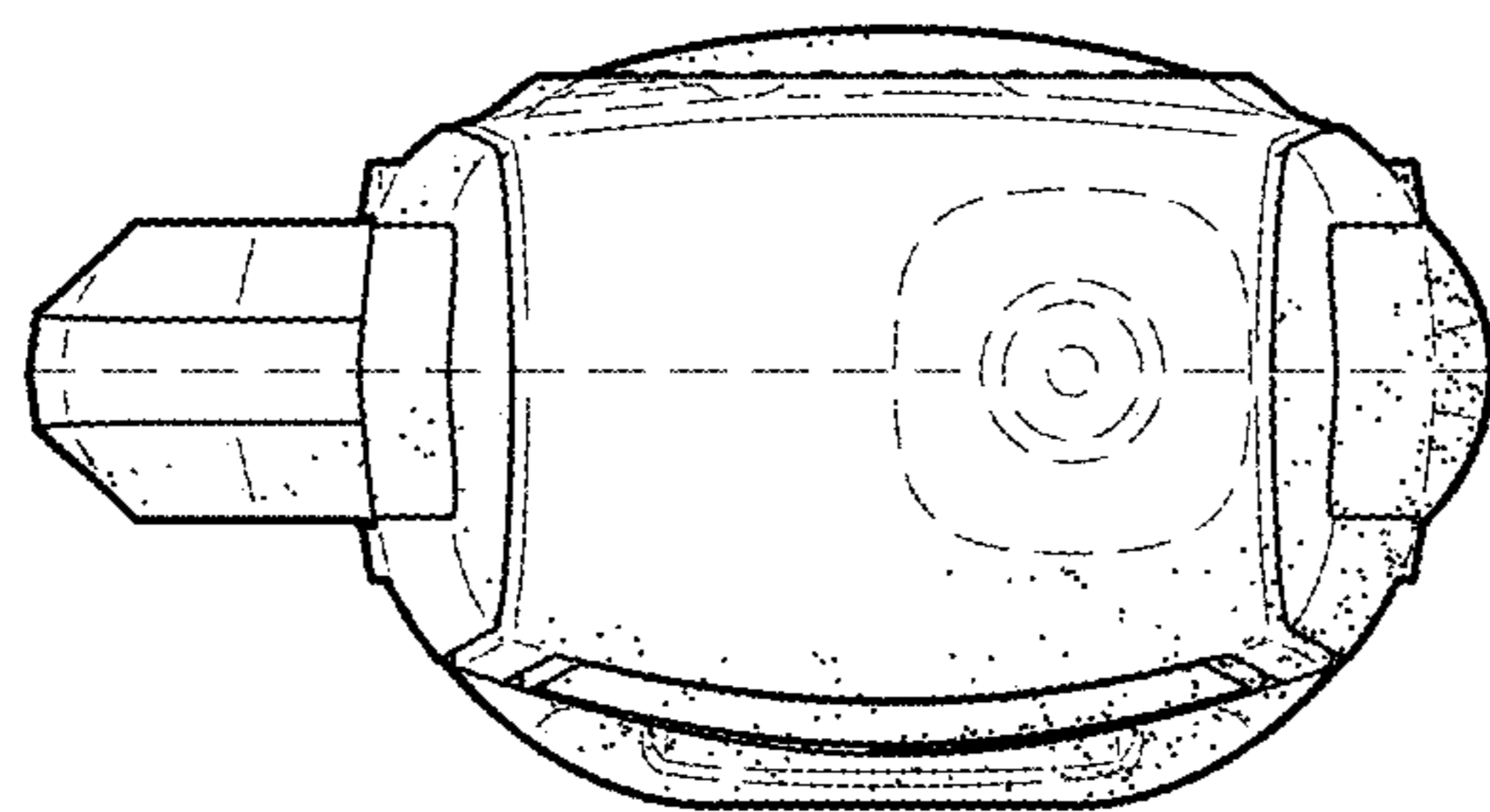

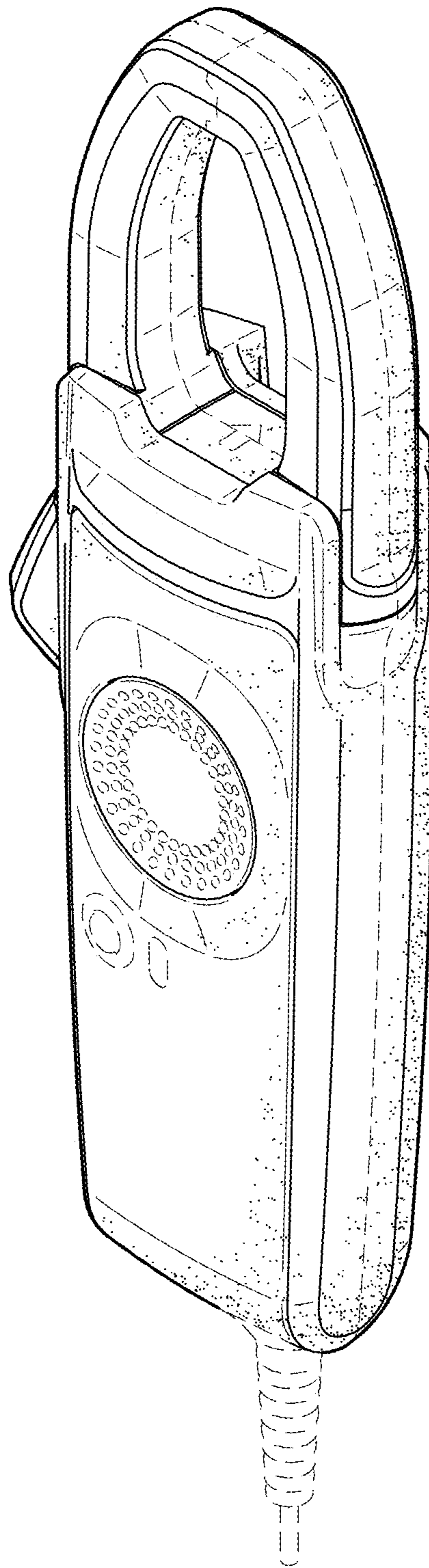

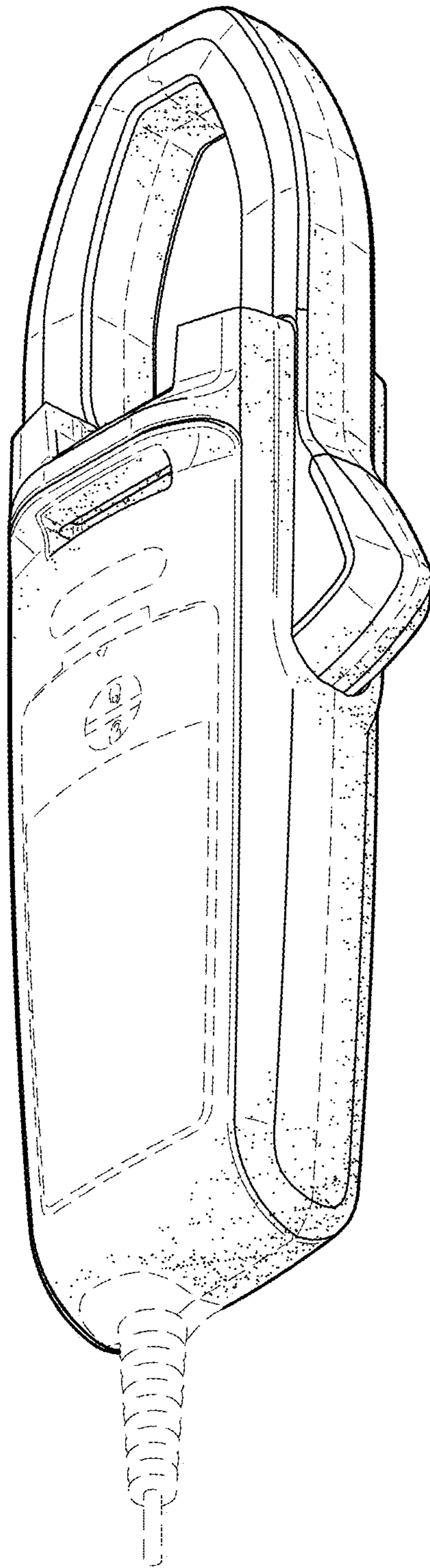

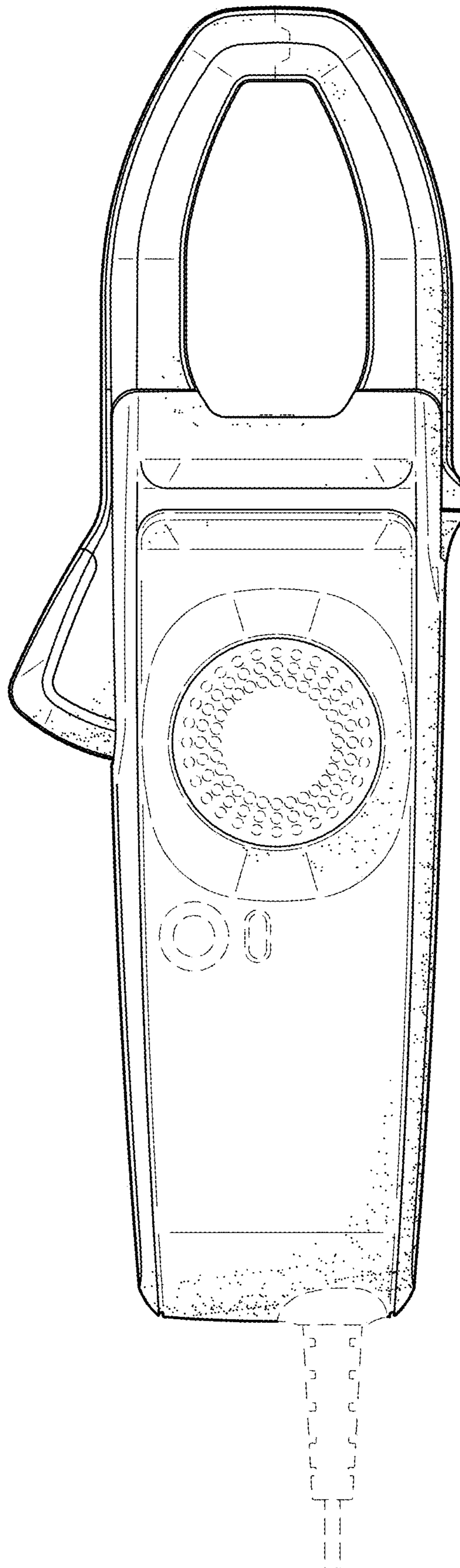

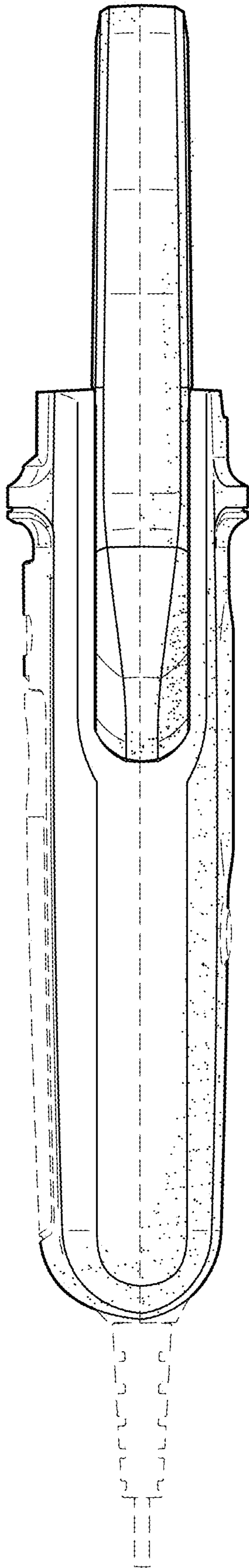

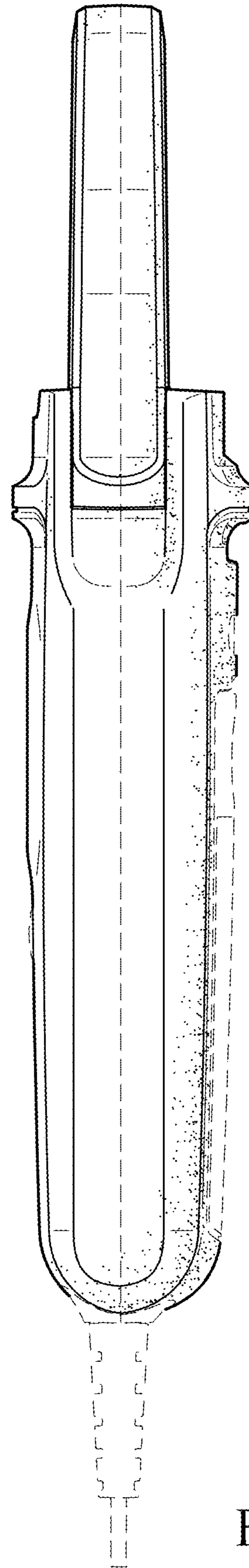

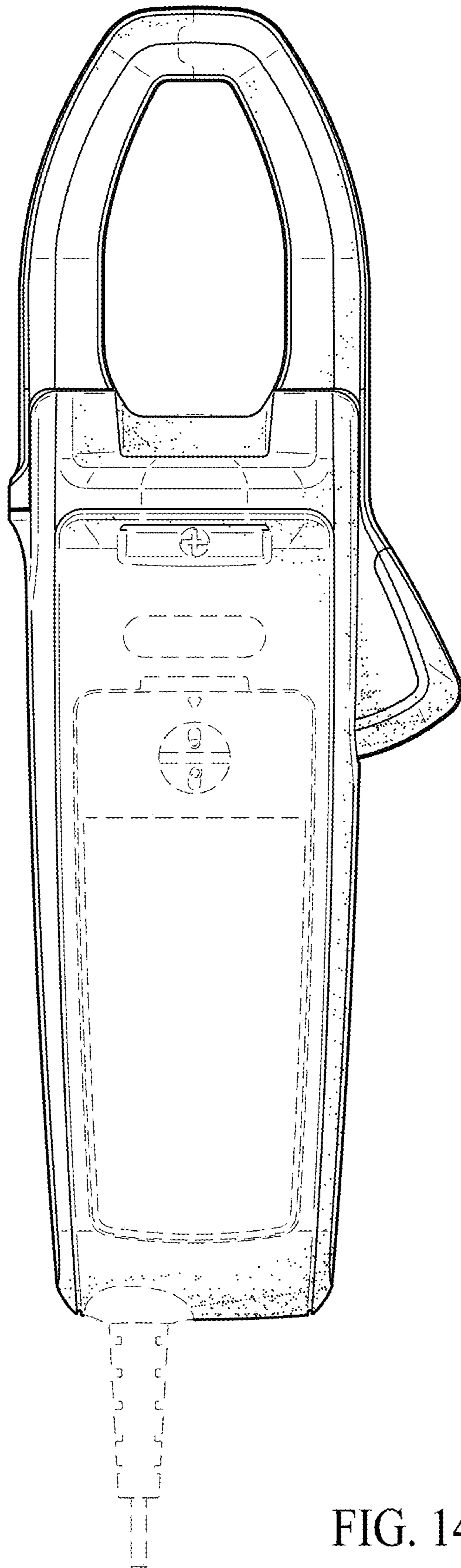

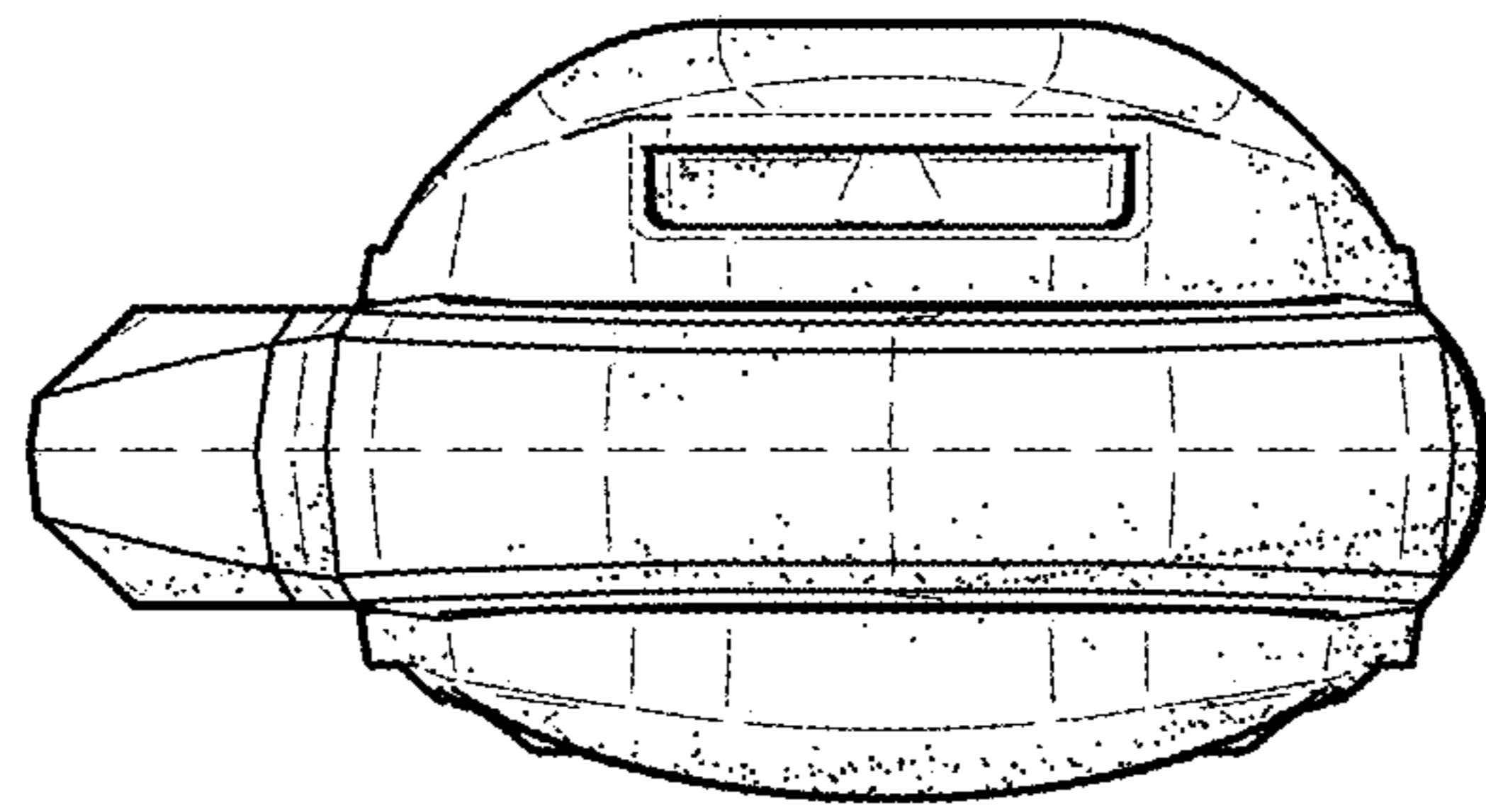

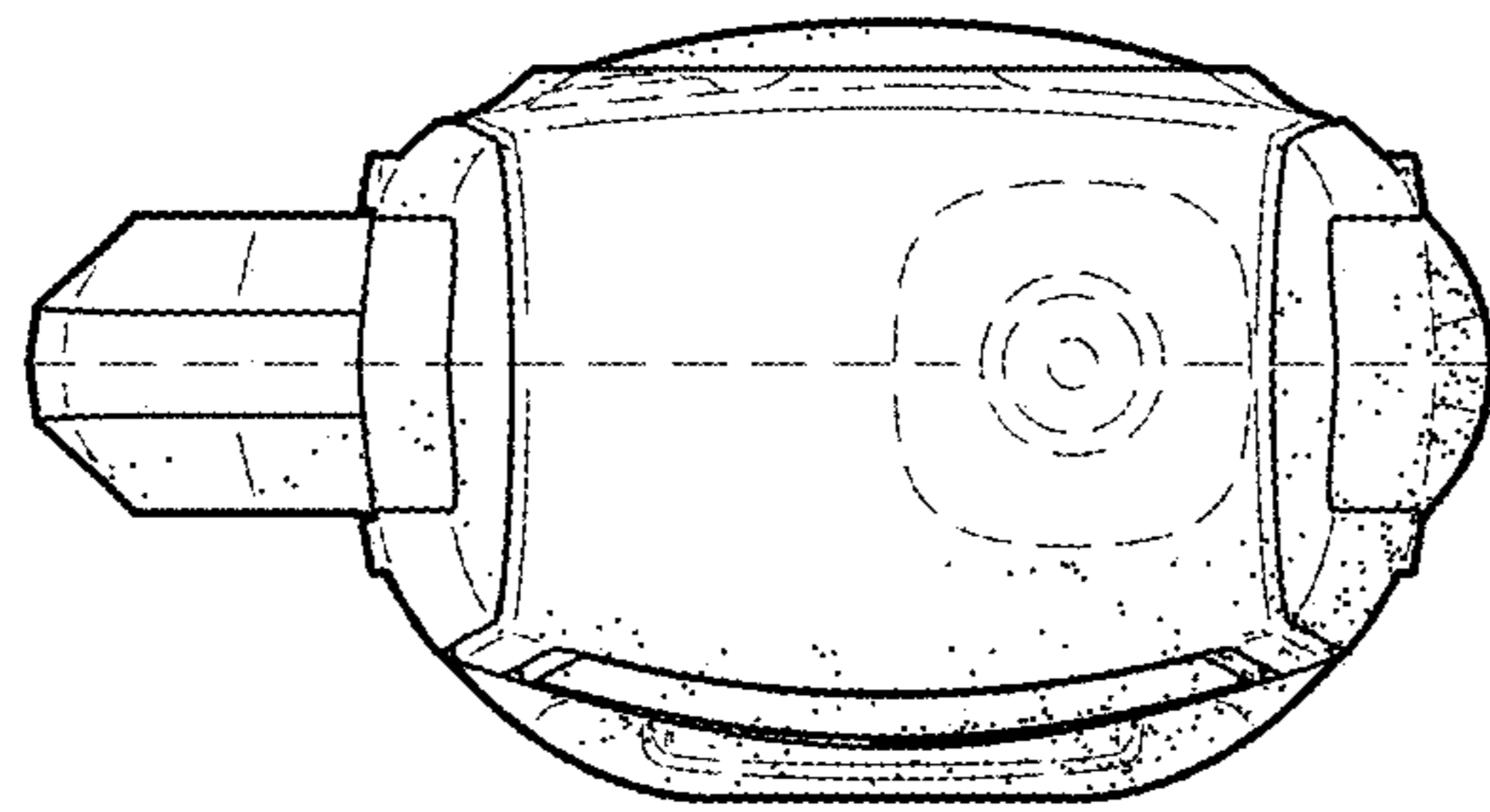
