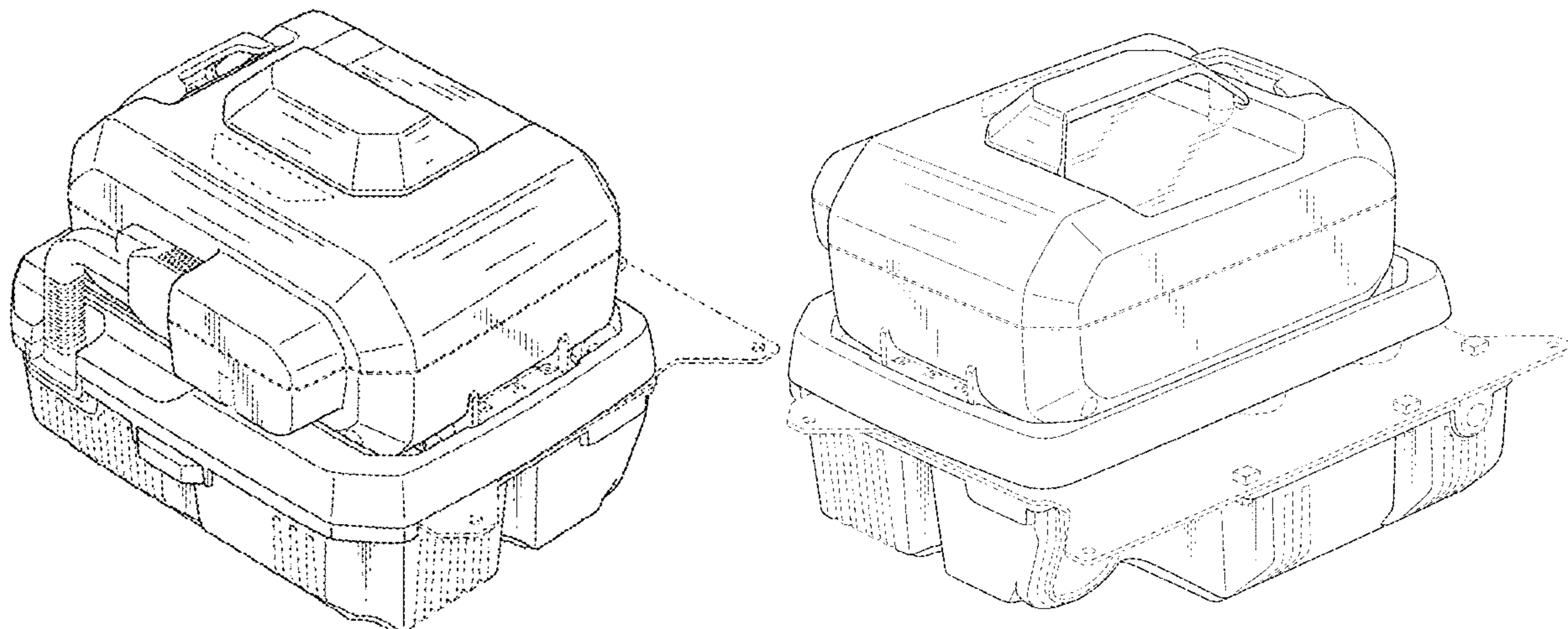
(57) **CLAIM**

The ornamental design for a battery module for electric power unit, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and right perspective view of a battery module for electric power unit;  
FIG. 2 is a front and left perspective view thereof;

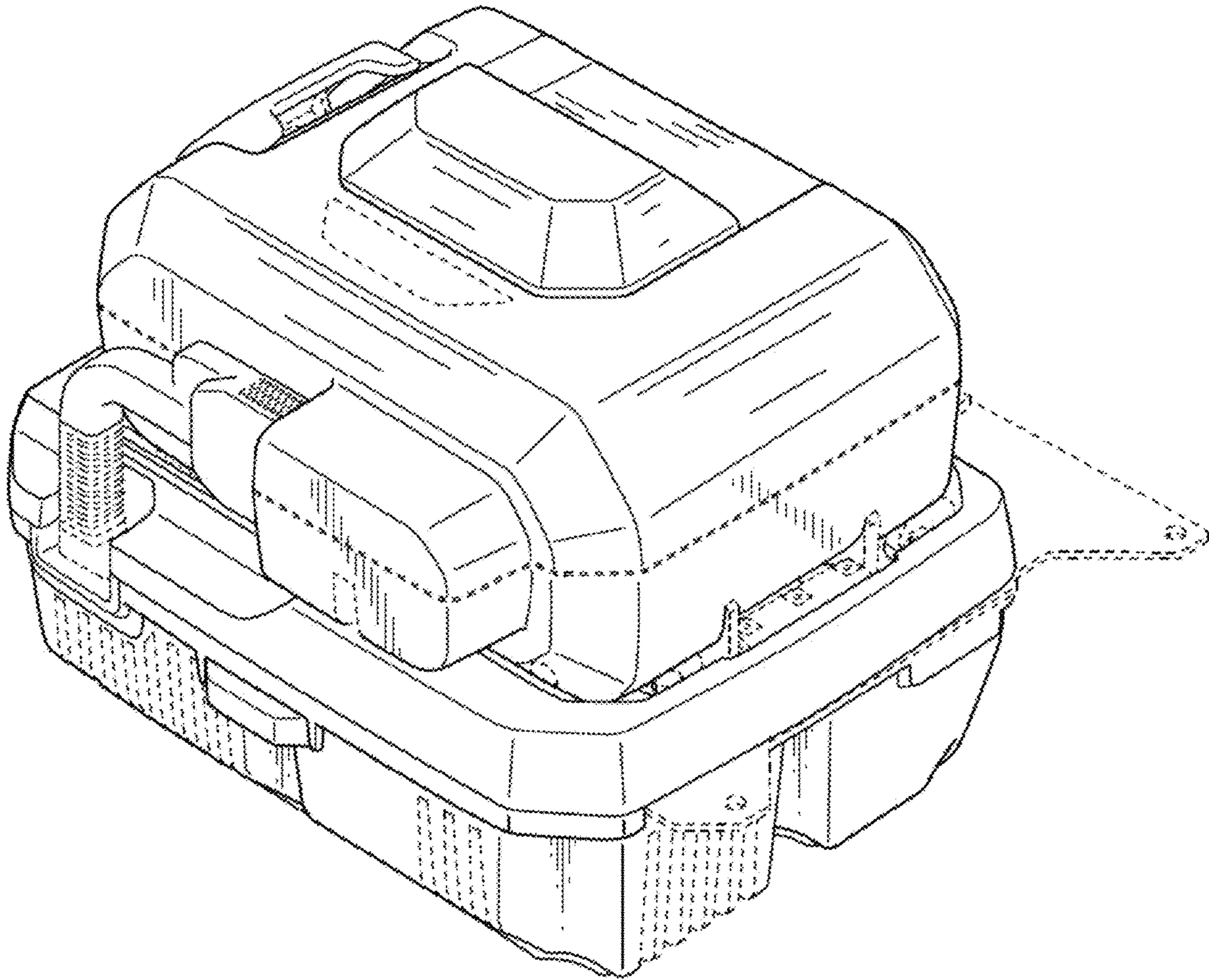

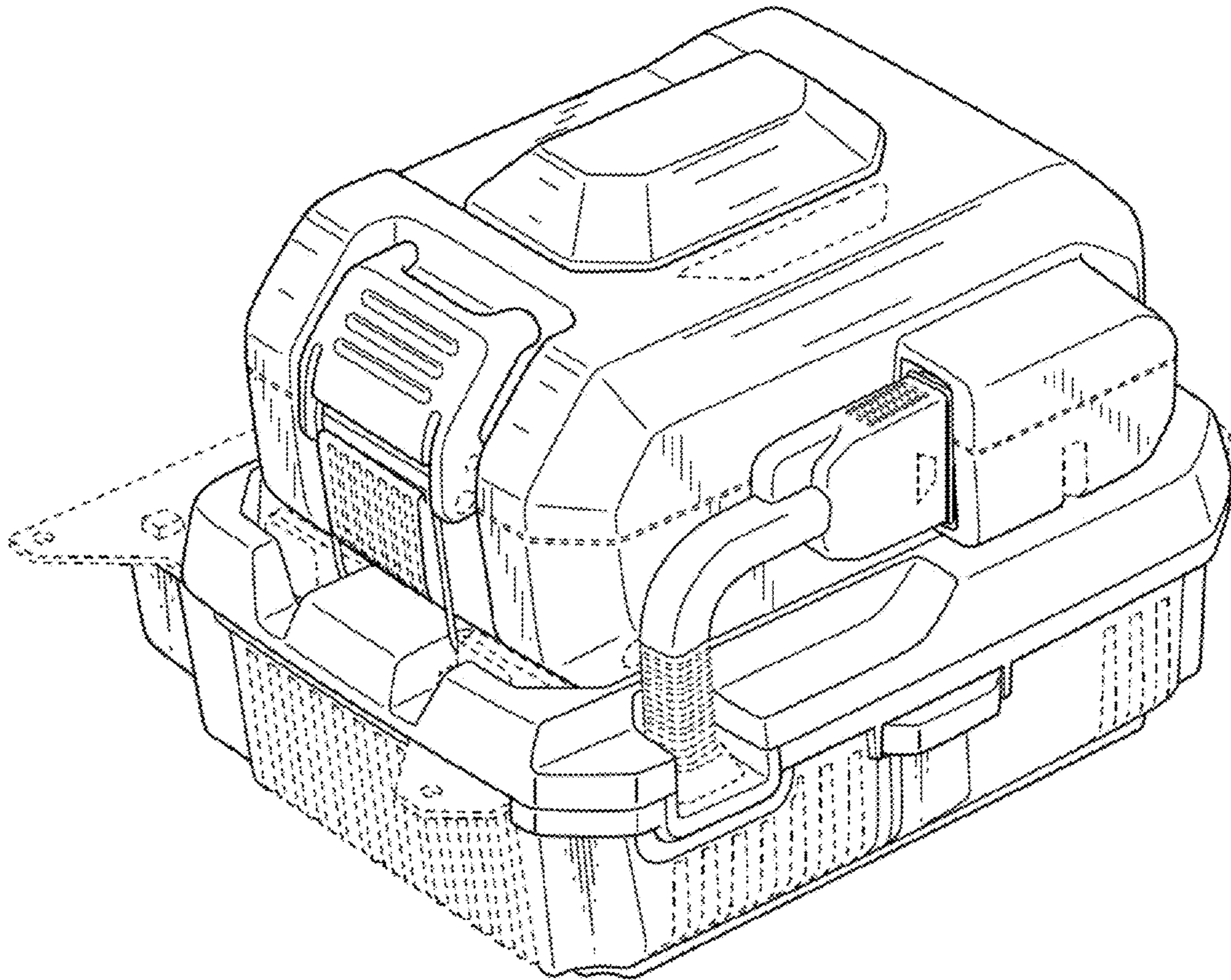

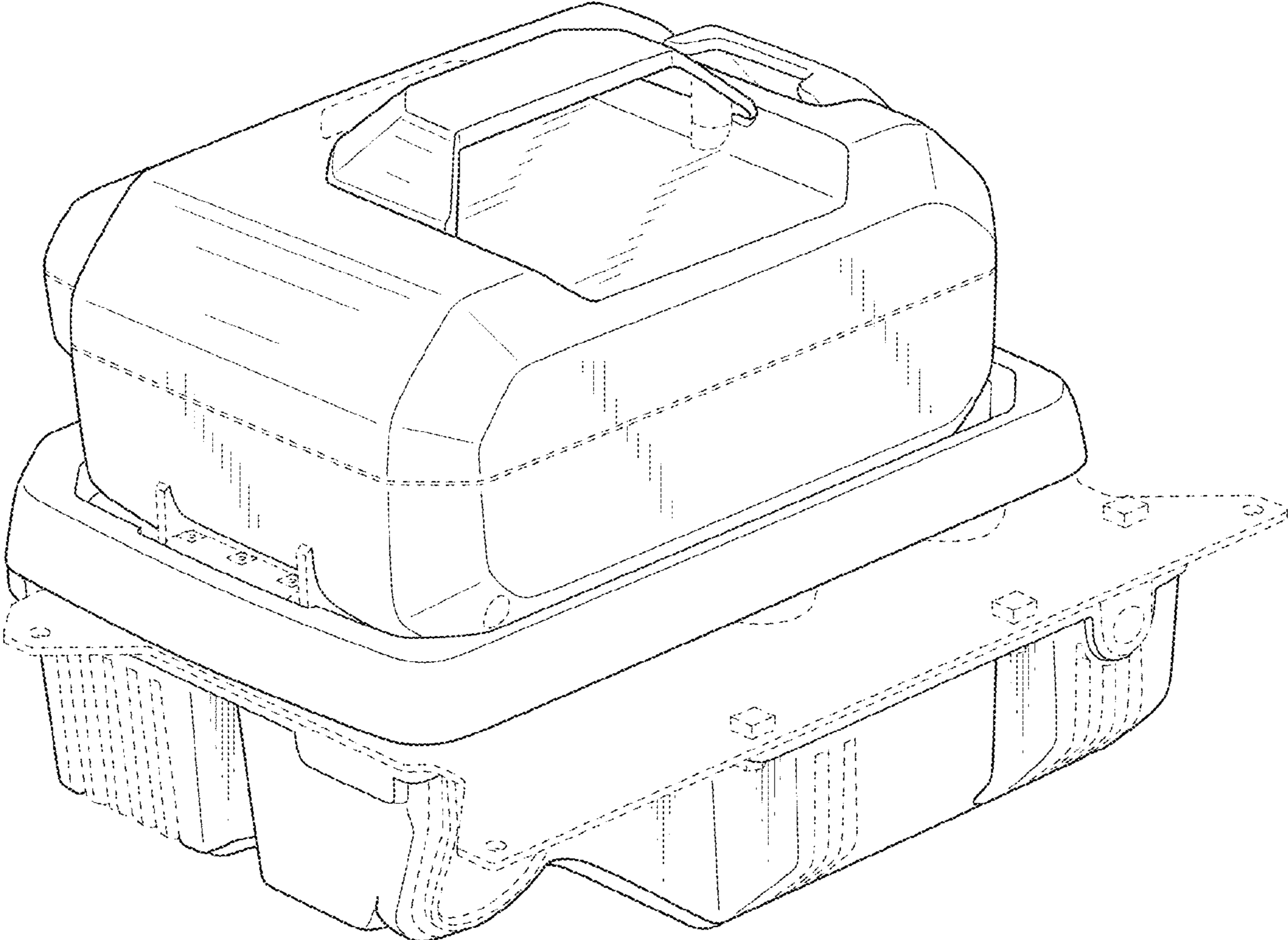

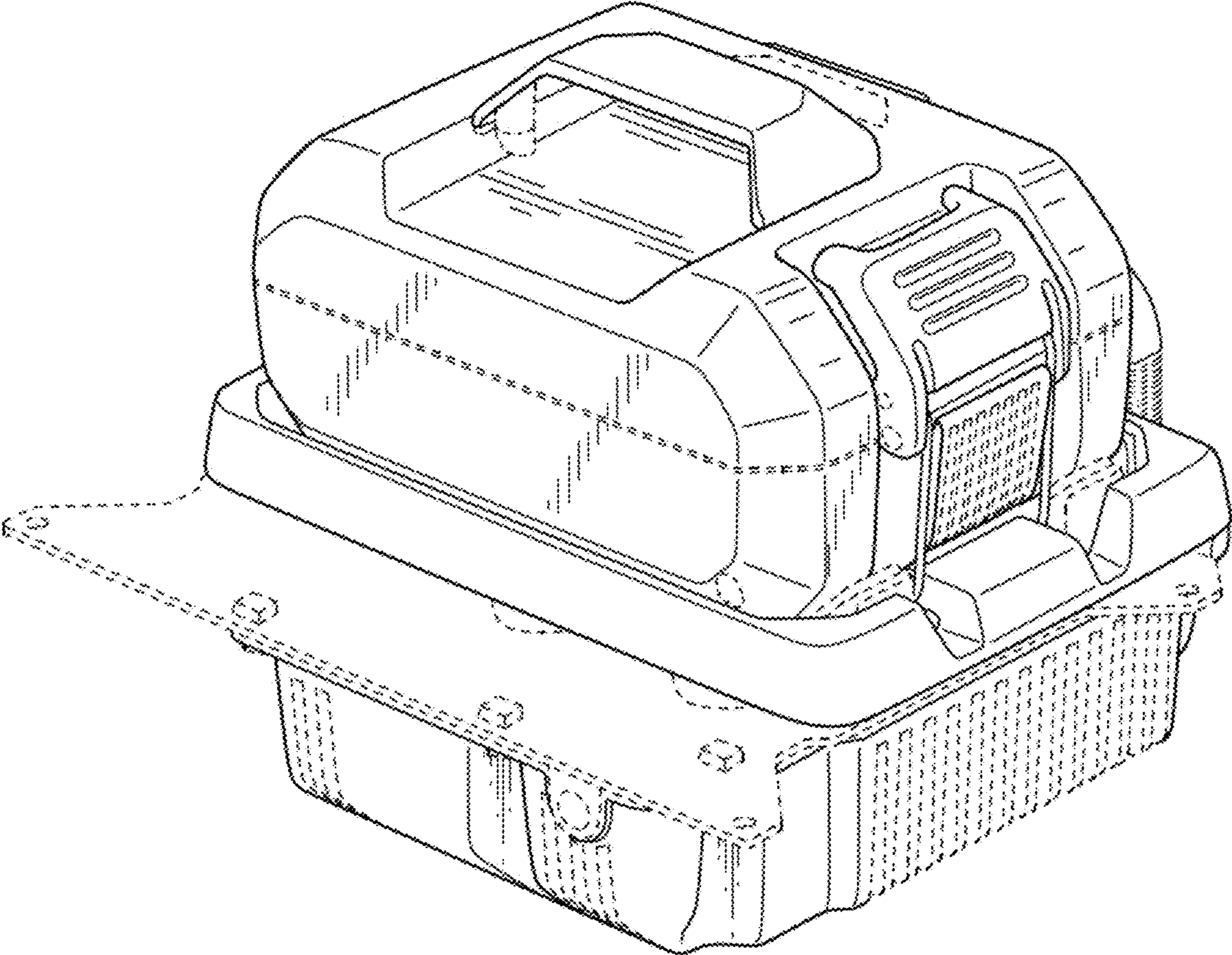

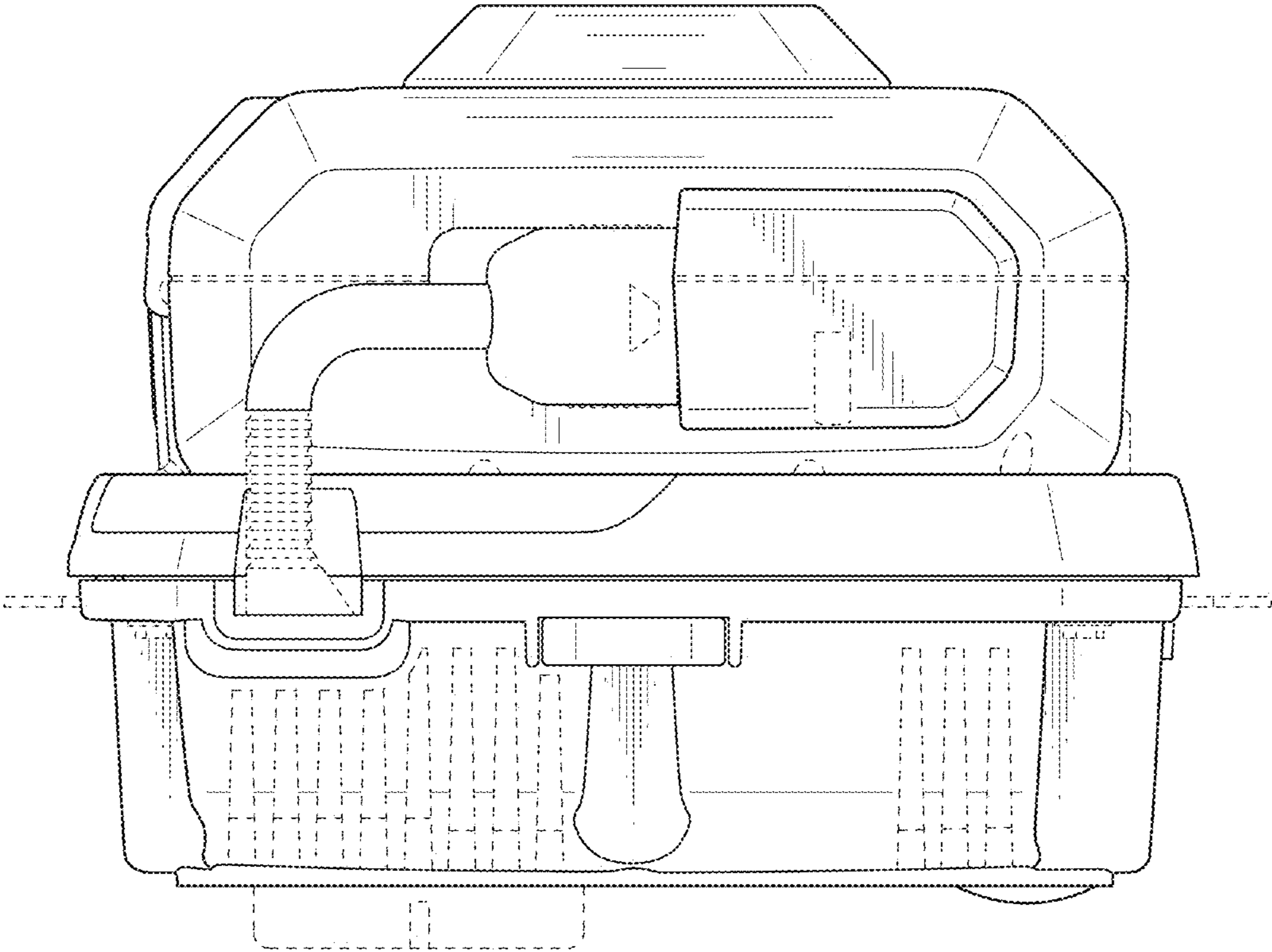

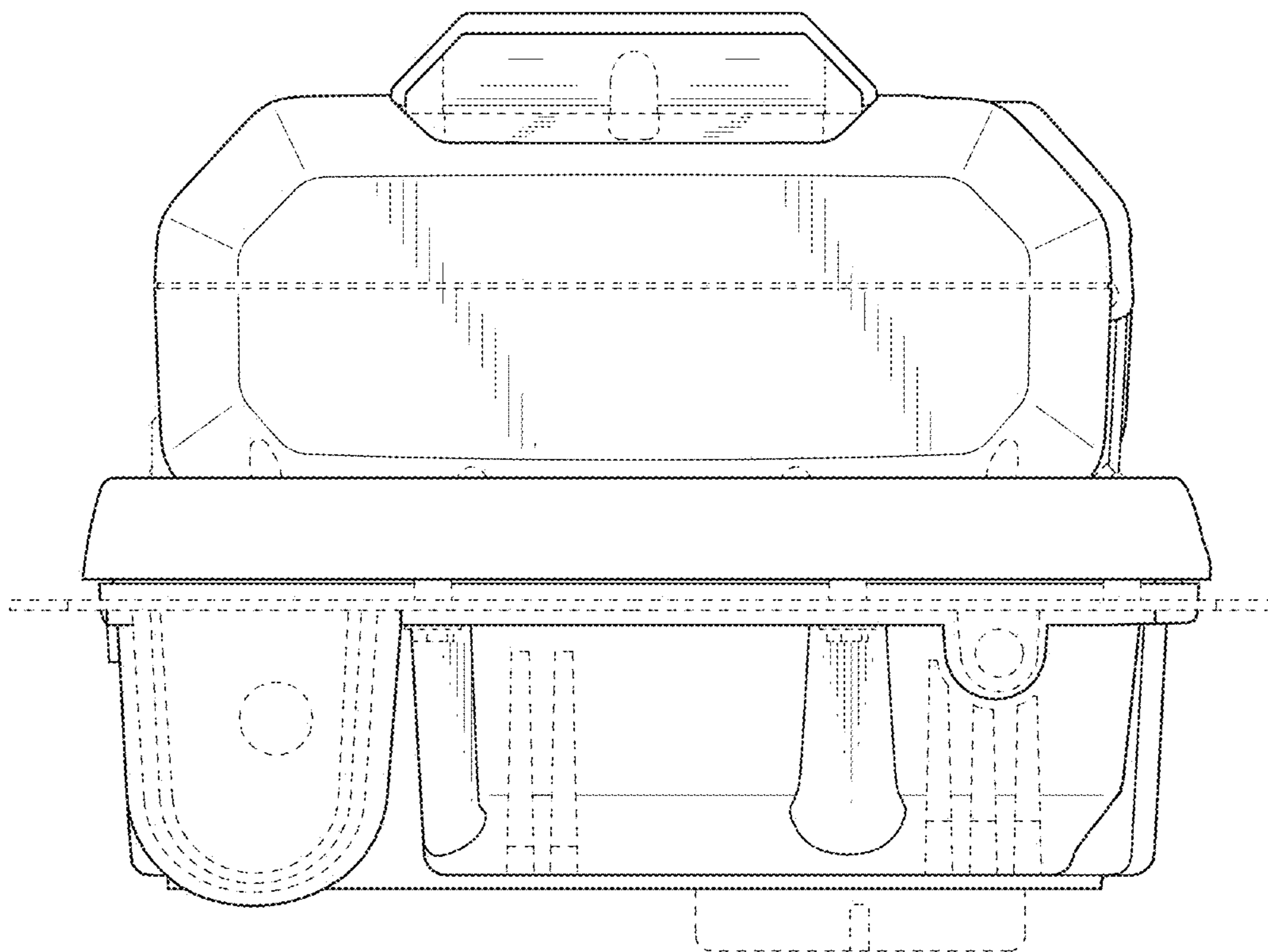

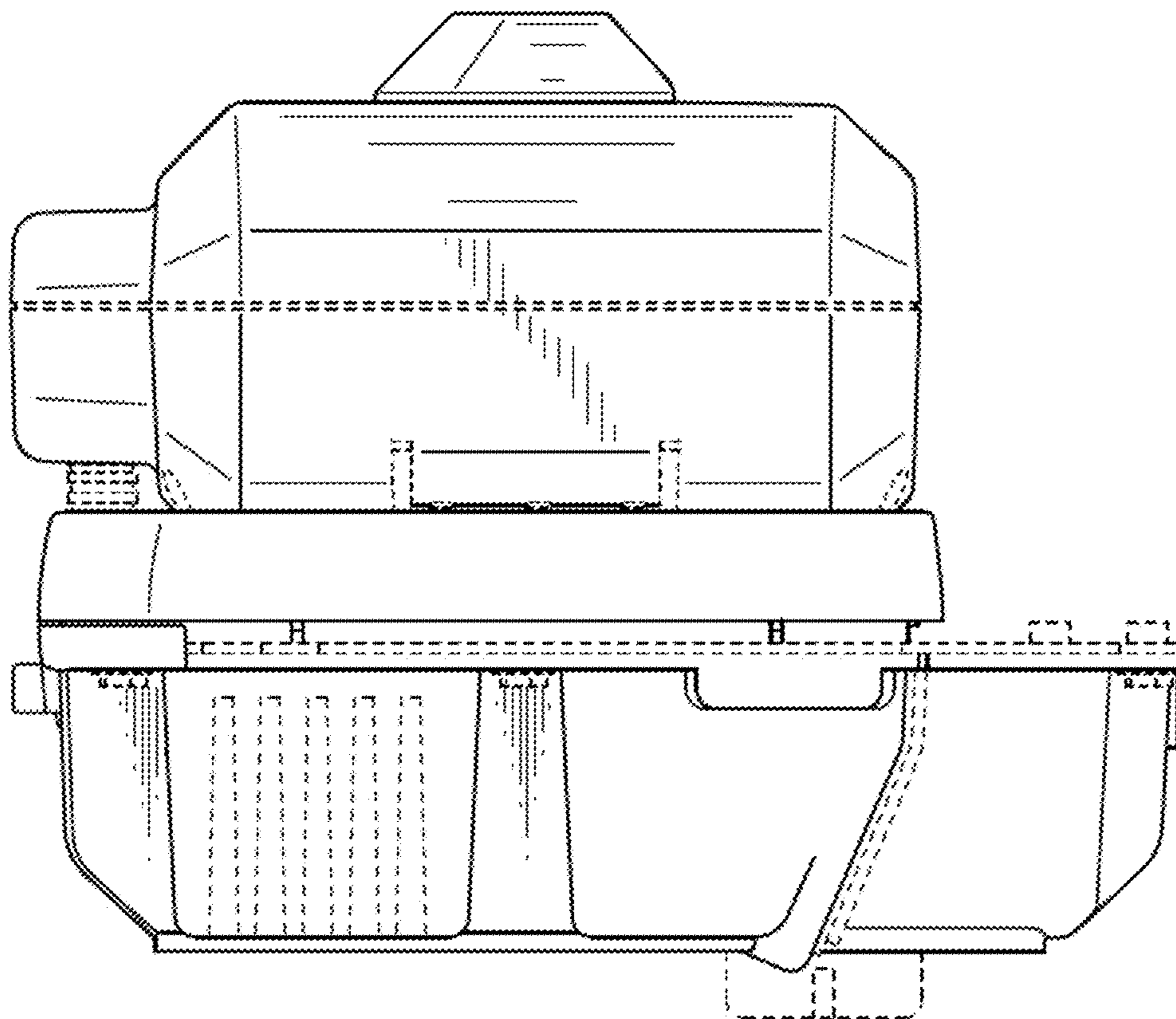

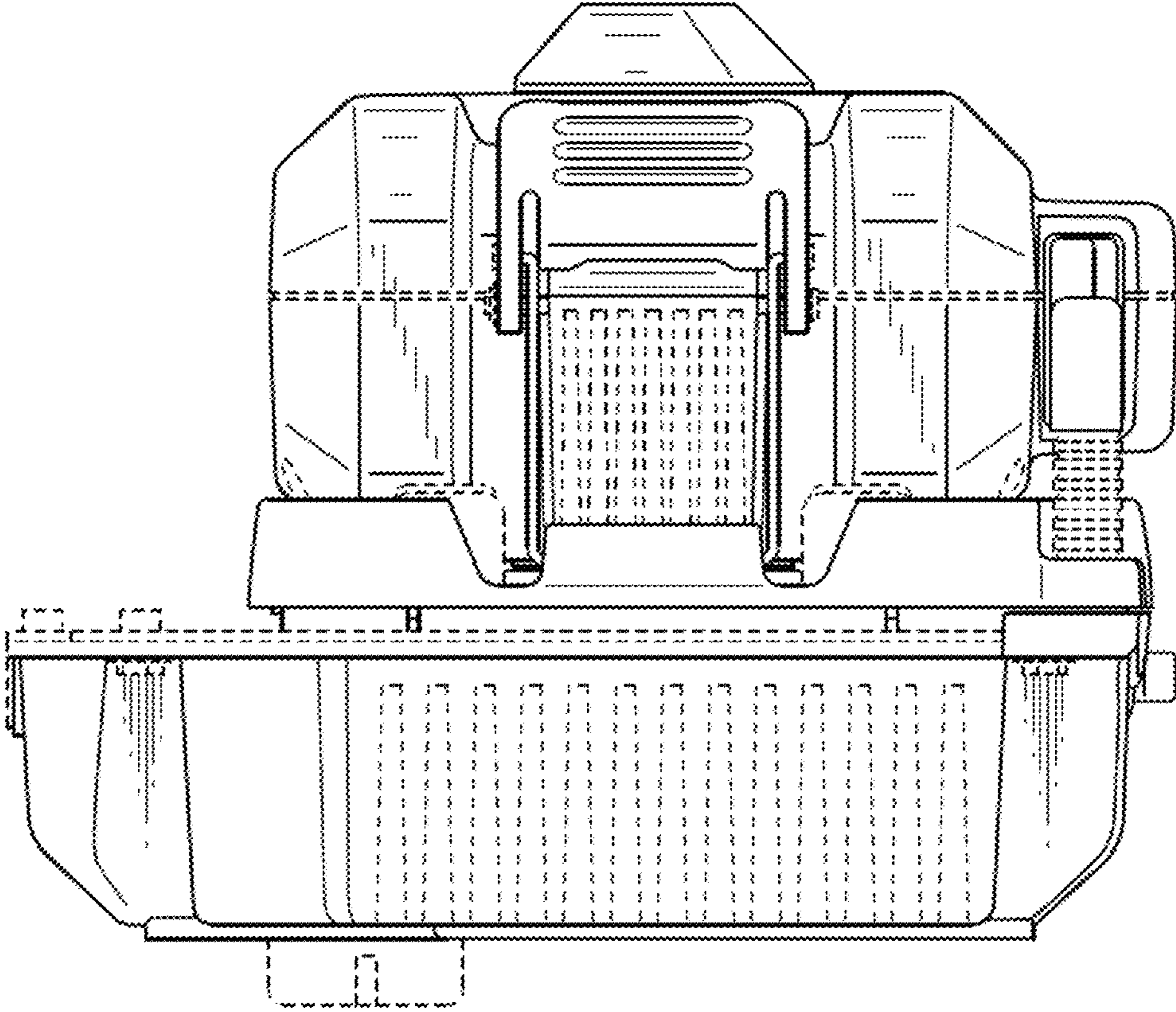

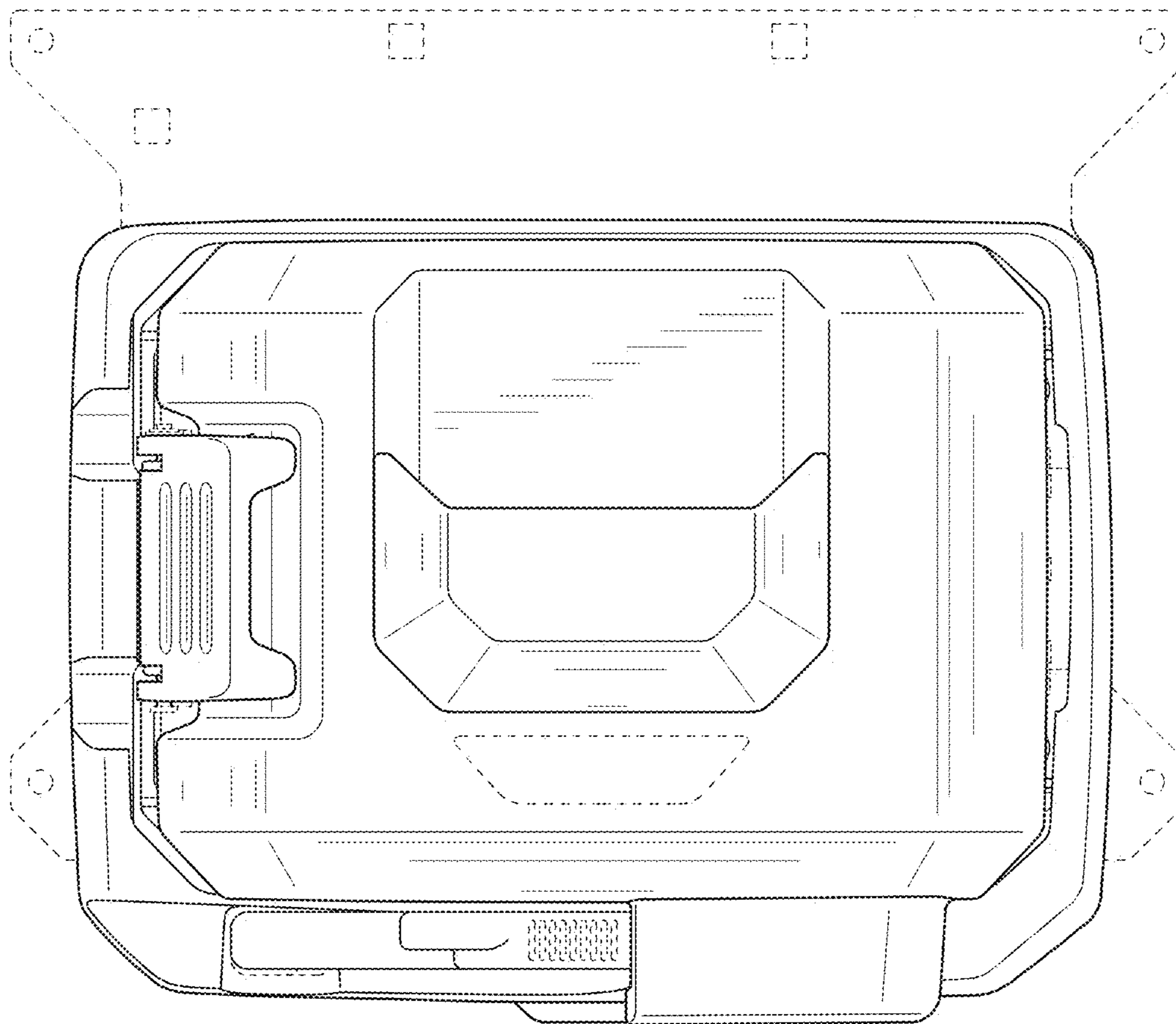

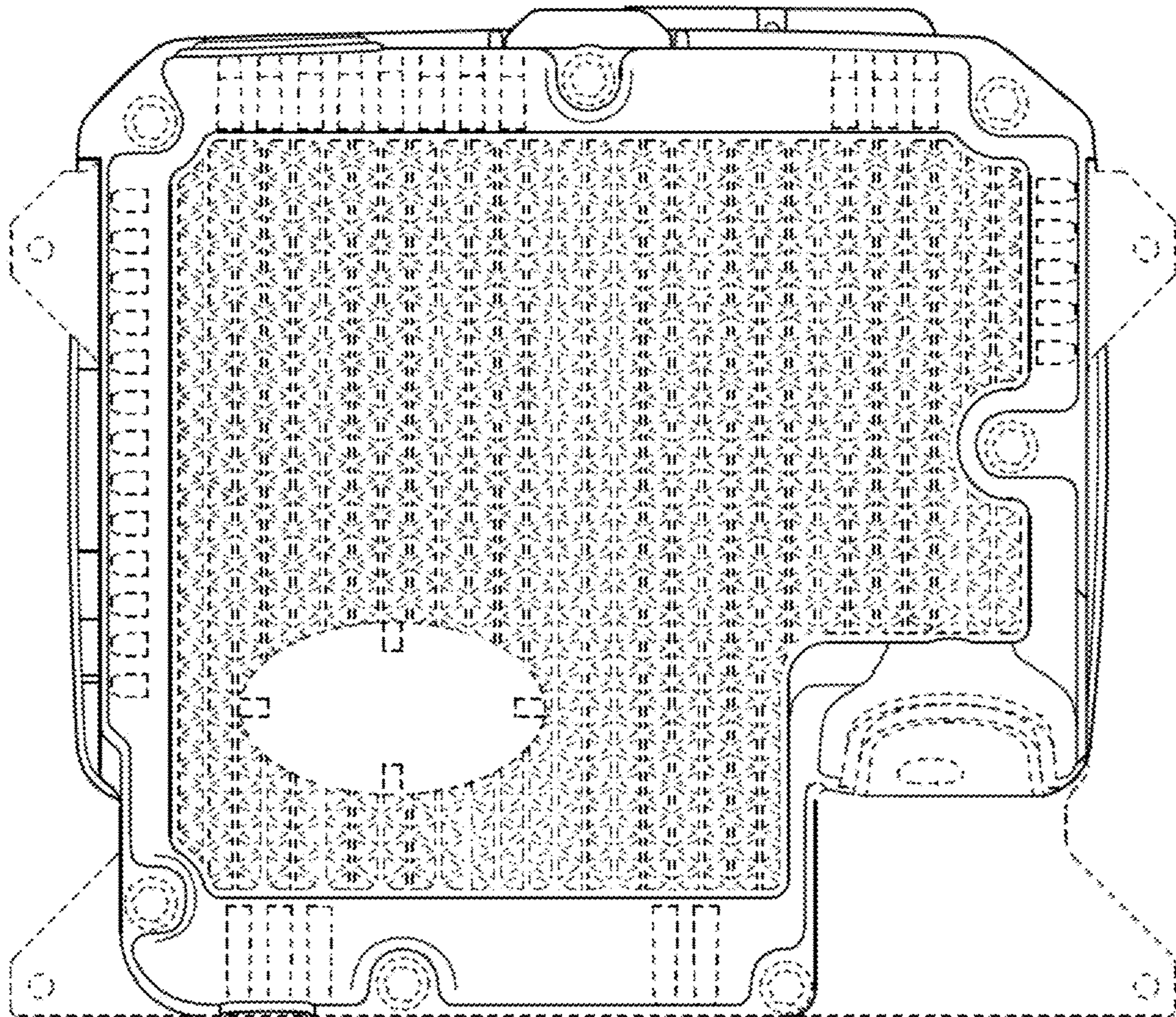
