(57) **CLAIM**

The ornamental design for a power bank for earphones, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, left side perspective view of a power bank for earphones, showing my new design closed in a first configuration;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

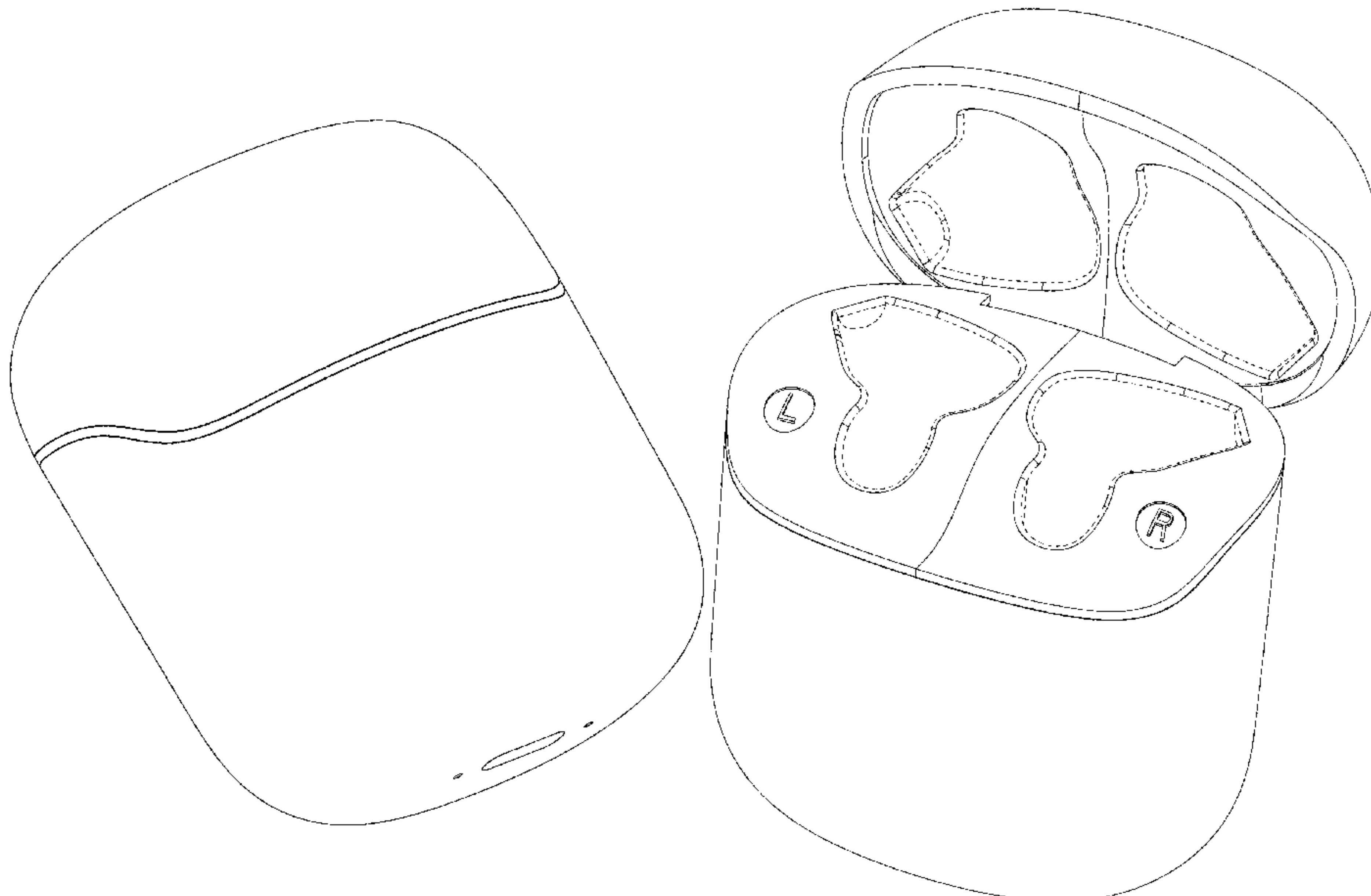
FIG. 6 is a top plan view thereof;

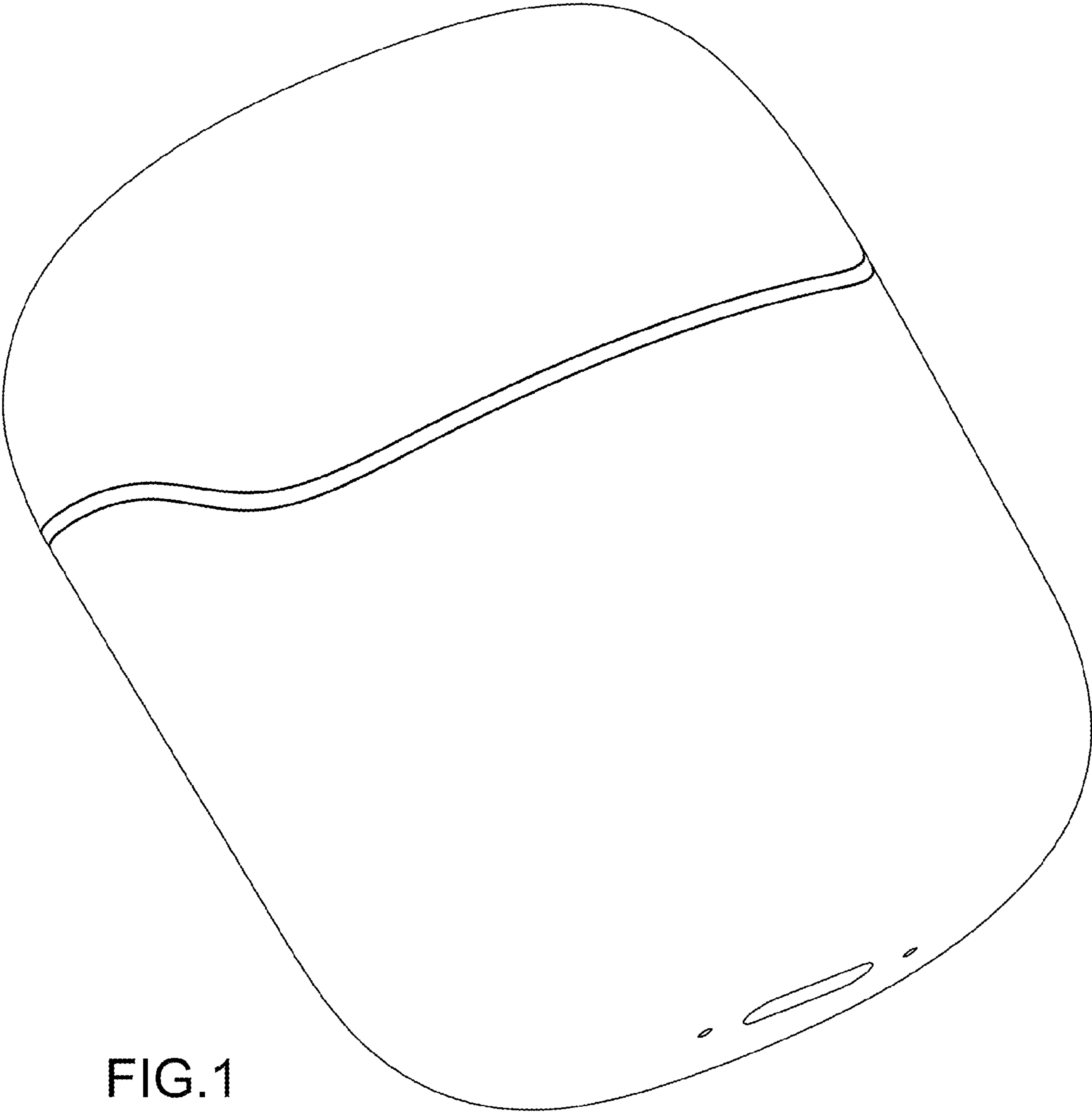

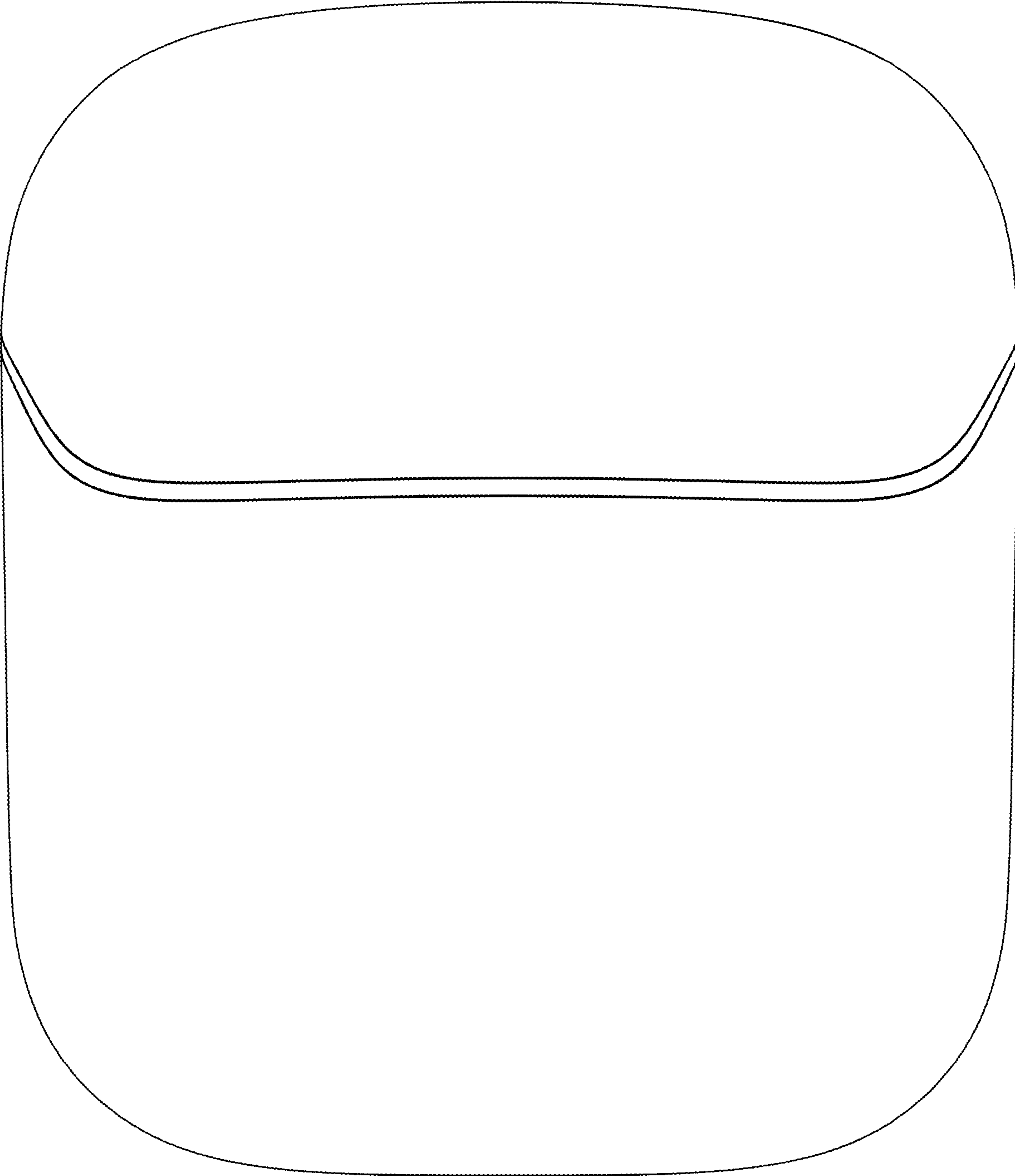

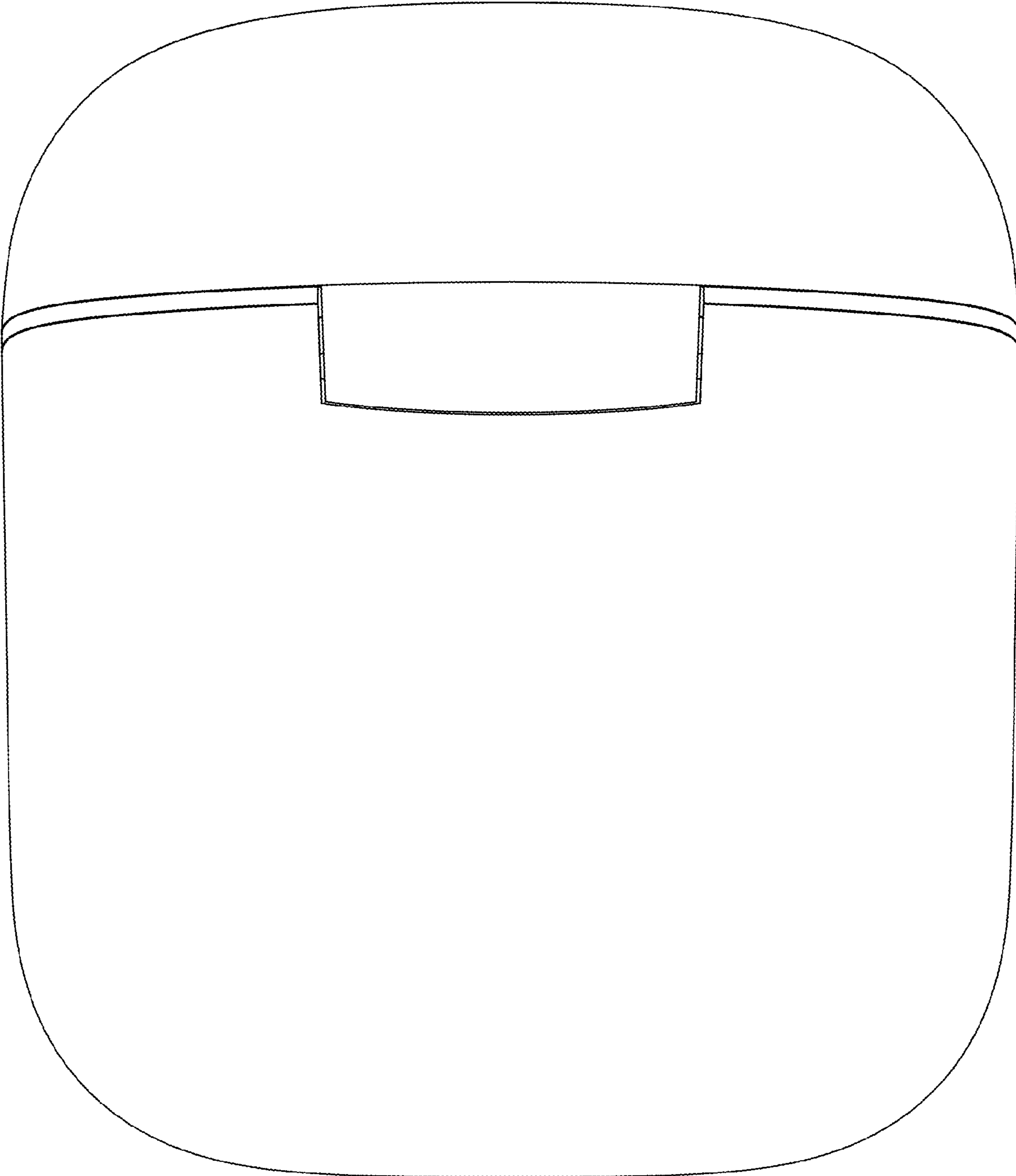

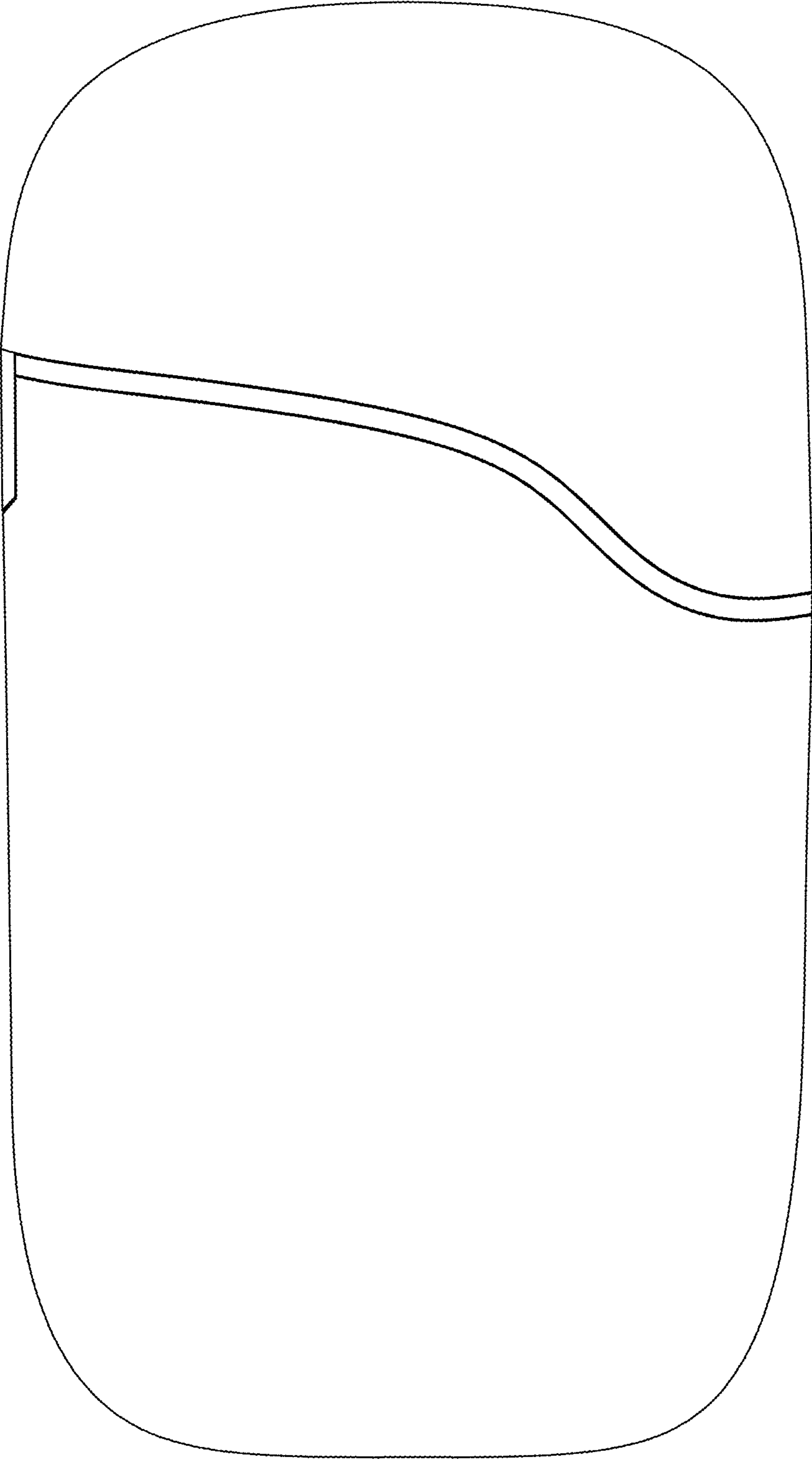

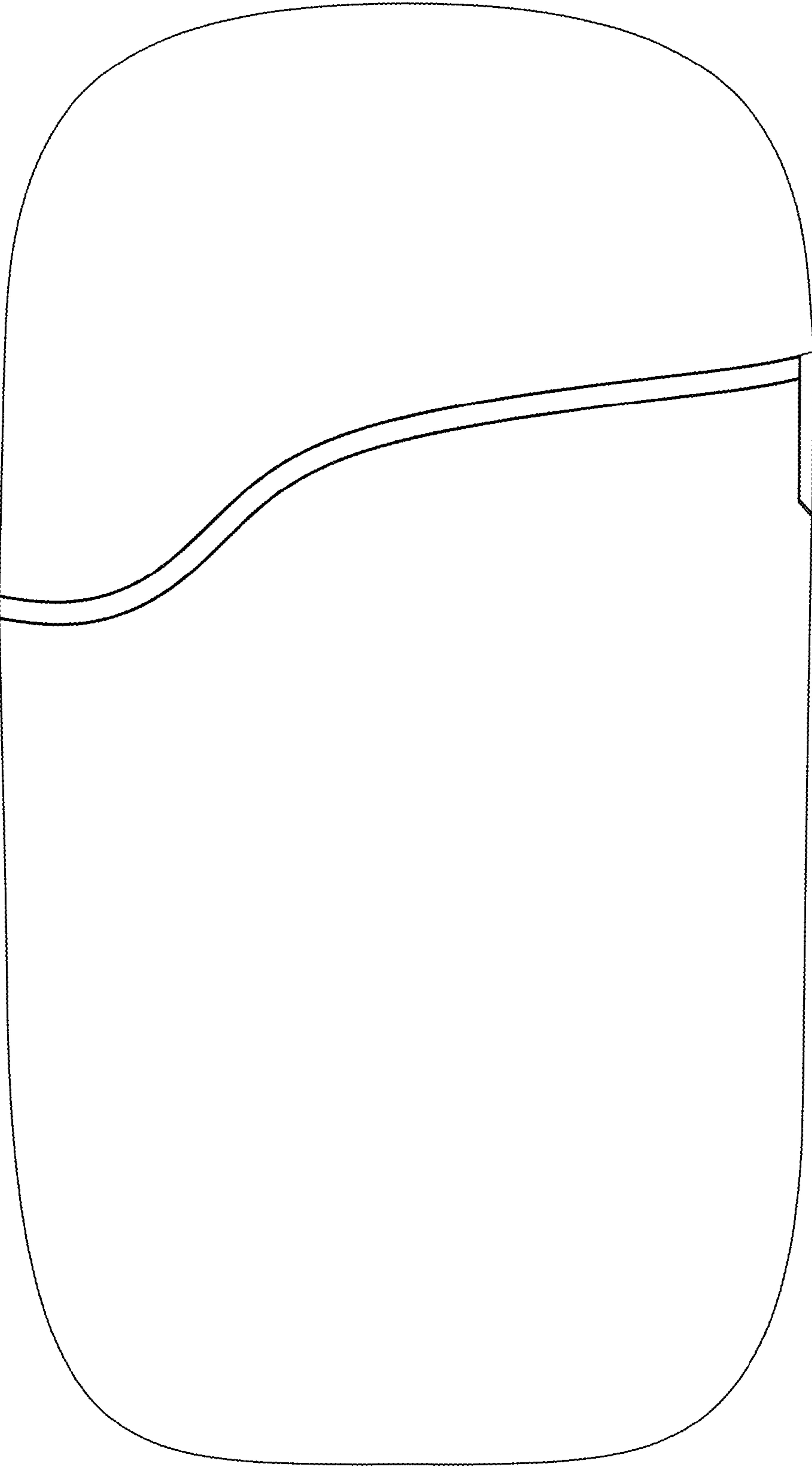

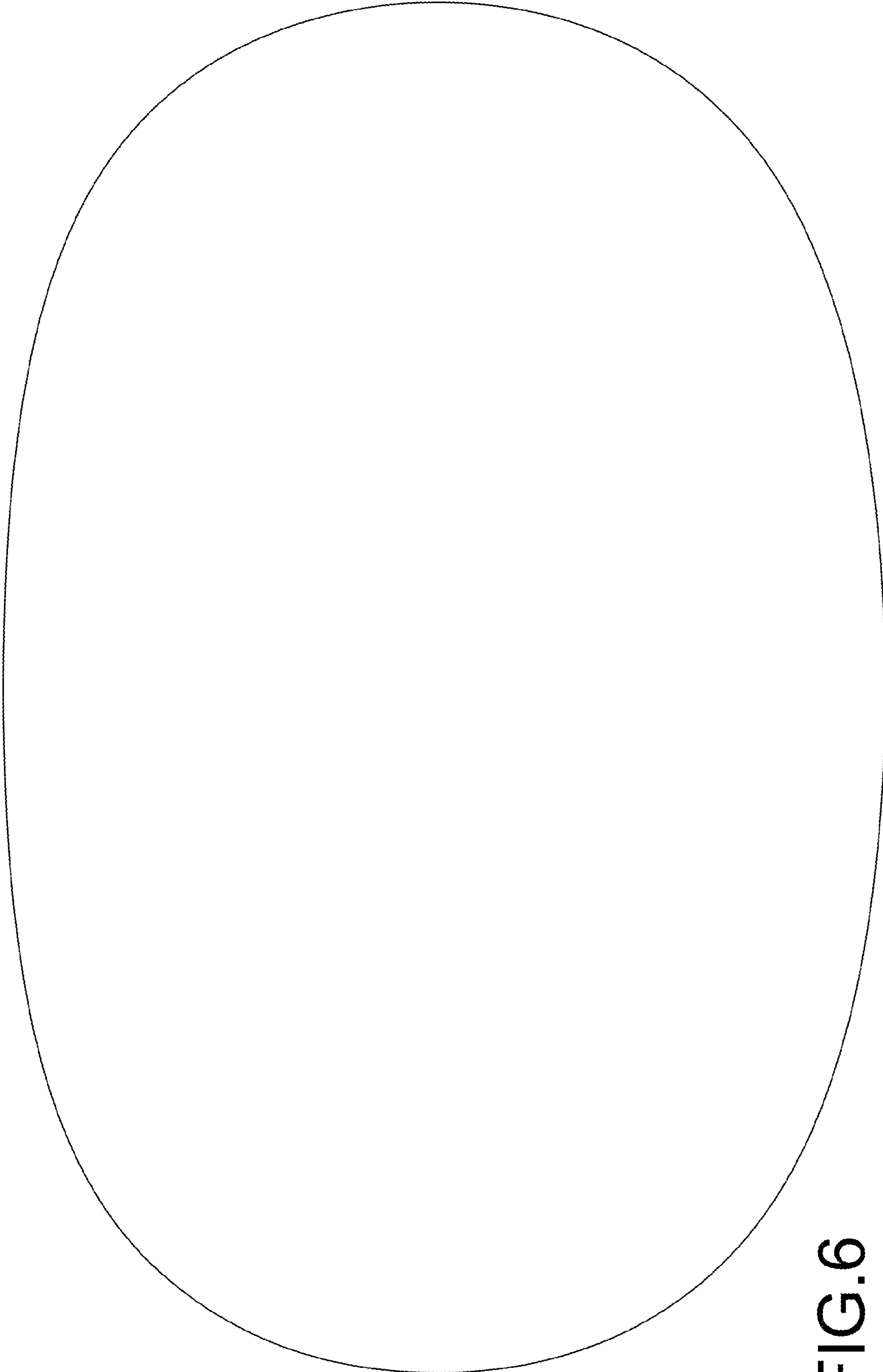

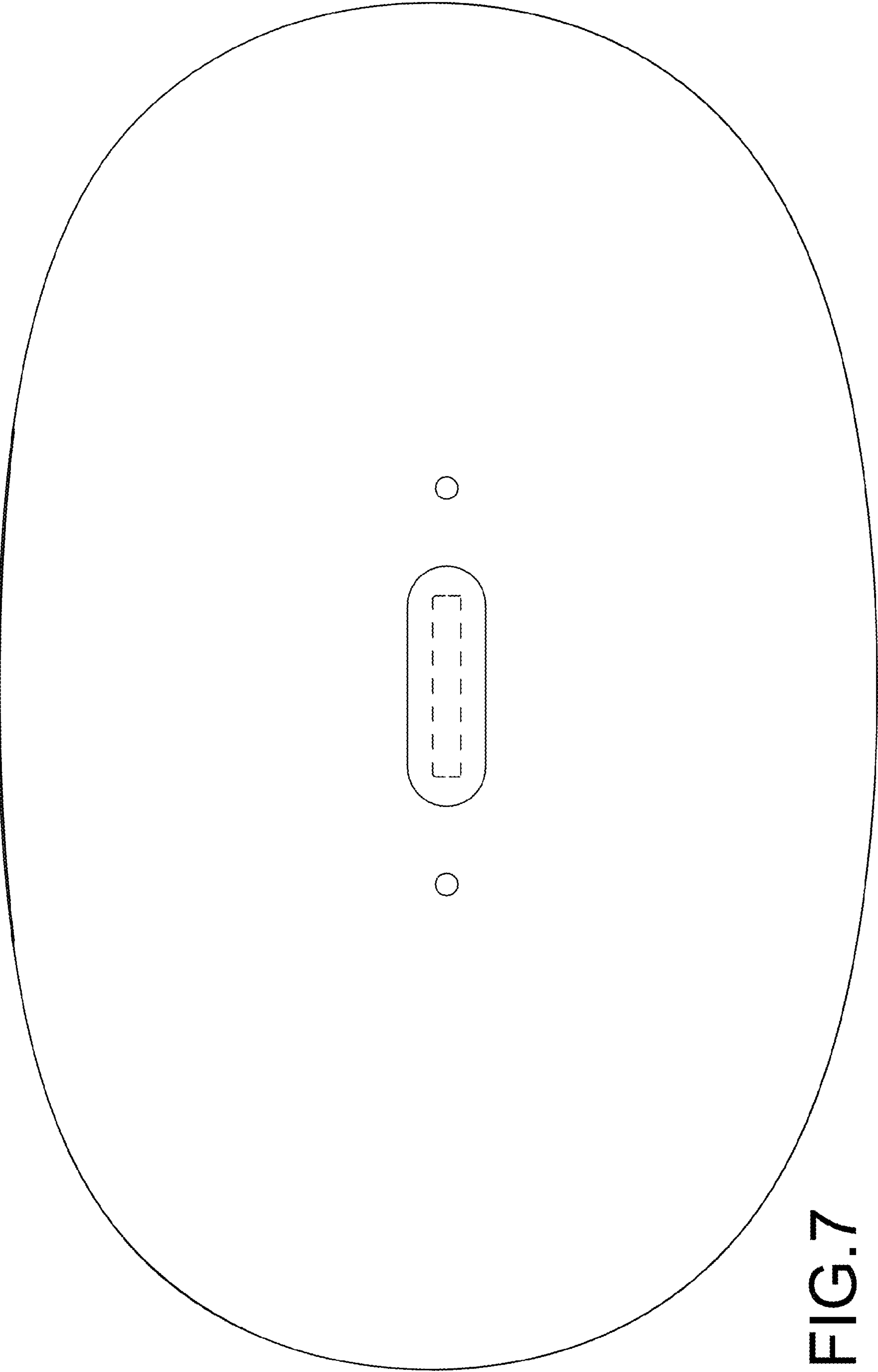

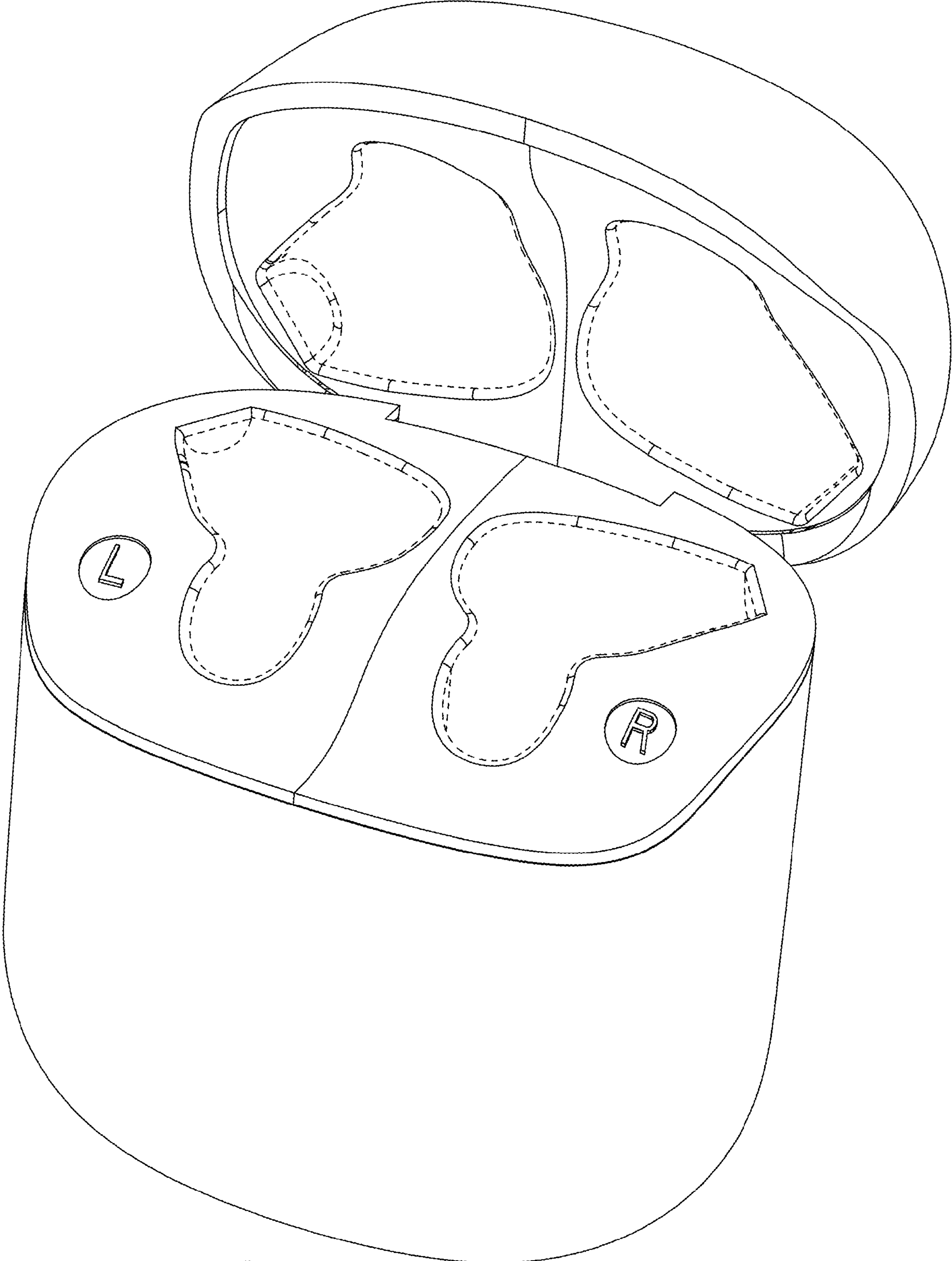
