FIG. 2 is a front view of a display screen or portion thereof with icon showing our new design according to a second embodiment; and,

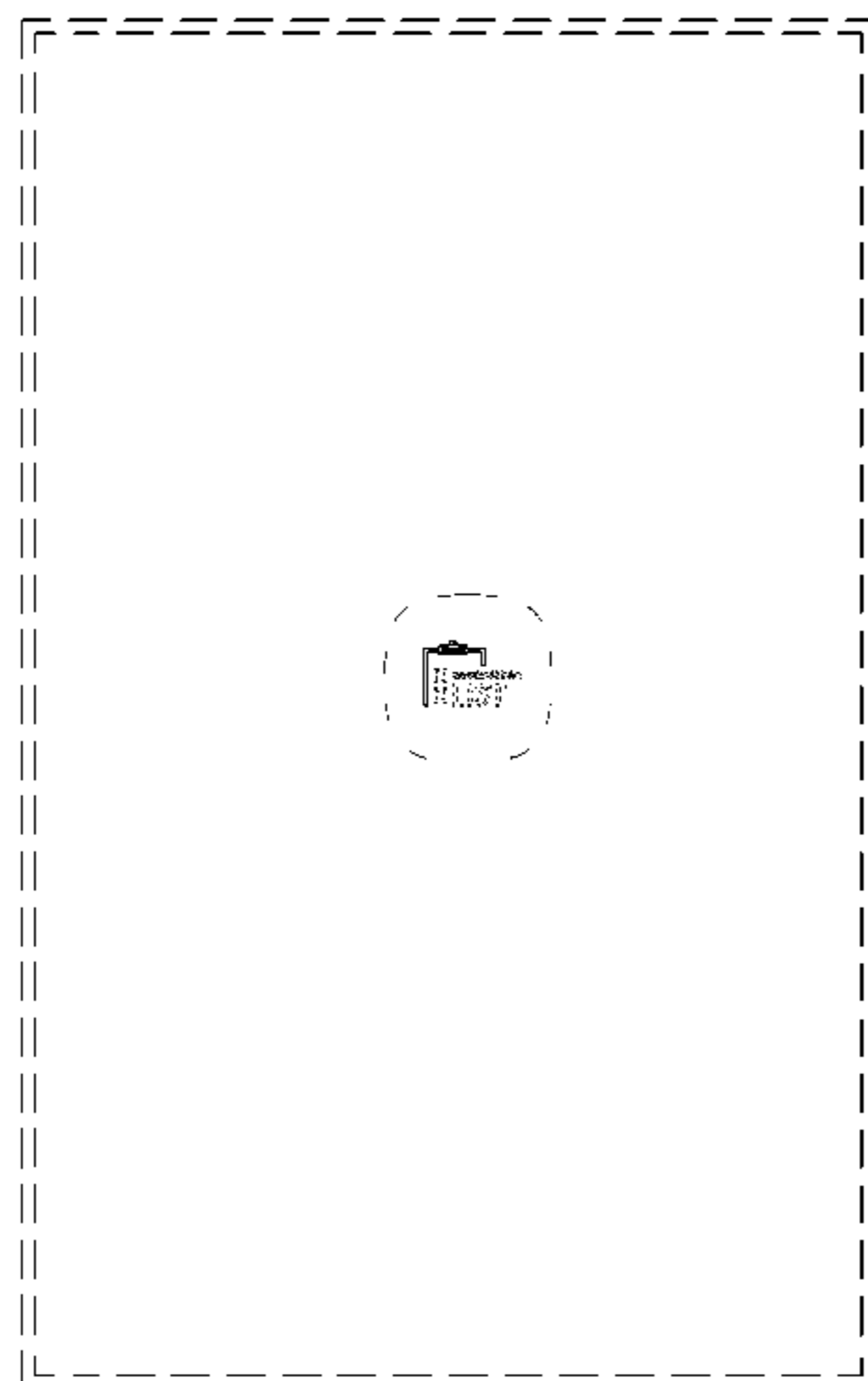

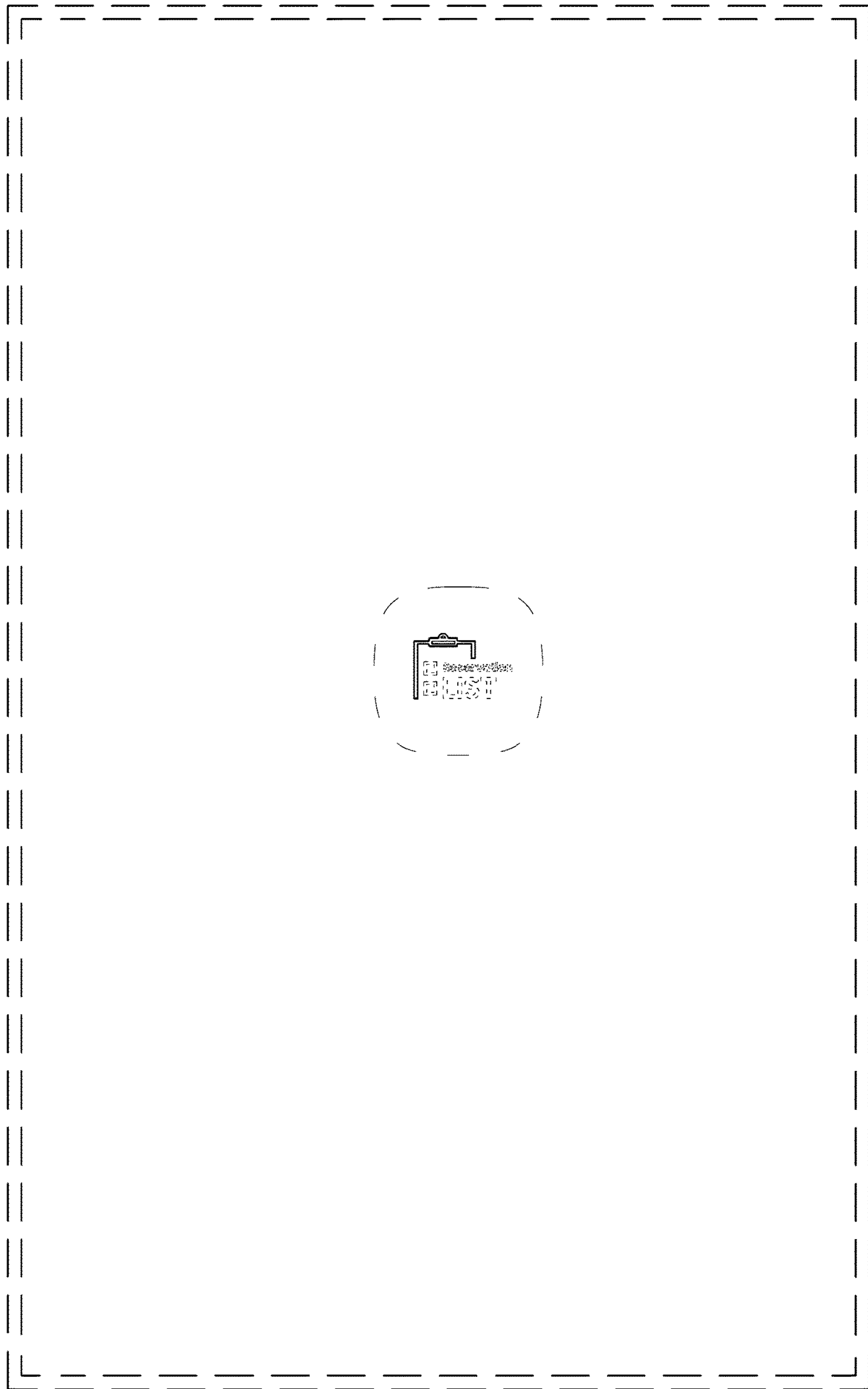

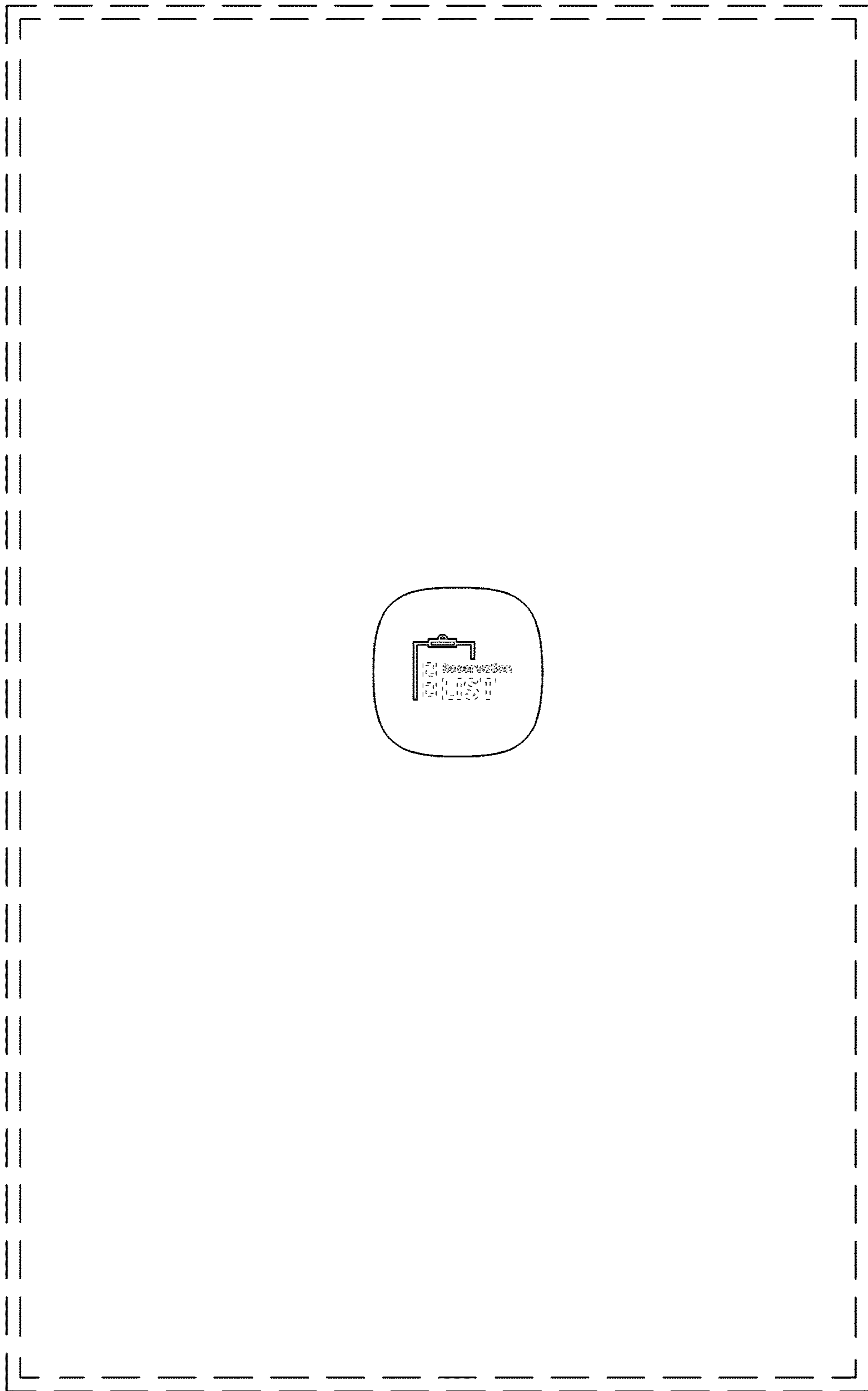
