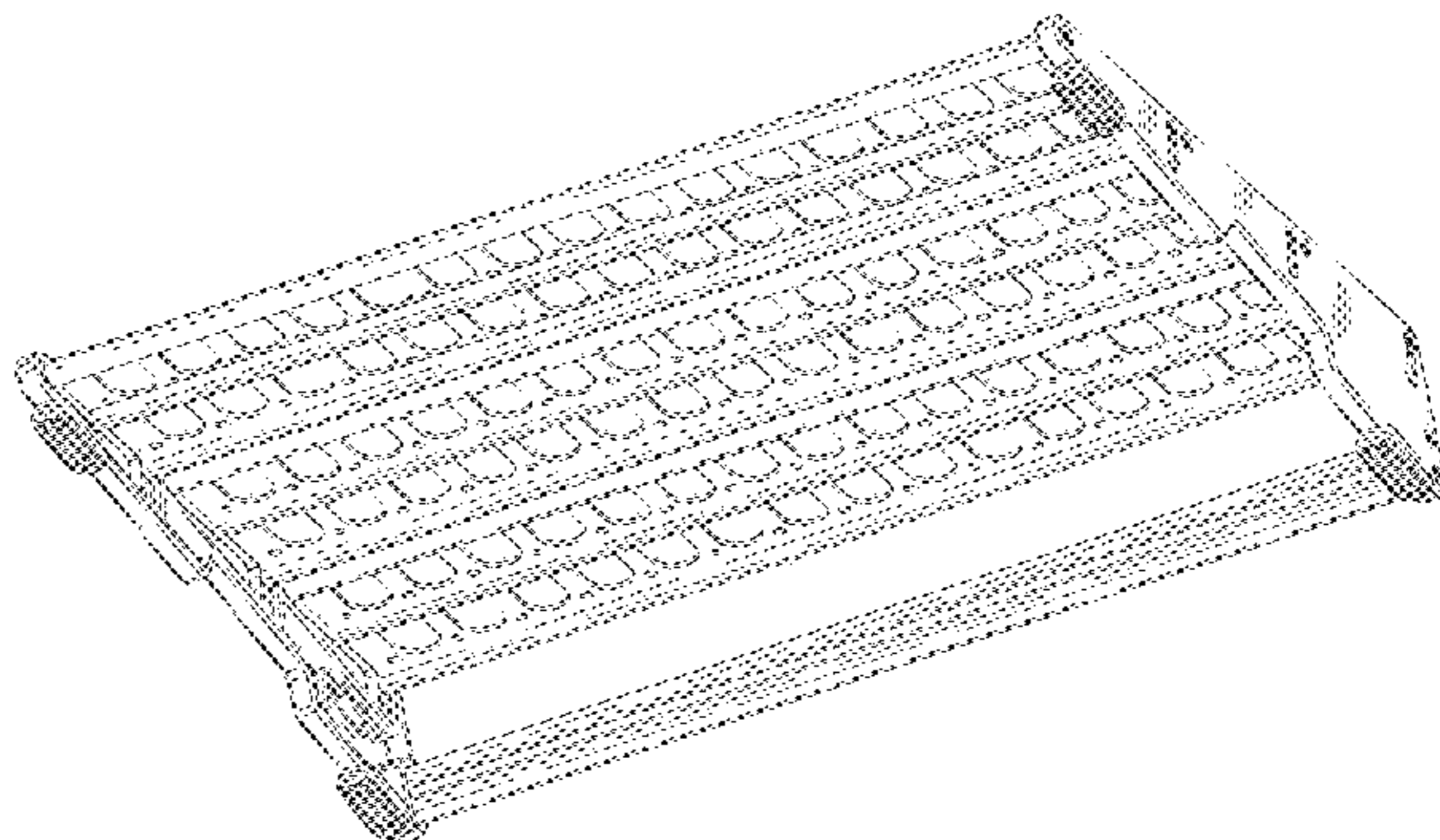
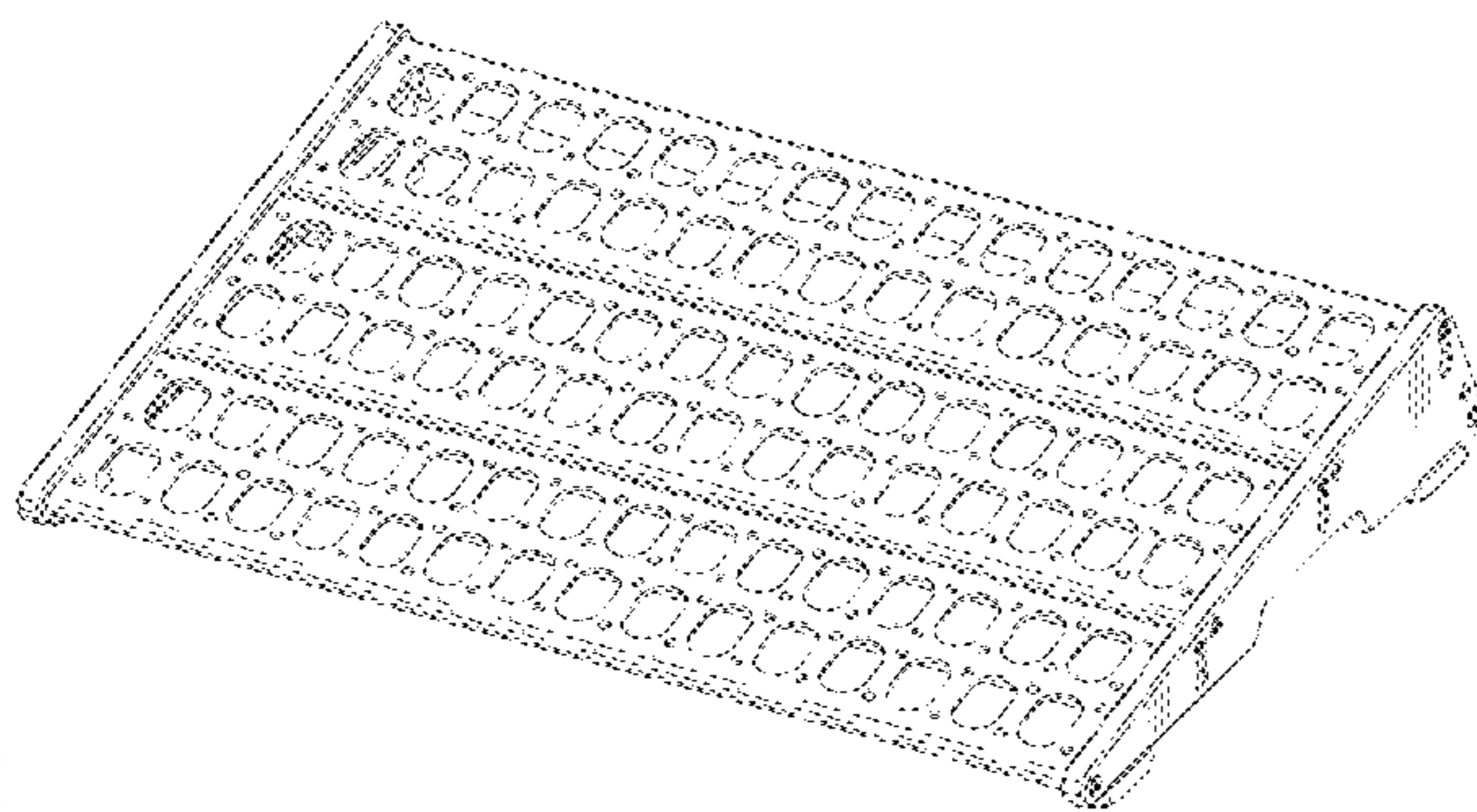
(57) **CLAIM**

**DESCRIPTION**

FIG. 7 is a bottom plan view of the pedalboard.

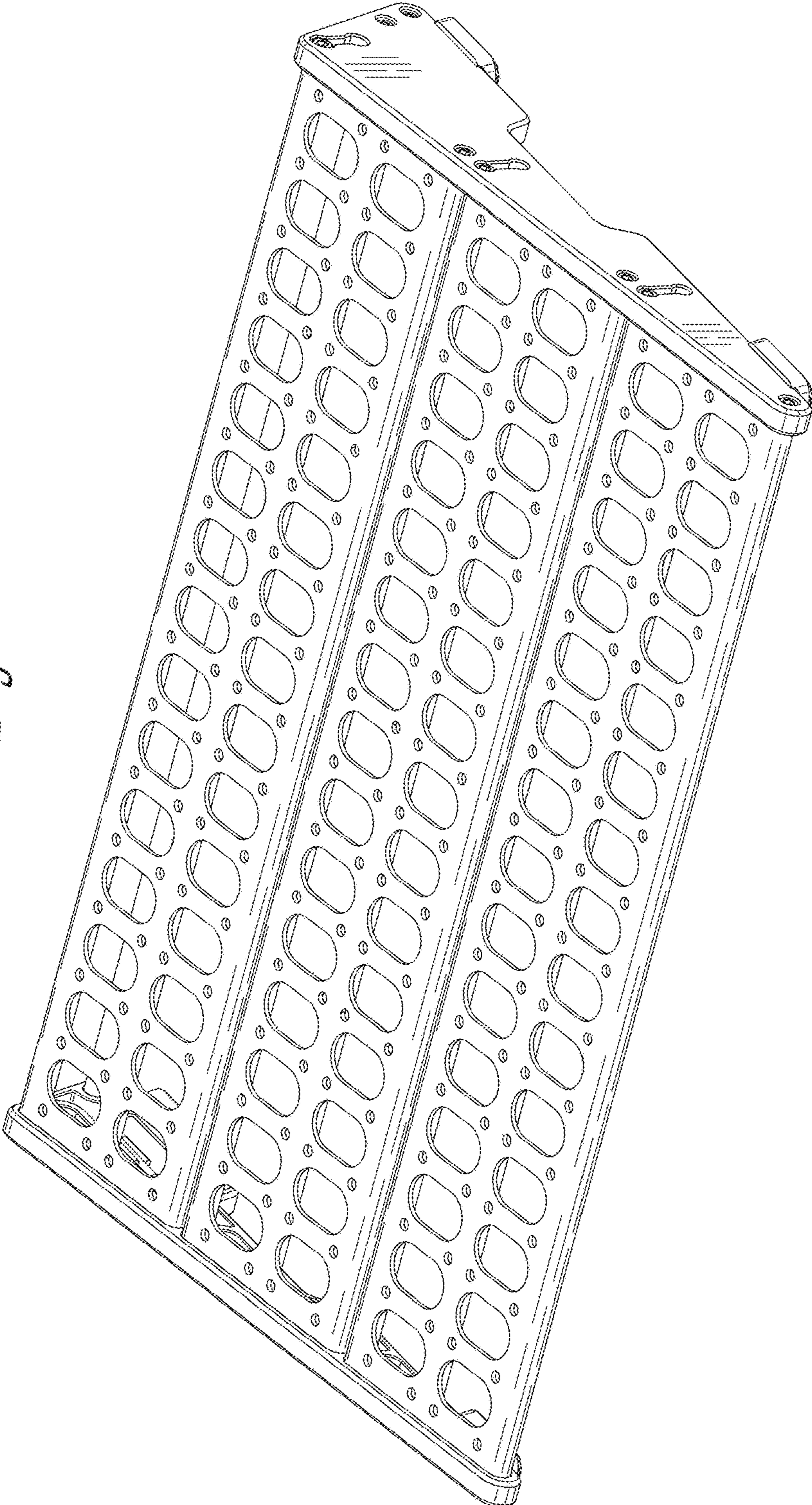

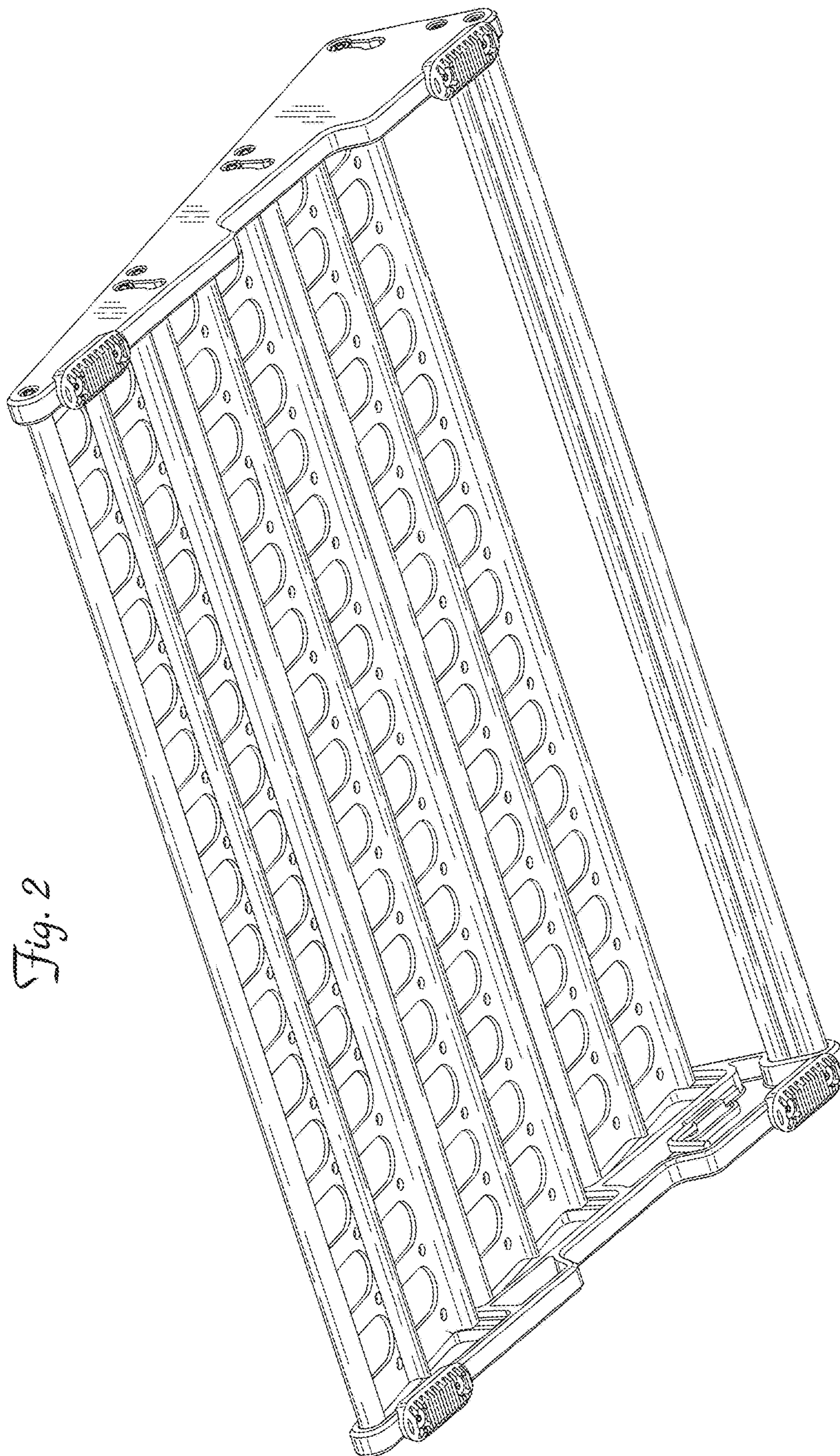

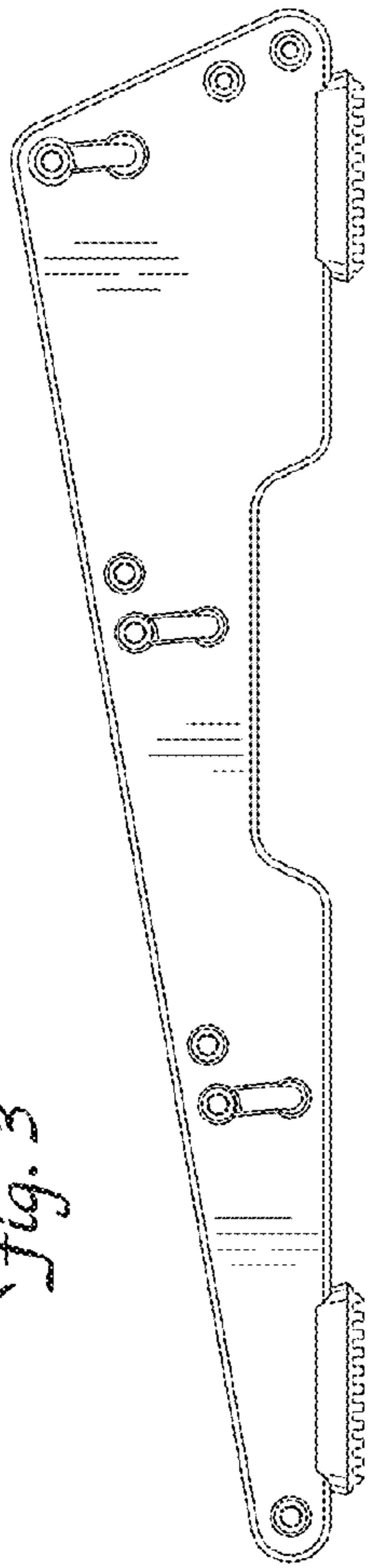

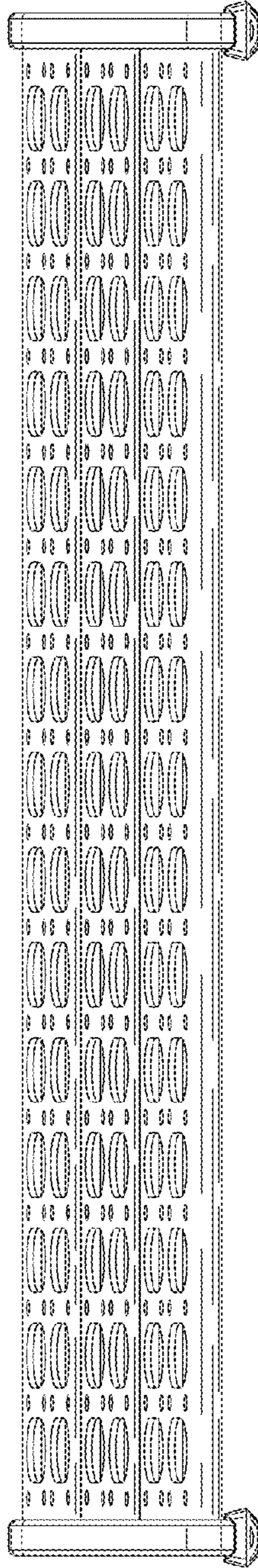

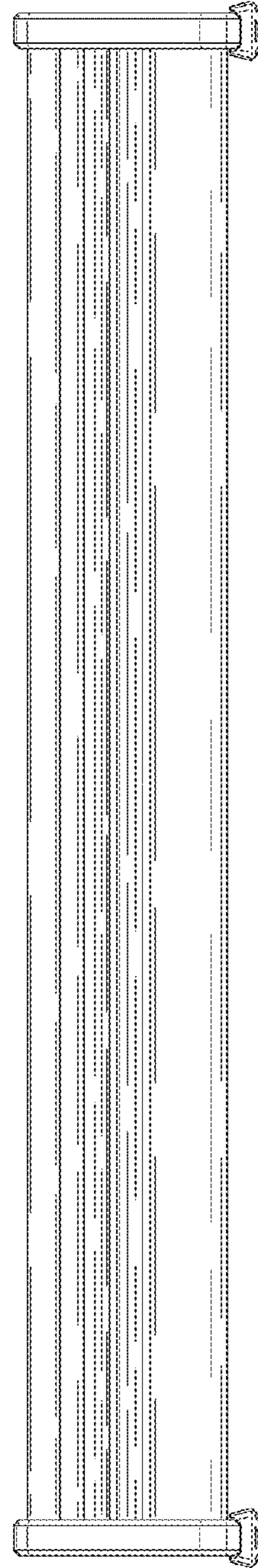

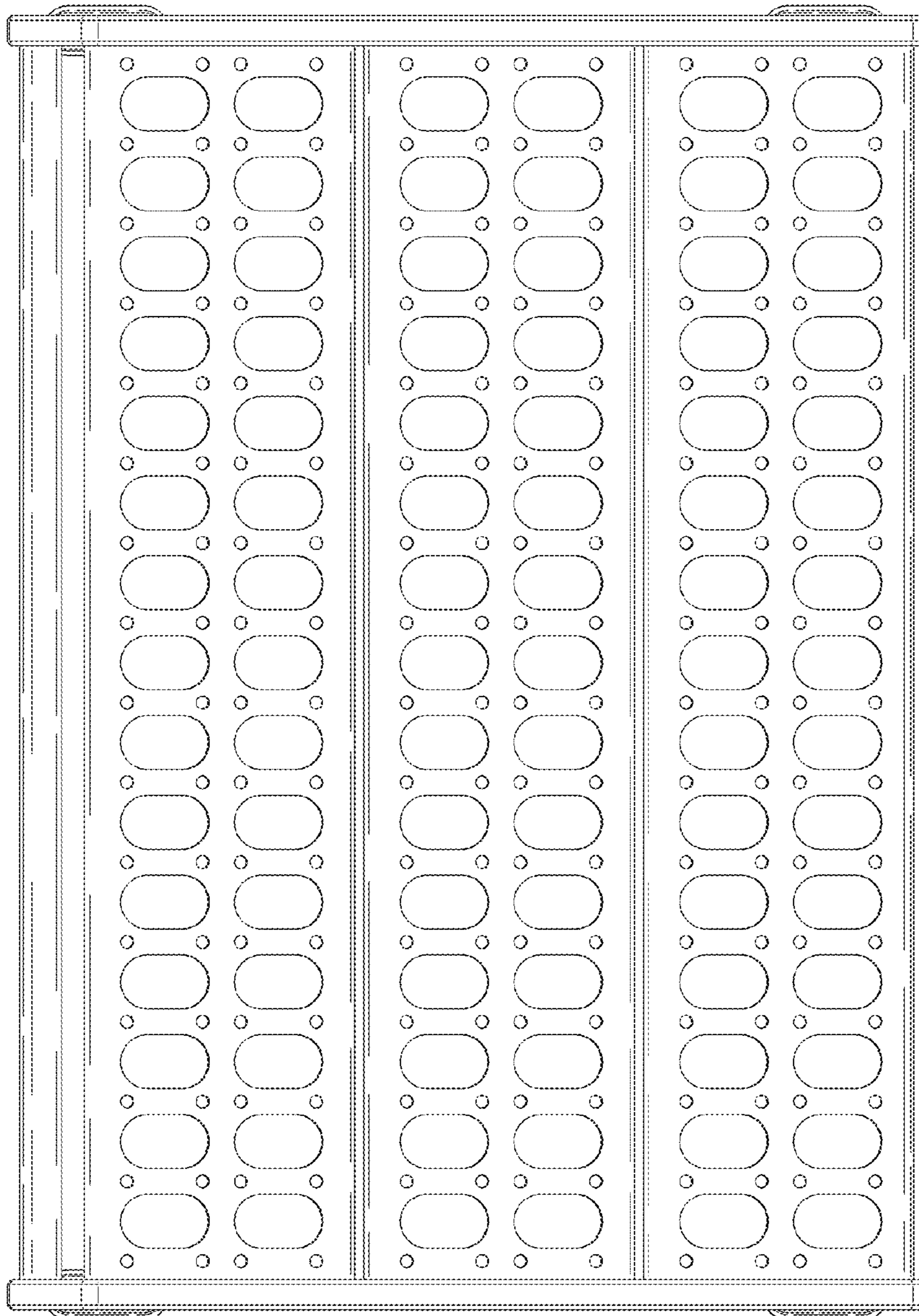
