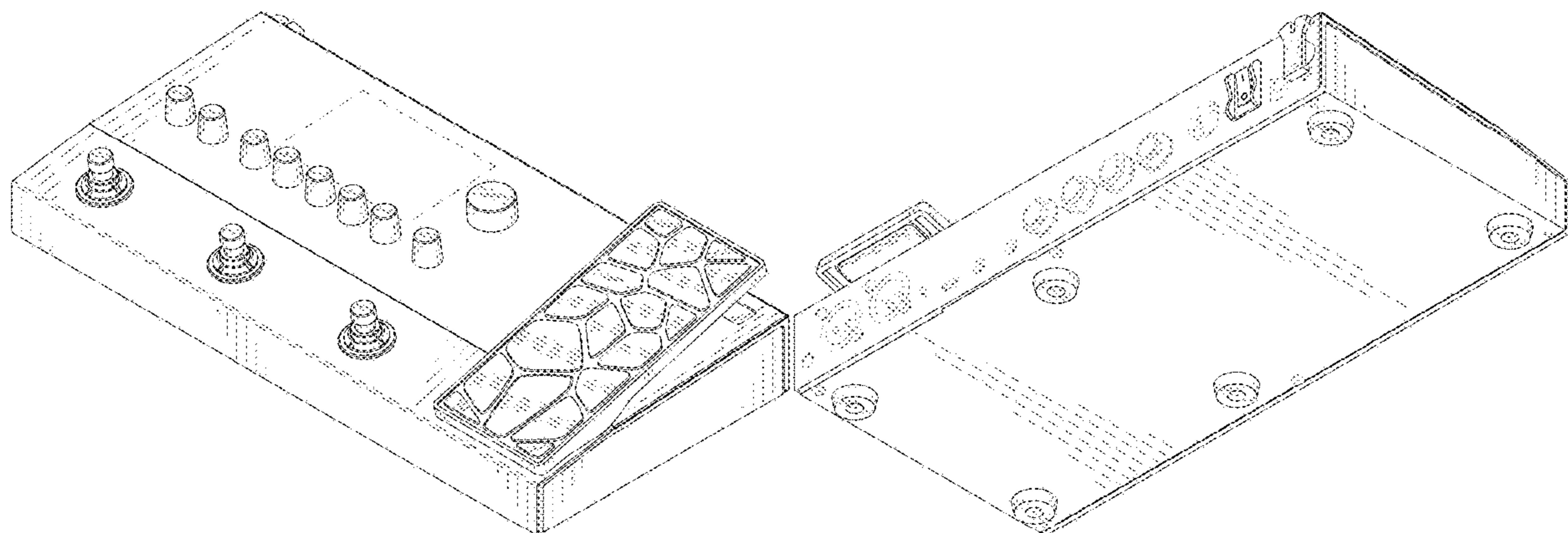
(57) **CLAIM**

The ornamental design for a guitar effect pedal, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and top perspective view of a guitar effect pedal, showing my new design;

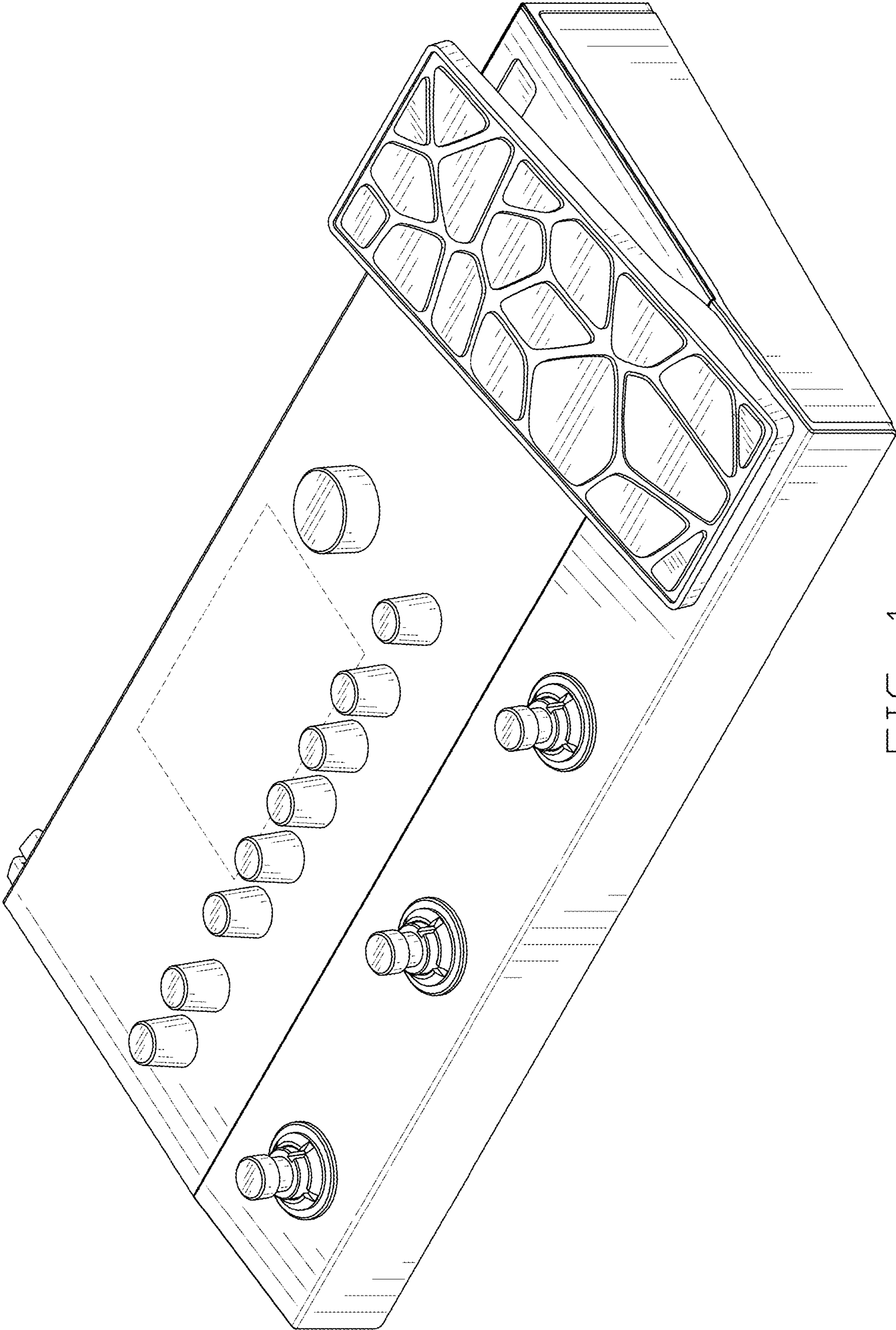

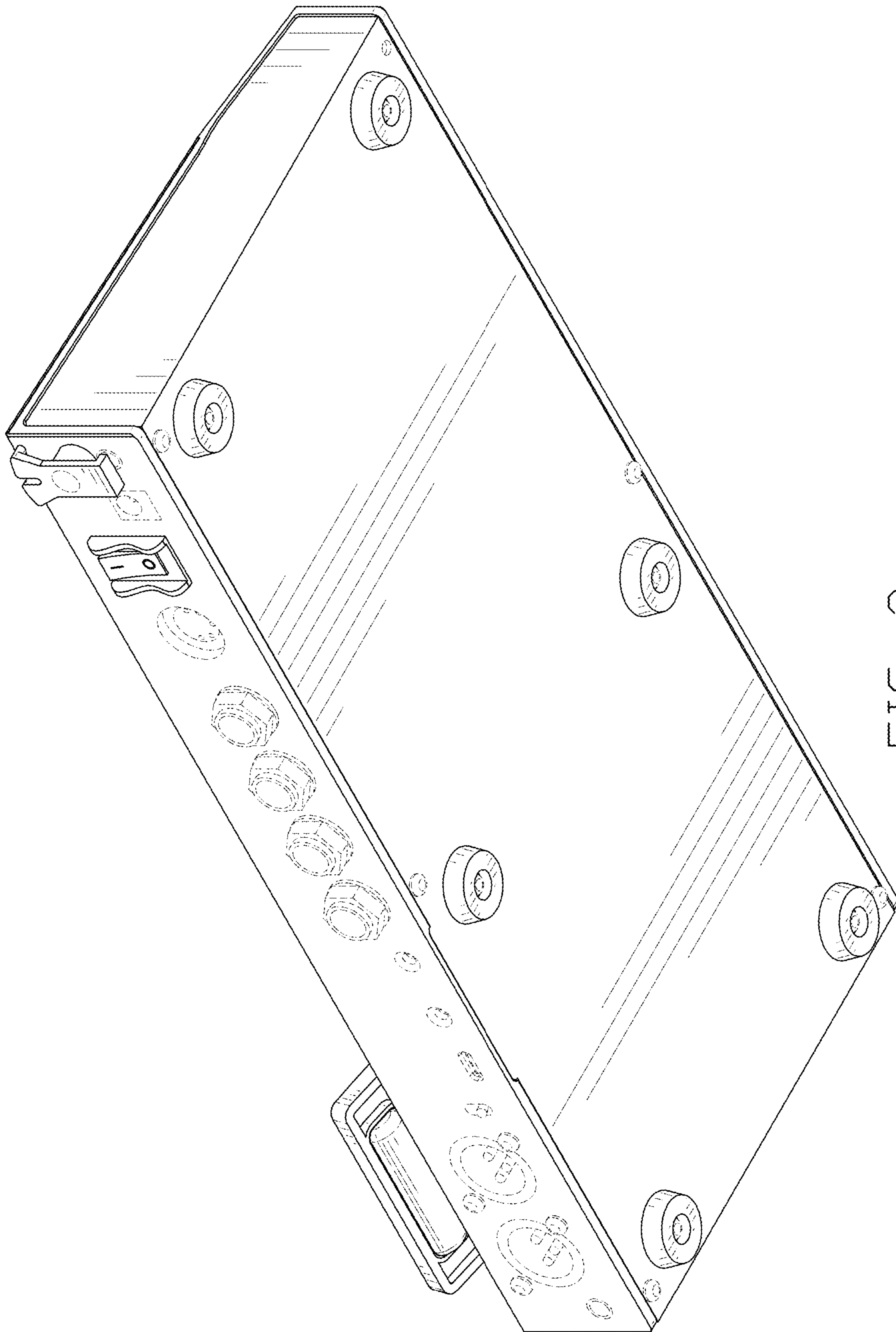

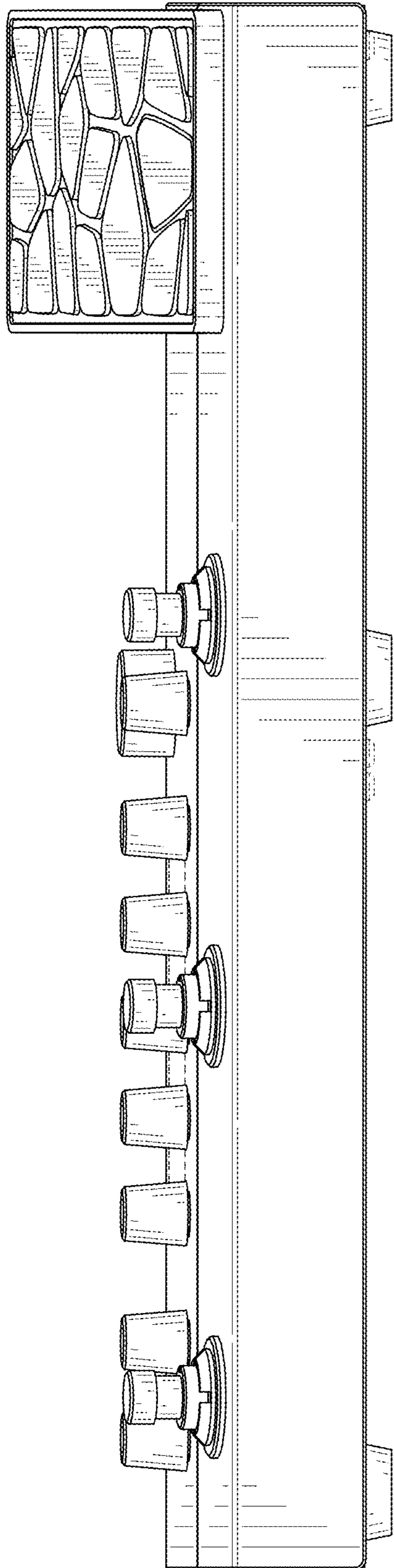

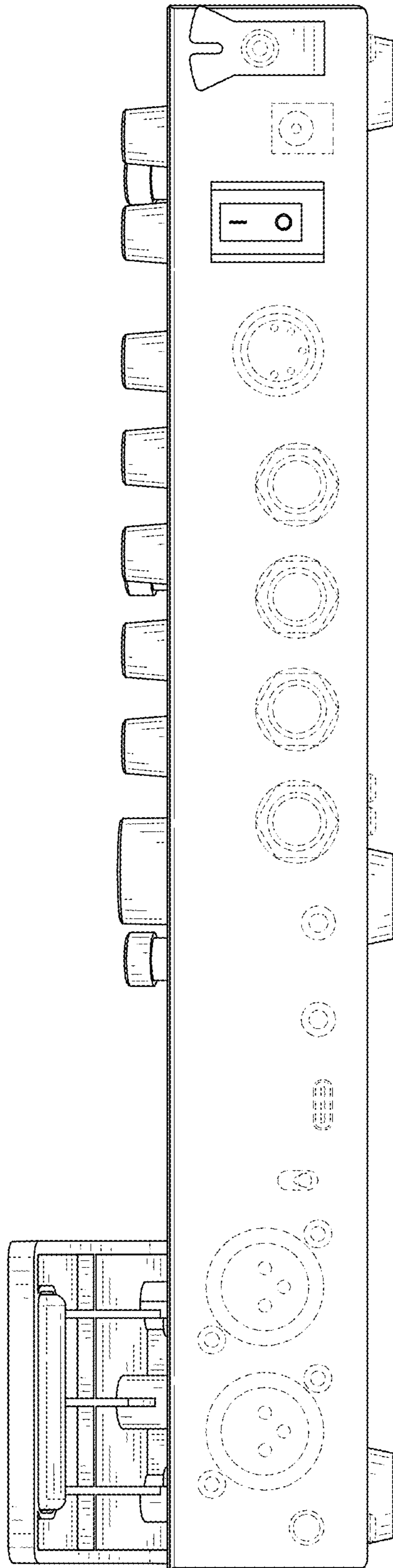

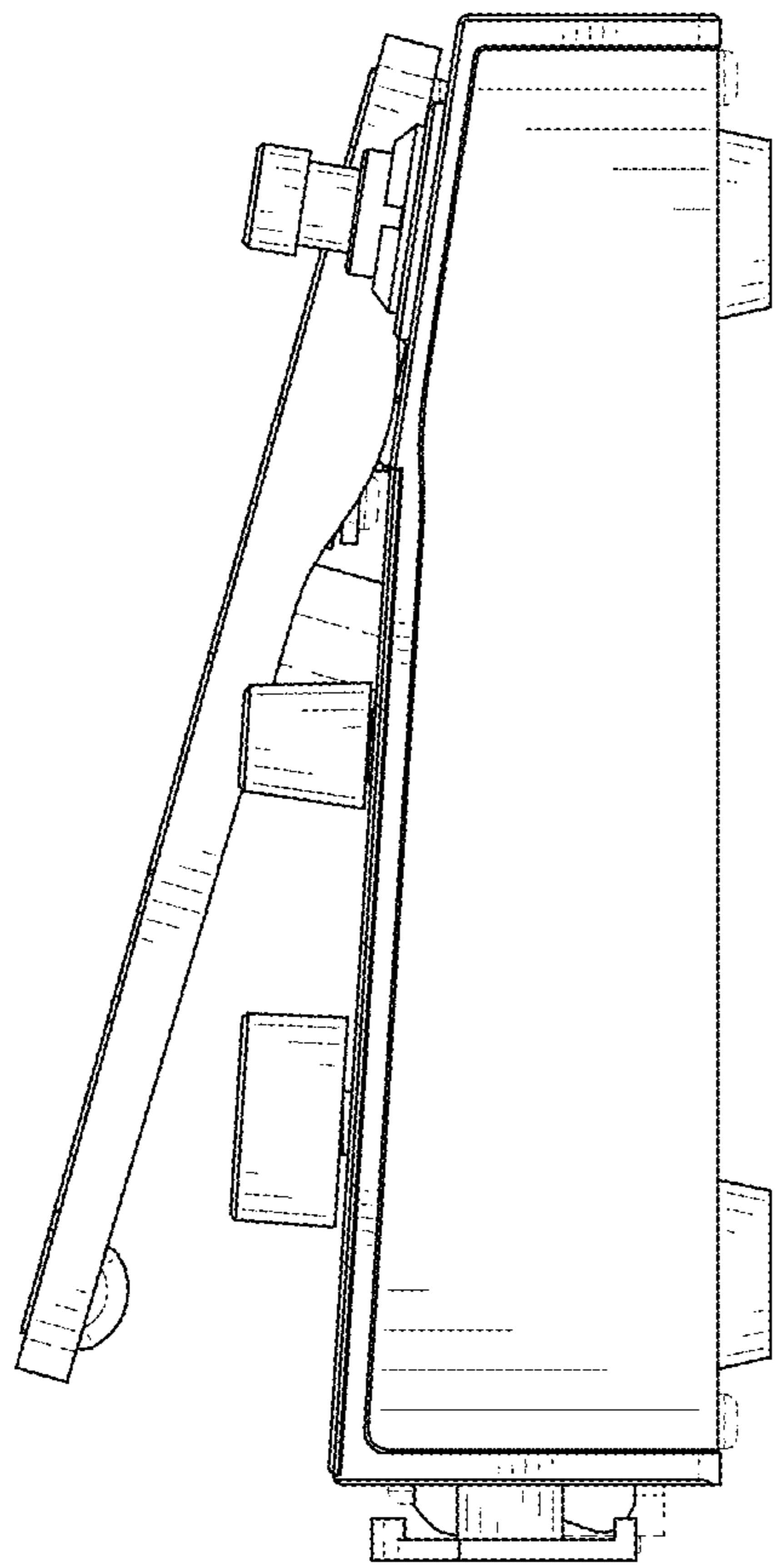

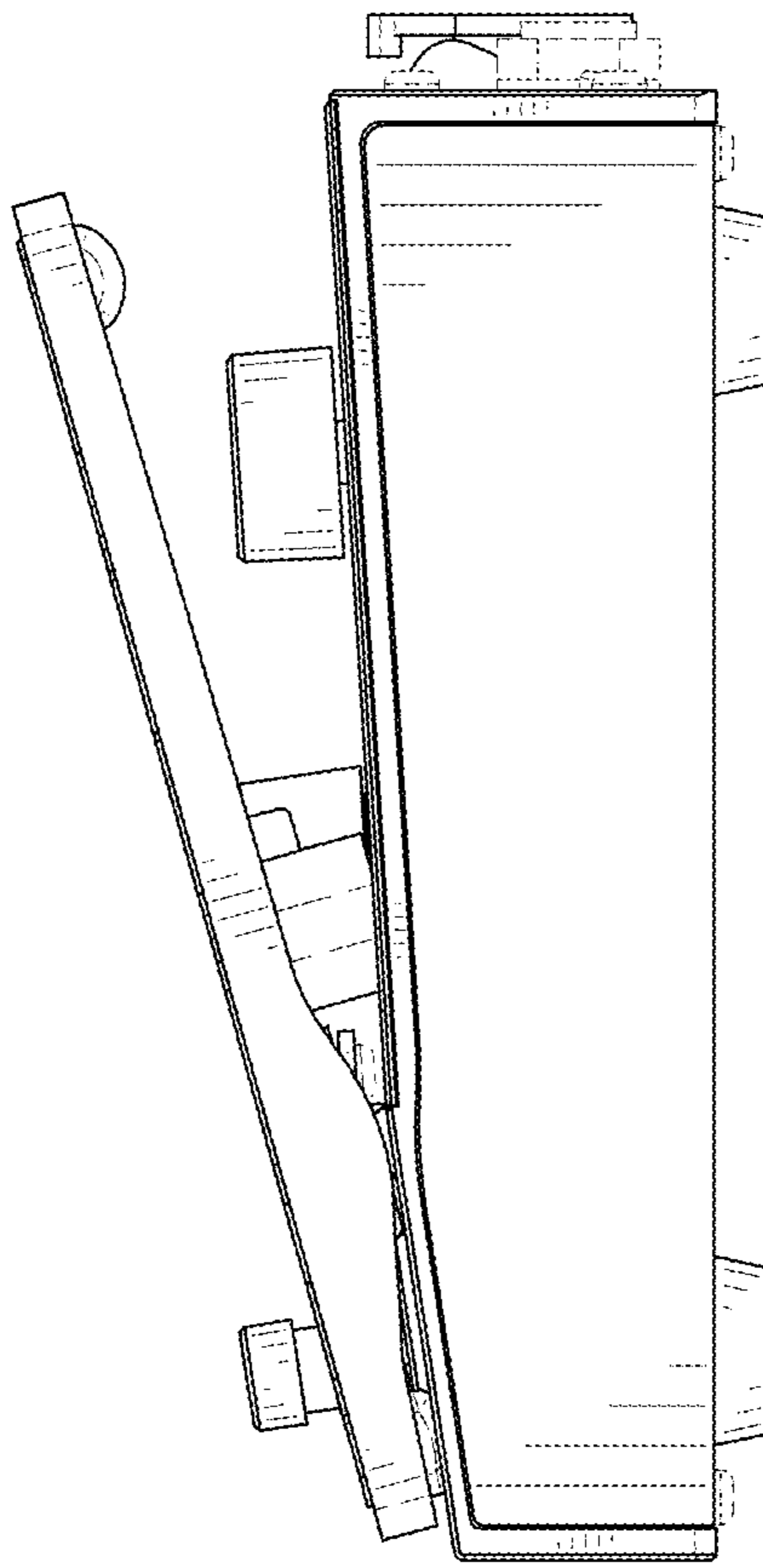

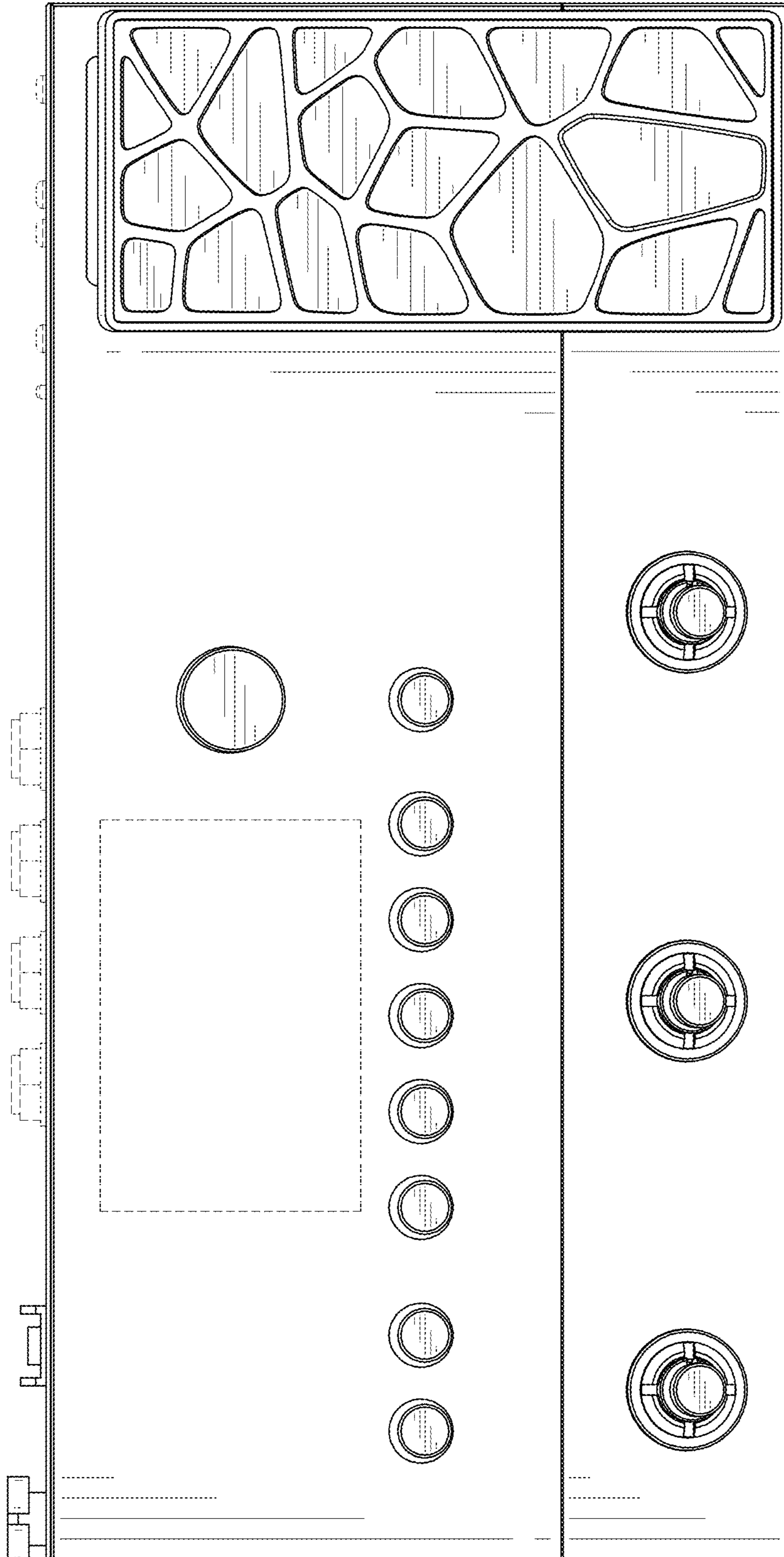

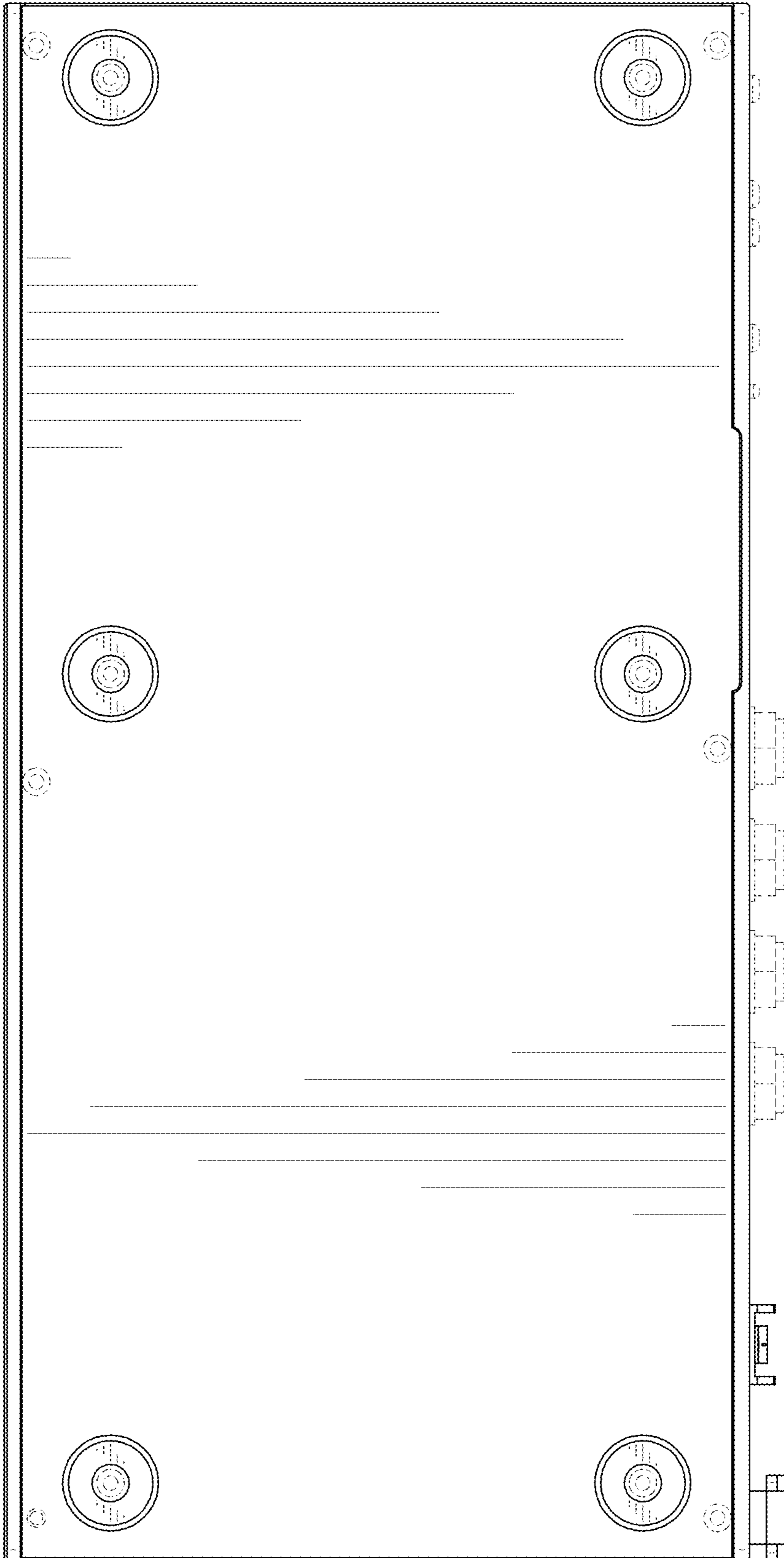
