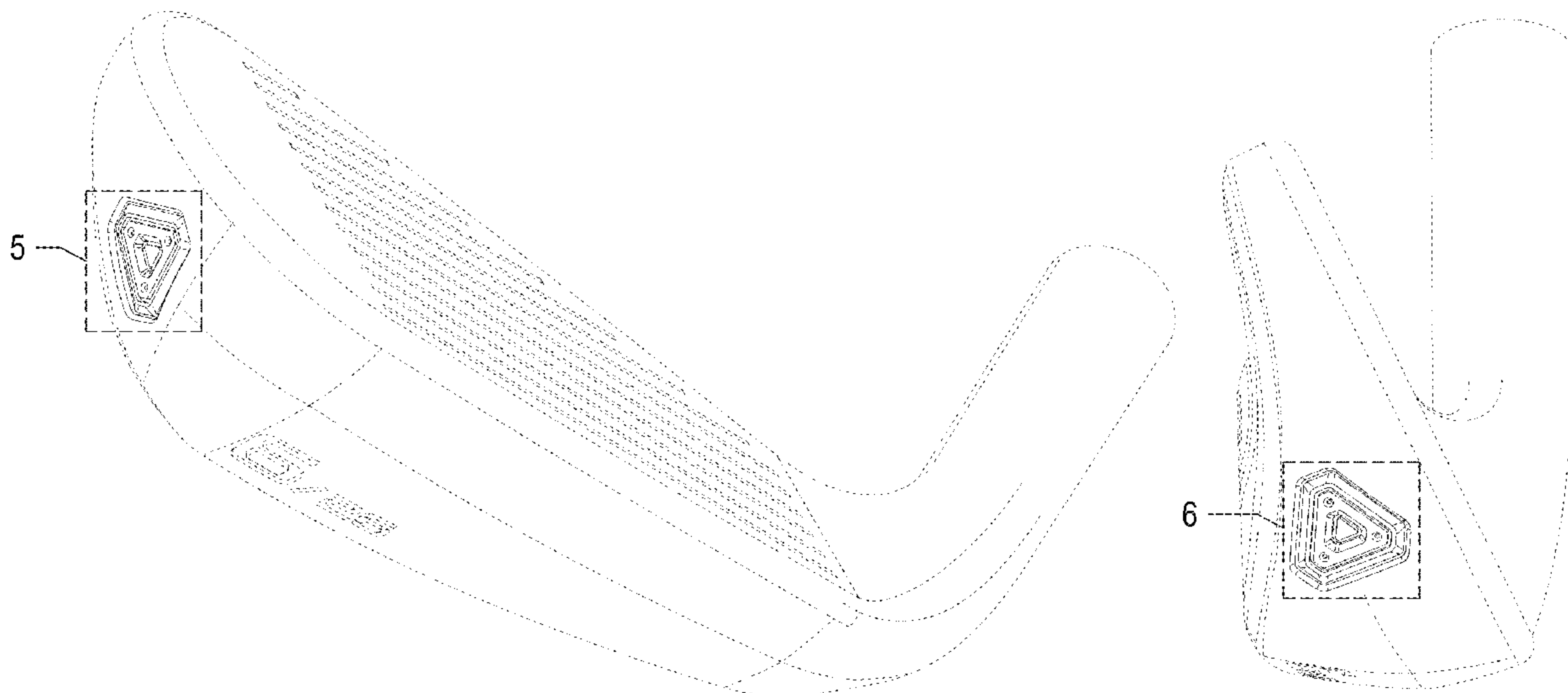
(57) **CLAIM**

The ornamental design for a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, toe-side, bottom perspective view of a golf club head, showing the new design;  
FIG. 2 is a toe-side elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is an enlargement of area 5 in FIG. 1; and,  
FIG. 6 is an enlargement of area 6 in FIG. 1.  
The broken lines depict parts of the golf club head that form no part of the claimed design. The dot-dash chain lines depict boundaries of the claimed subject matter and form no part of the claimed design.

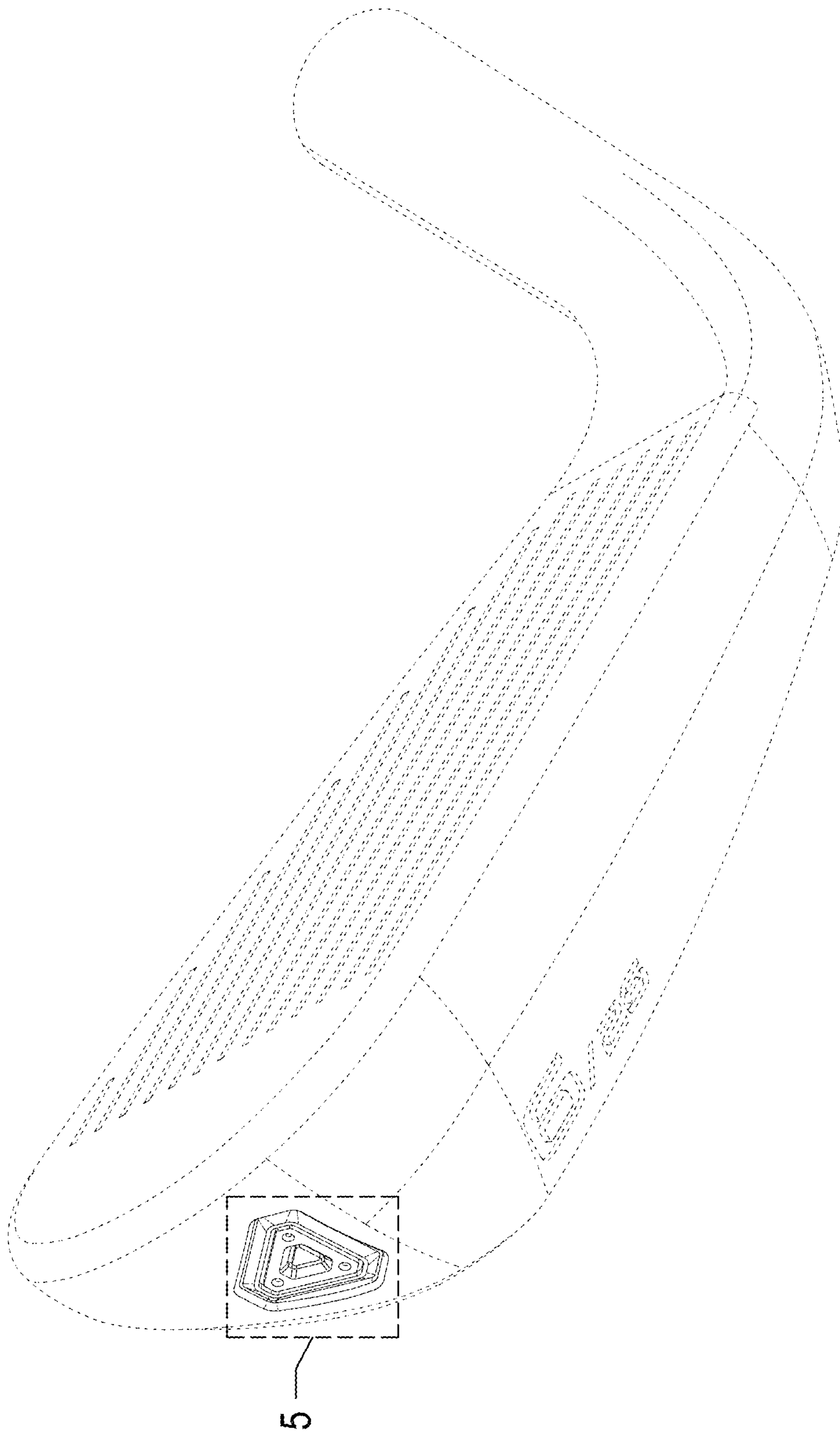

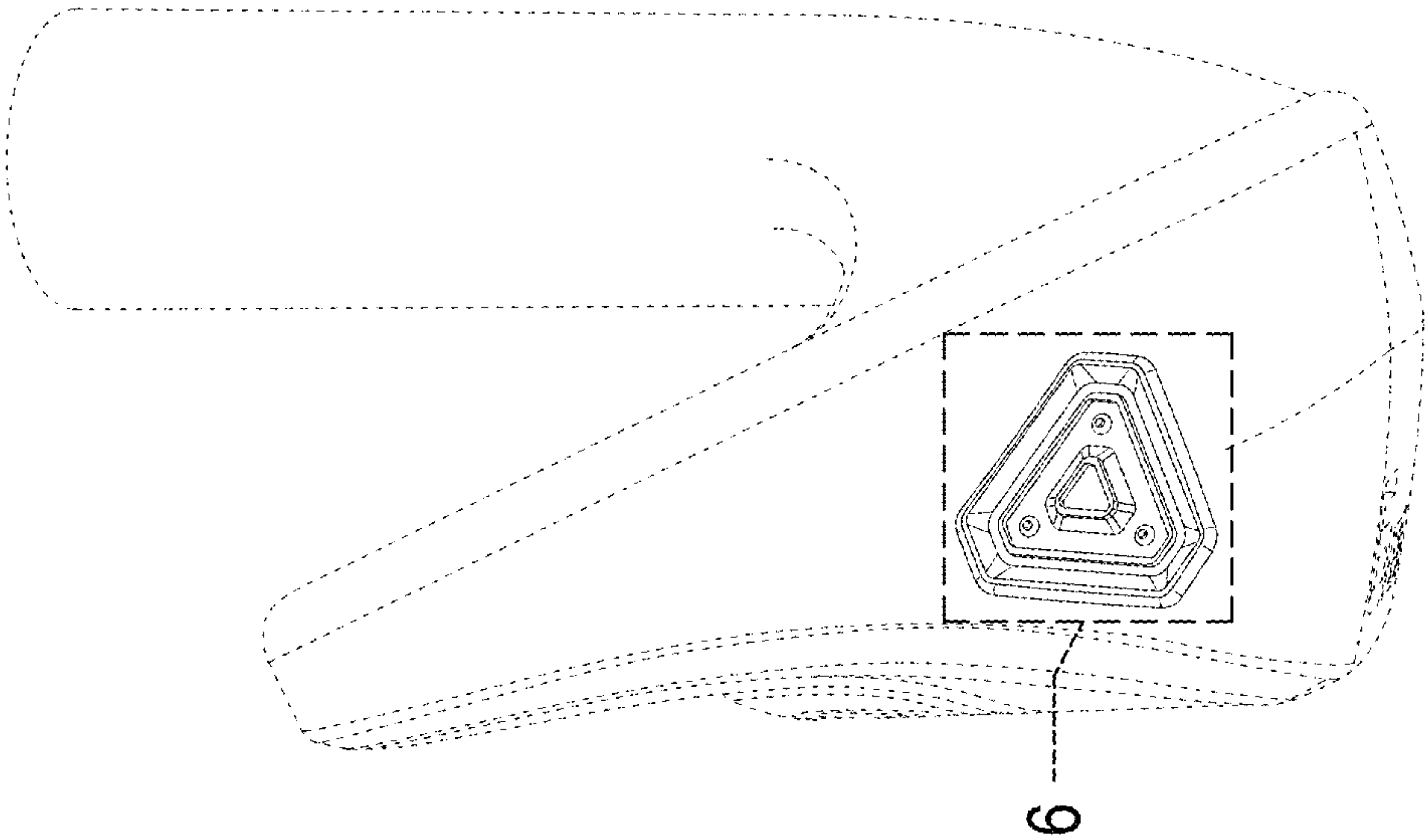

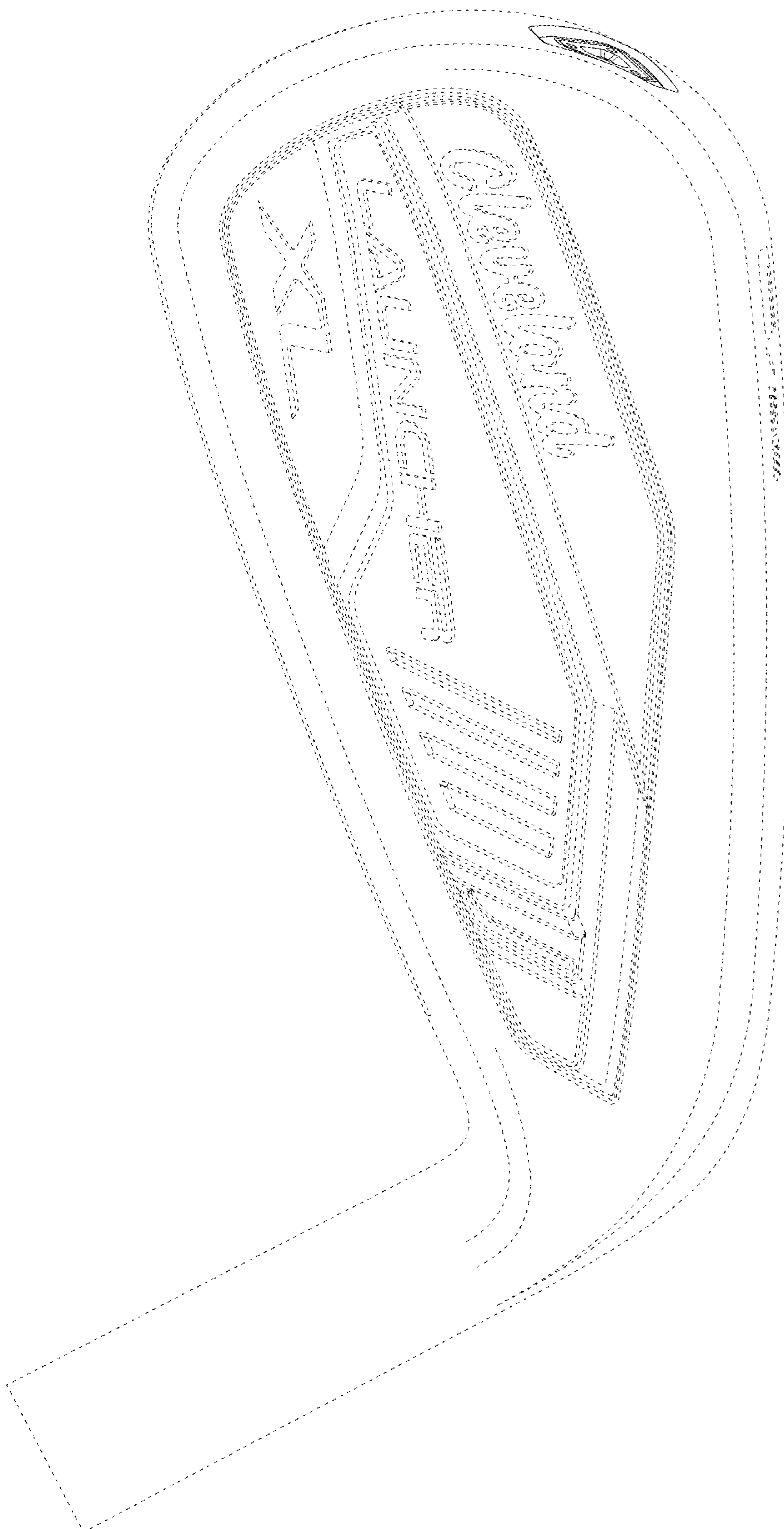

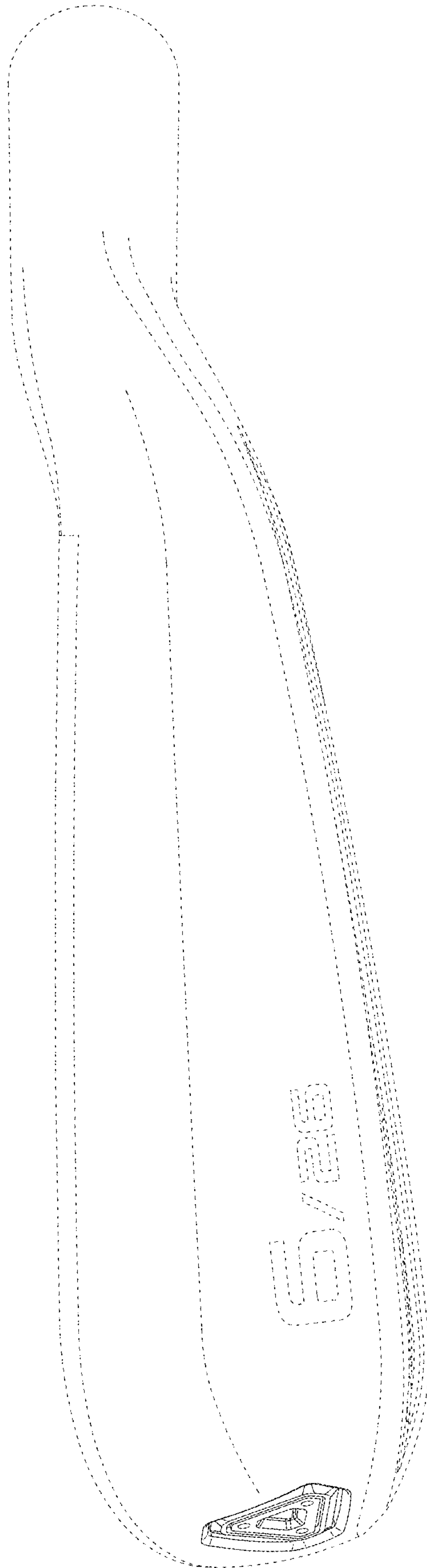

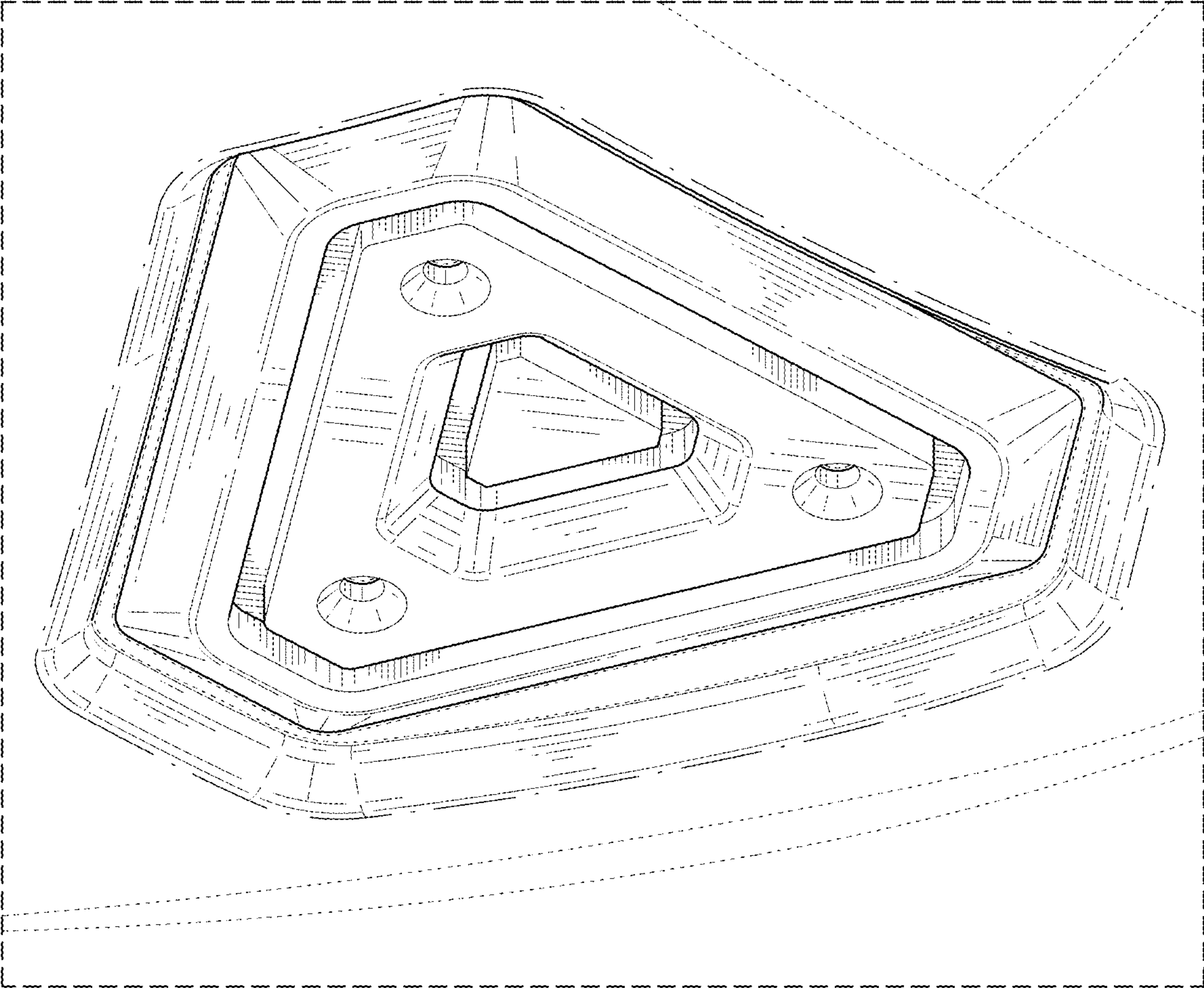

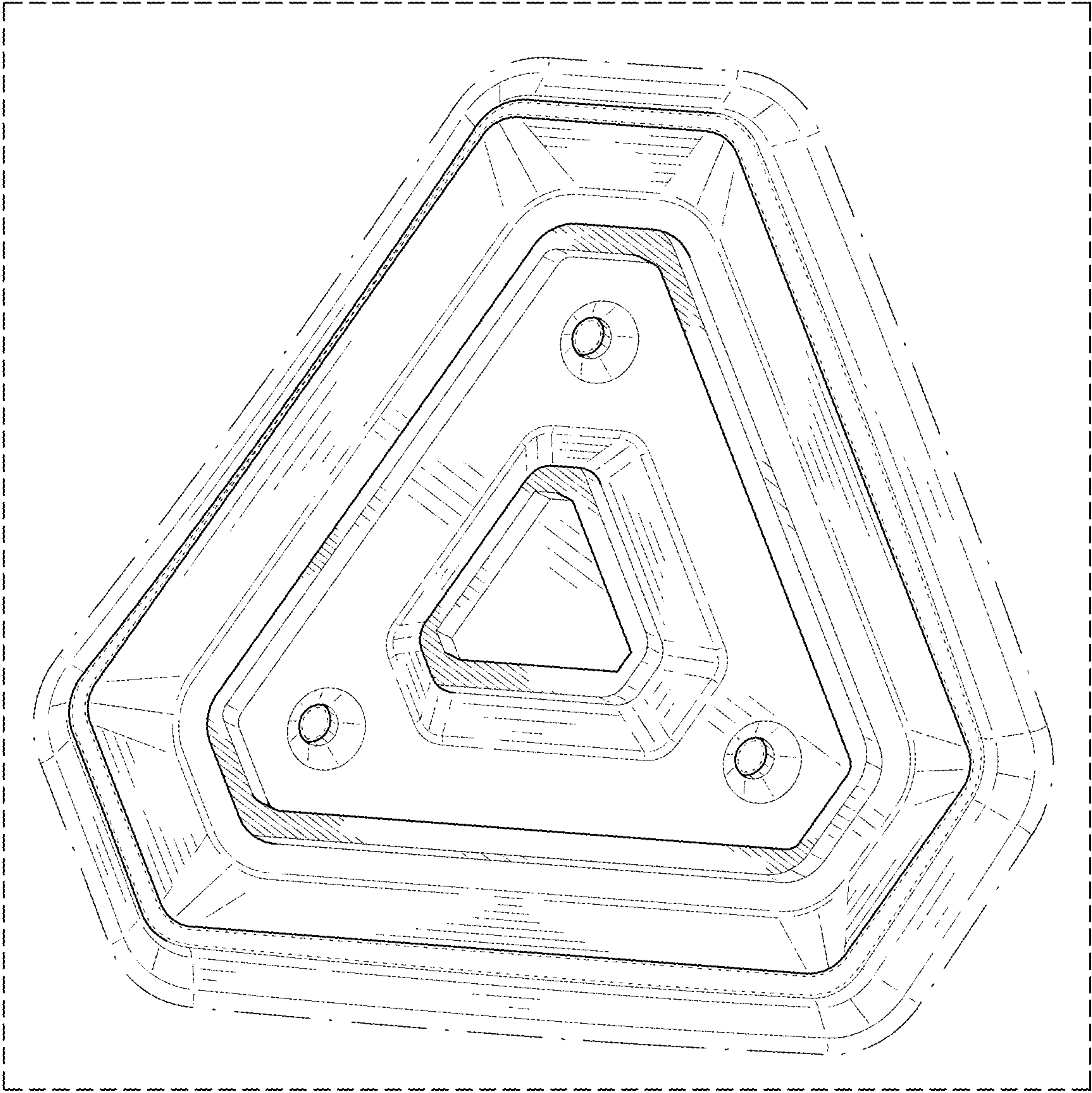
