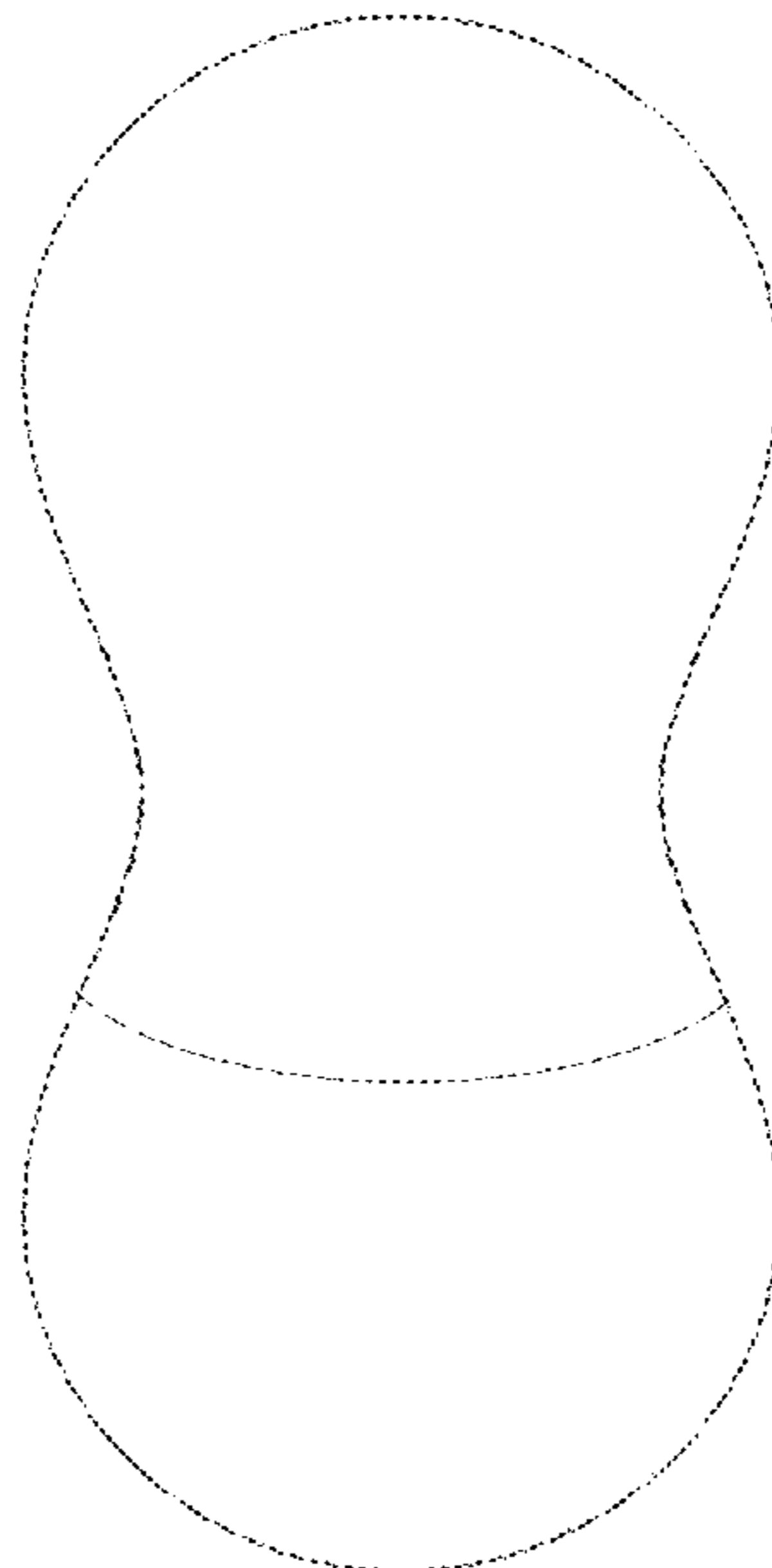

The ornamental design for tubes of lipstick and lip balm, as shown and described.

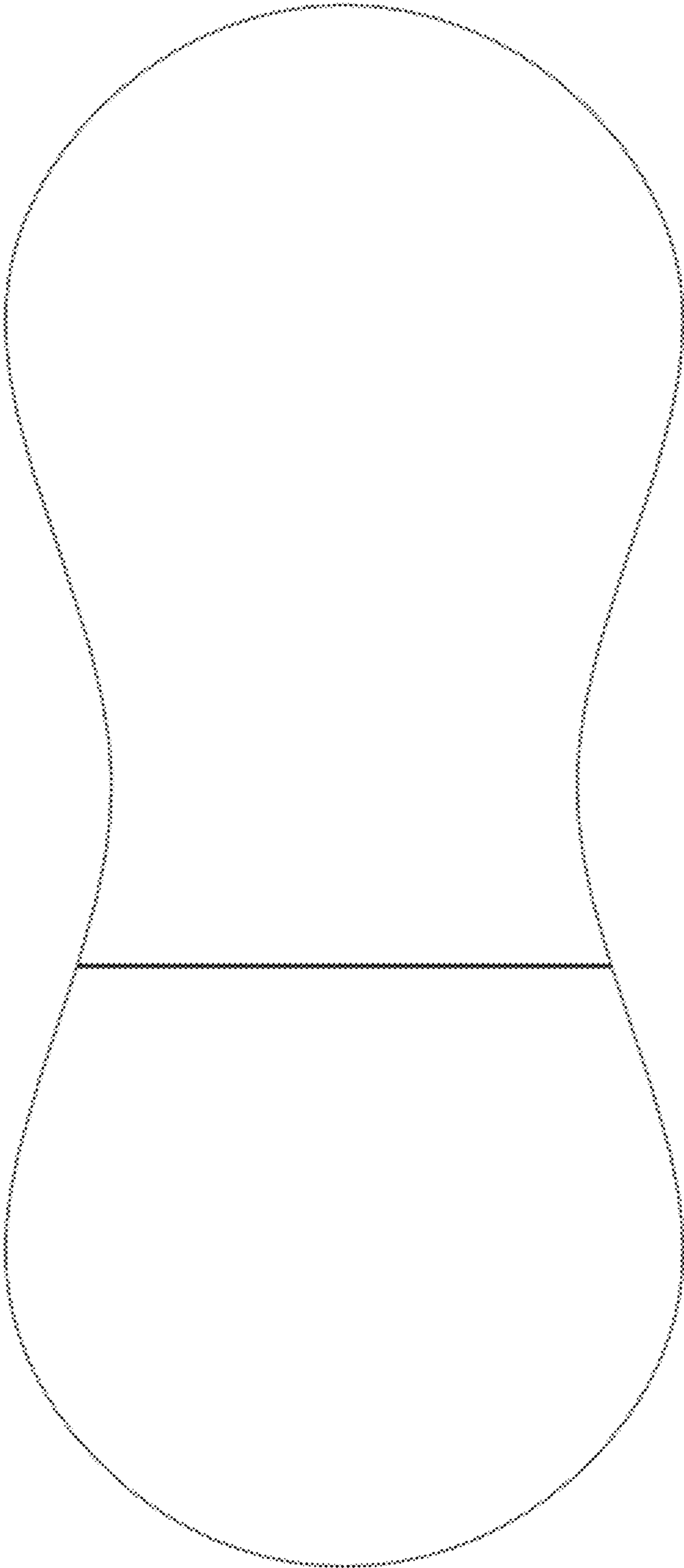
**DESCRIPTION**

Figure 1.7 is a top plan view thereof.

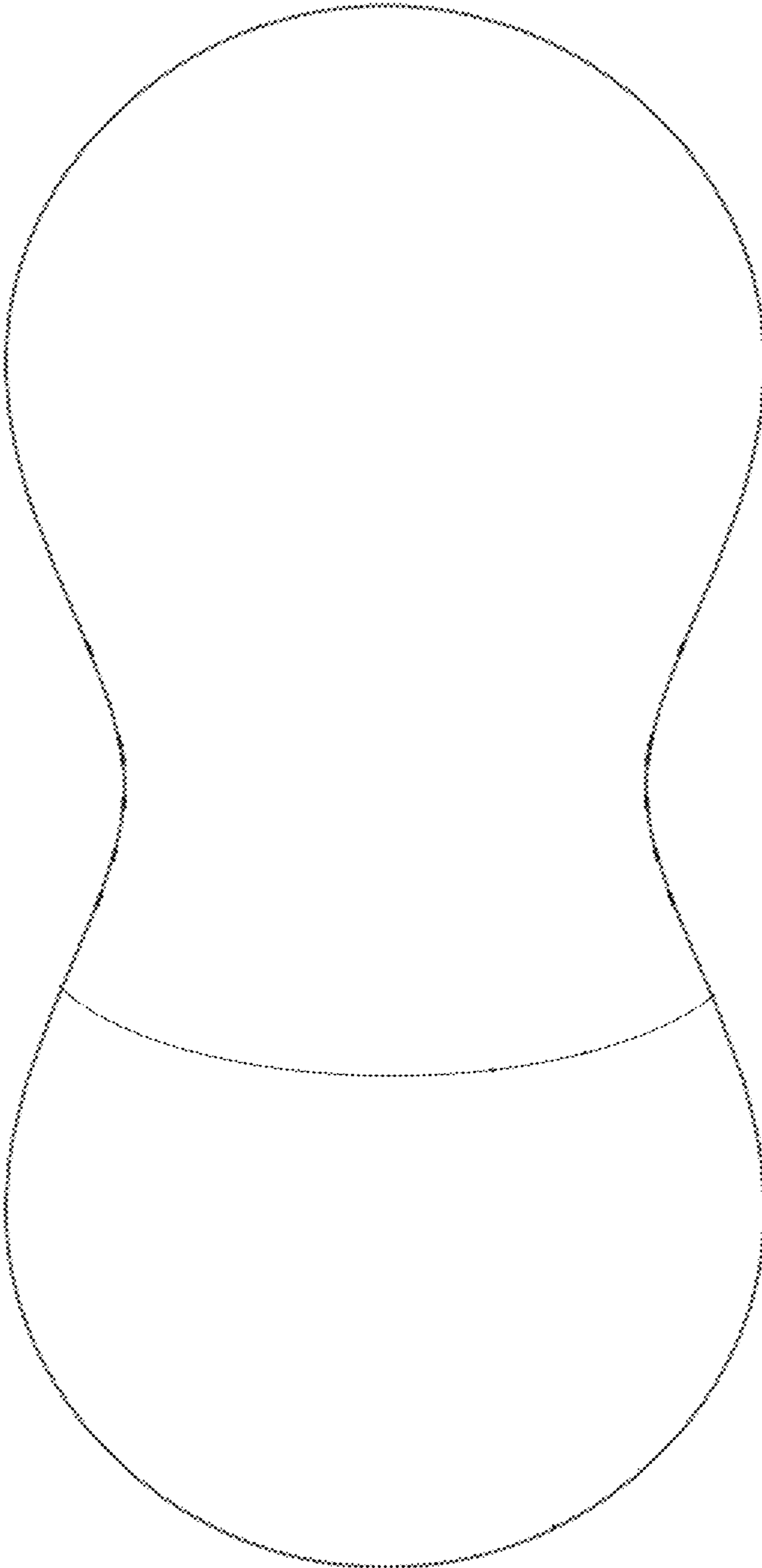

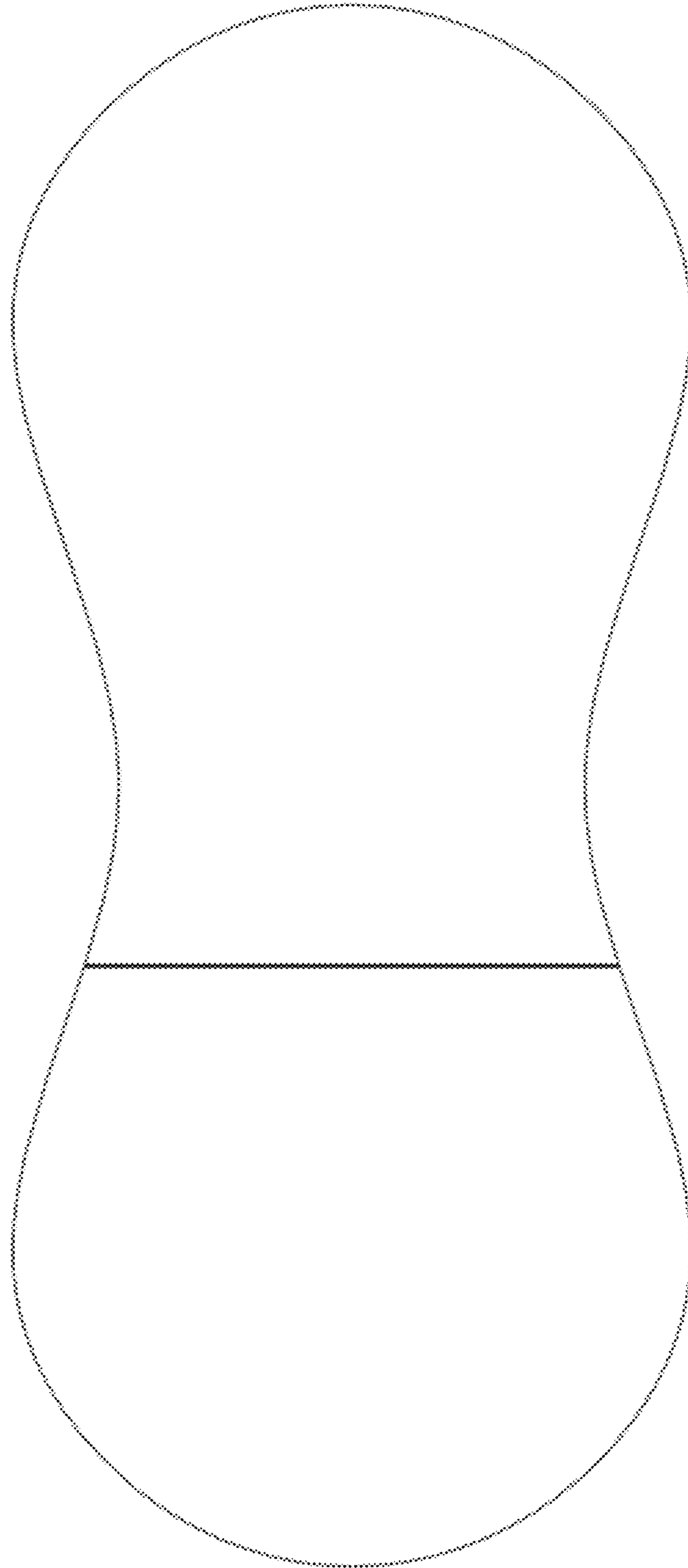

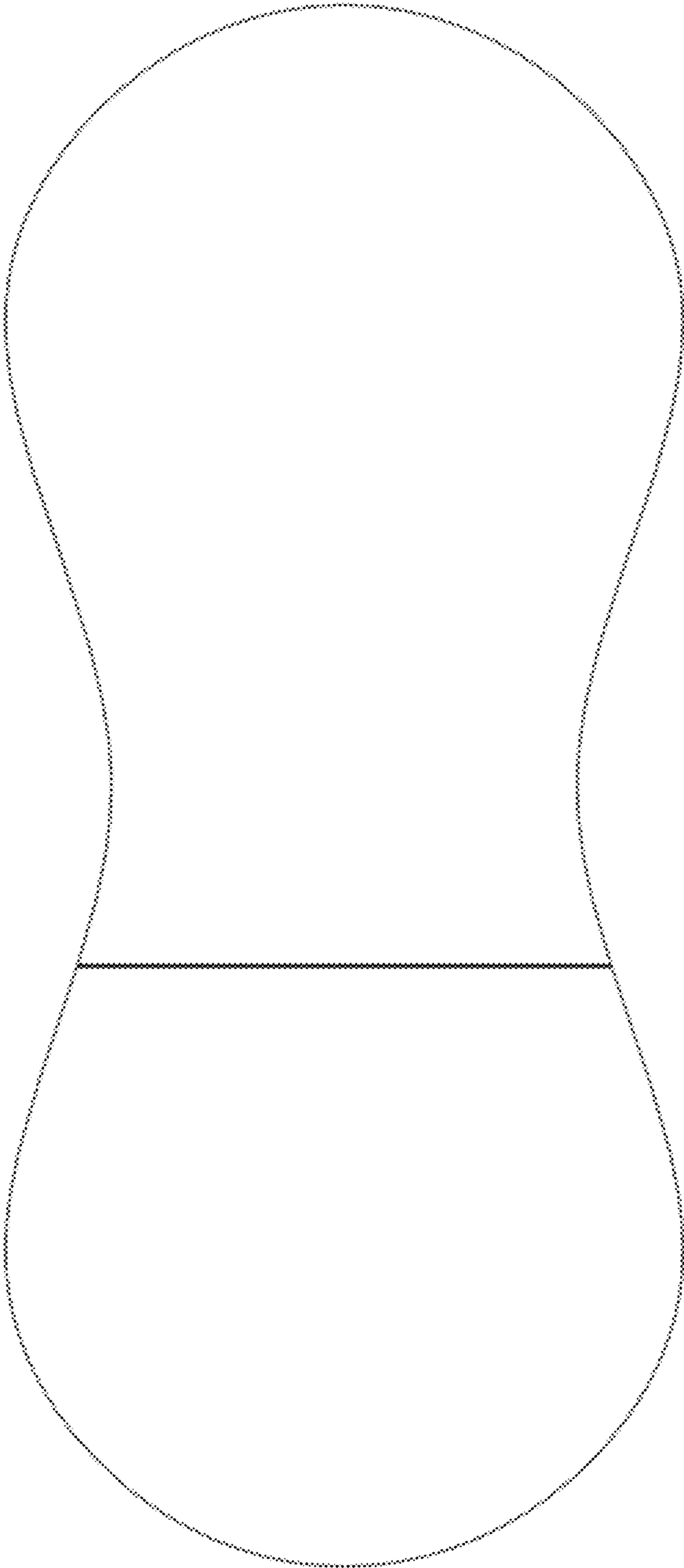

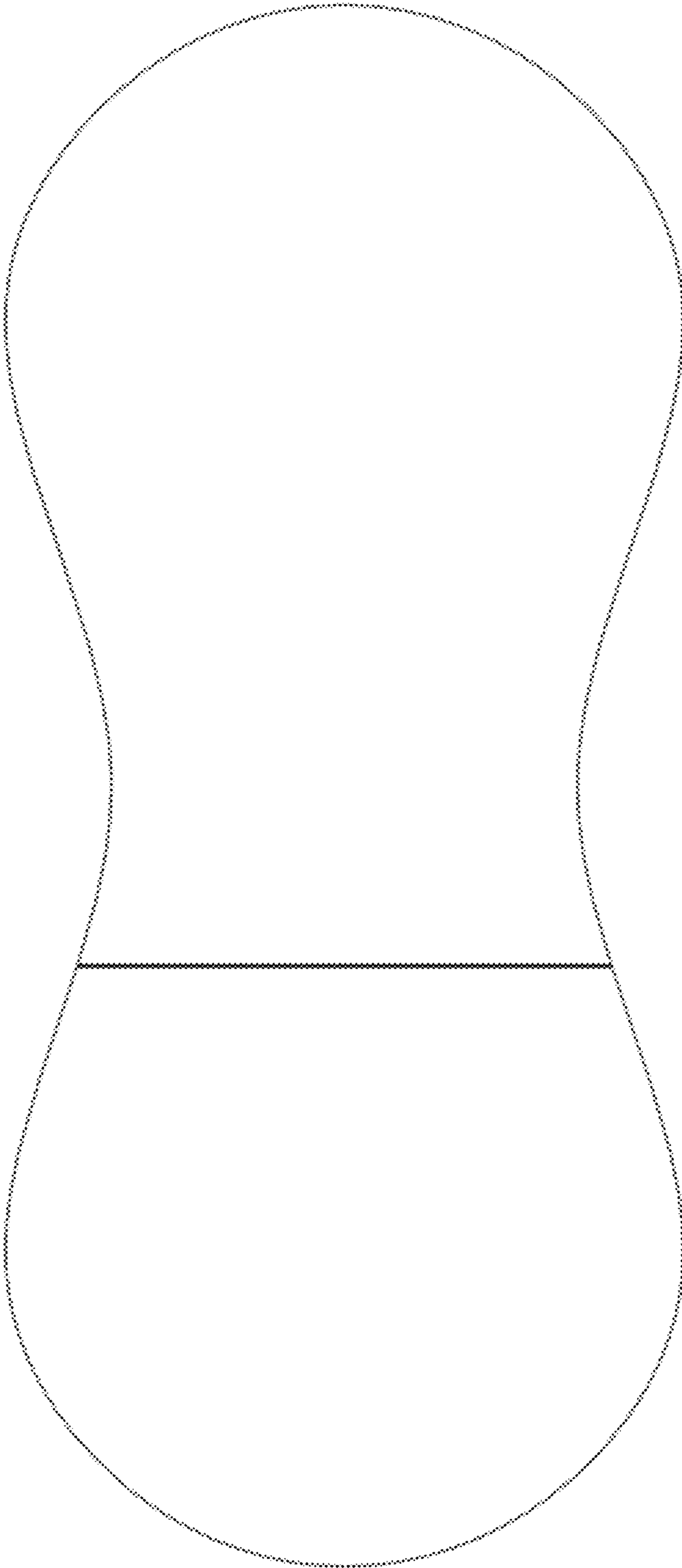

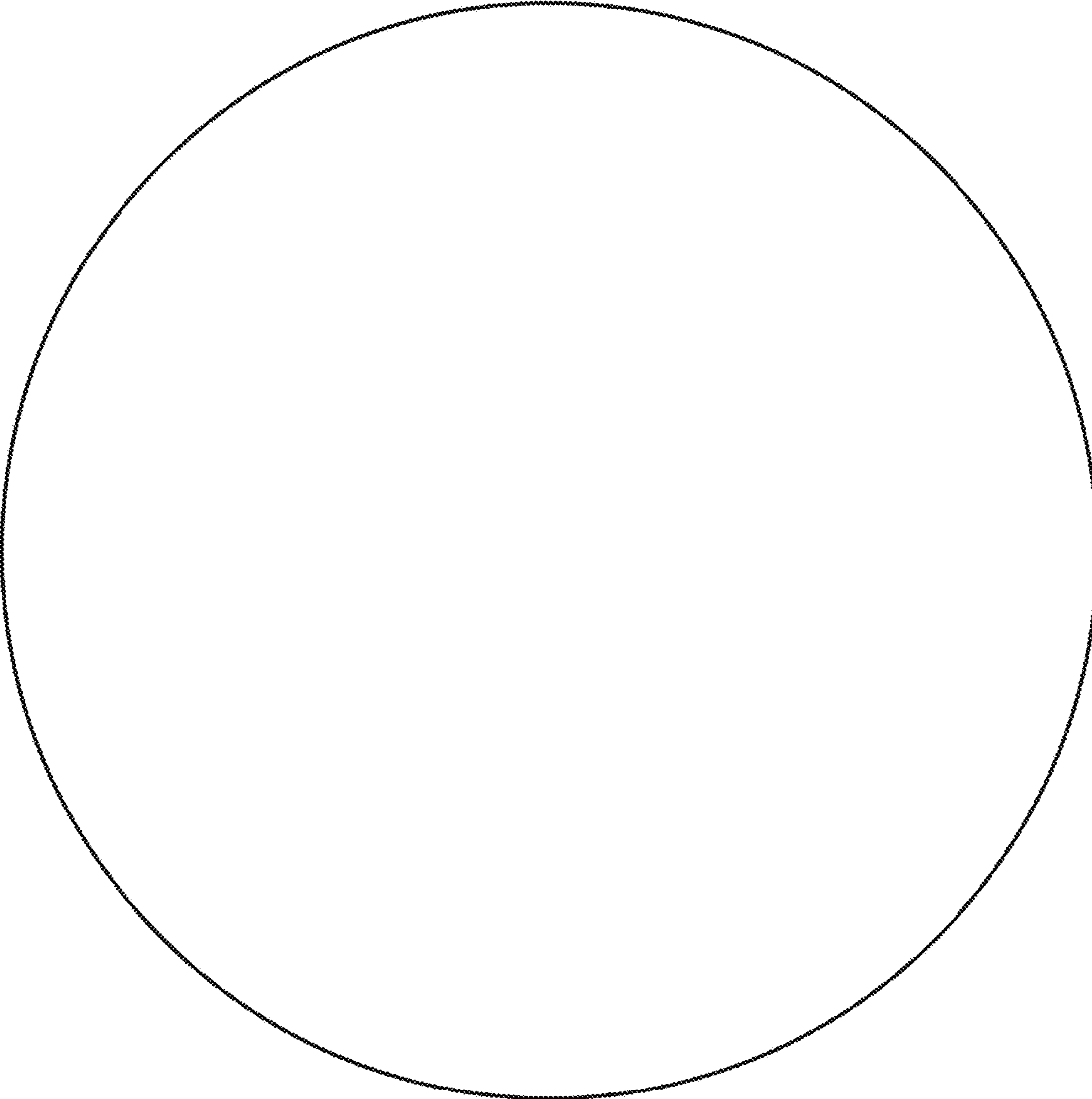
