(57) **CLAIM**

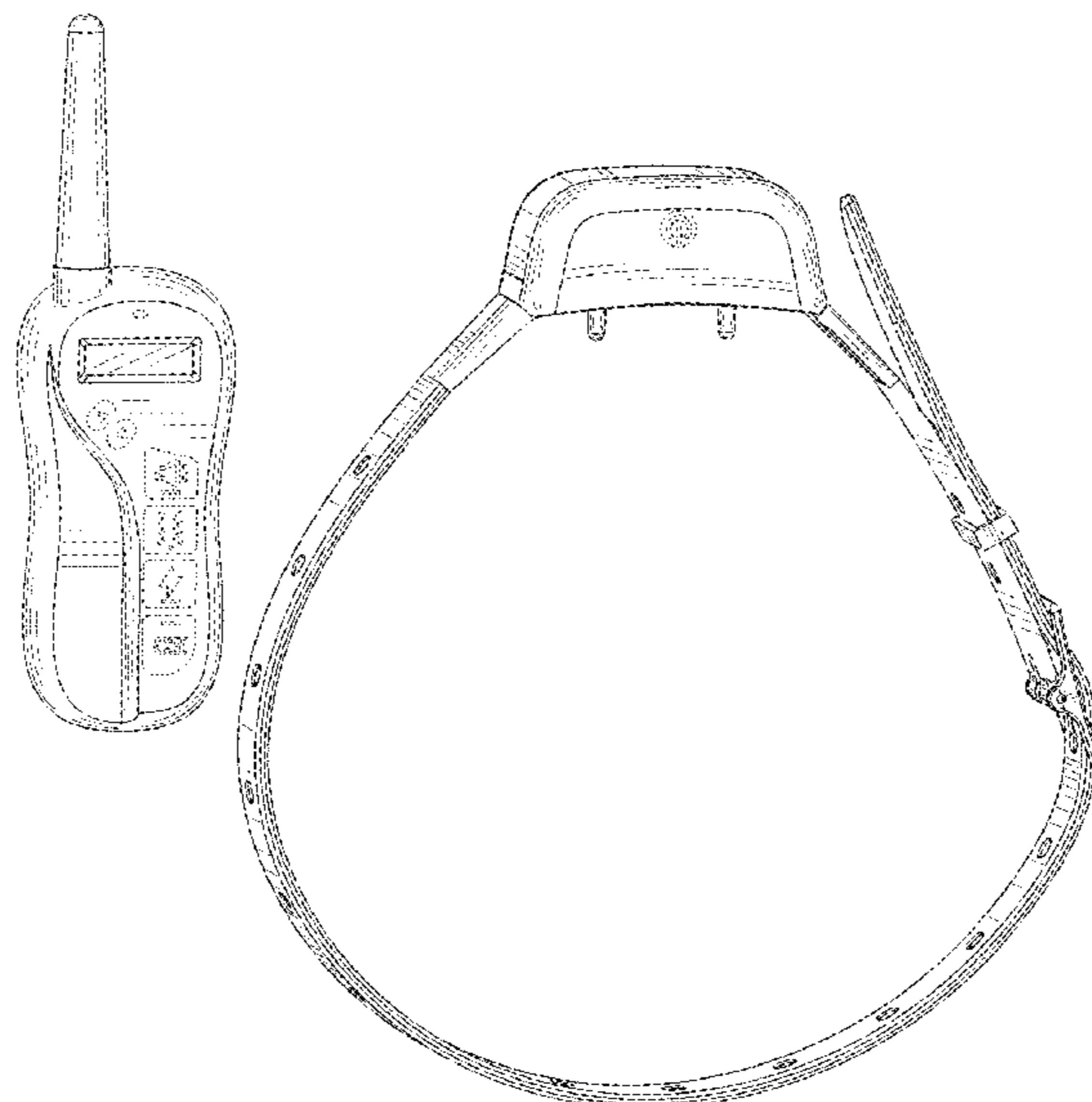
The ornamental design for a training collar with remote control, as shown and described.

DESCRIPTION

FIG. 1 is a front and top perspective view of a training collar with remote control, showing my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

The broken lines in the figures illustrate portions of the training collar with remote control that form no part of the claimed design.

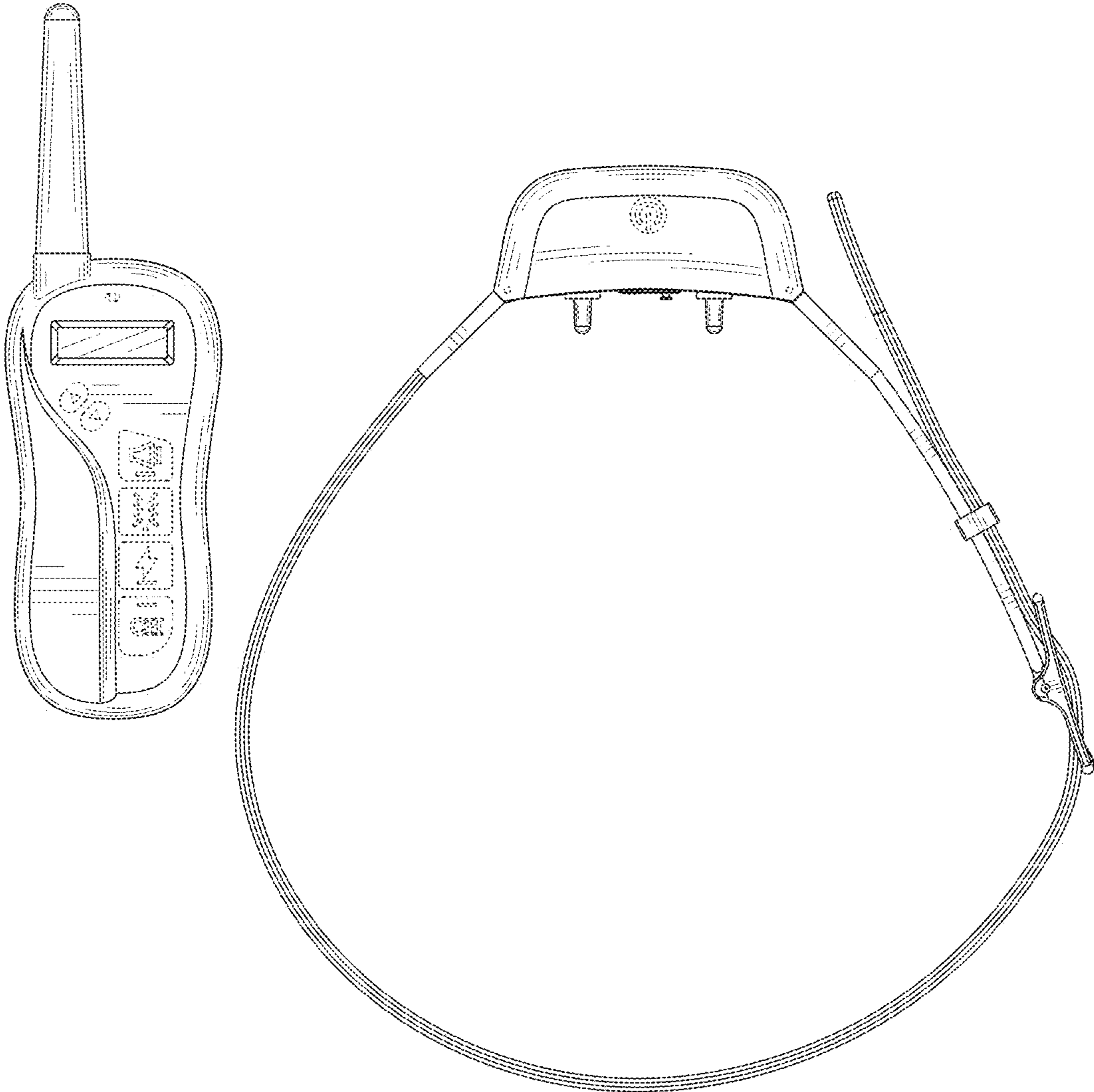

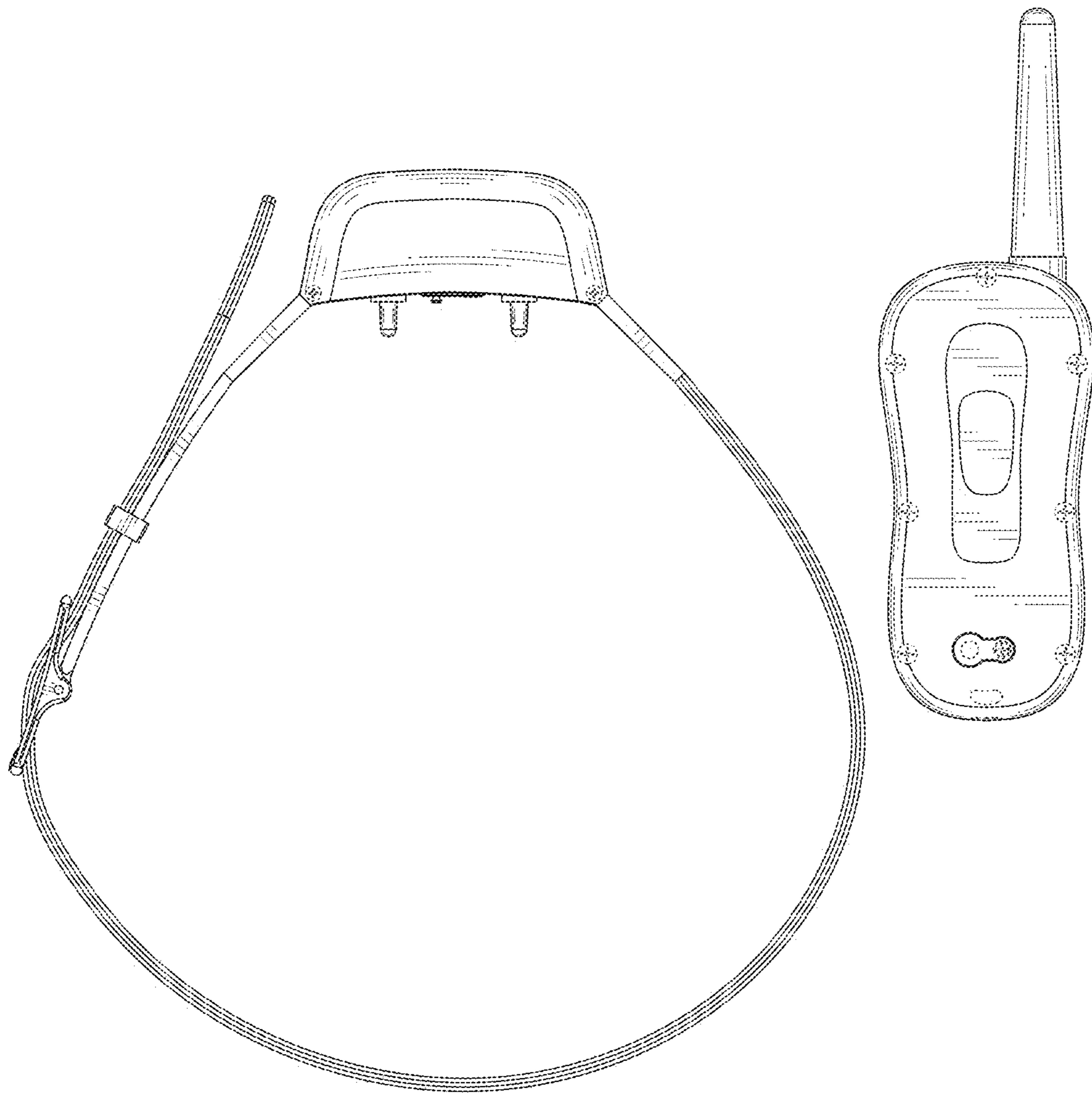

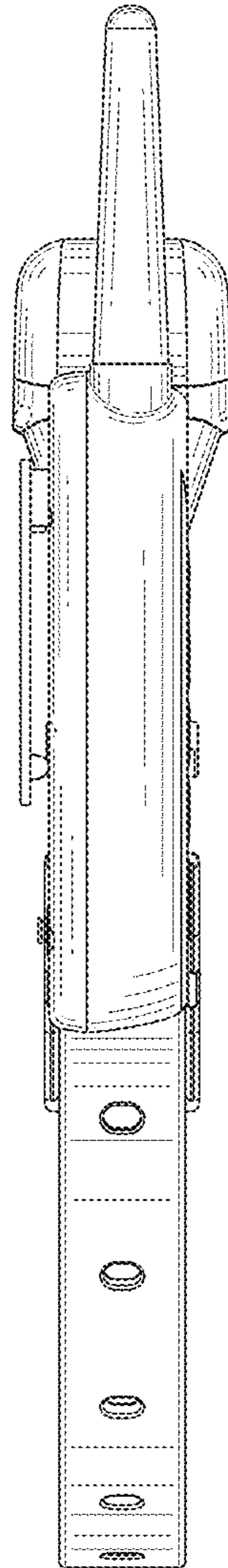

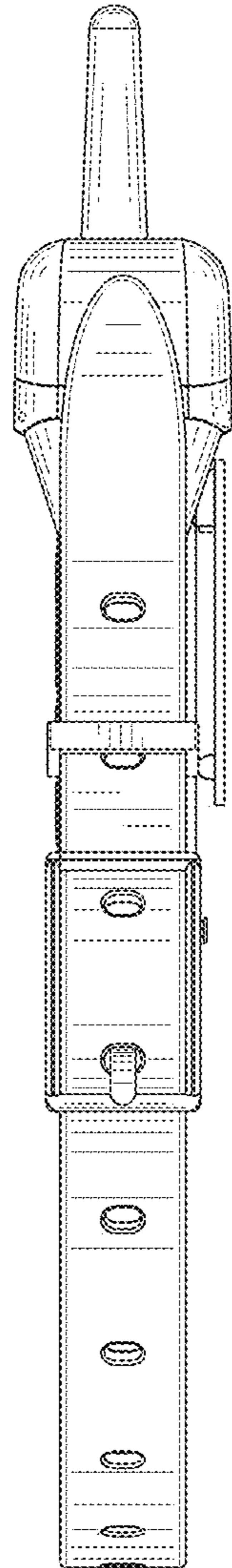

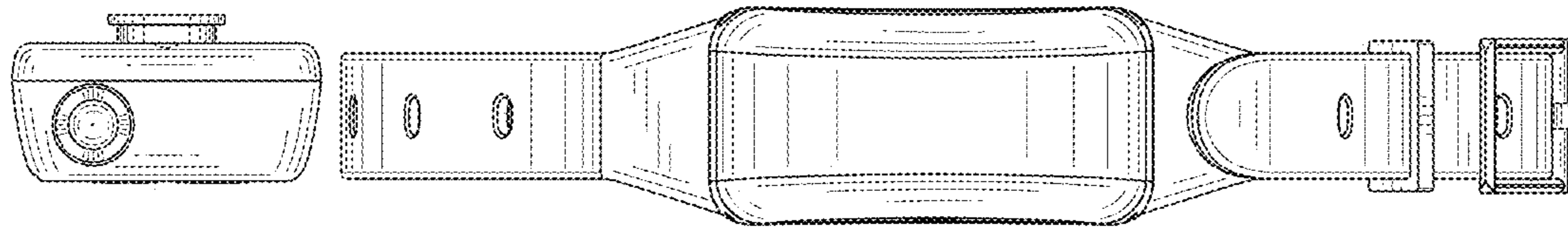

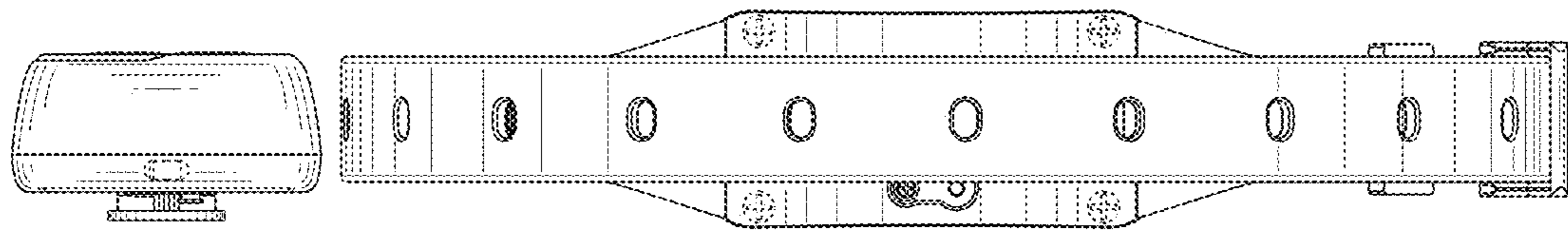
