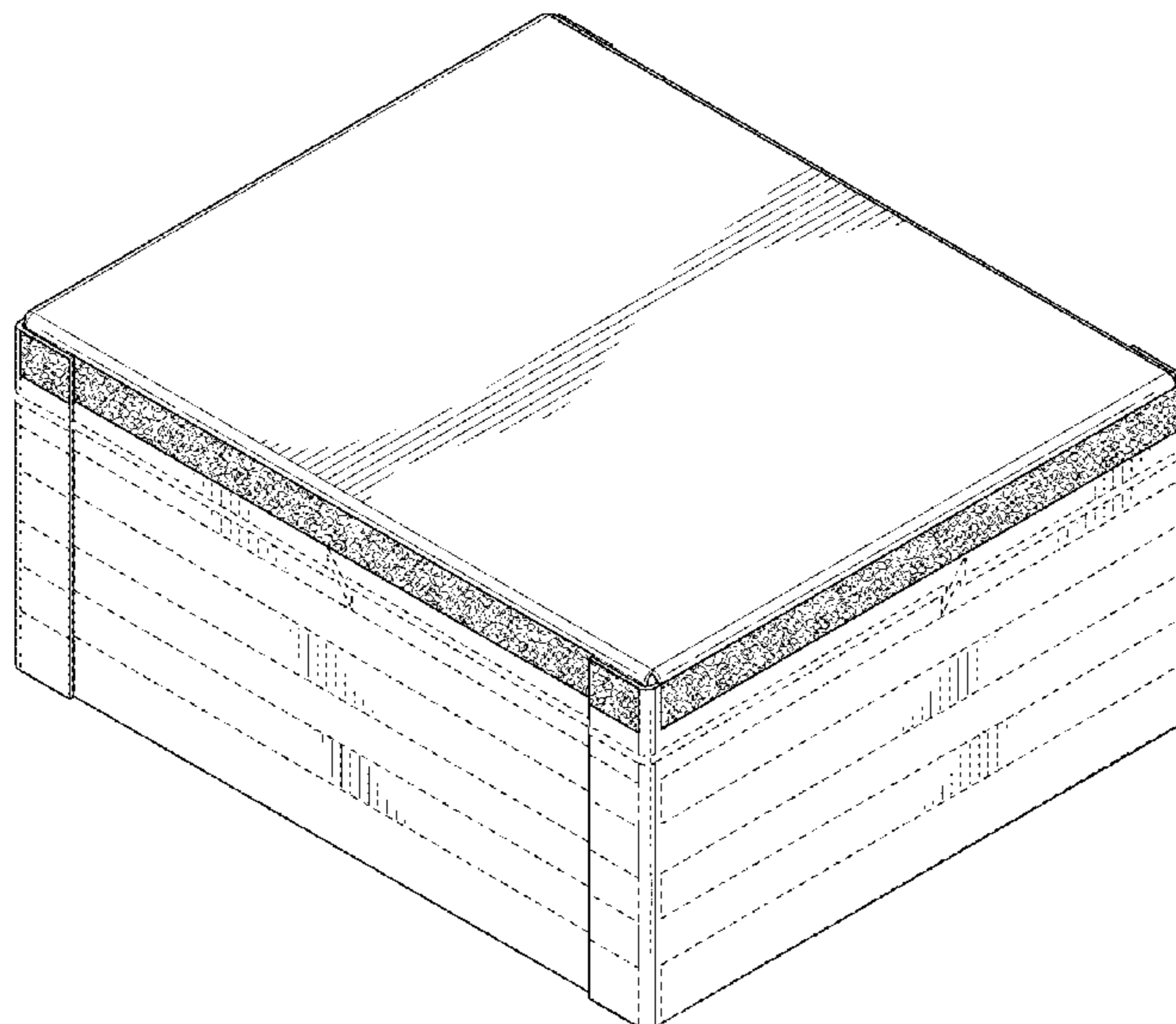
(57) **CLAIM**

The ornamental design for a pallet cover system, as shown  
and described.

**DESCRIPTION**

FIG. 1 is a front perspective view for a pallet cover system  
showing our new design;  
FIG. 2 is a front elevation view thereof;

FIG. 4 is a left elevation view thereof;  
FIG. 5 is a right elevation view thereof;  
FIG. 6 is a top plan view thereof;

FIG. 9 is a top plan view thereof in a flat configuration.  
The broken lines in the figures show portions of the pallet  
cover system, which form no part of the claimed design. The

height. The appearance of any portion of the article between  
the break lines forms no part of the claimed design.

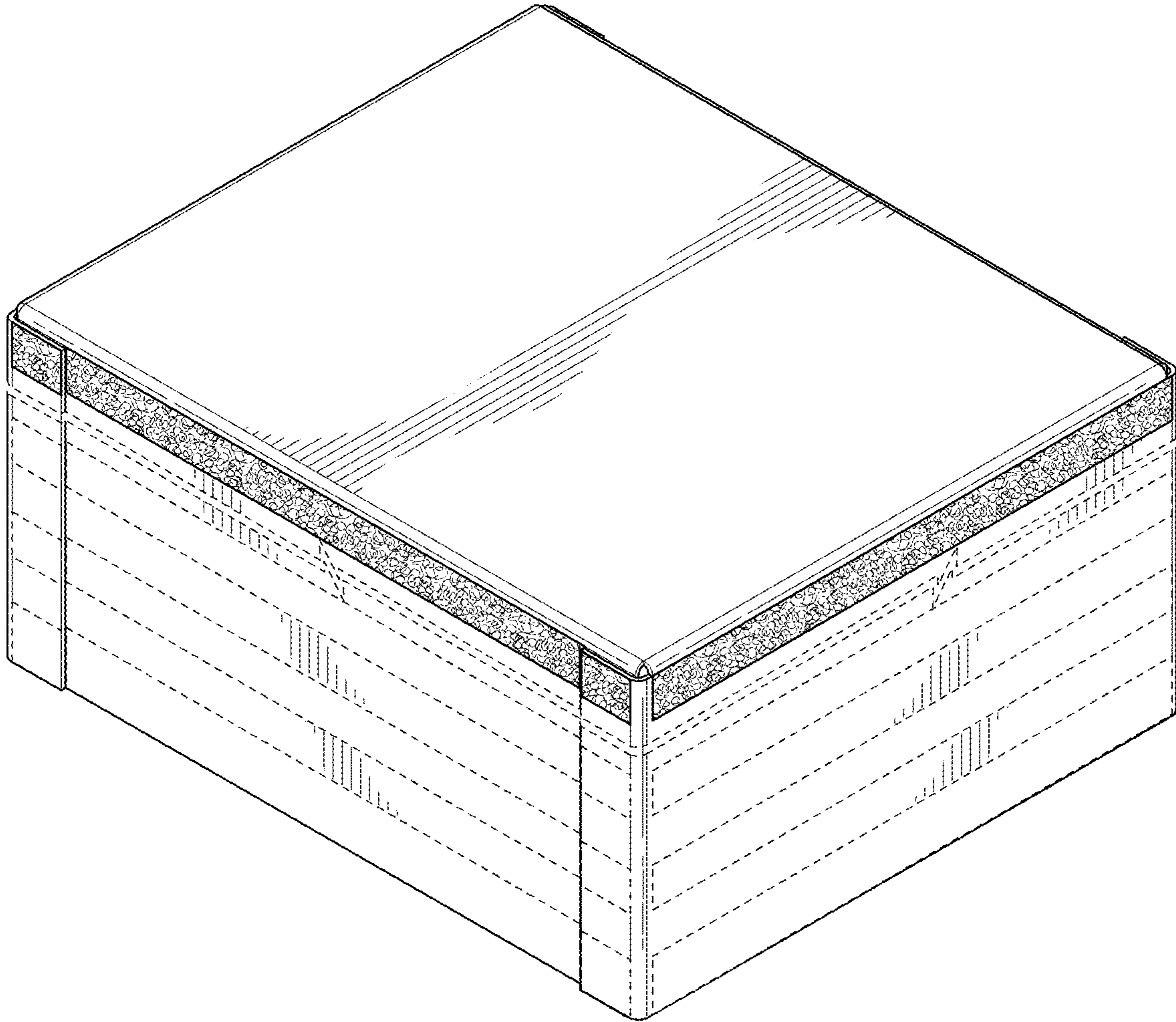

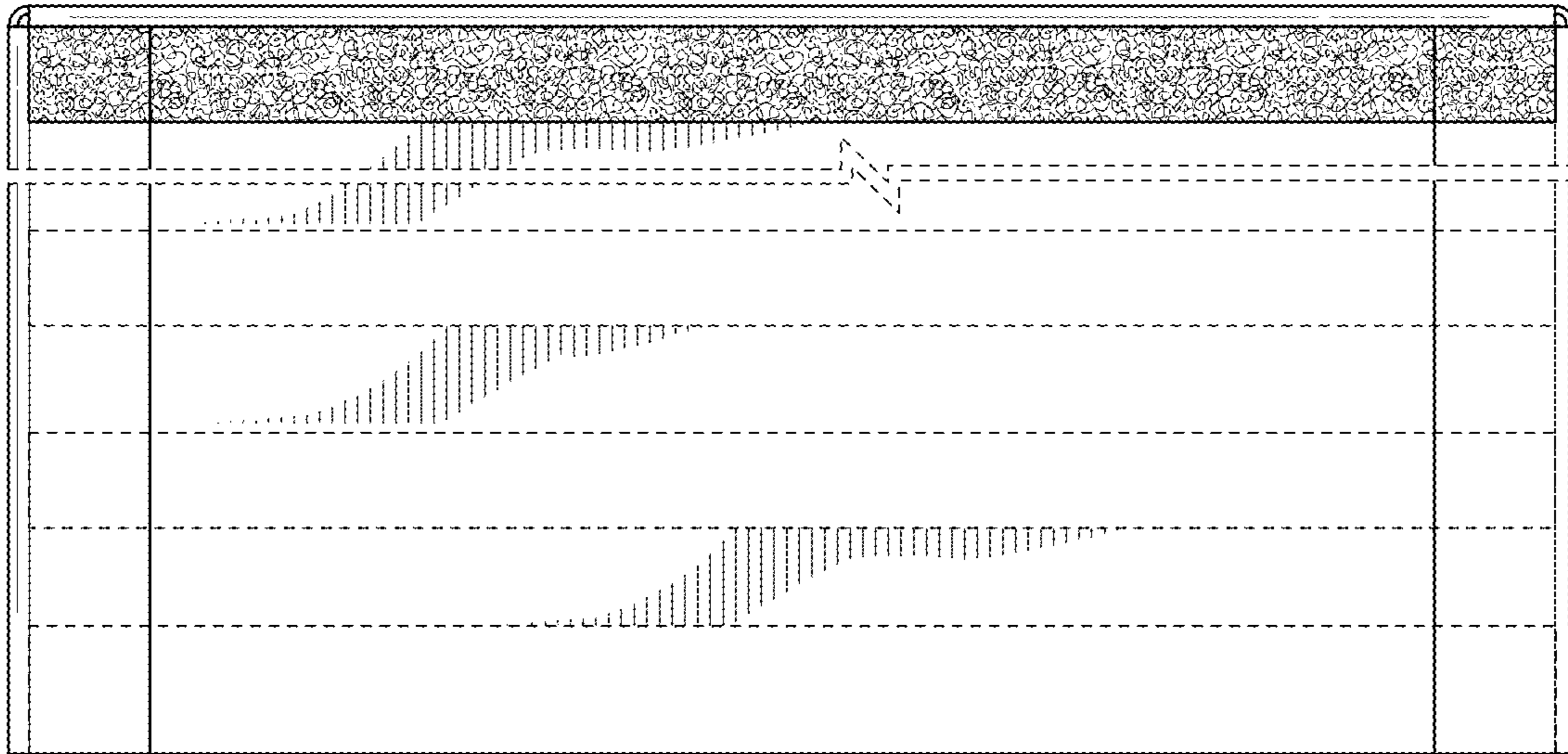

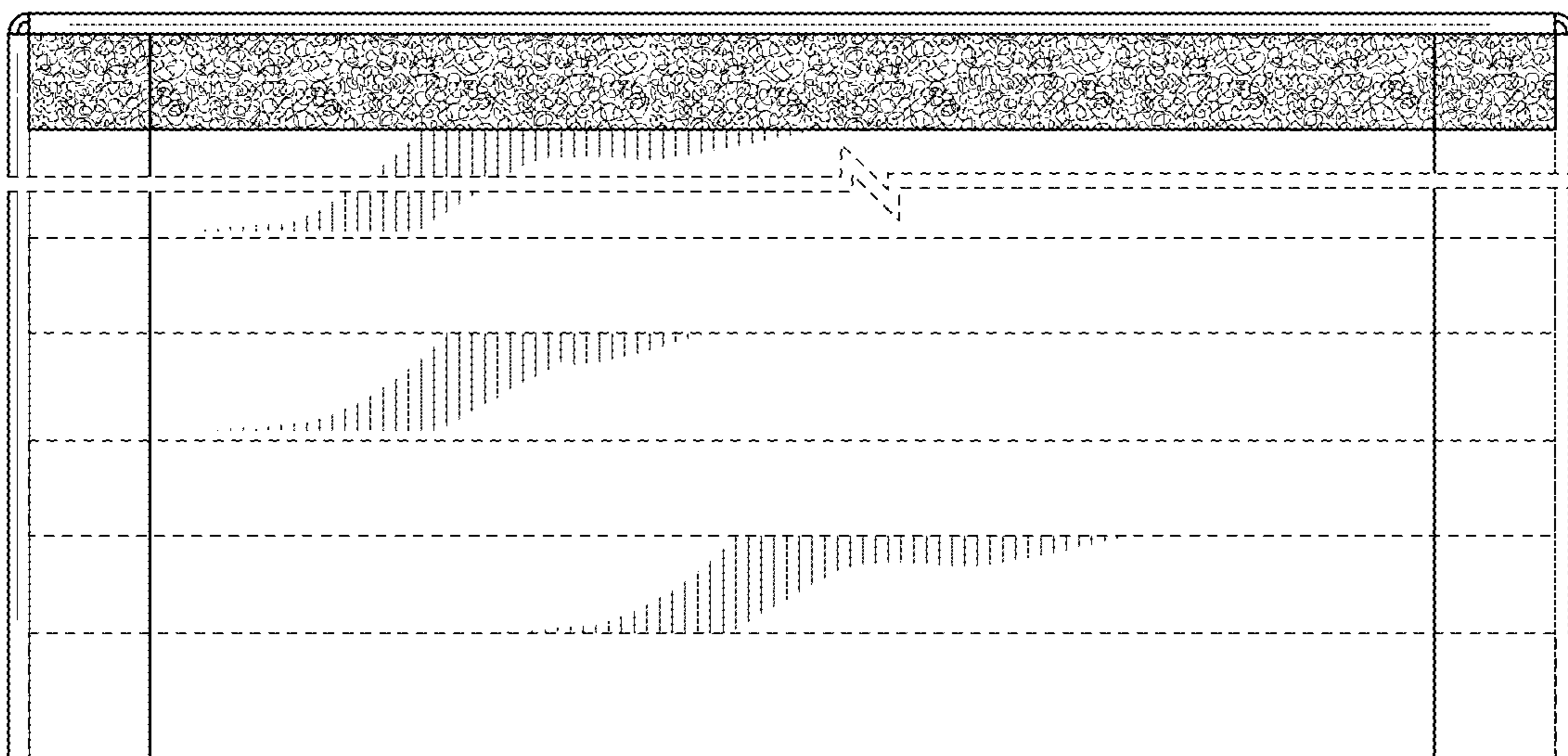

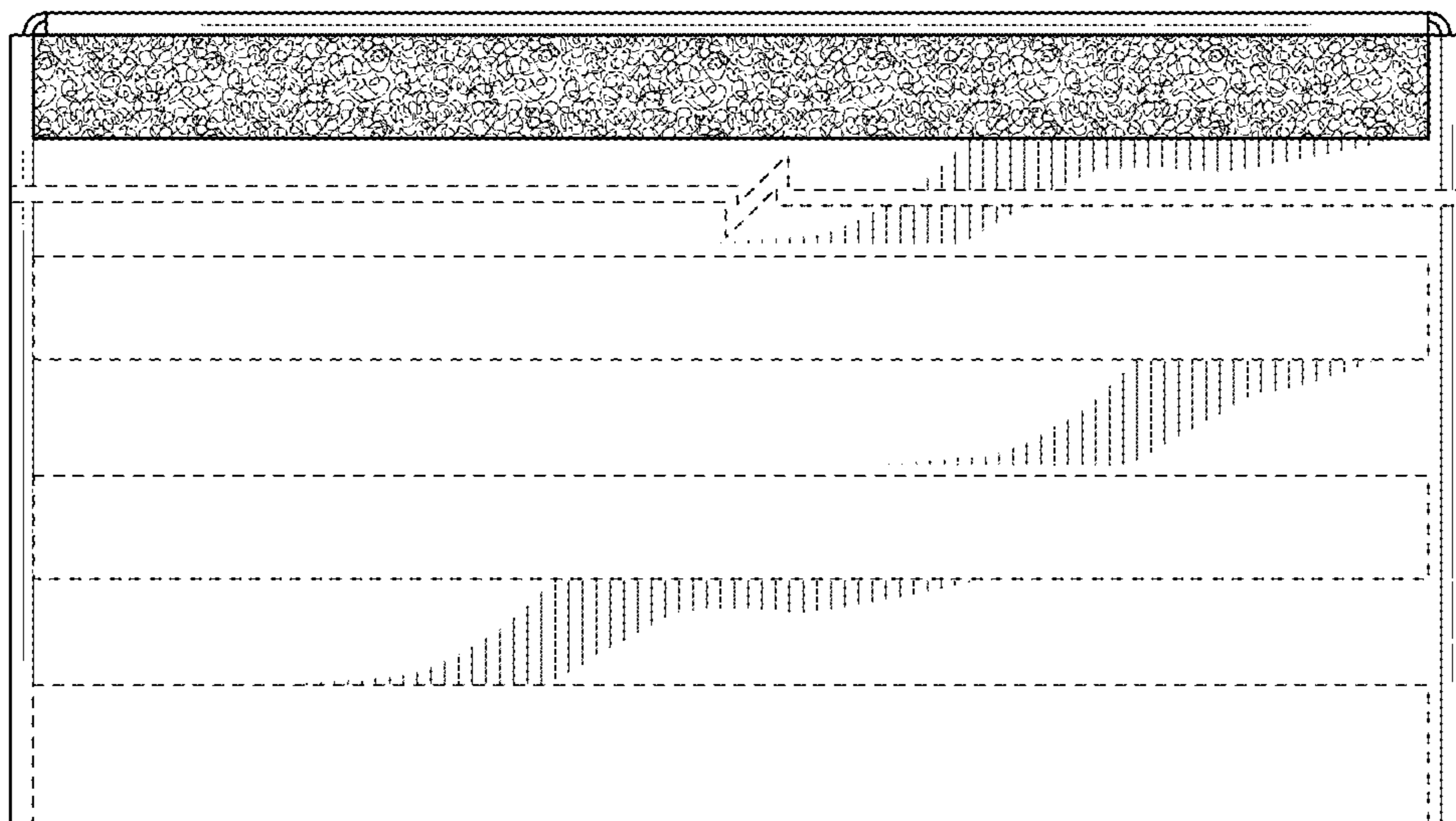




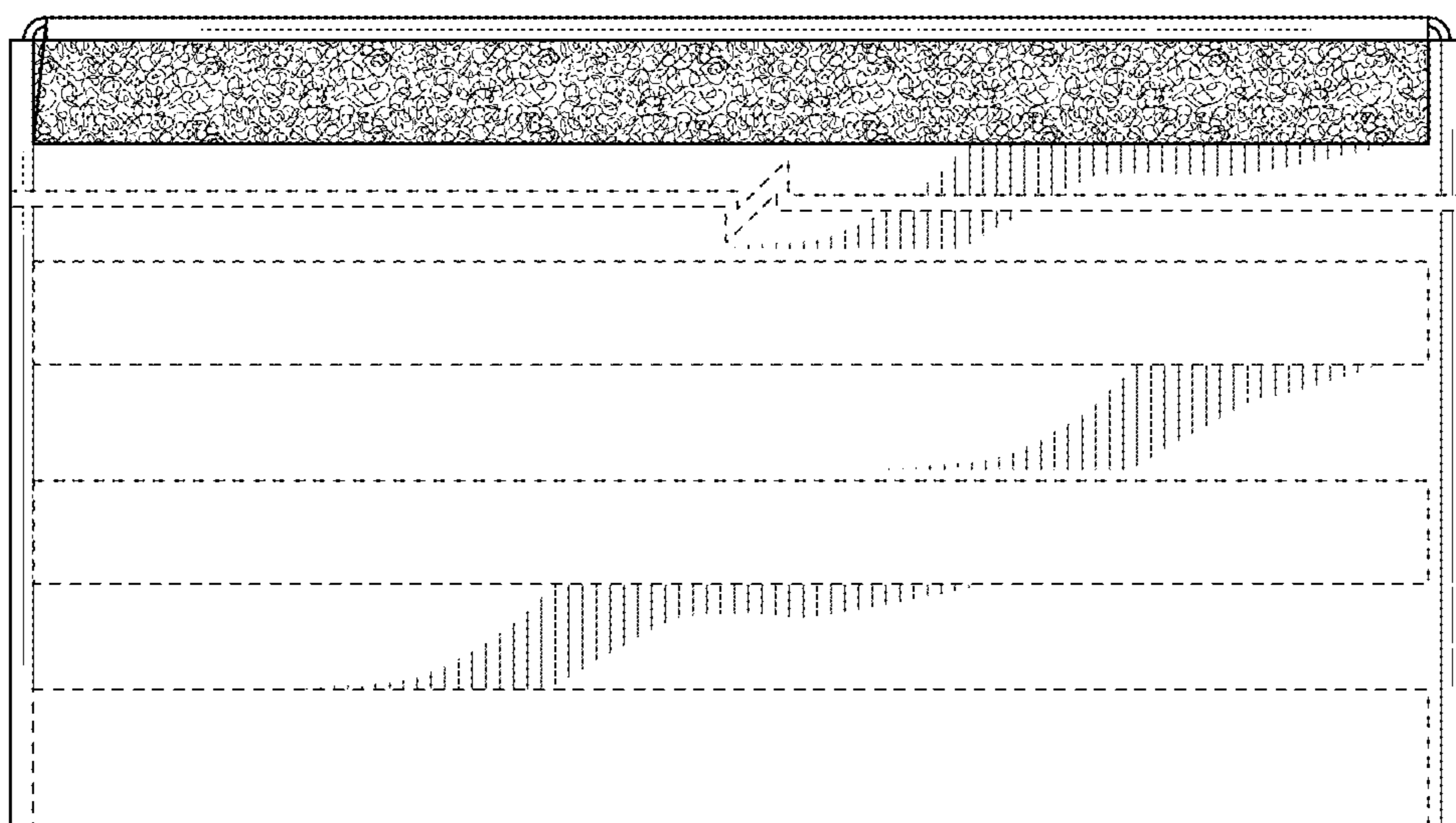

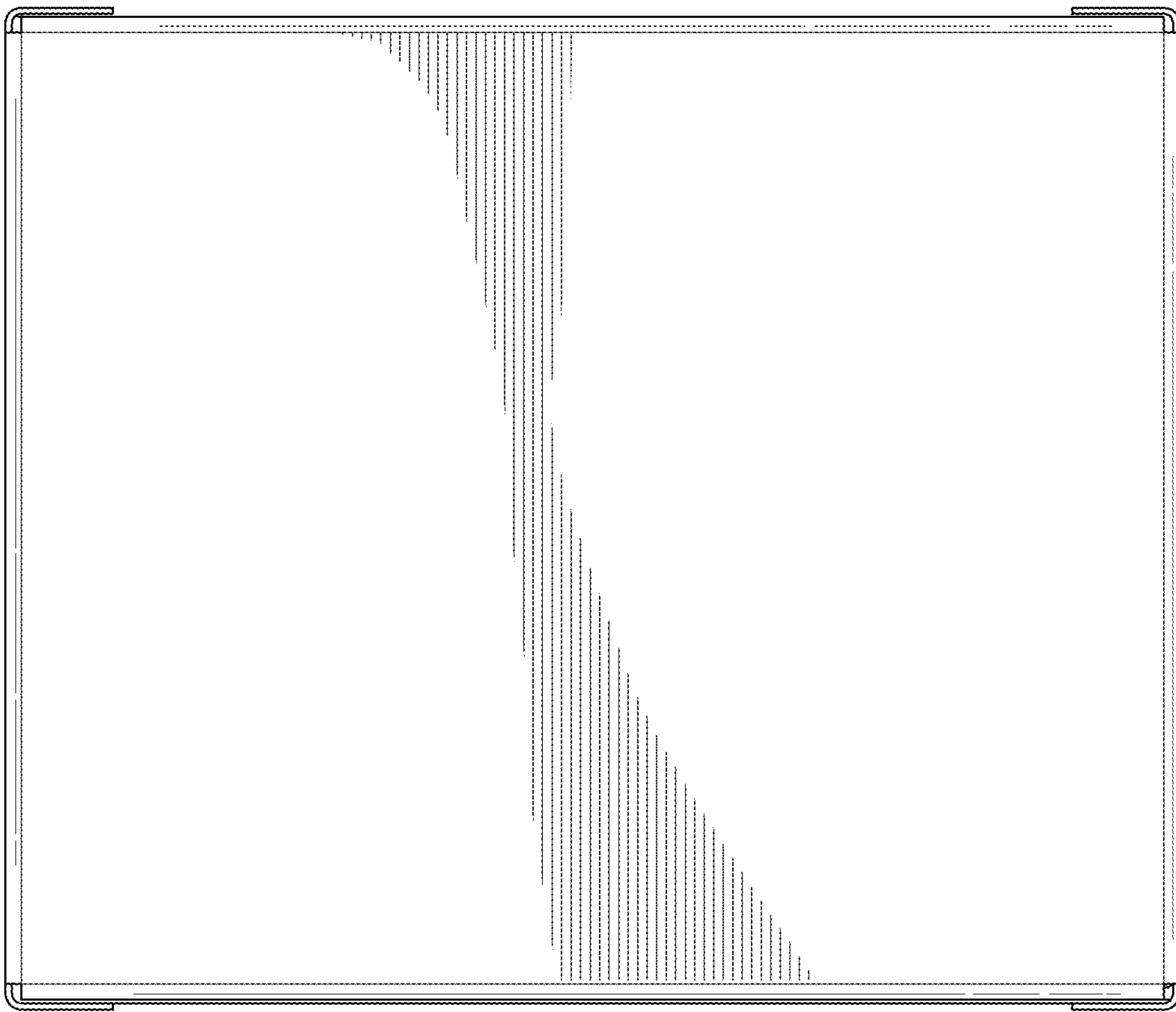

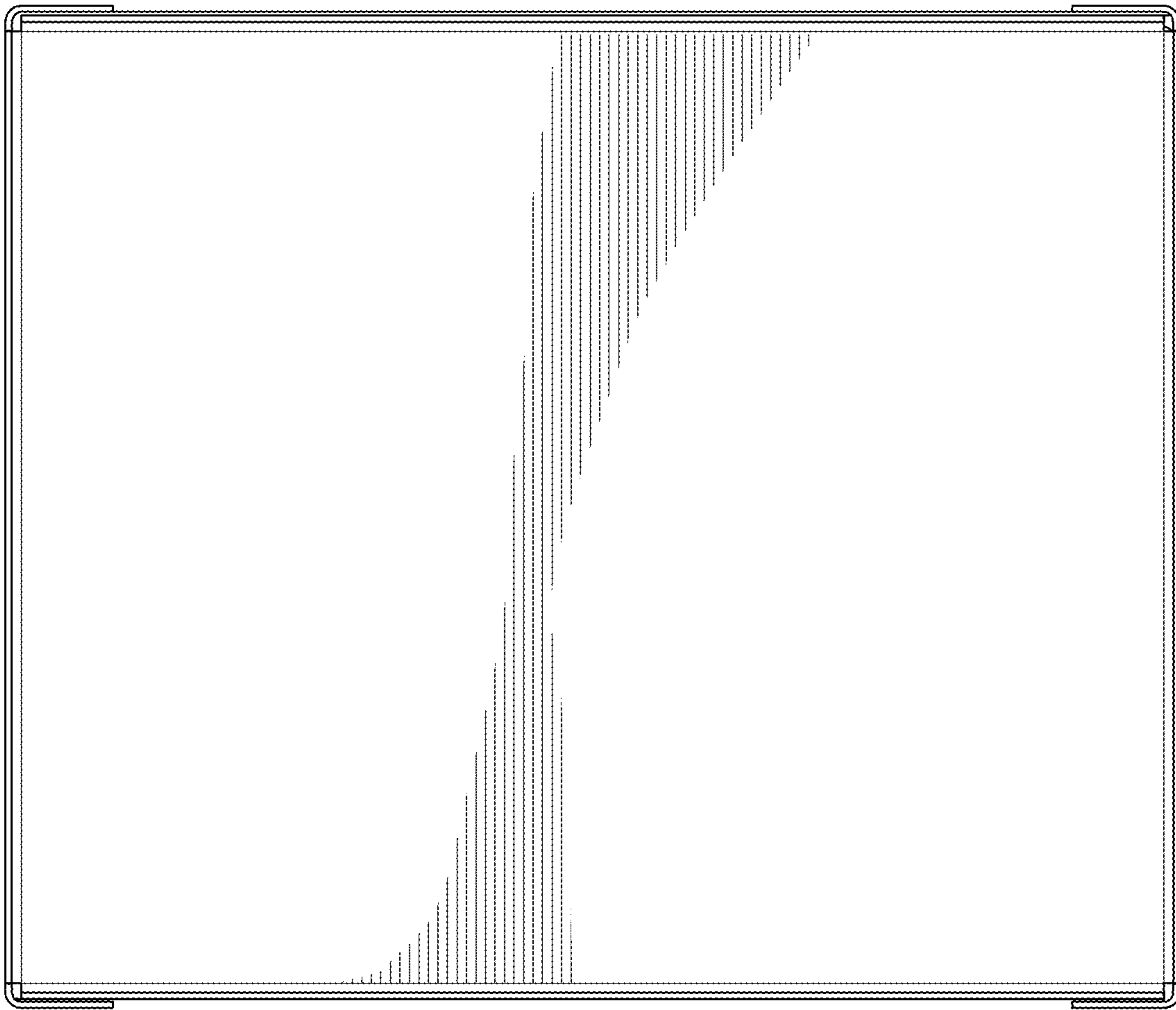

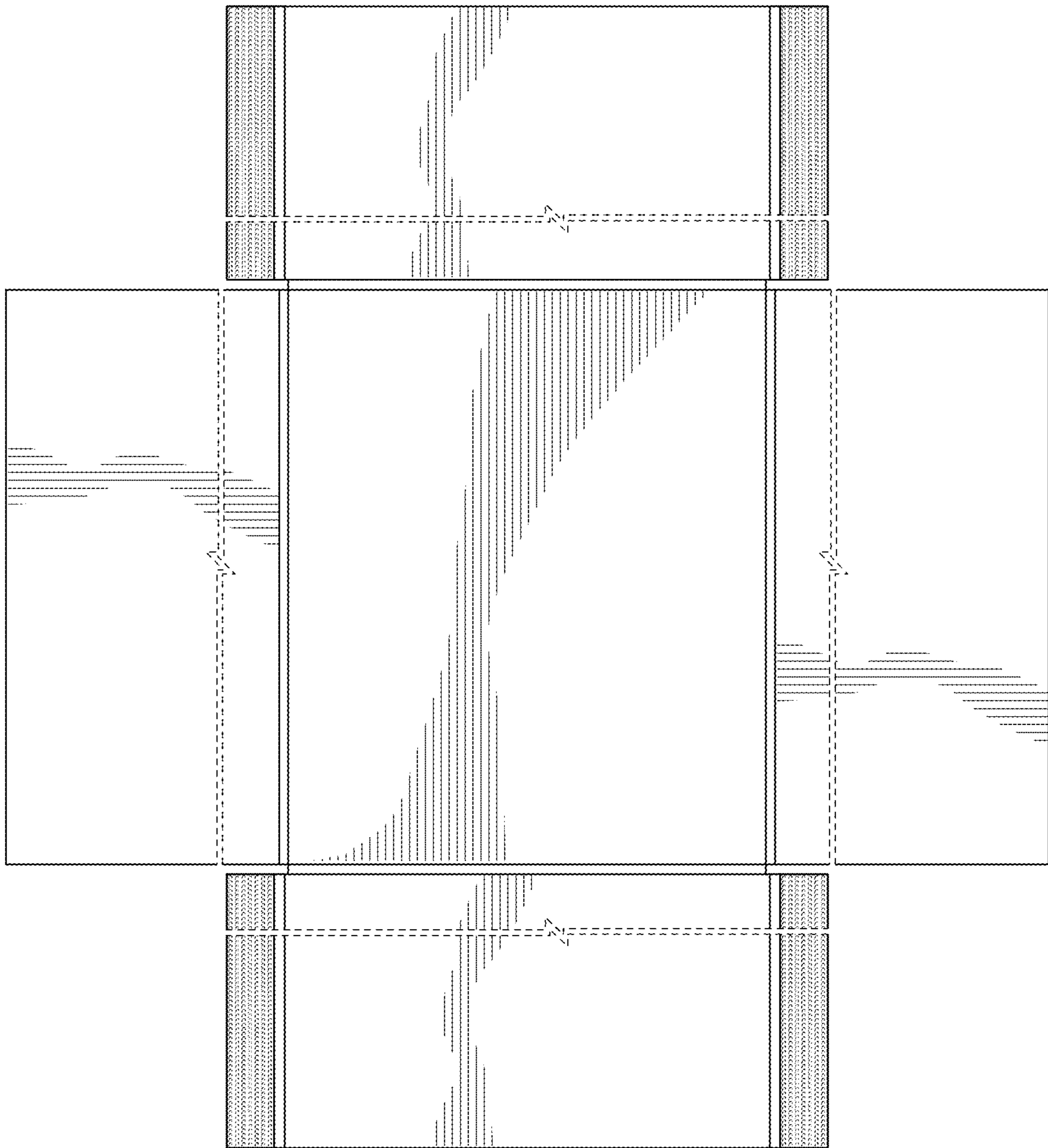

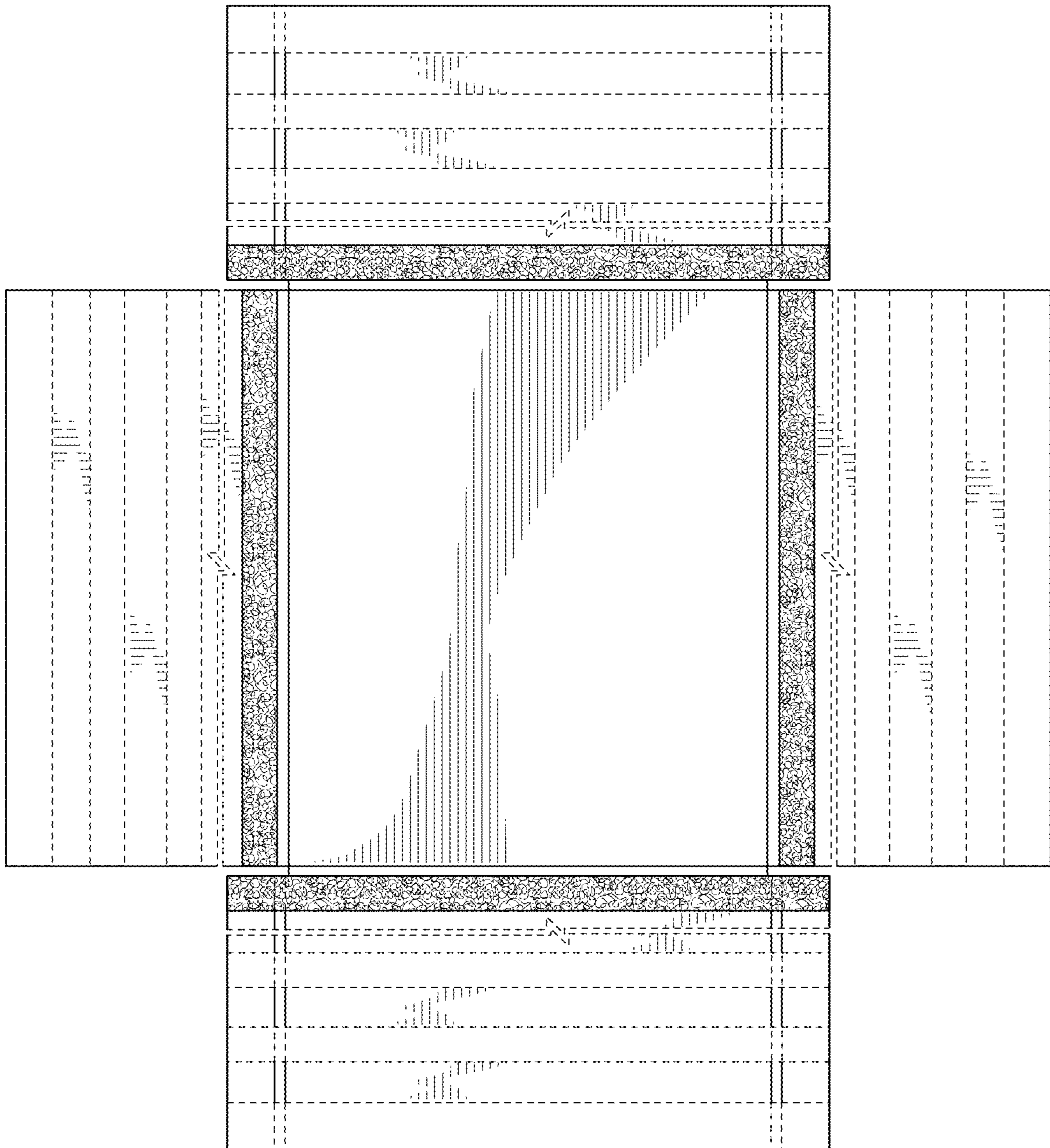
