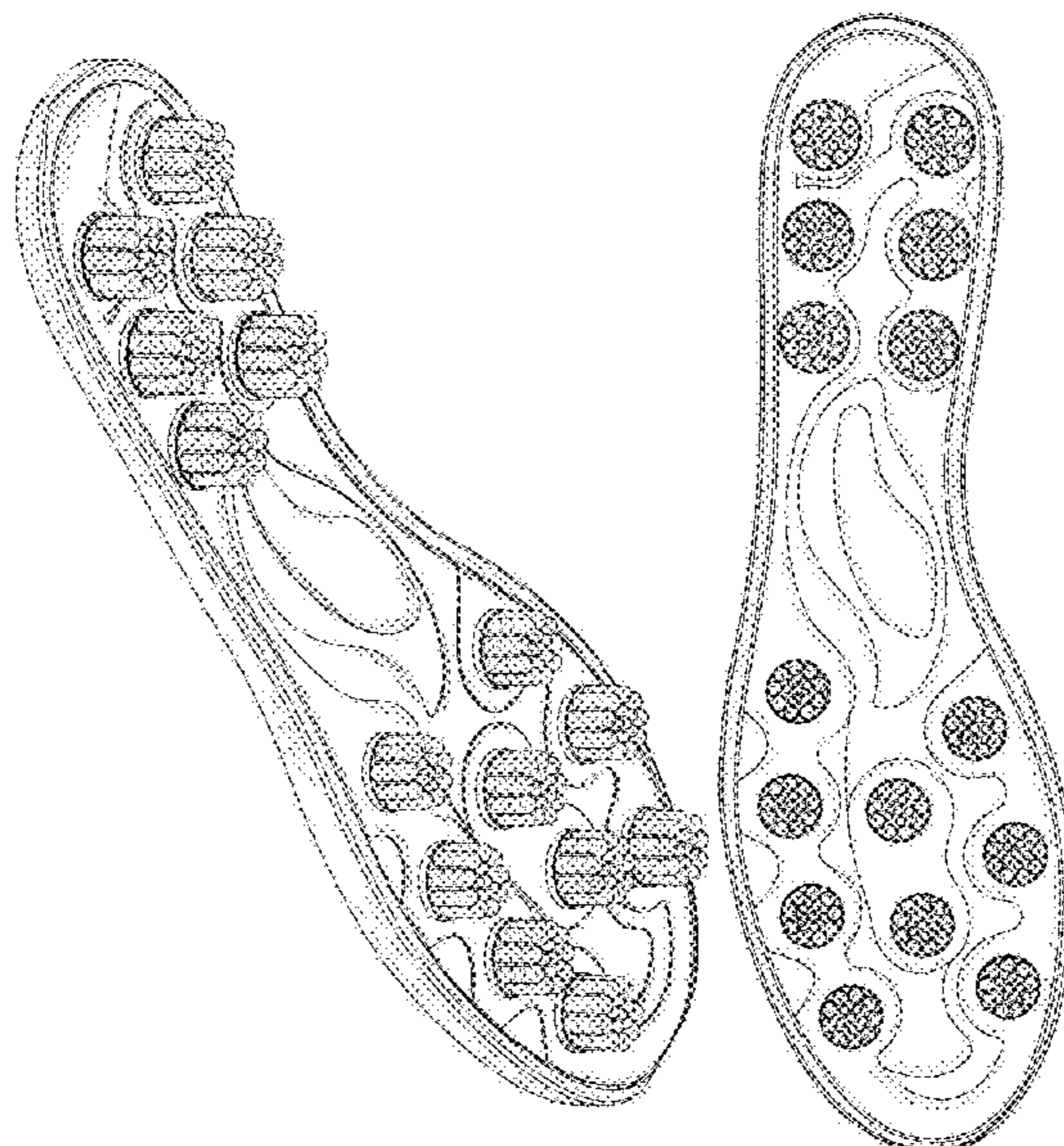
(57) **CLAIM**

The ornamental design for a football sole with spikes, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a football sole with spikes showing my new design.  
FIG. 2 is a front view of the football sole with spikes.  
FIG. 3 is a rear view of the football sole with spikes.  
FIG. 4 is a left side view of the football sole with spikes.  
FIG. 5 is a right side view of the football sole with spikes.  
FIG. 6 is a top view of the football sole with spikes; and,  
FIG. 7 is a bottom view of the football sole with spikes.  
Any shading is not a feature of the design but is utilized to illustrate the surface contours of the football sole with spikes in the drawings.  
The broken line boundaries seen in FIGS. 3 and 7 define the bounds of the claimed design and form no part thereof.

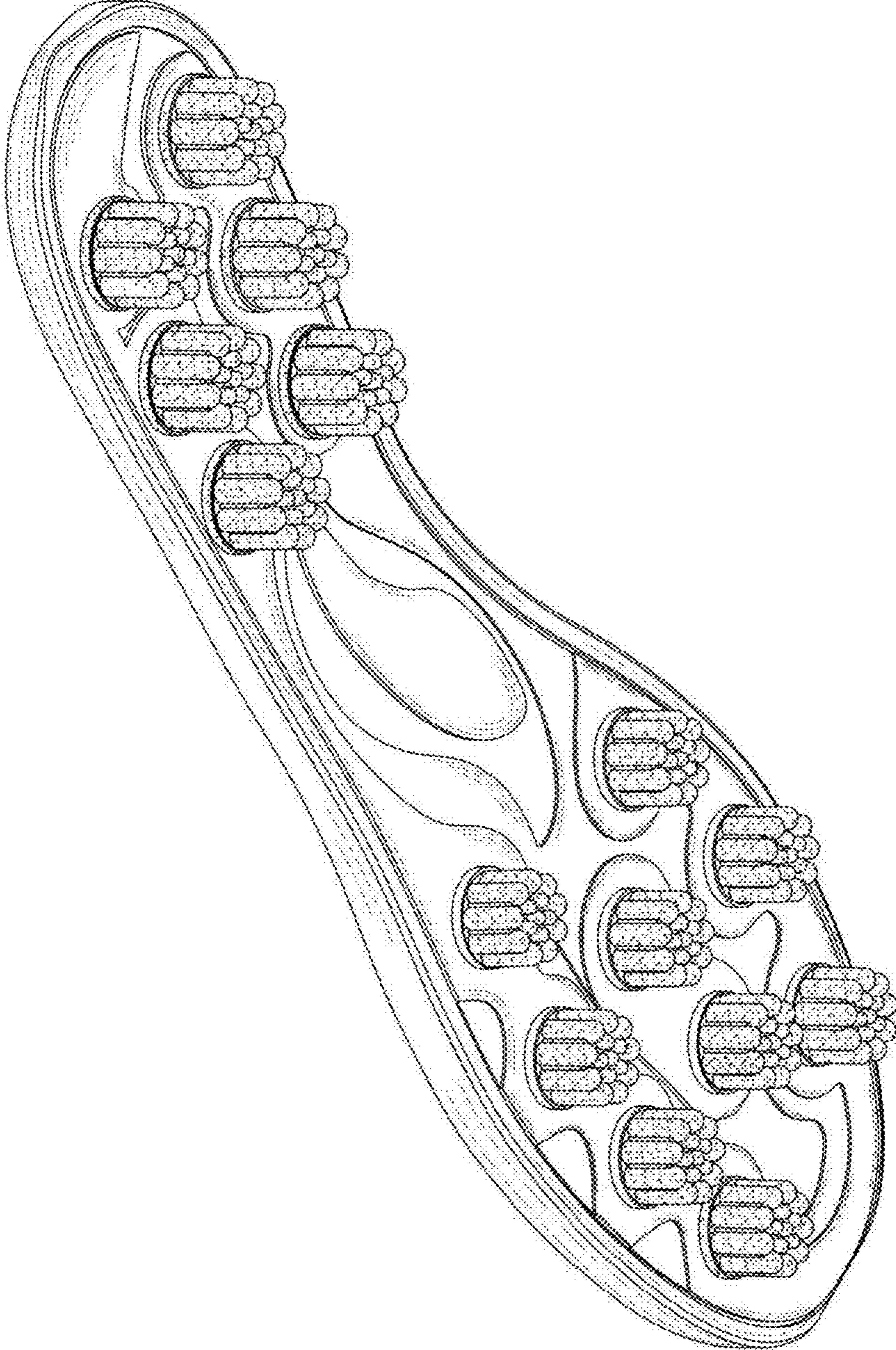

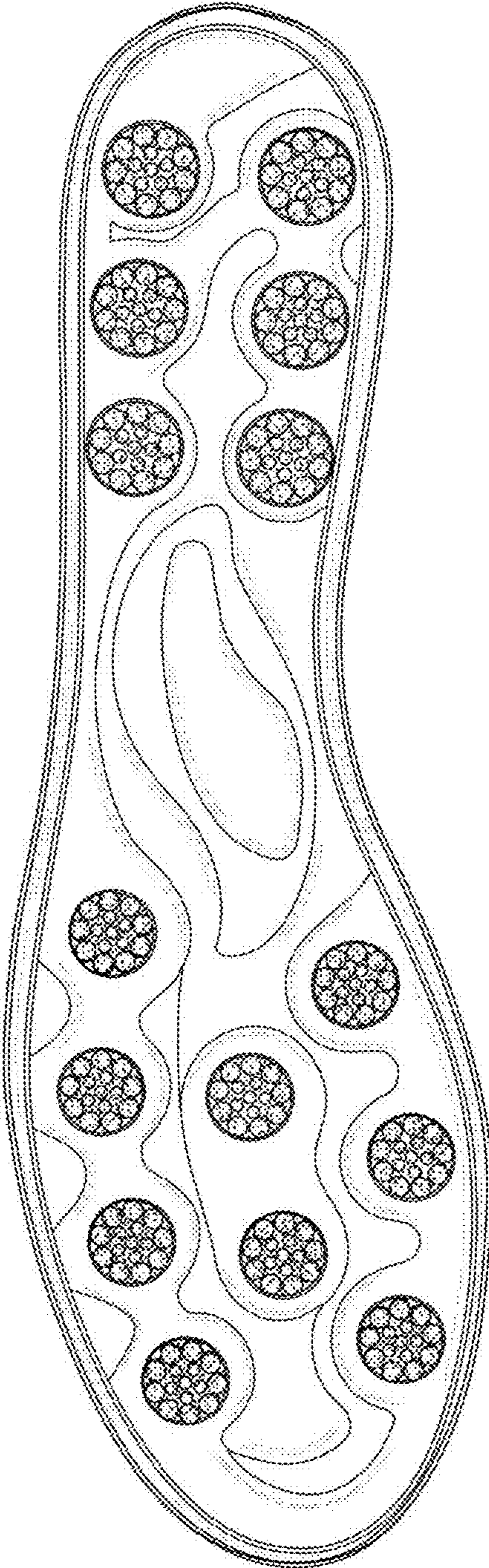

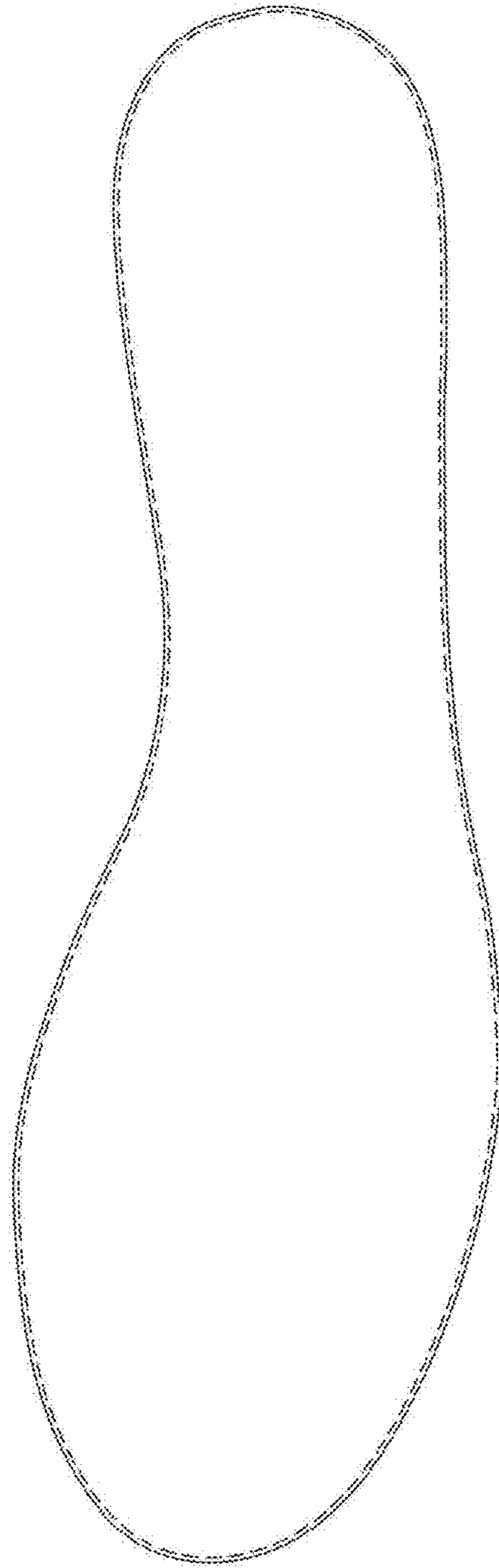

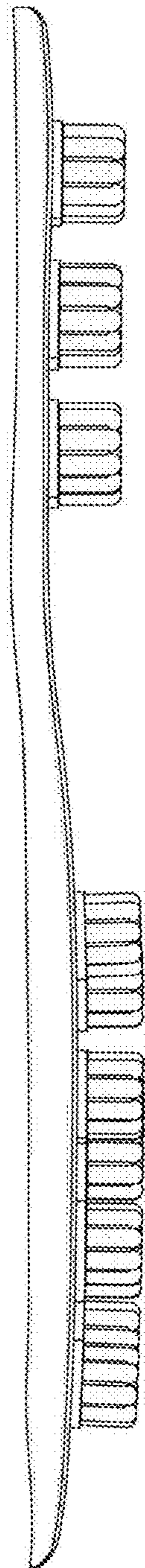

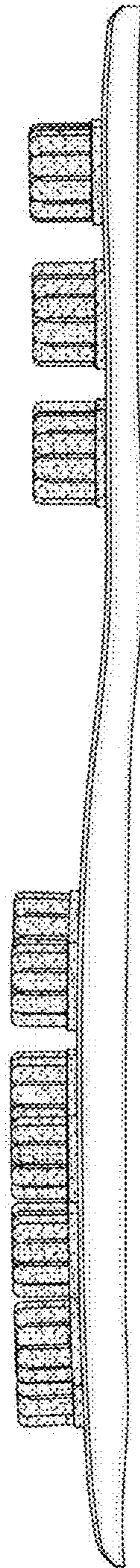

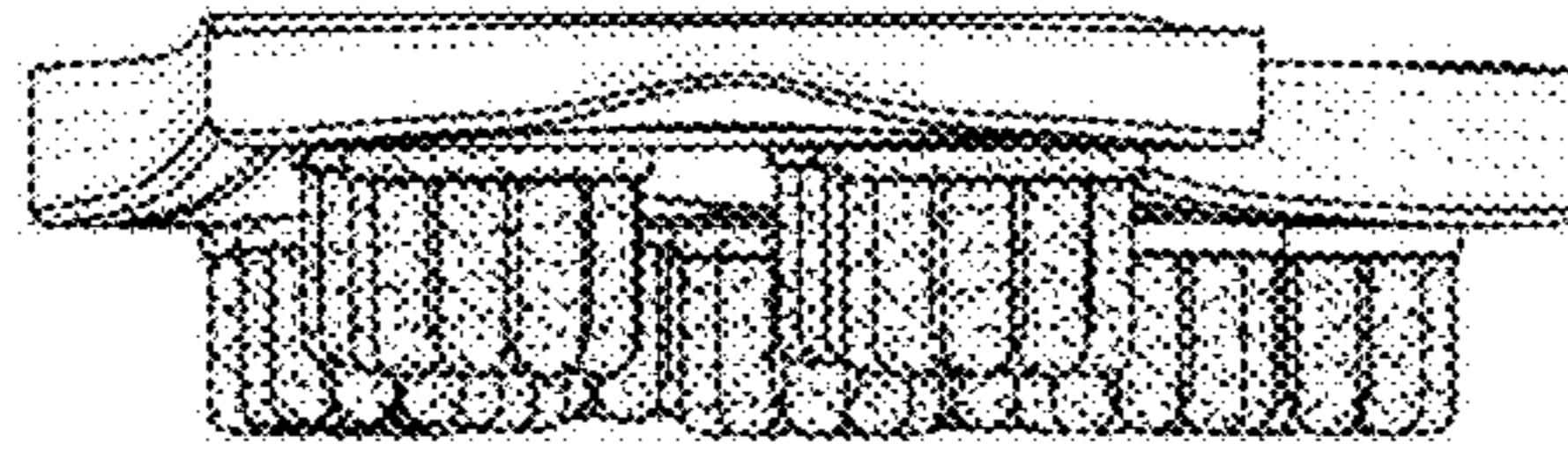

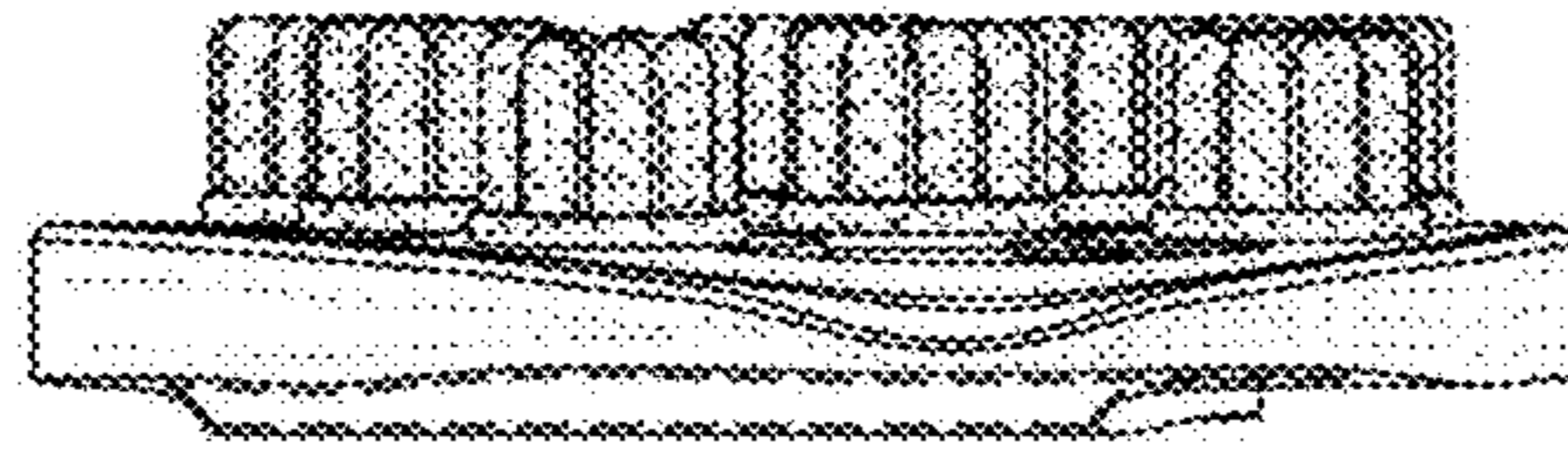
