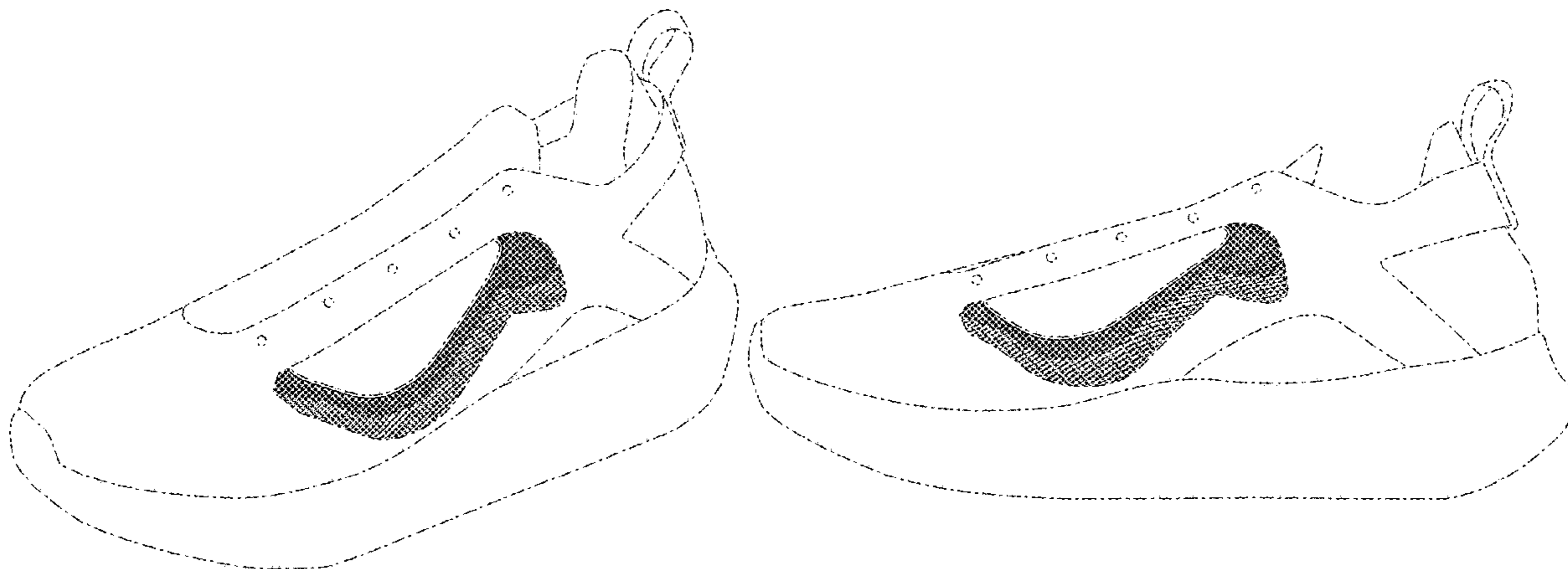
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing our new design;
FIG. 2 is a side view thereof; and,
FIG. 3 is a rear perspective view thereof.
The broken line immediately adjacent to the internal perimeter of the solid line defines the internal bounds of the claimed design and forms no part thereof. The broken line immediately adjacent to the photographic area represents the bounds of the claimed design and forms no part thereof. The broken lines depicting the remainder of the shoe form no part of the claimed design.

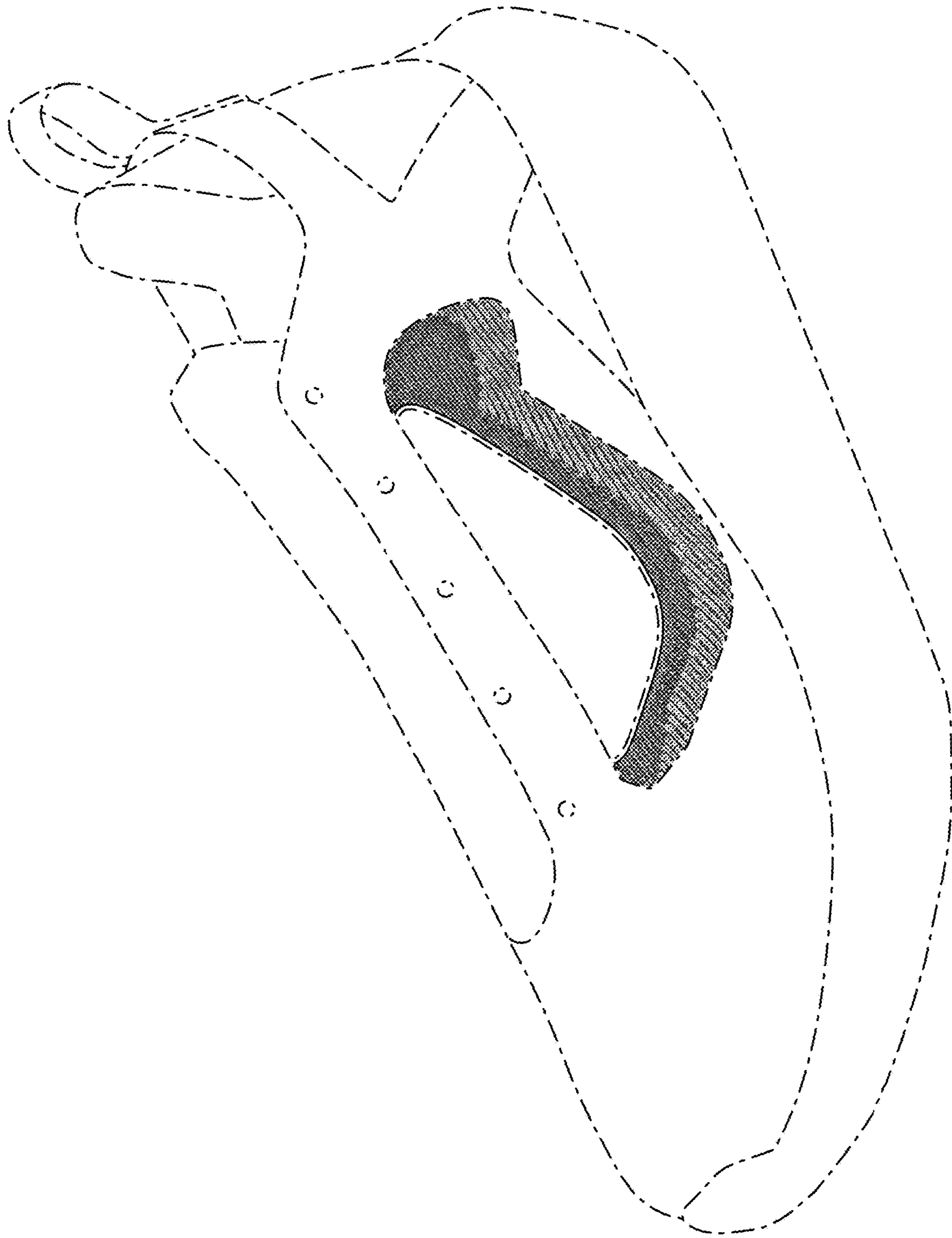

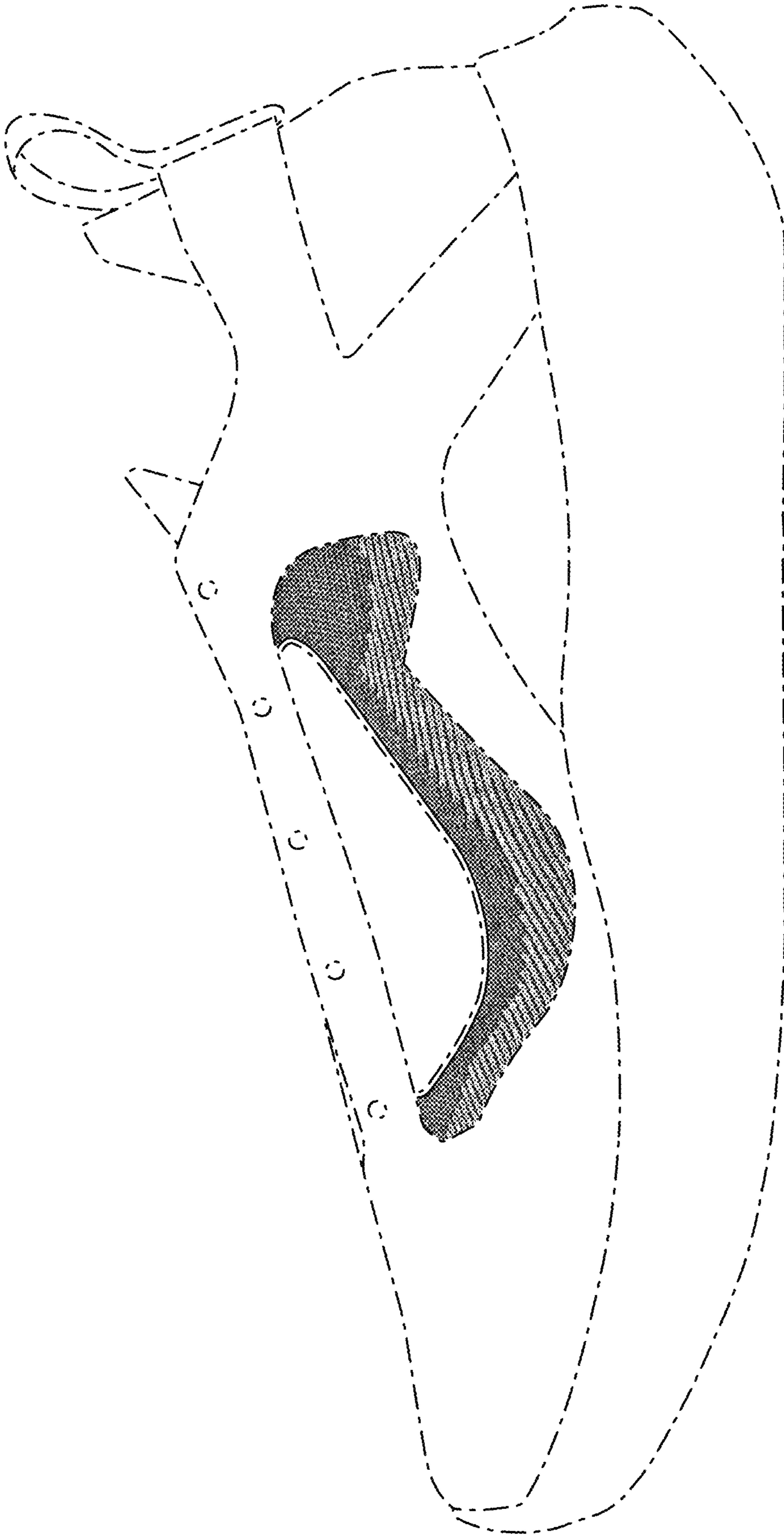

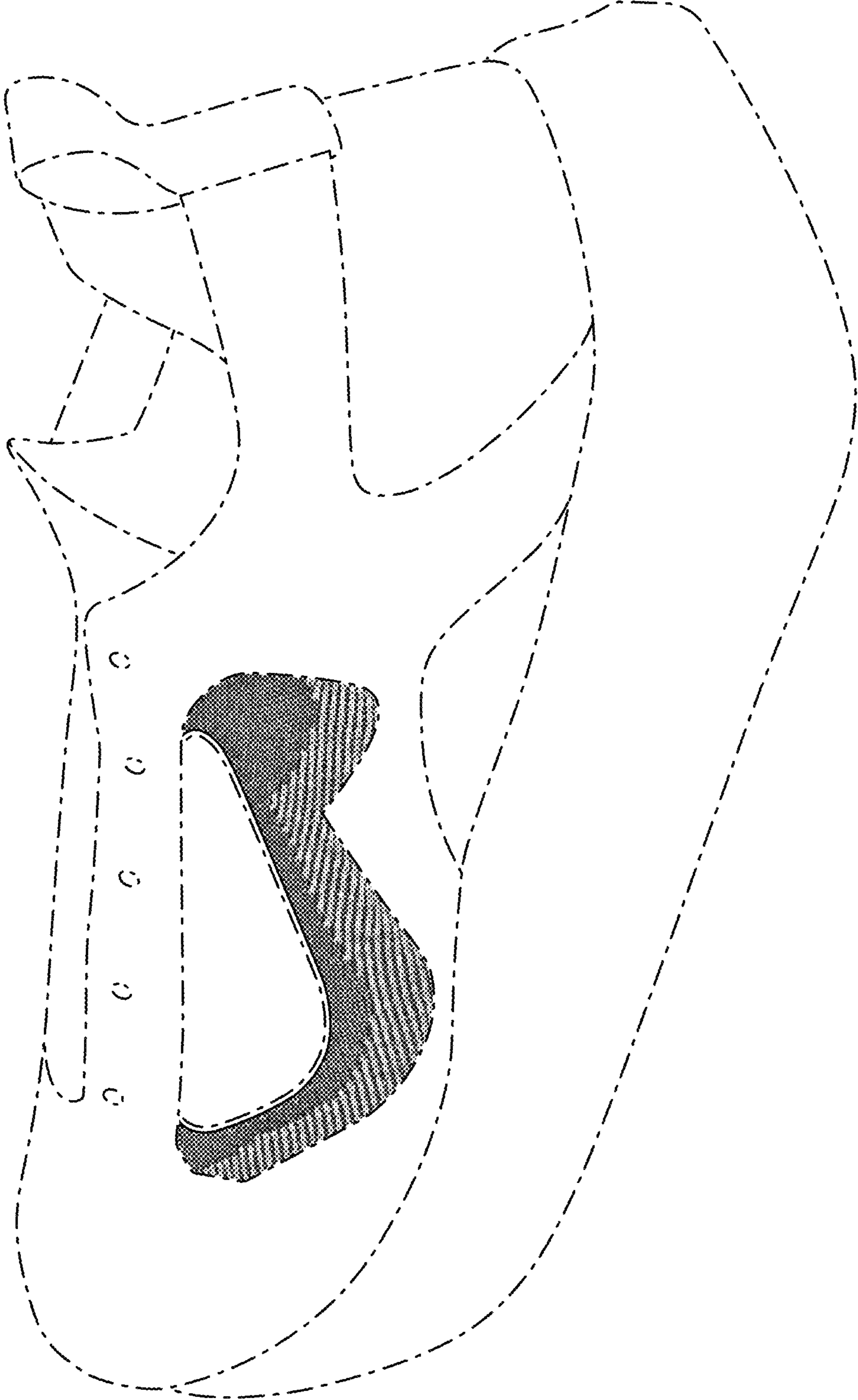
