The ornamental design for a bag, as shown and described.

DESCRIPTION

- 1. Bag
- 1.1 : Perspective
- 1.2 : Front
- 1.3 : Back
- 1.4 : Right
- 1.5 : Left
- 1.6 : Top
- 1.7 : Bottom

1.1 is a top, front, and right side perspective view of bags embodying our new design; 1.2 is a front elevation view thereof; 1.3 is a rear elevation view thereof; 1.4 is a right side elevation view thereof; 1.5 is a left side elevation view thereof; 1.6 is a top plan view thereof; and 1.7 is a bottom plan view thereof; this article is a bag that stores various items such as wallets, smartphones, cosmetics, accessories, etc; it is portable by using a strap connected to the main body, and is used with being attached to and detached from electric kickboards and bicycles.

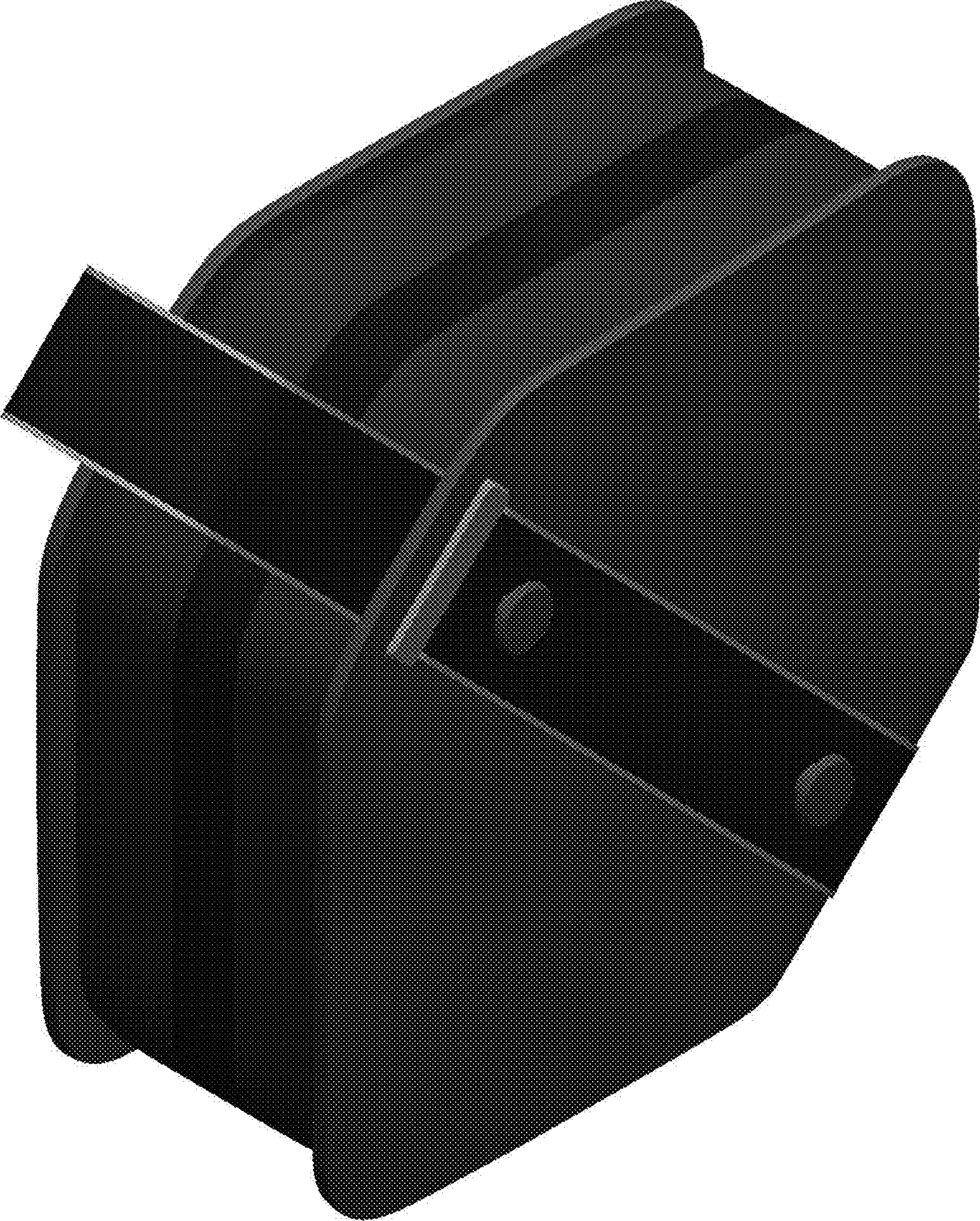

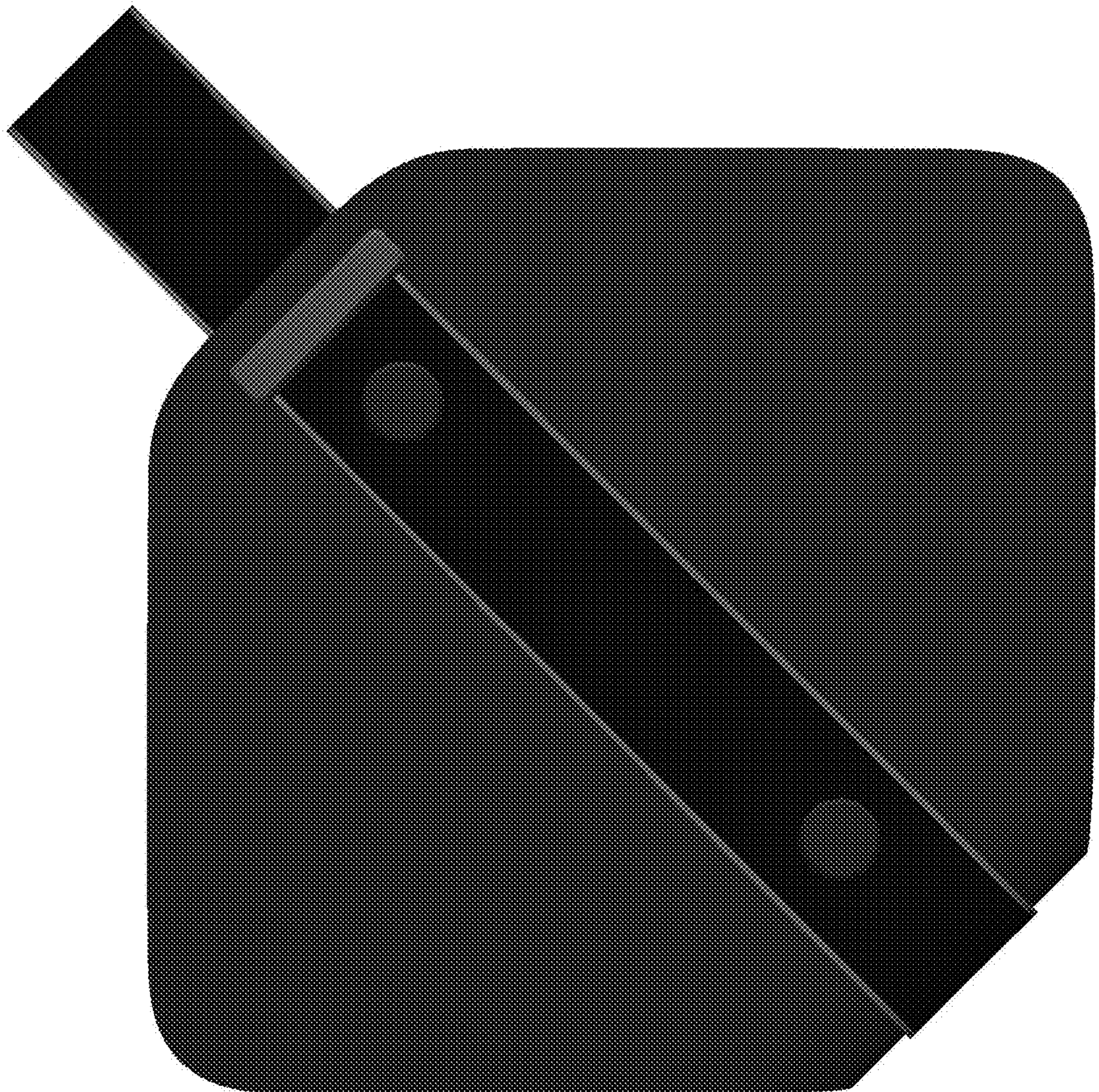

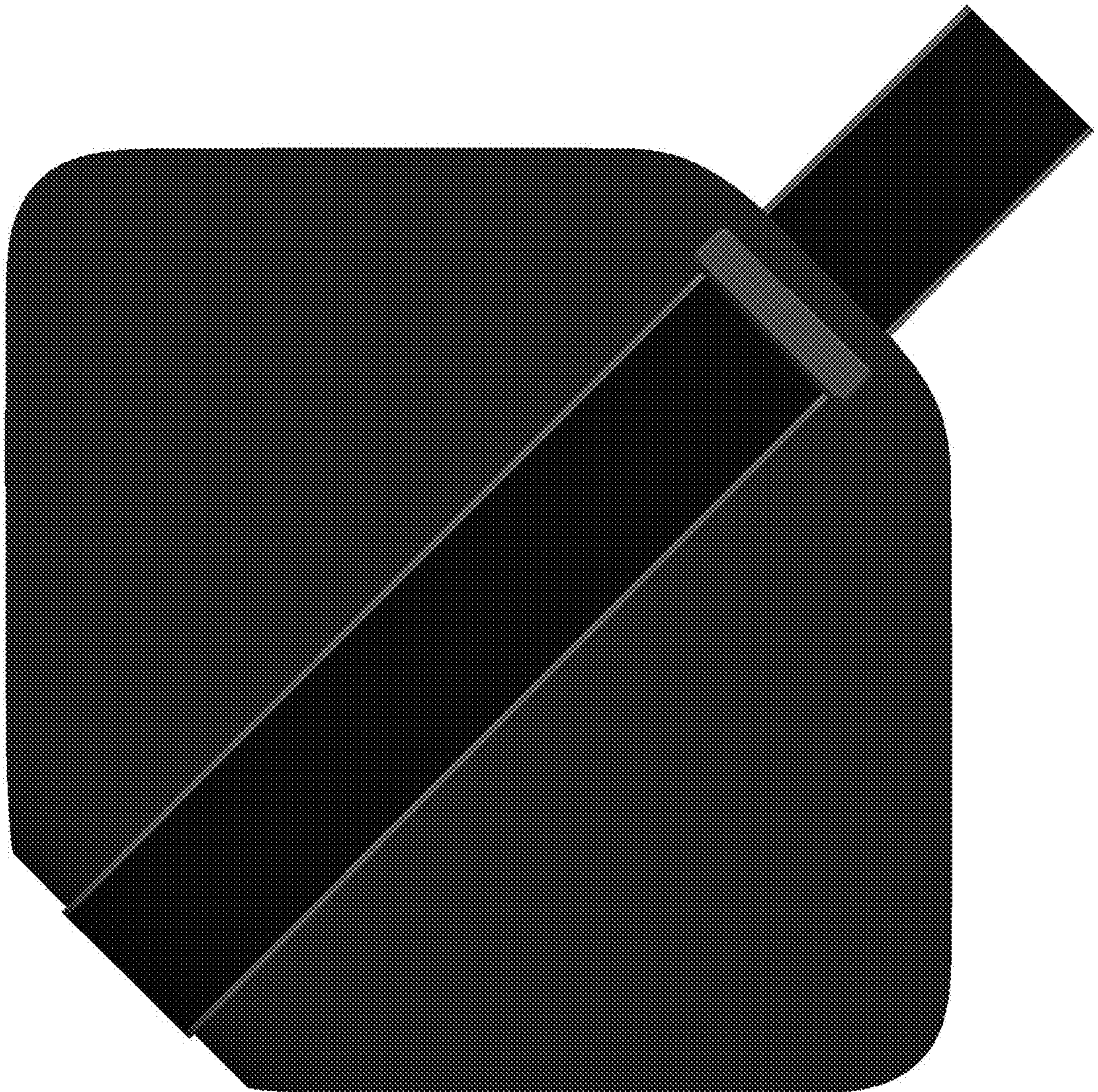

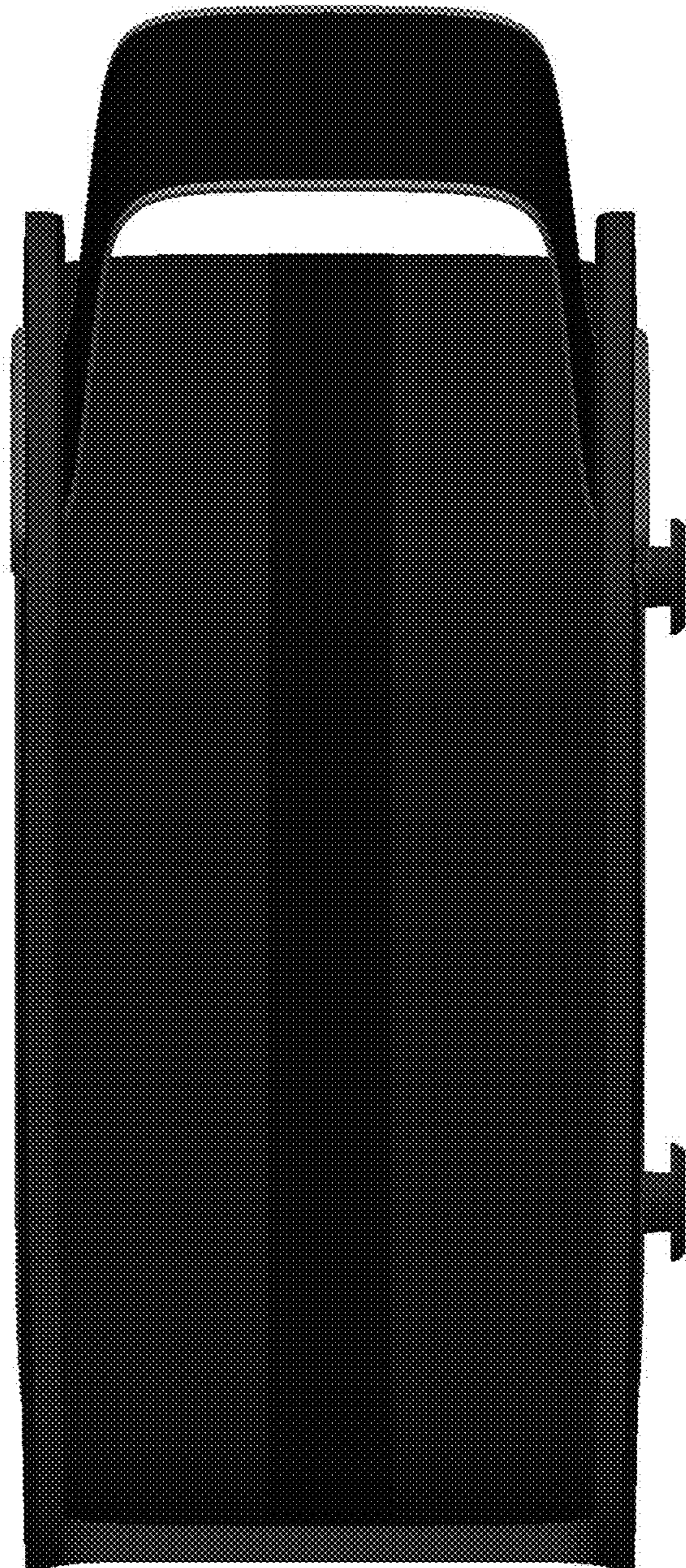

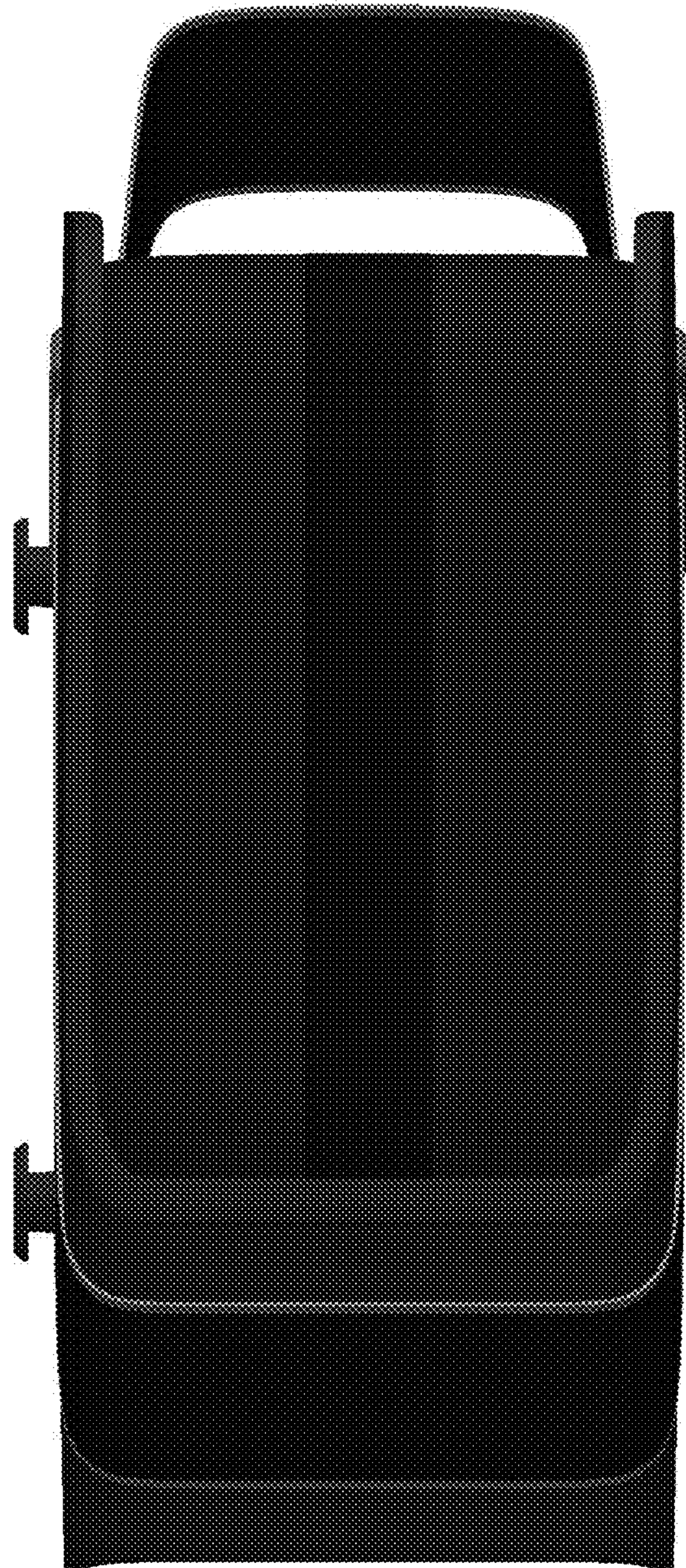
