FIG. 6 is a left side view of the pet backpack of FIG. 1;

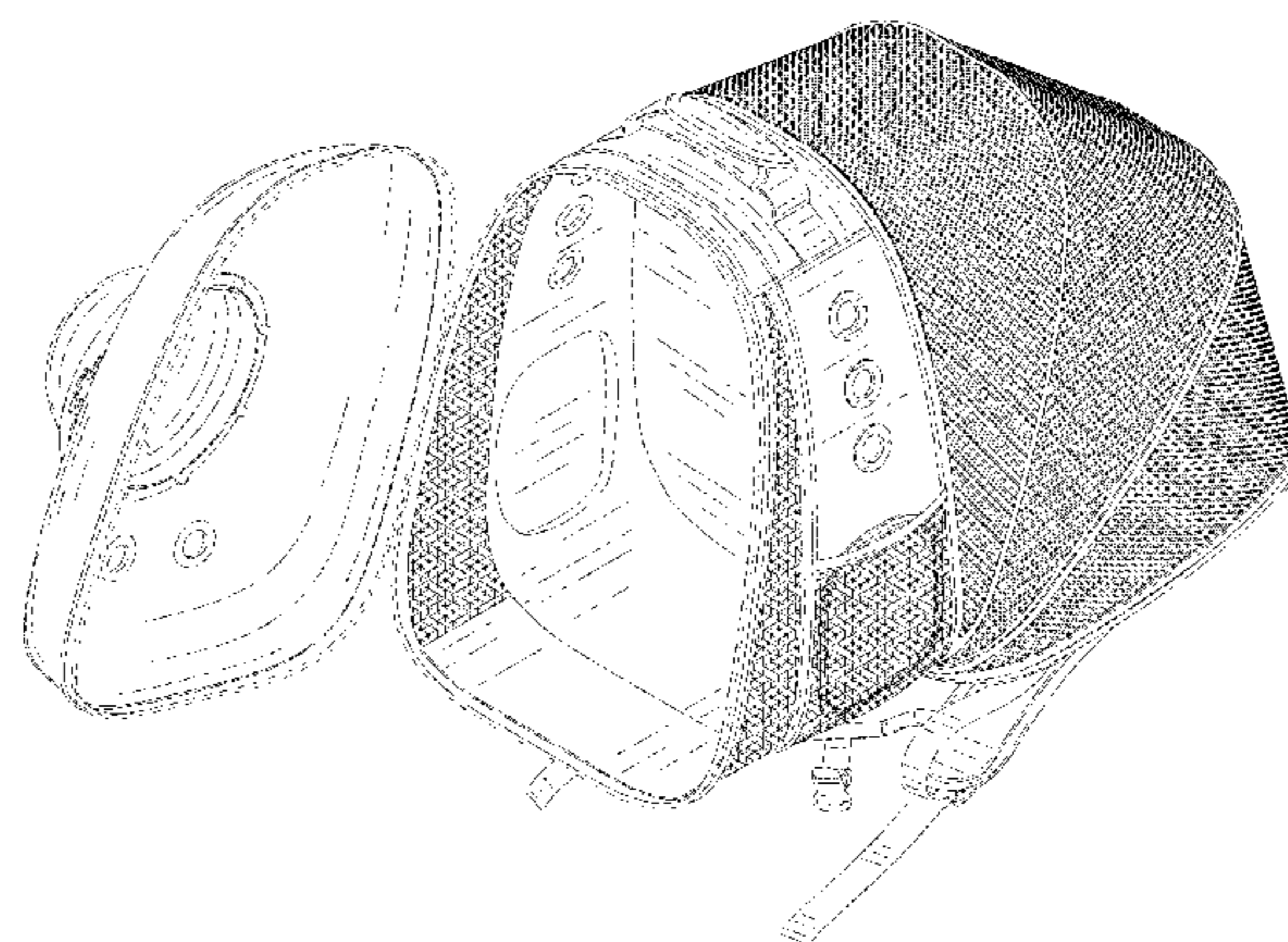
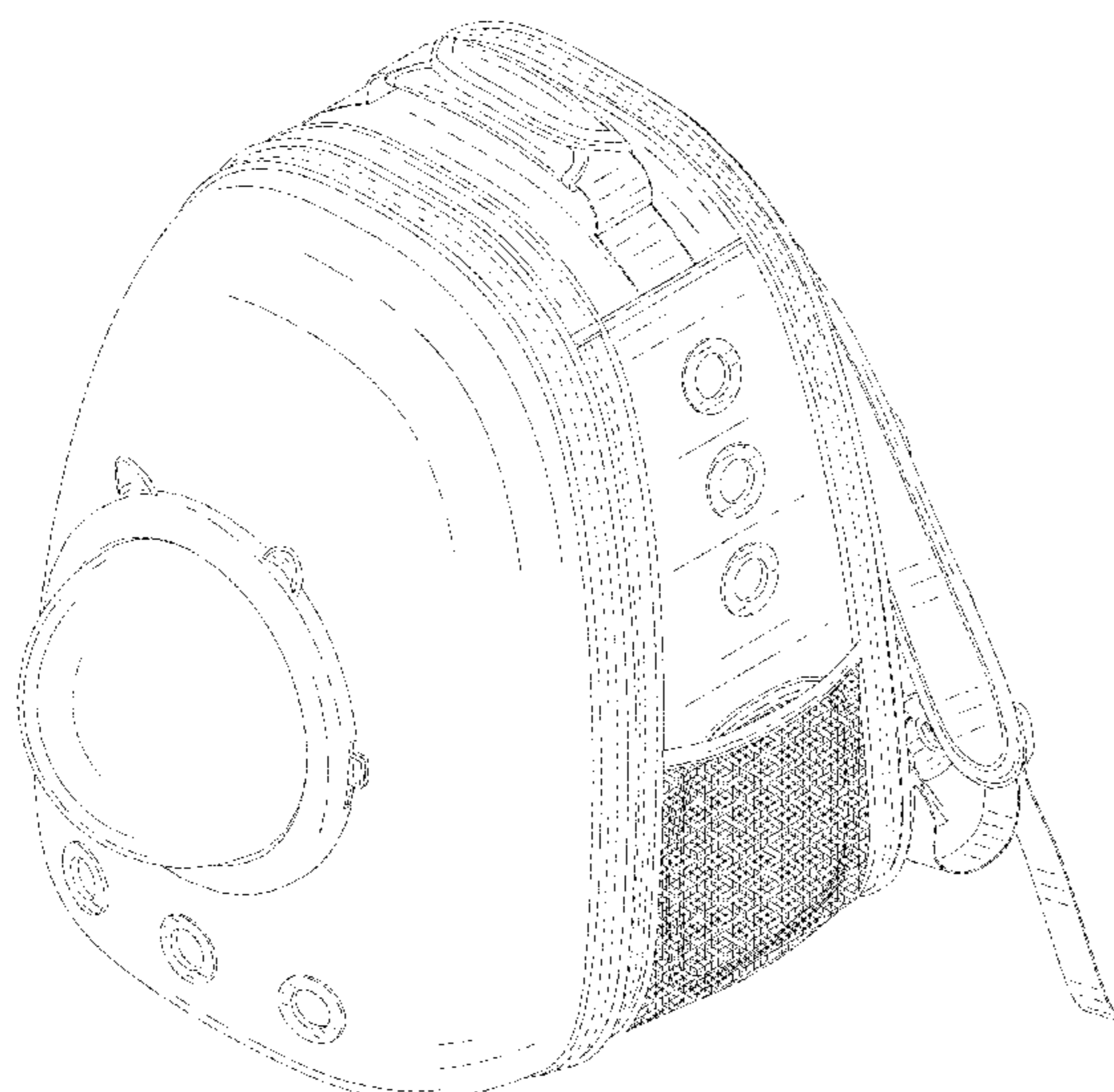
FIG. 7 is a right side view of the pet backpack of FIG. 1;

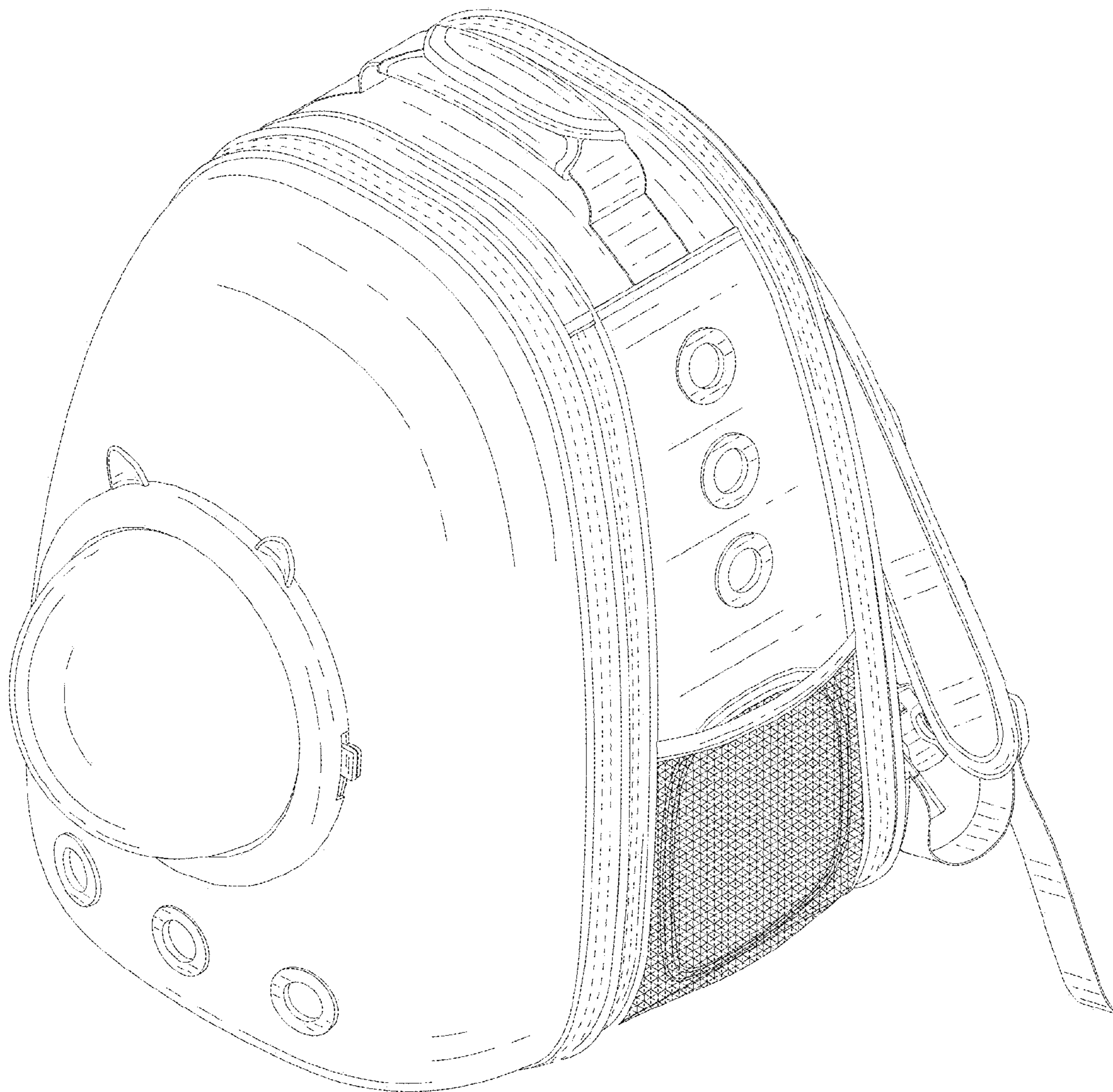

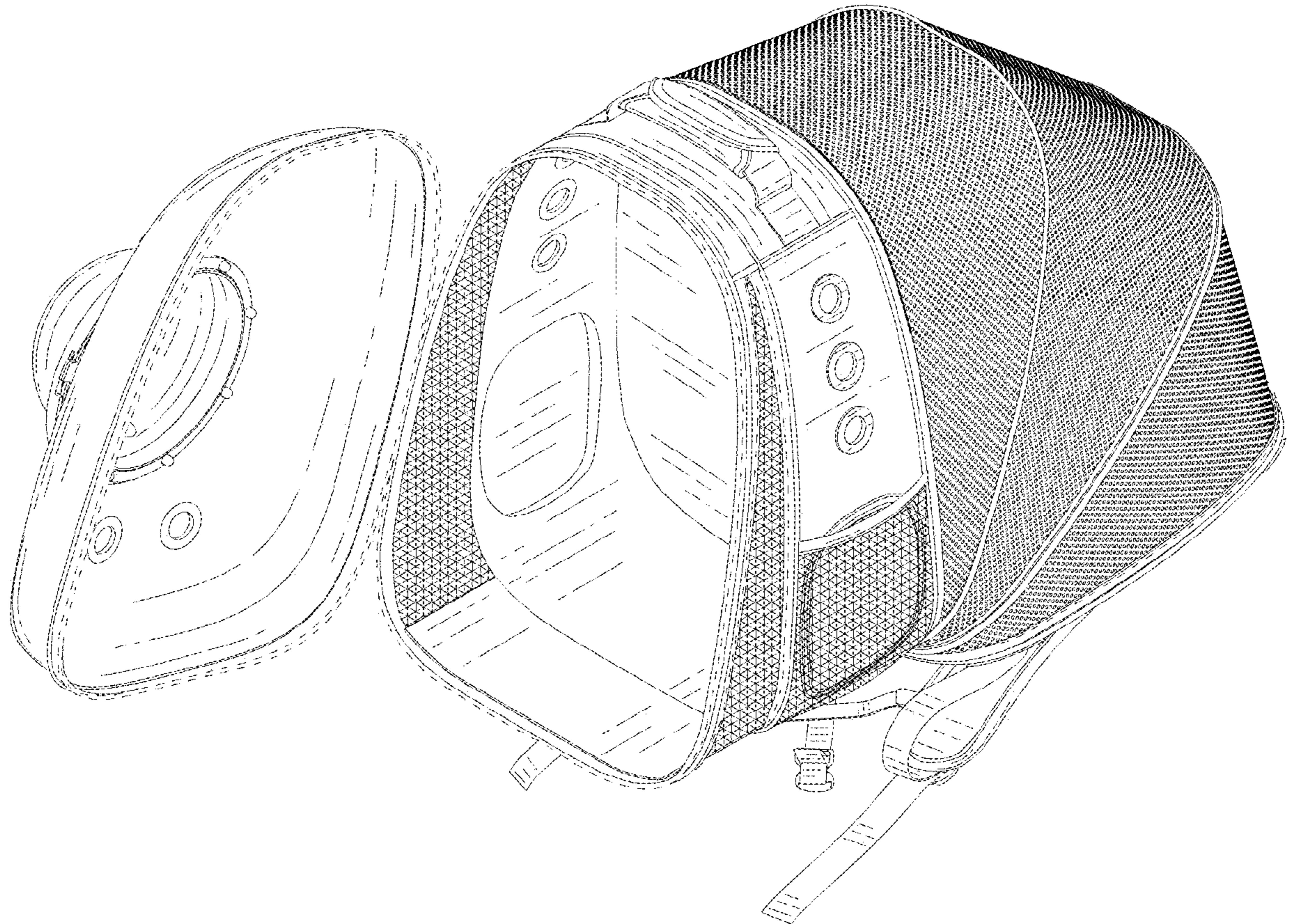

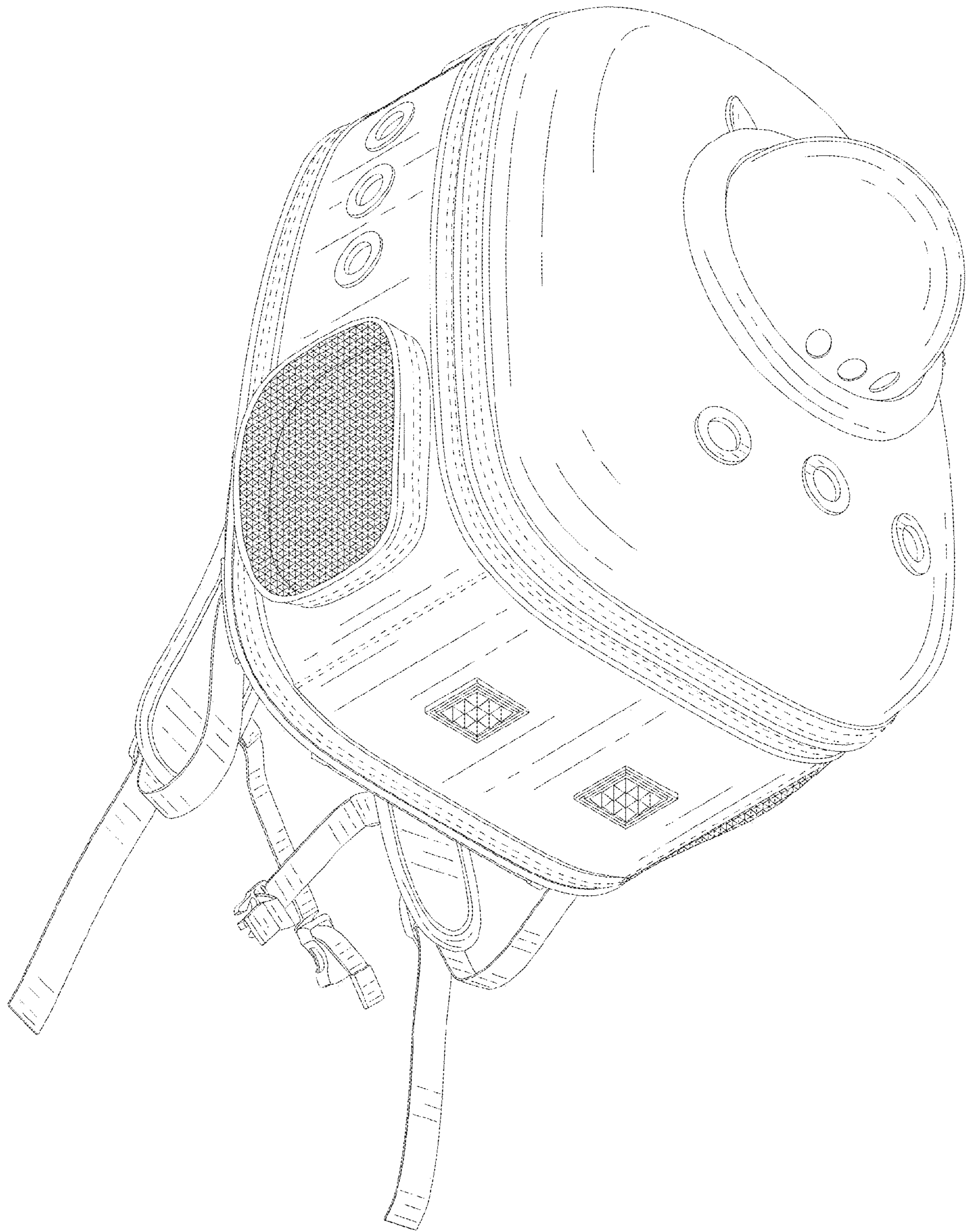

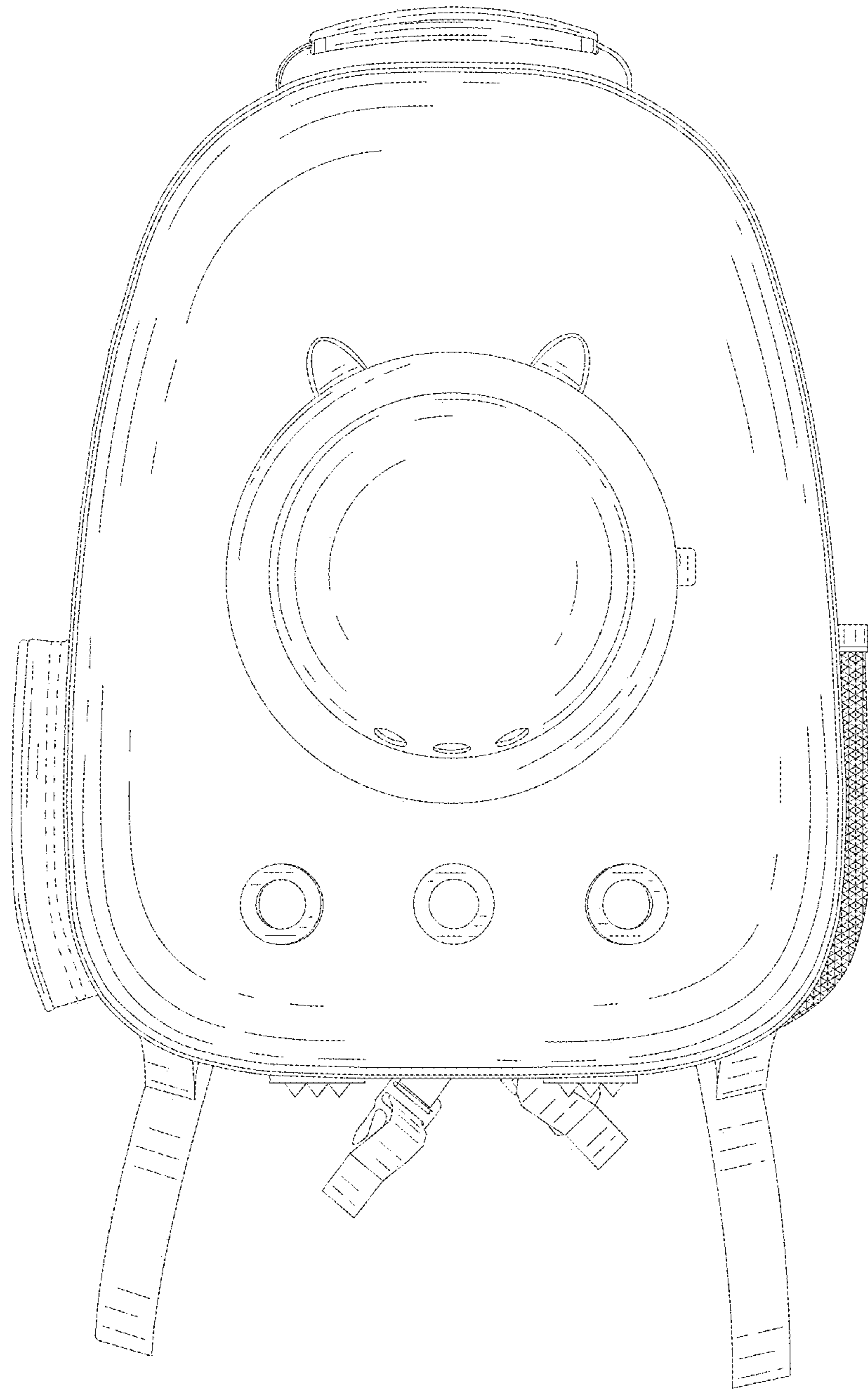

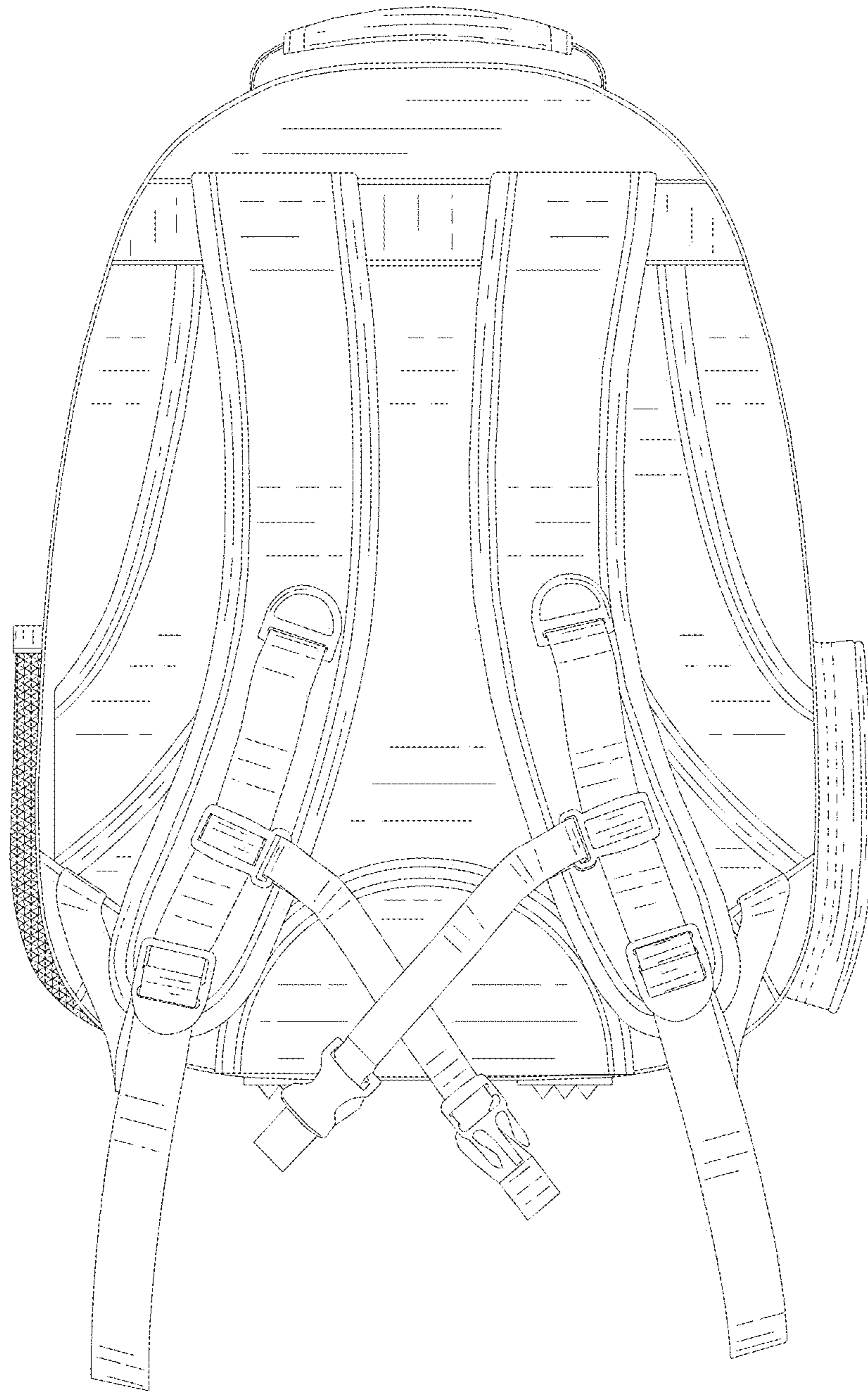

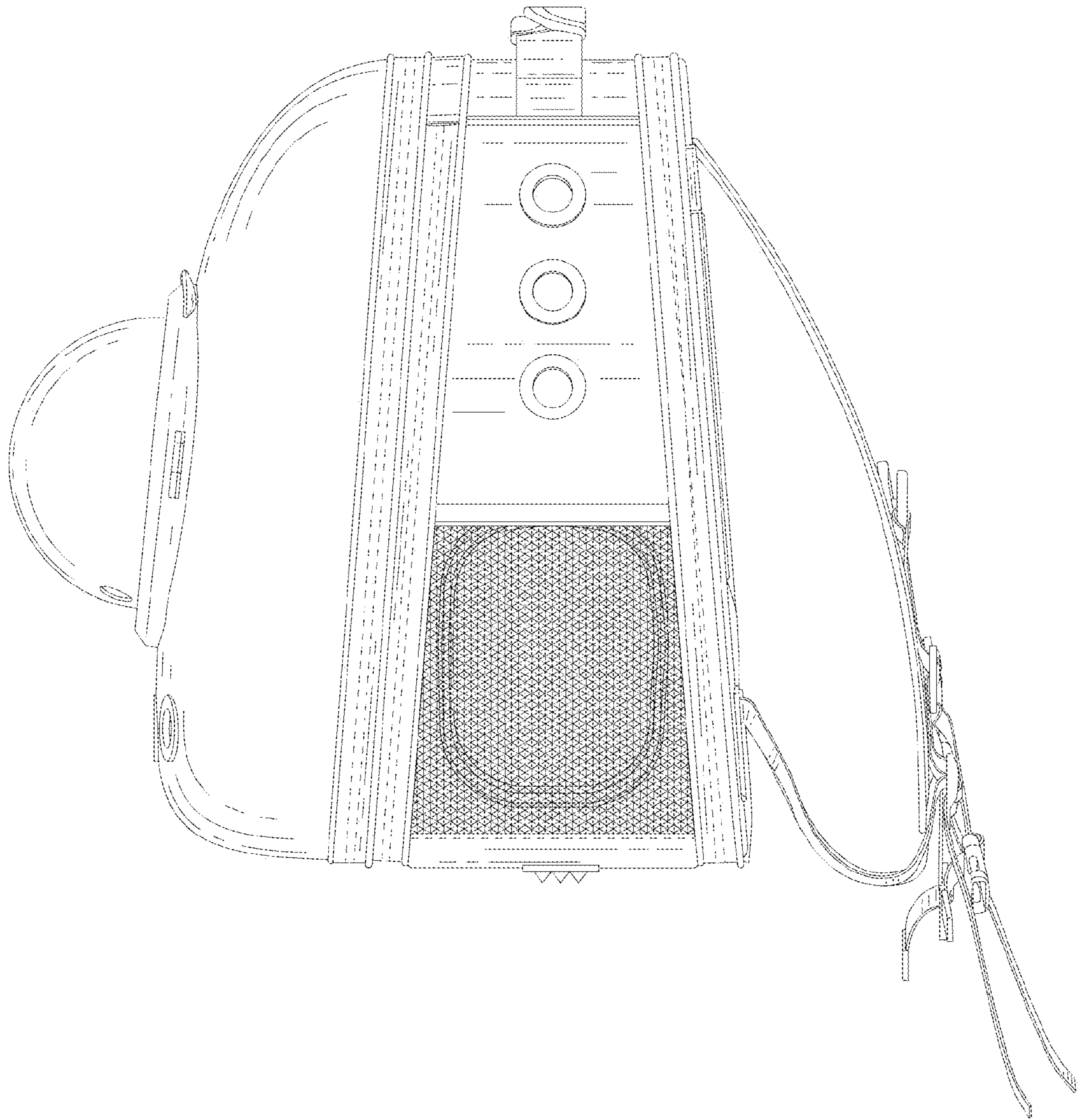

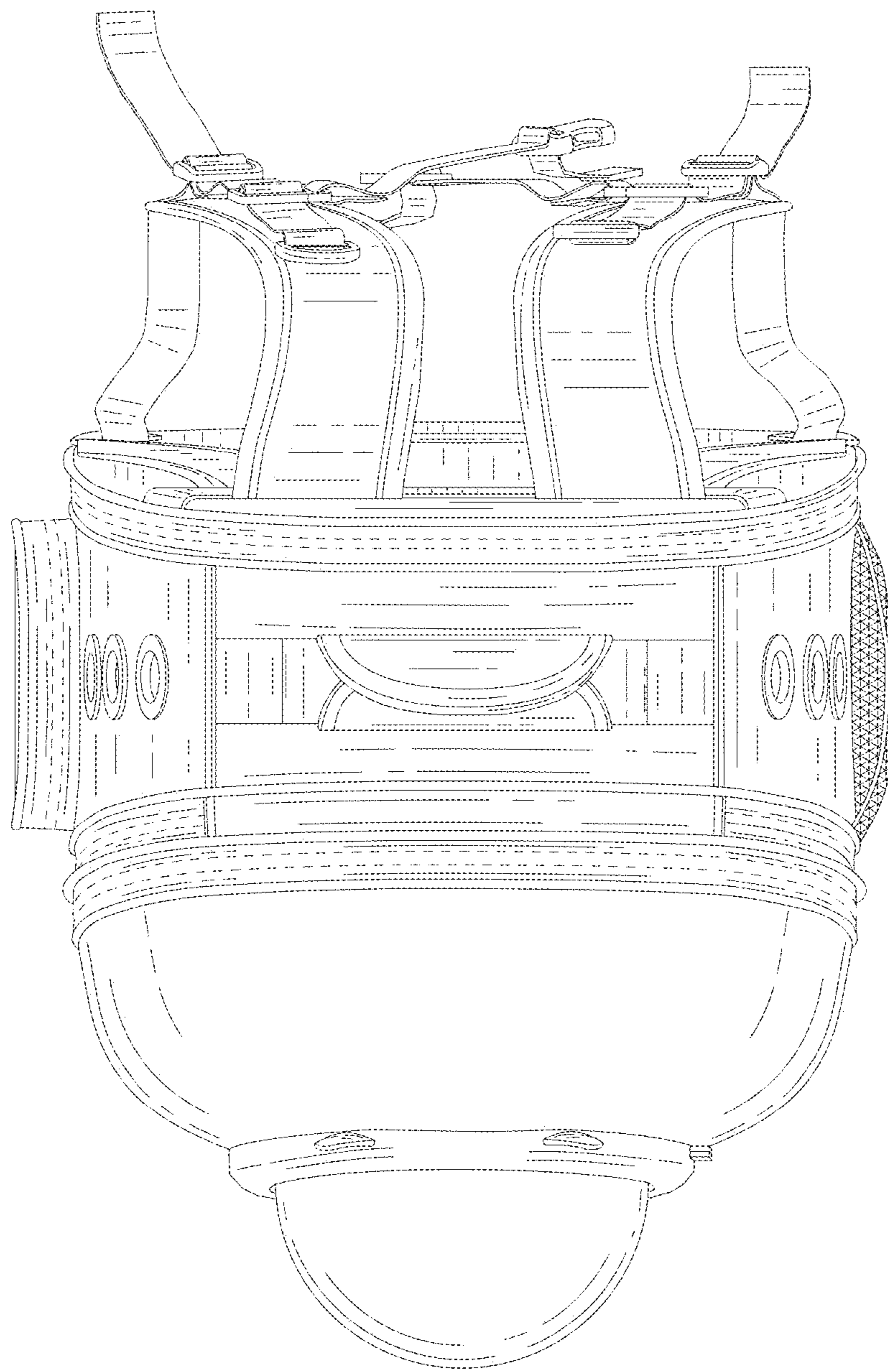

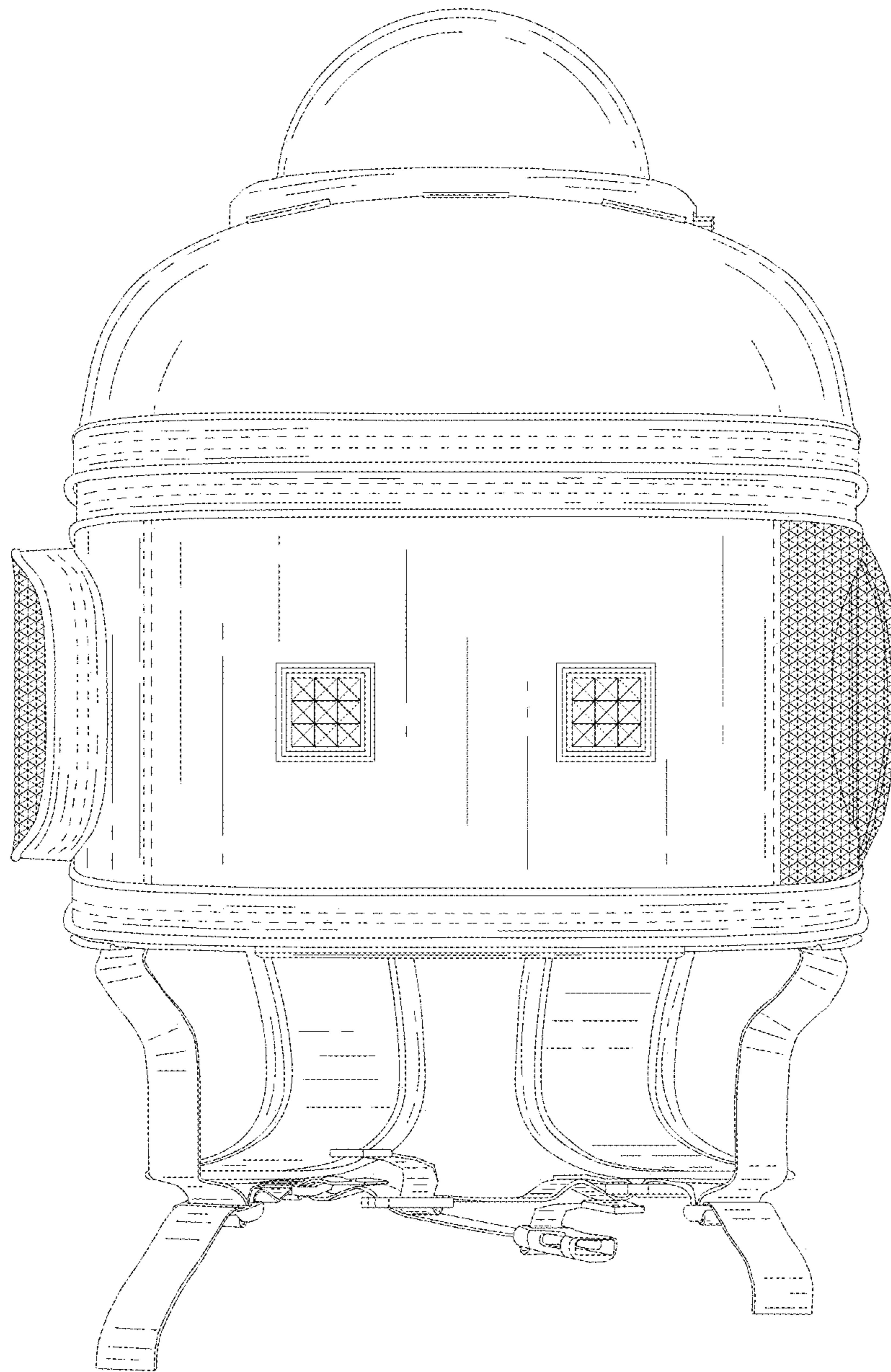
