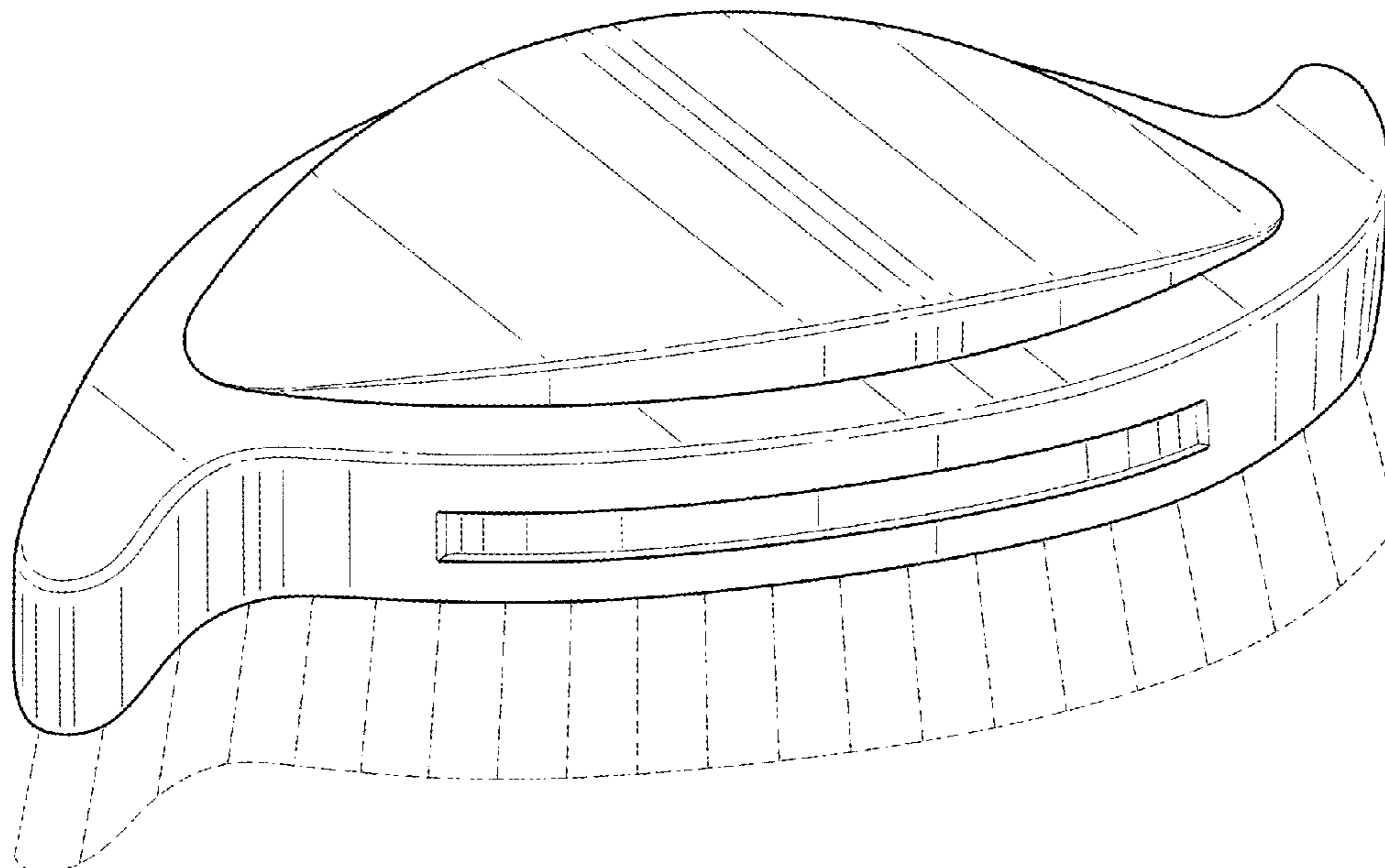
(57) **CLAIM**

I claim the ornamental design for a hair brush, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a hair brush showing my new design;

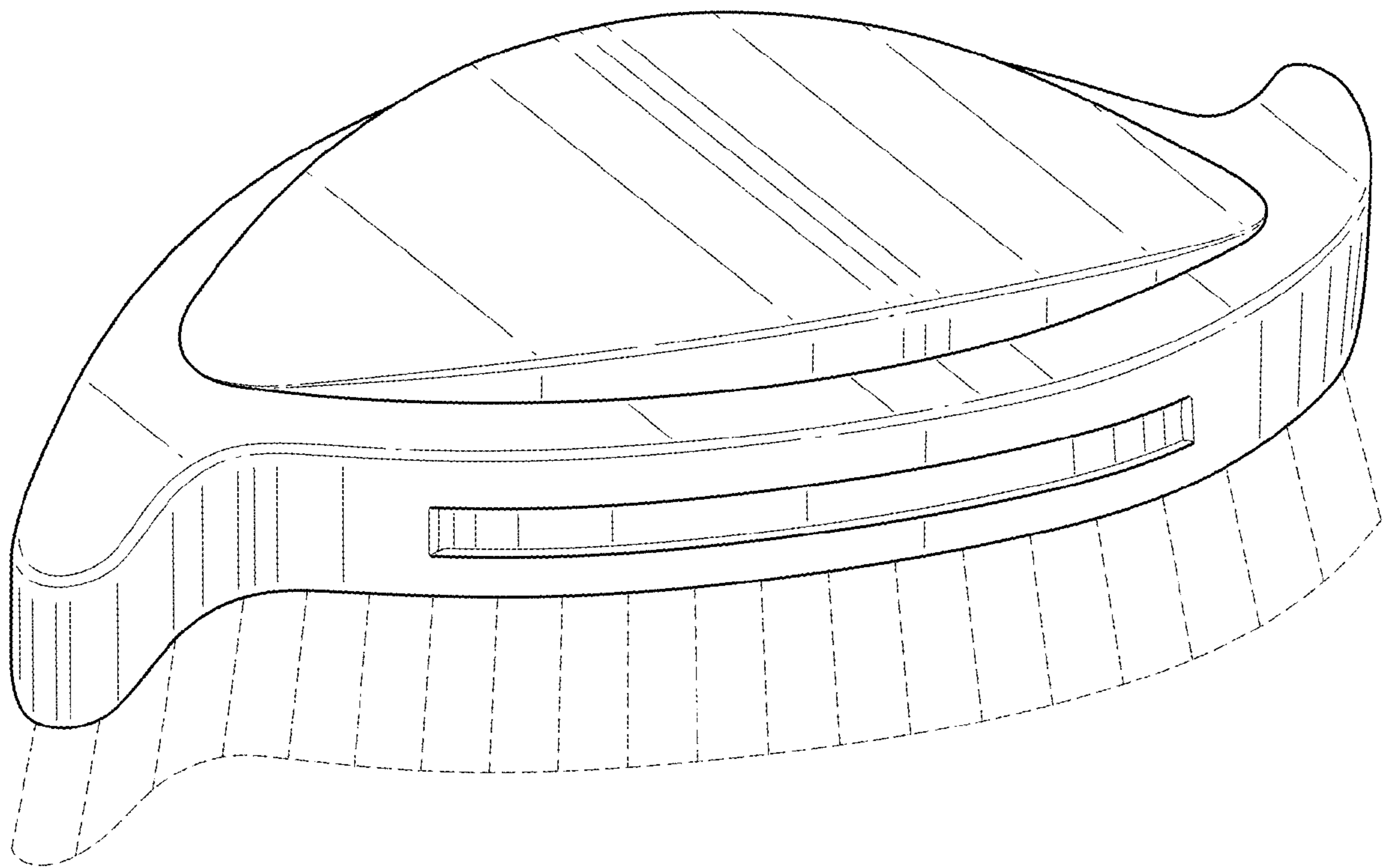

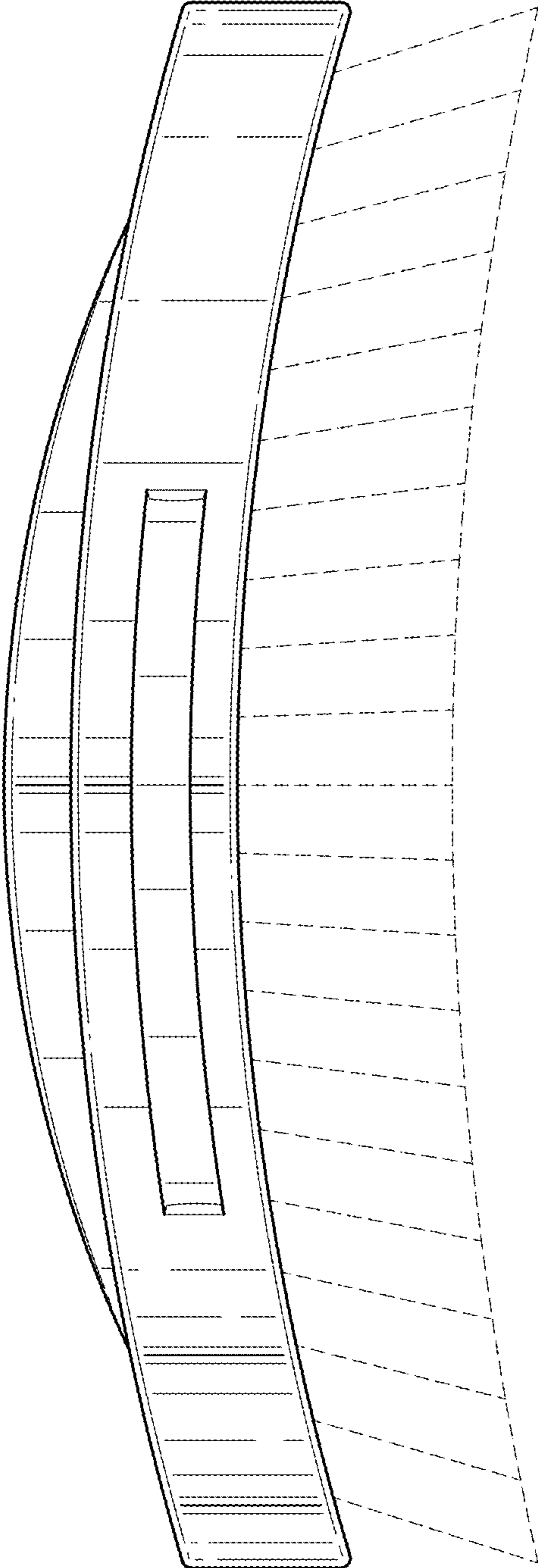

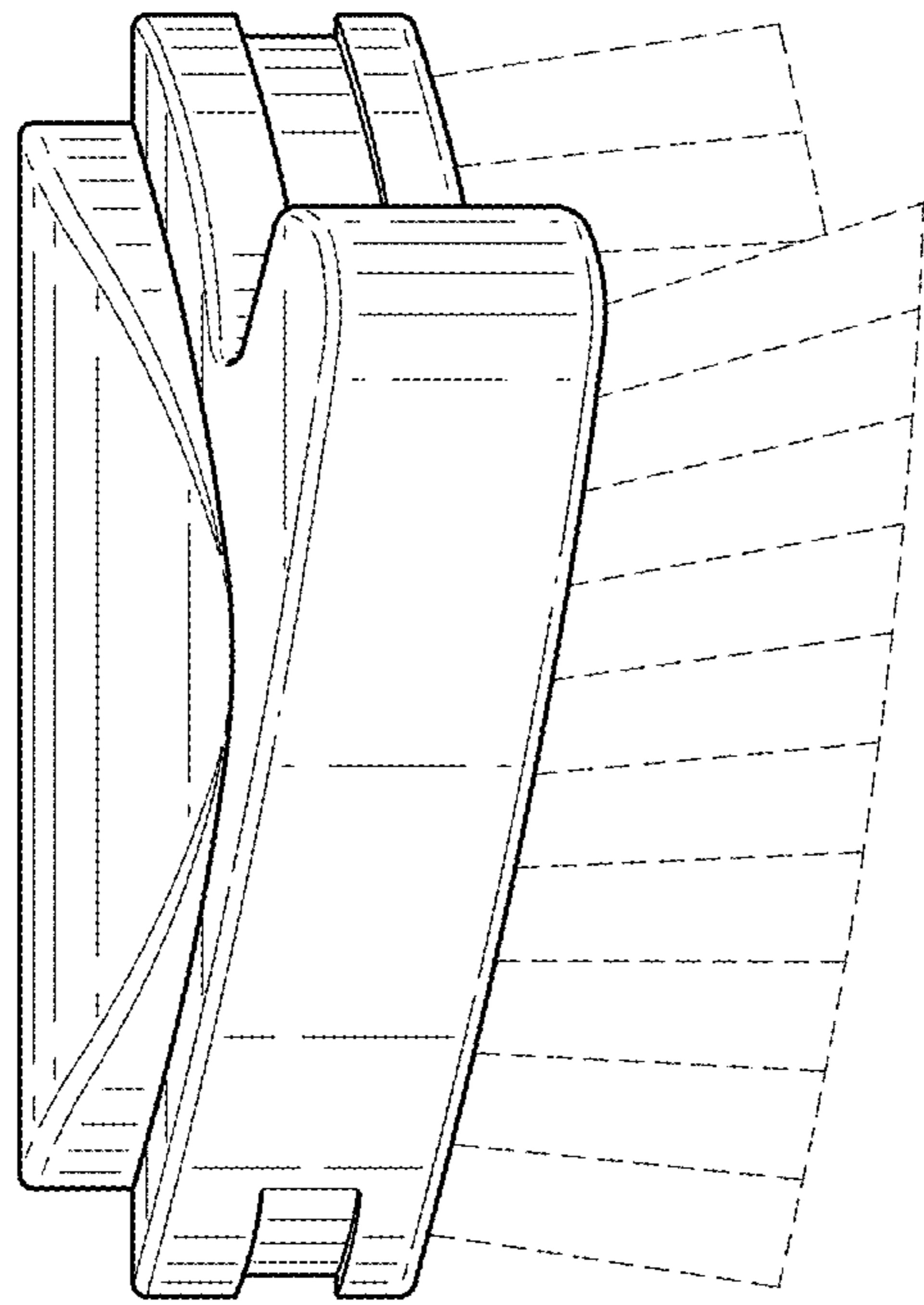

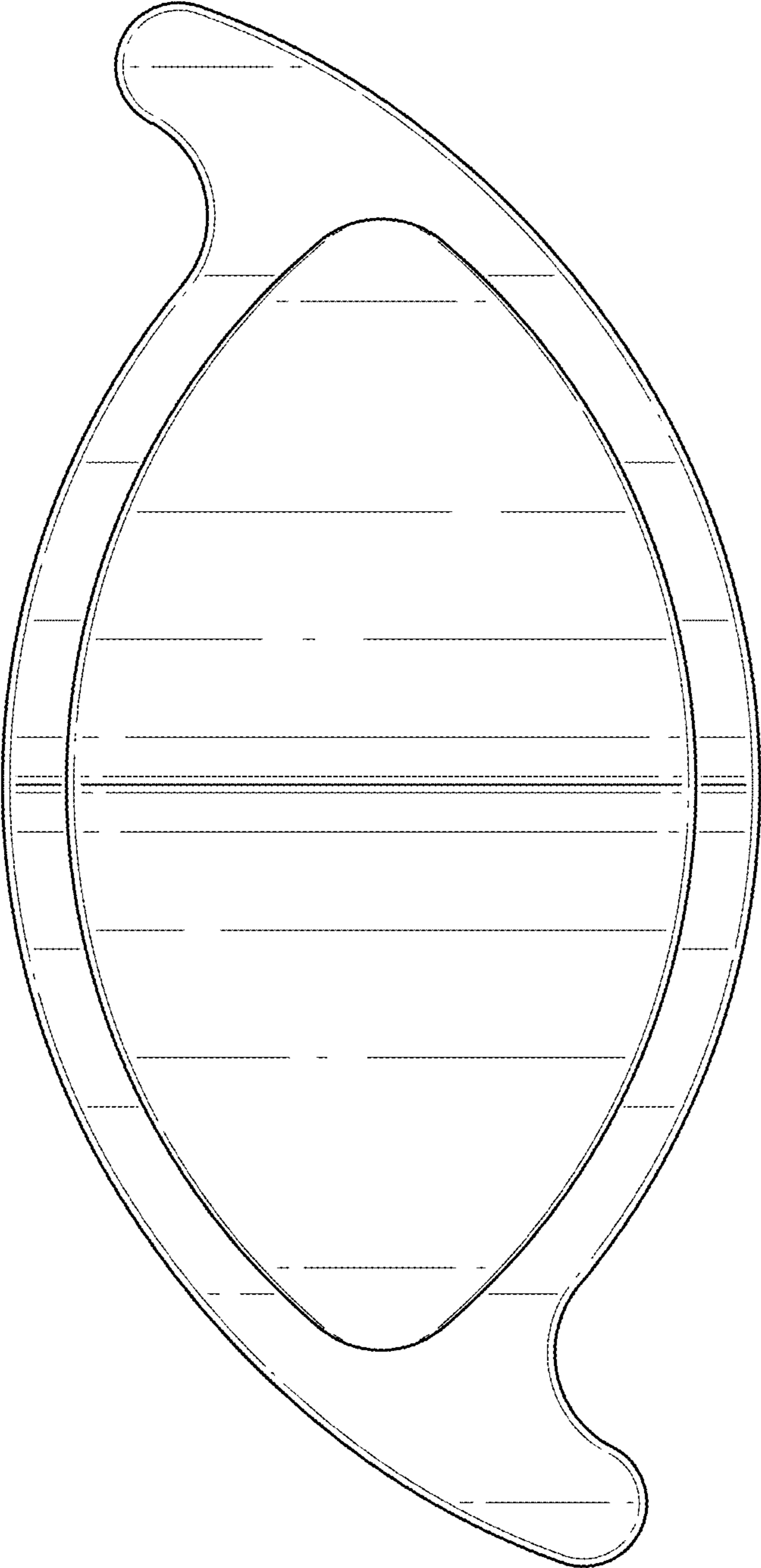

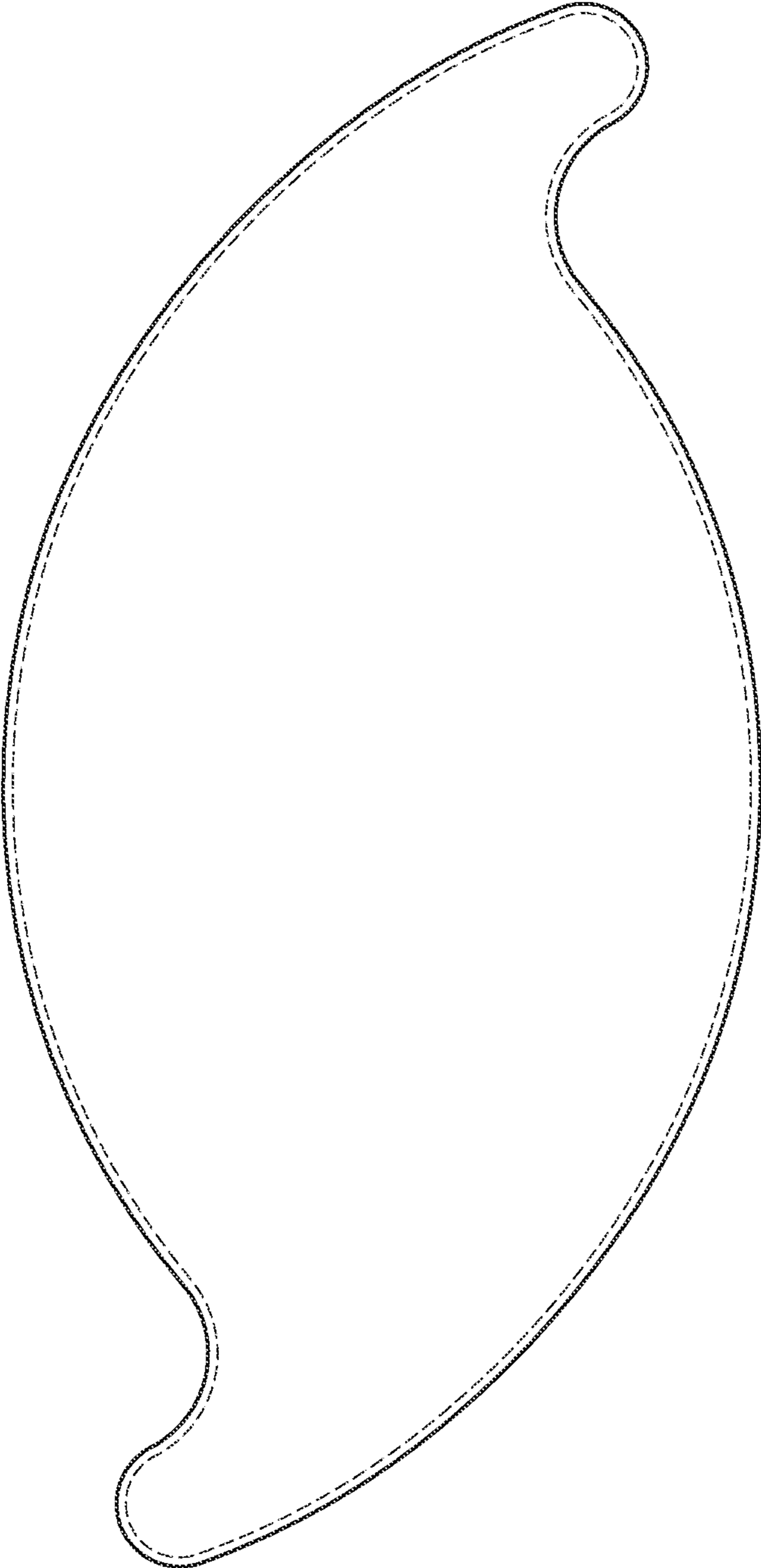
