DESCRIPTION

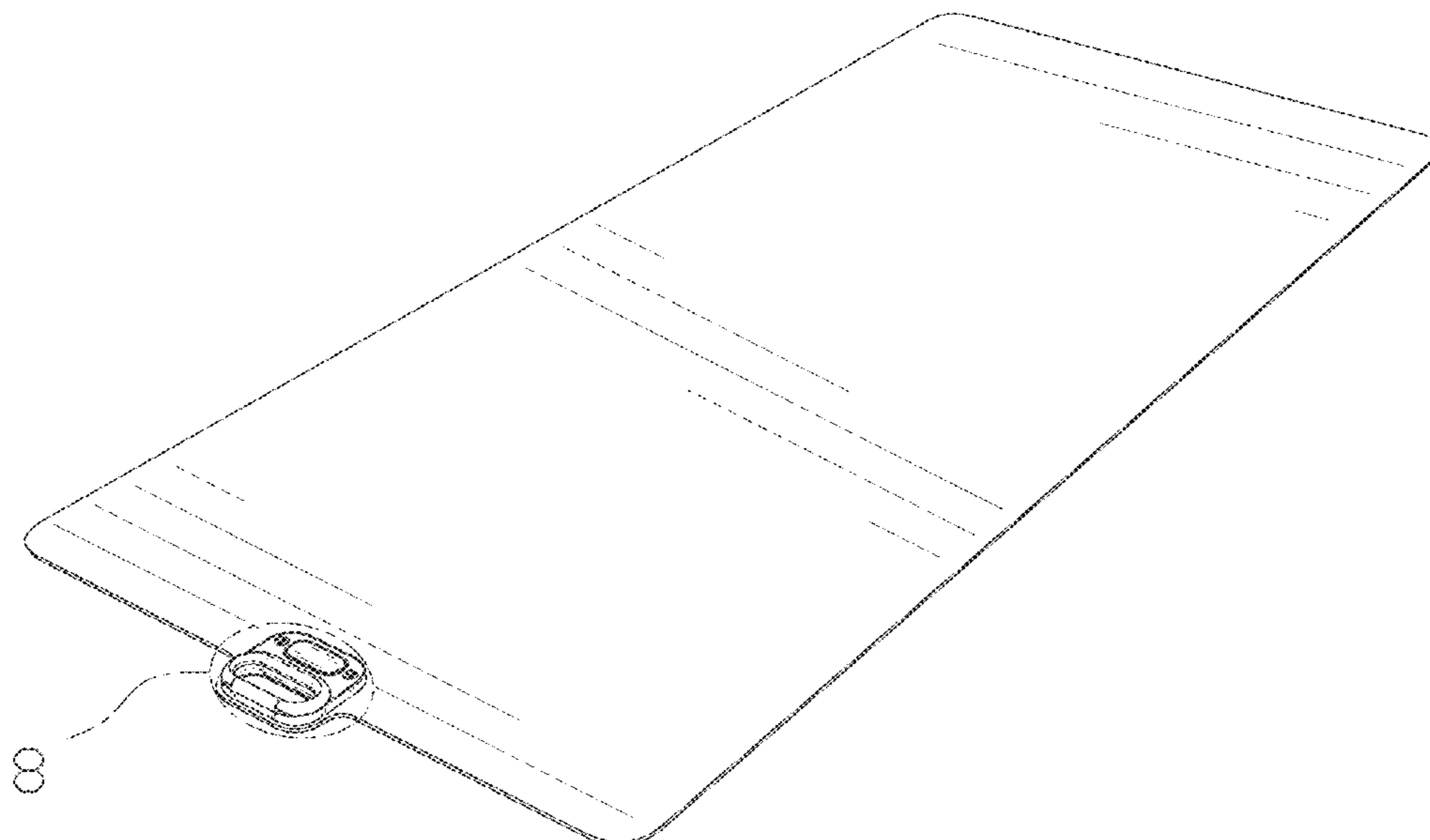
FIG. 1 is a front and top perspective view of a yoga mat, showing our new design;

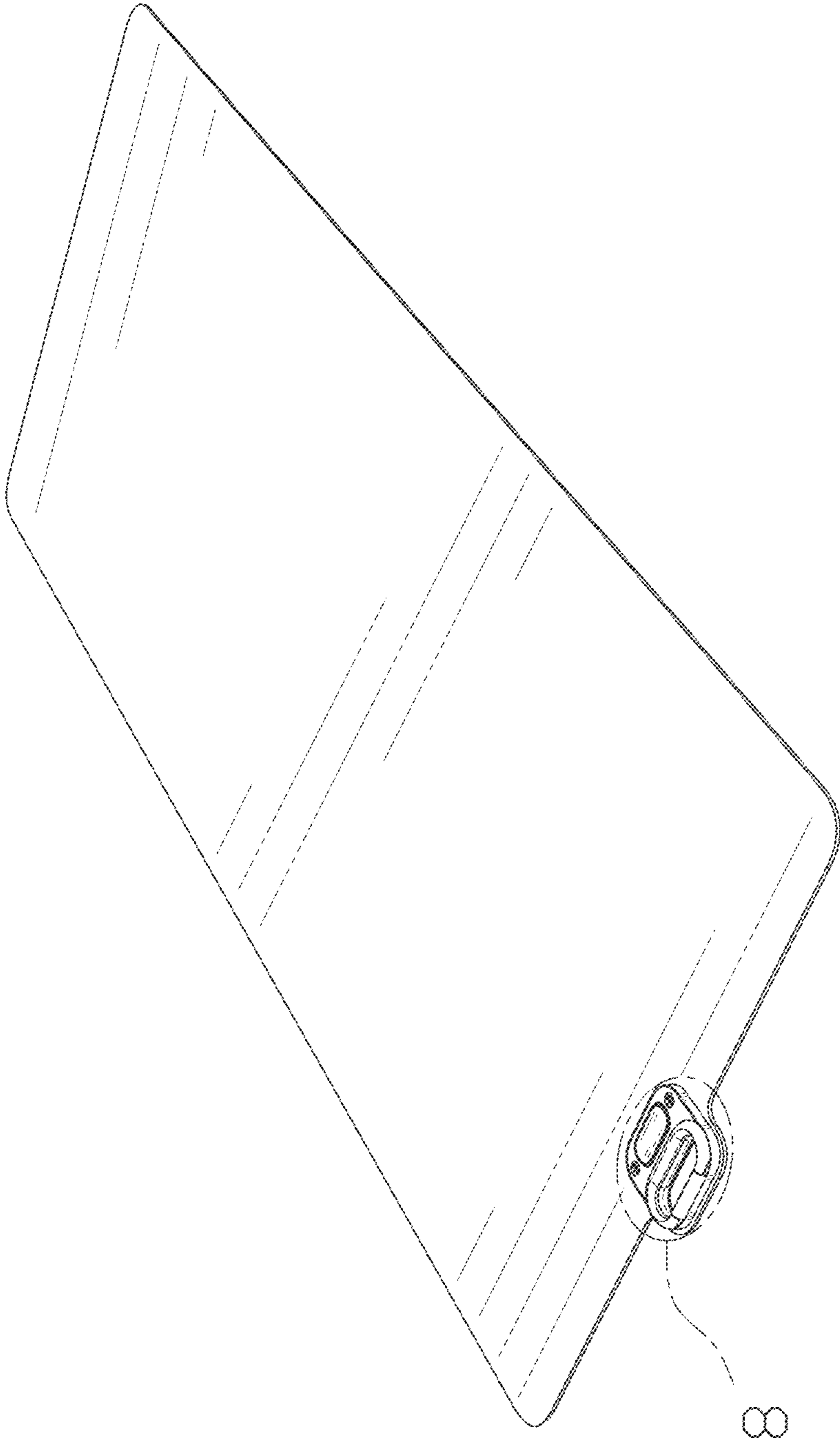

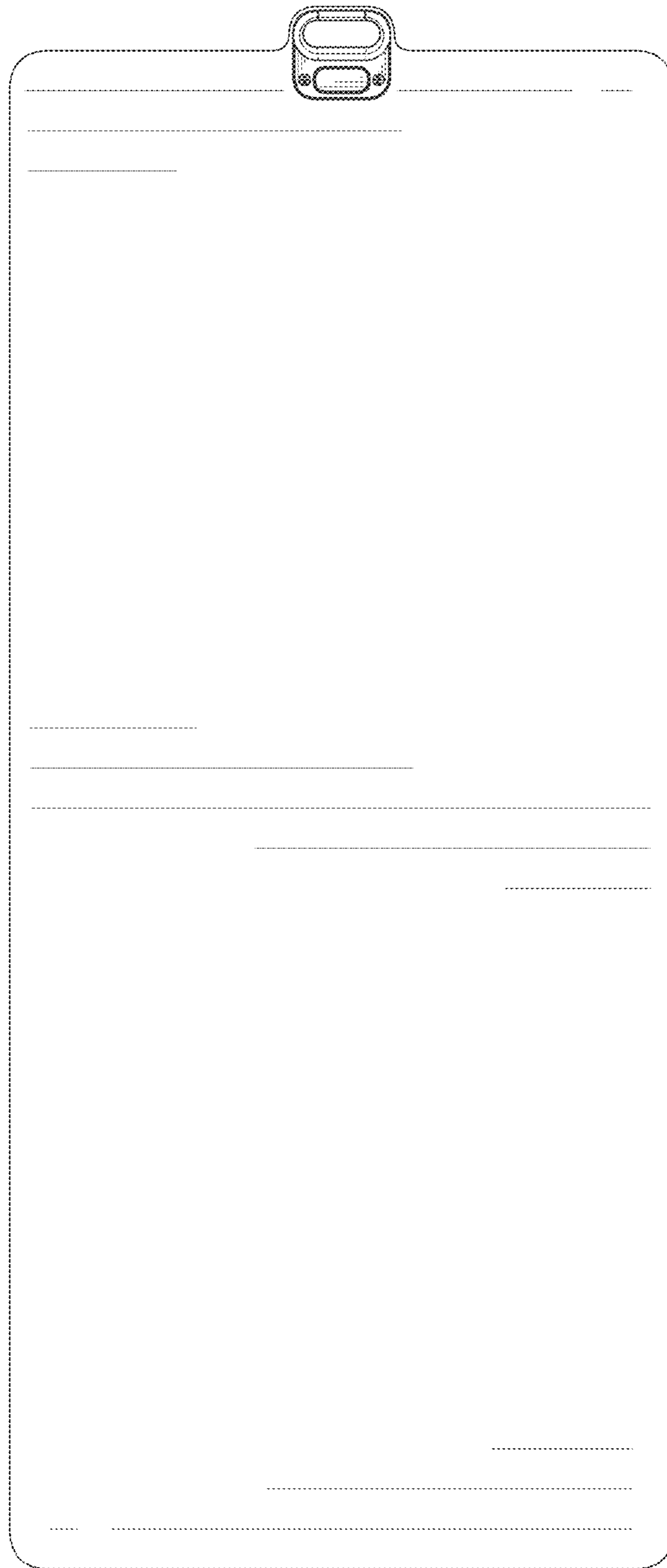

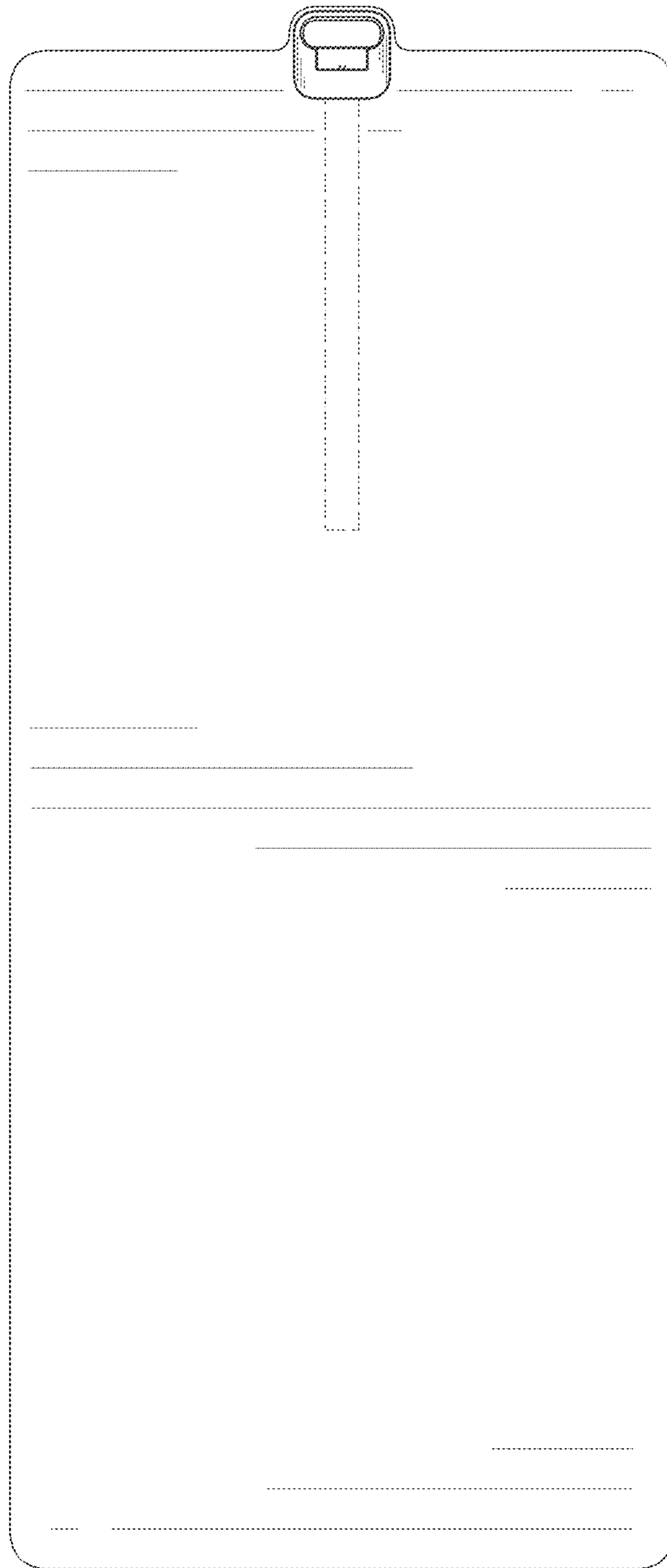

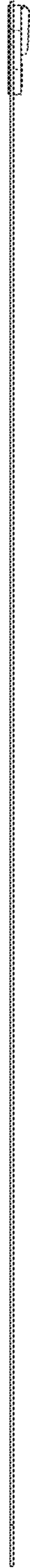

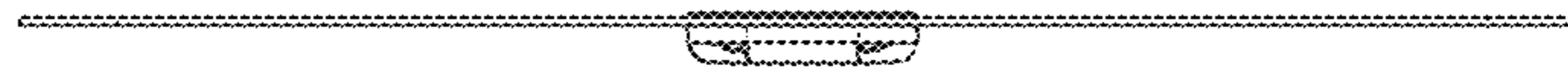

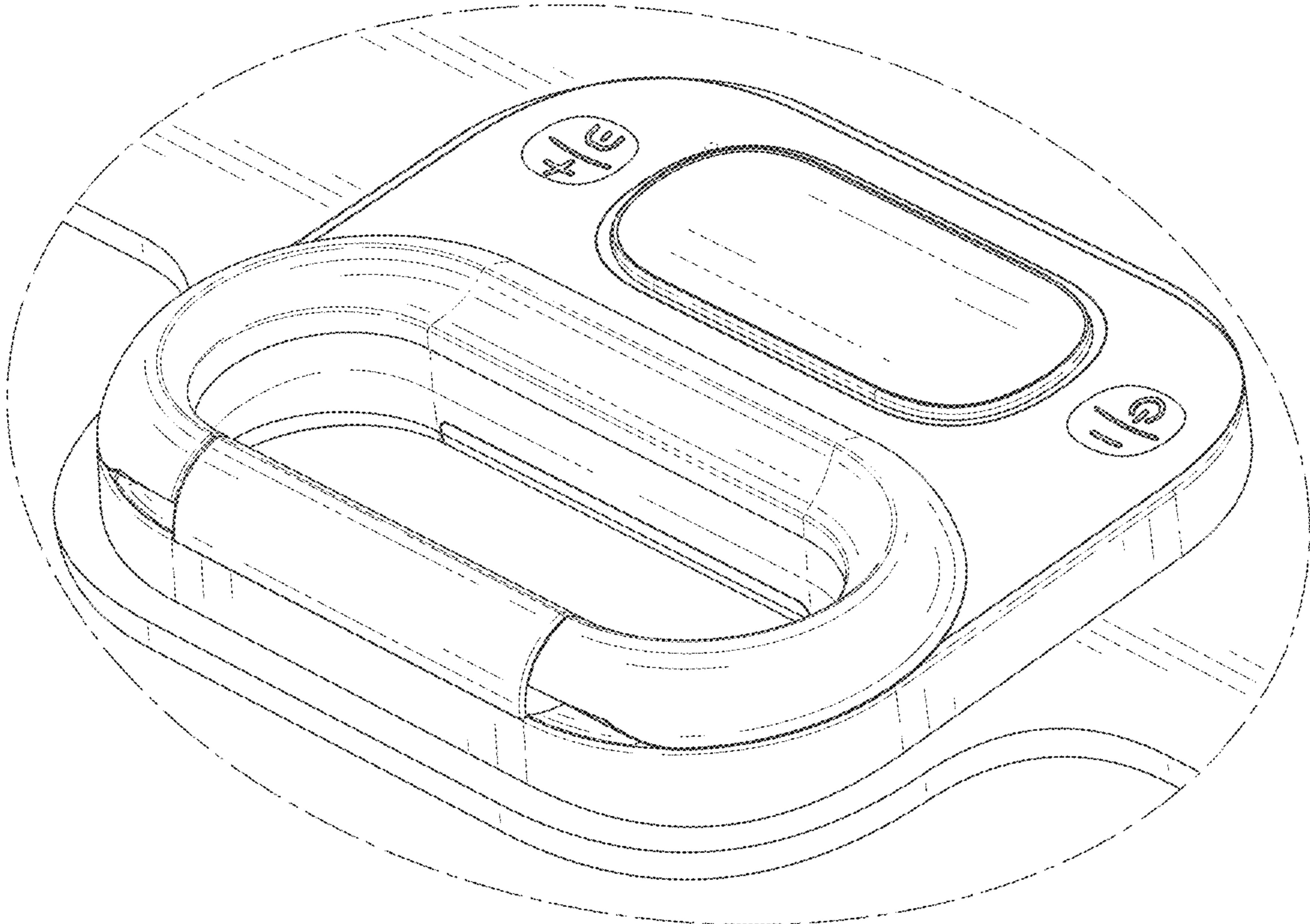

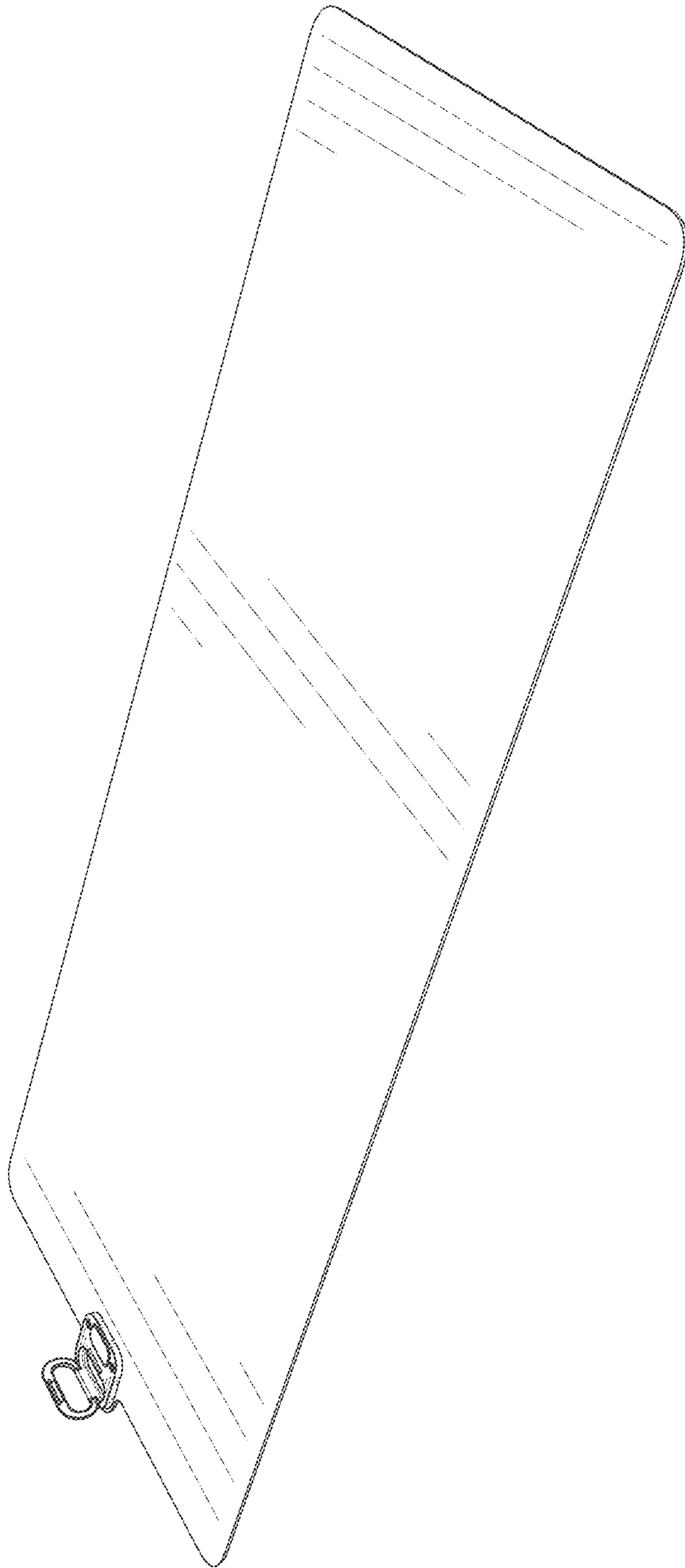
