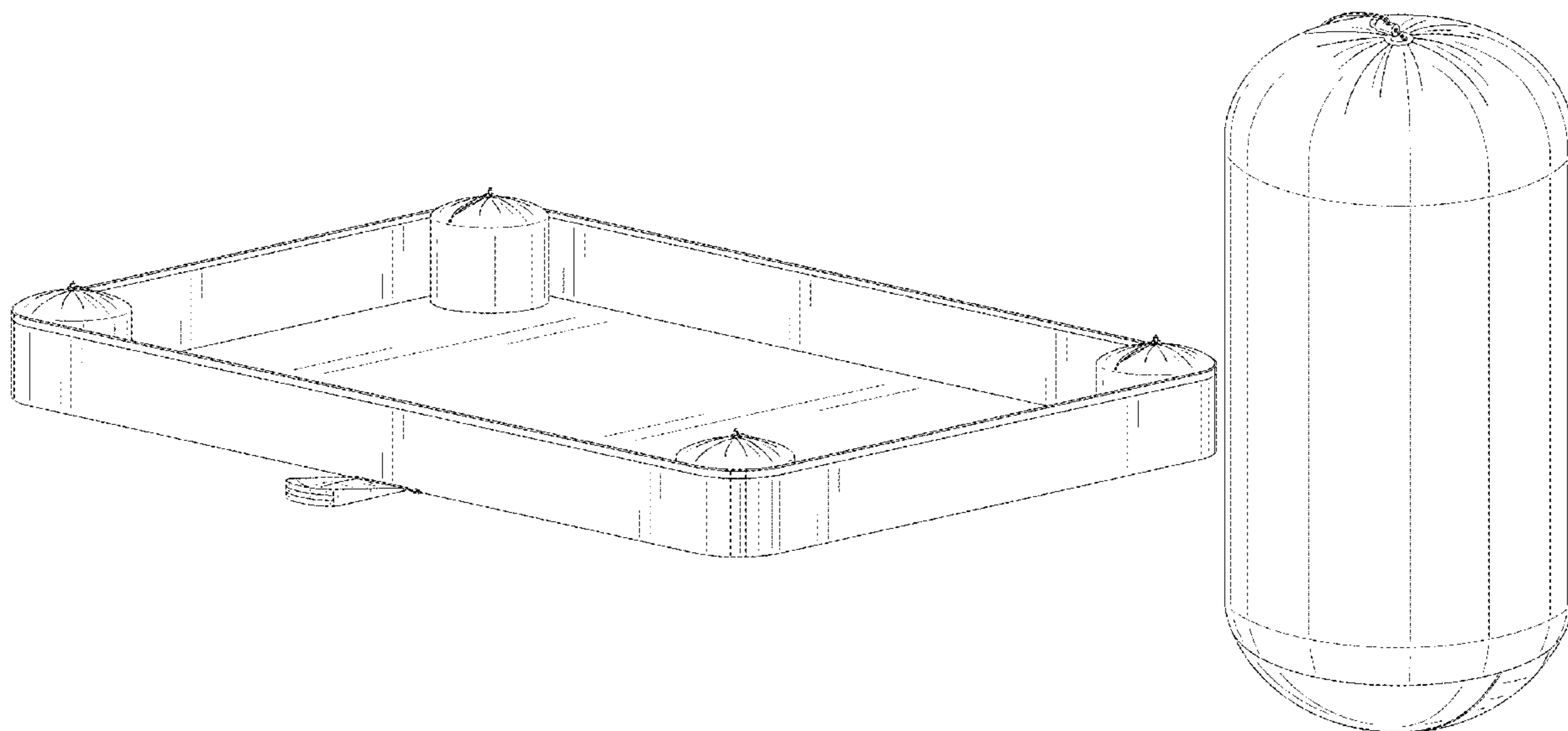
(57) **CLAIM**

I claim the ornamental design for a beach blanket with supported sidewalls and attached carry pouch, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a beach blanket with supported sidewalls and attached carry pouch showing my new design;

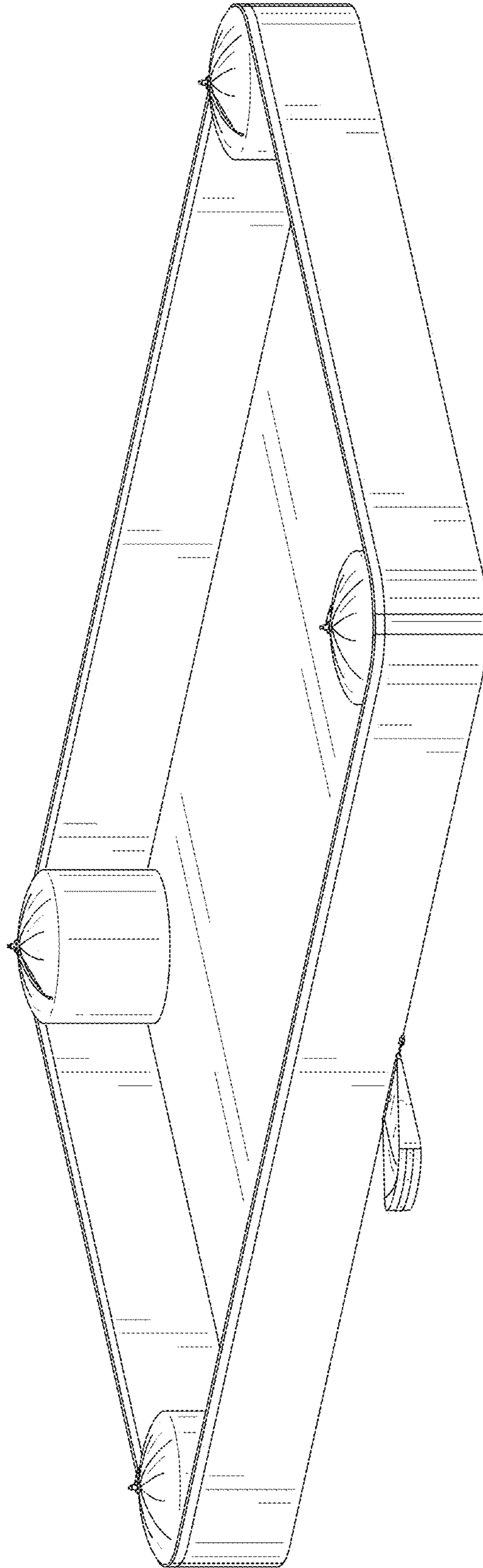

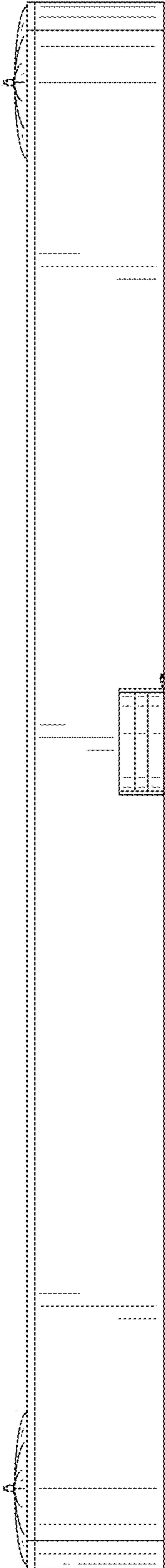

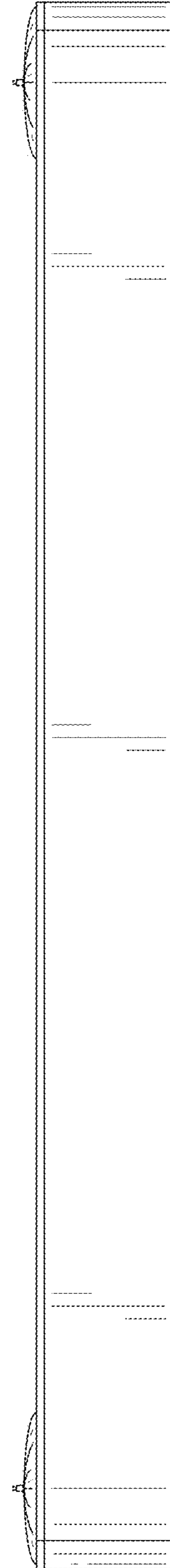

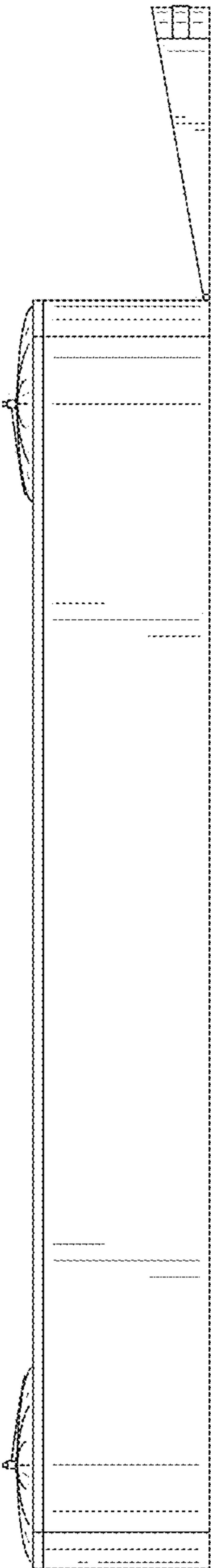

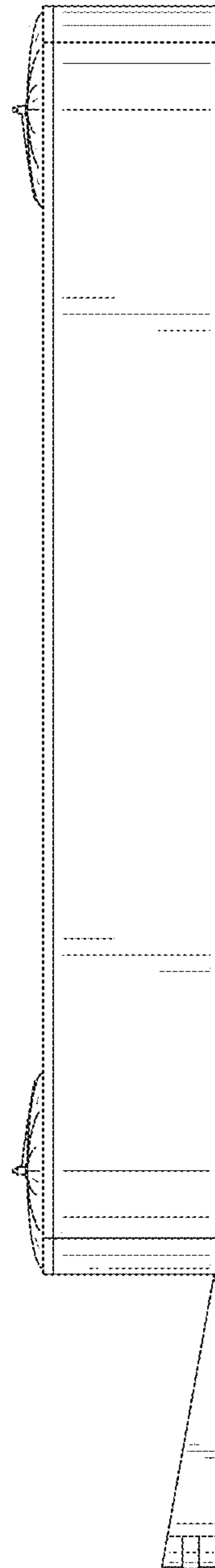

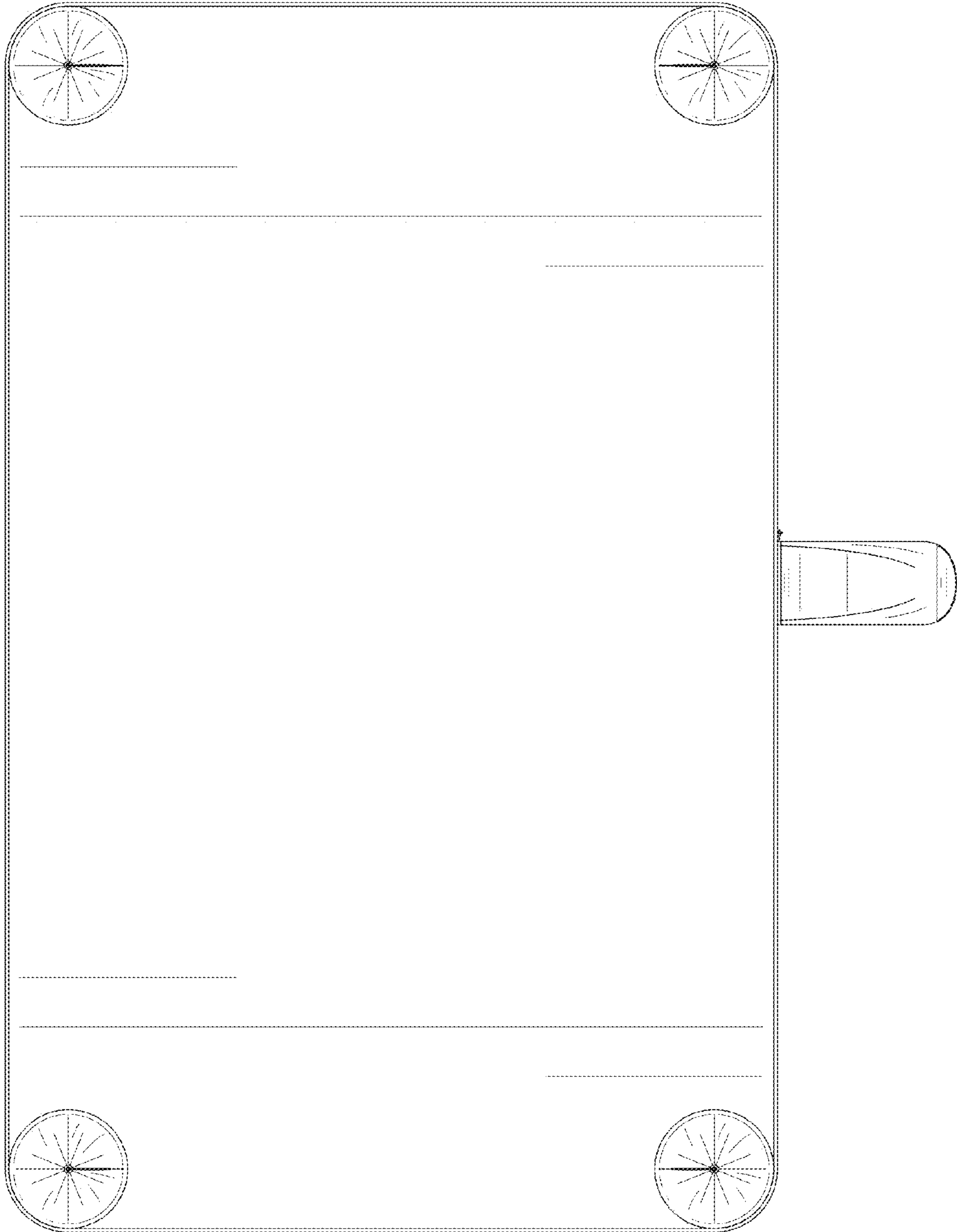

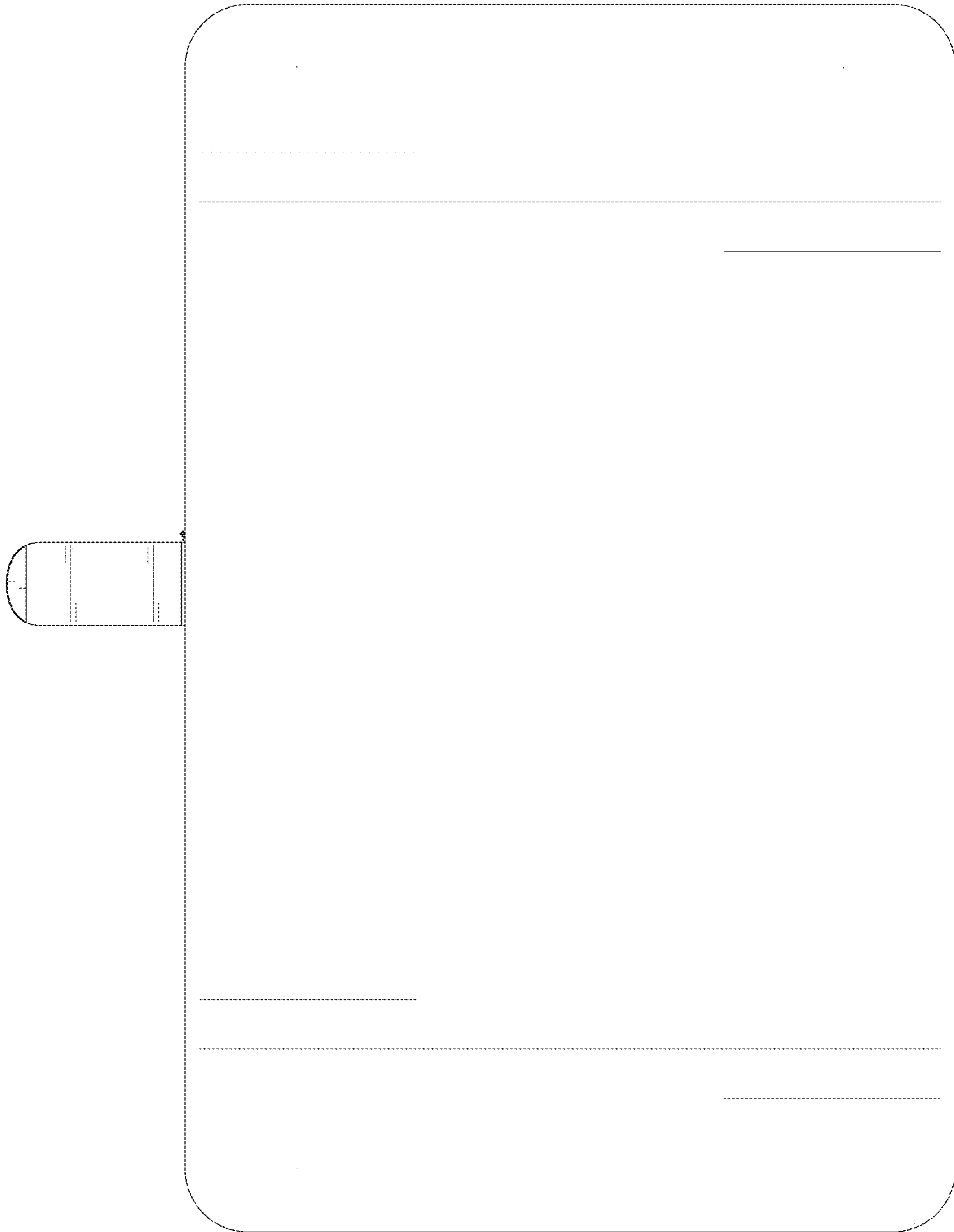

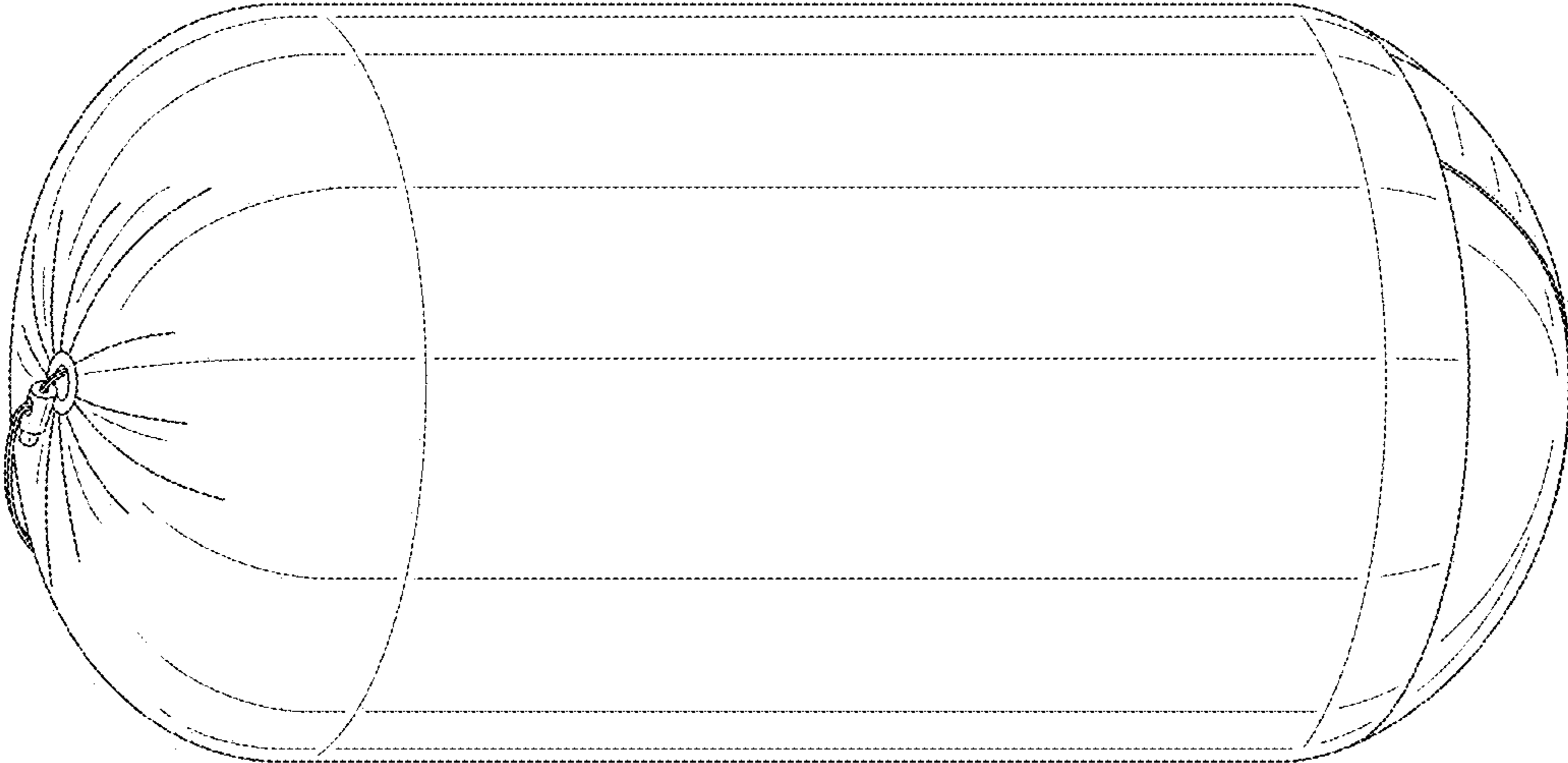

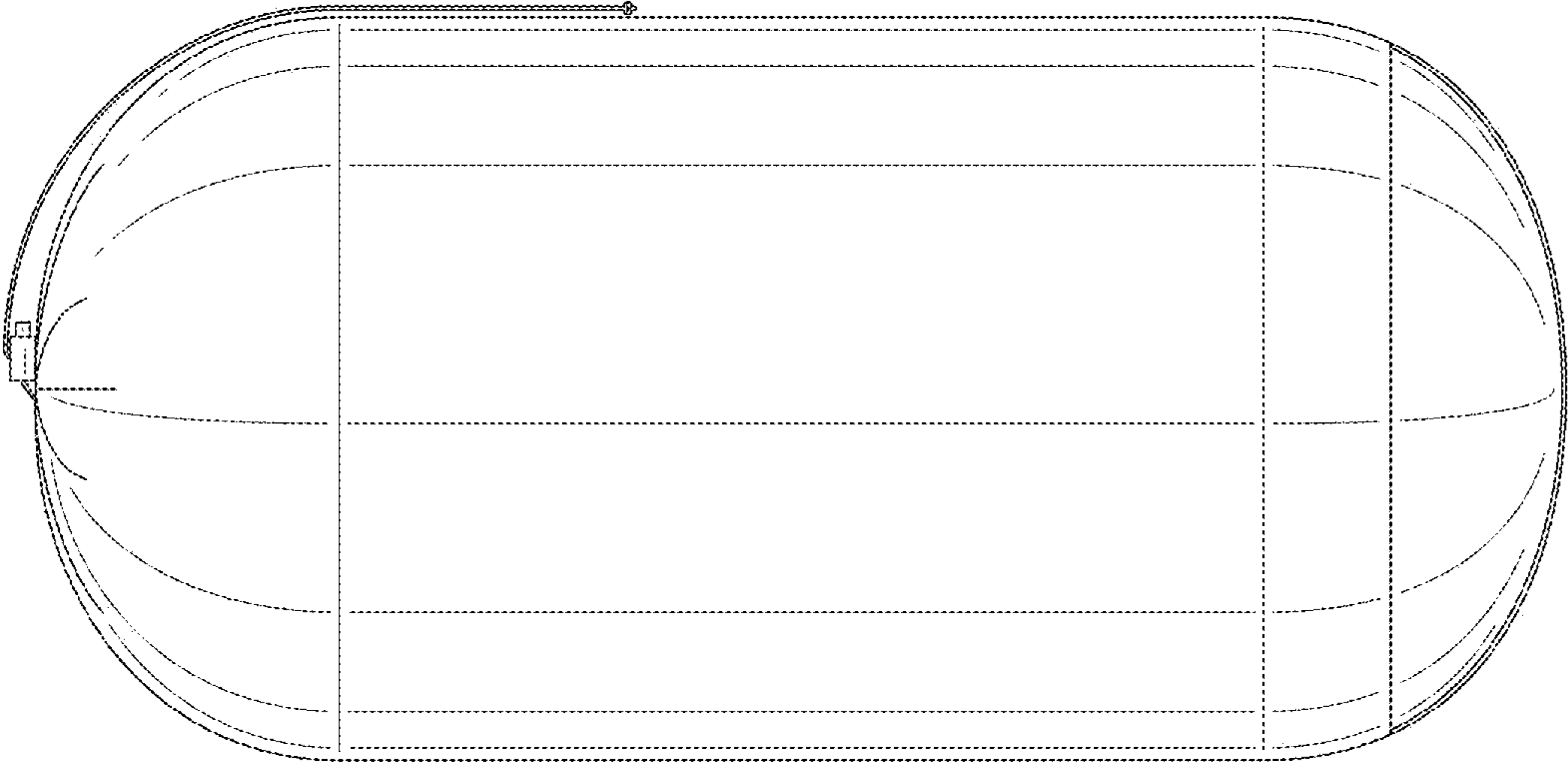

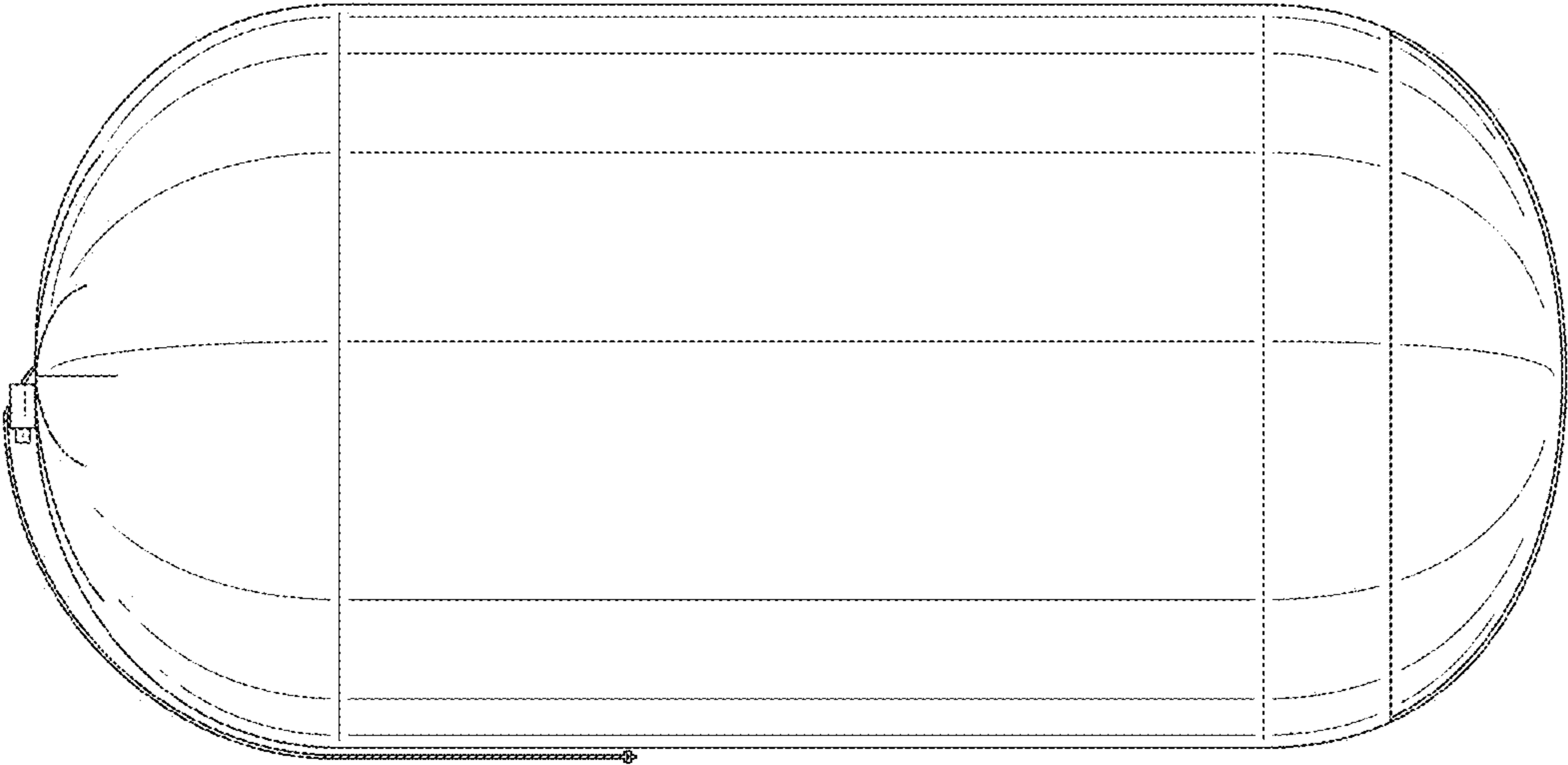

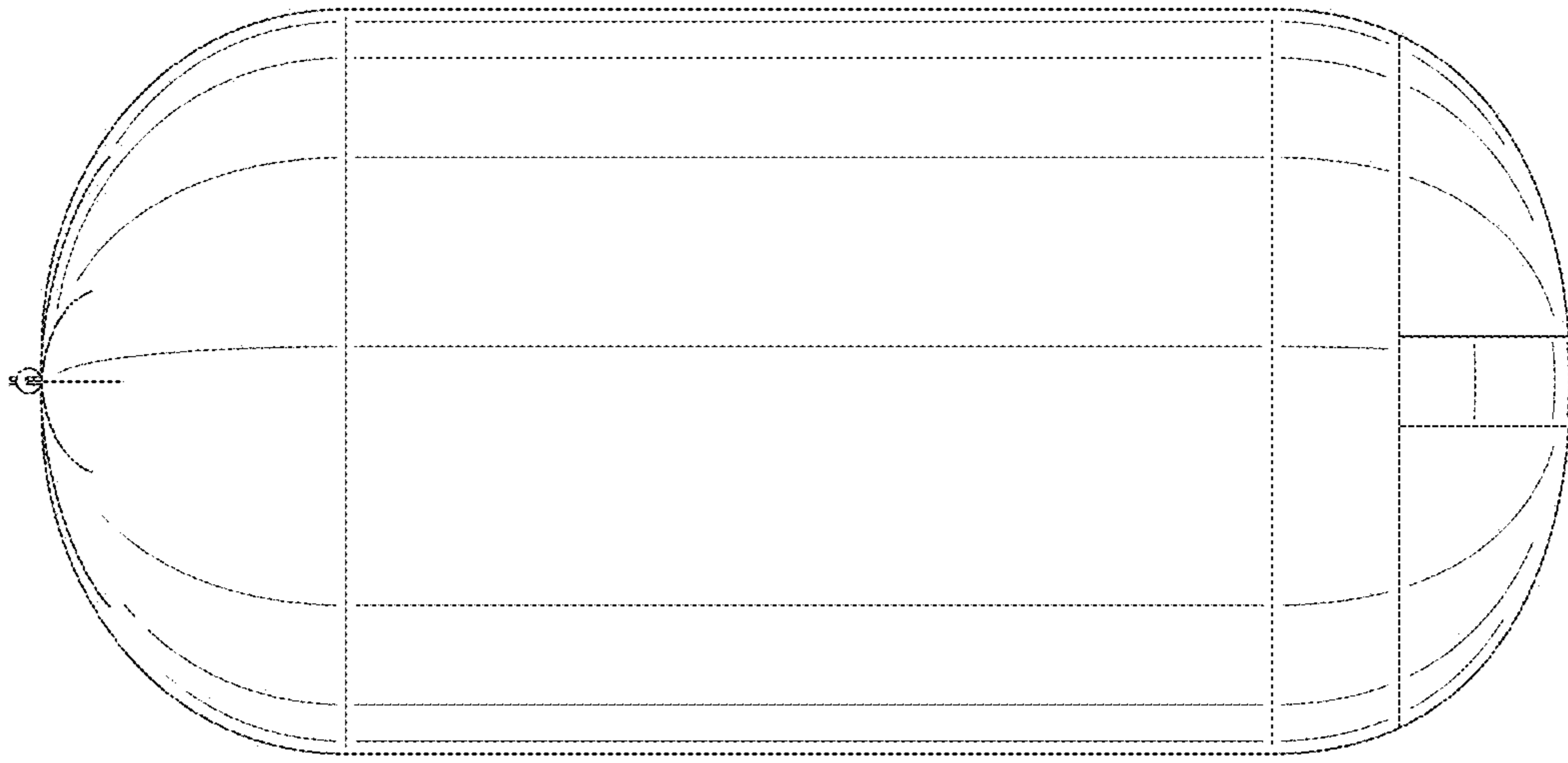

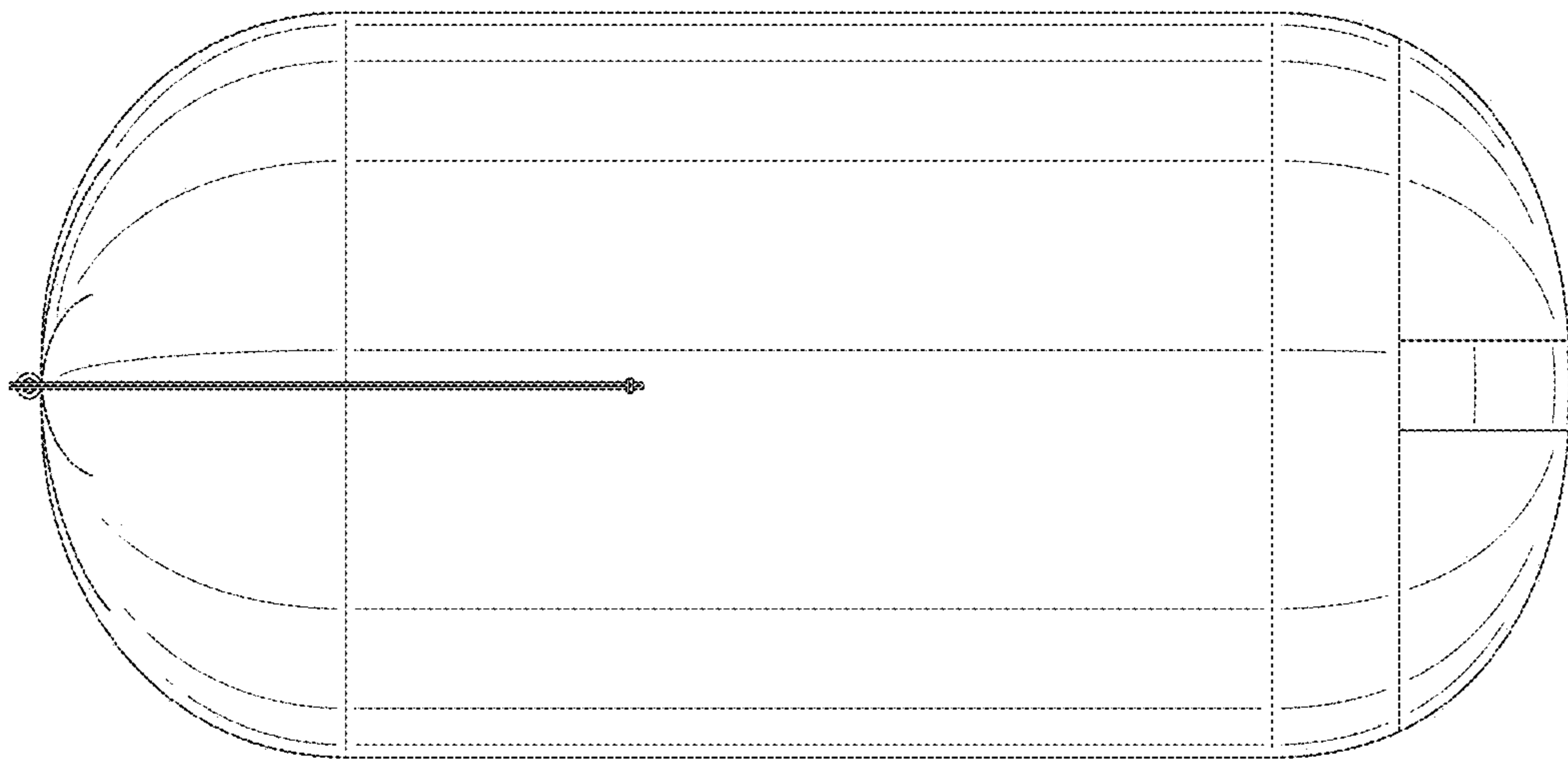

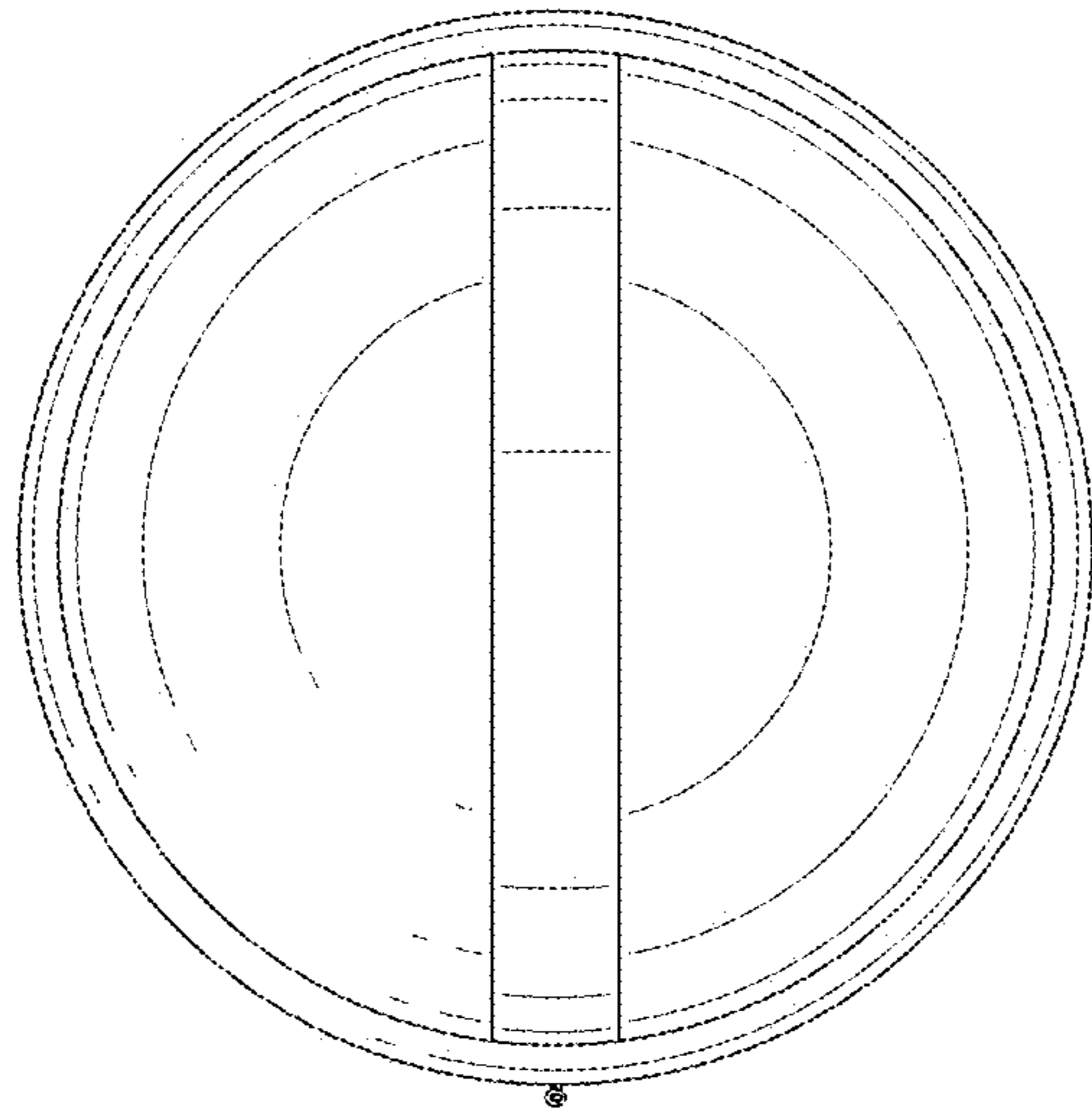

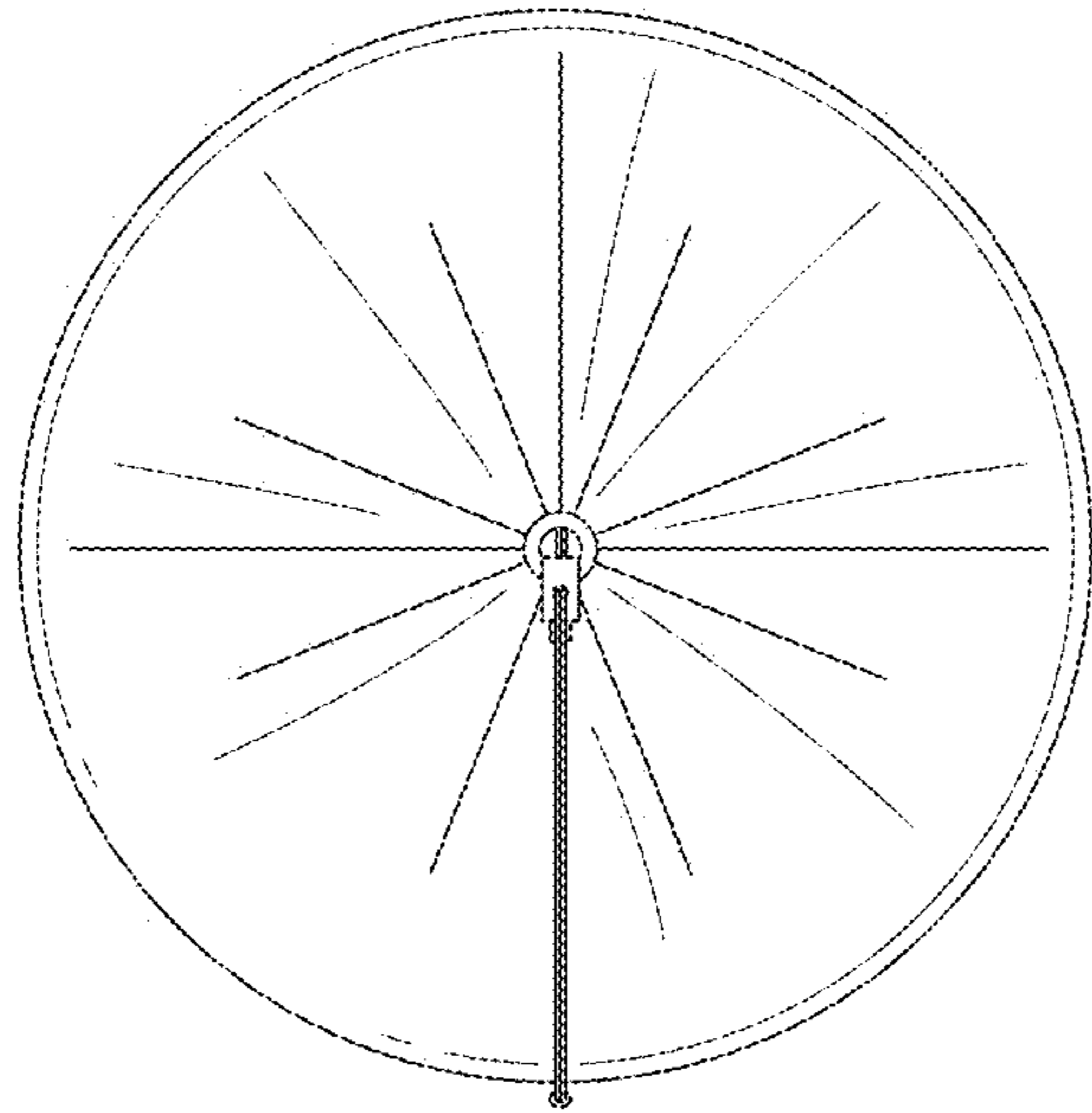
