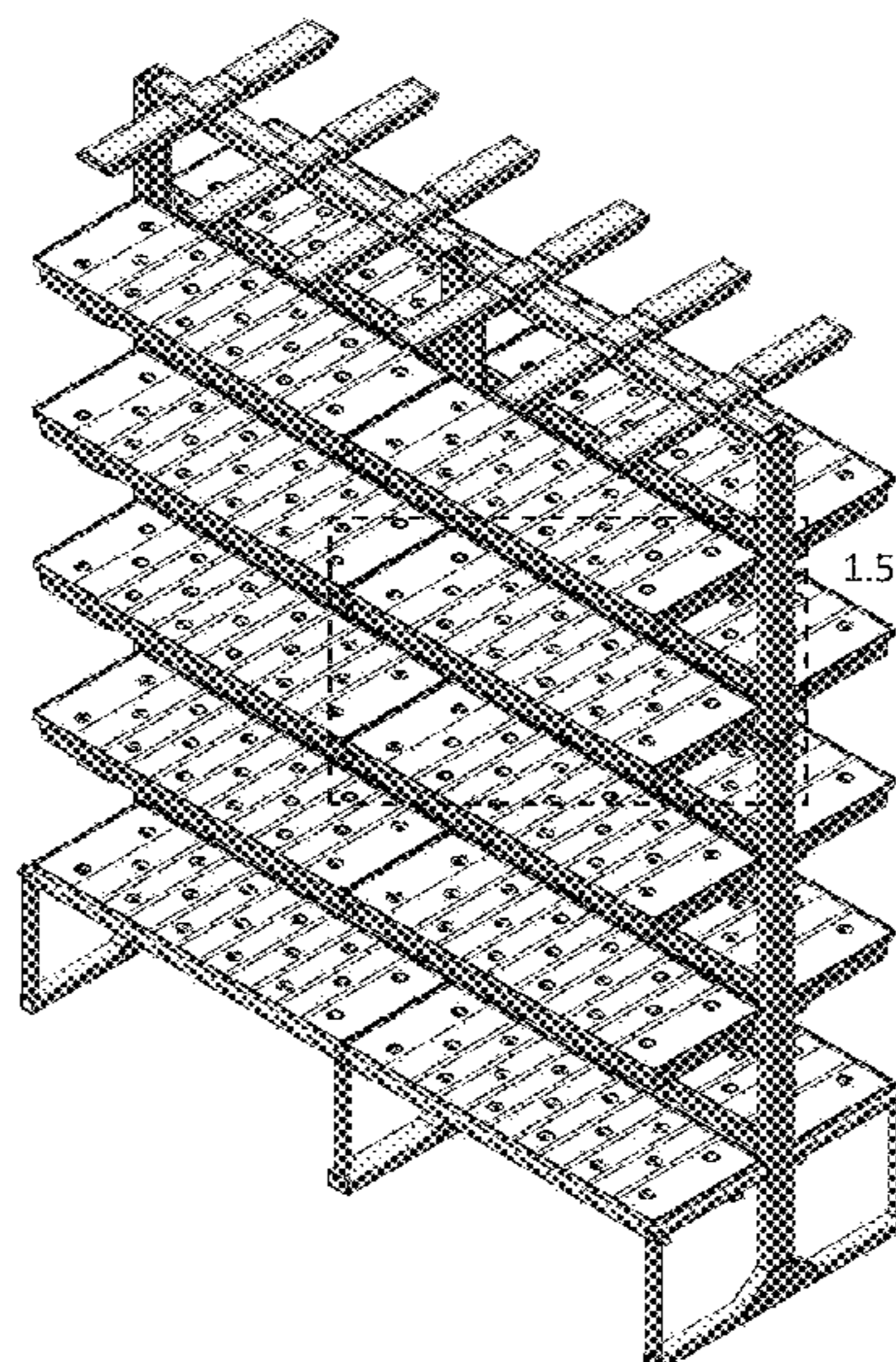
(57) **CLAIM**

The ornamental design for a combined rack and containers for plant cultivation, as shown and described.

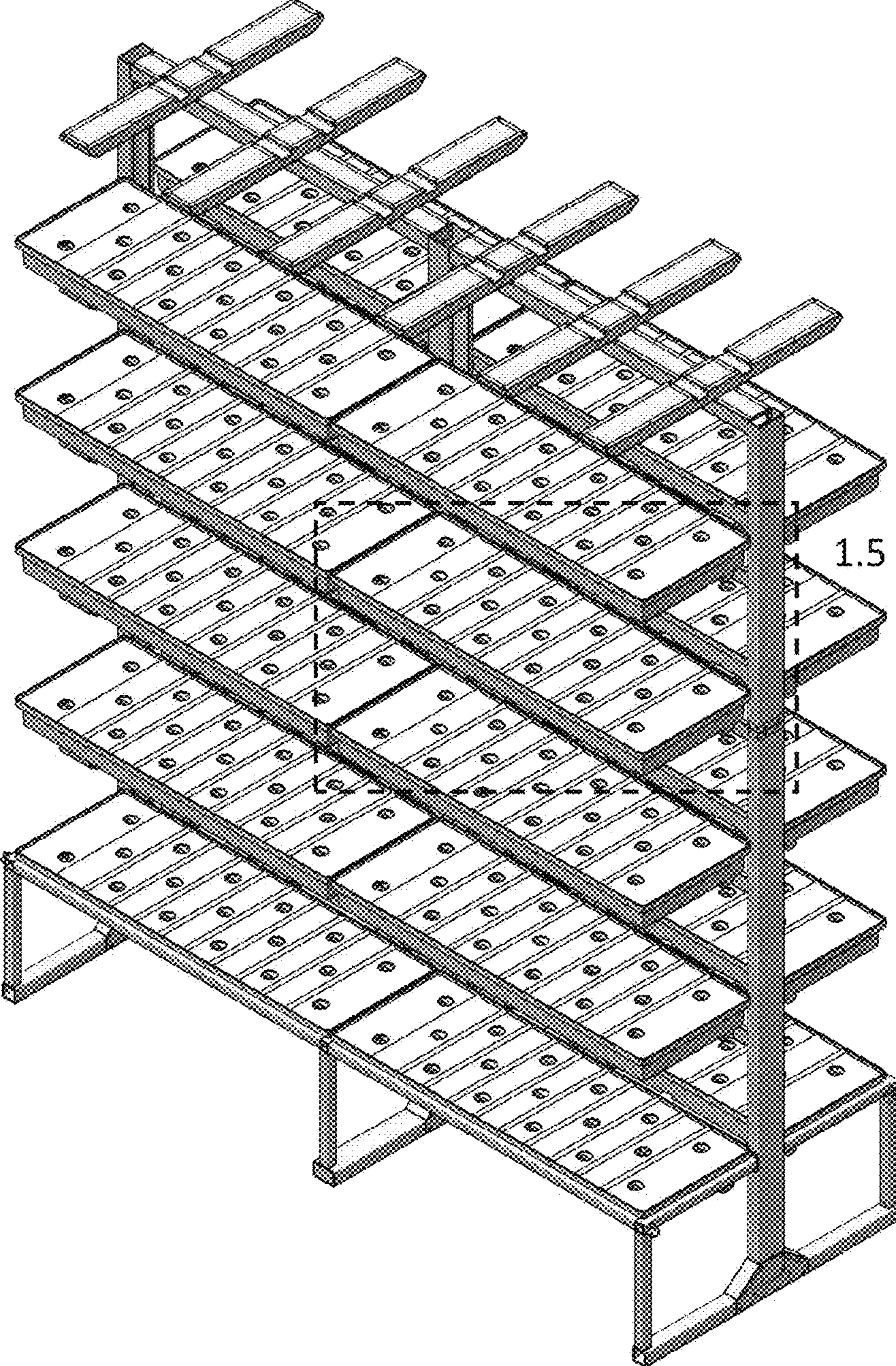
DESCRIPTION

The product is a hydroponic rack structure; the product can be used as a stand with identical containers for plant cultivation installed thereon.

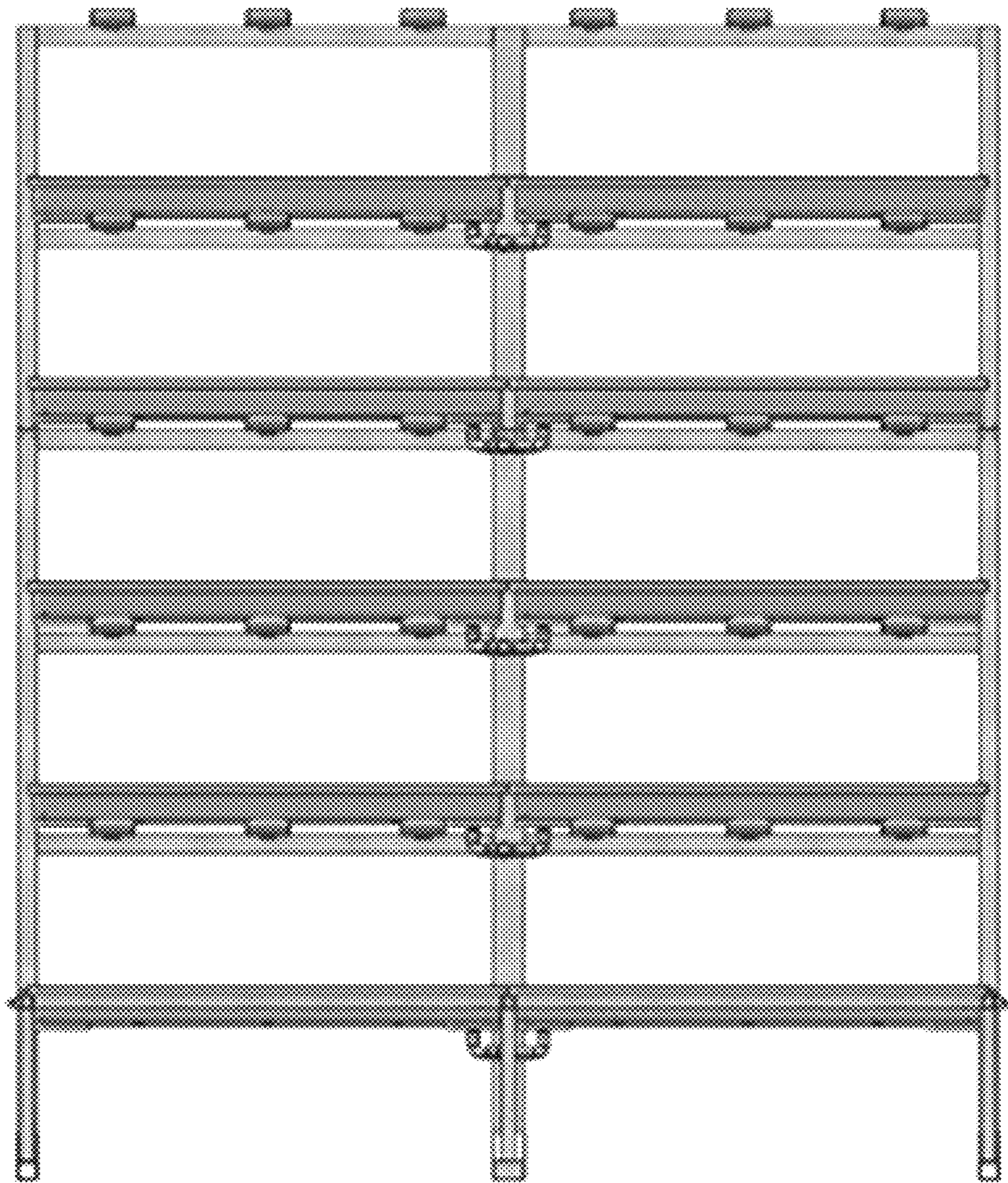

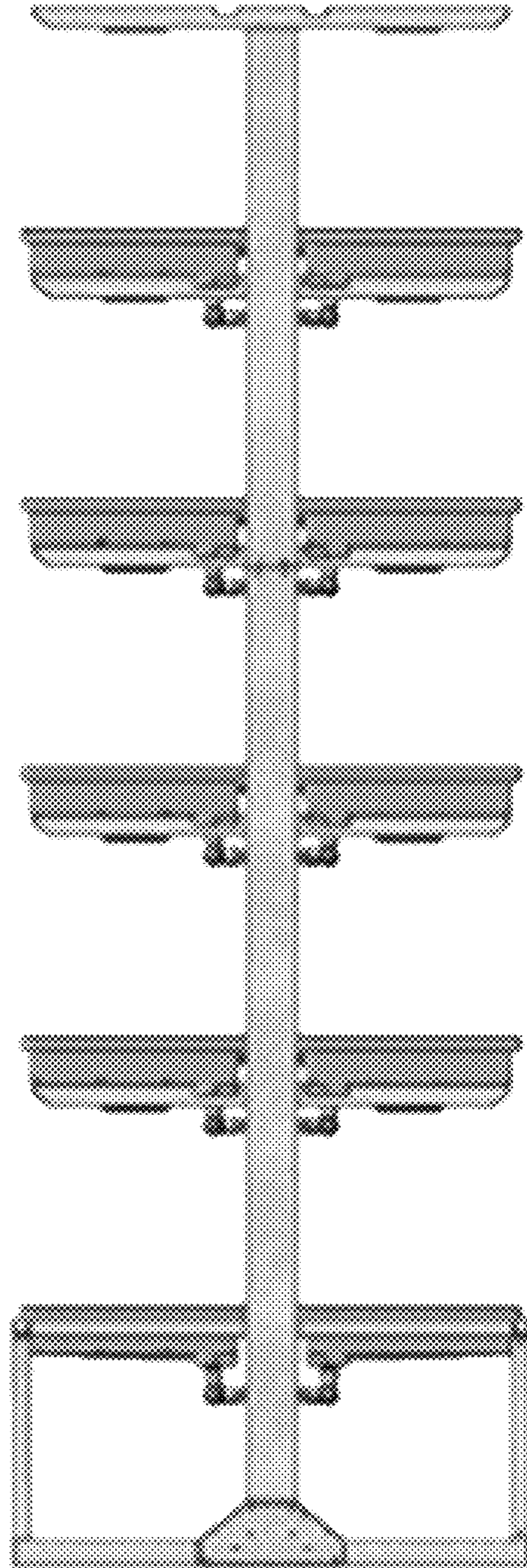

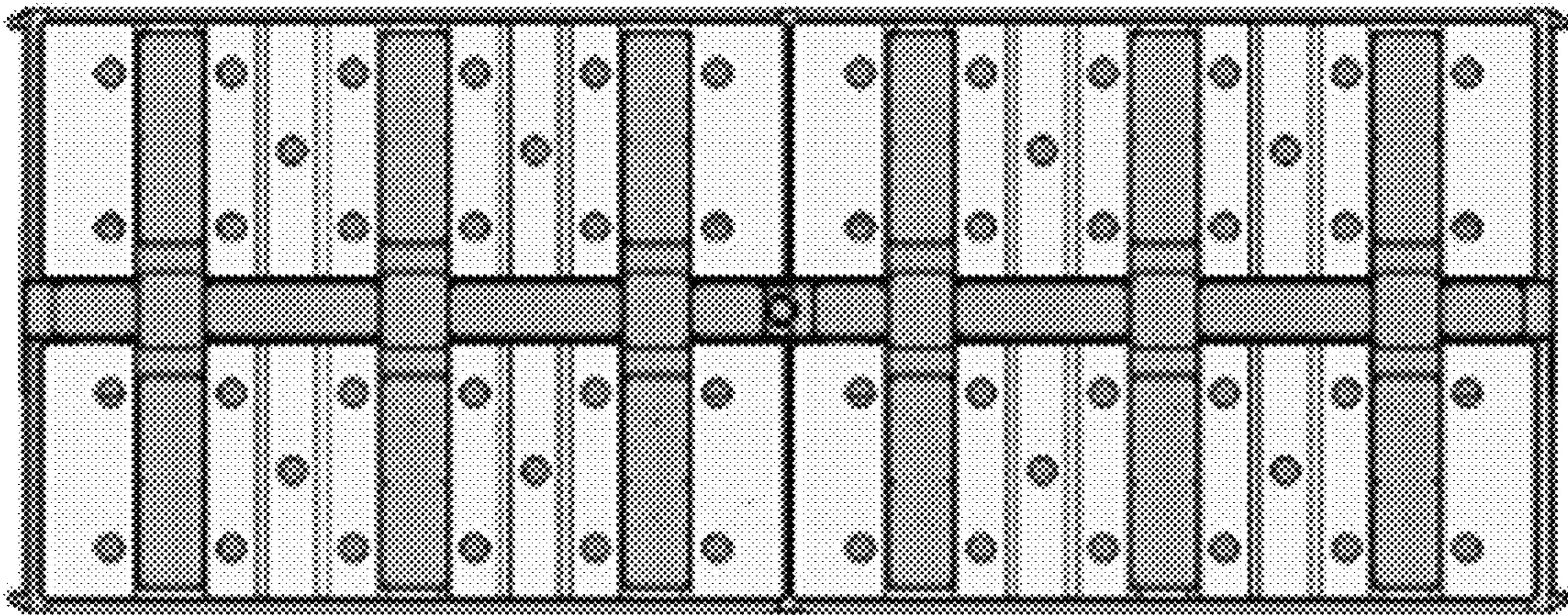
