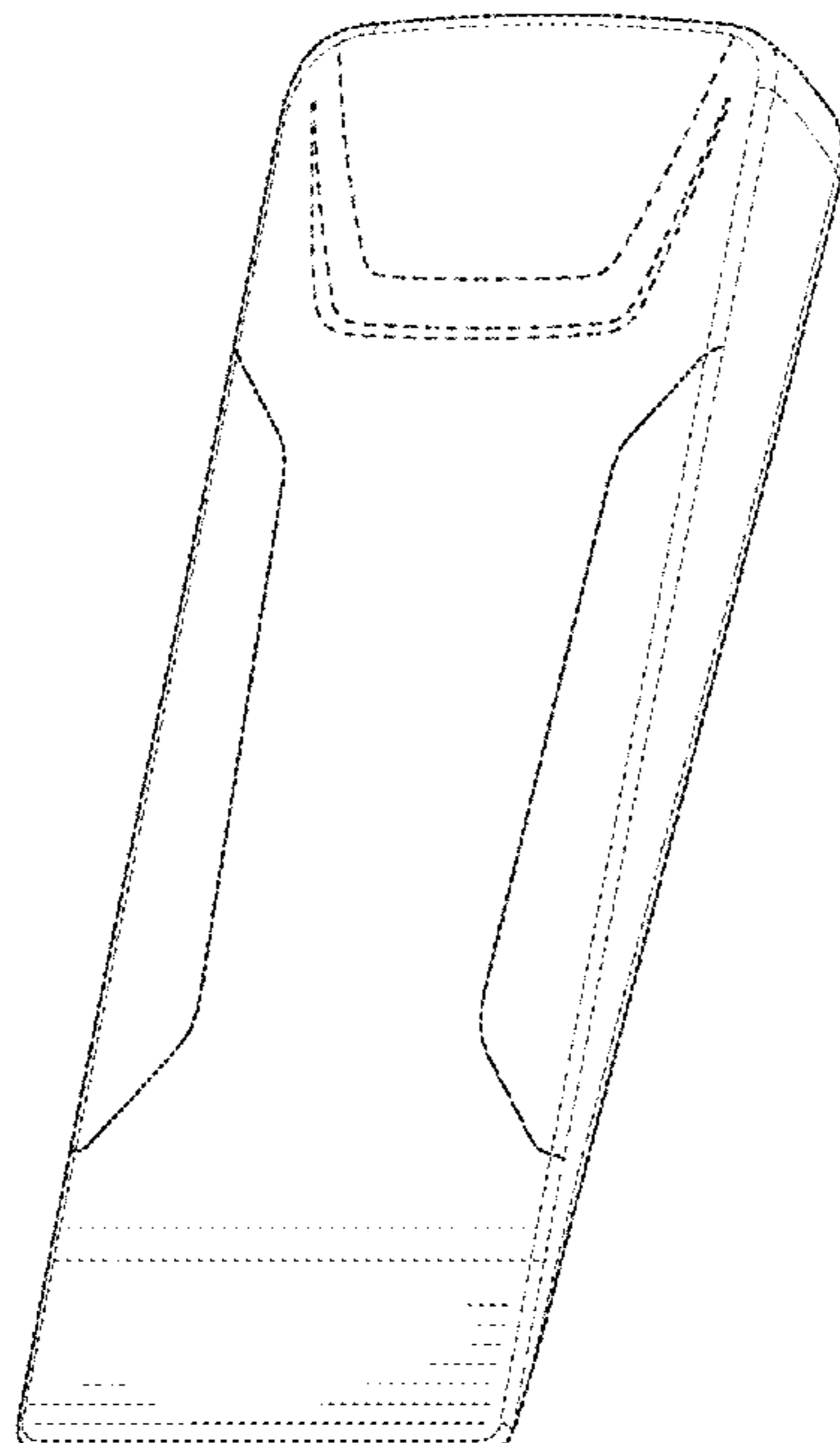
(57) **CLAIM**

The ornamental design for a felling wedge, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a felling wedge in accordance with an embodiment of the present invention; FIG. 2 is a front view of the felling wedge of FIG. 1; FIG. 3 is a rear view of the felling wedge of FIG. 1; FIG. 4 is a top view of the felling wedge of FIG. 1; FIG. 5 is a bottom view of the power grinder of FIG. 1; FIG. 6 is a left side view of the felling wedge of FIG. 1; and, FIG. 7 is a right side view of the felling wedge of FIG. 1. The broken lines depict portions the felling wedge in which the design is embodied that are not considered part of the claimed design.

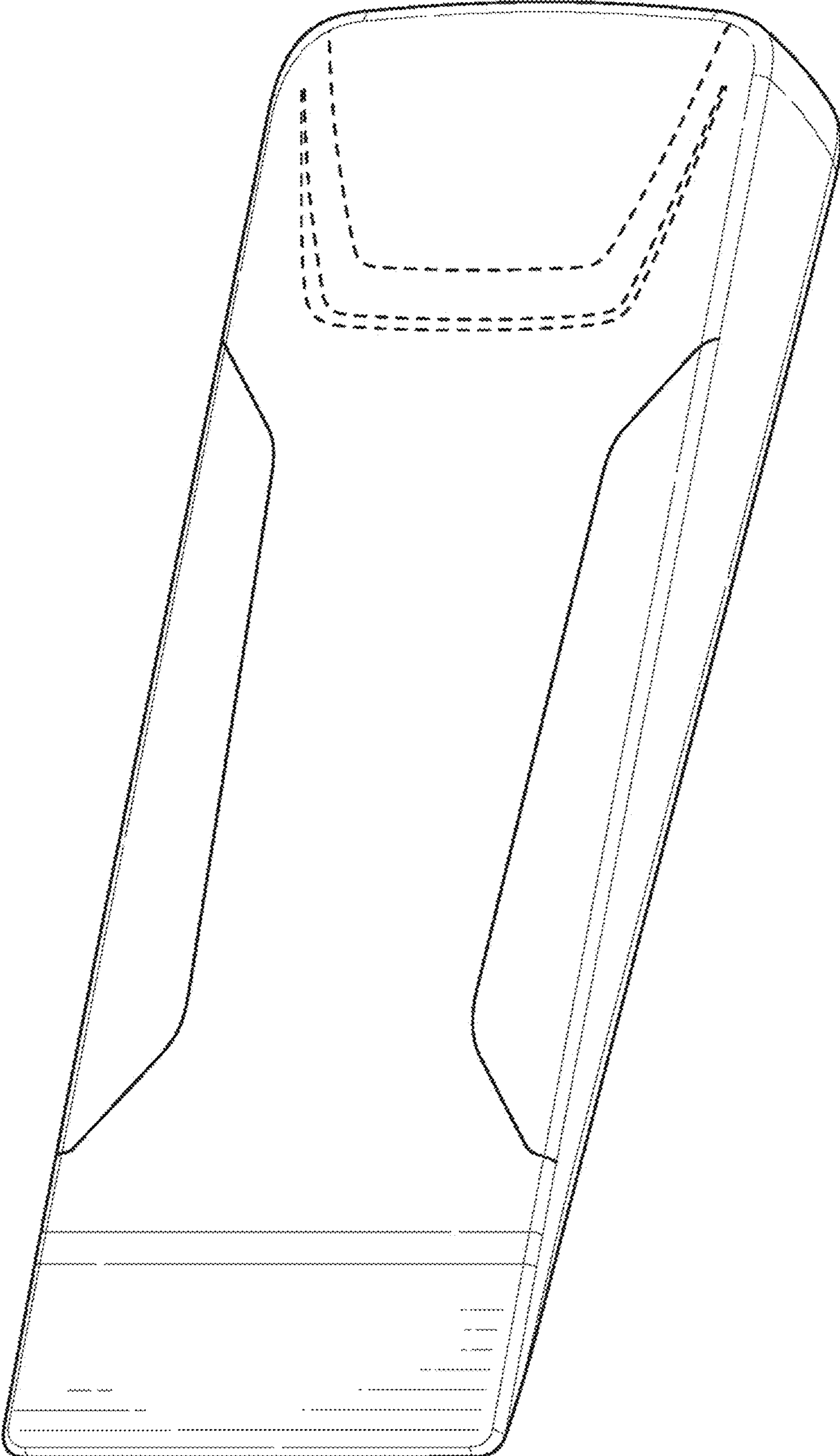

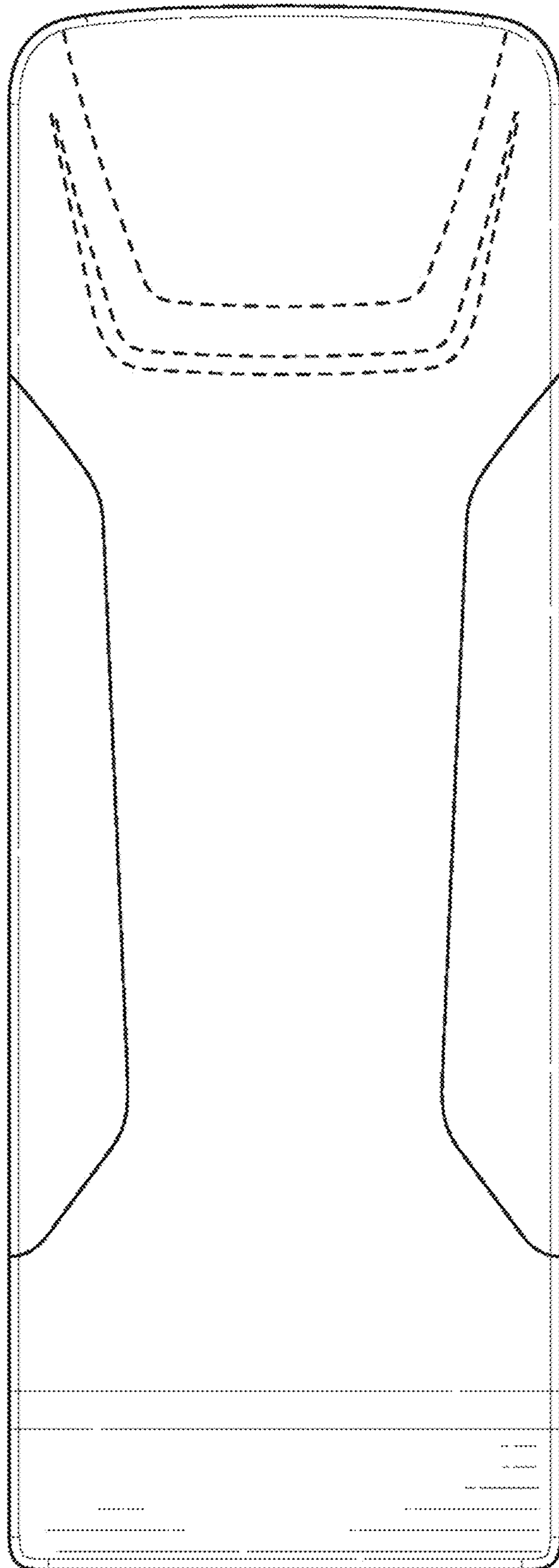

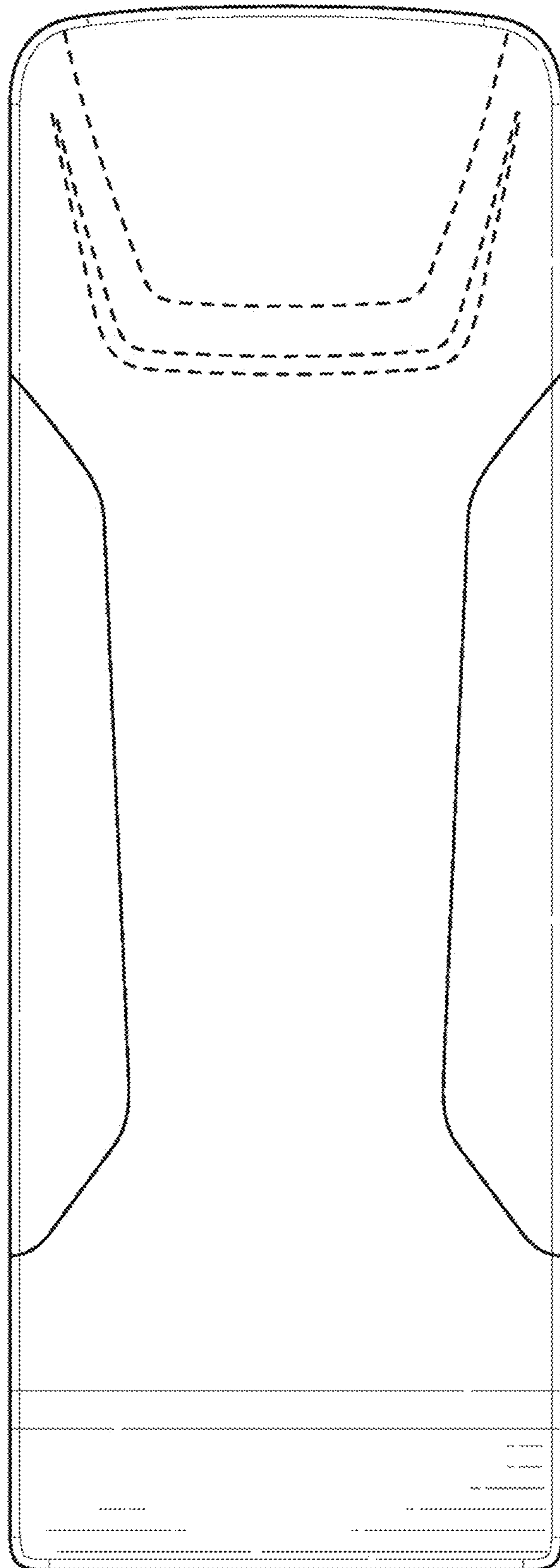

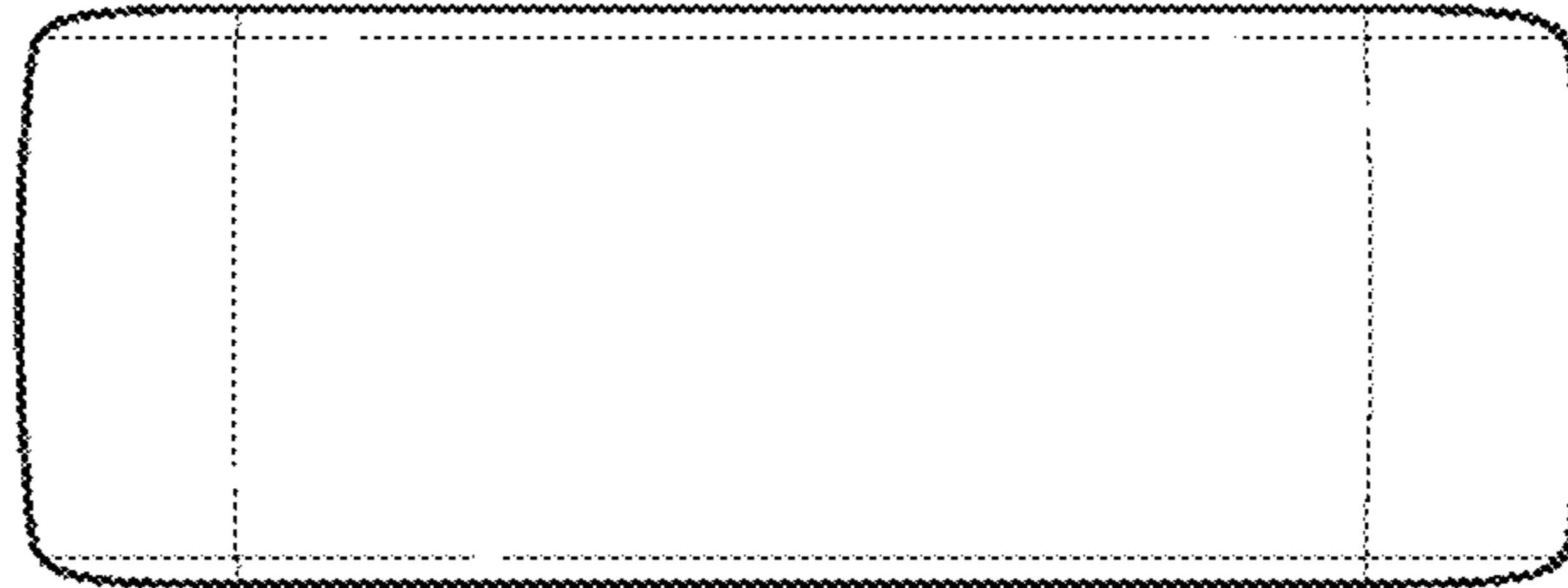

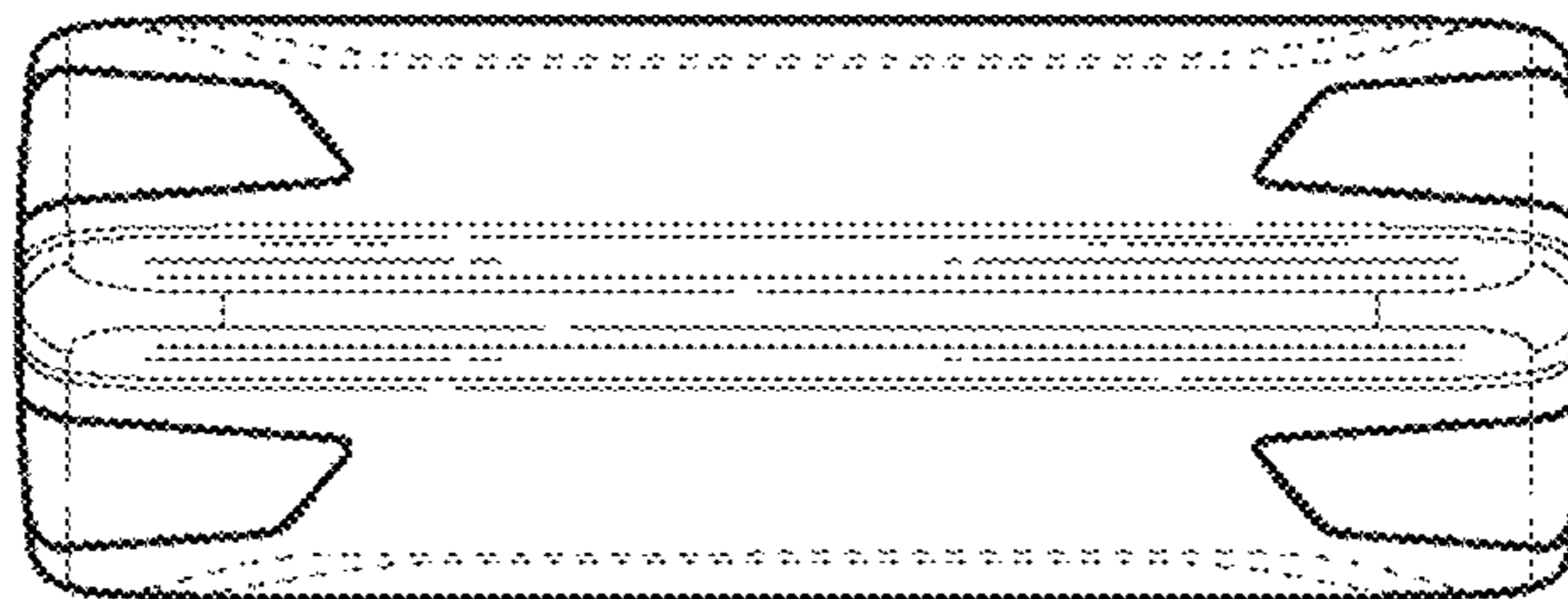

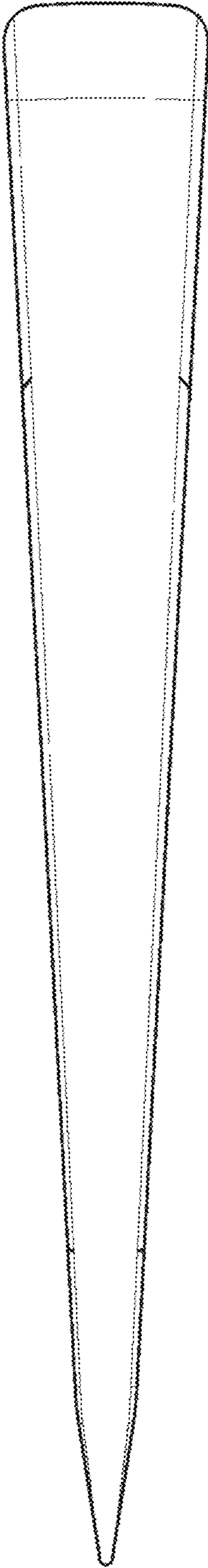

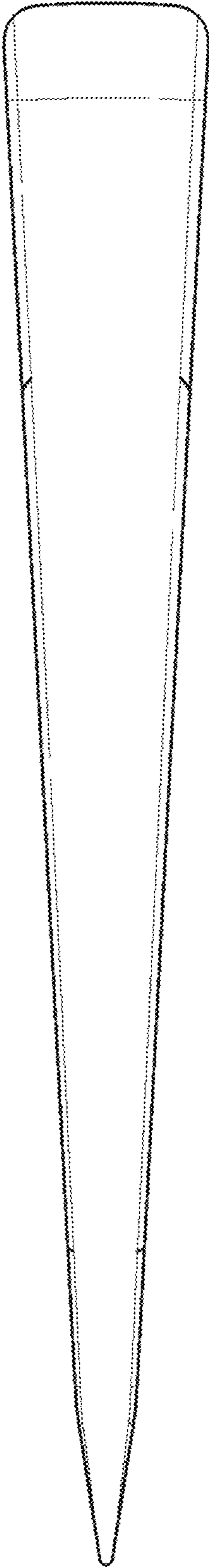
