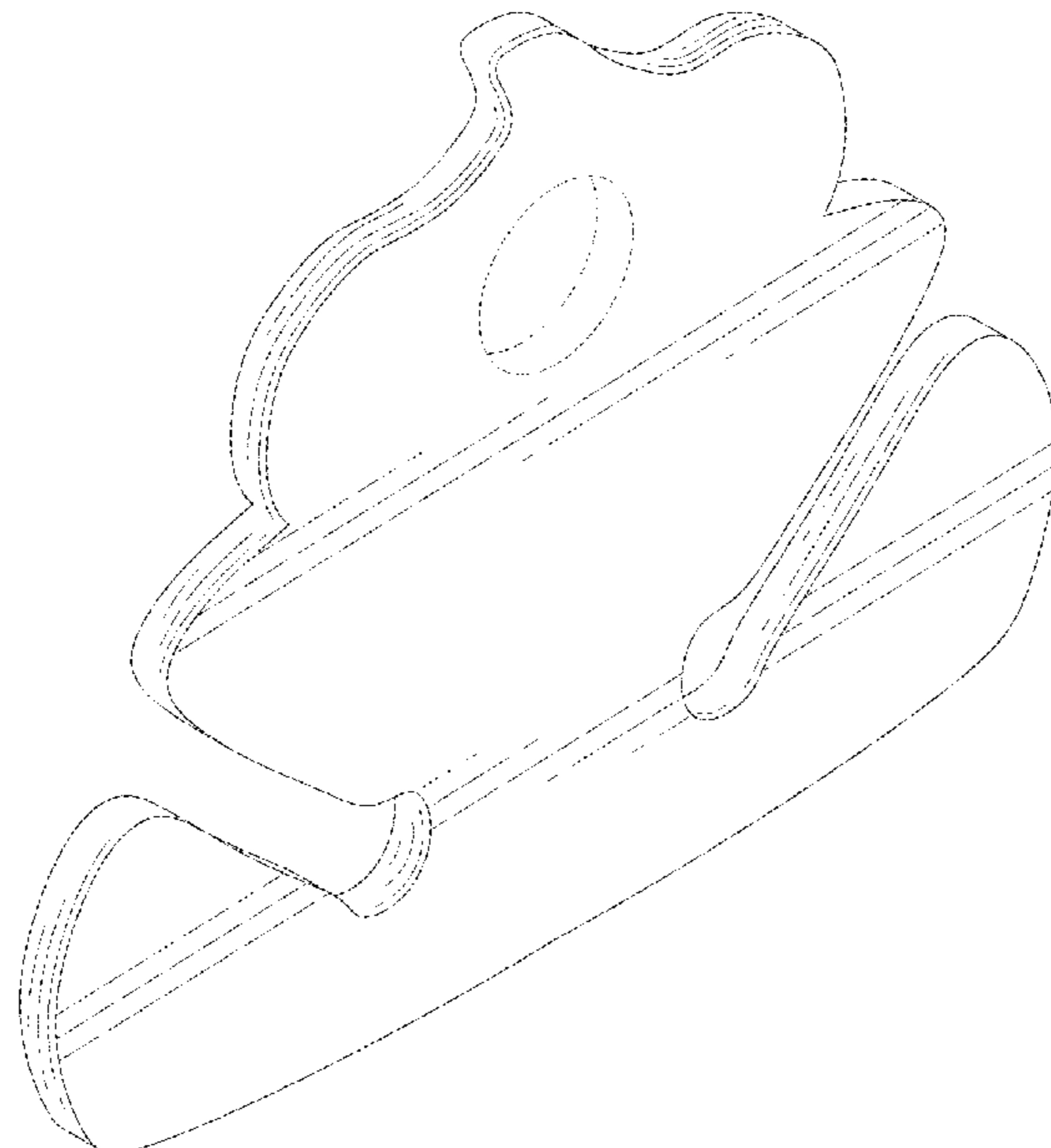
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a waste bag holder, showing my new design;
FIG. 2 is a front view thereof;

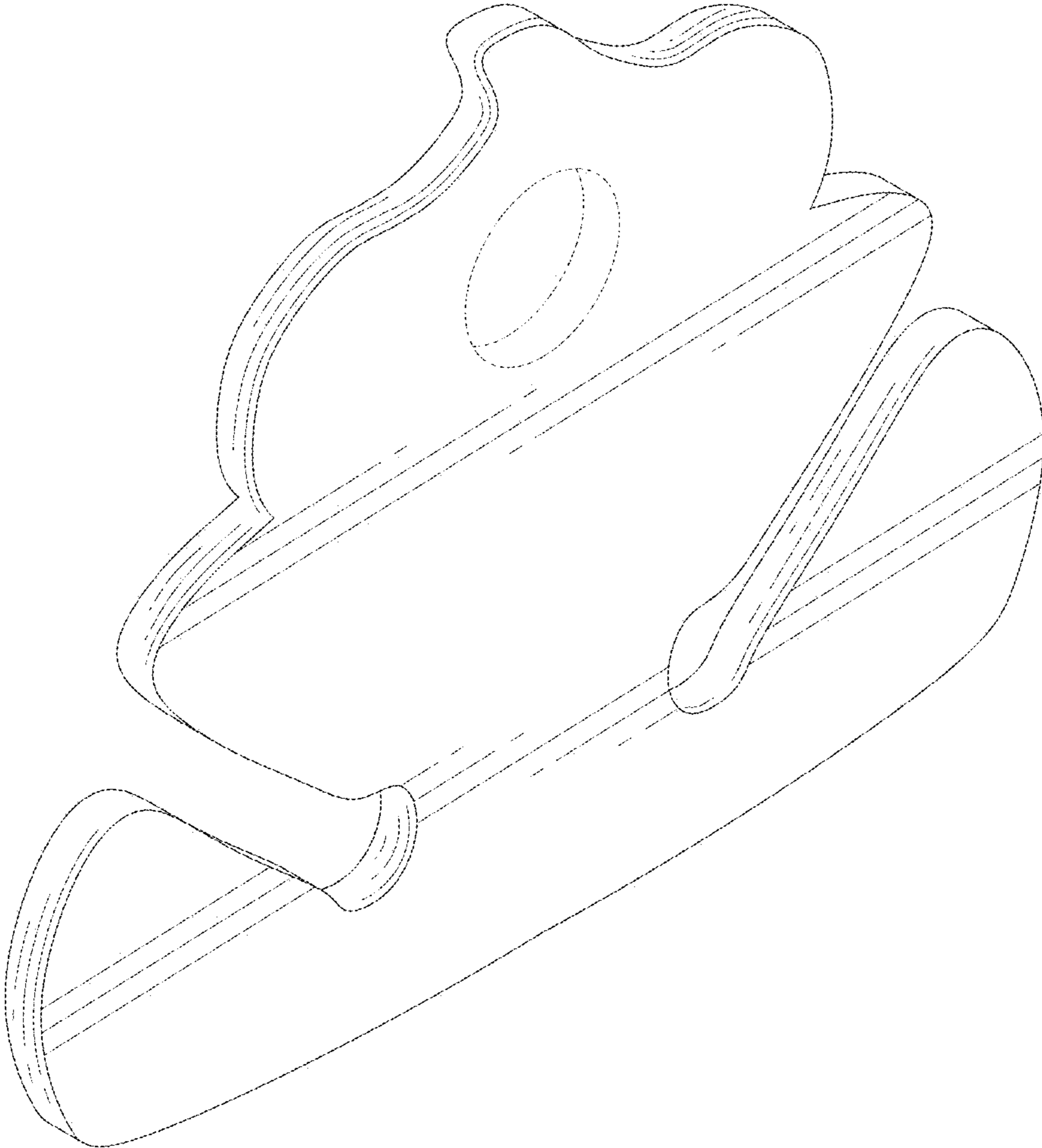

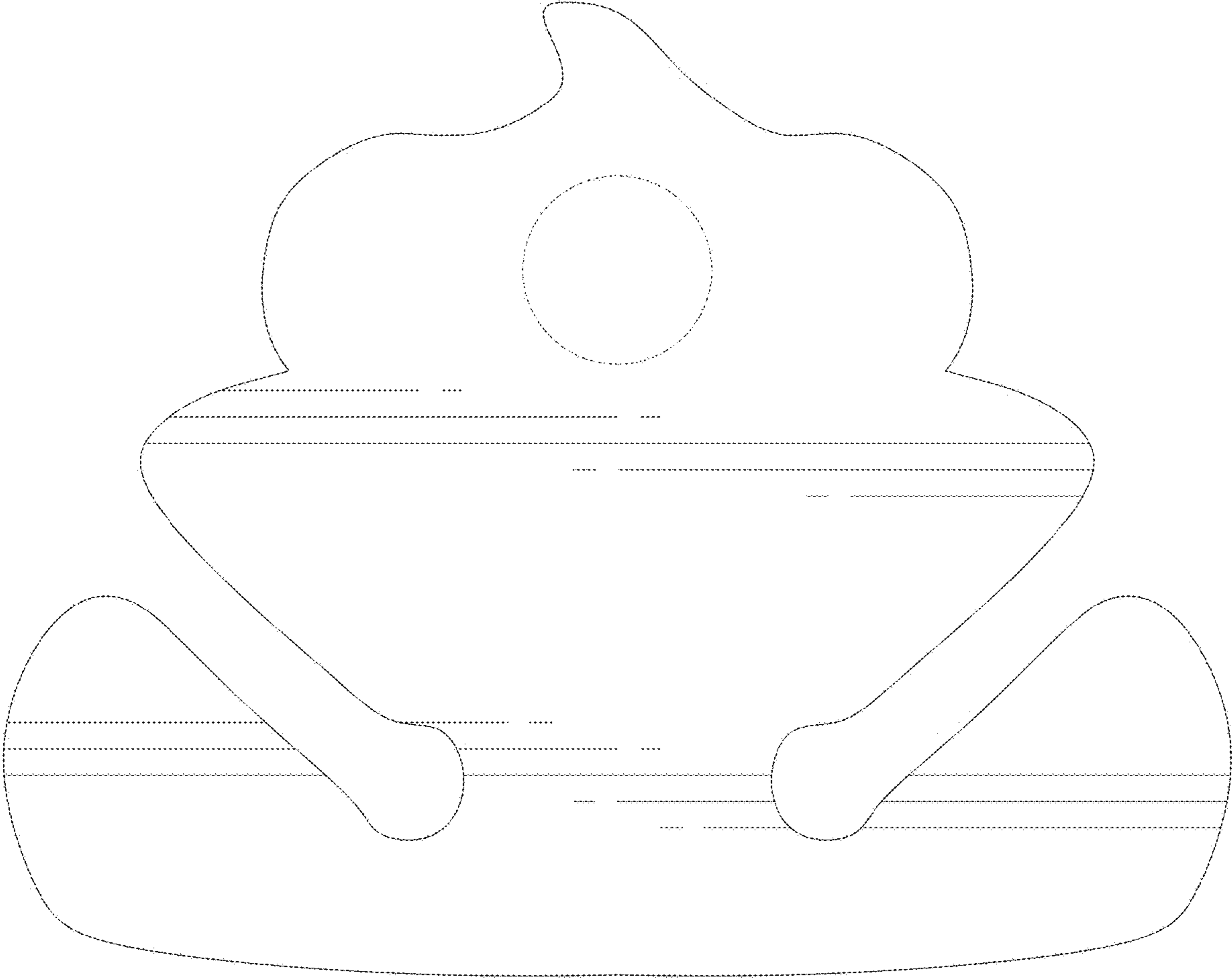

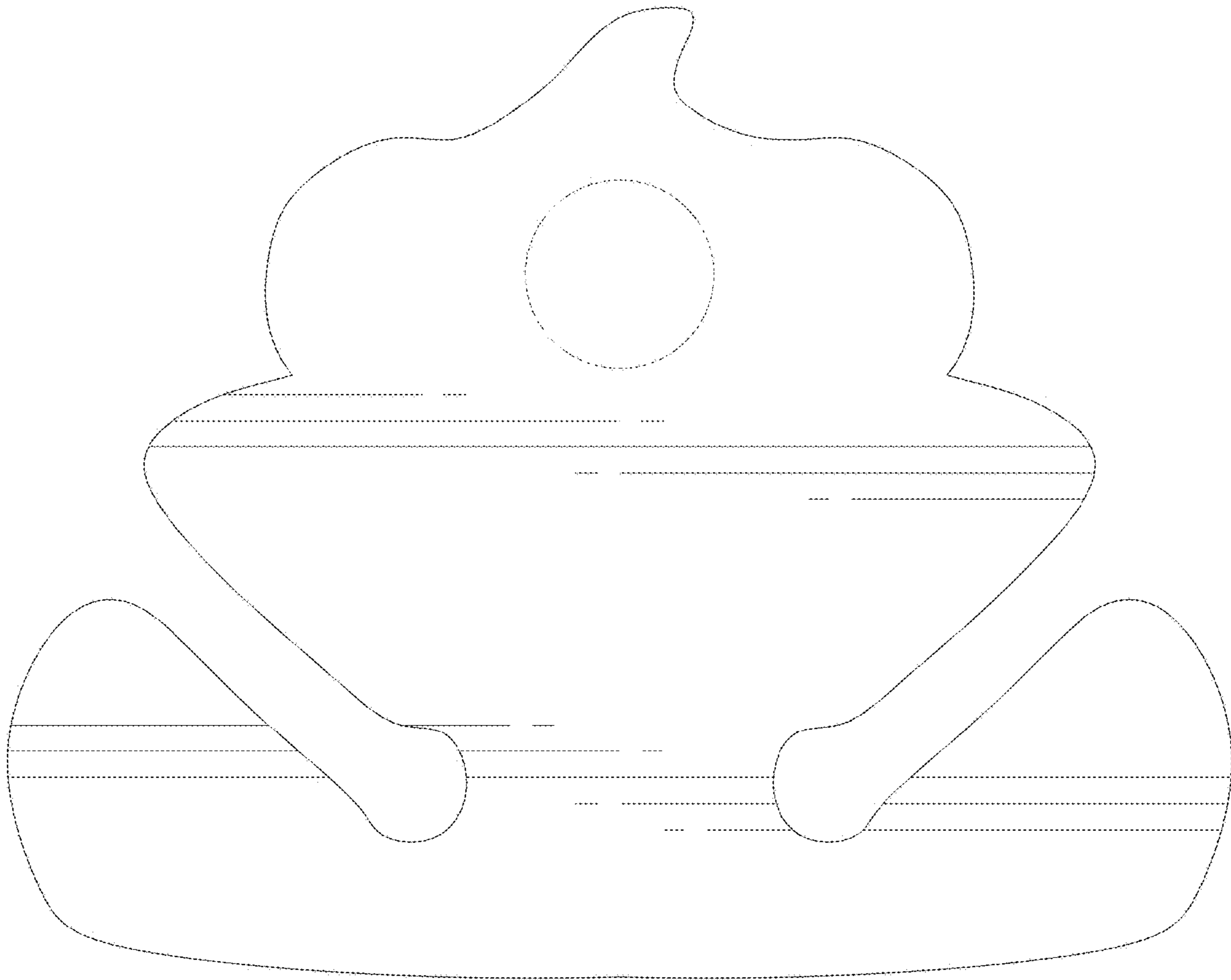

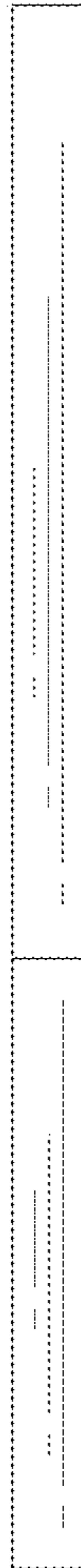

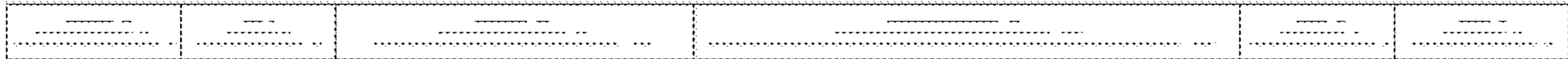

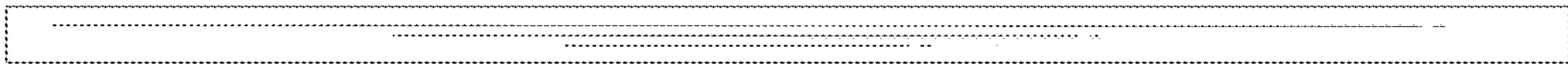
