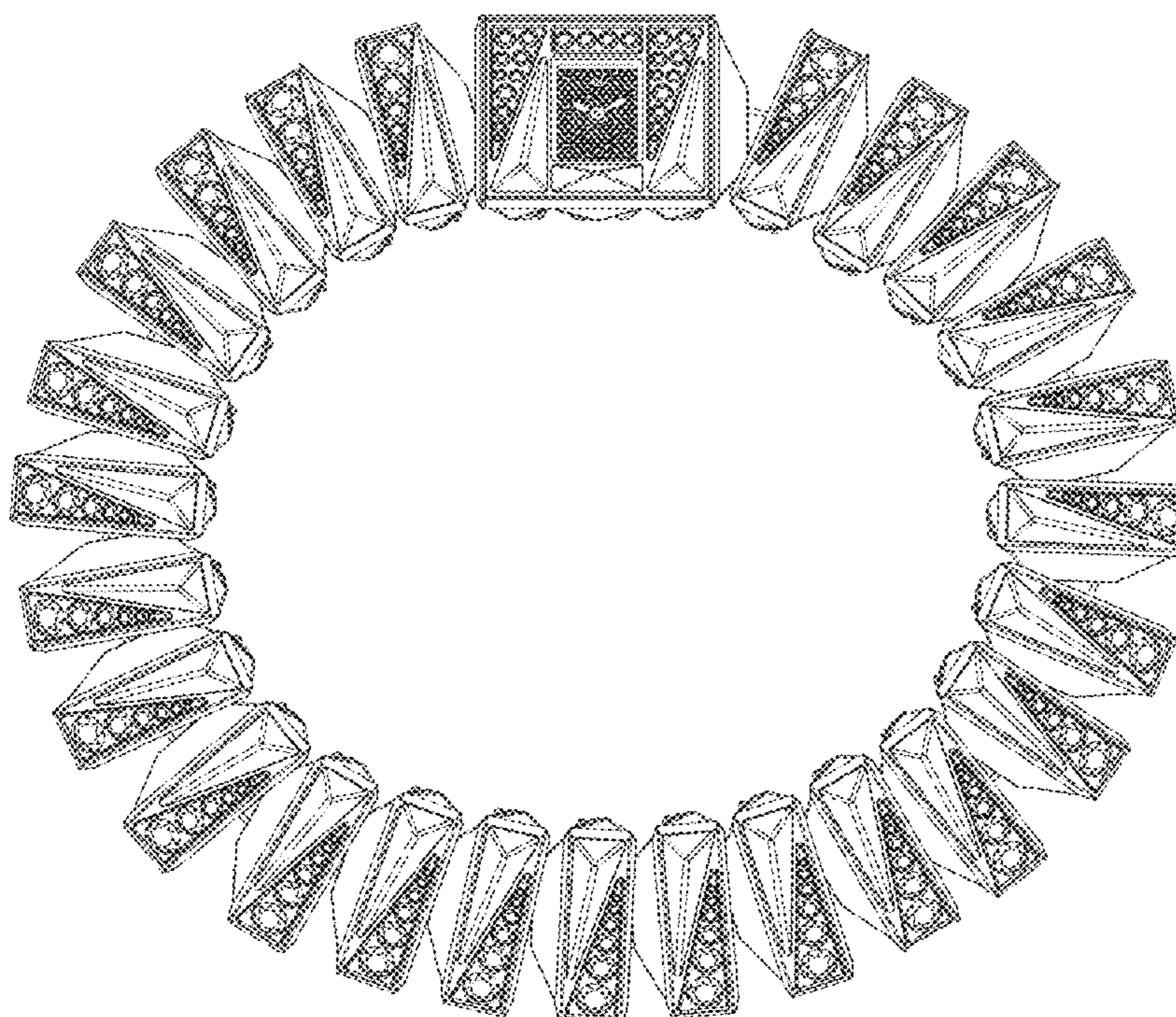
(57) **CLAIM**

The ornamental design for a wrist watch, as shown and described.

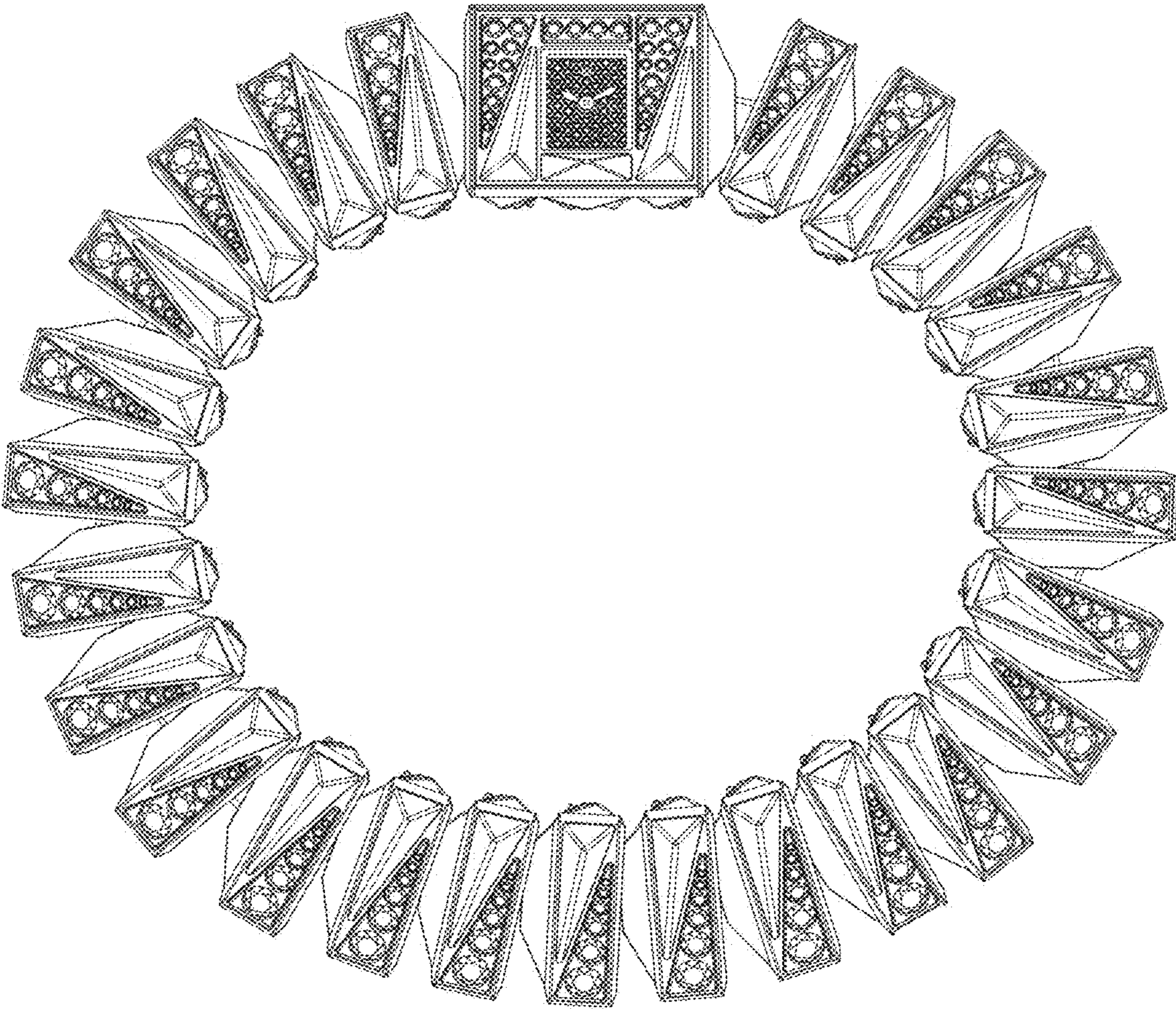
DESCRIPTION

- 1.8 is a rear perspective view of a wrist watch.

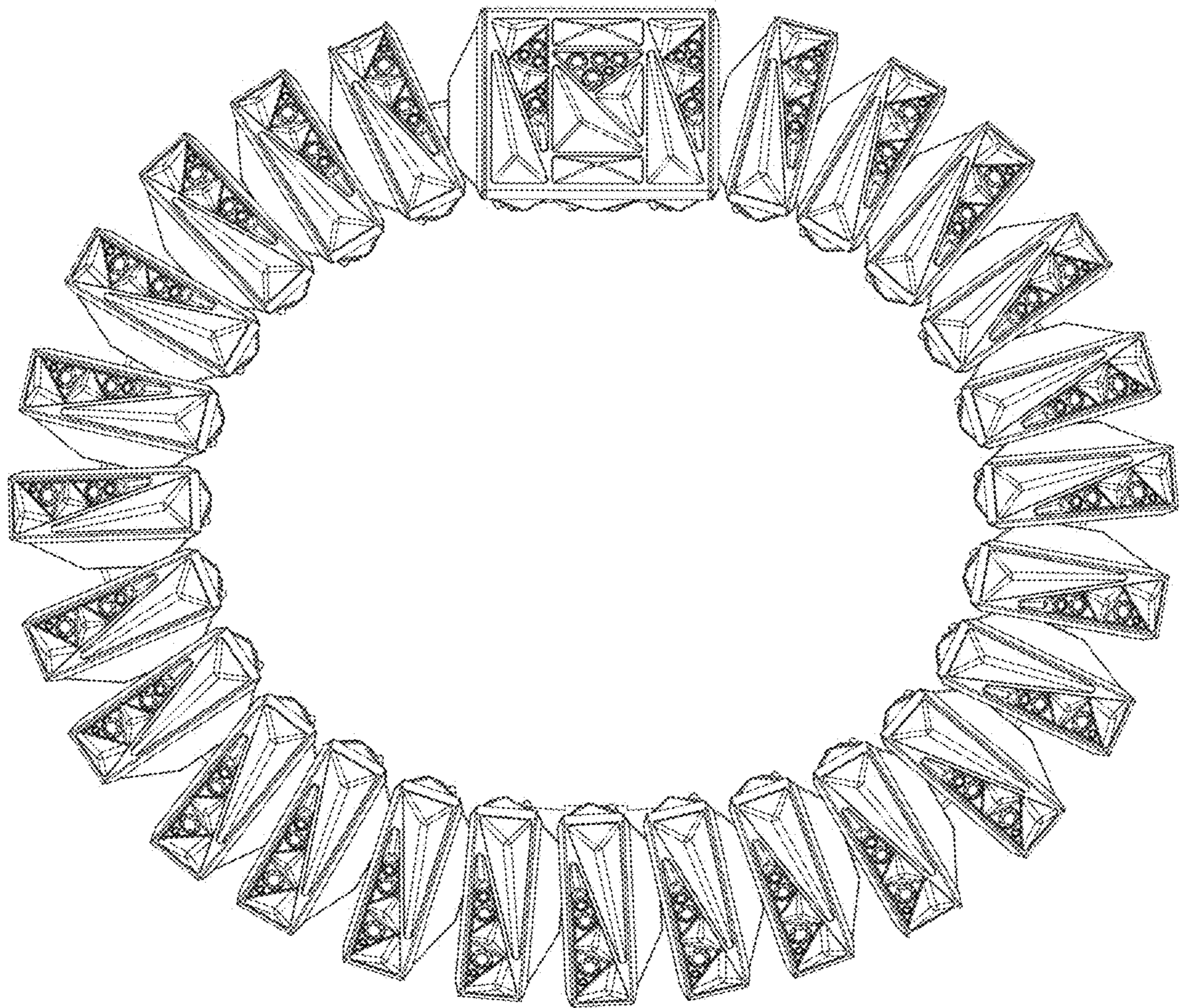

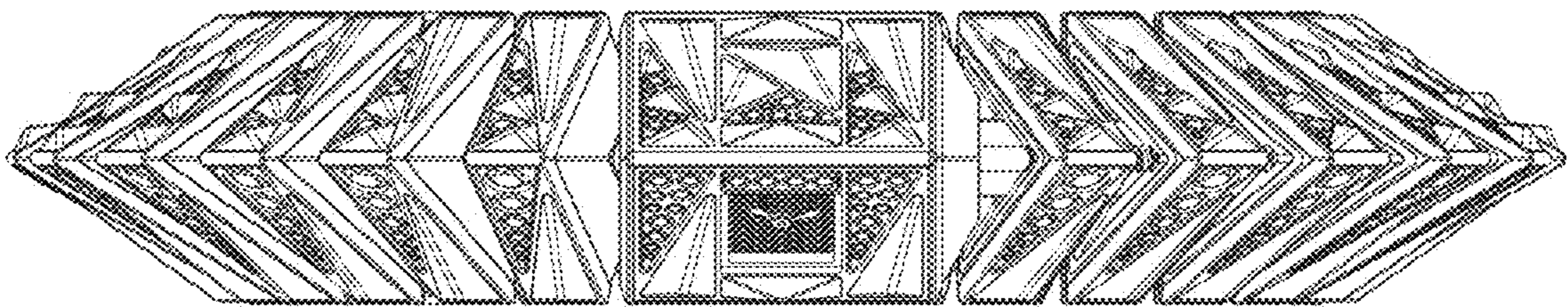

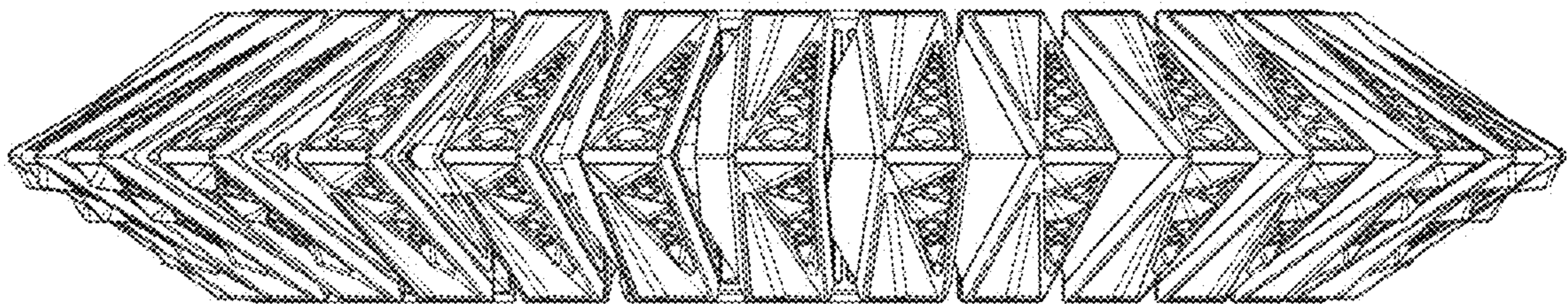

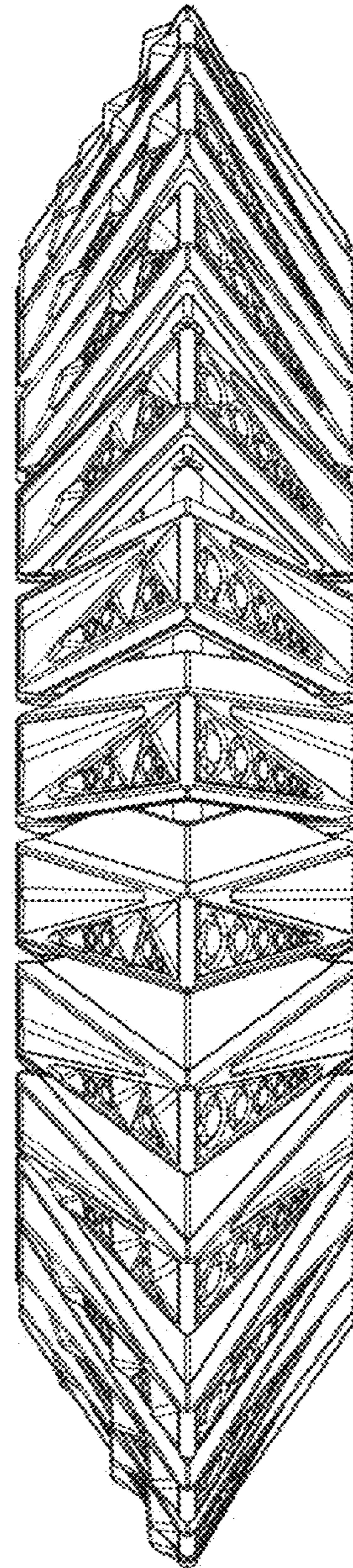

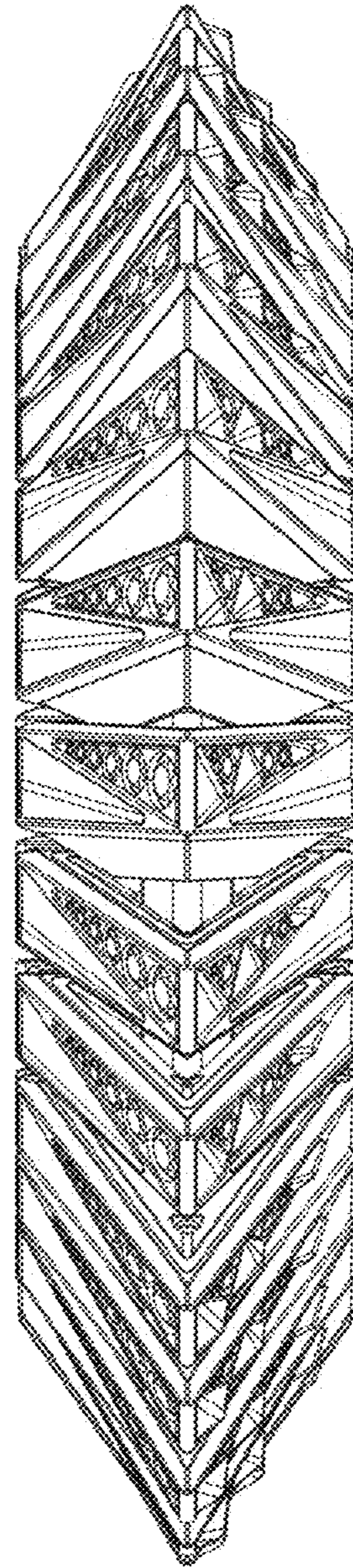

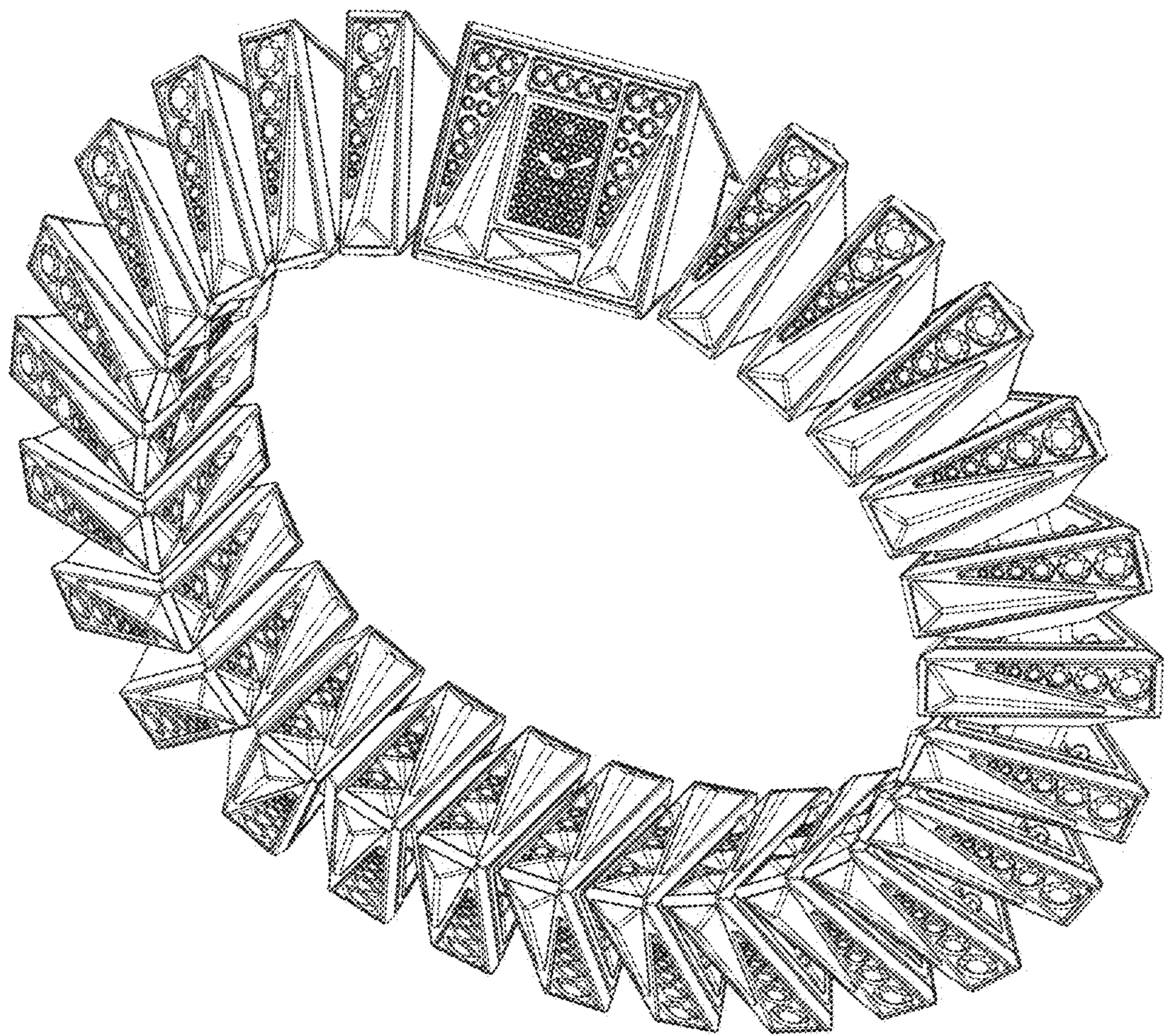
