(57) **CLAIM**

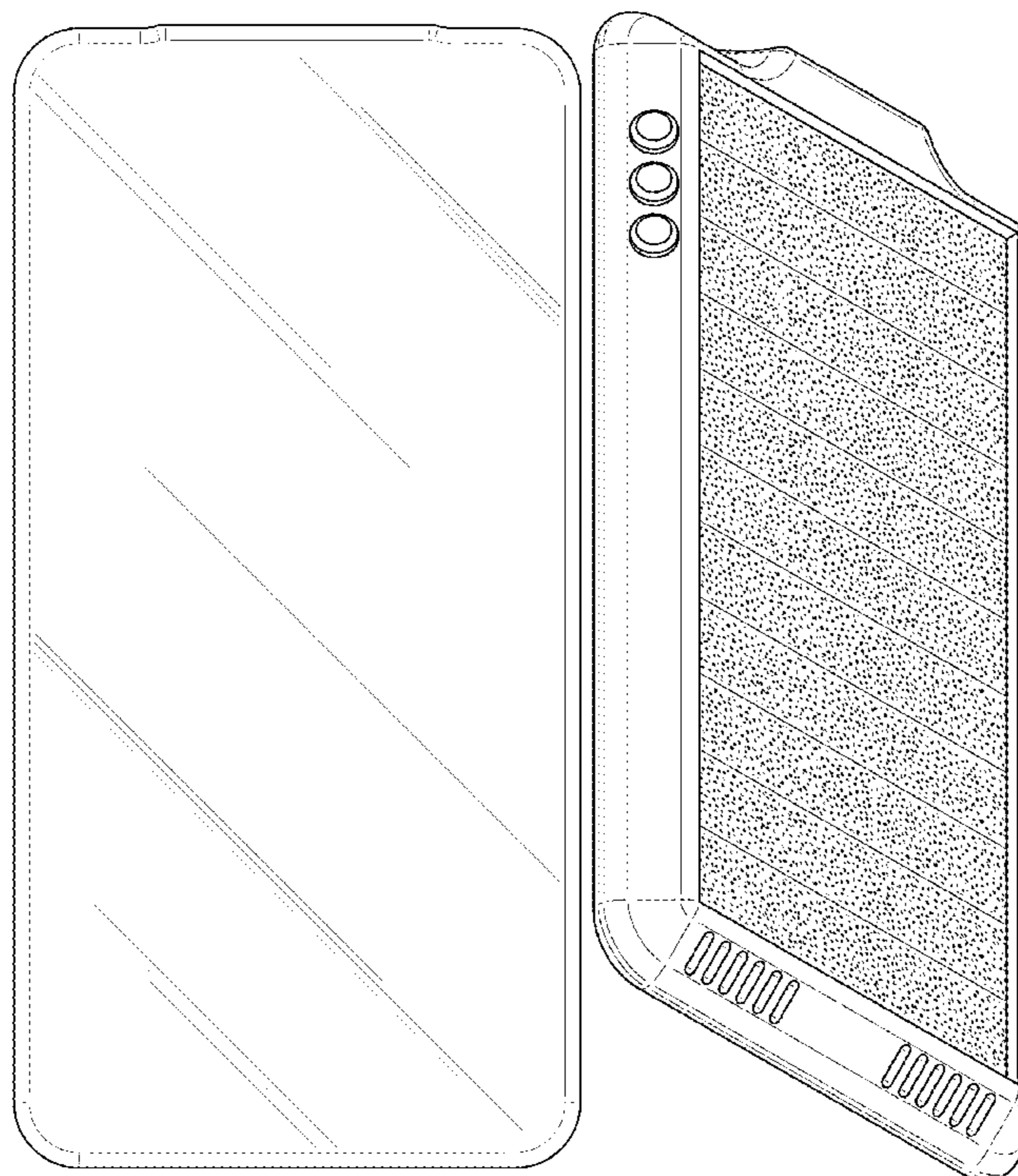
I claim the ornamental design for a solar-powered cell phone, as shown and described.

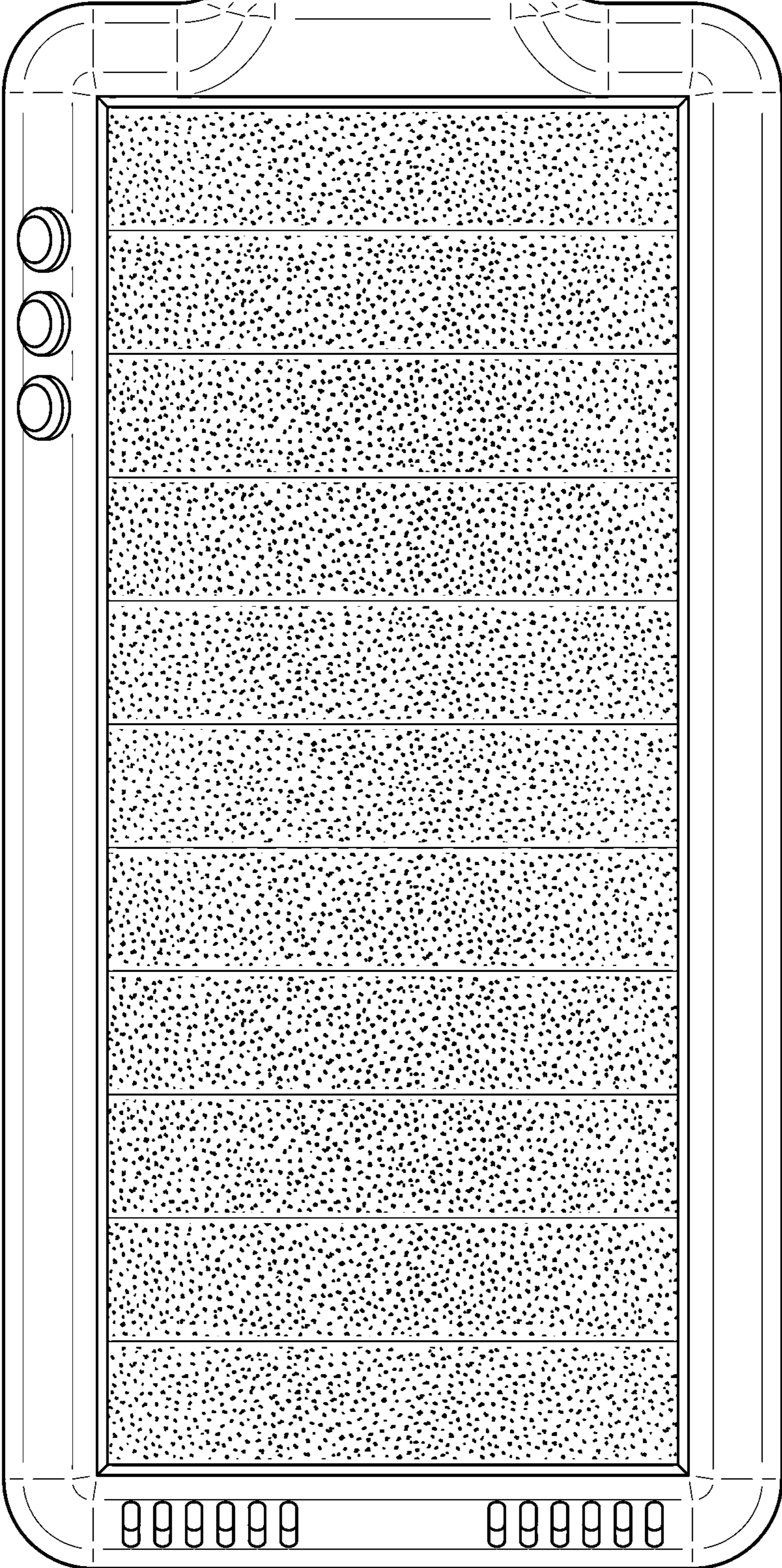

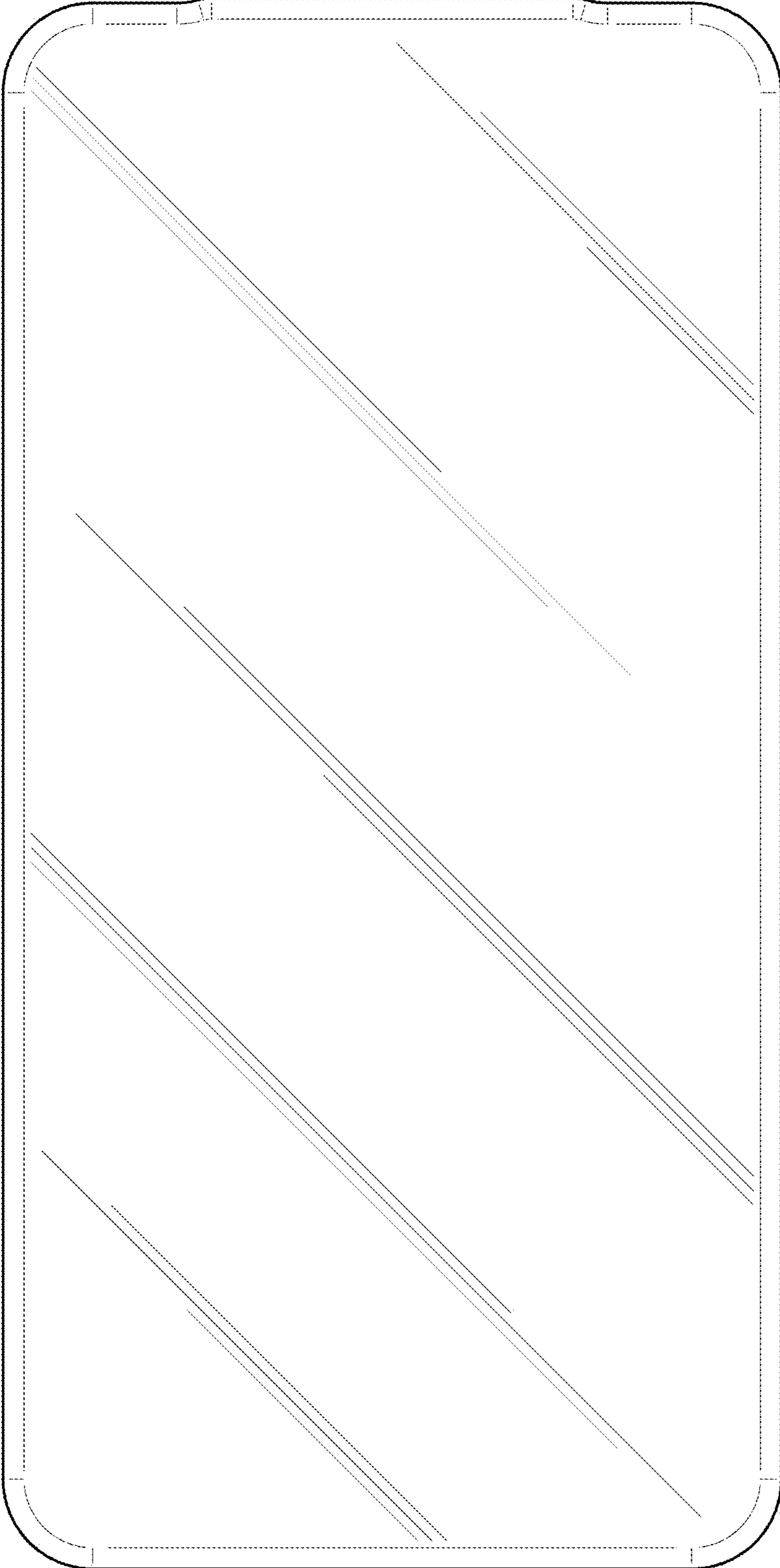

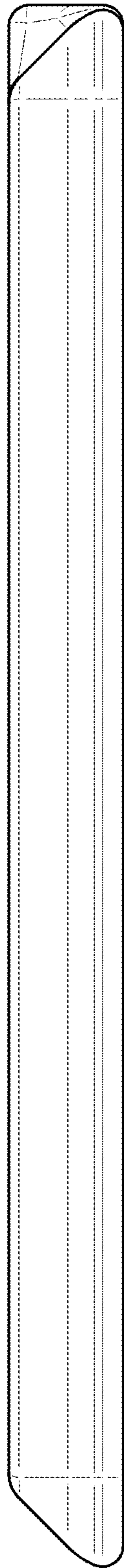

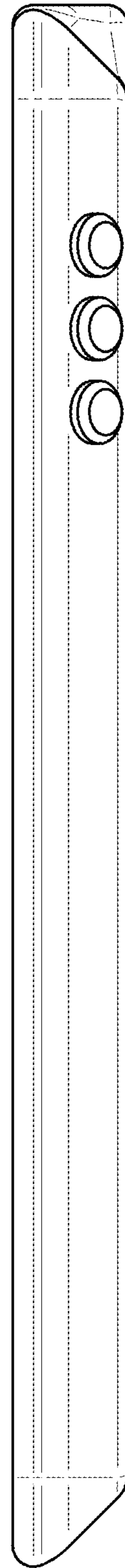

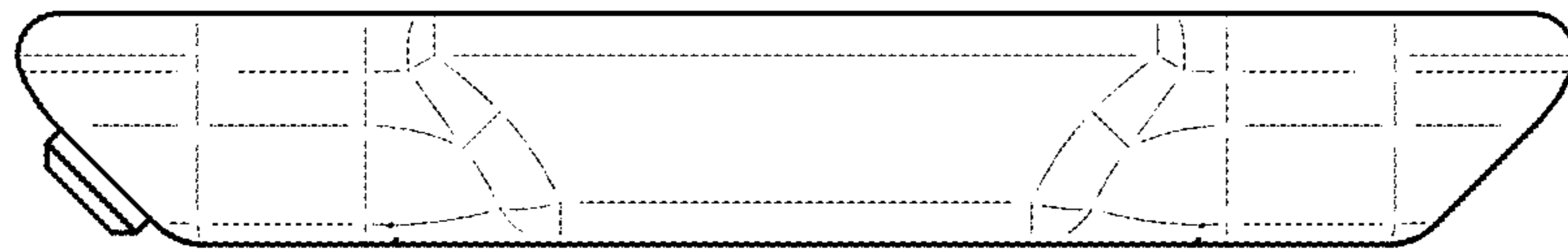

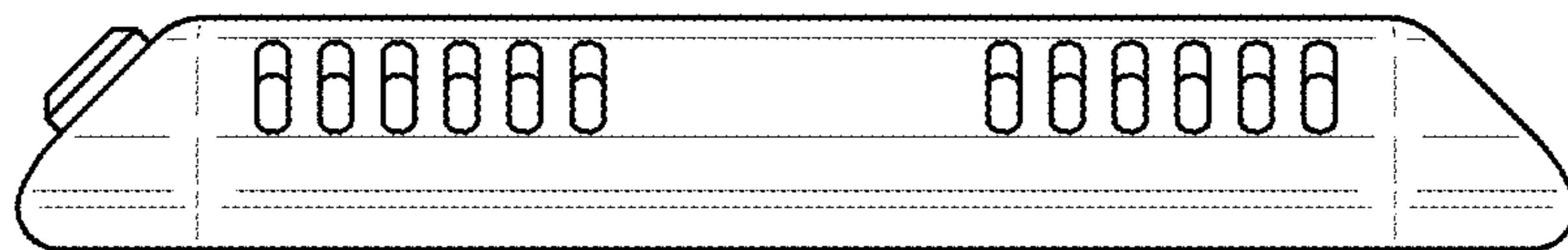

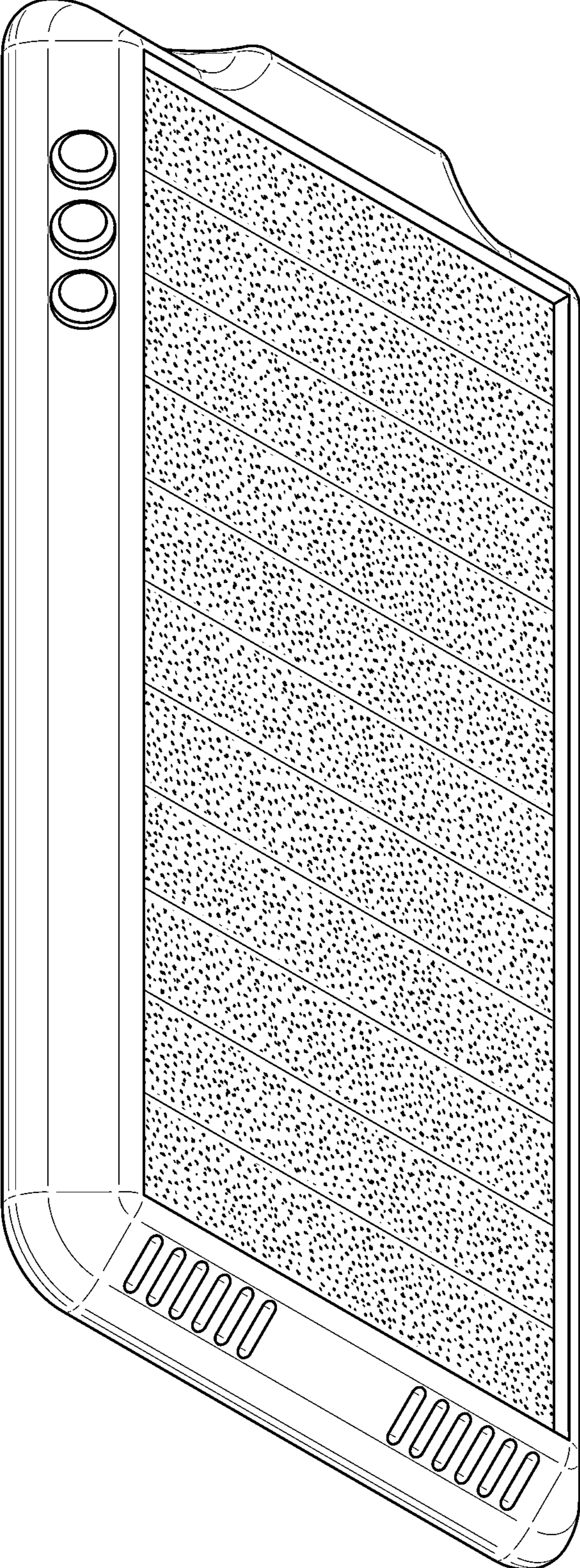
