**DESCRIPTION**

FIG. 1 is a front perspective view of tablet computer showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is an enlarged view thereof, taken from portion 8 in FIG. 1;

FIG. 9 is an enlarged view thereof, taken from portion 9 in FIG. 1;

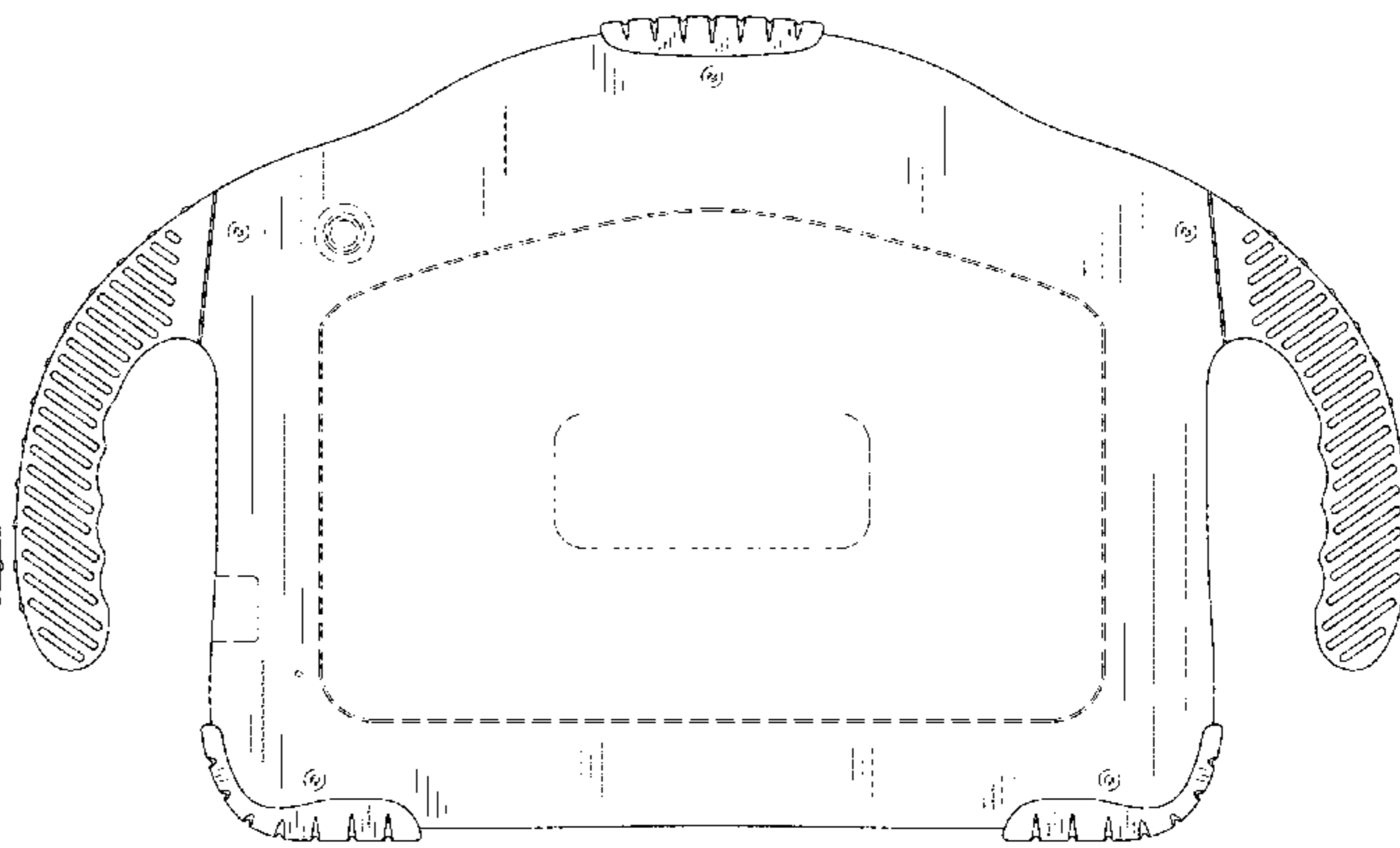
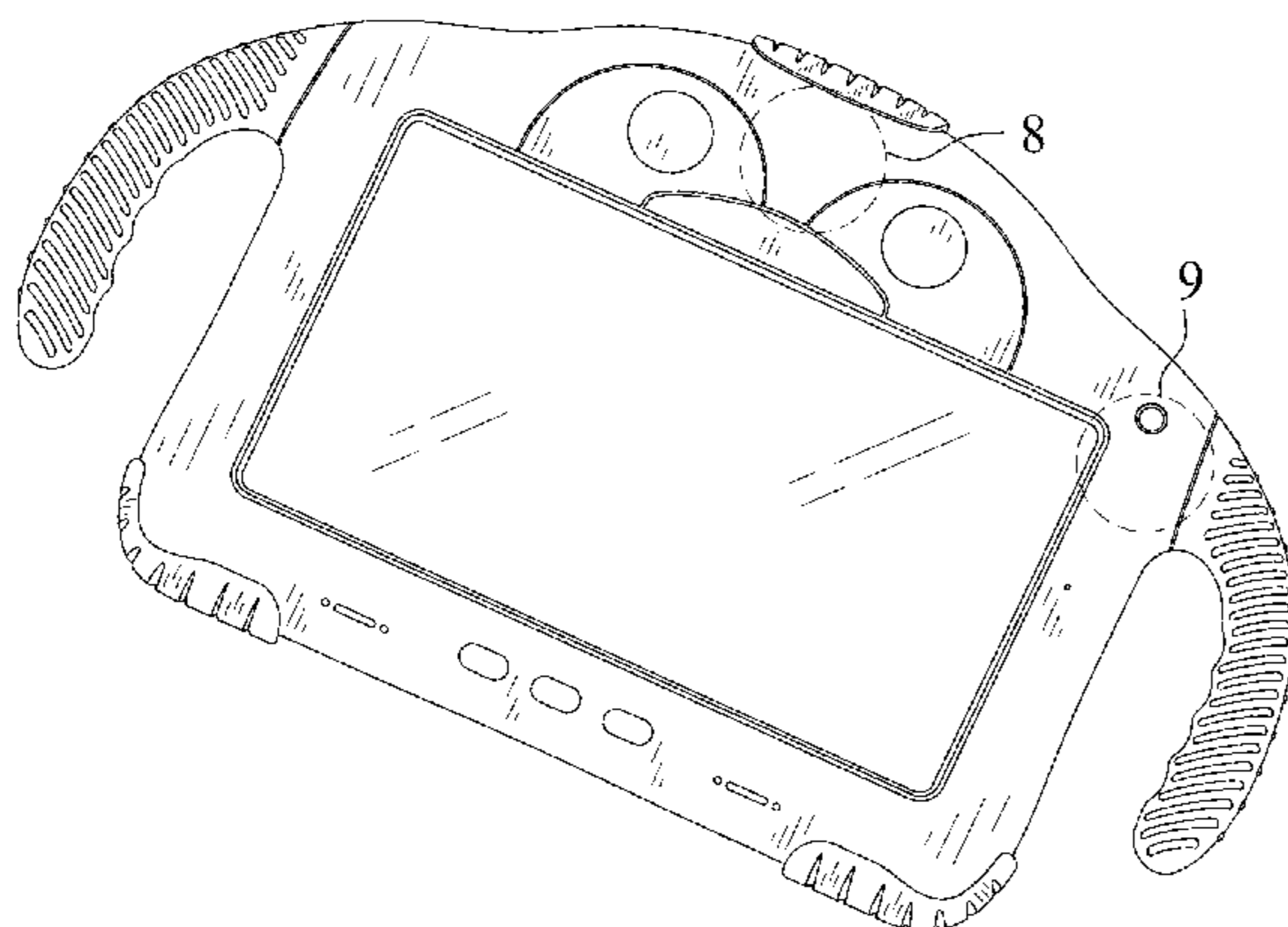
FIG. 10 is an enlarged view thereof, taken from portion 10 in FIG. 4;

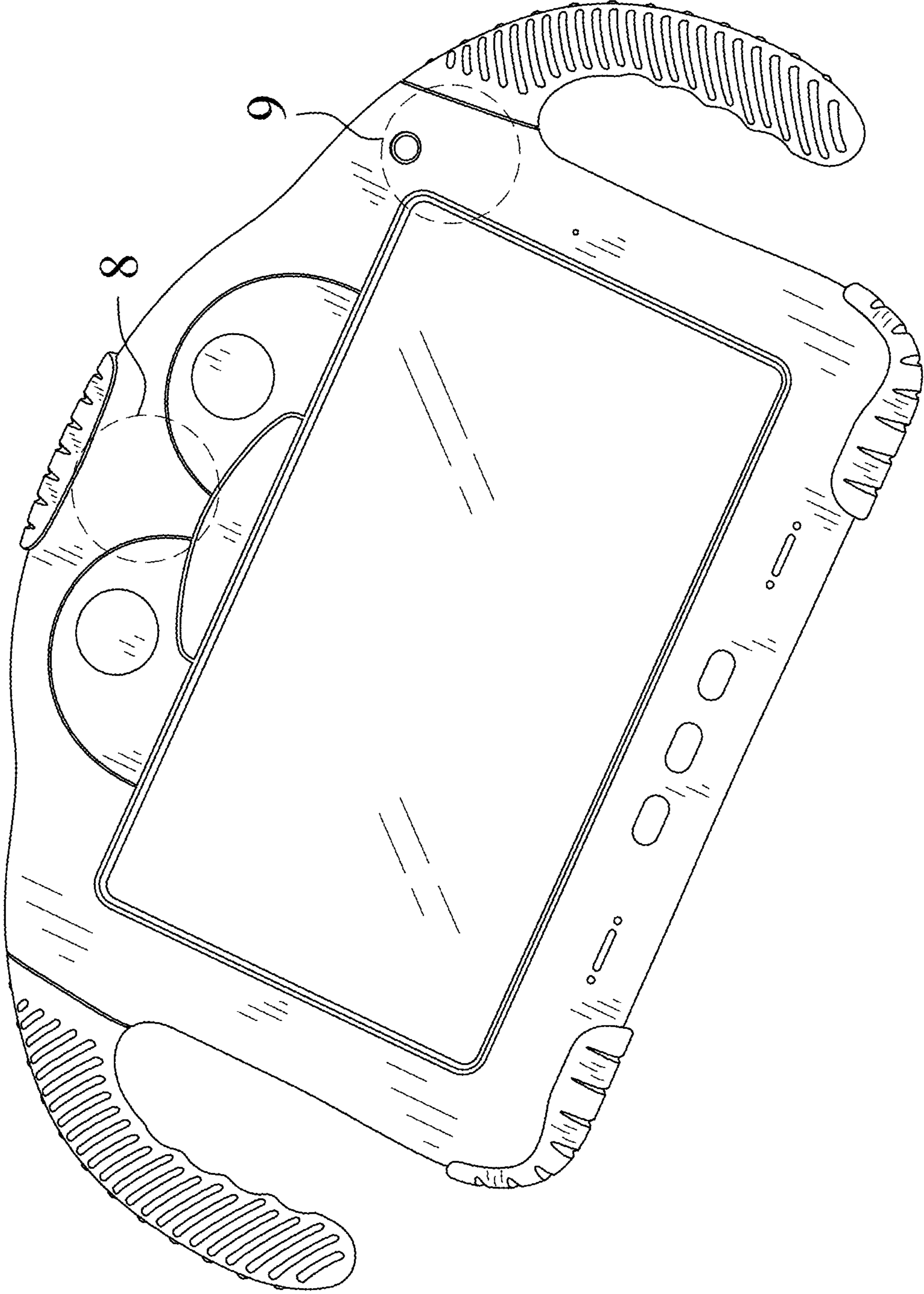

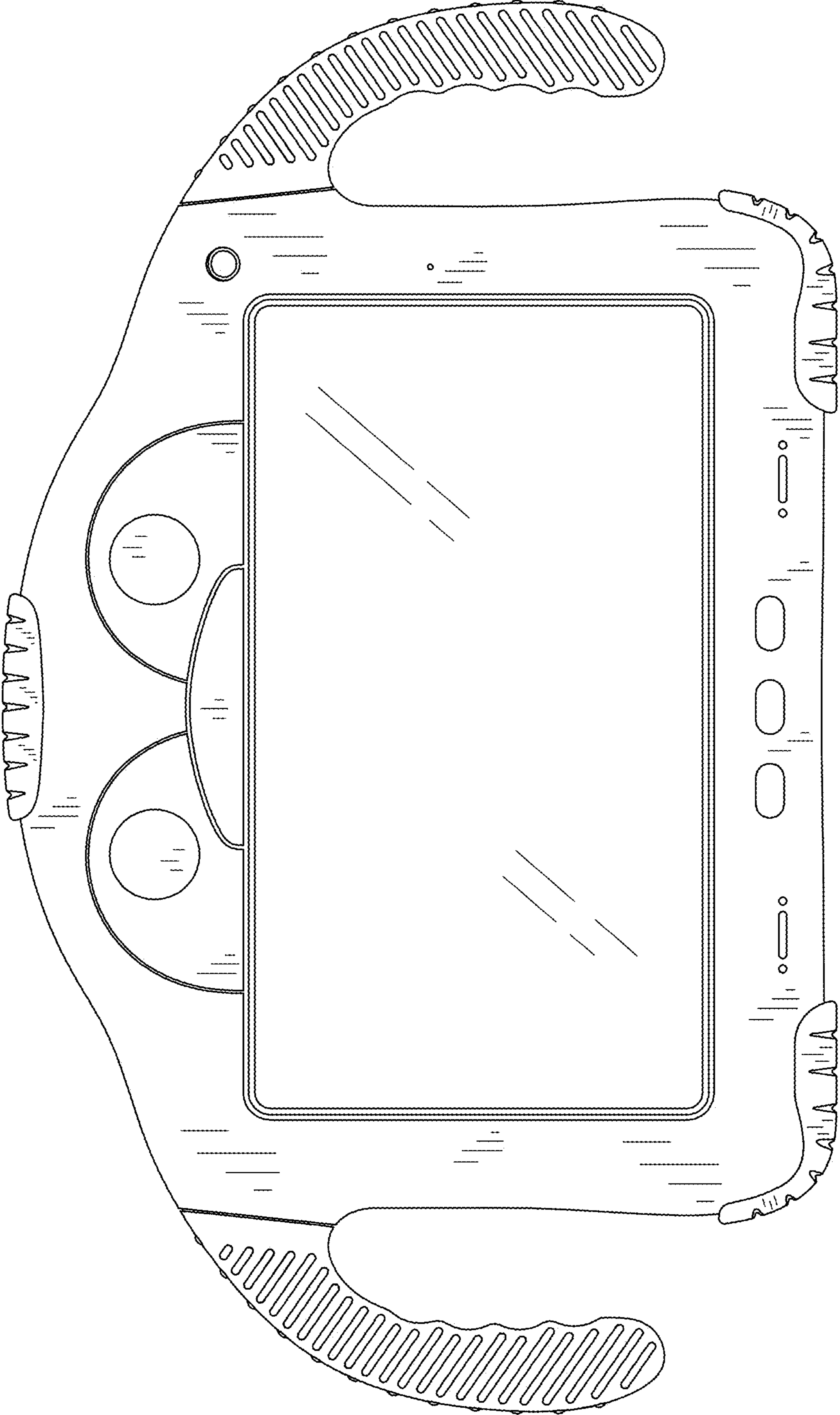

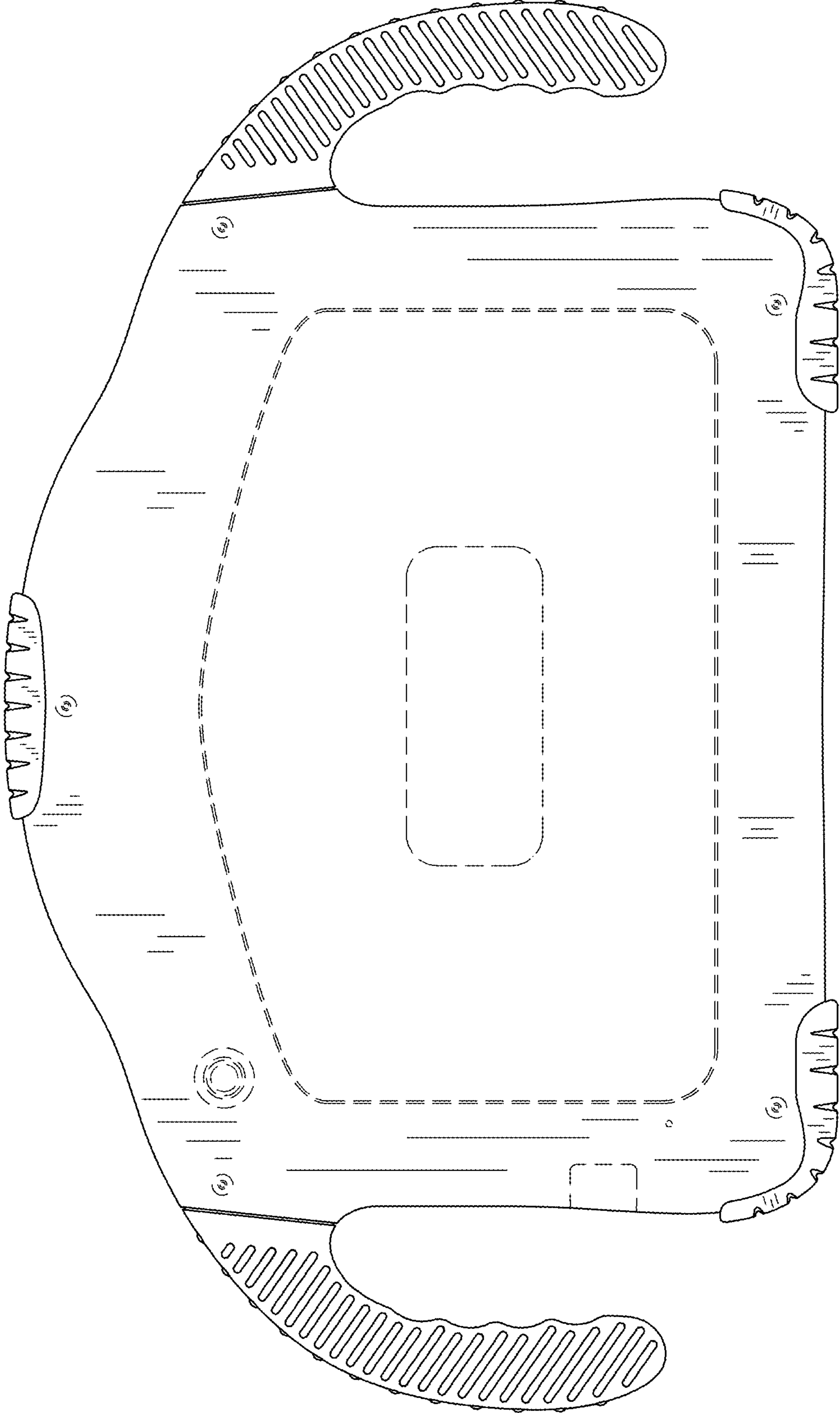

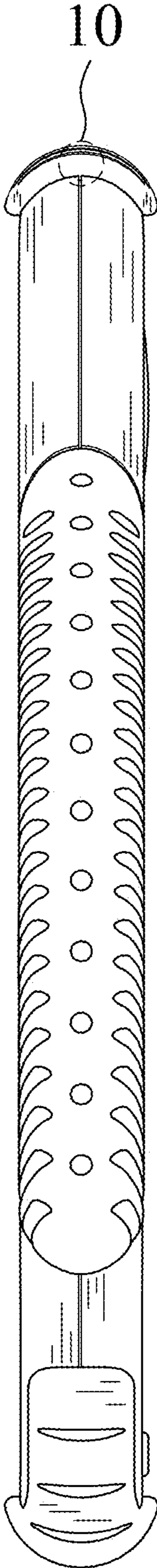

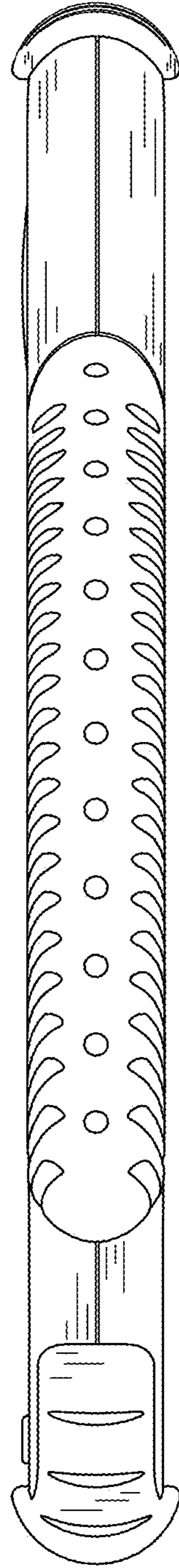

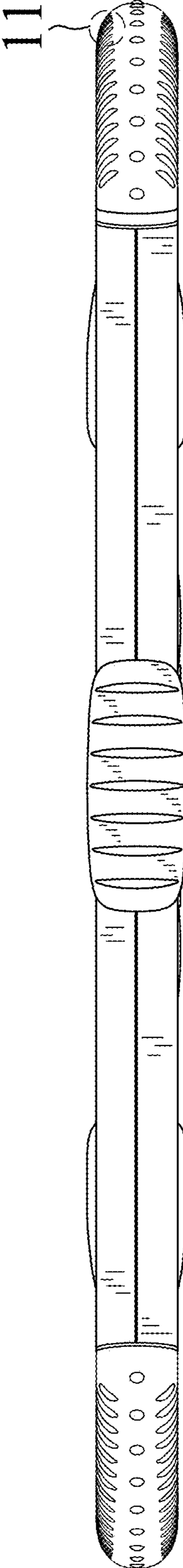

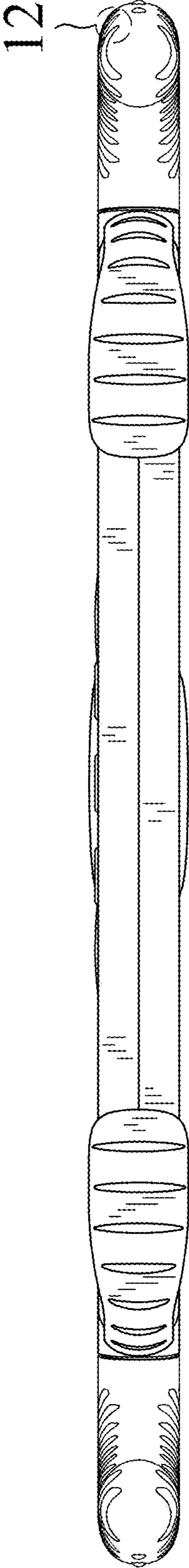

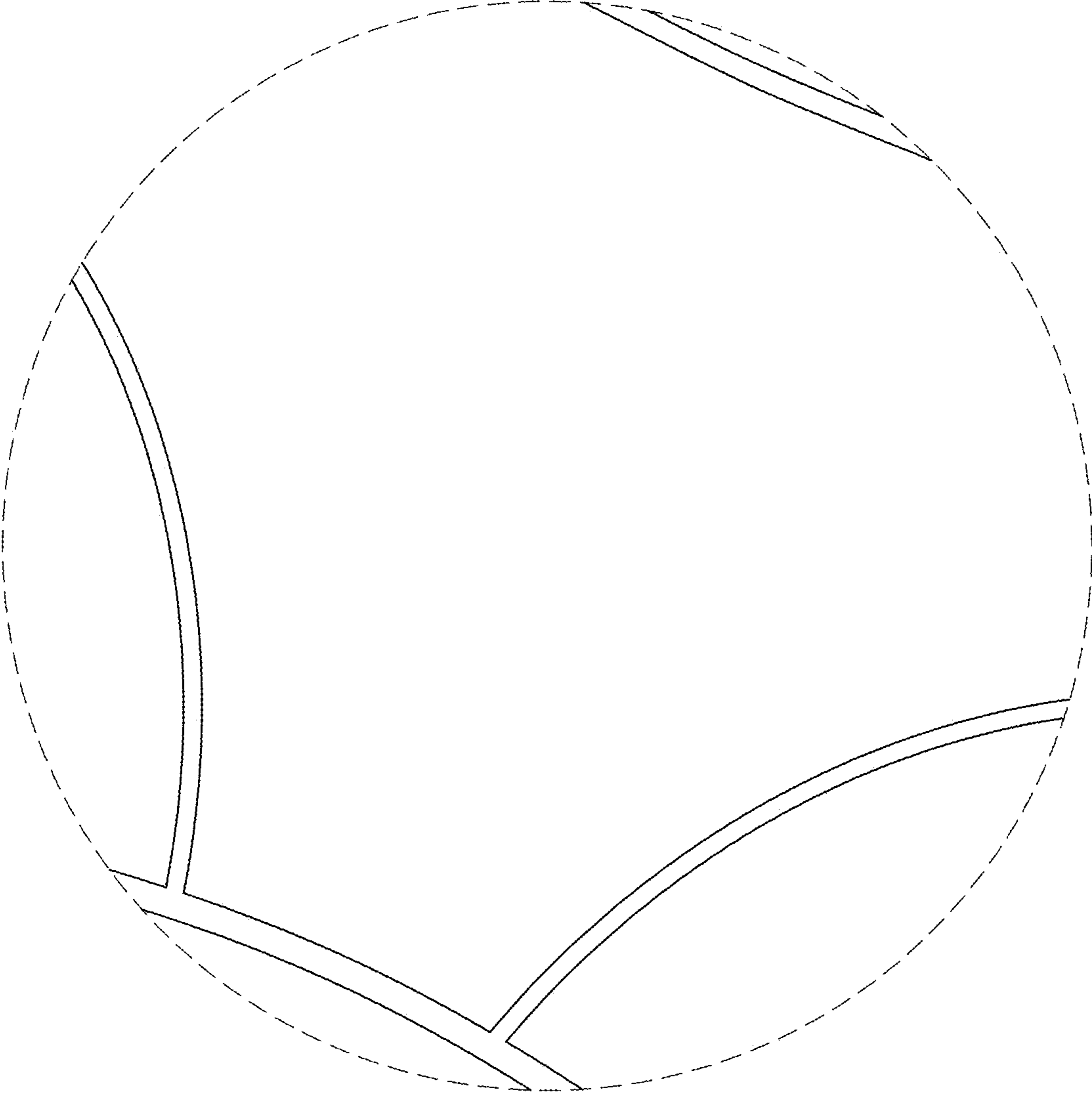

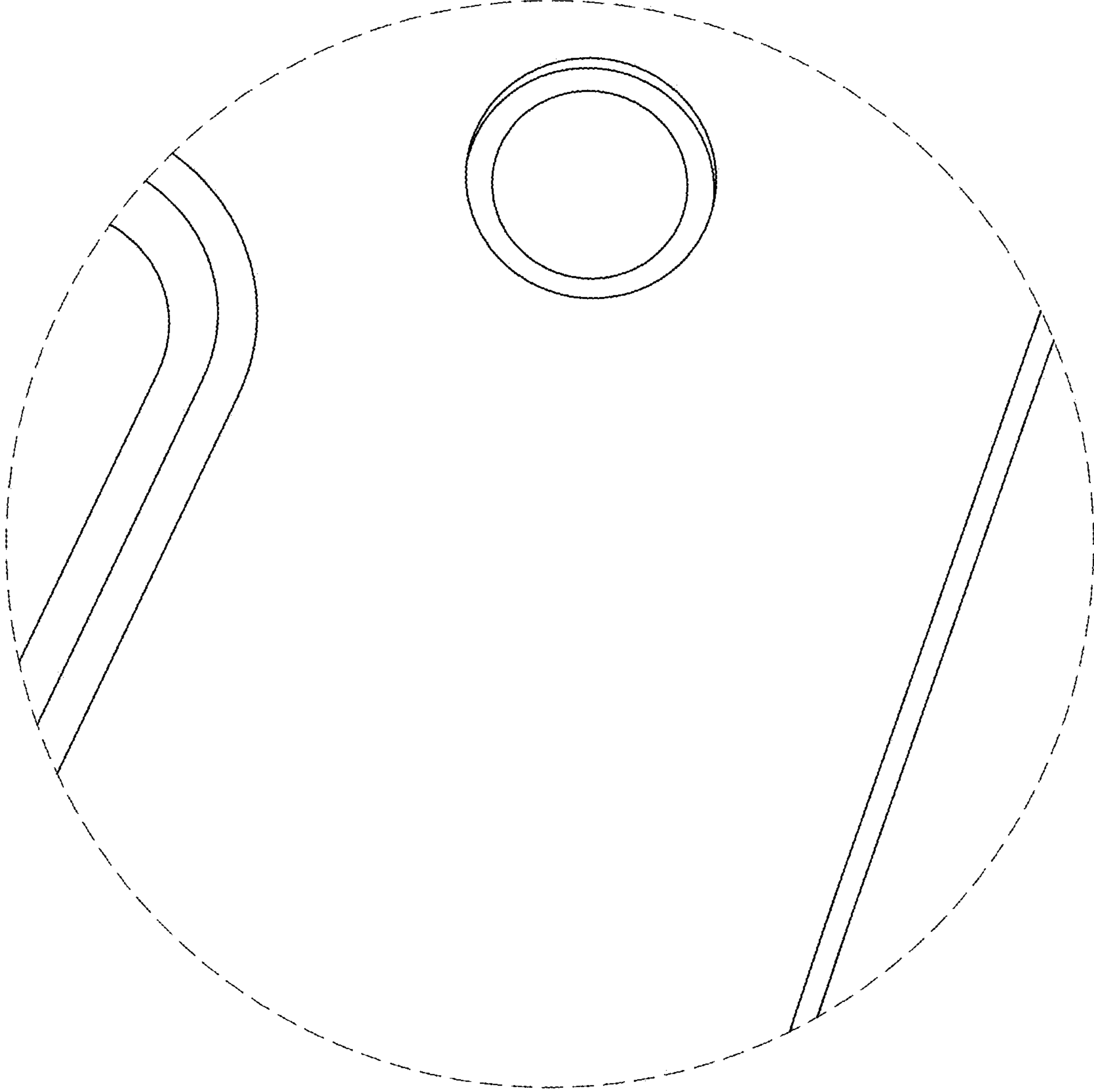

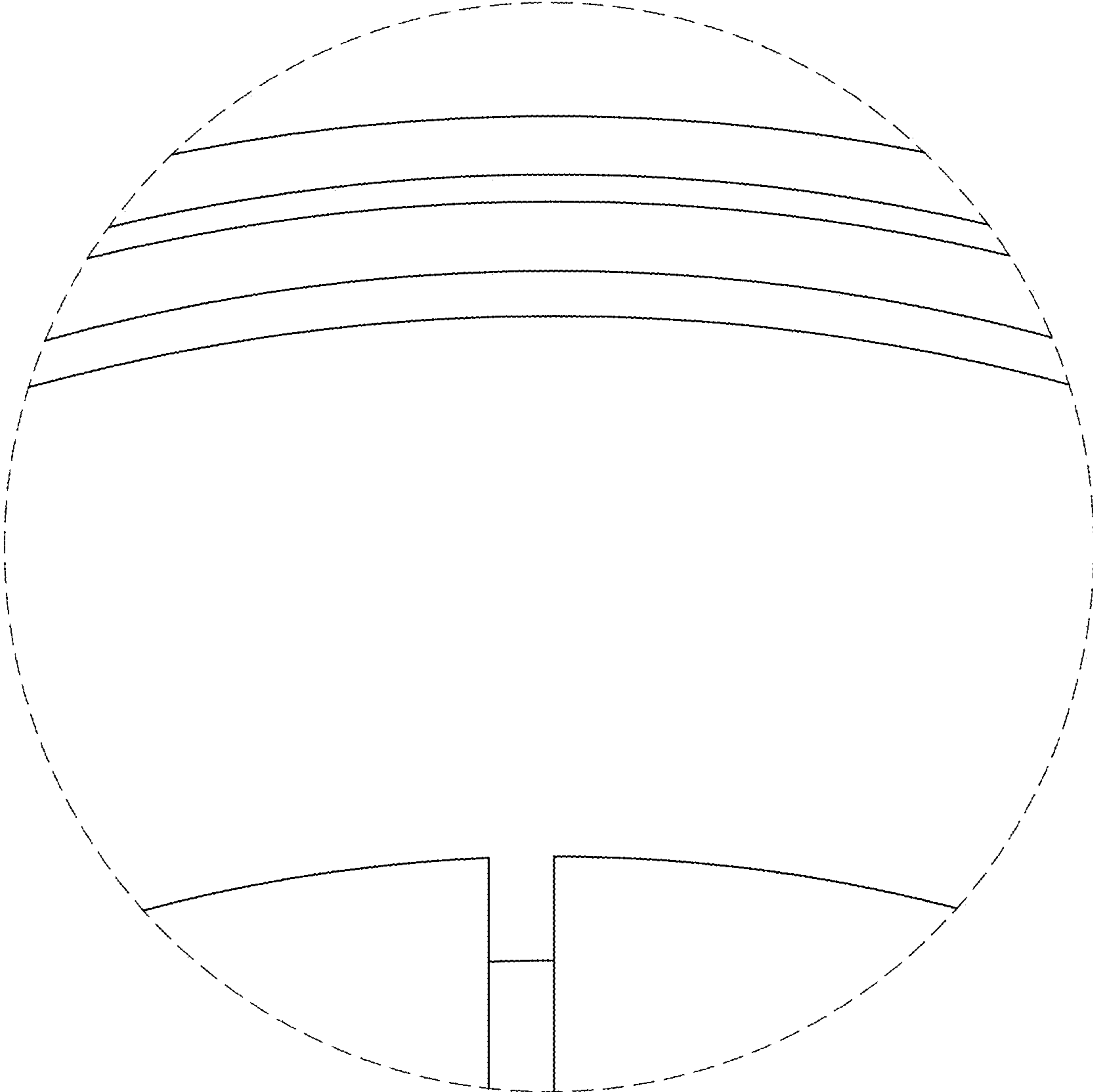

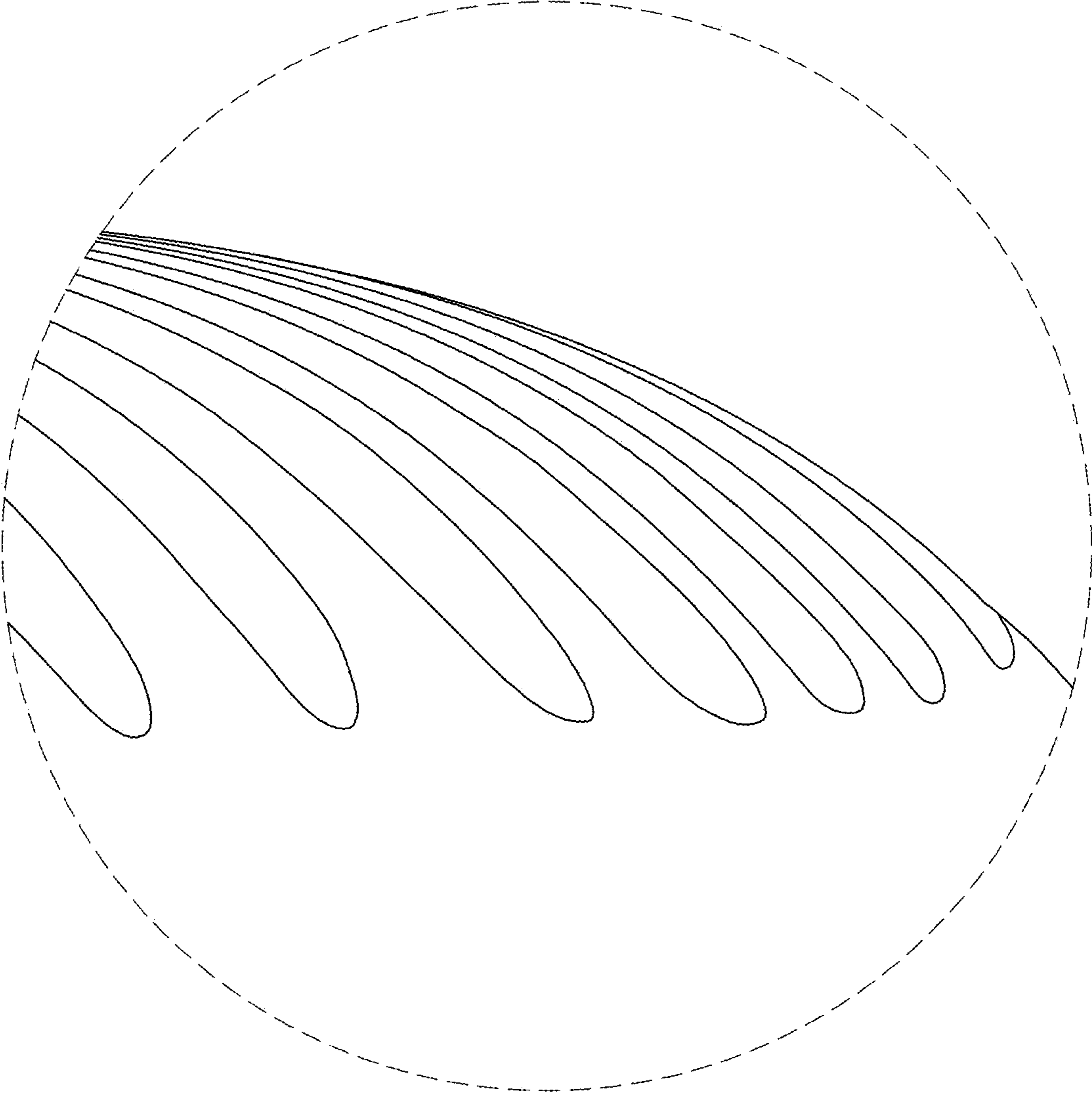

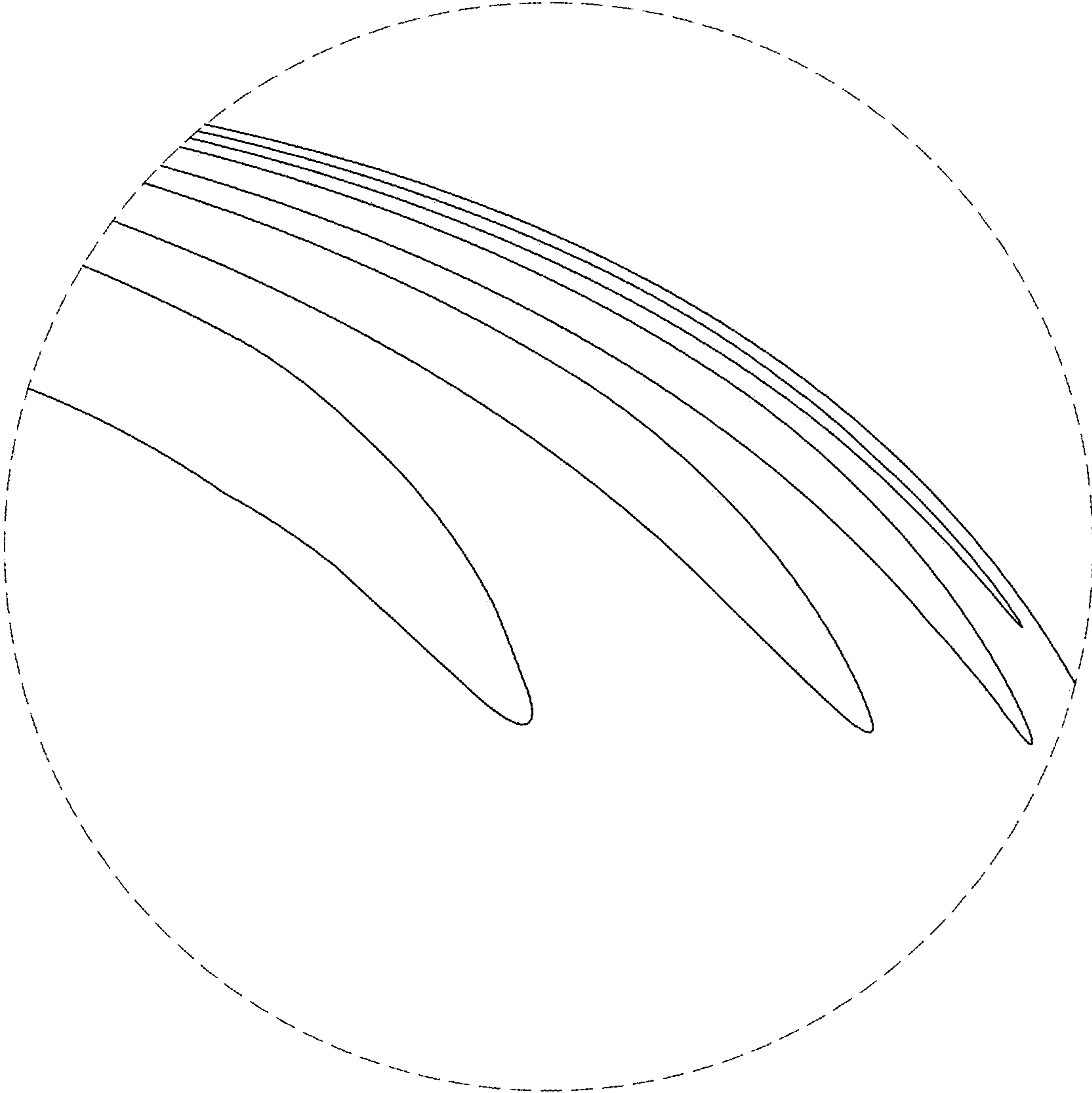
