The ornamental design for an instrument panel, as shown and described.

**DESCRIPTION**

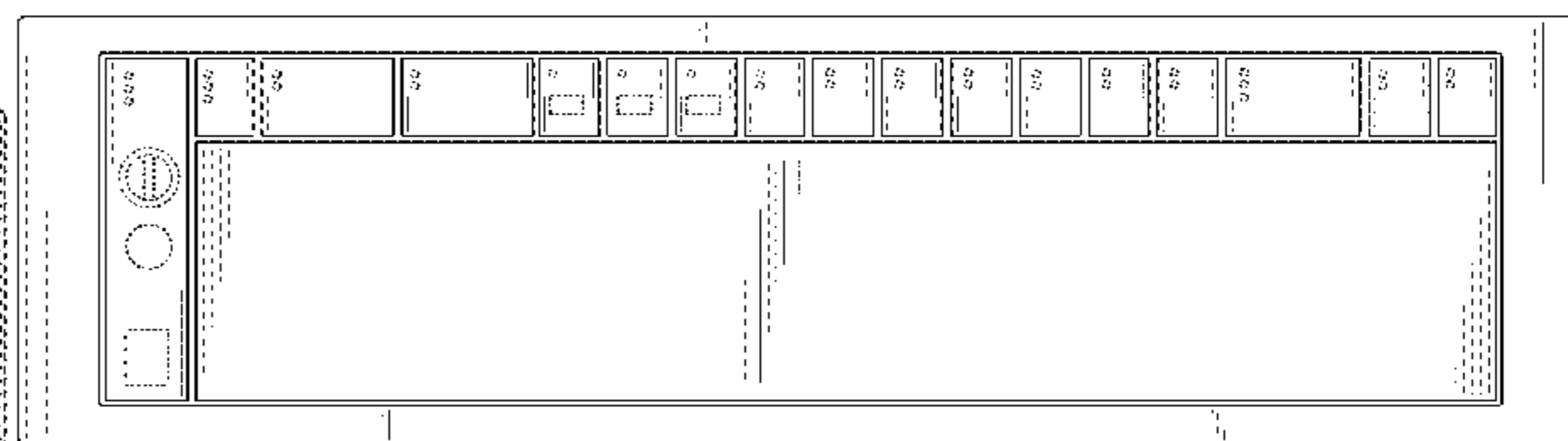
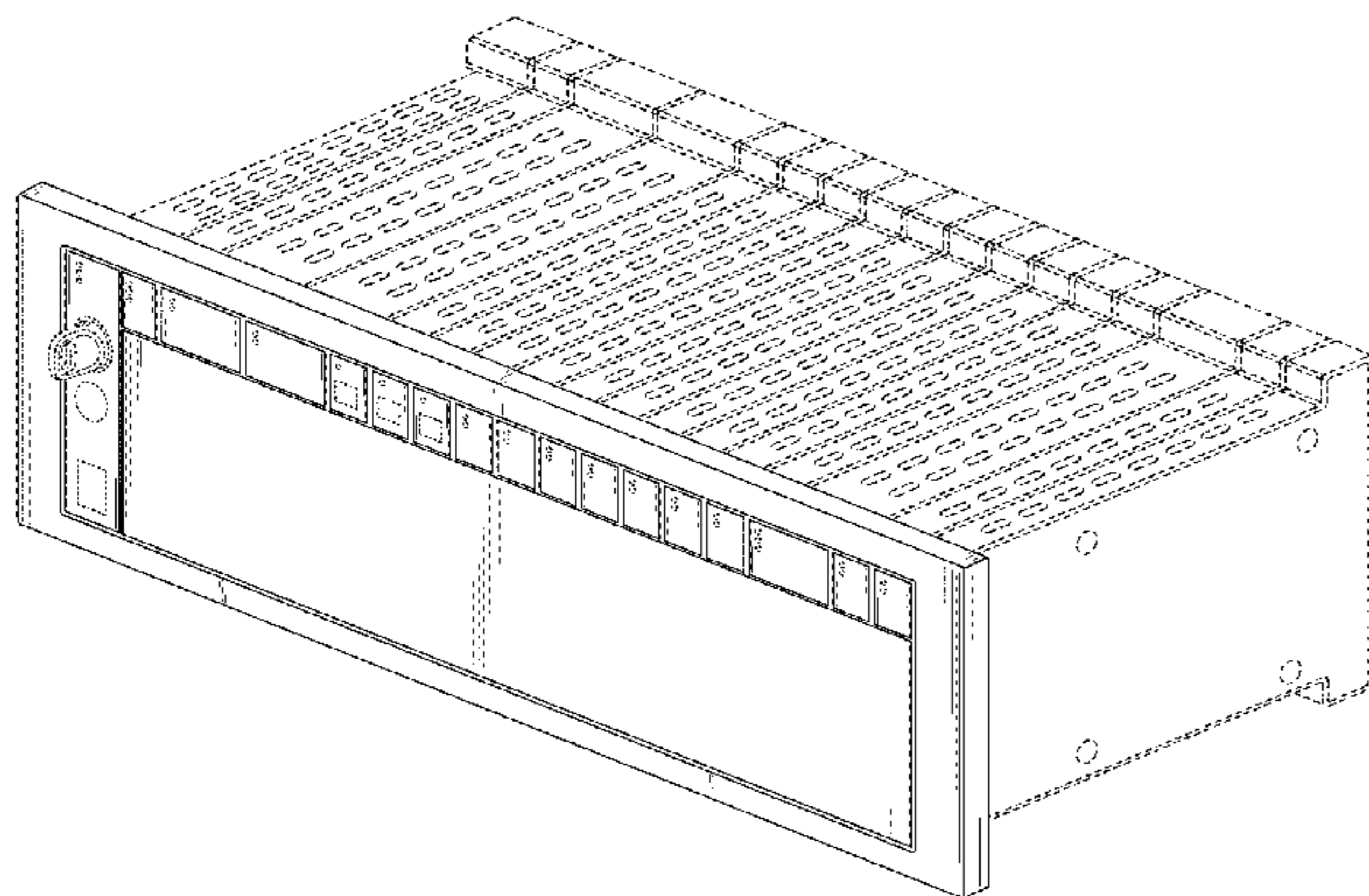

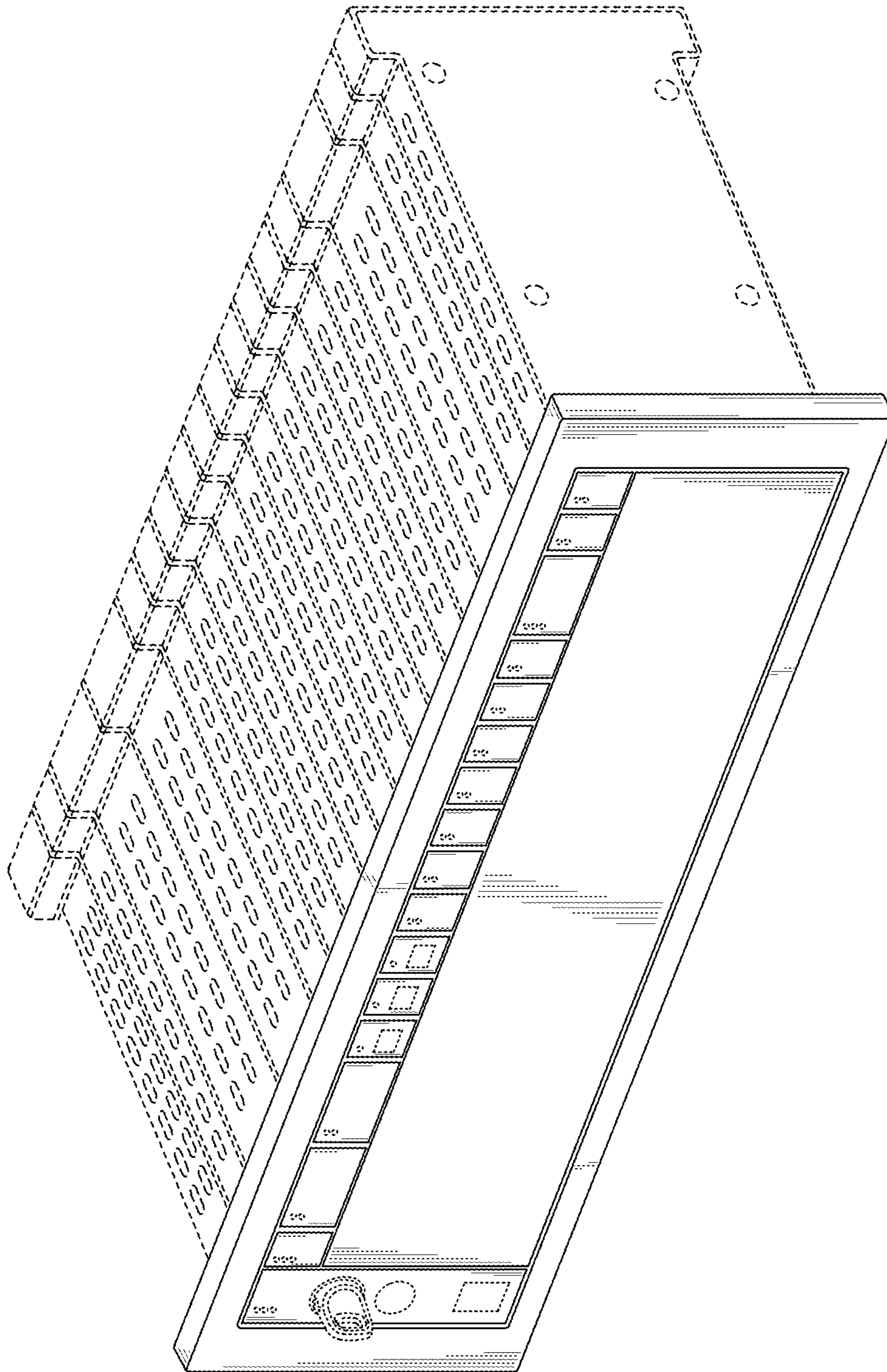

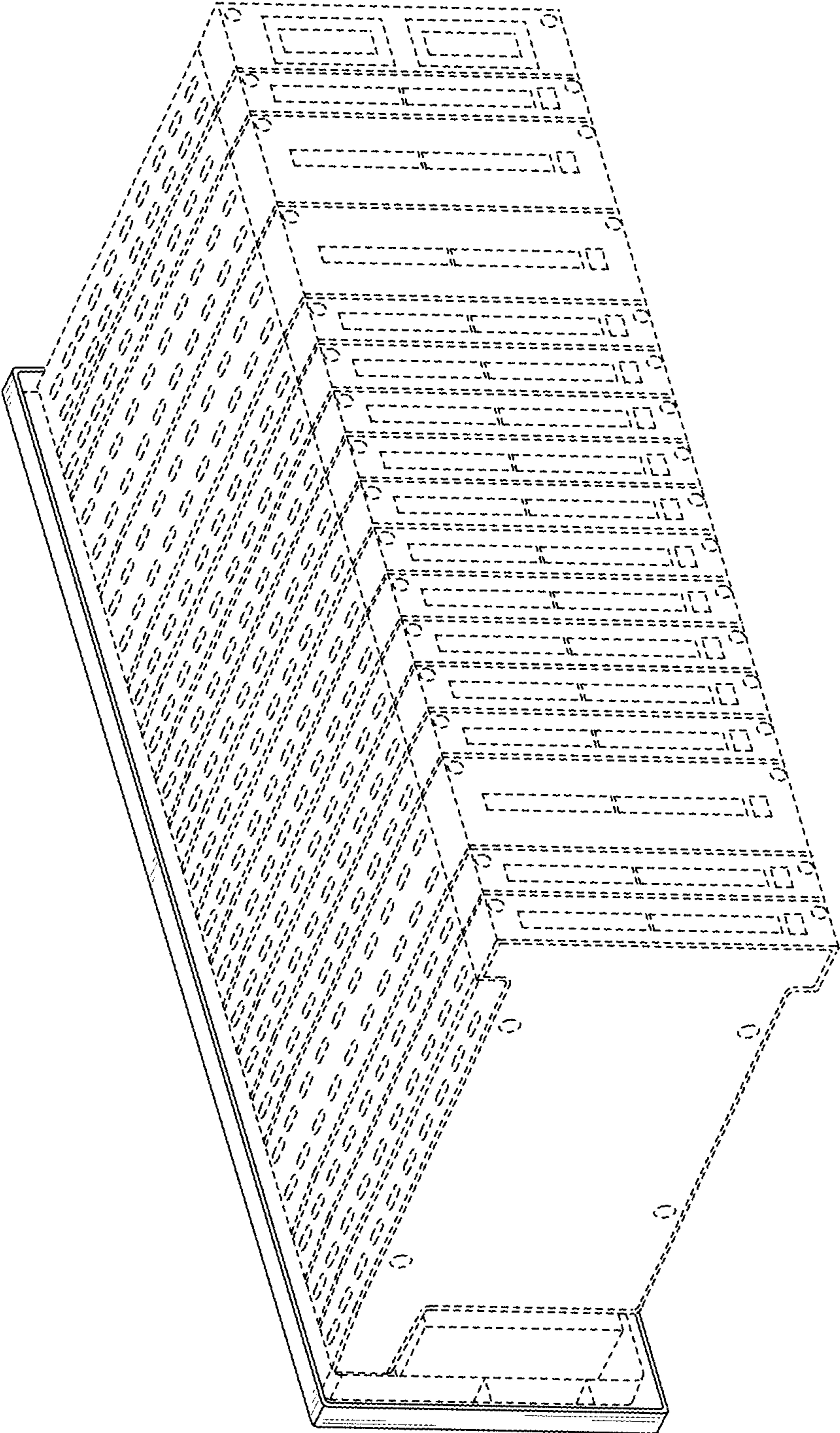

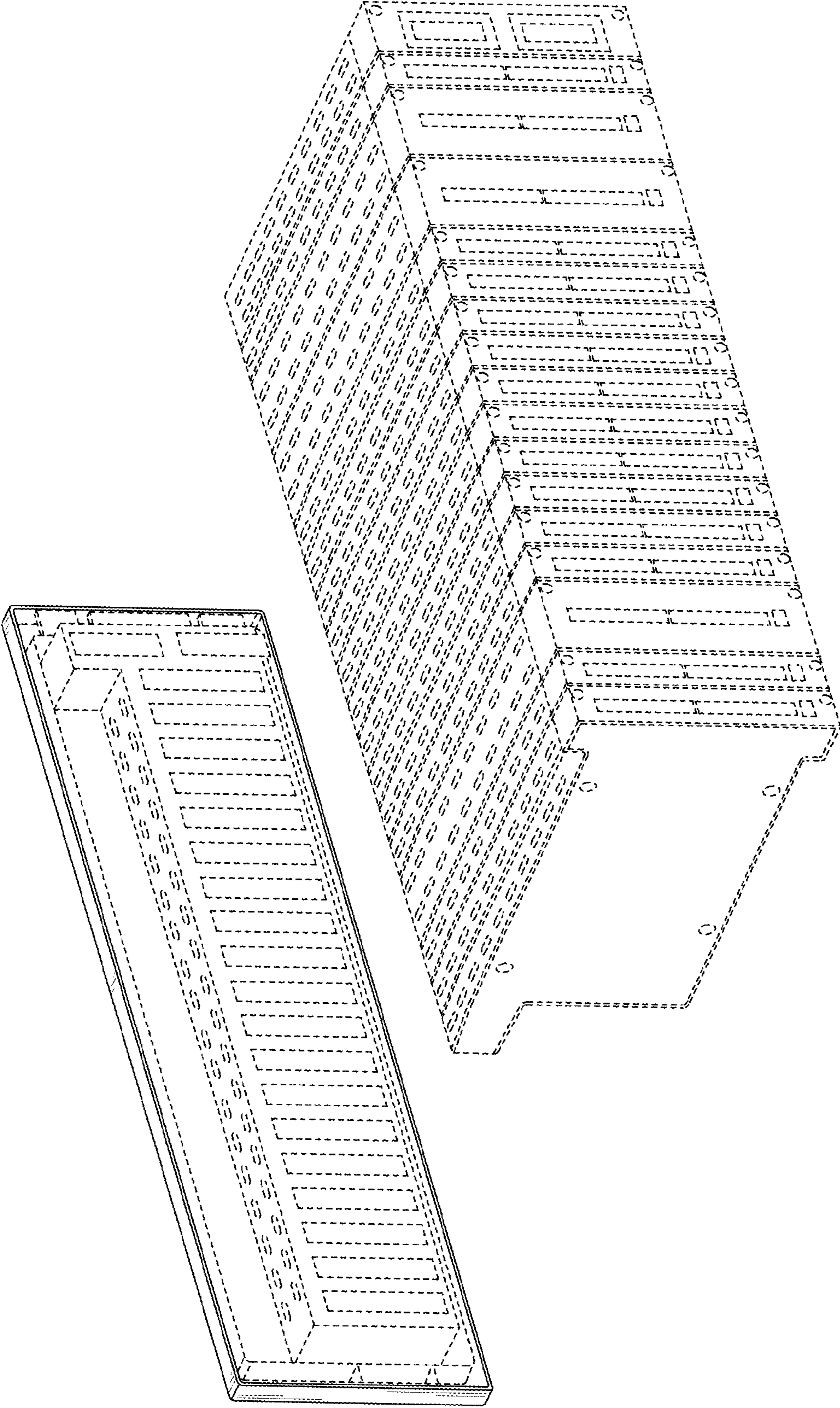

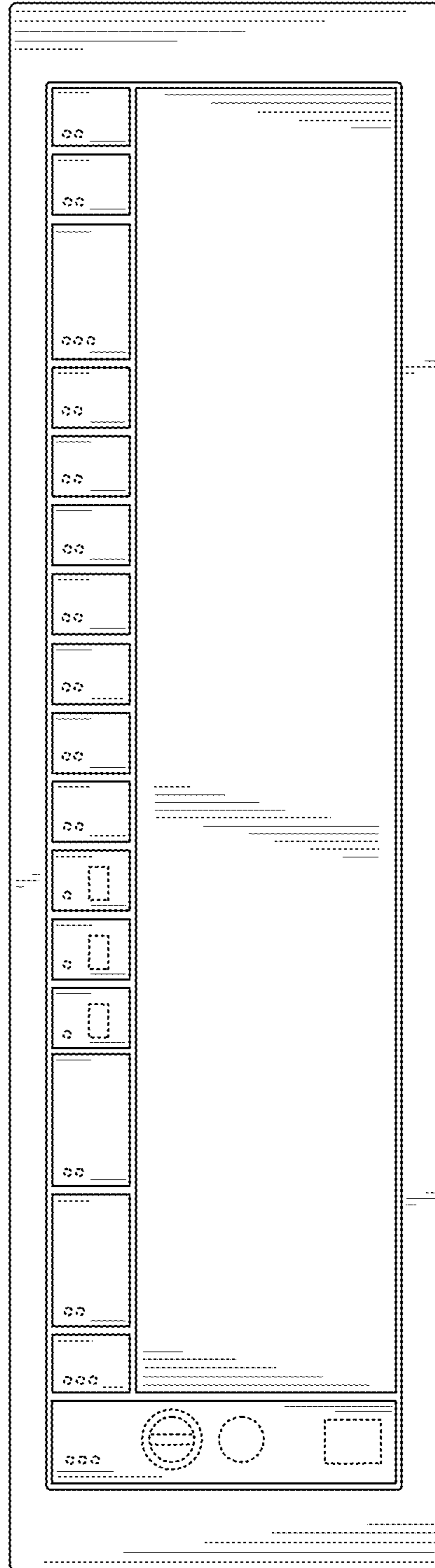

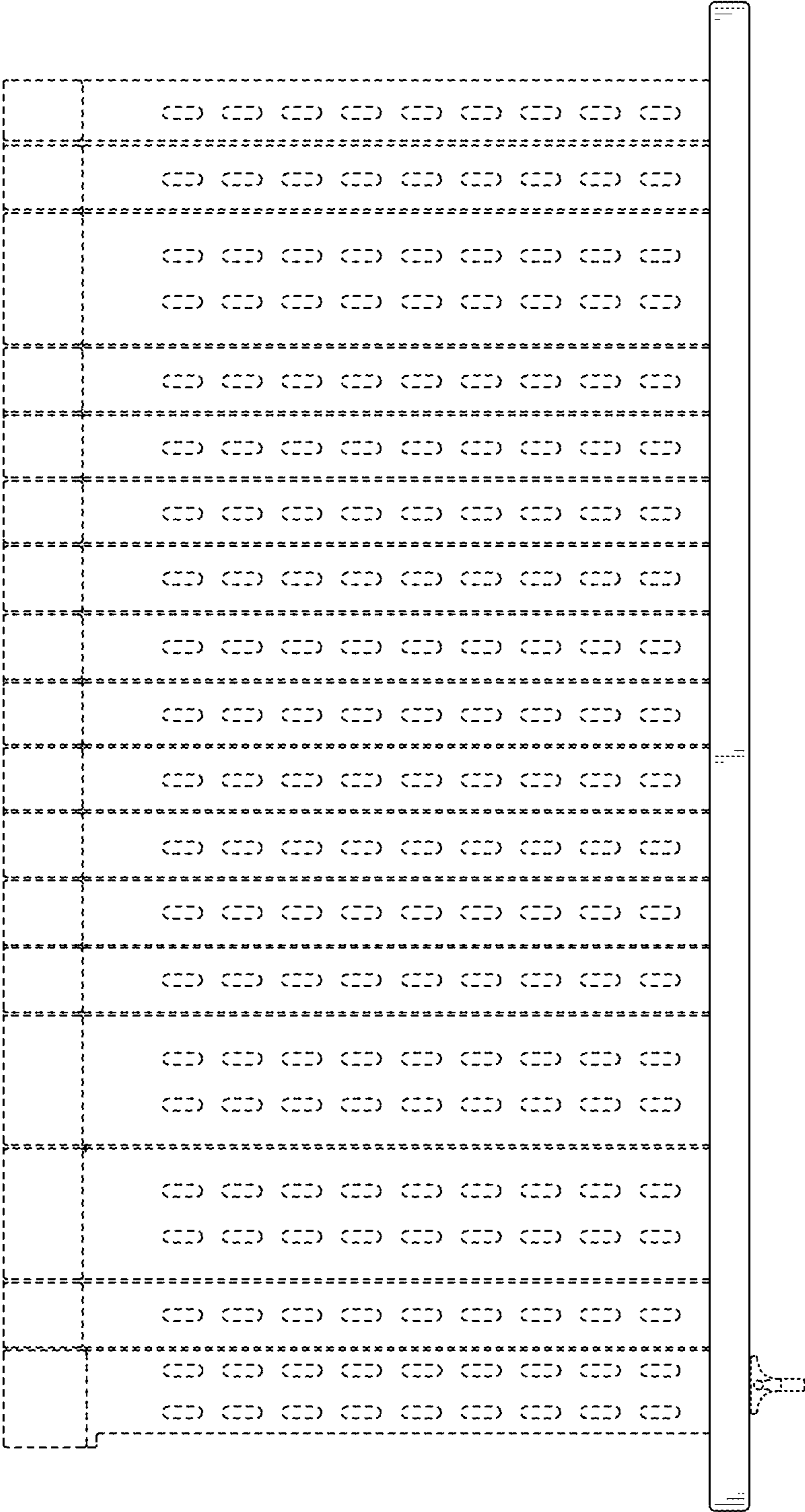

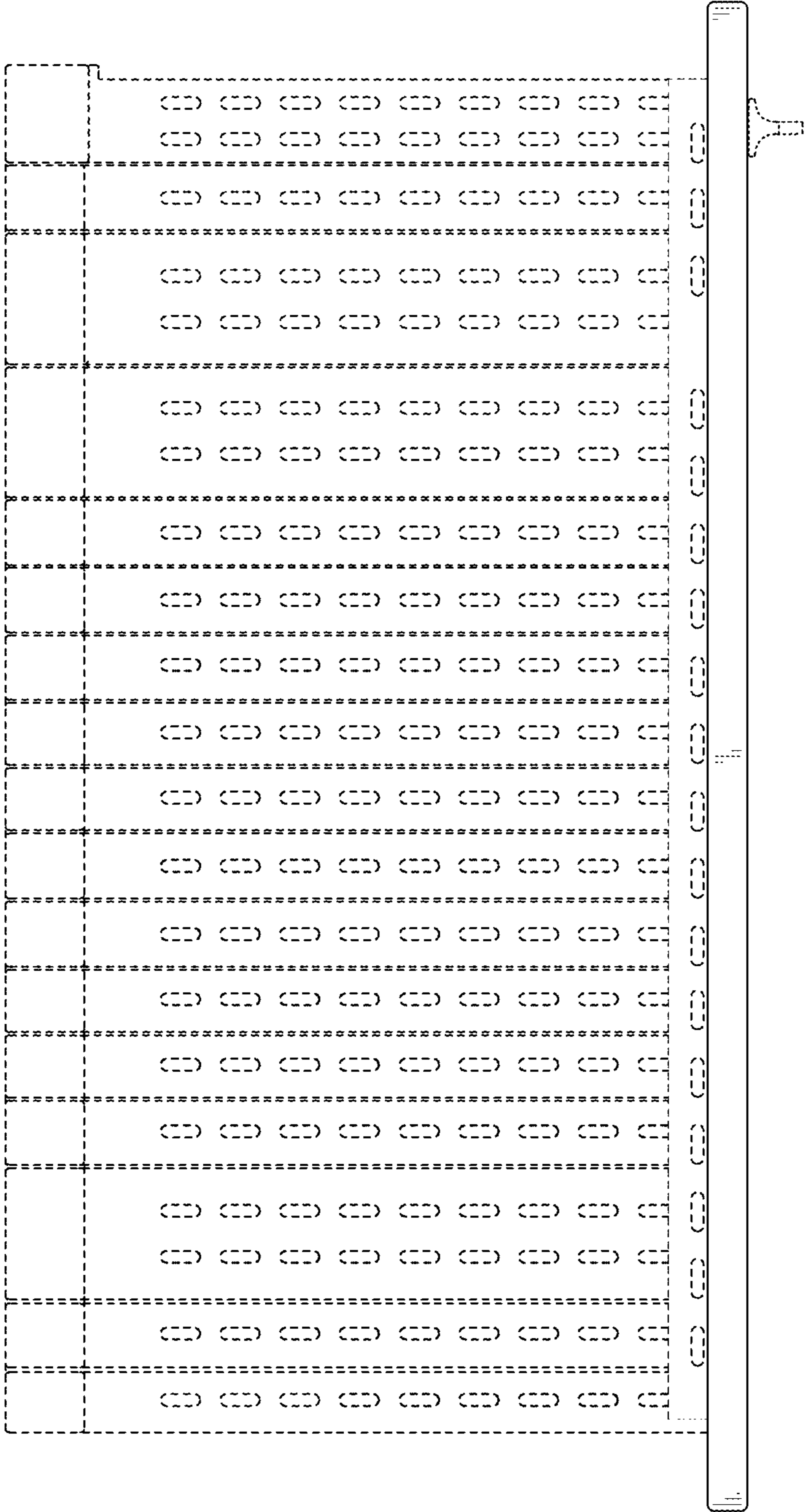

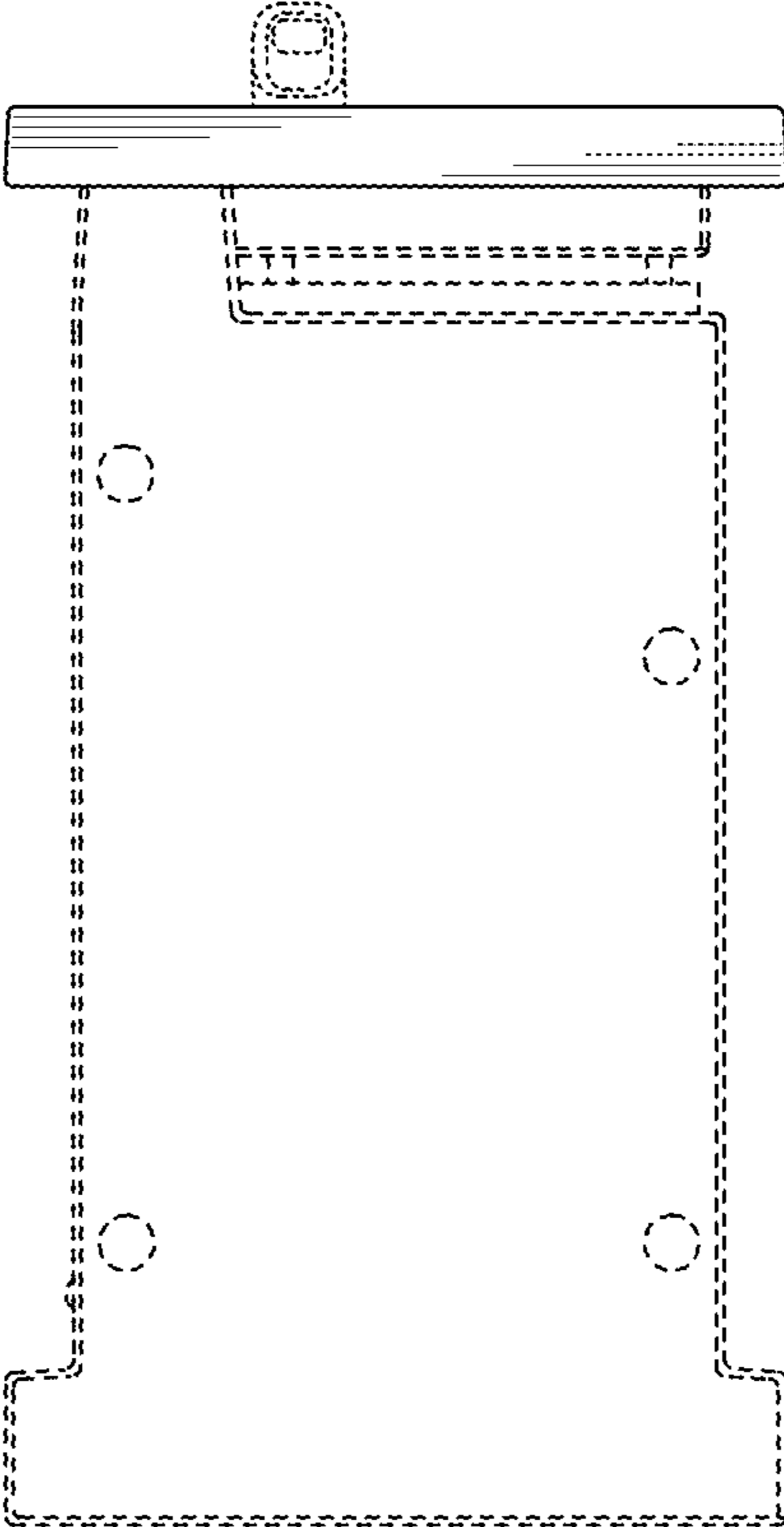

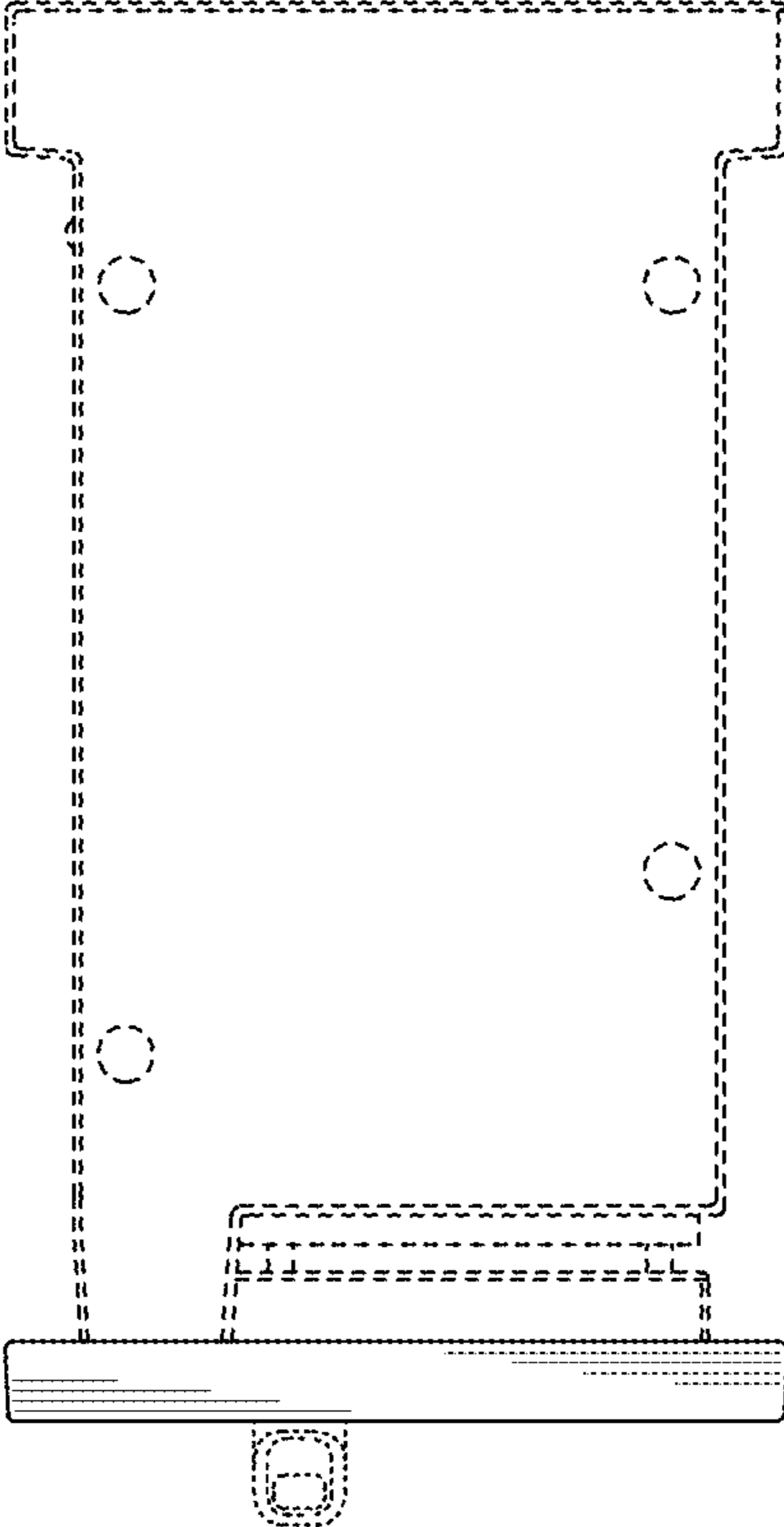

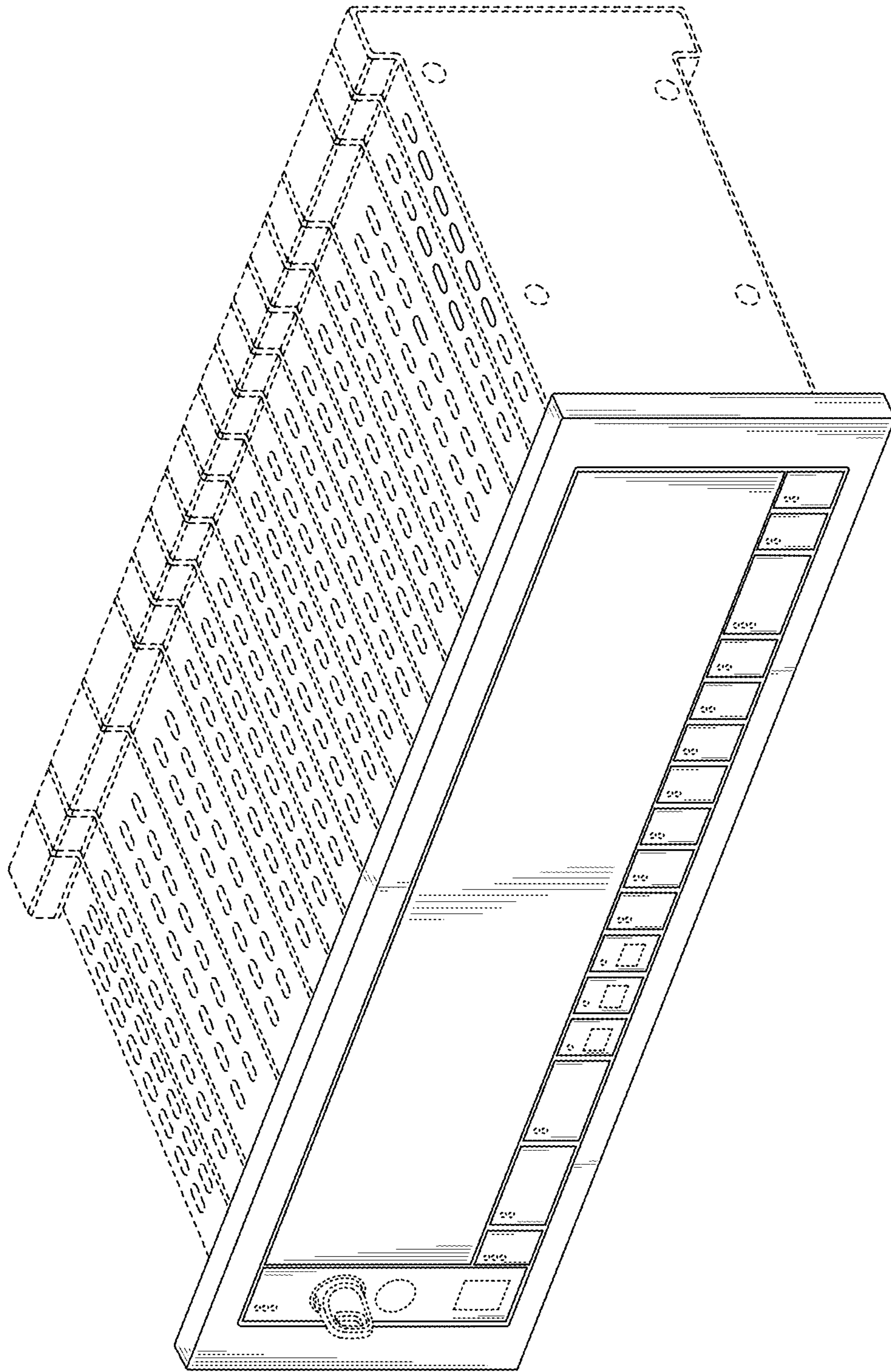

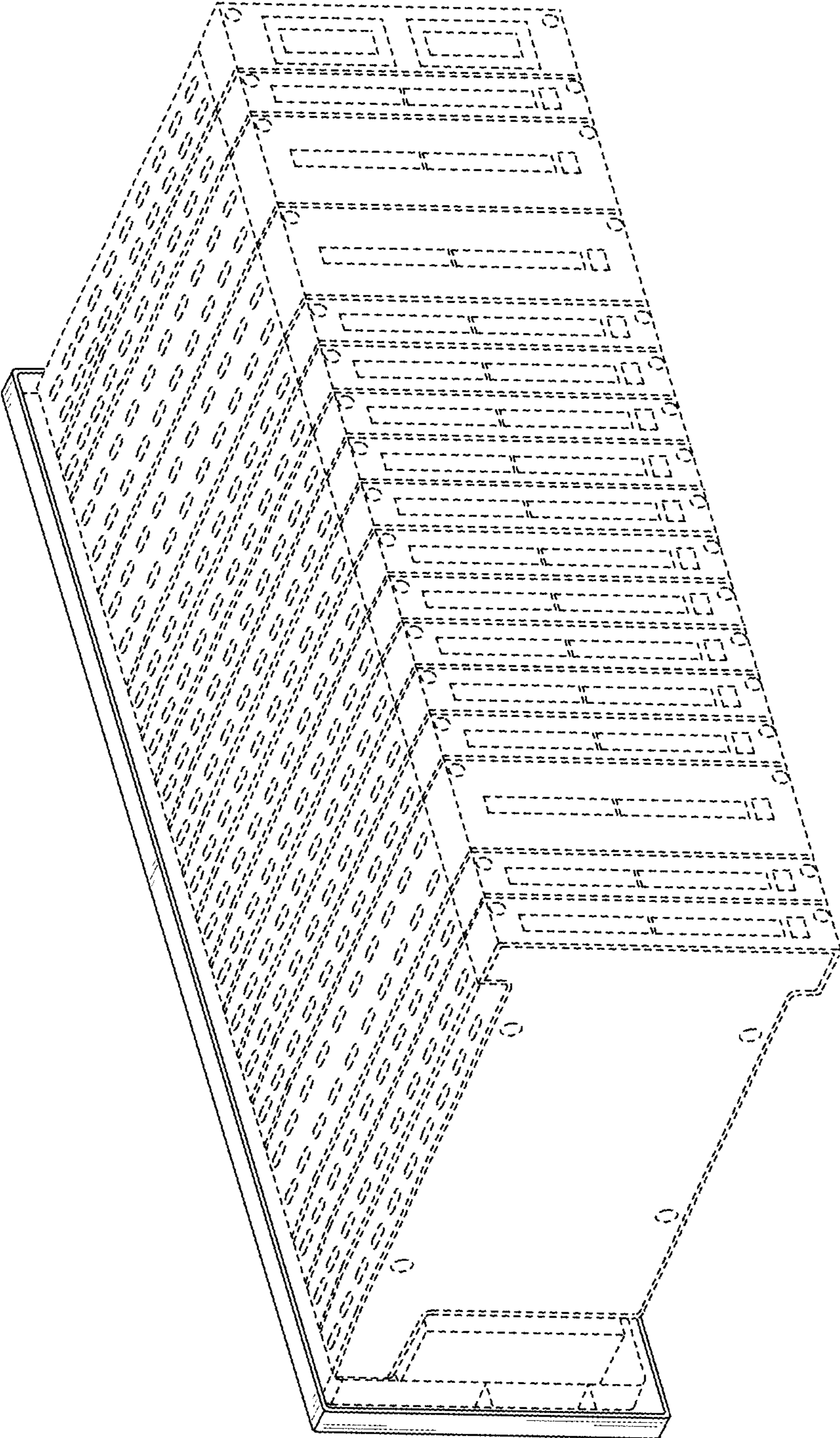

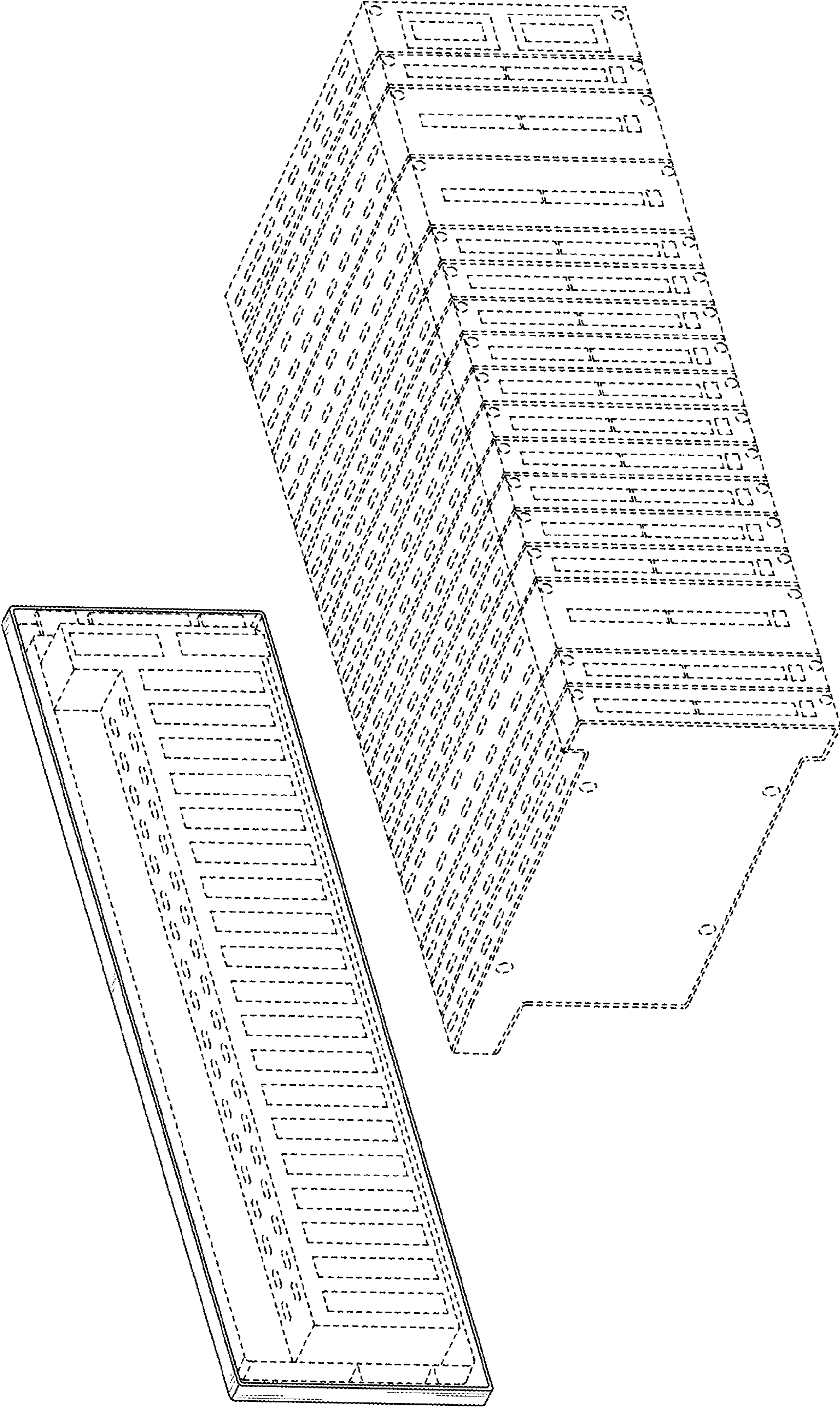

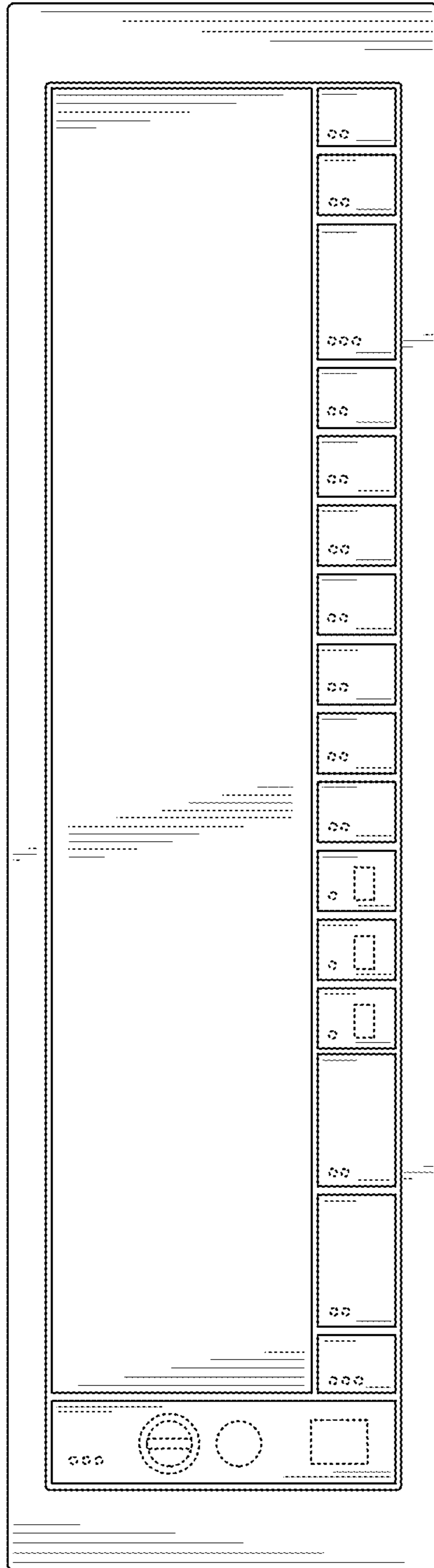

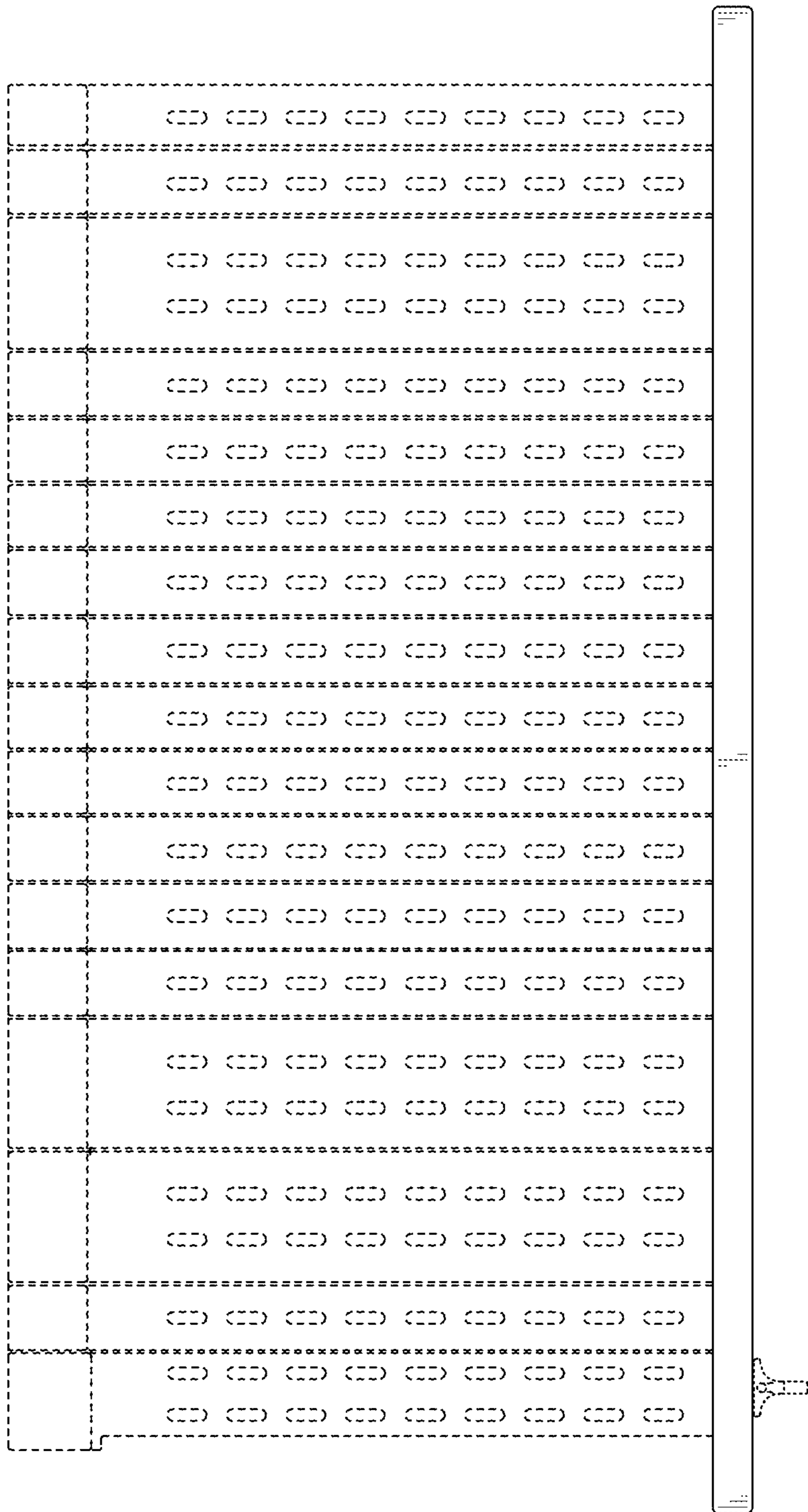

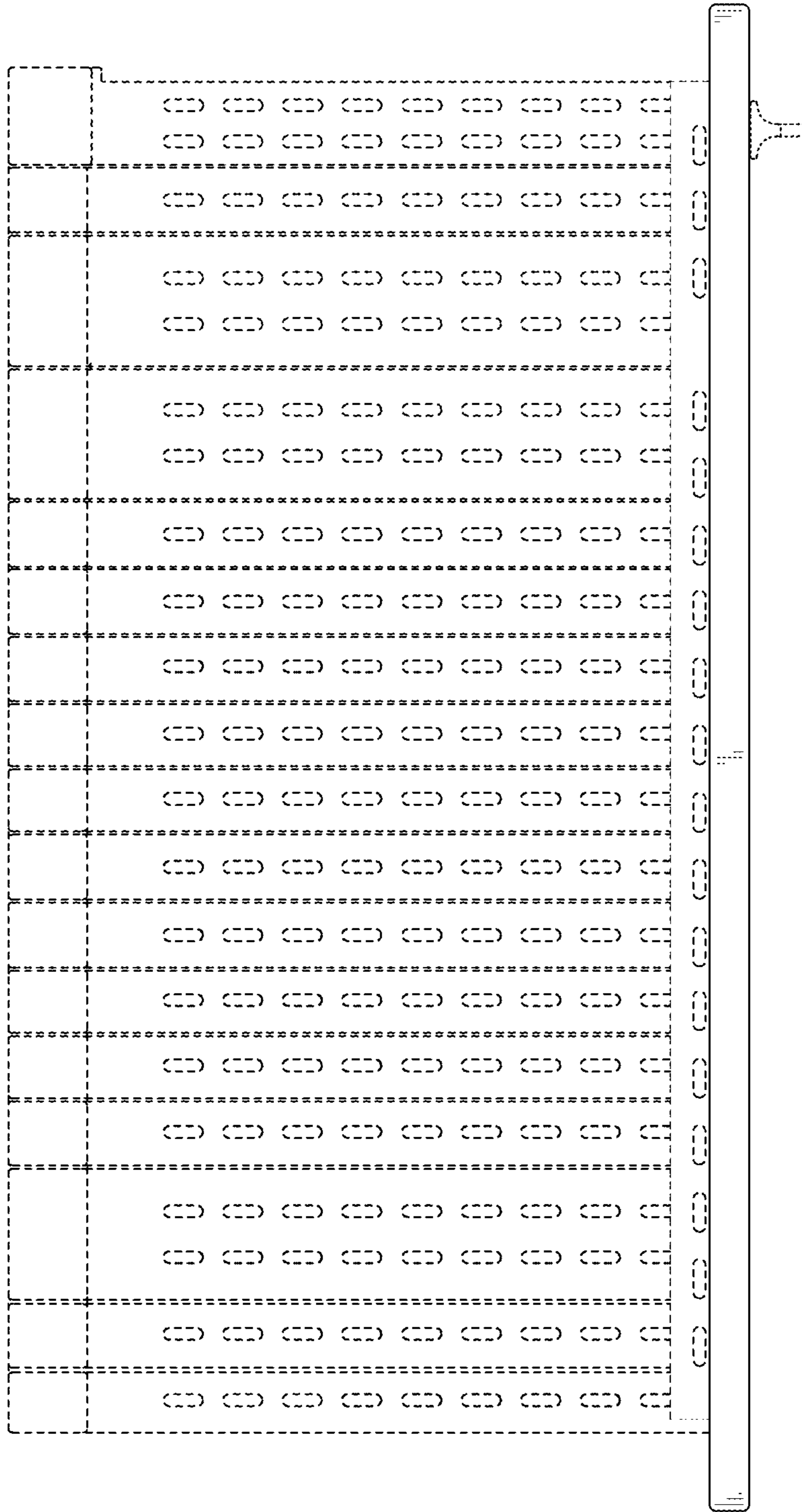

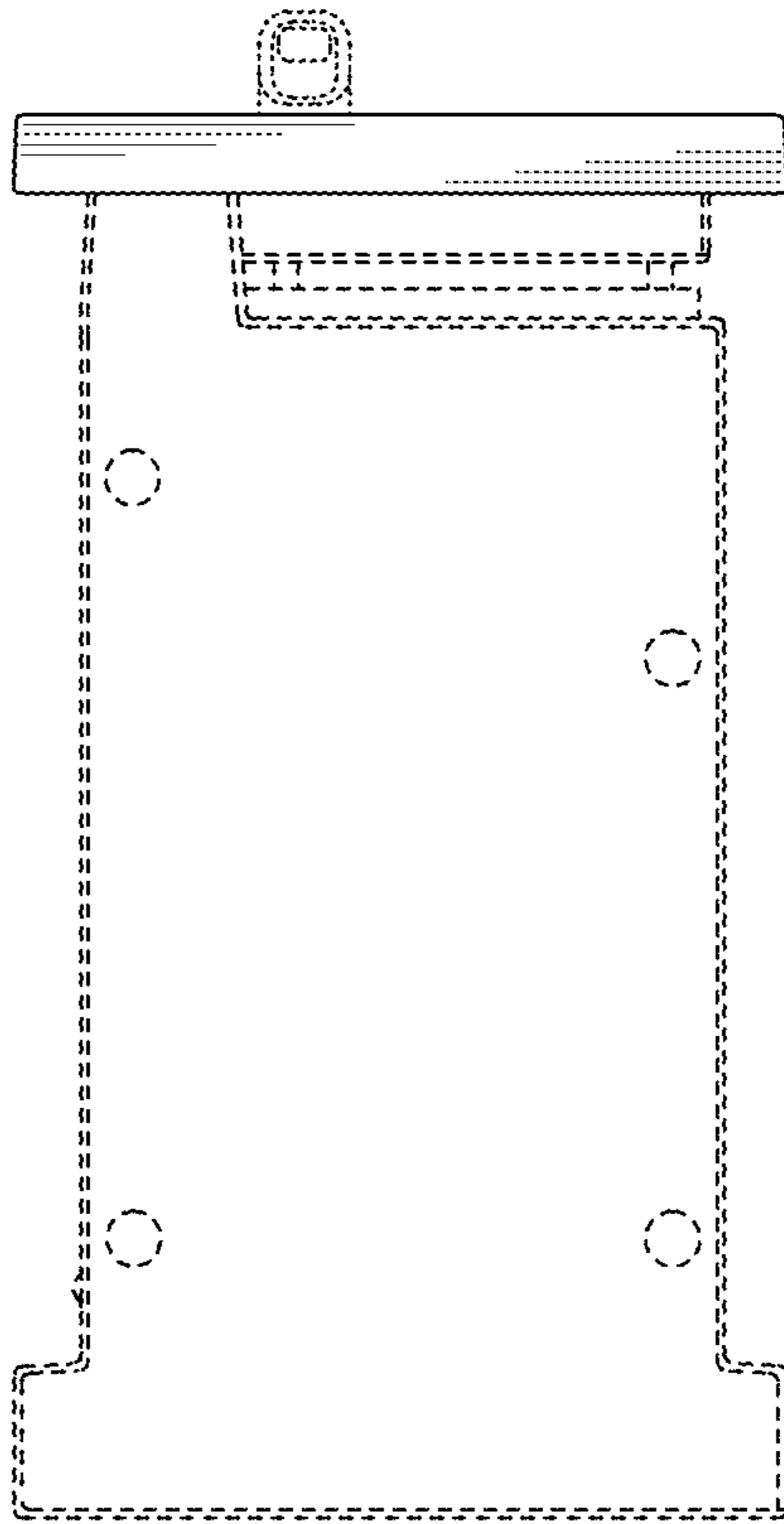

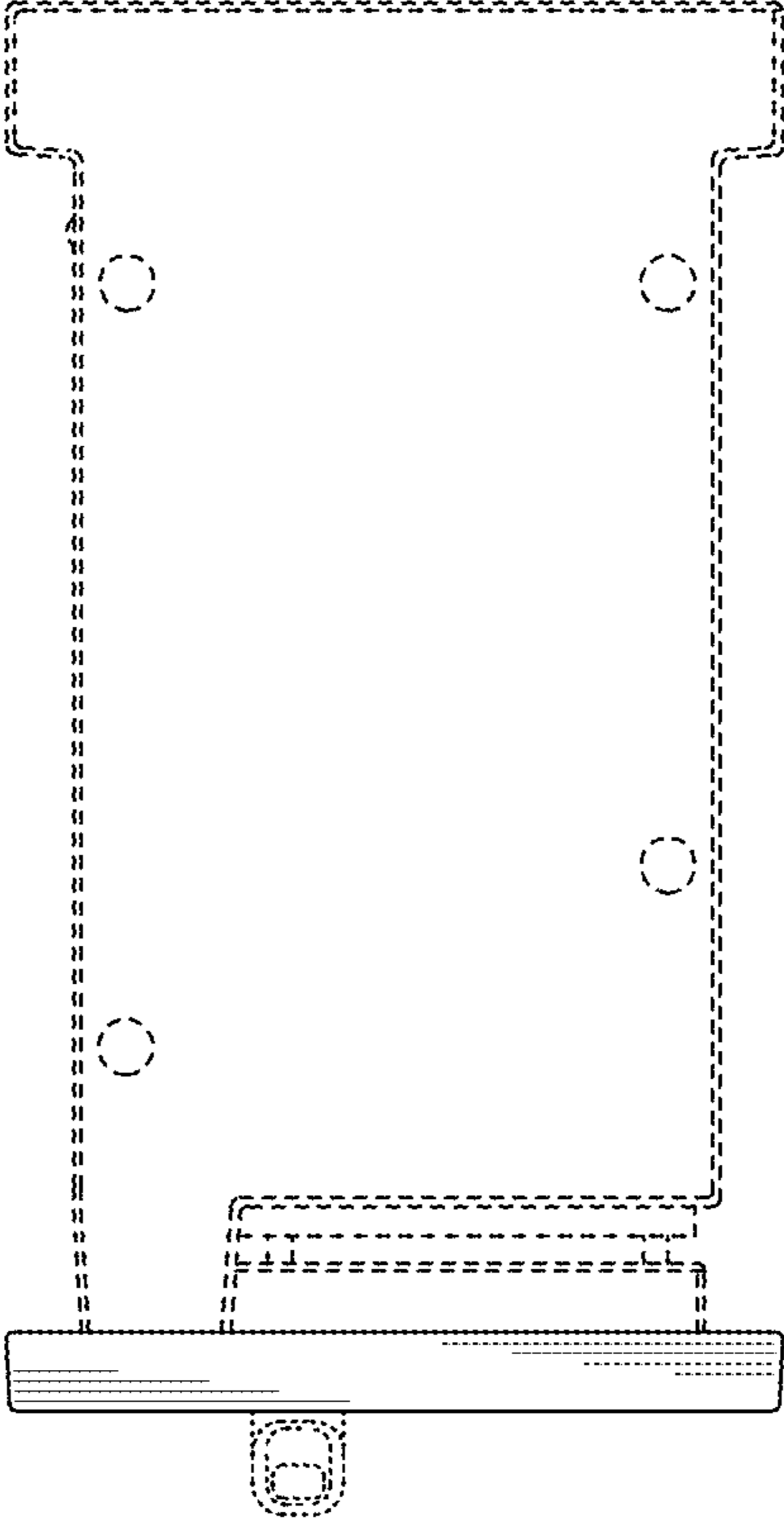

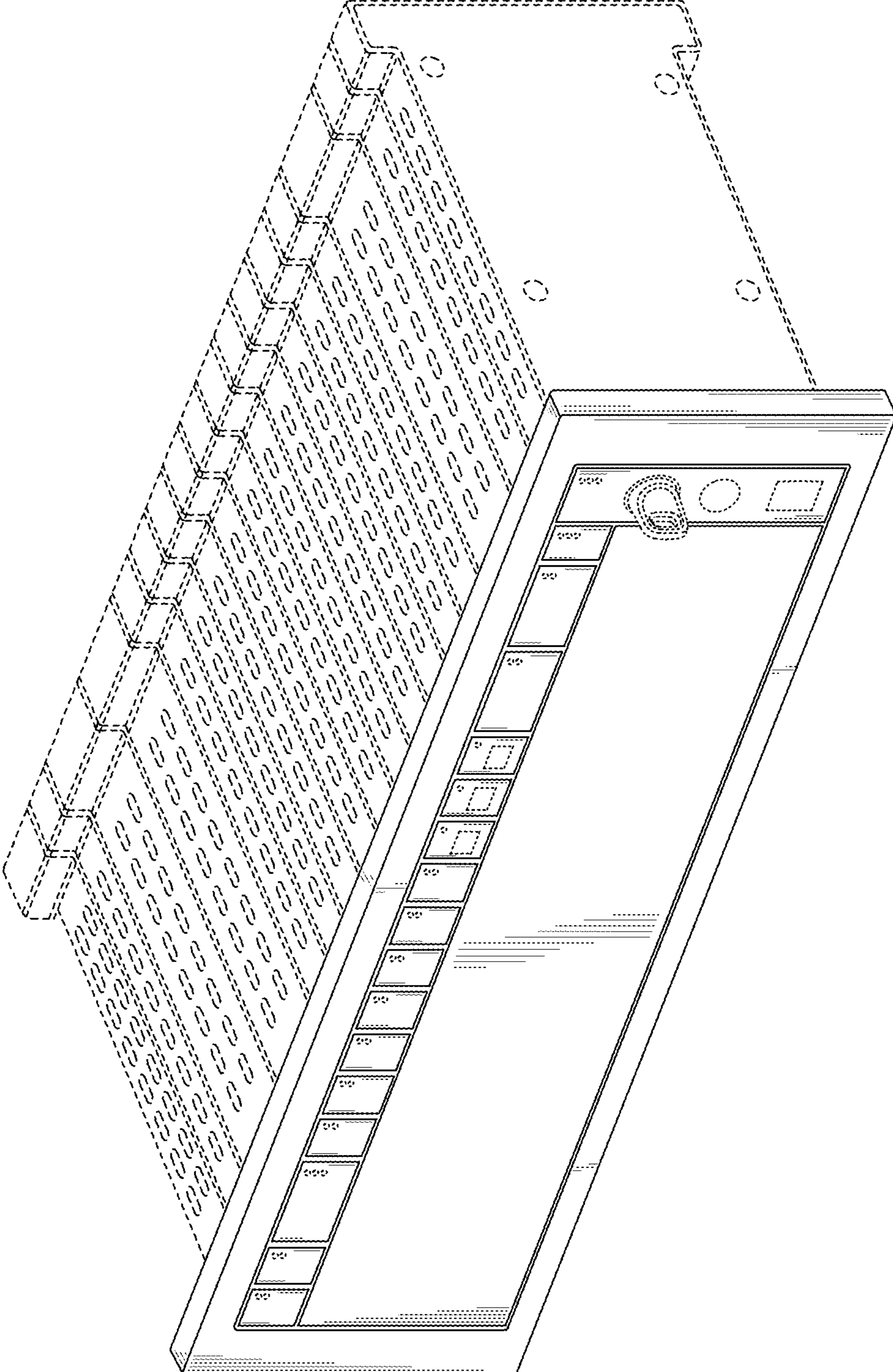

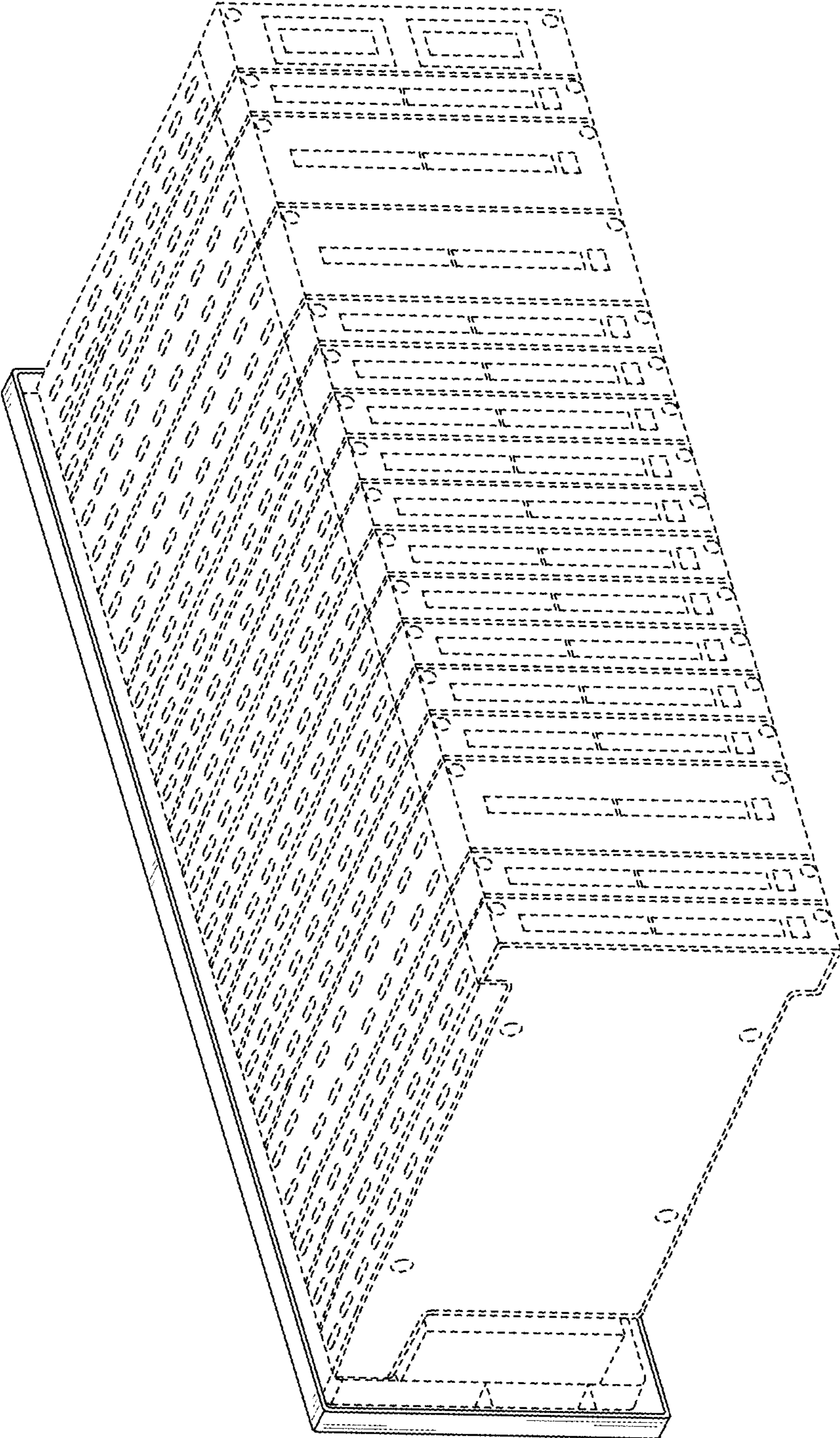

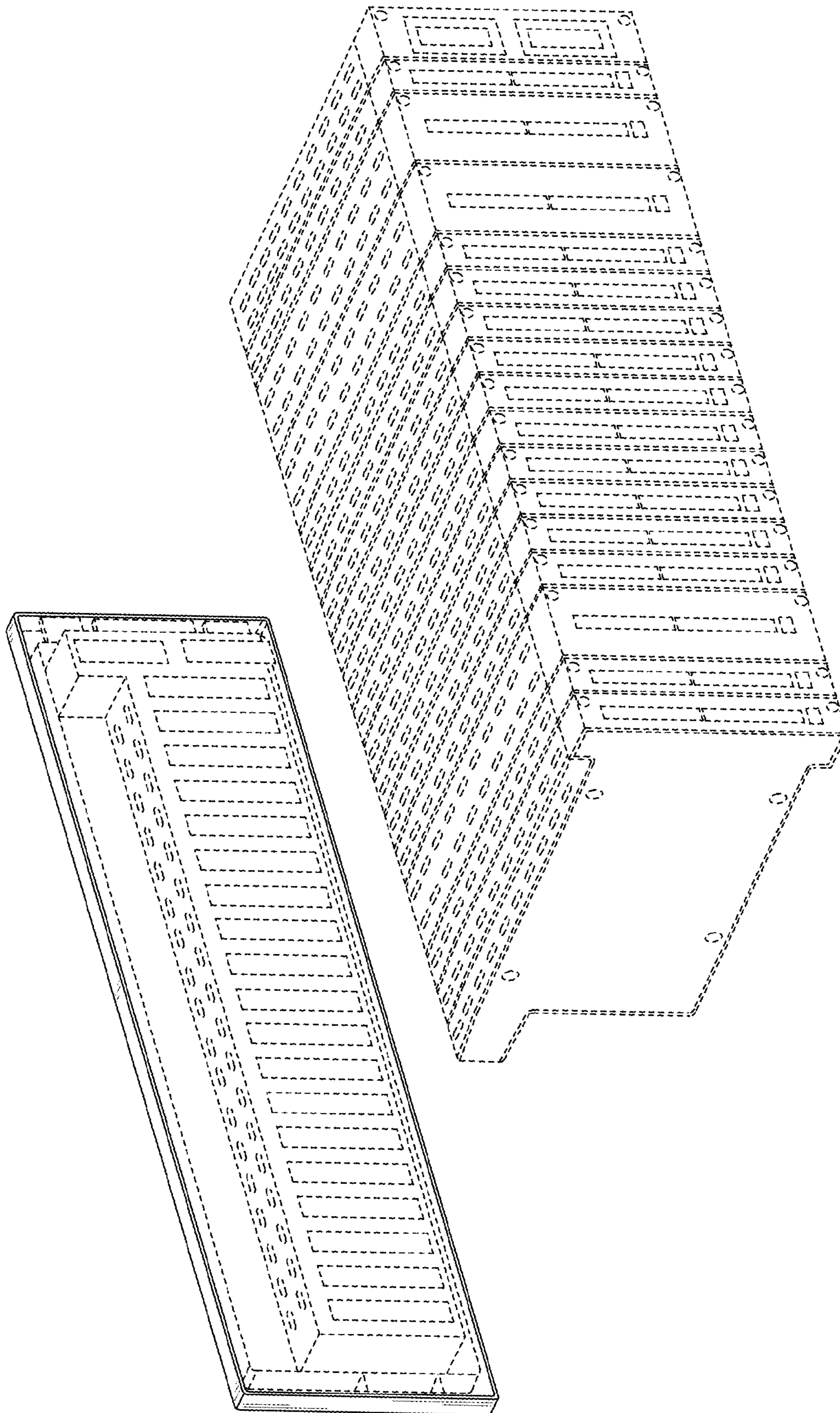

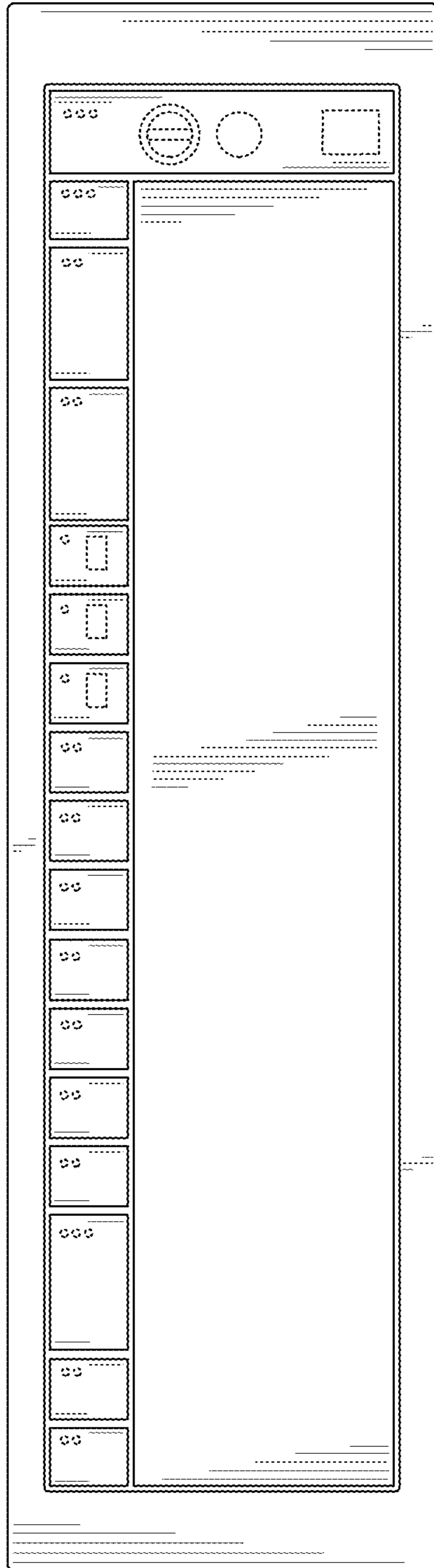

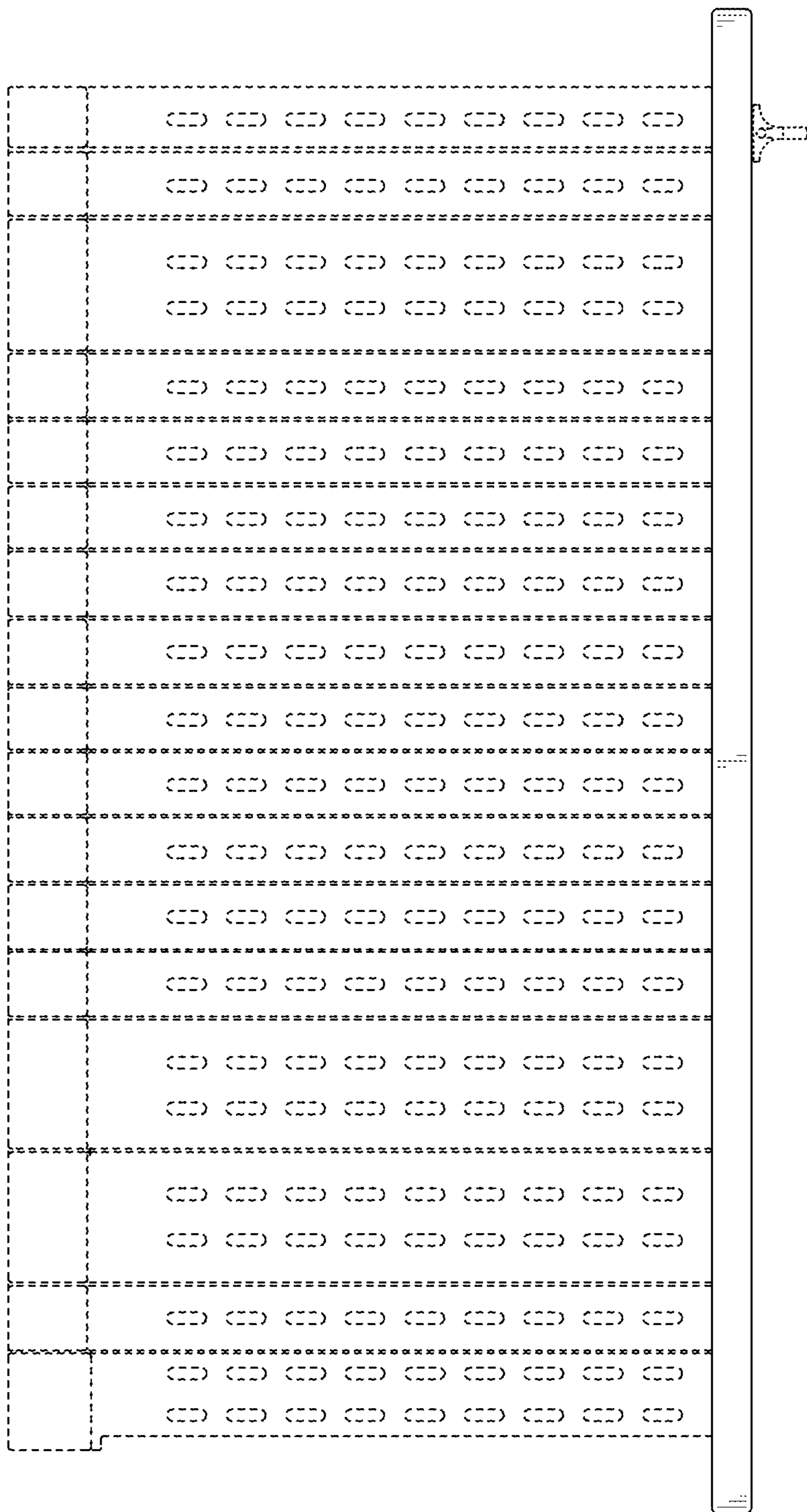

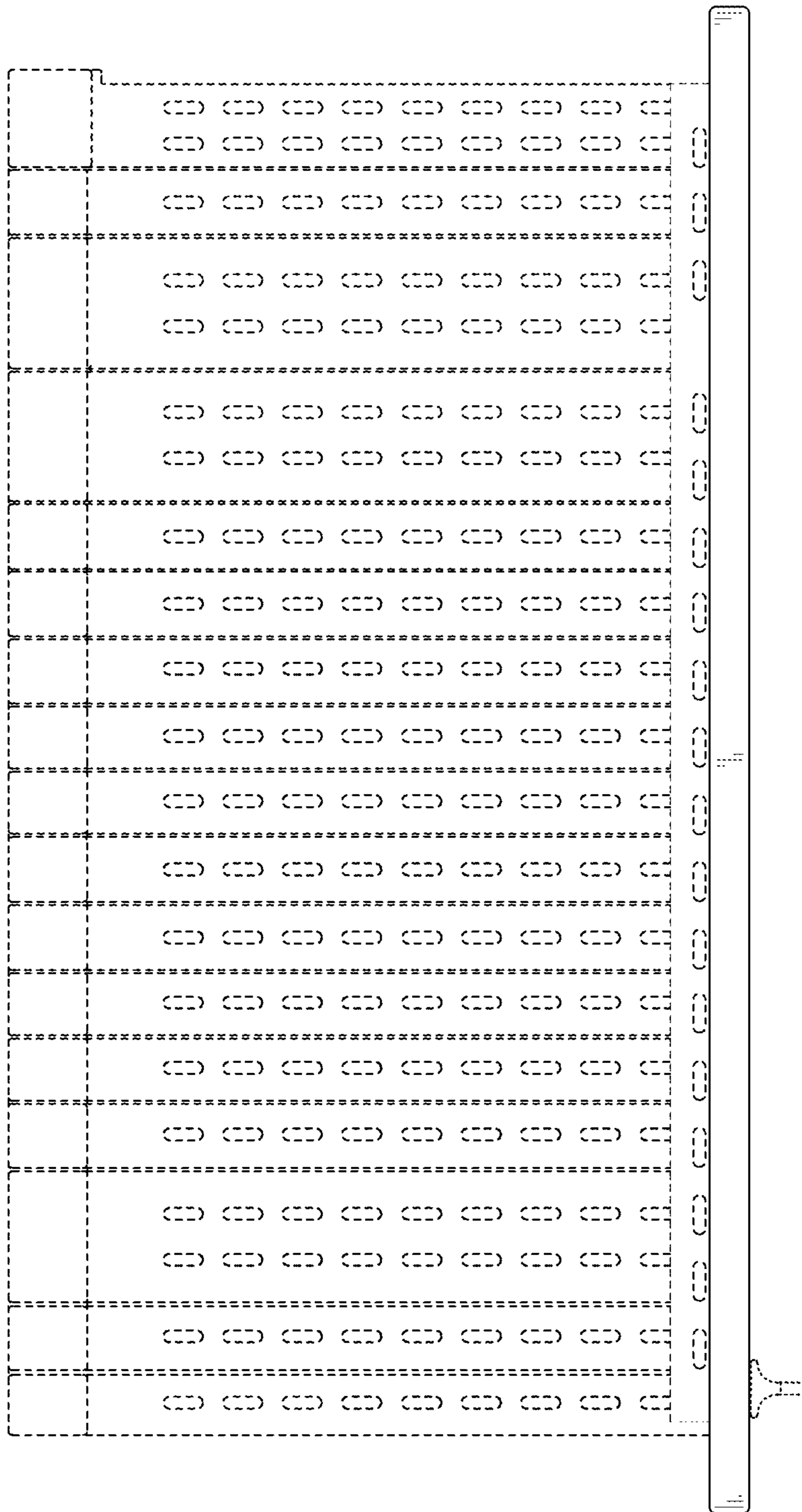

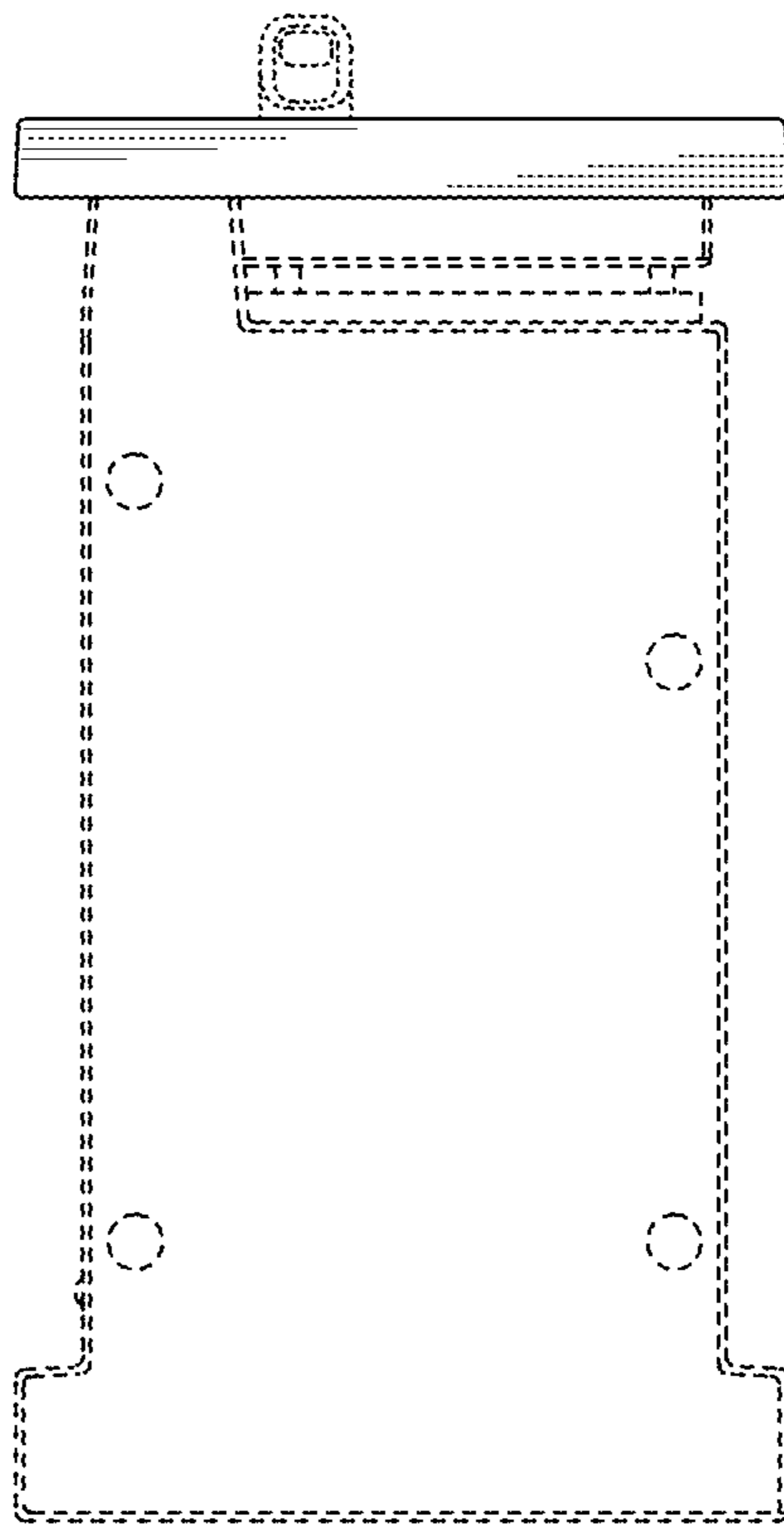

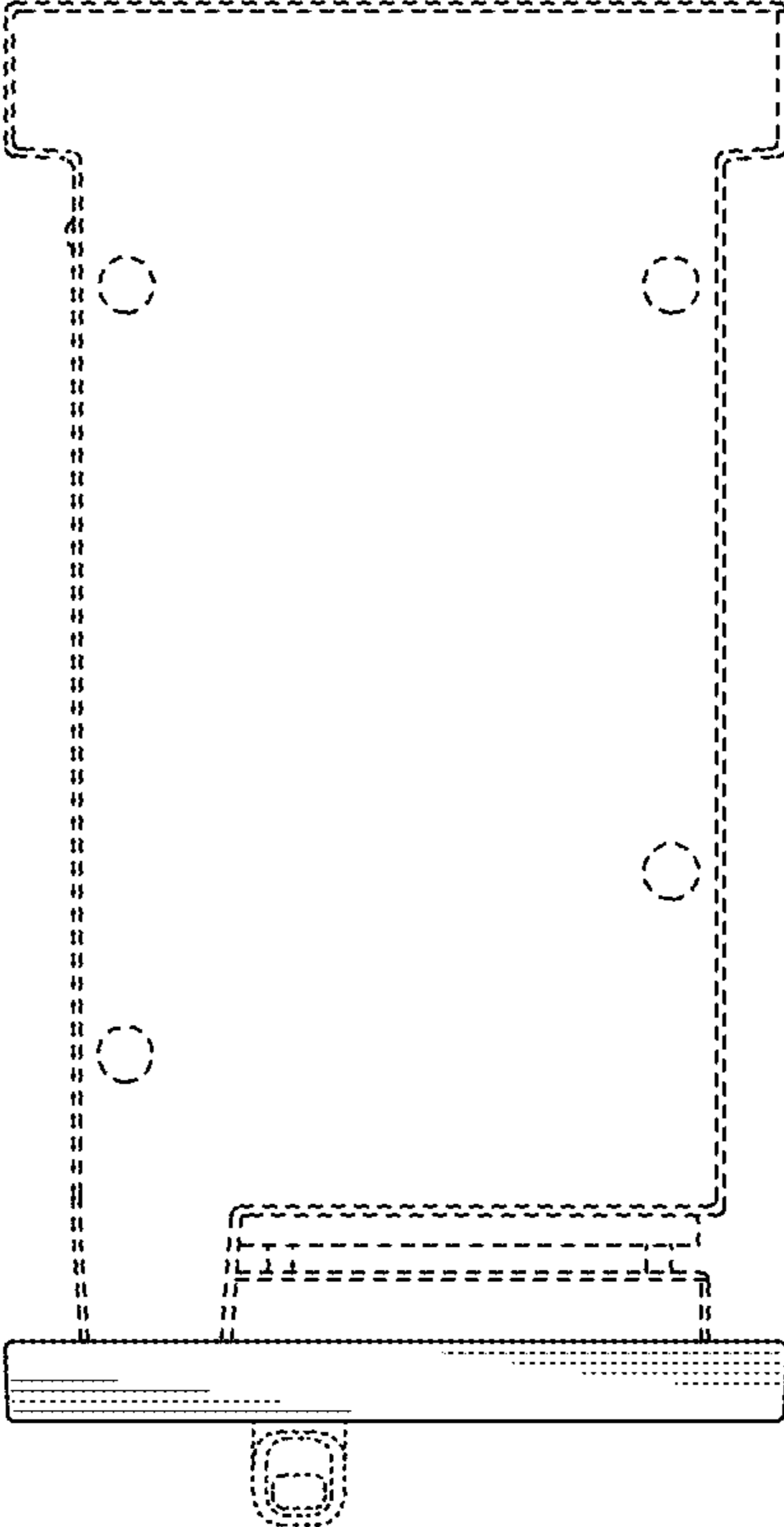

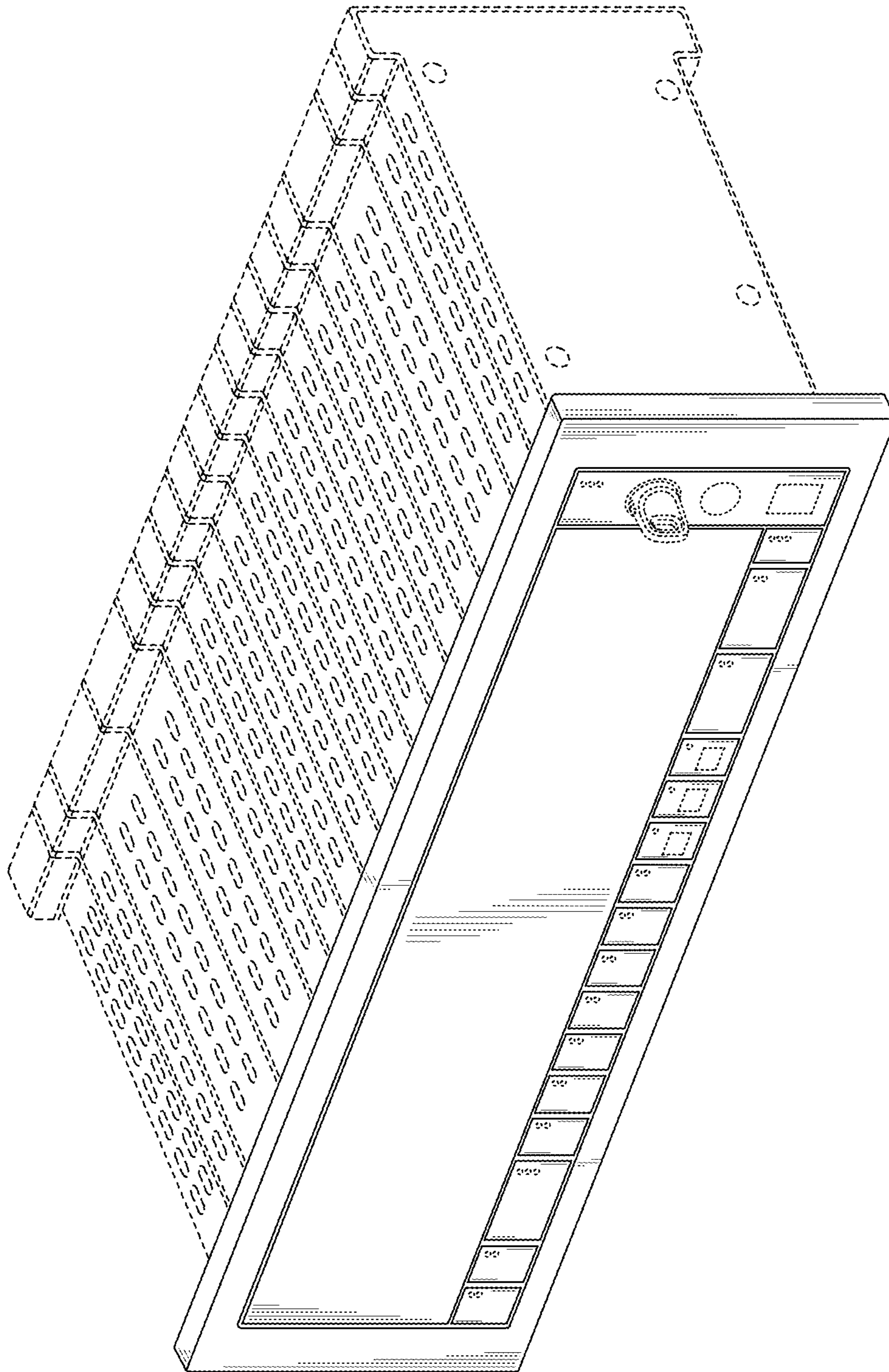

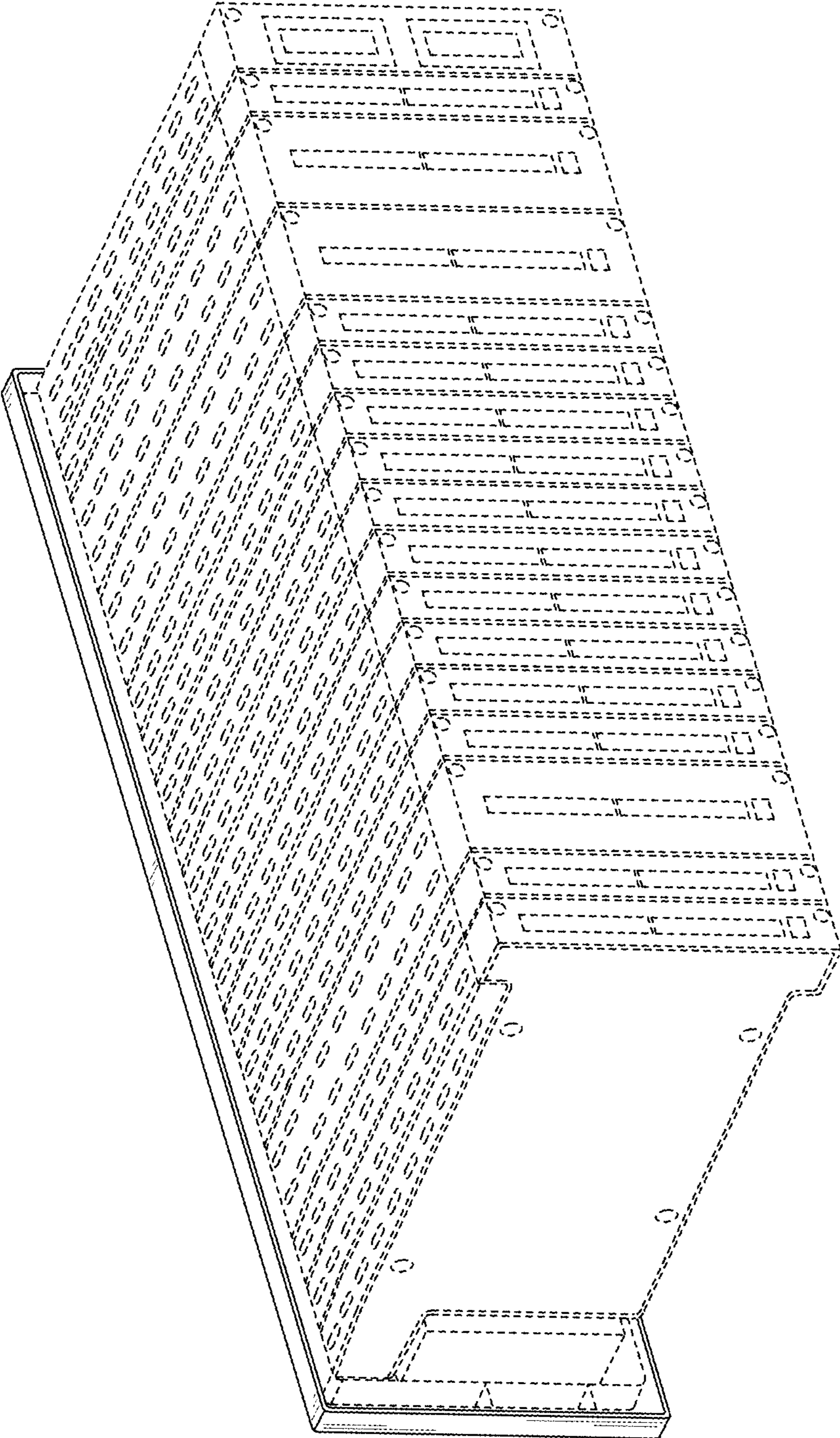

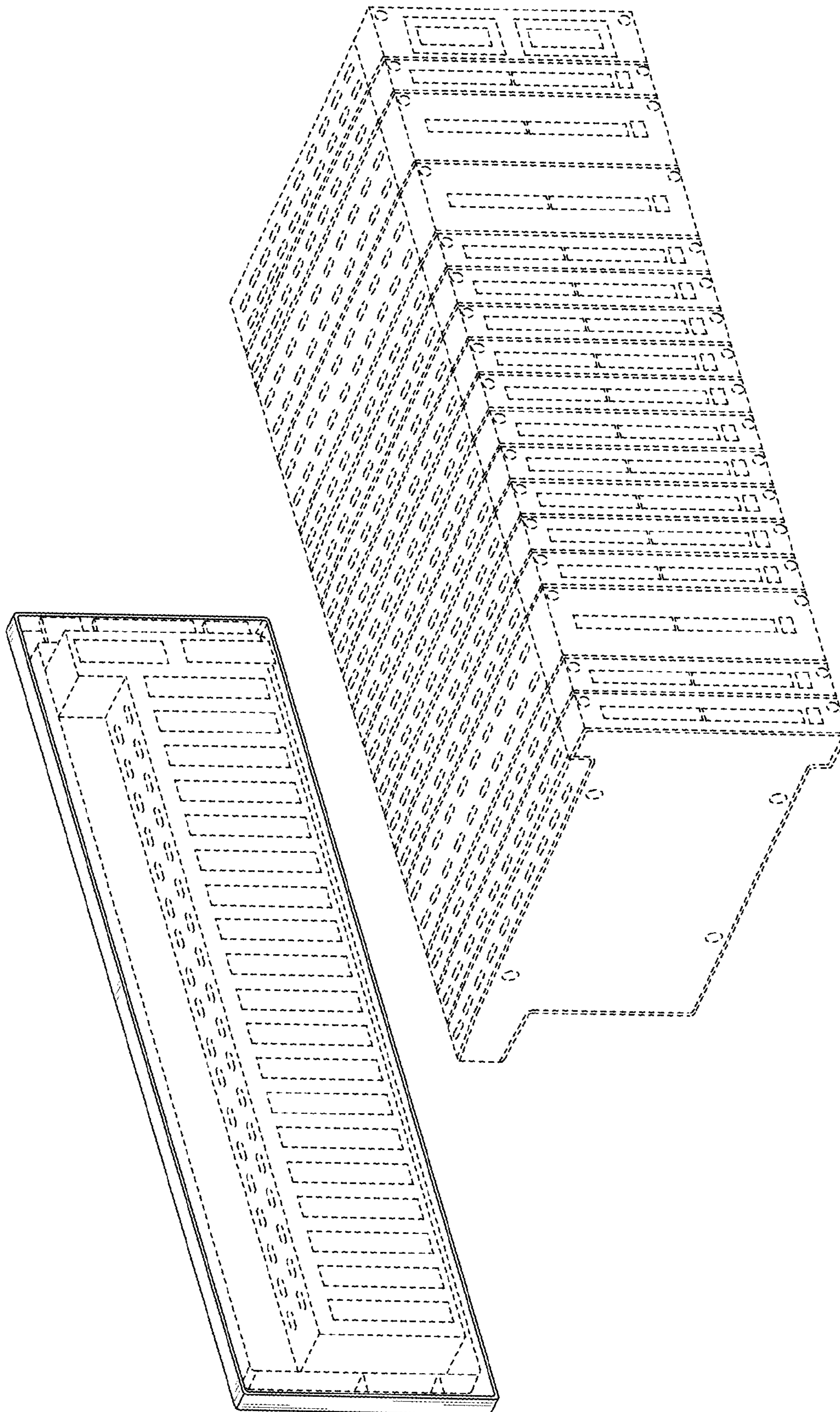

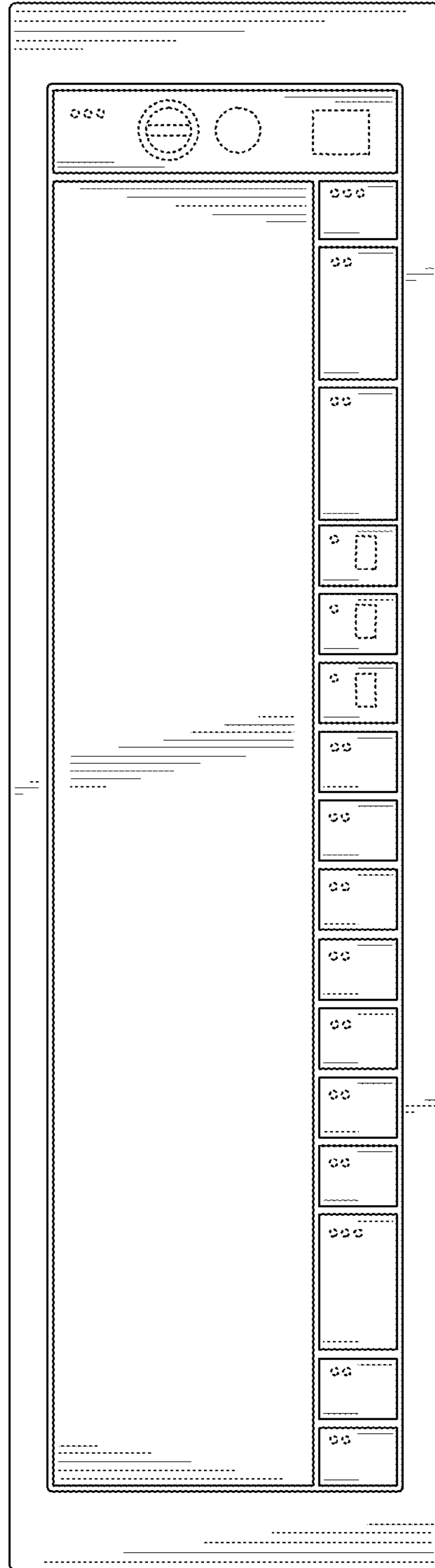

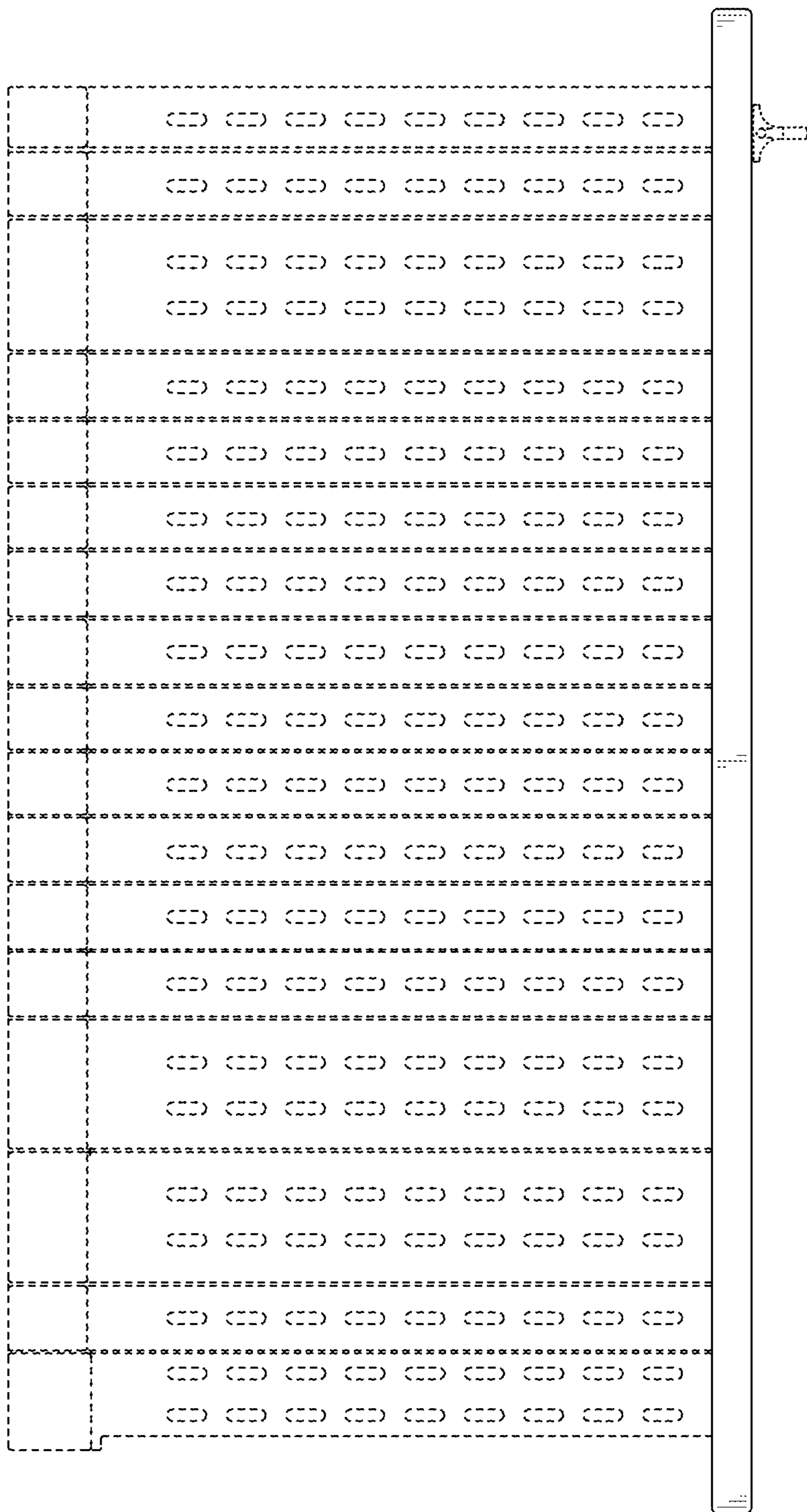

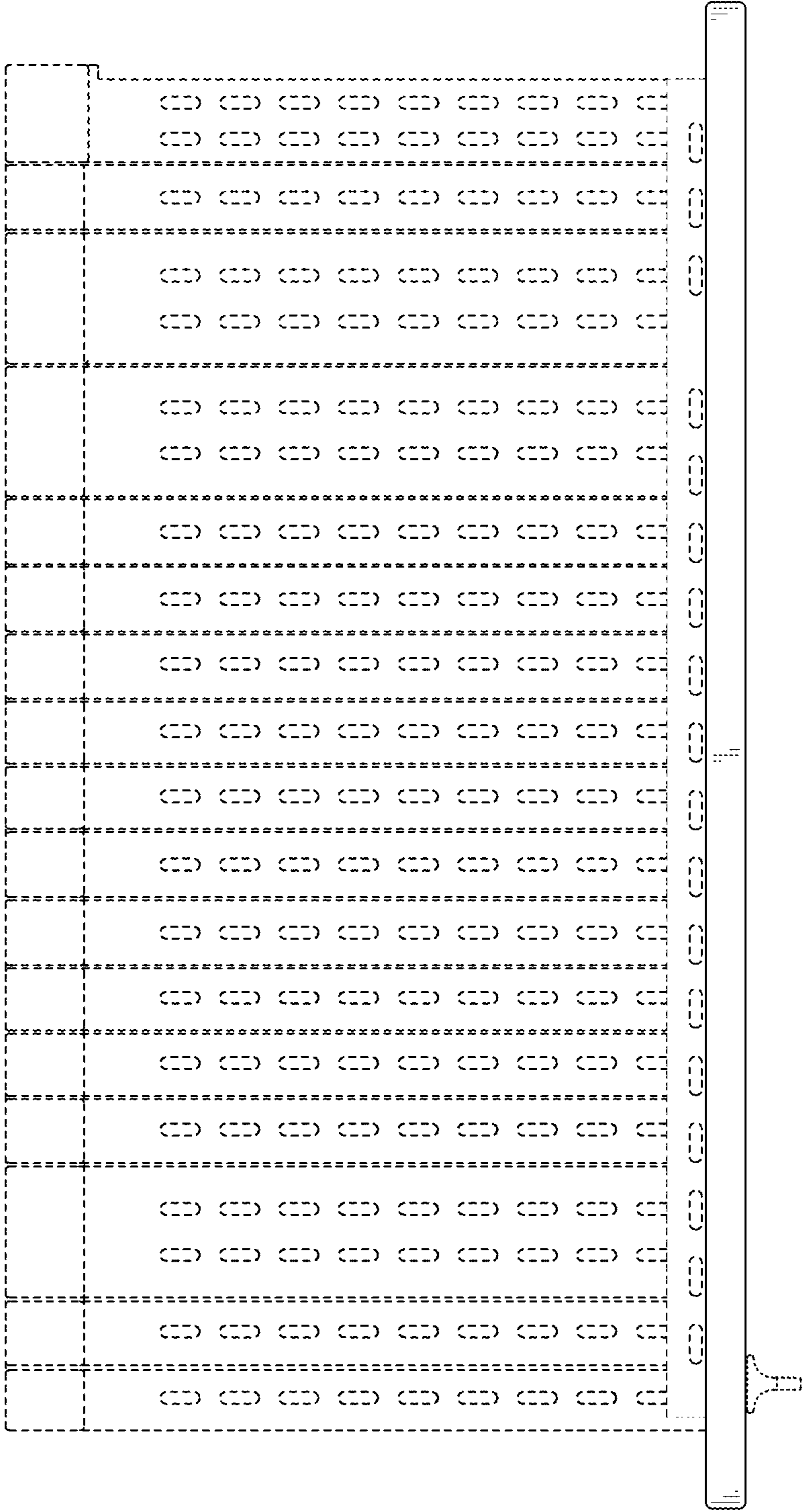

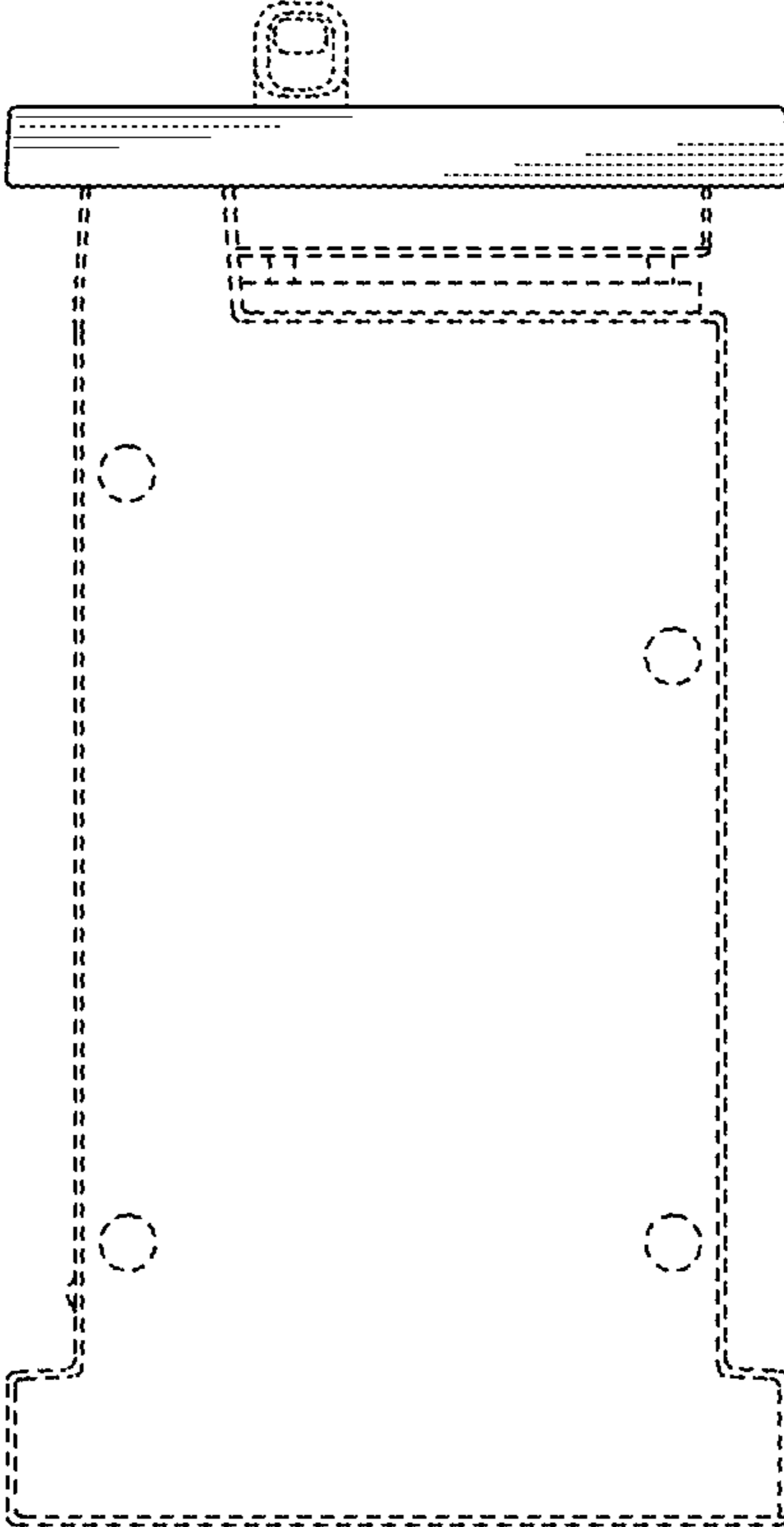

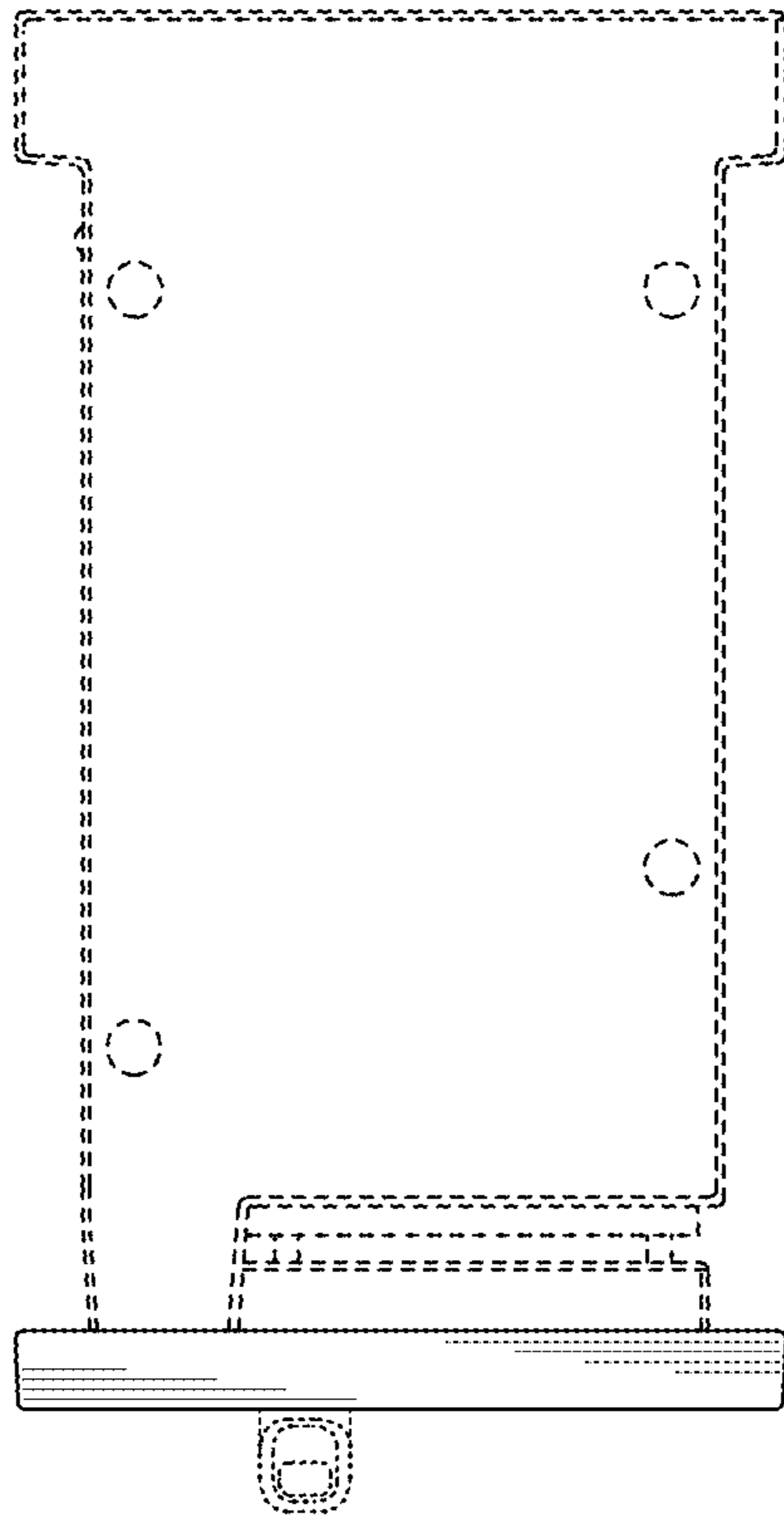
