I claim the ornamental design for a beverage dispenser display screen with an animated graphical user interface, as shown and described.

FIG. 18 is a second image thereof;

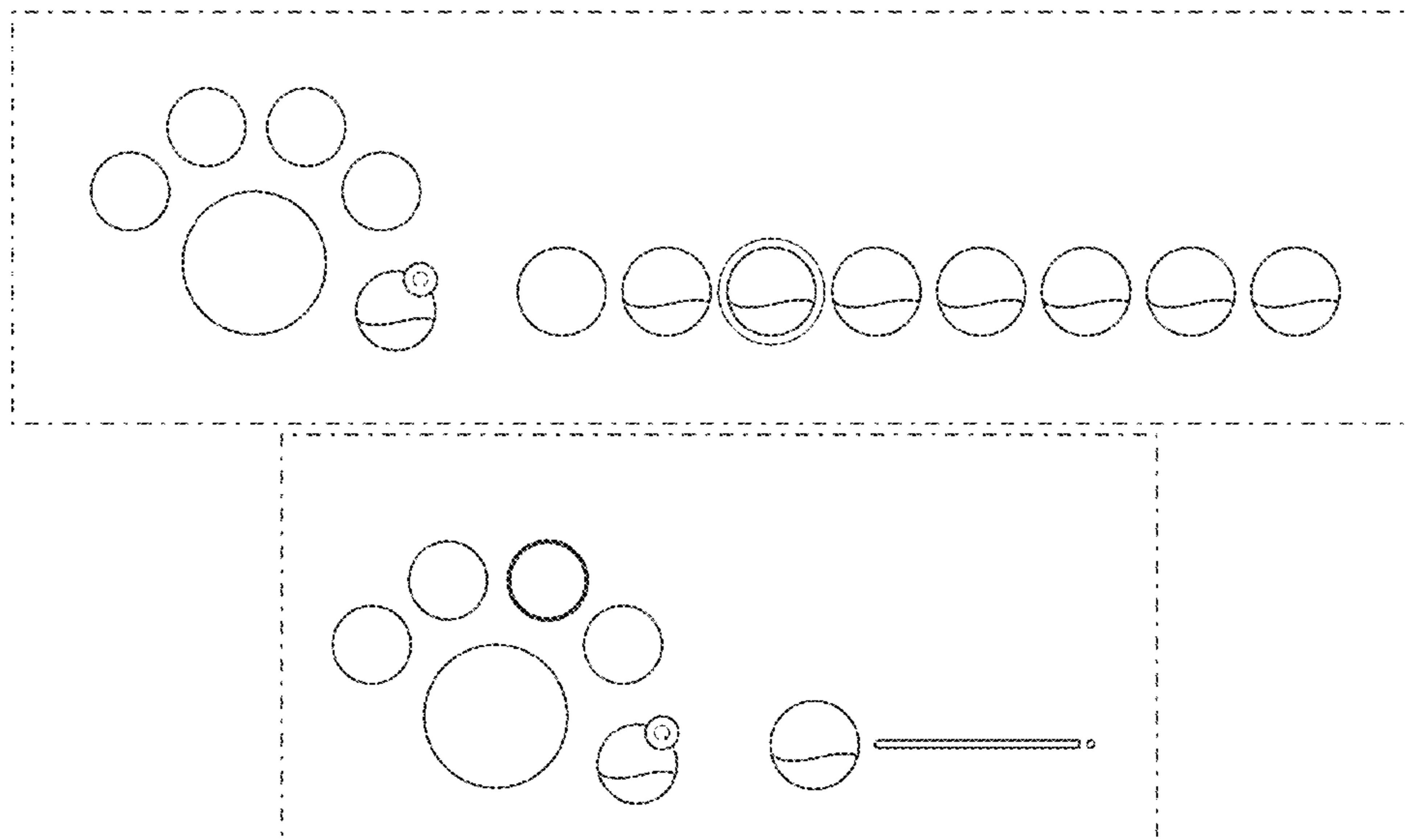
FIG. 19 is a third image thereof;

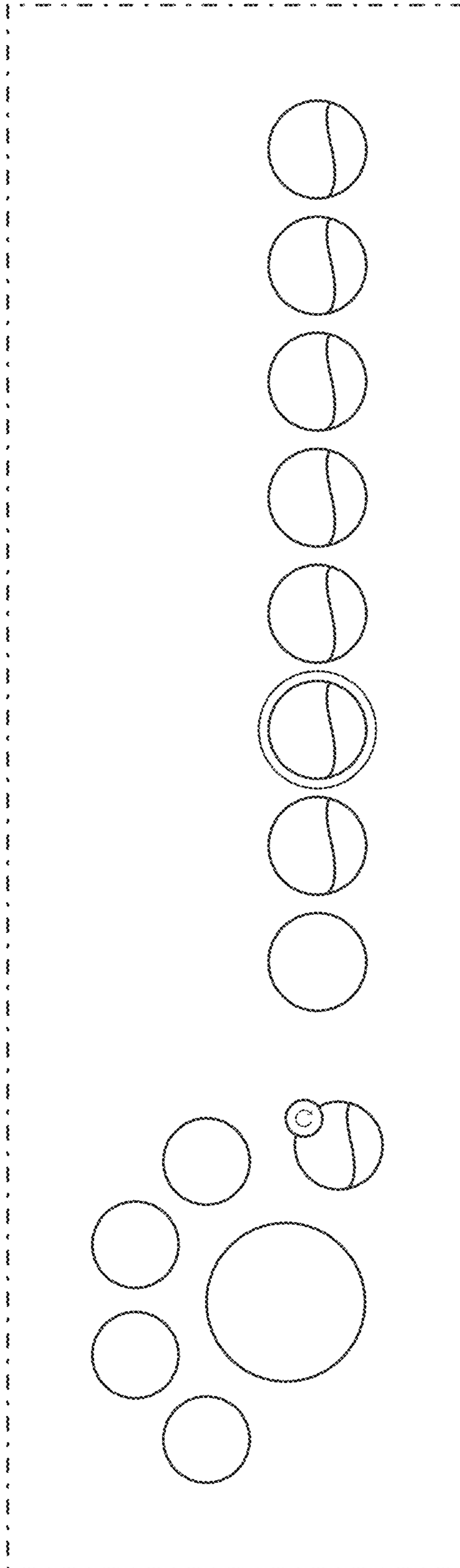

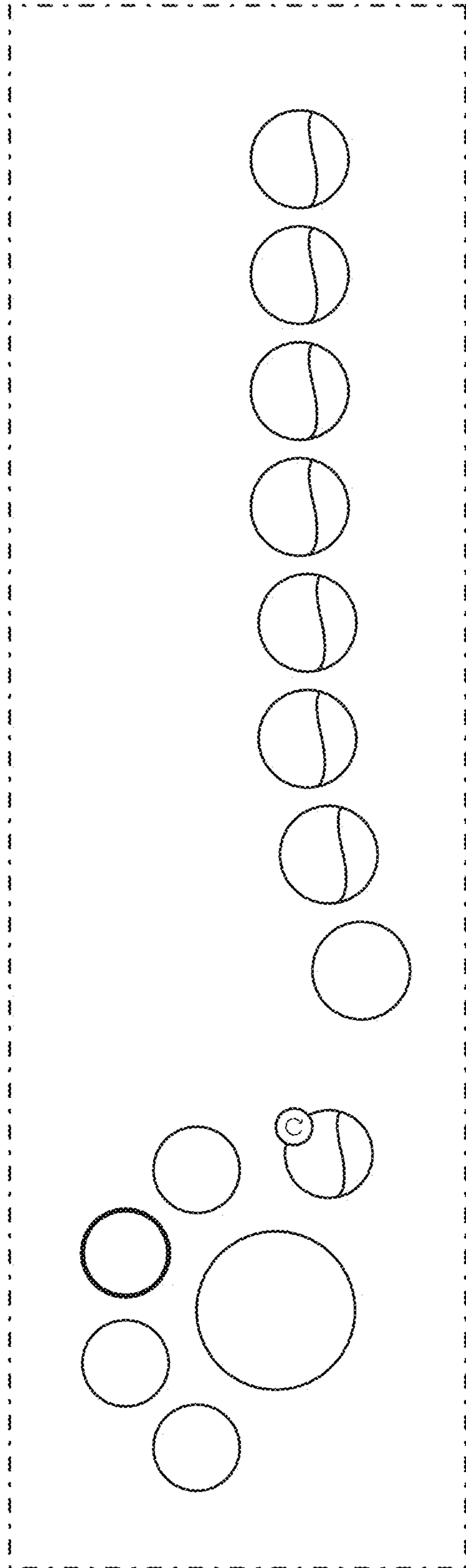

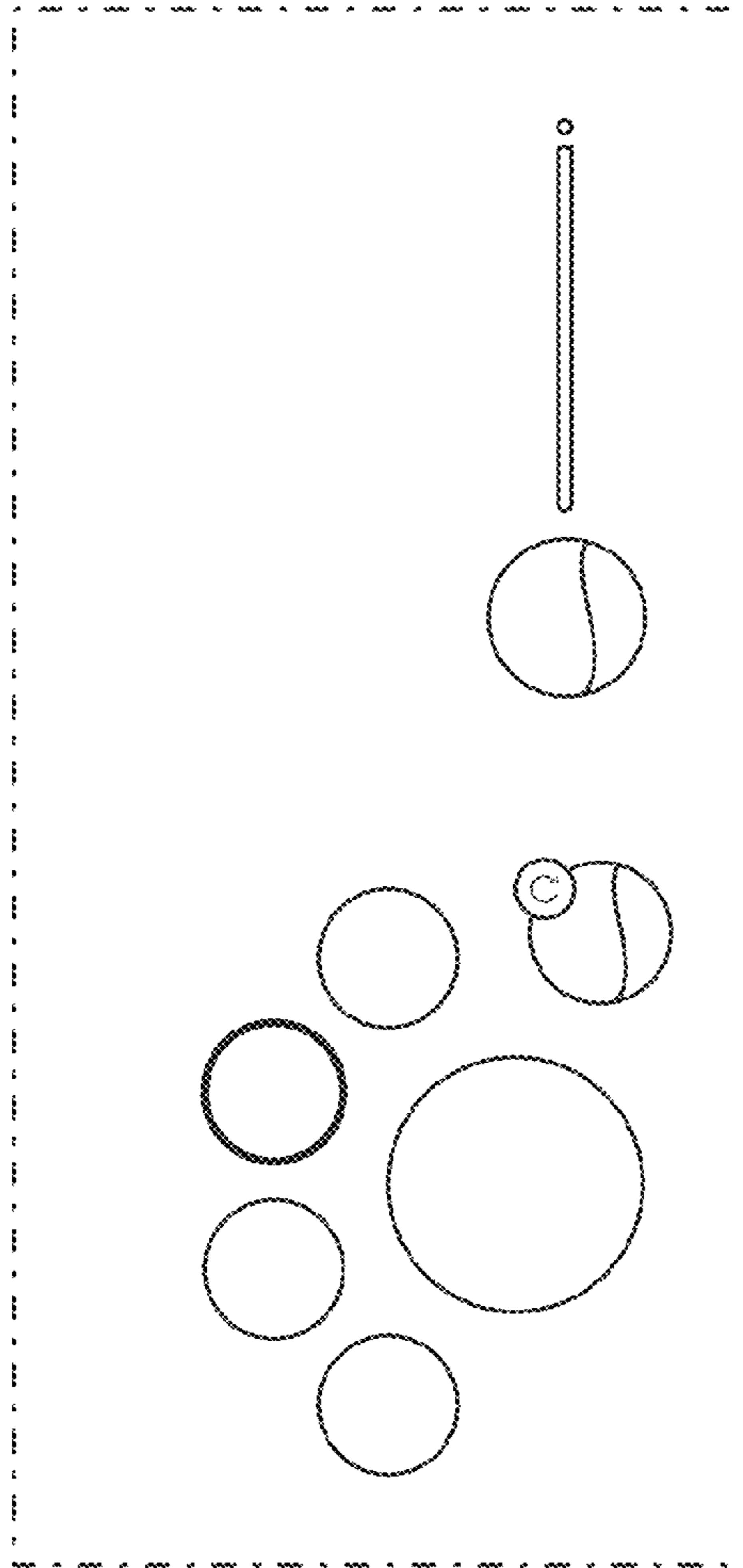

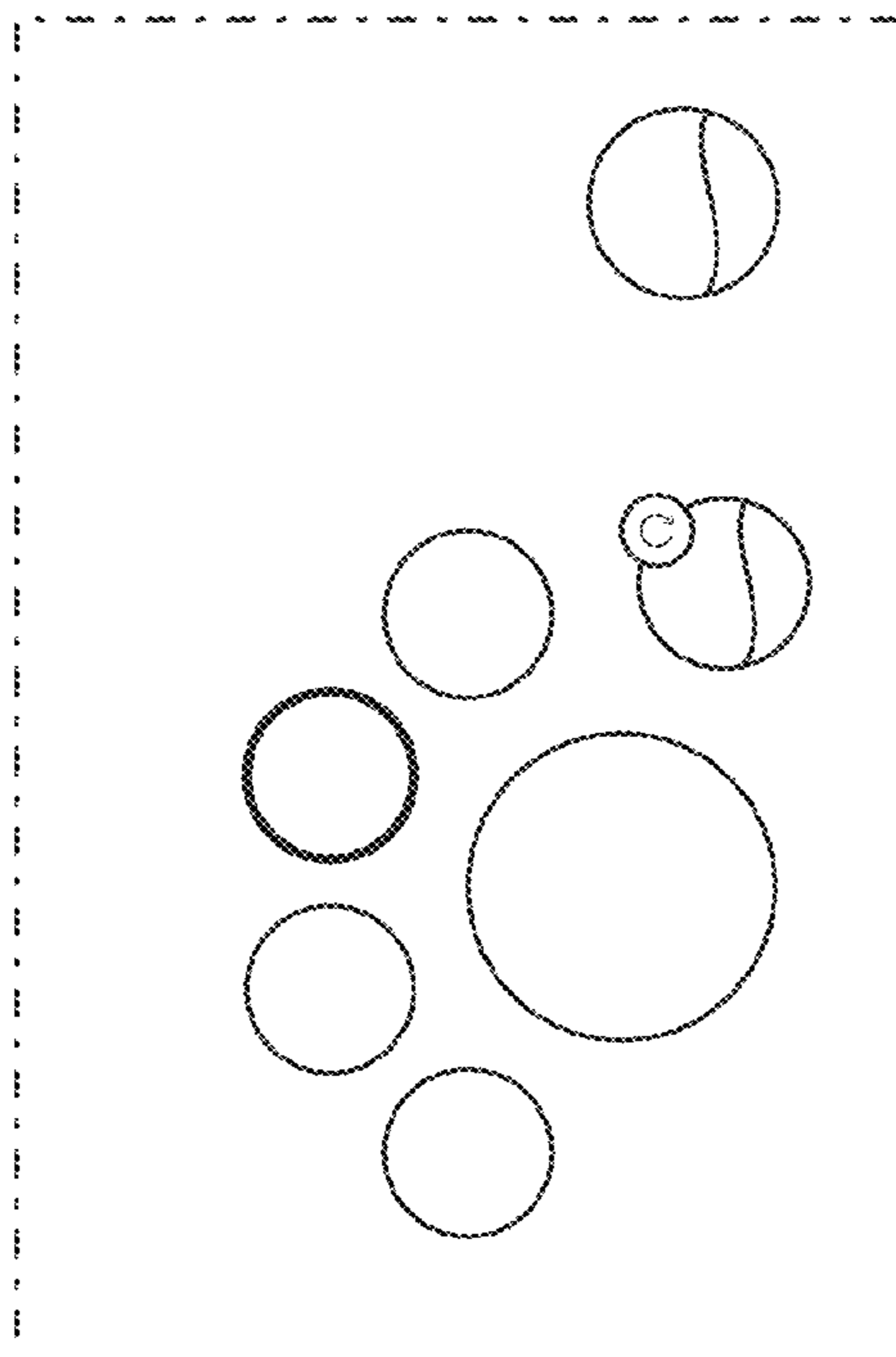

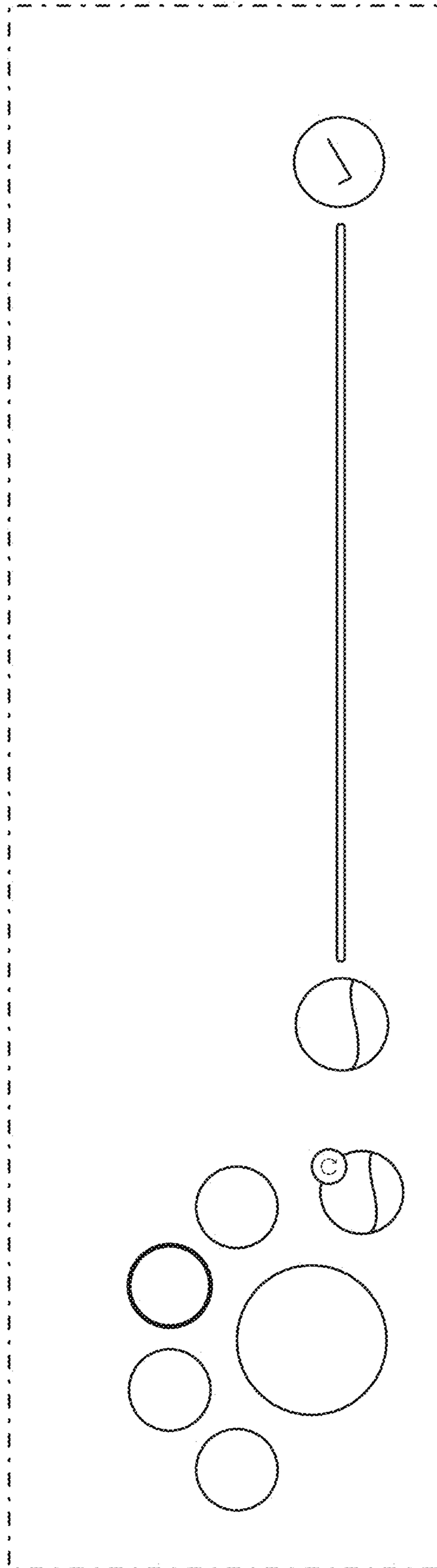

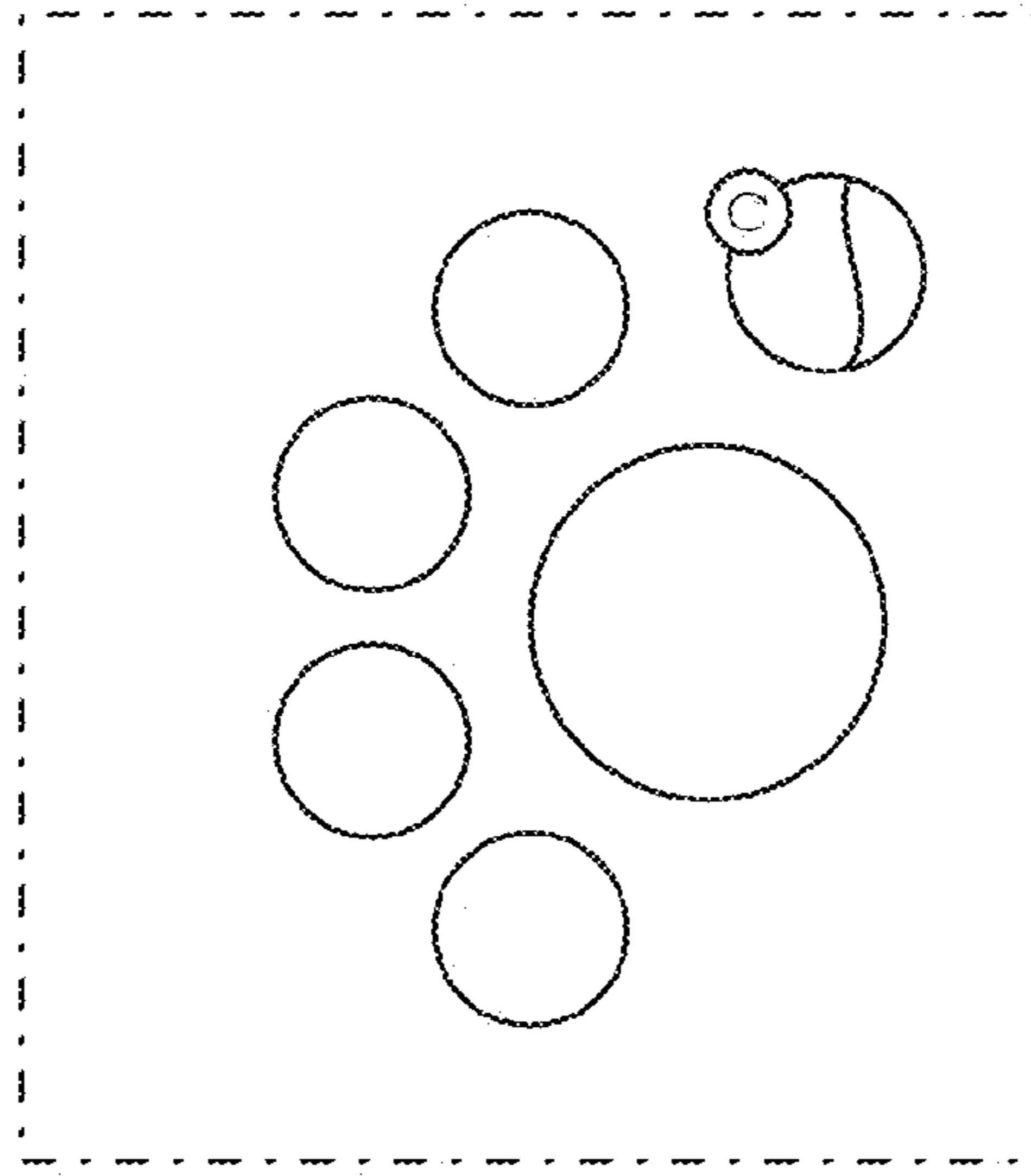

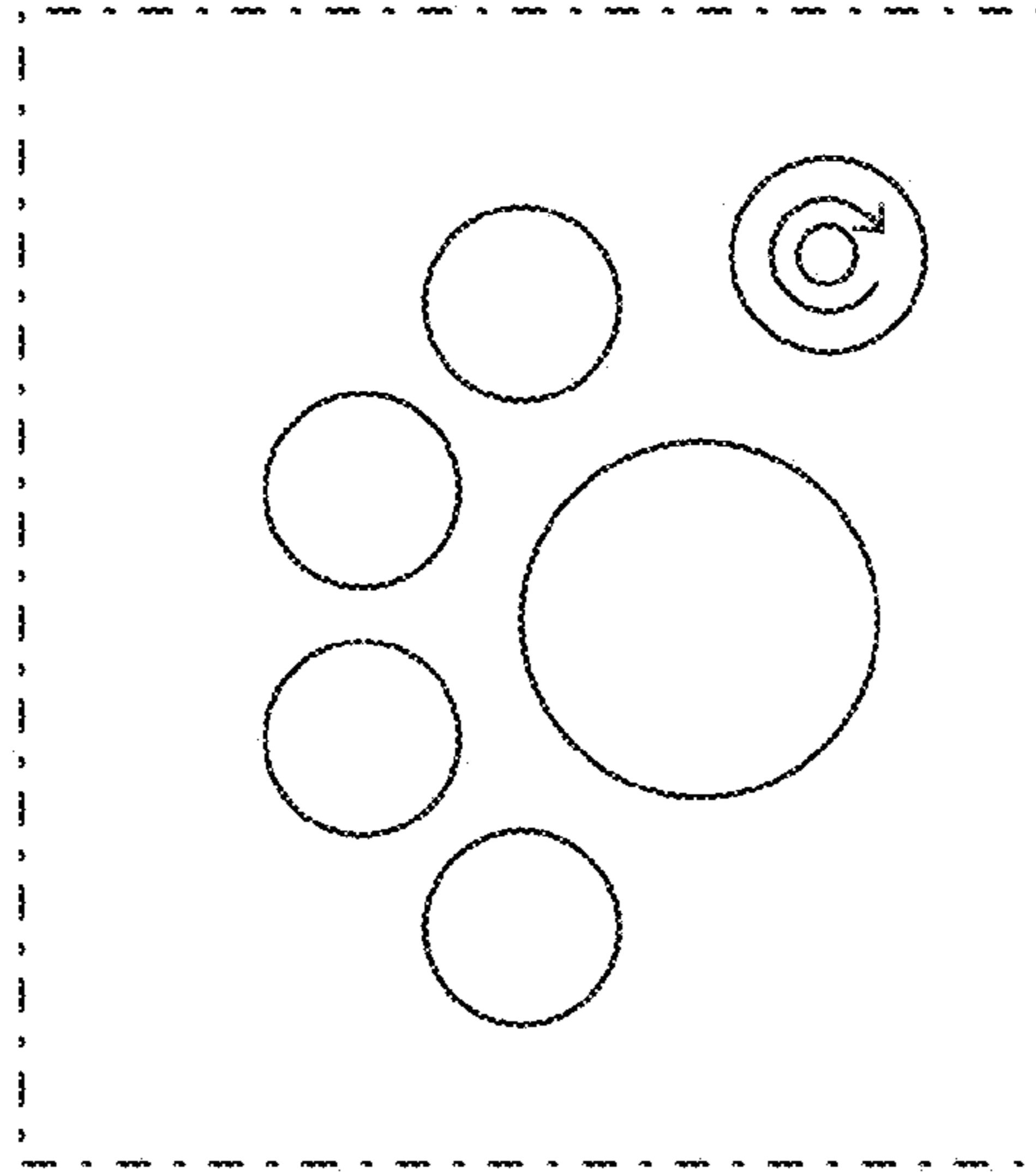

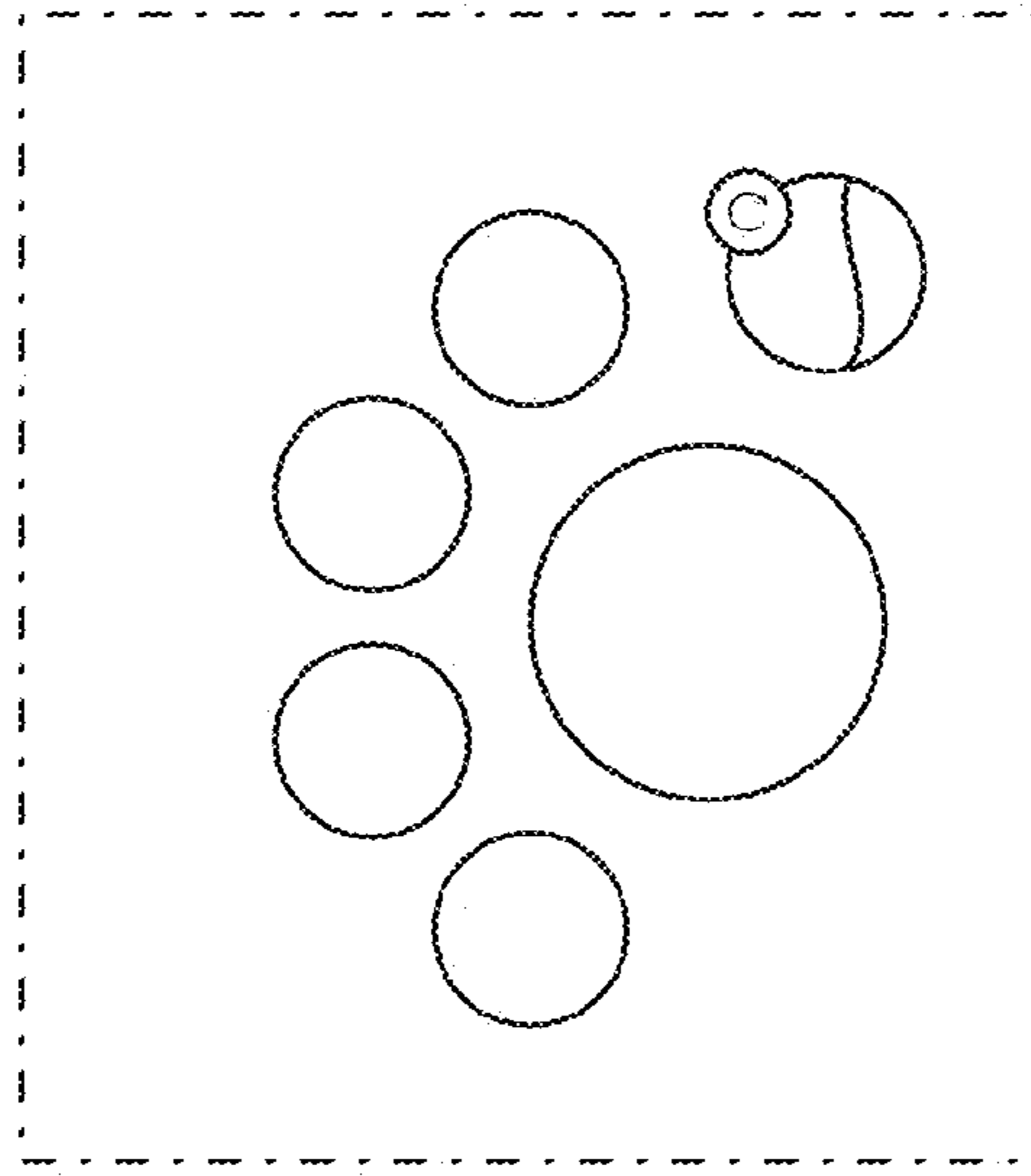

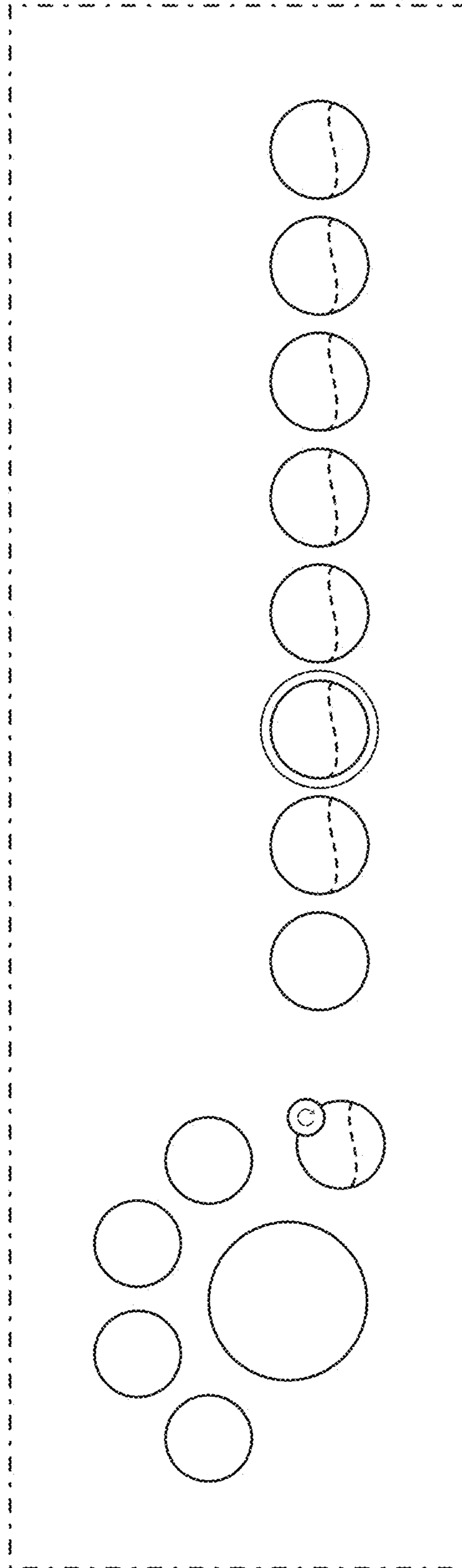

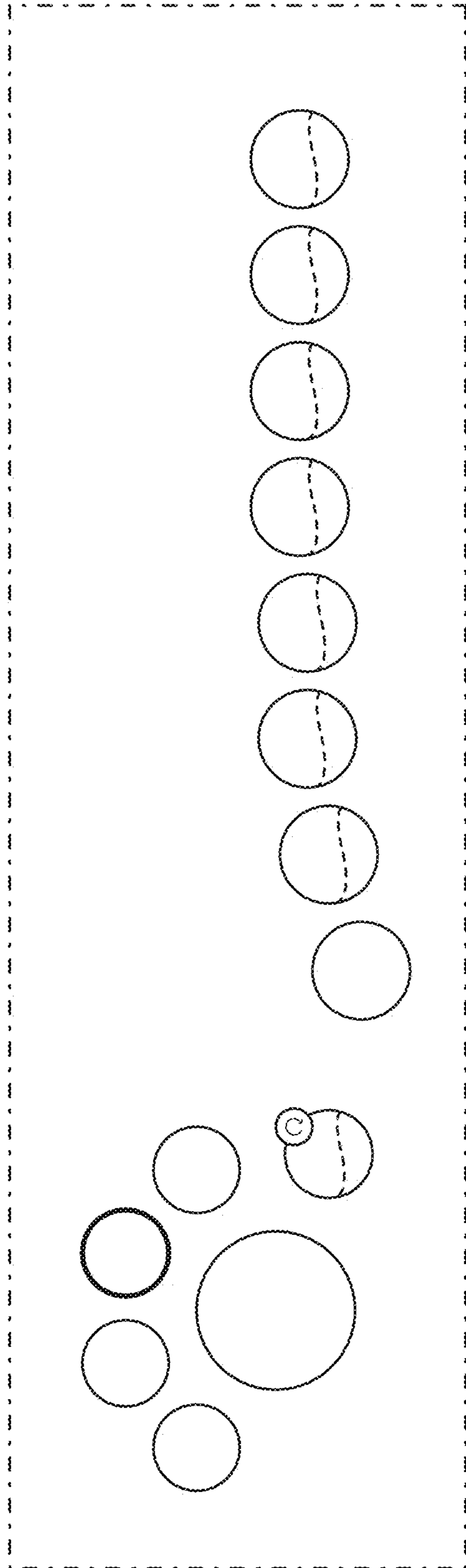

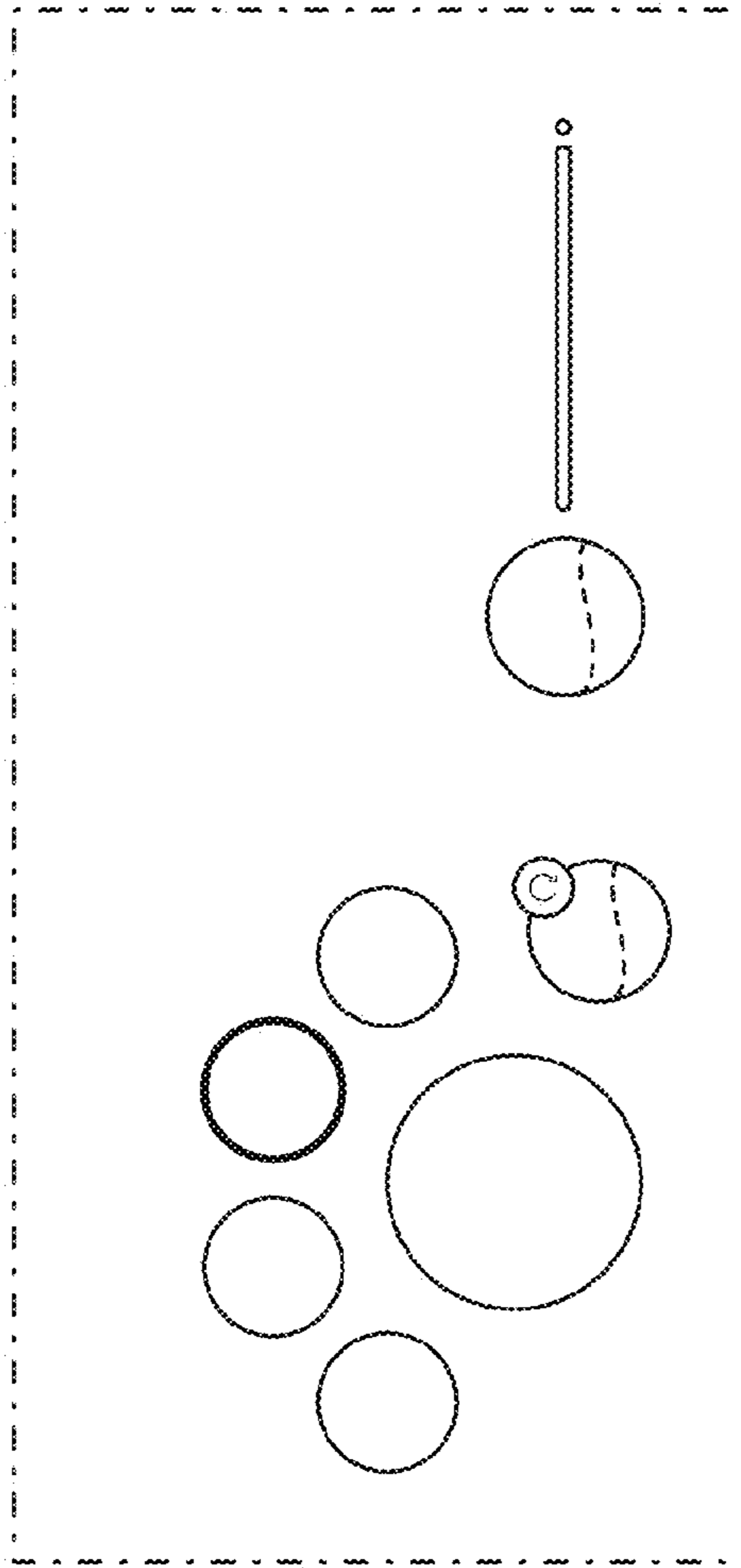

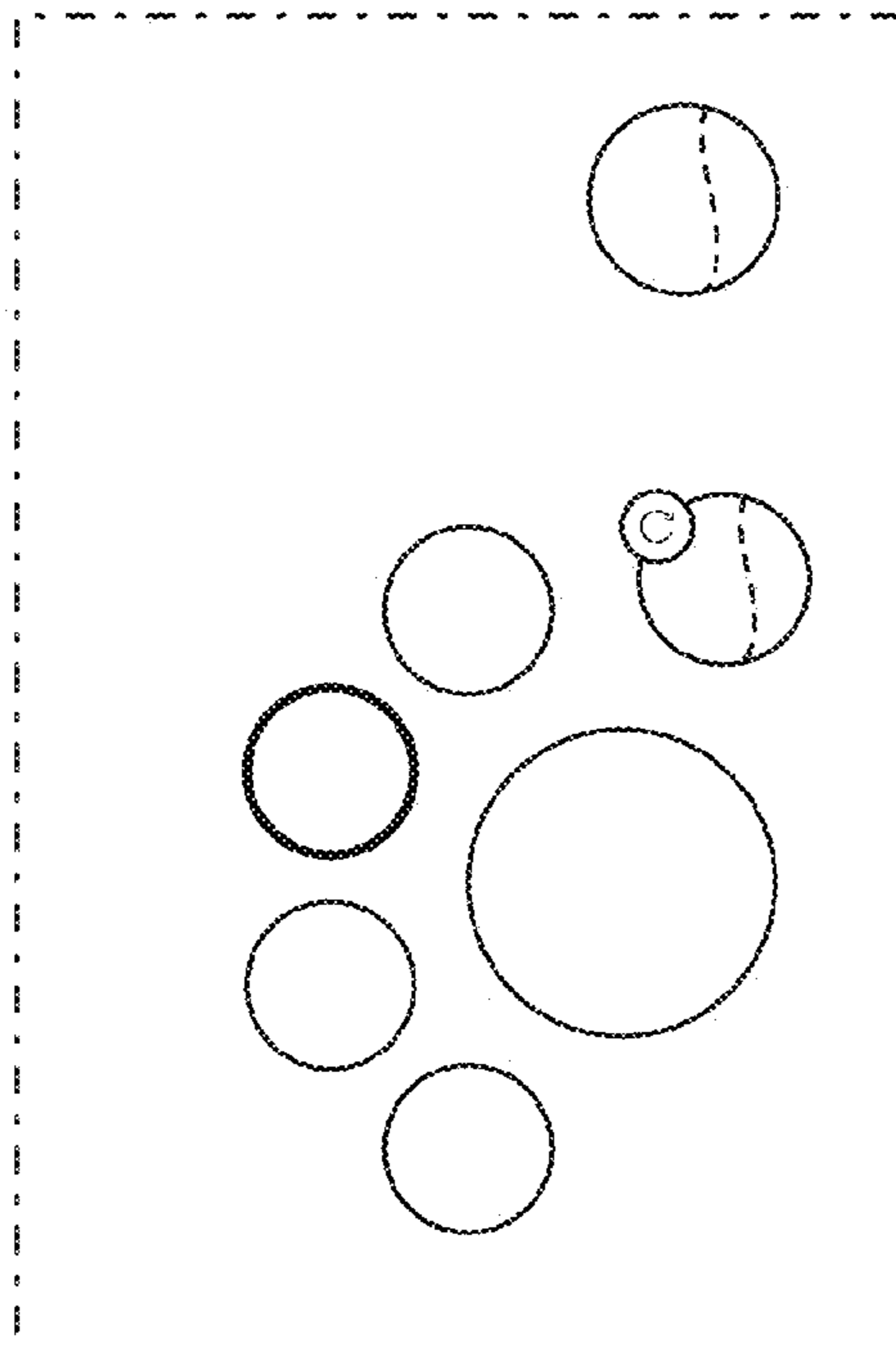

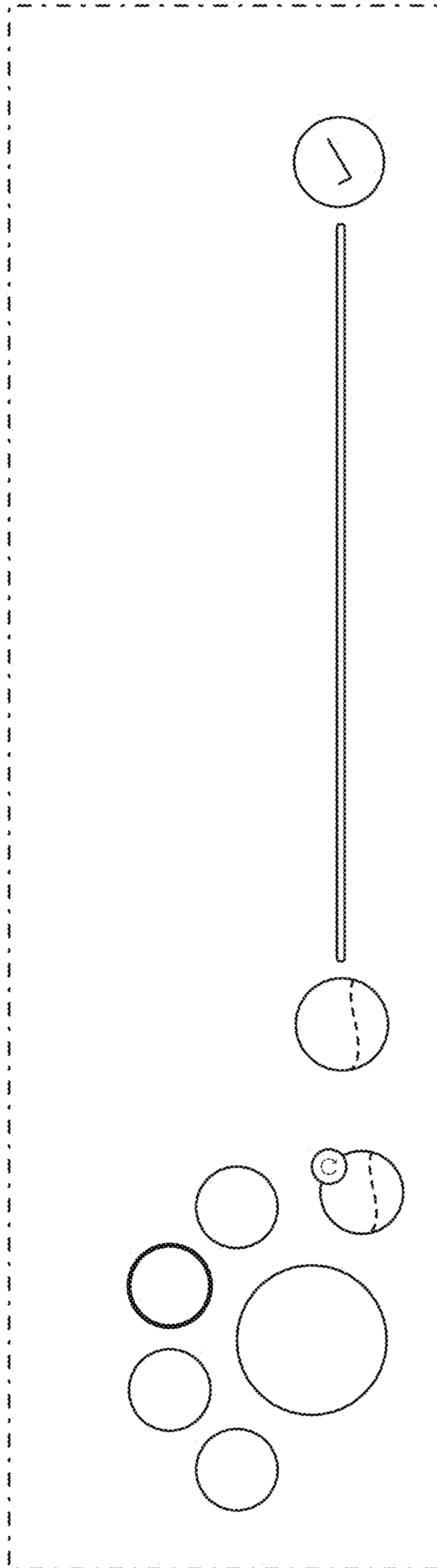

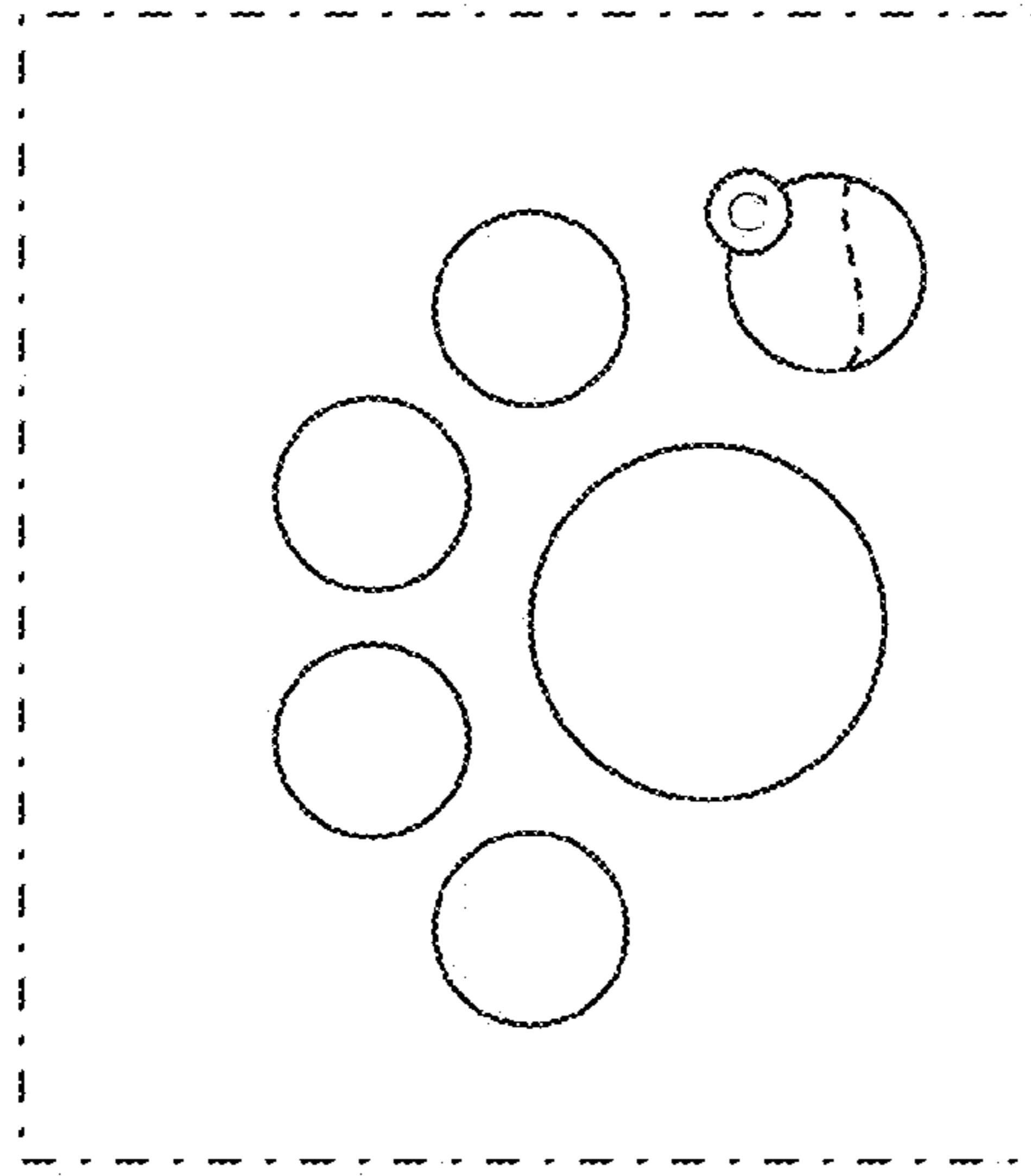

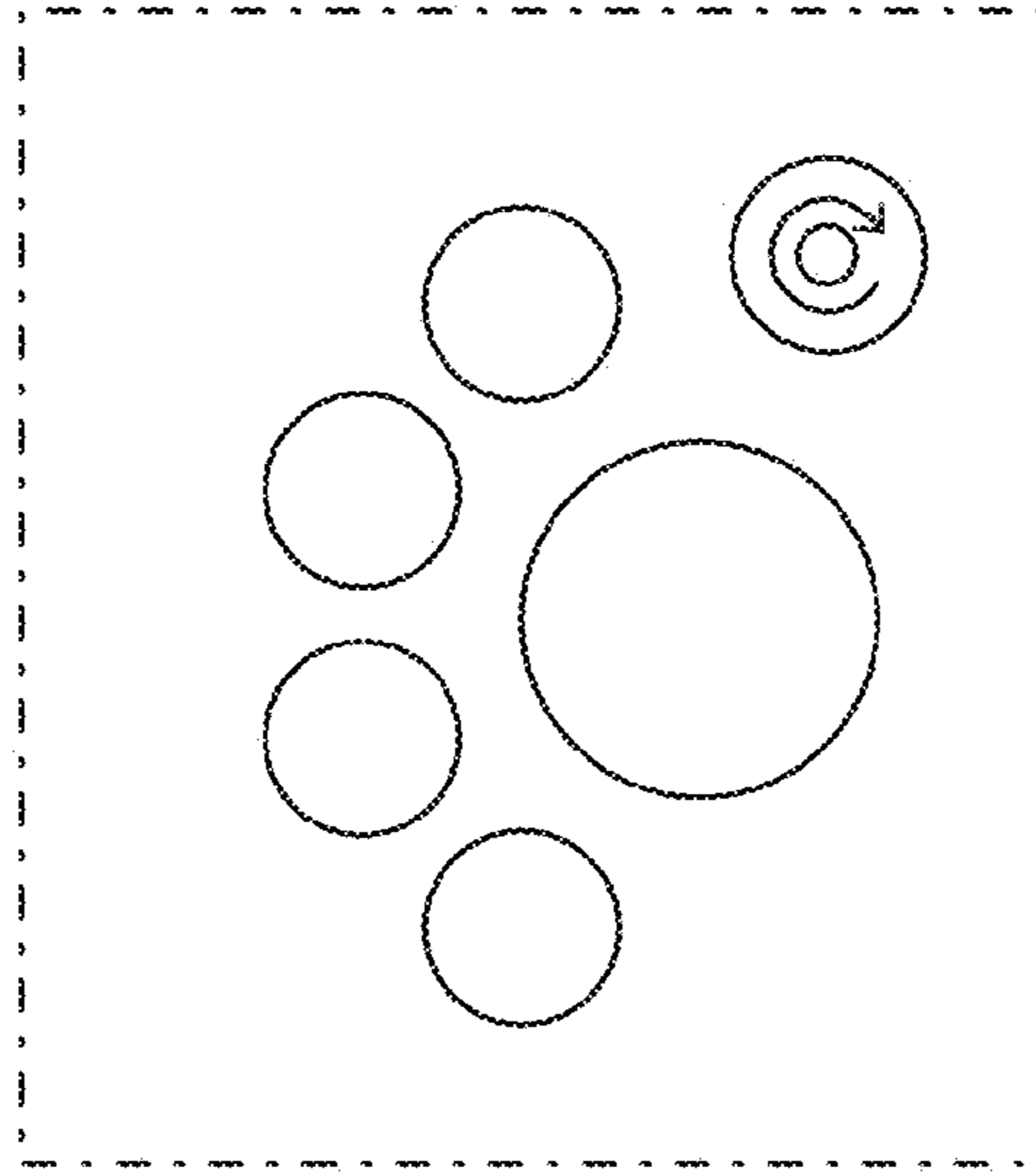

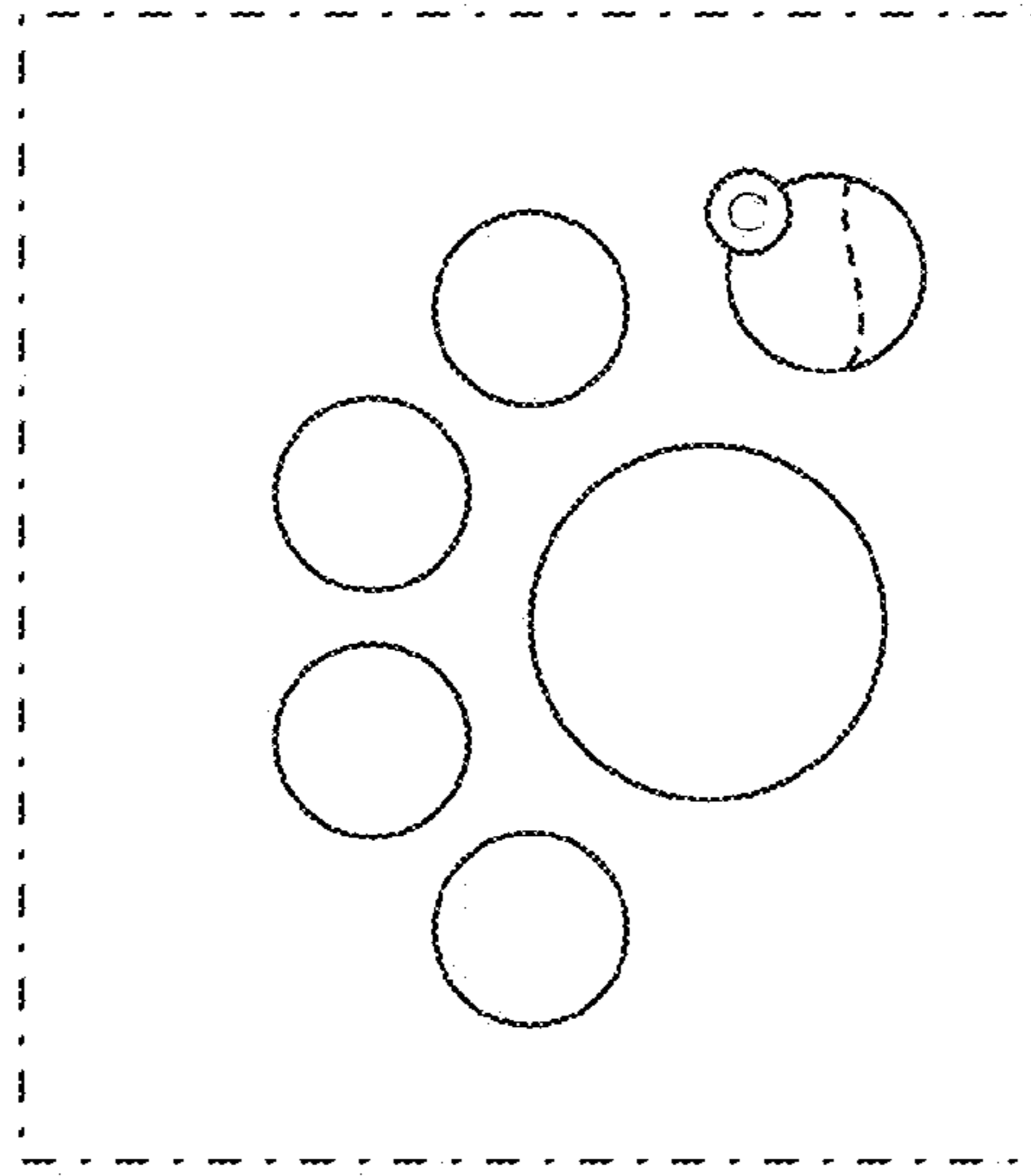

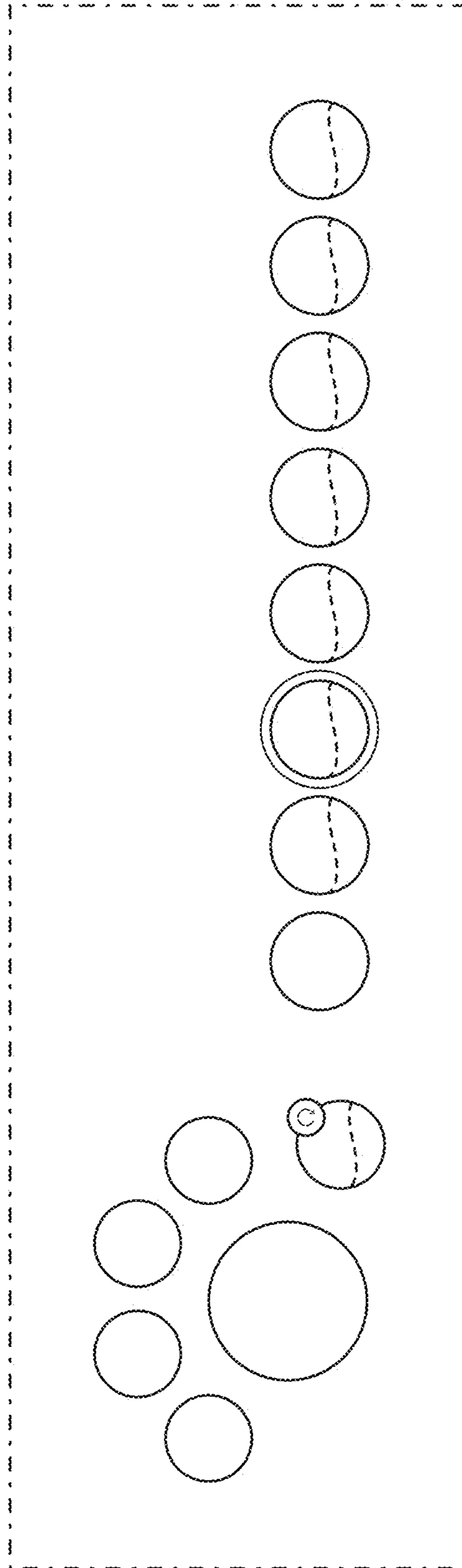

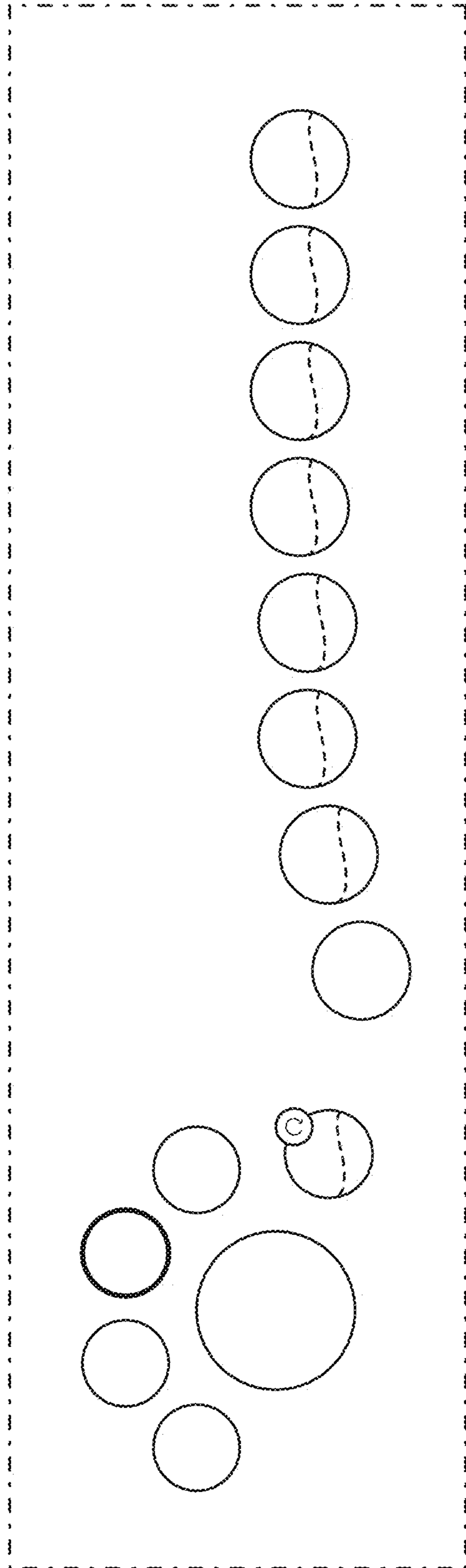

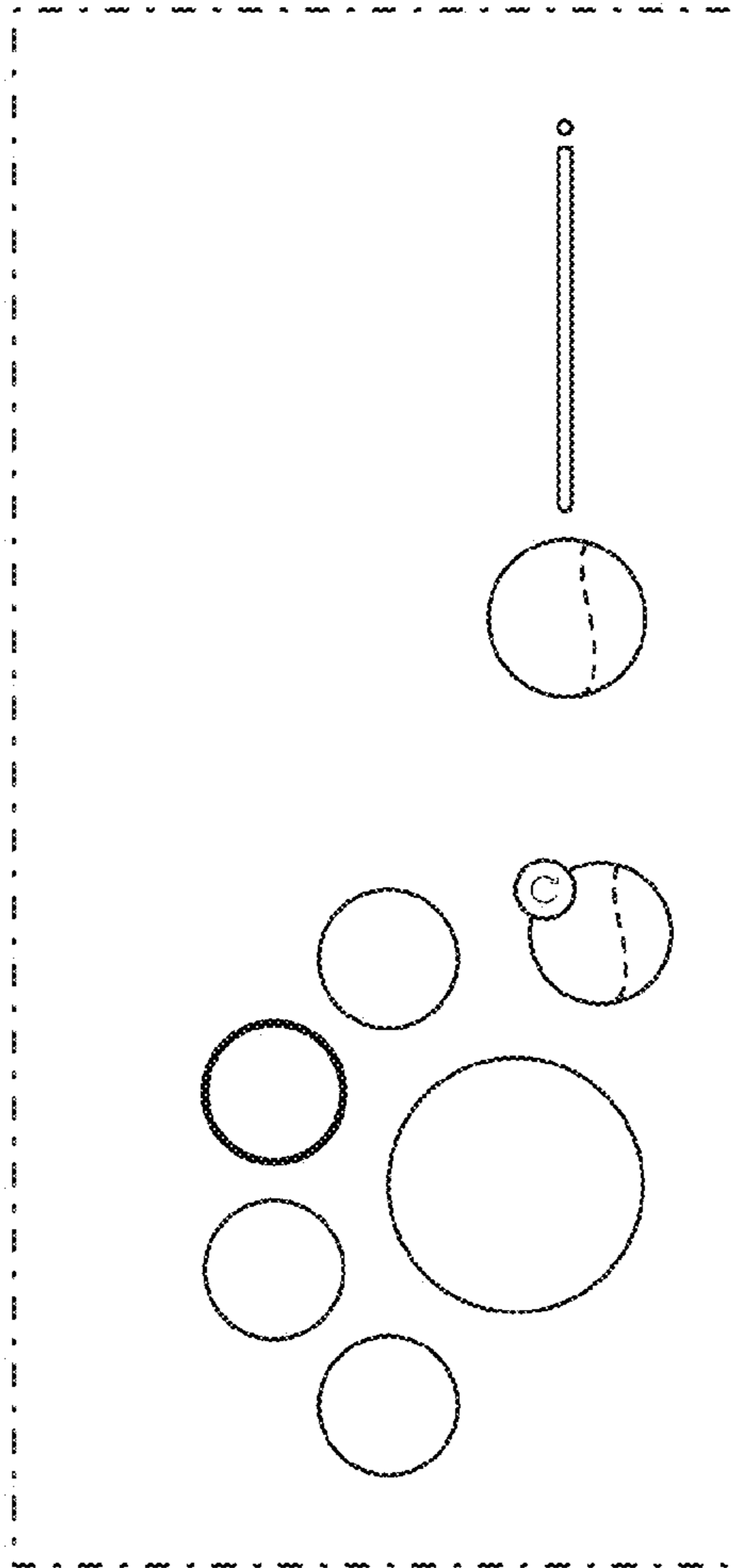

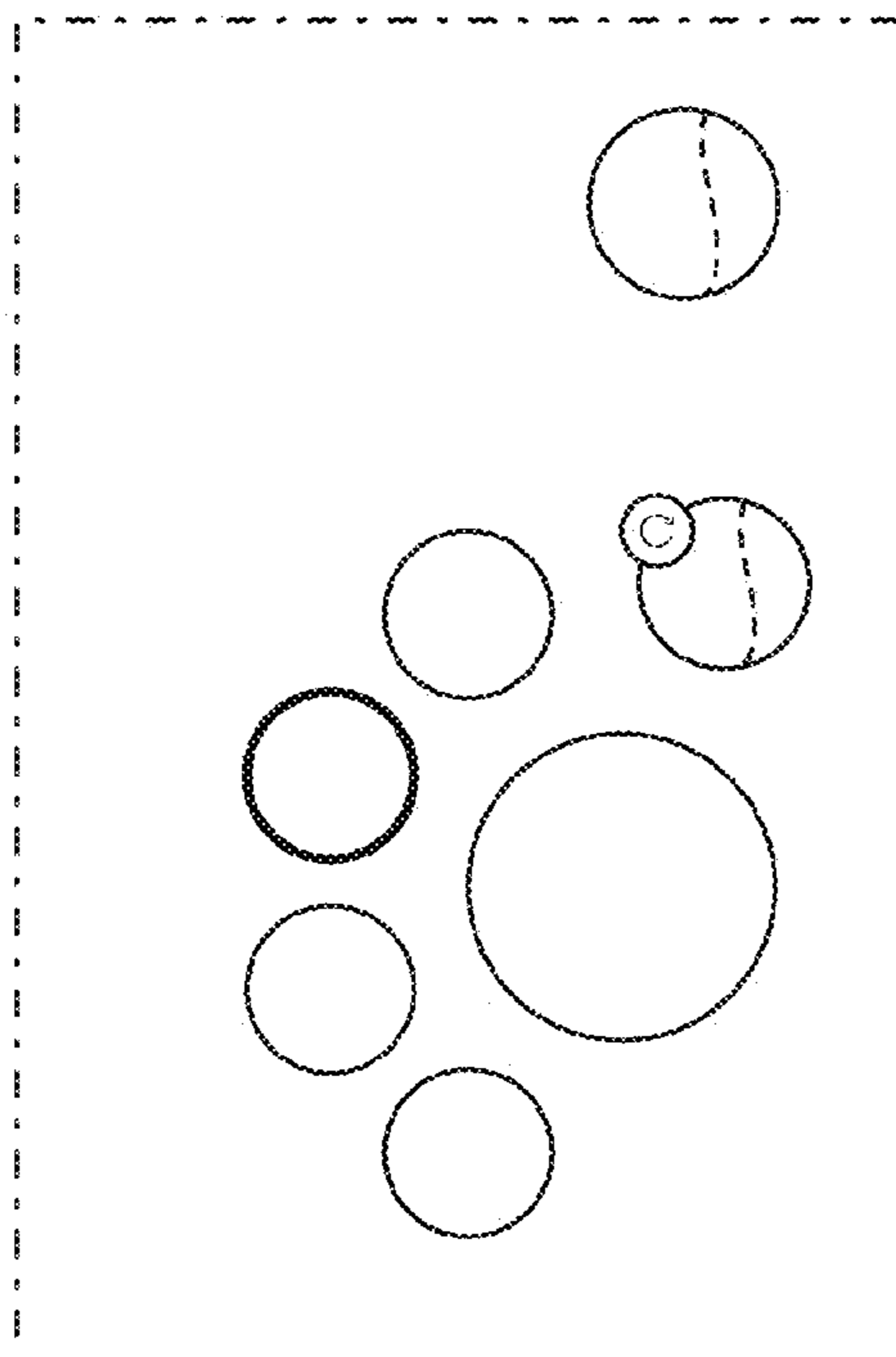

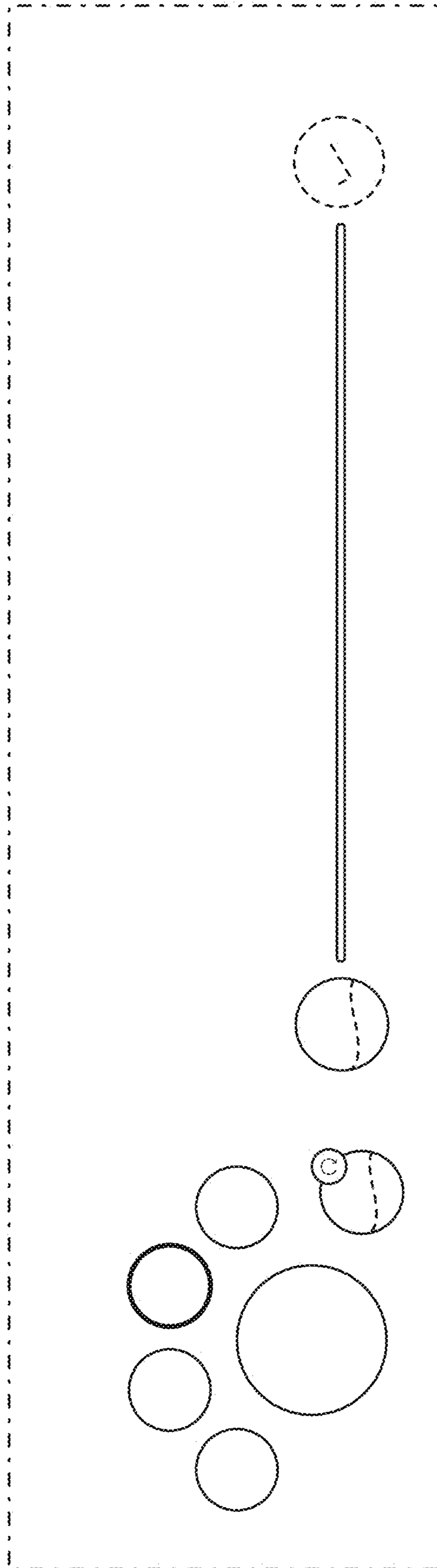
