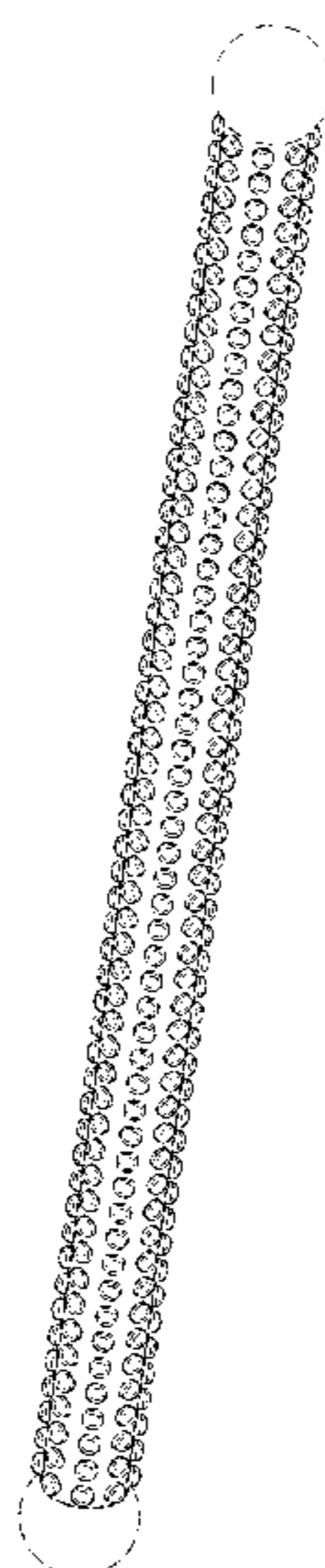
(57) **CLAIM**

I claim the ornamental design for a noodle string with bumps, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, left perspective view of the noodle string with bumps;  
FIG. 2 is a front elevation view thereof, in which the noodle string with bumps is symmetrical and the periodicity of the design continues to the left, rear, and right sides thereof; and, FIG. 3 is a top side plan view thereof, the bottom side plan view being a mirror image of the top side plan view.  
Broken lines, such as those showing the rounded balls on the ends, represent portions of the noodle string with bumps that form no part of the claimed design.

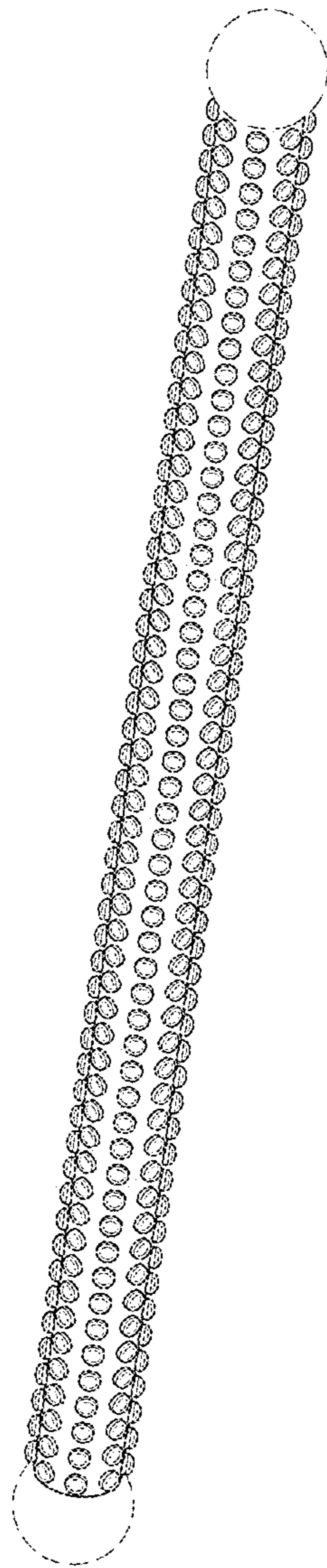

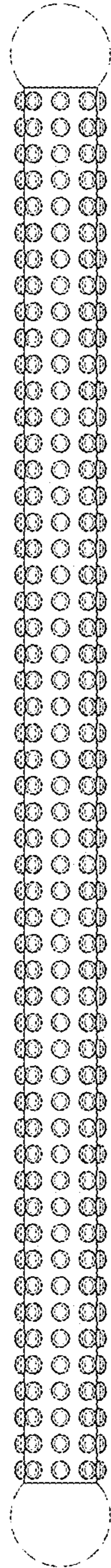
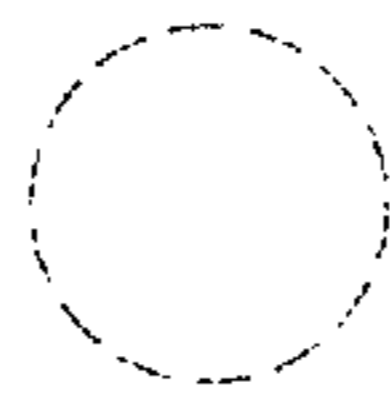
