FIG. 3 is a front side elevational view of the face mask of FIG. 1;

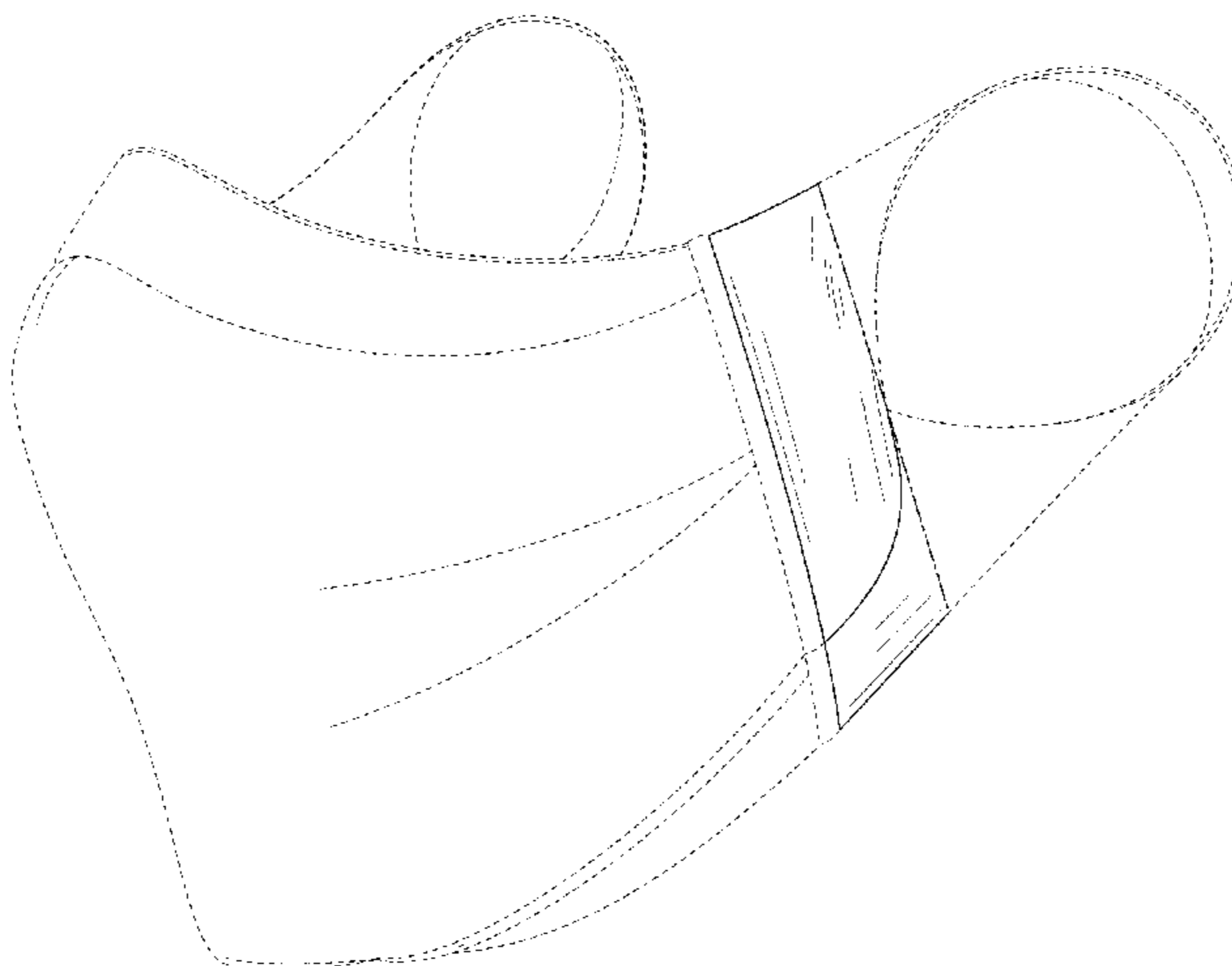
FIG. 4 is a rear side elevational view of the face mask of FIG. 1;

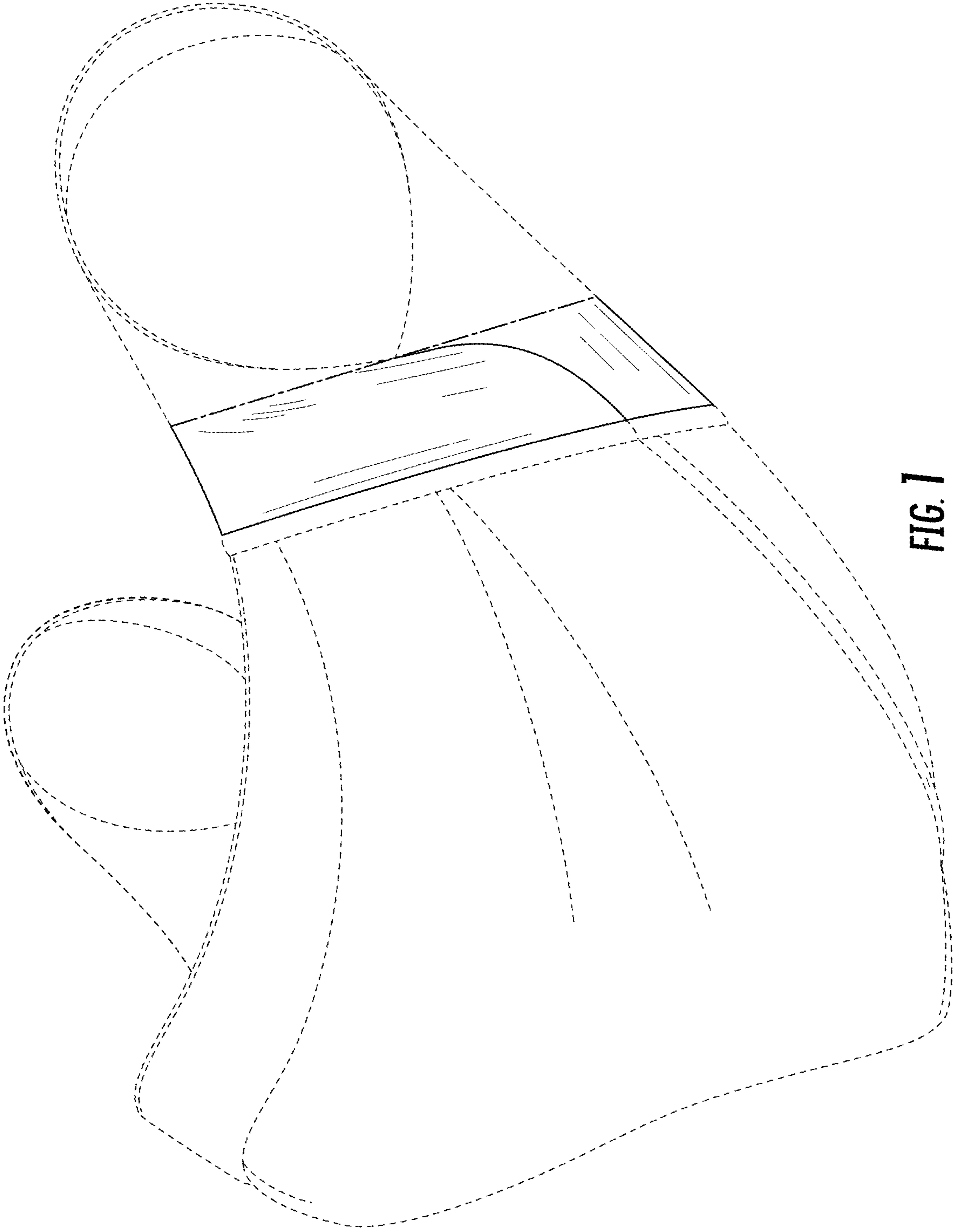

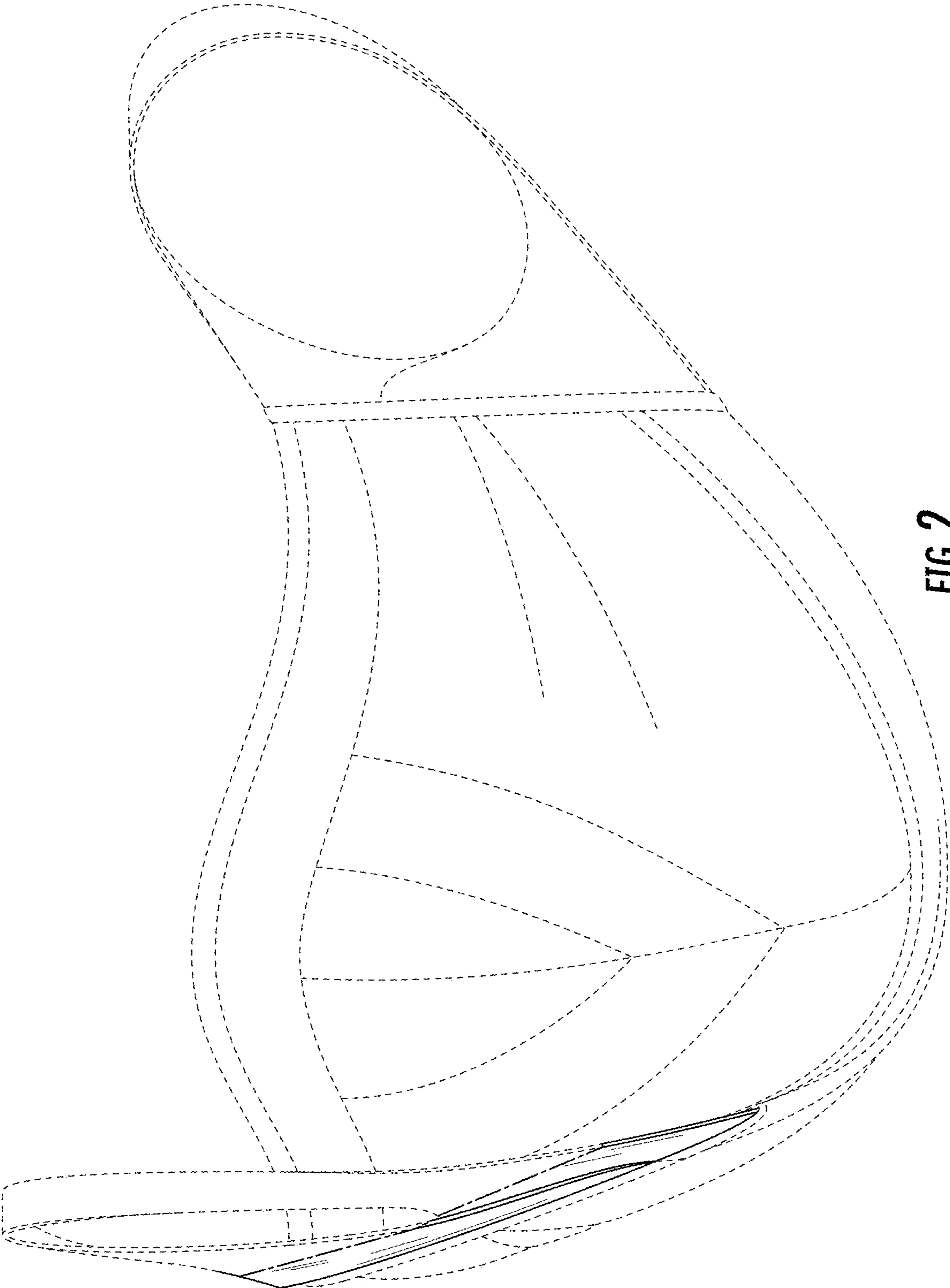

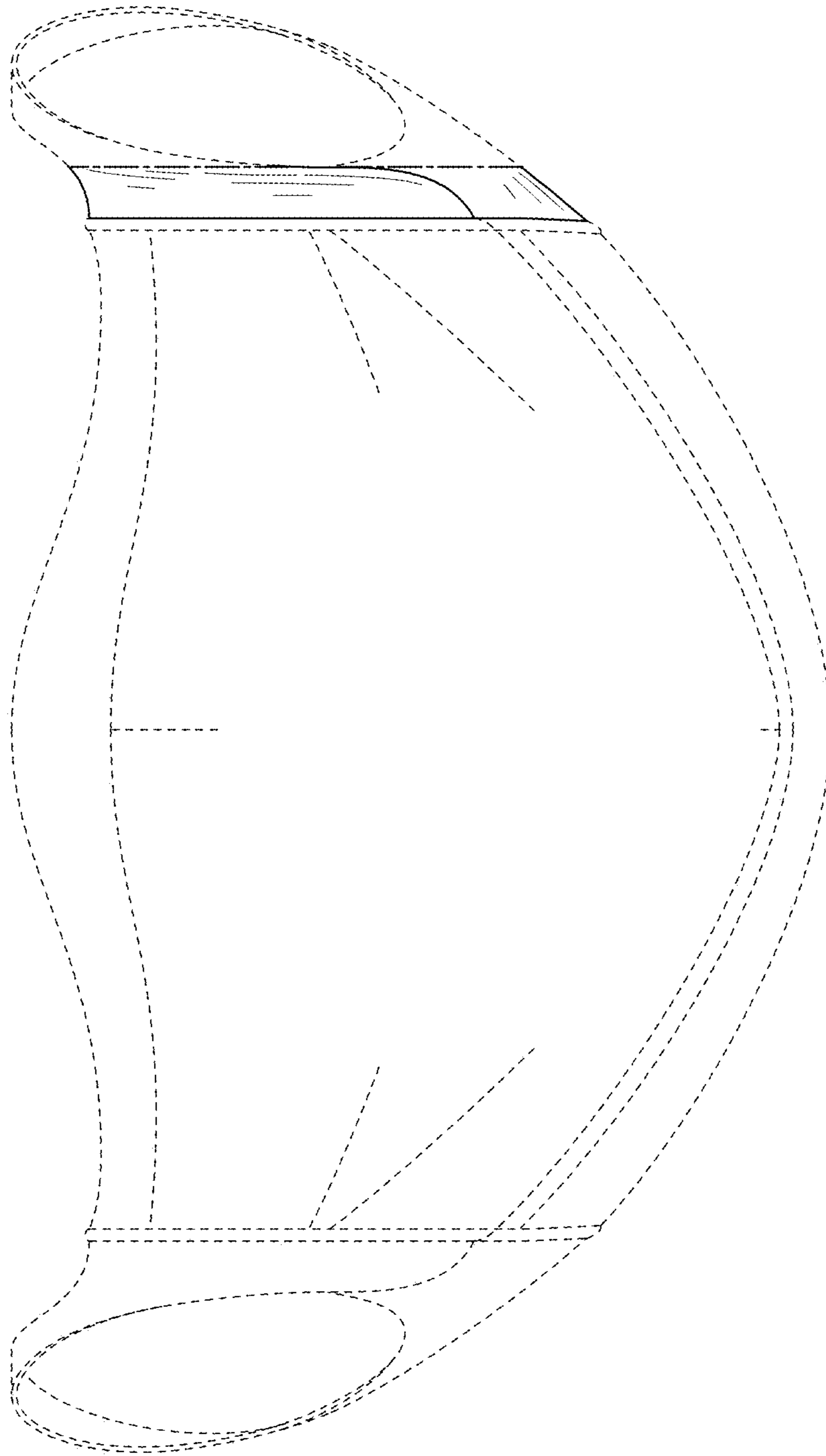

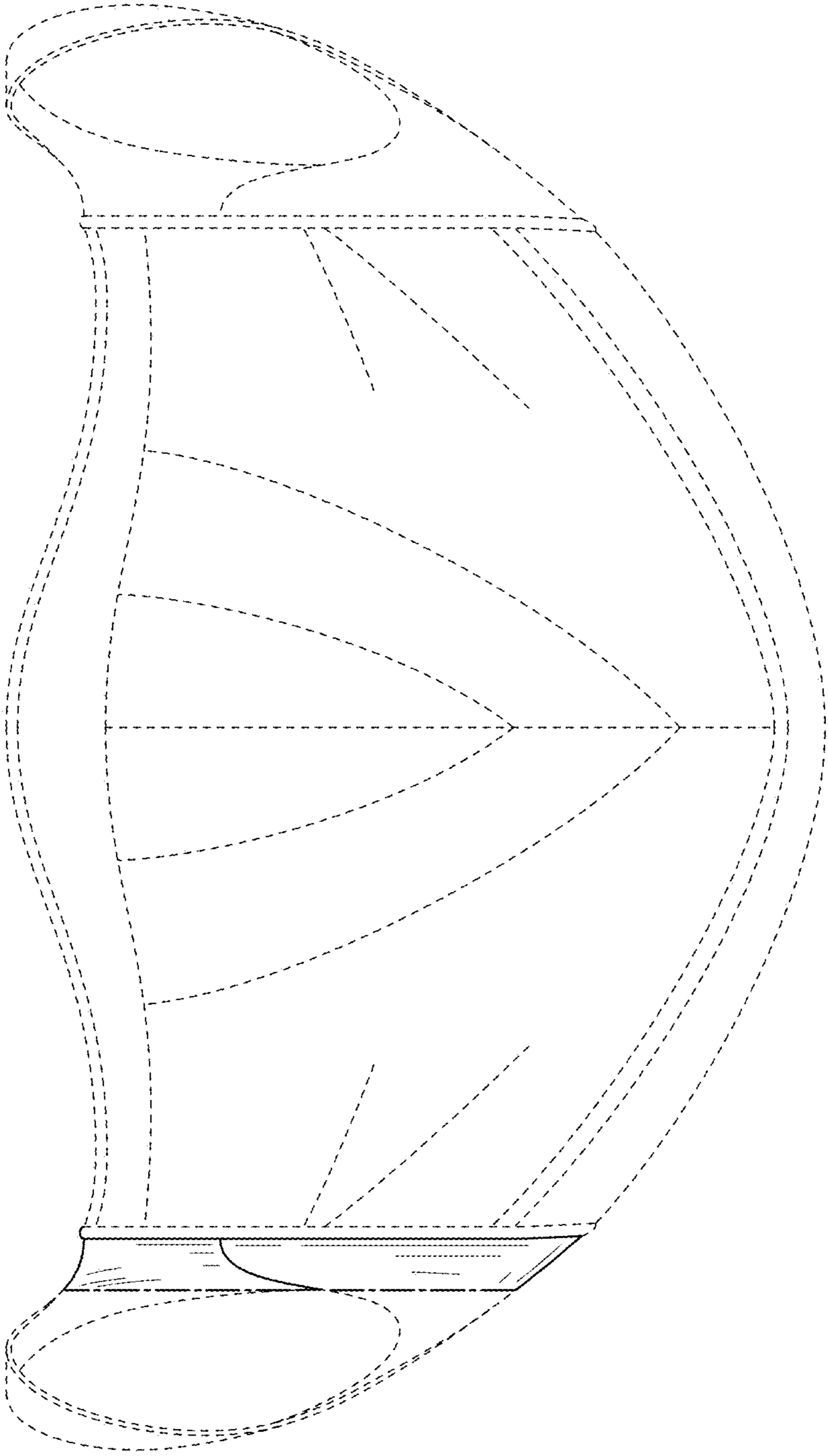

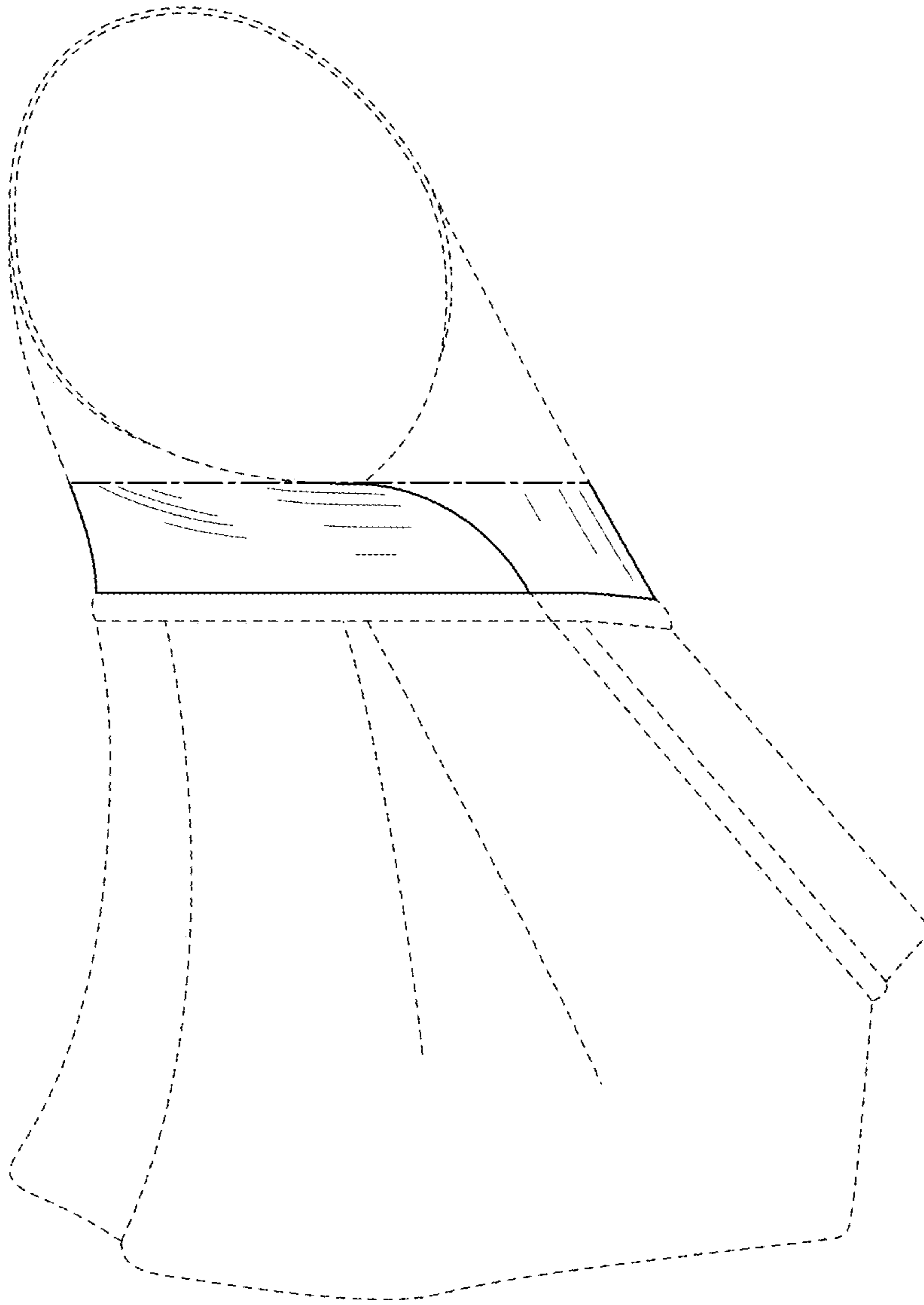
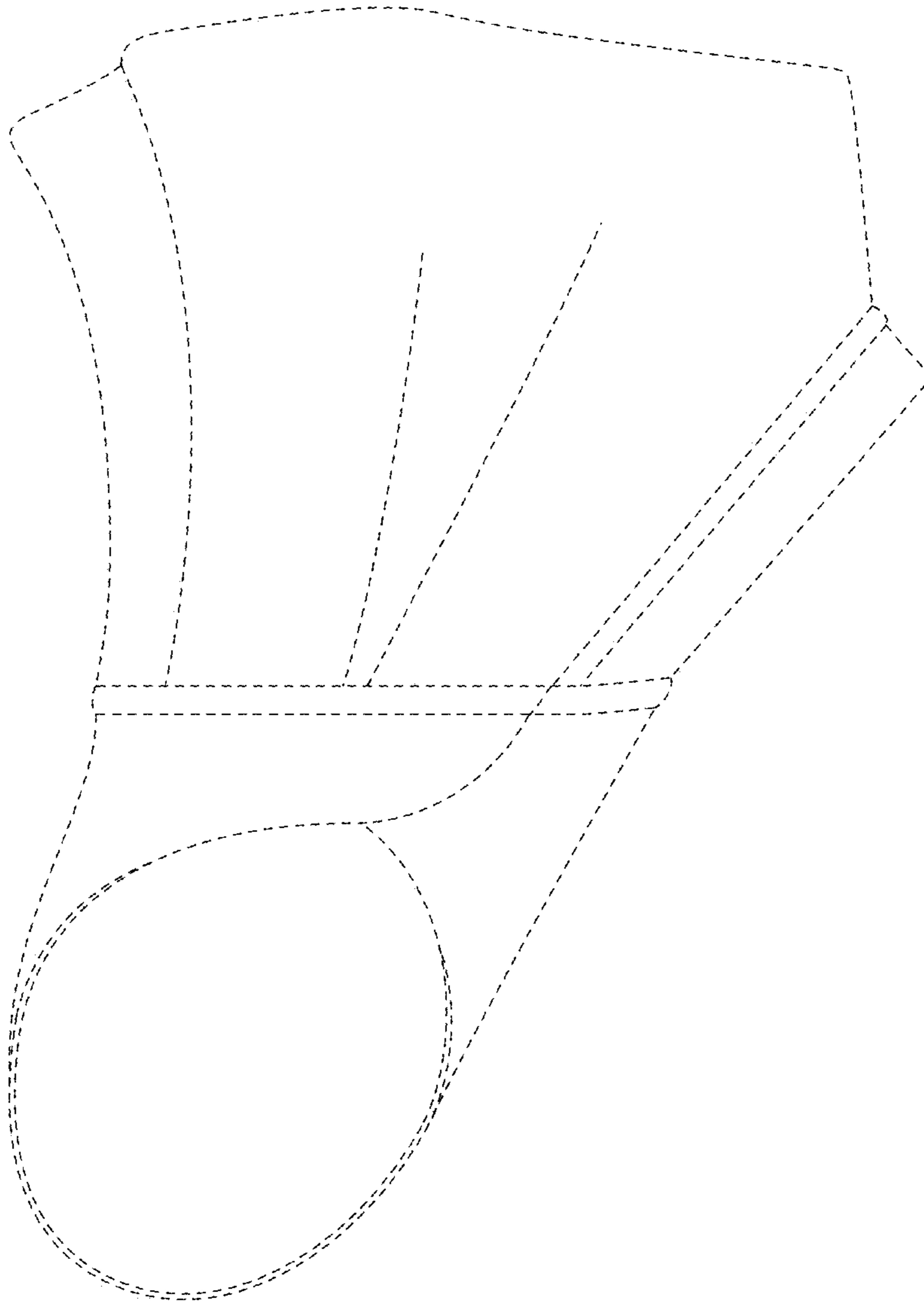

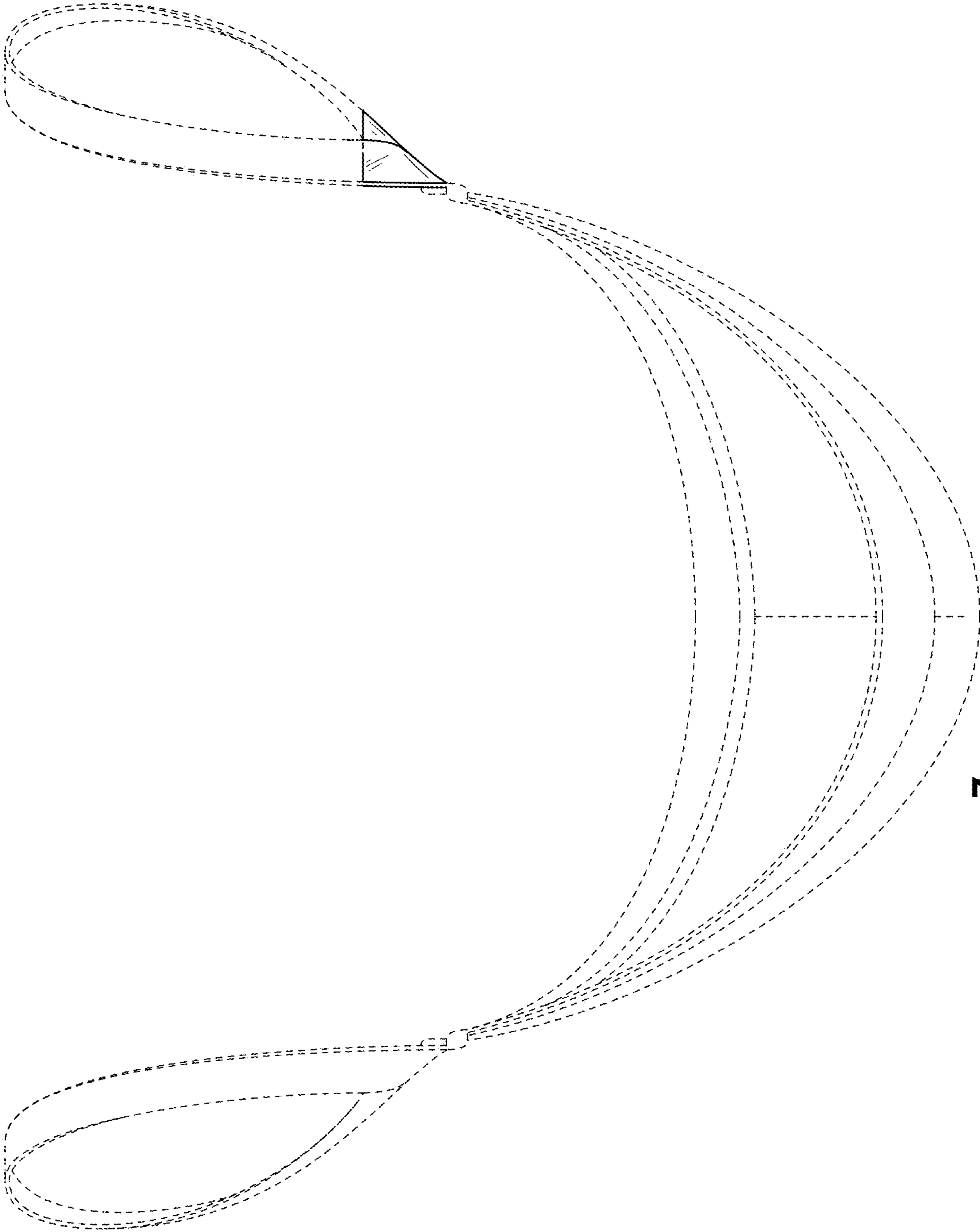

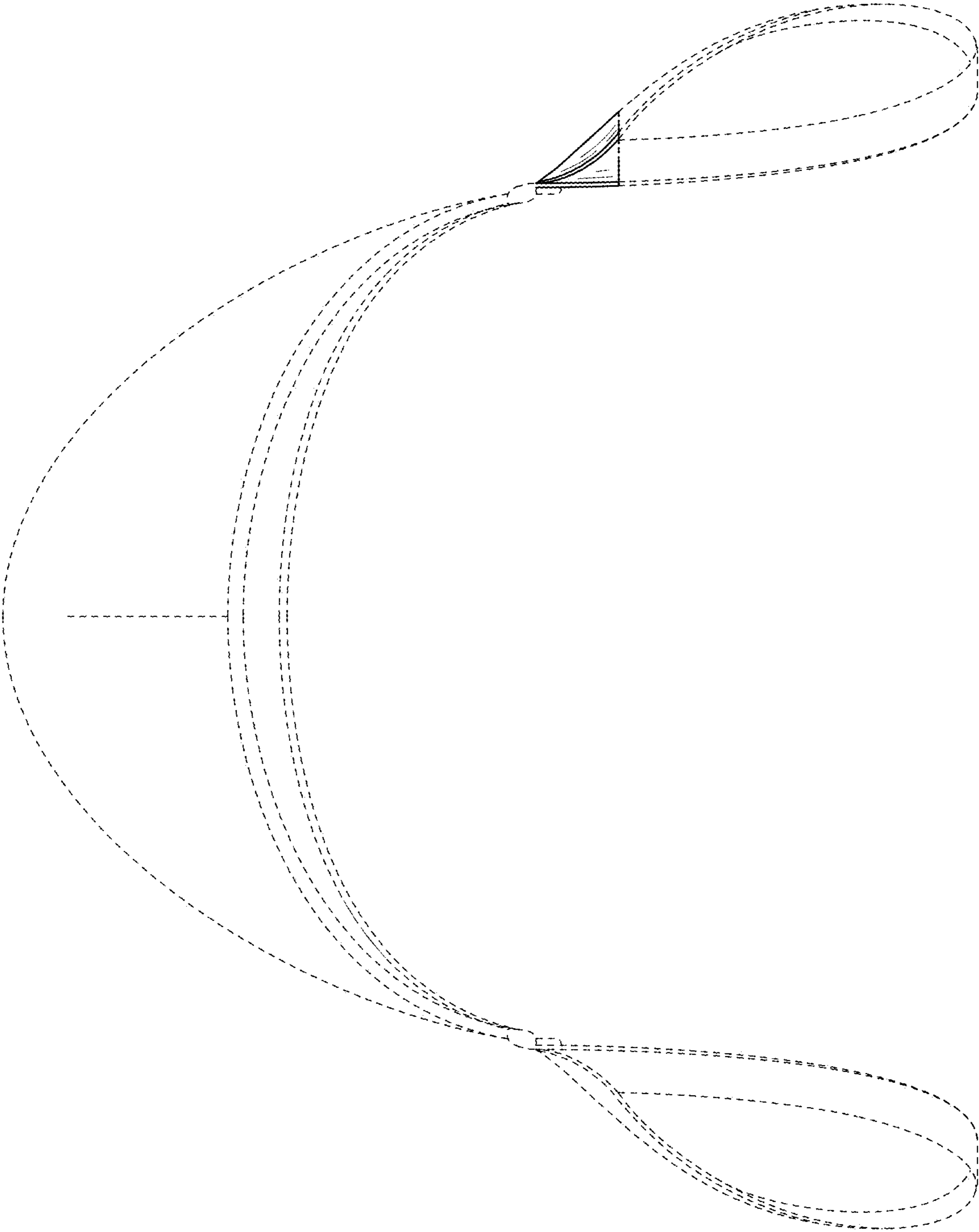
