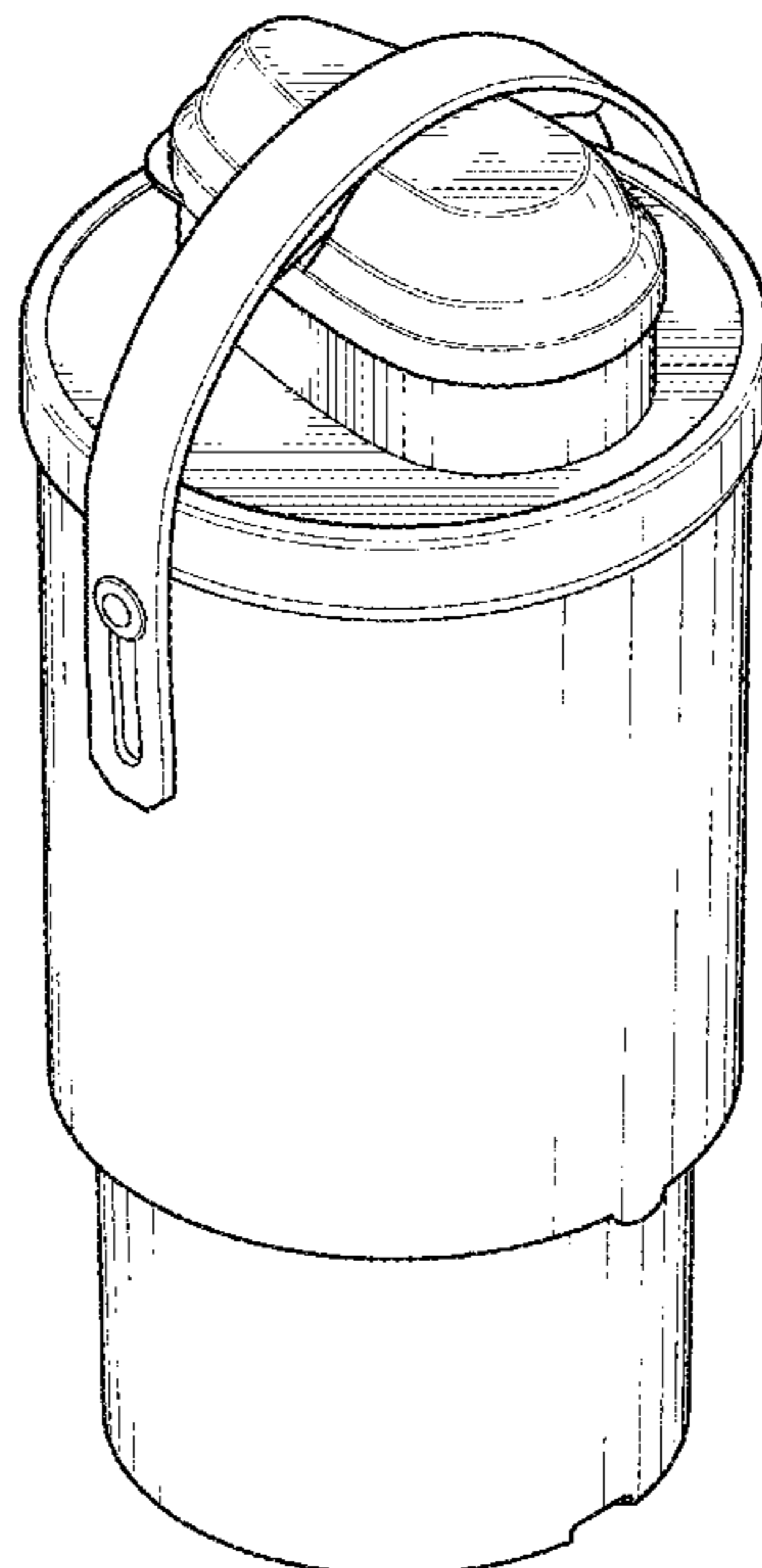
(57) **CLAIM**

The ornamental design for an elution generator canister assembly, substantially as shown and described.

DESCRIPTION

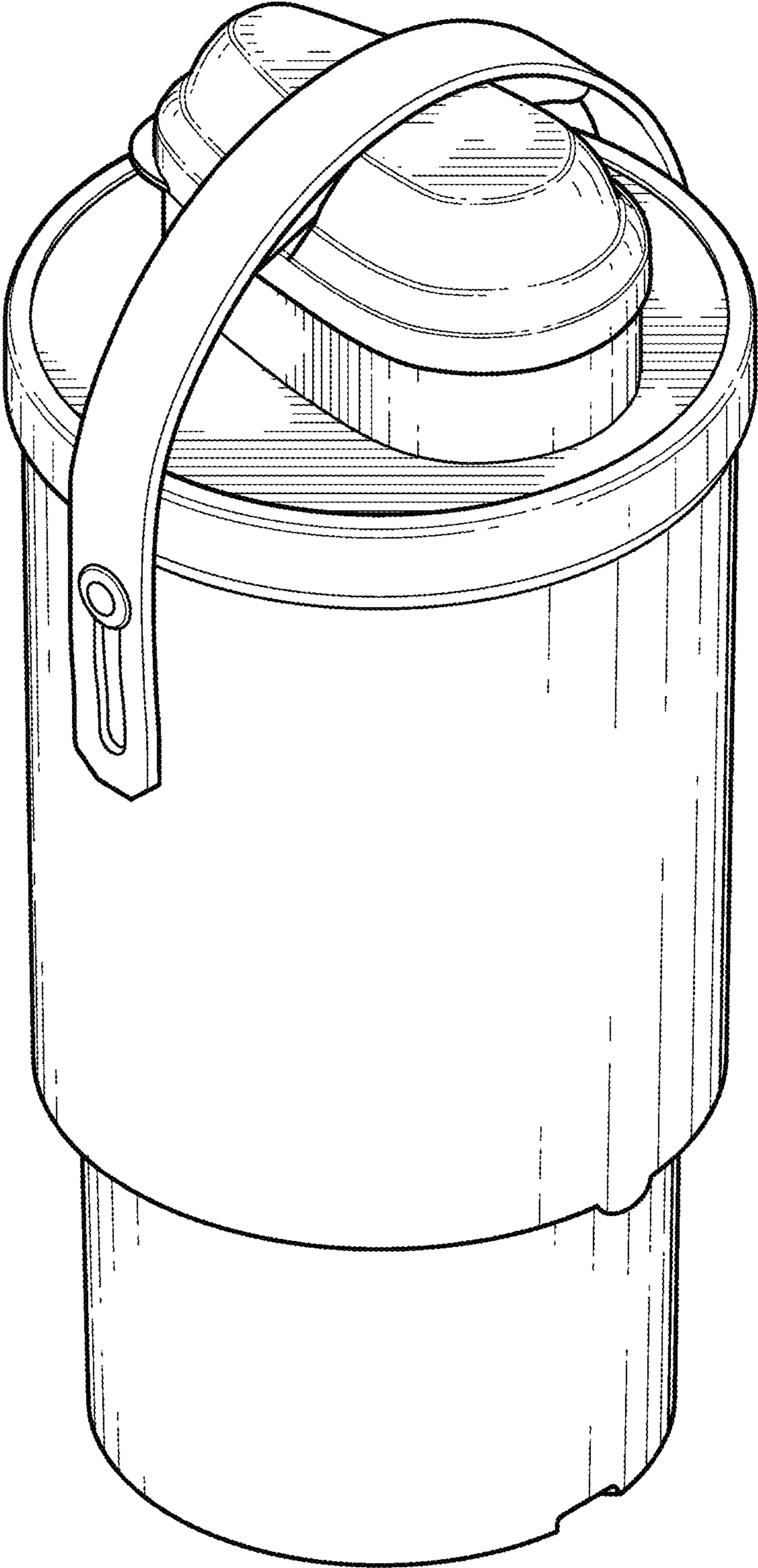

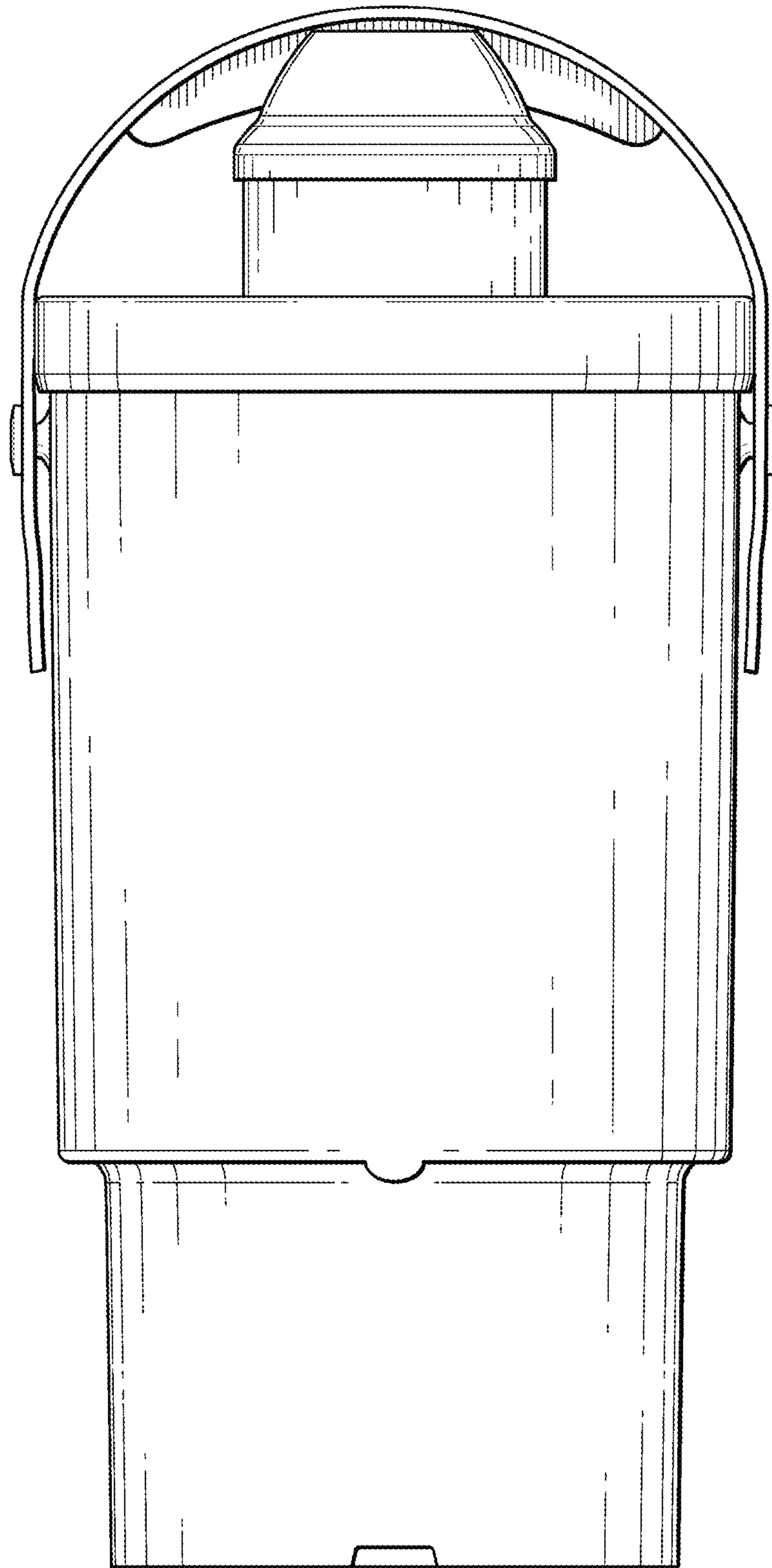

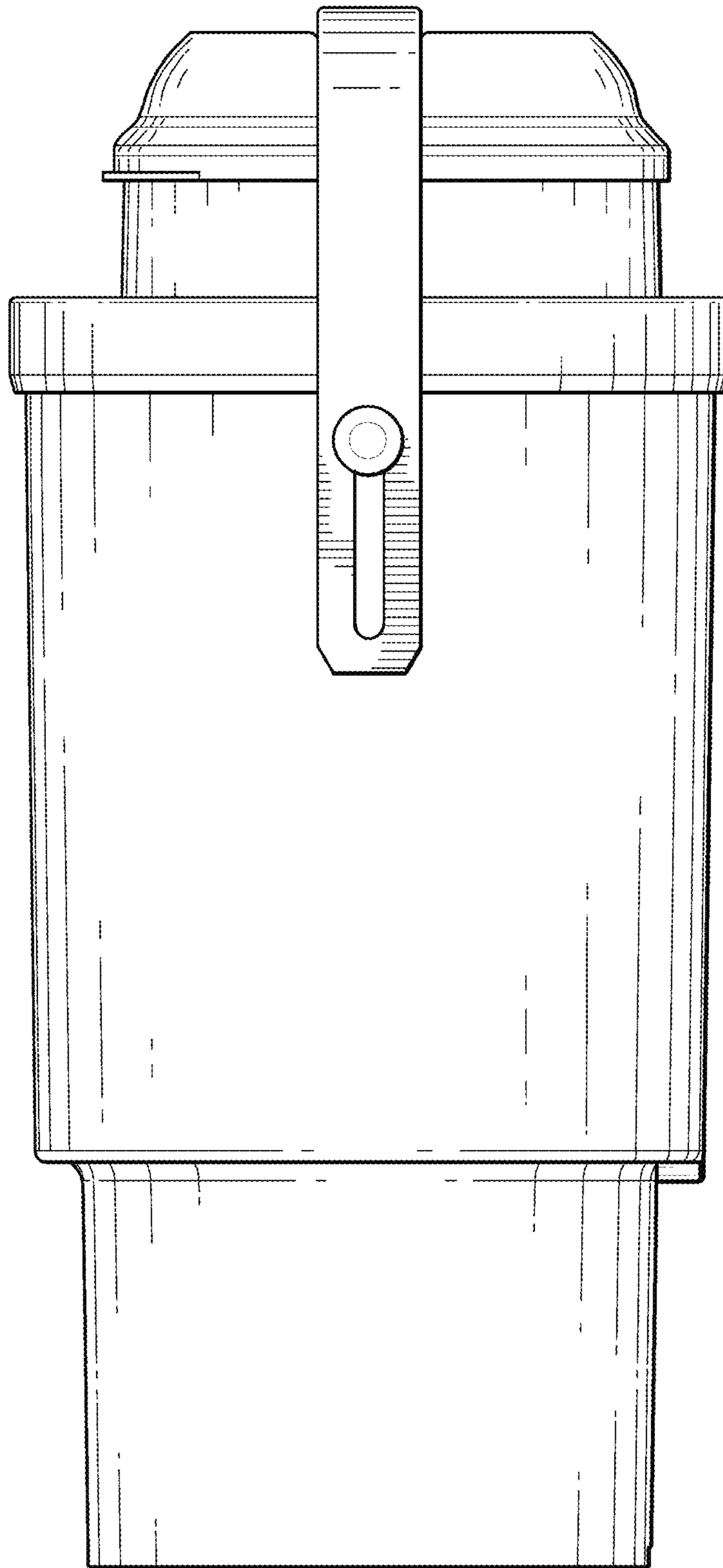

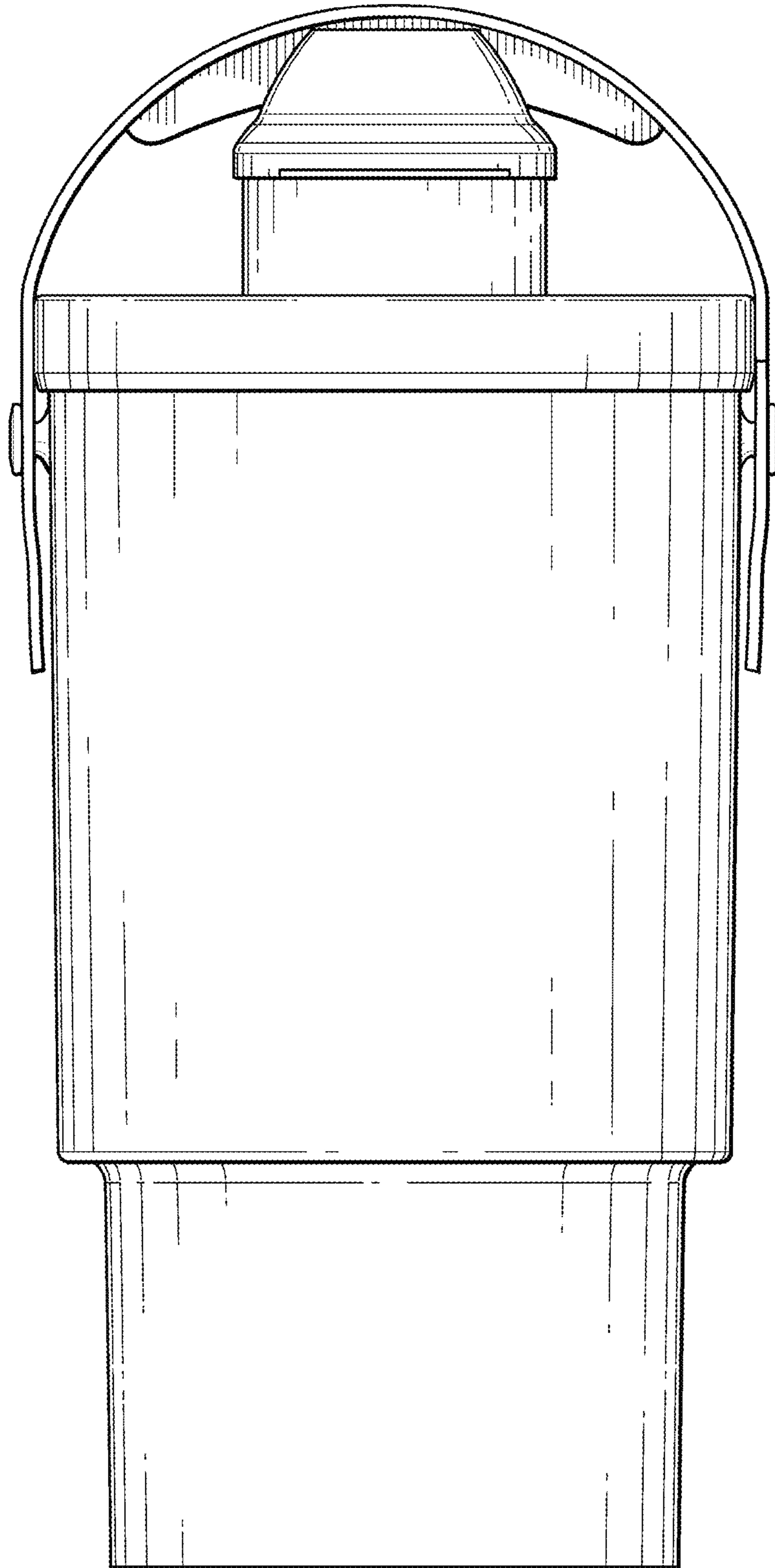

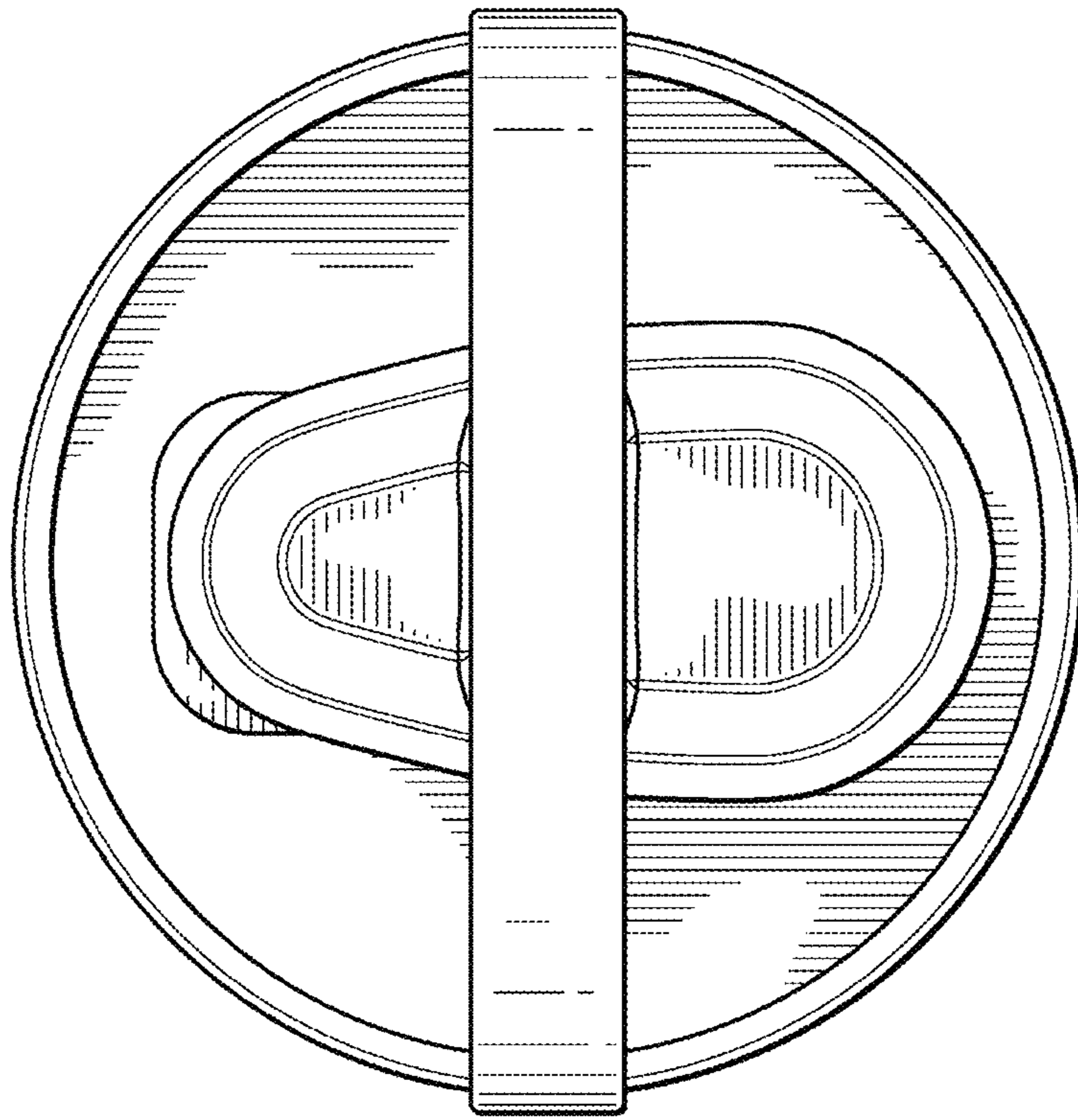

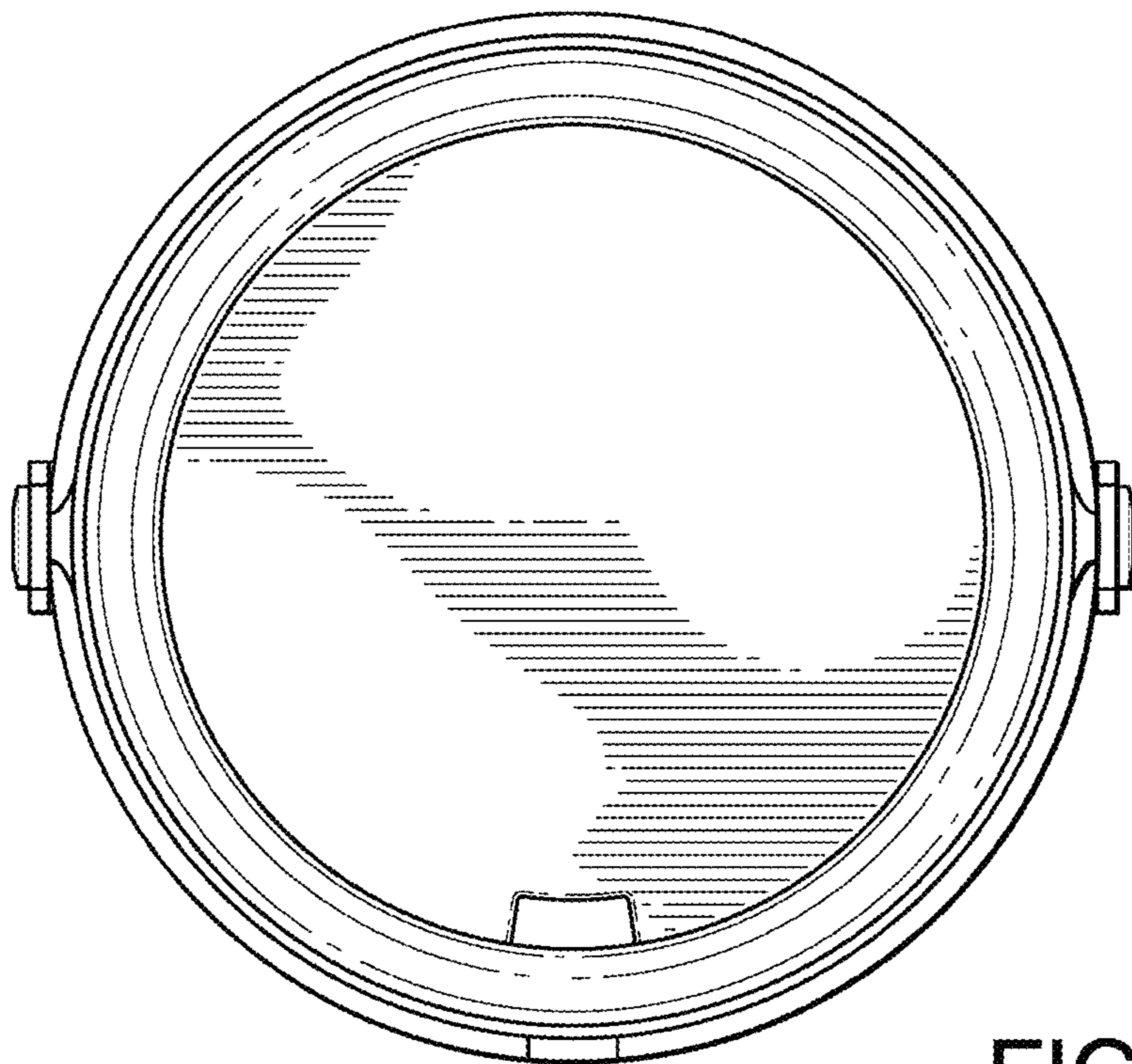
