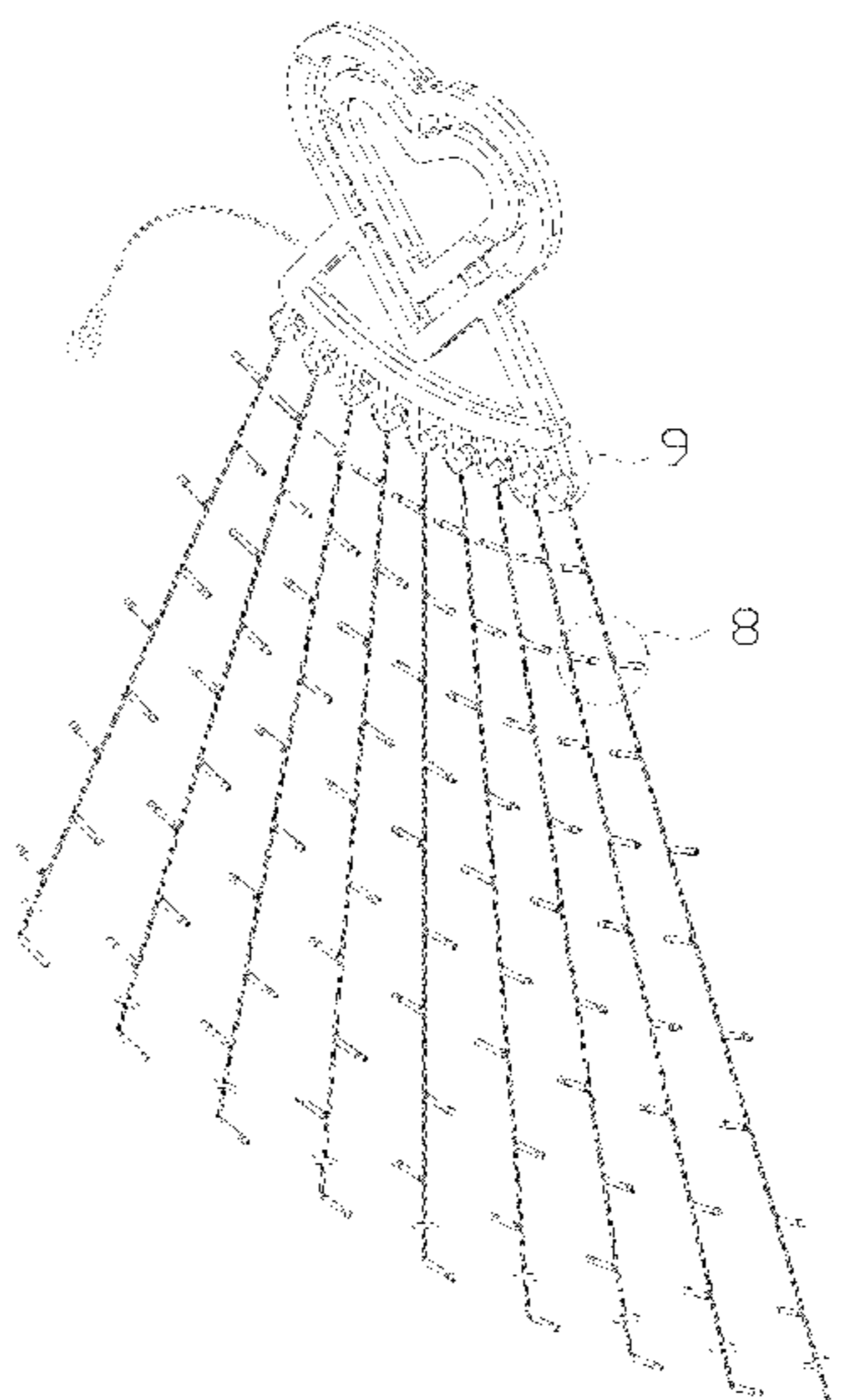

(57) **CLAIM**
The ornamental design for a light assembly, as shown and described.

DESCRIPTION
FIG. 1 is a perspective view of a light assembly showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is an enlarged view of portion 8 shown in FIG. 1; and,
FIG. 9 is an enlarged view of portion 9 shown in FIG. 1.
The dash-dash broken lines in the drawings depict portions of the light assembly that form no part of the claimed design. The dot-dash broken lines represent boundaries of the enlarged portions and form no part of the claimed design. The light assembly is shown with a symbolic break in its length and the appearance of any portion of the light assembly between the break lines form no part of the claimed design.

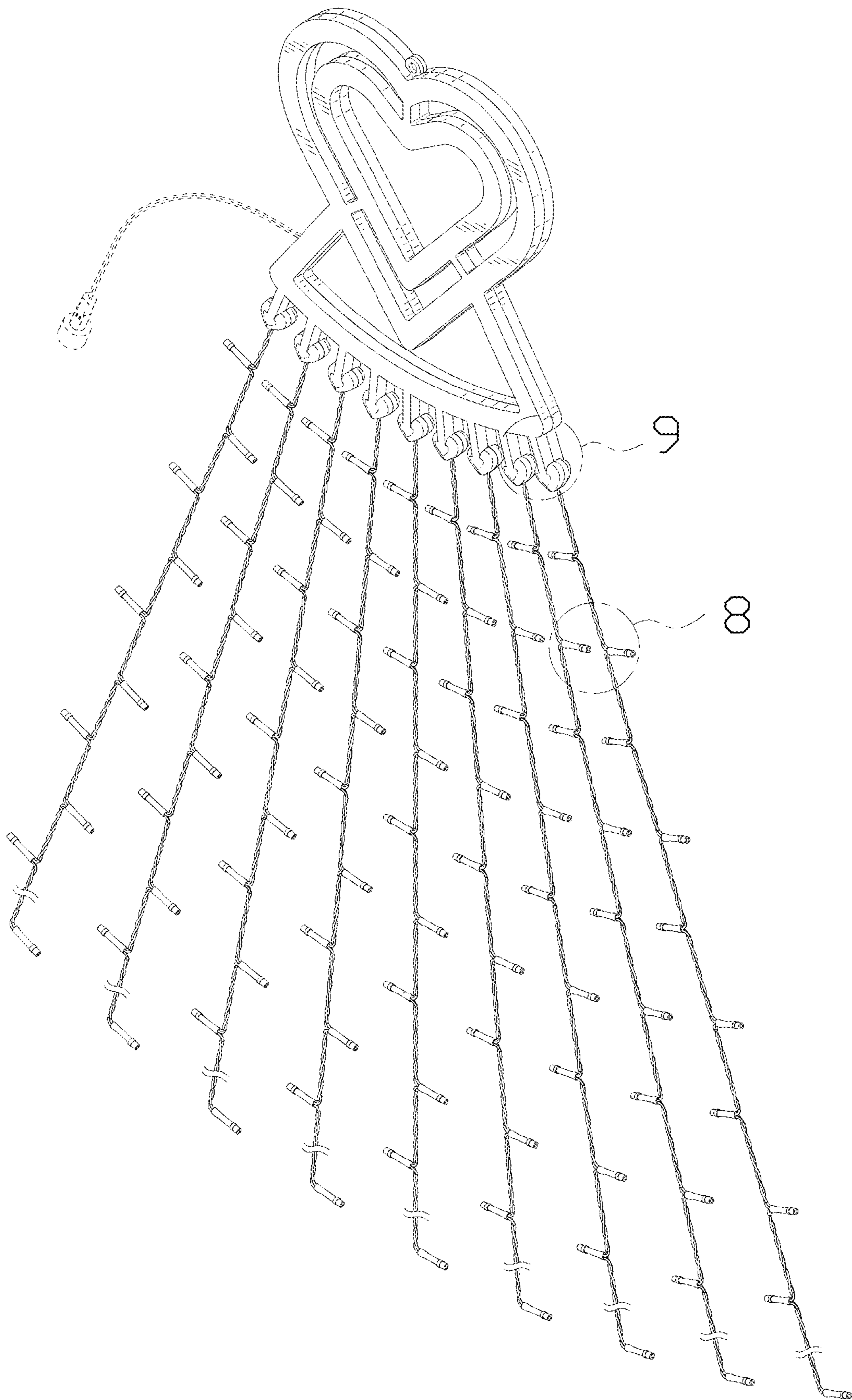

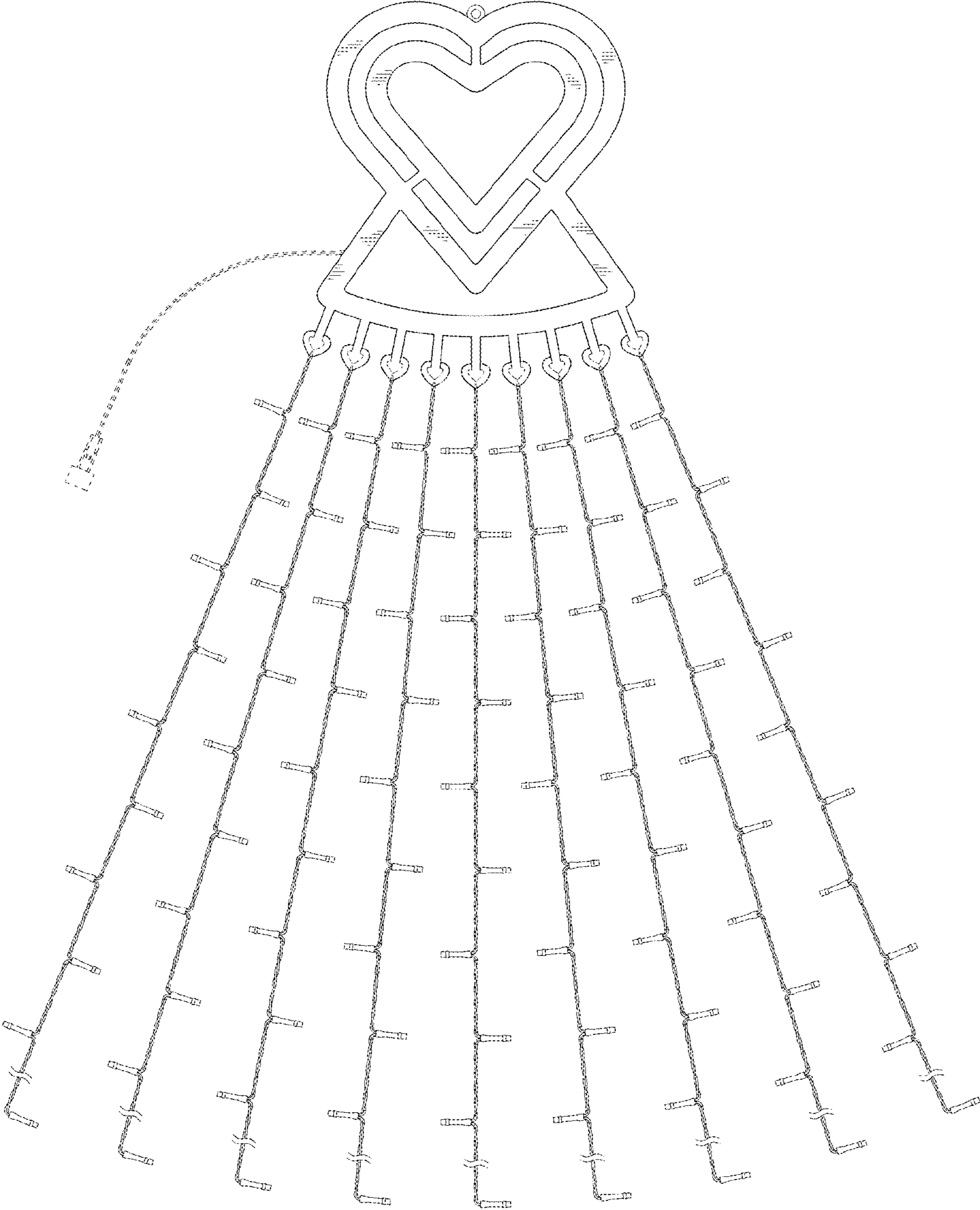

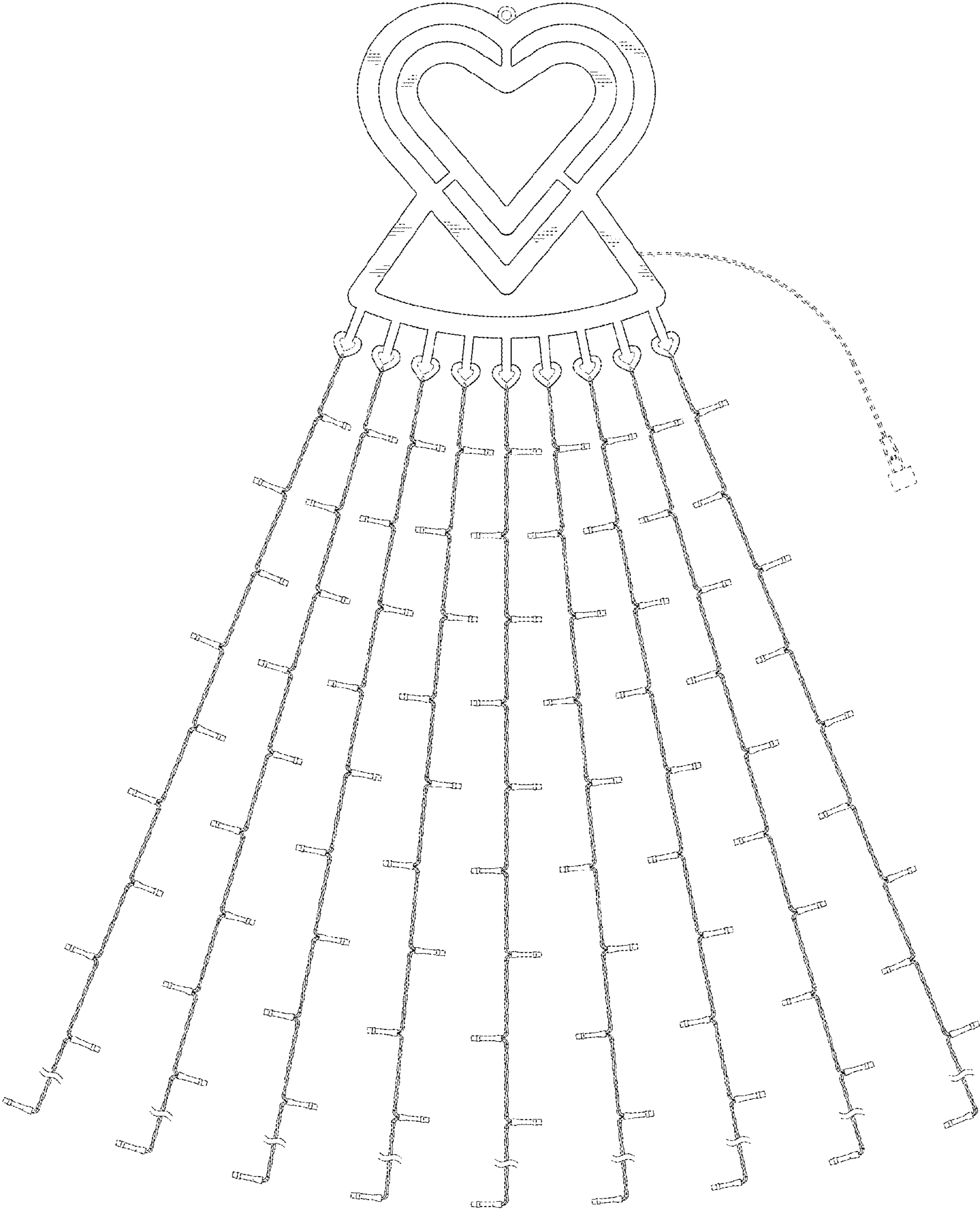

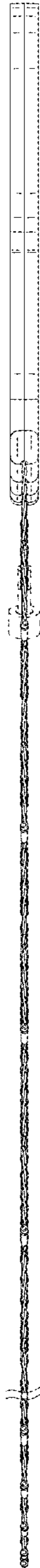

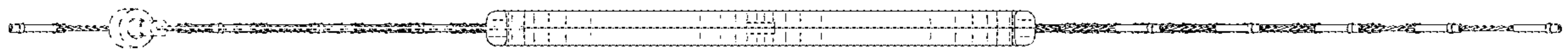

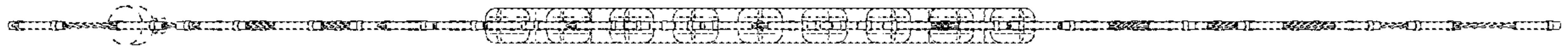

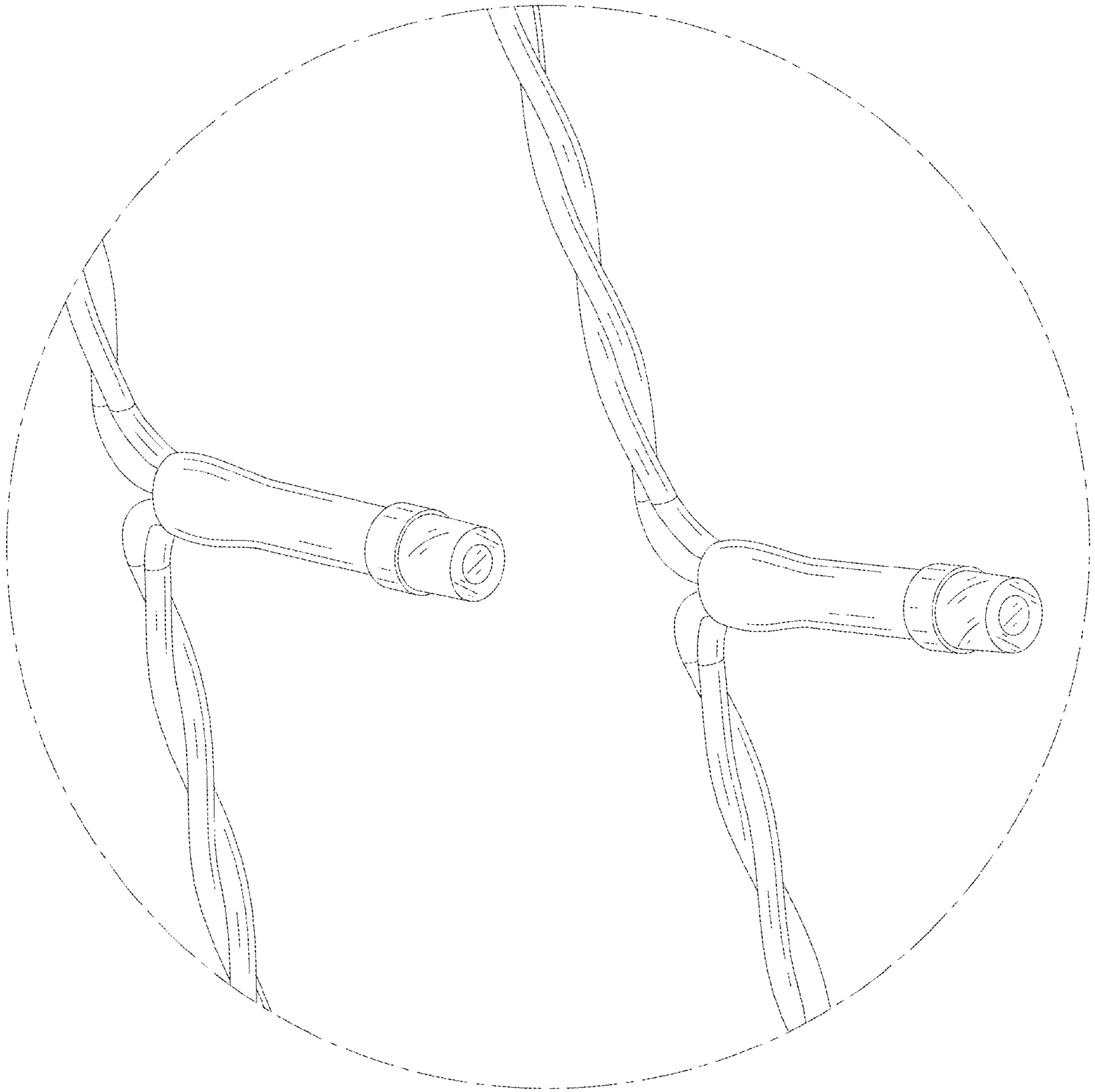

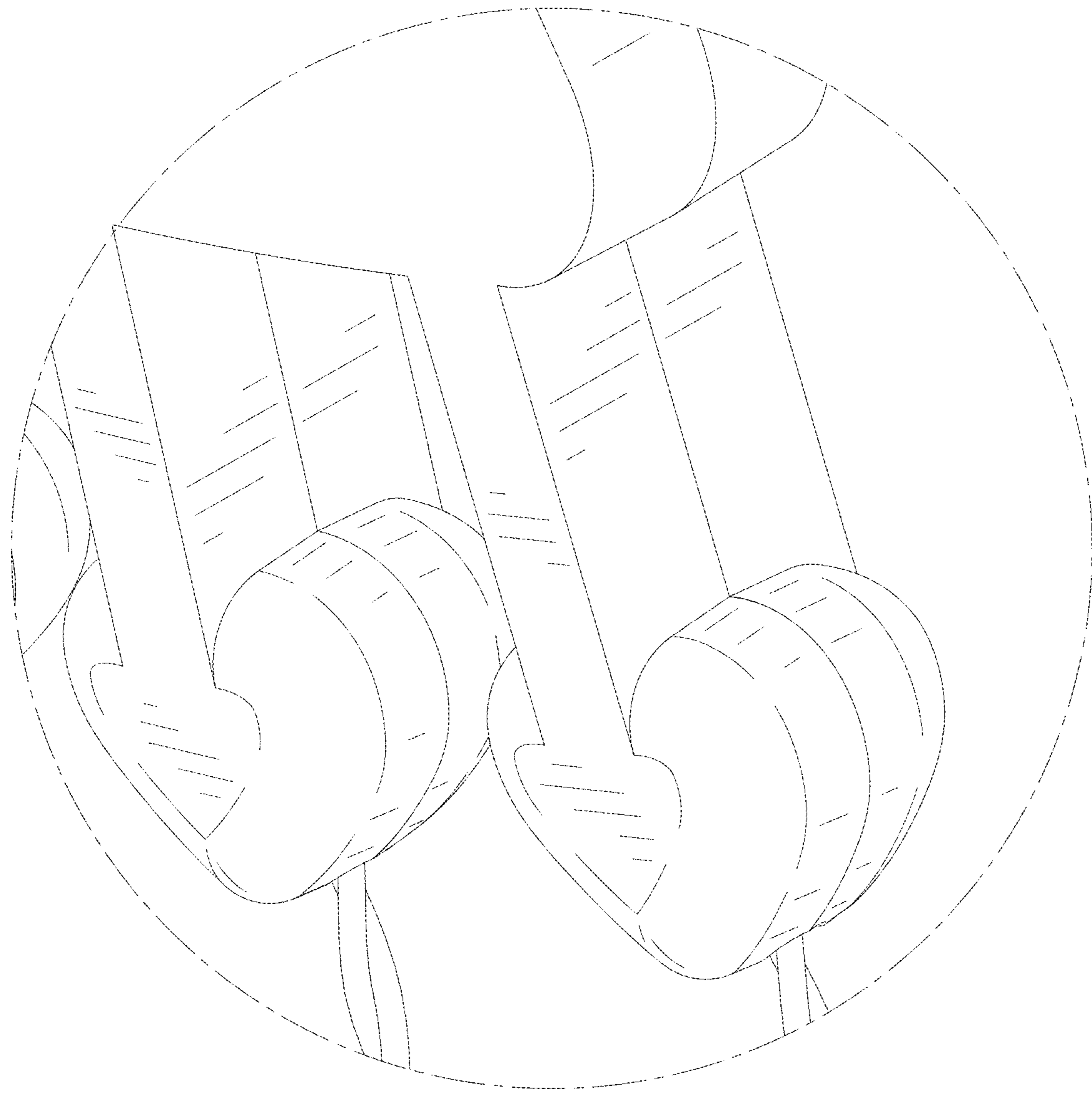
