DESCRIPTION

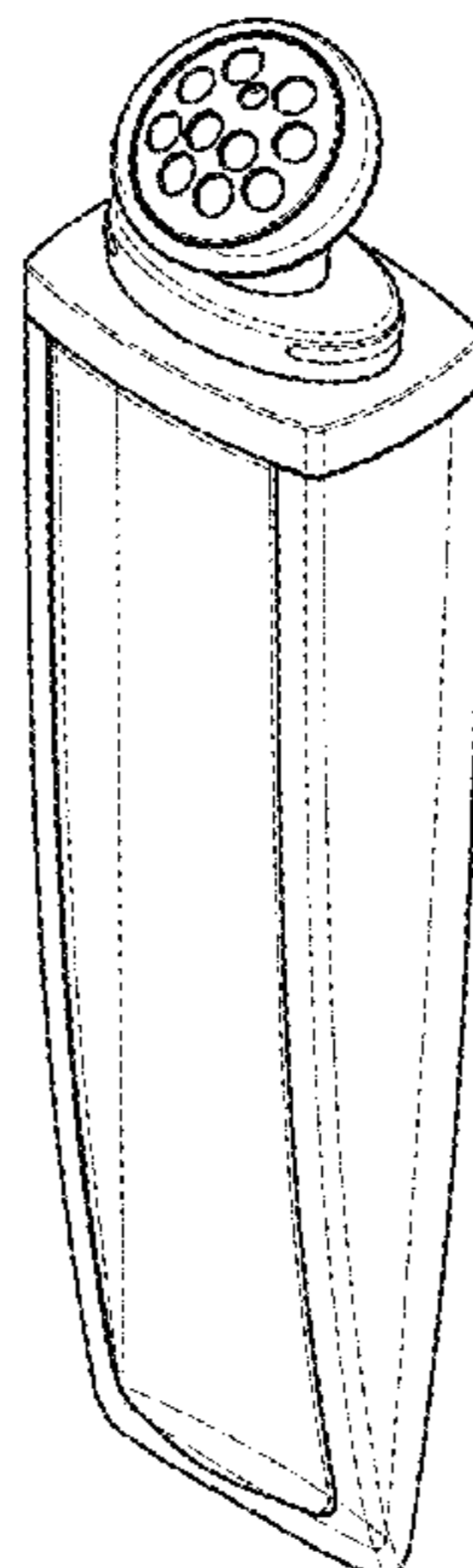
FIG. 1 is a top, front, and right side perspective view of the cosmetic product of our design.

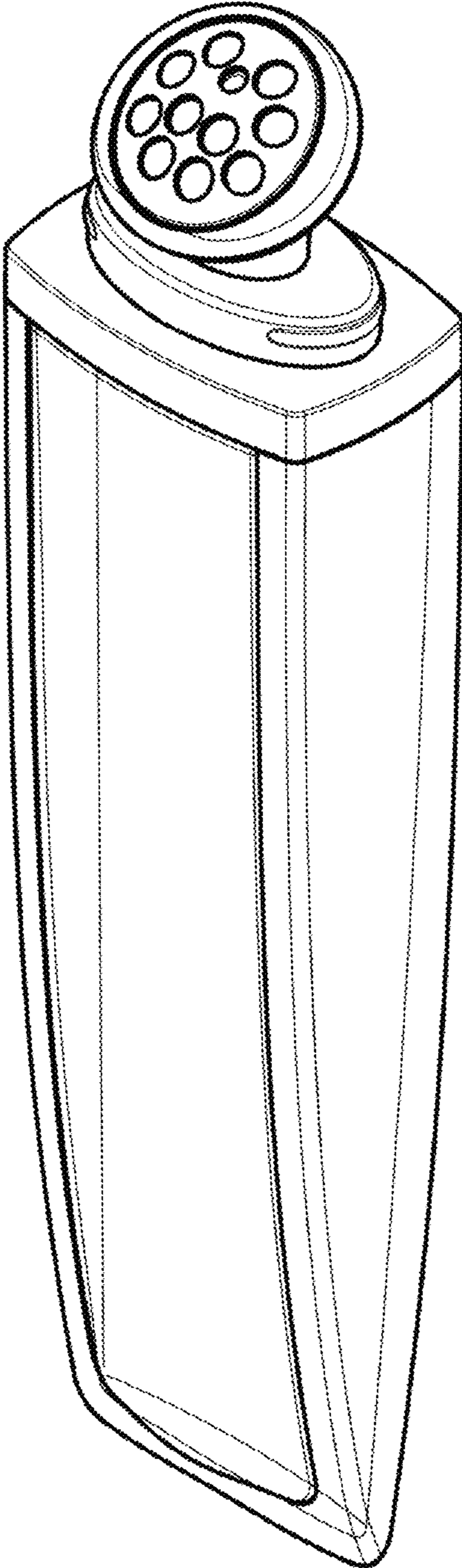

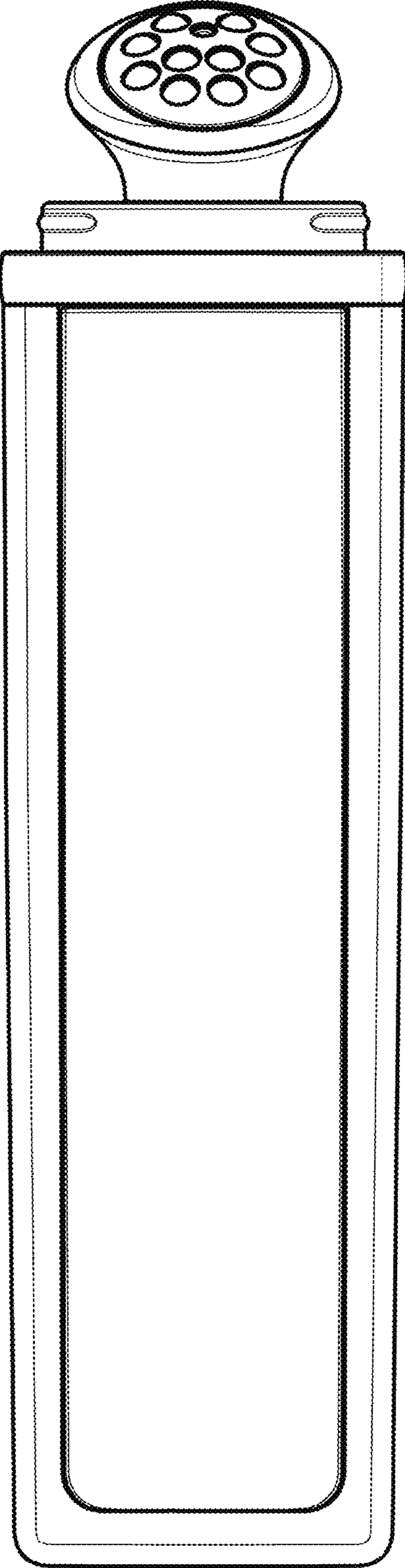

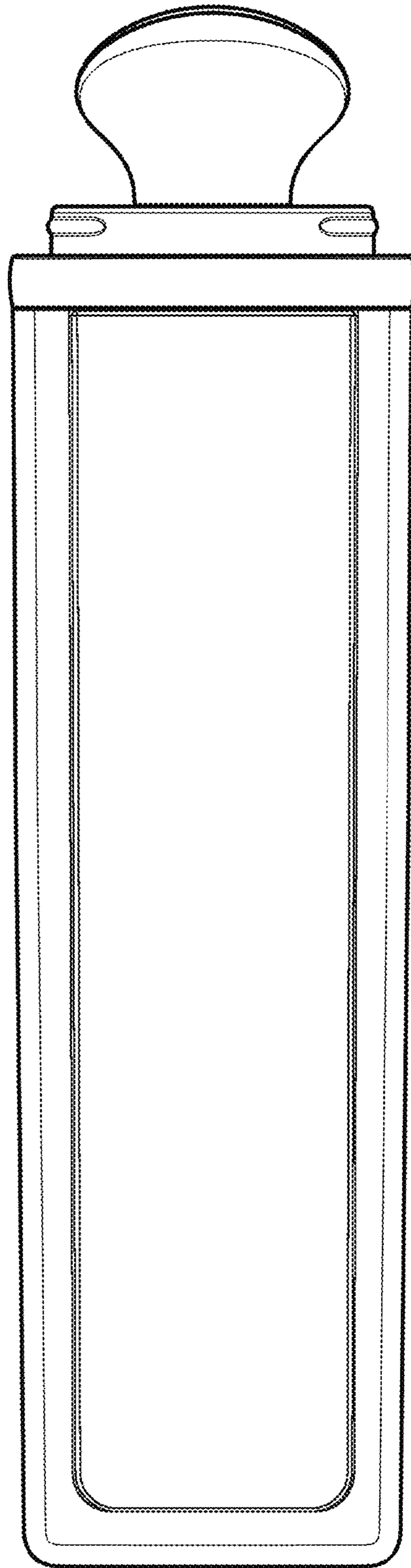

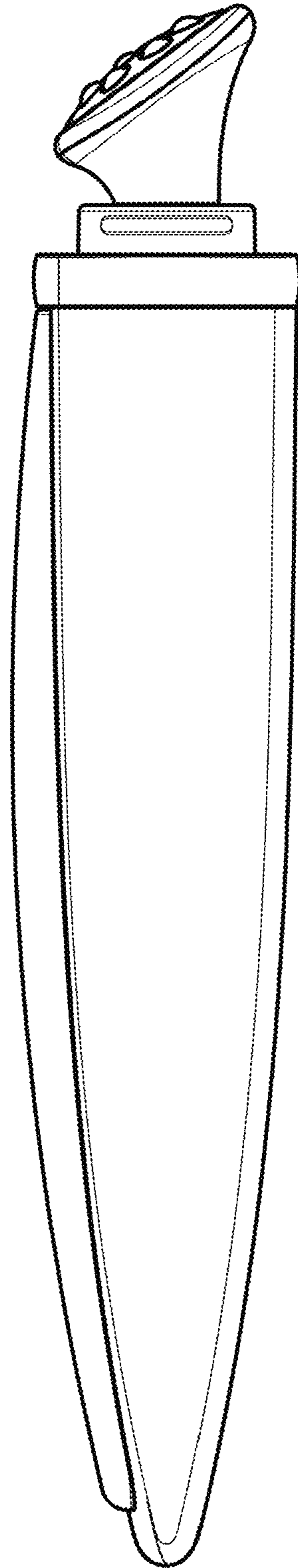

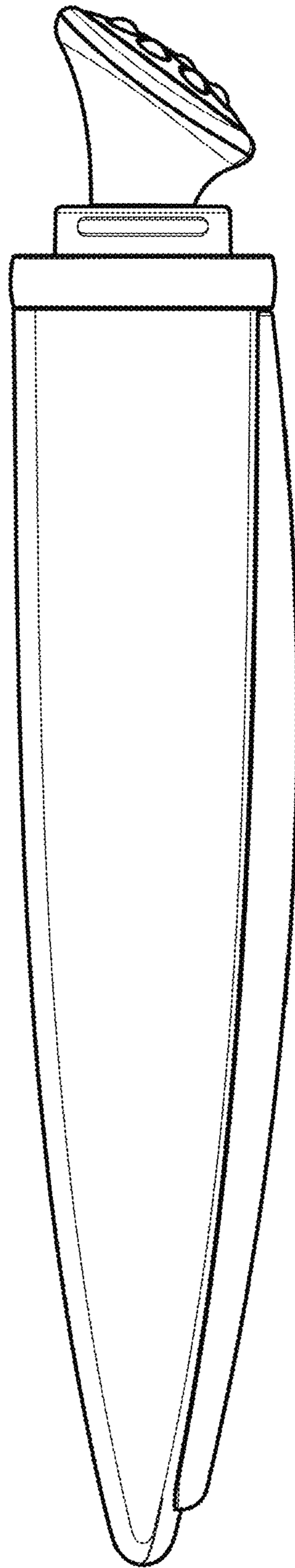

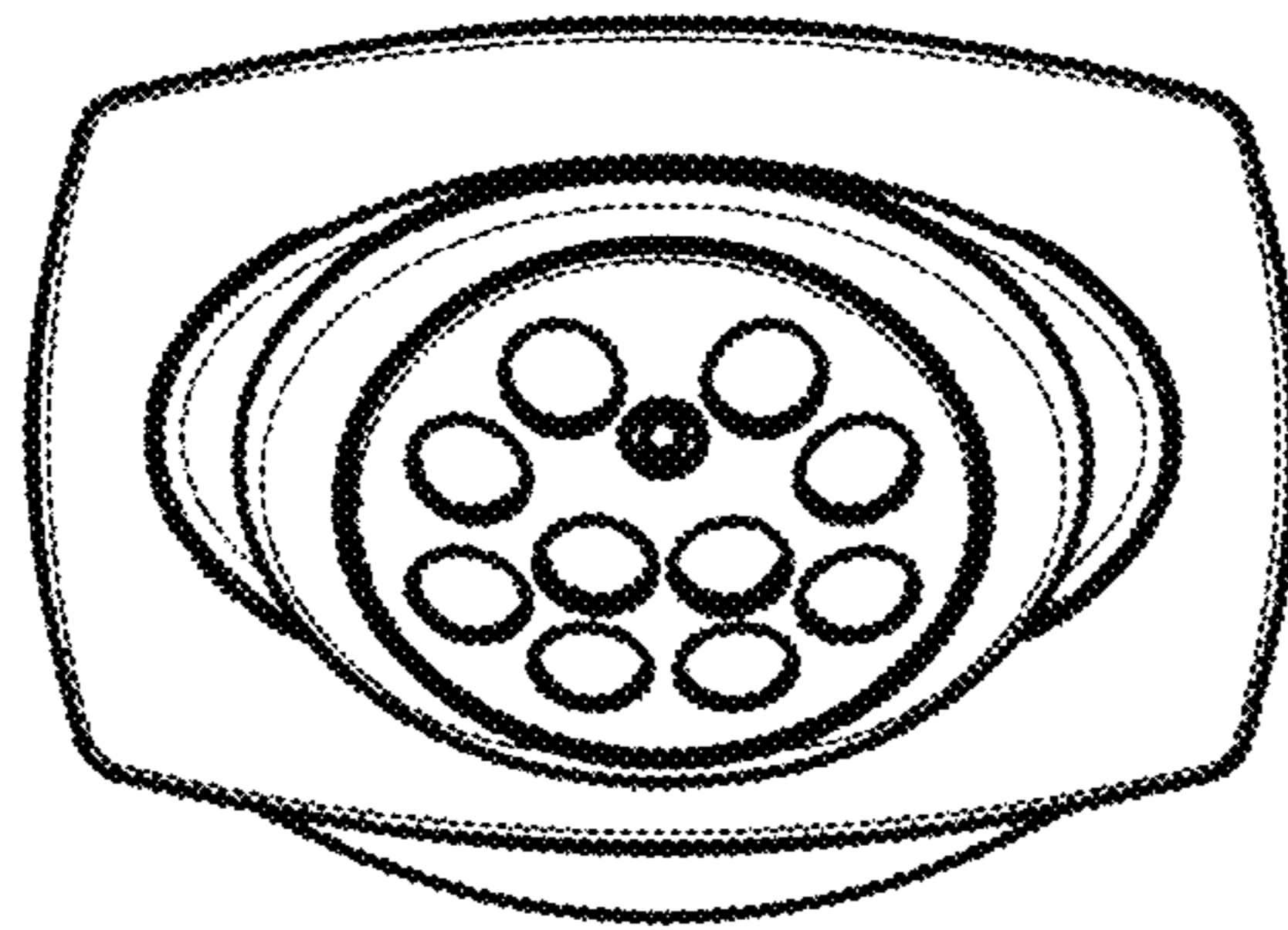

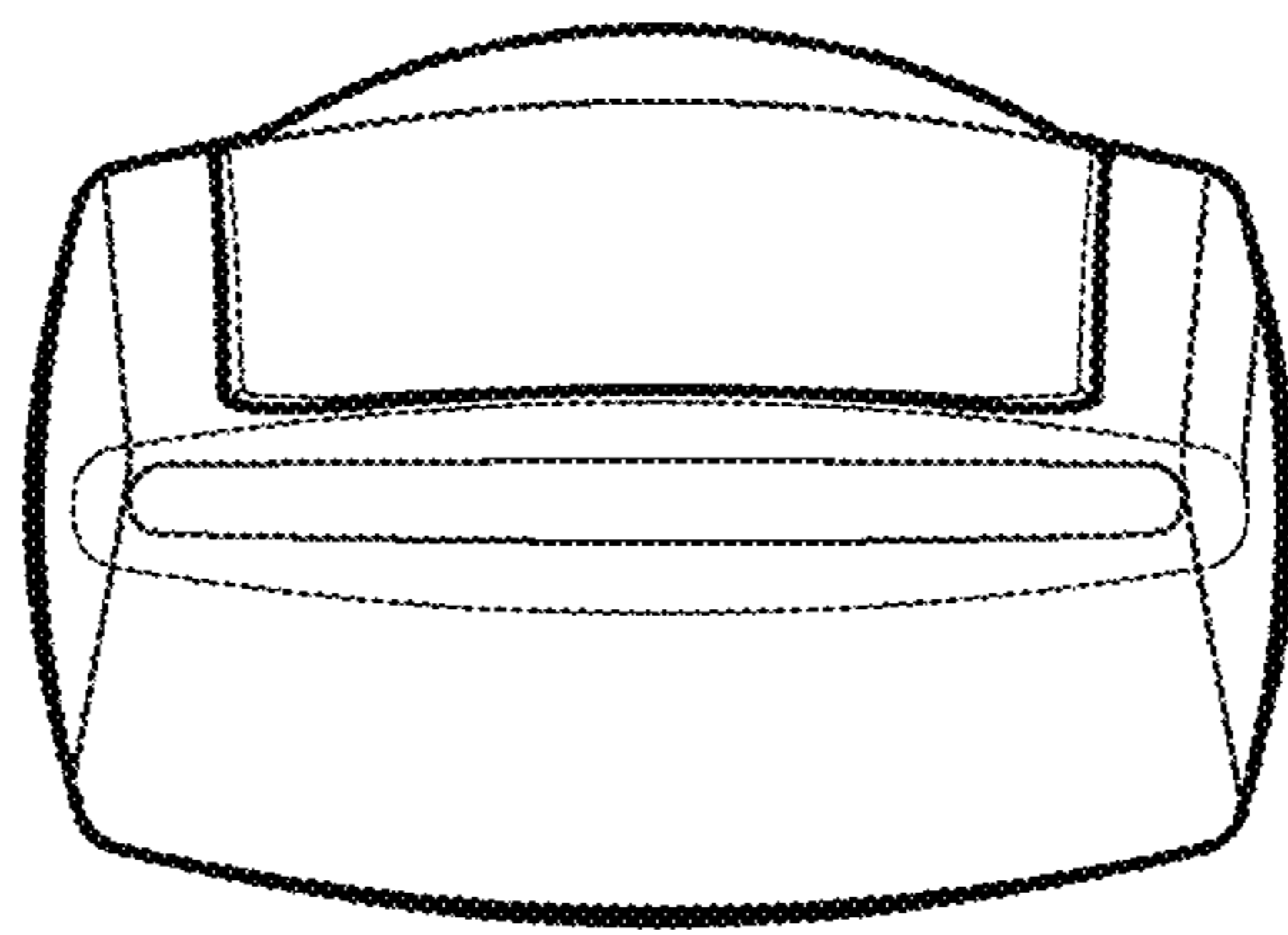
