DESCRIPTION

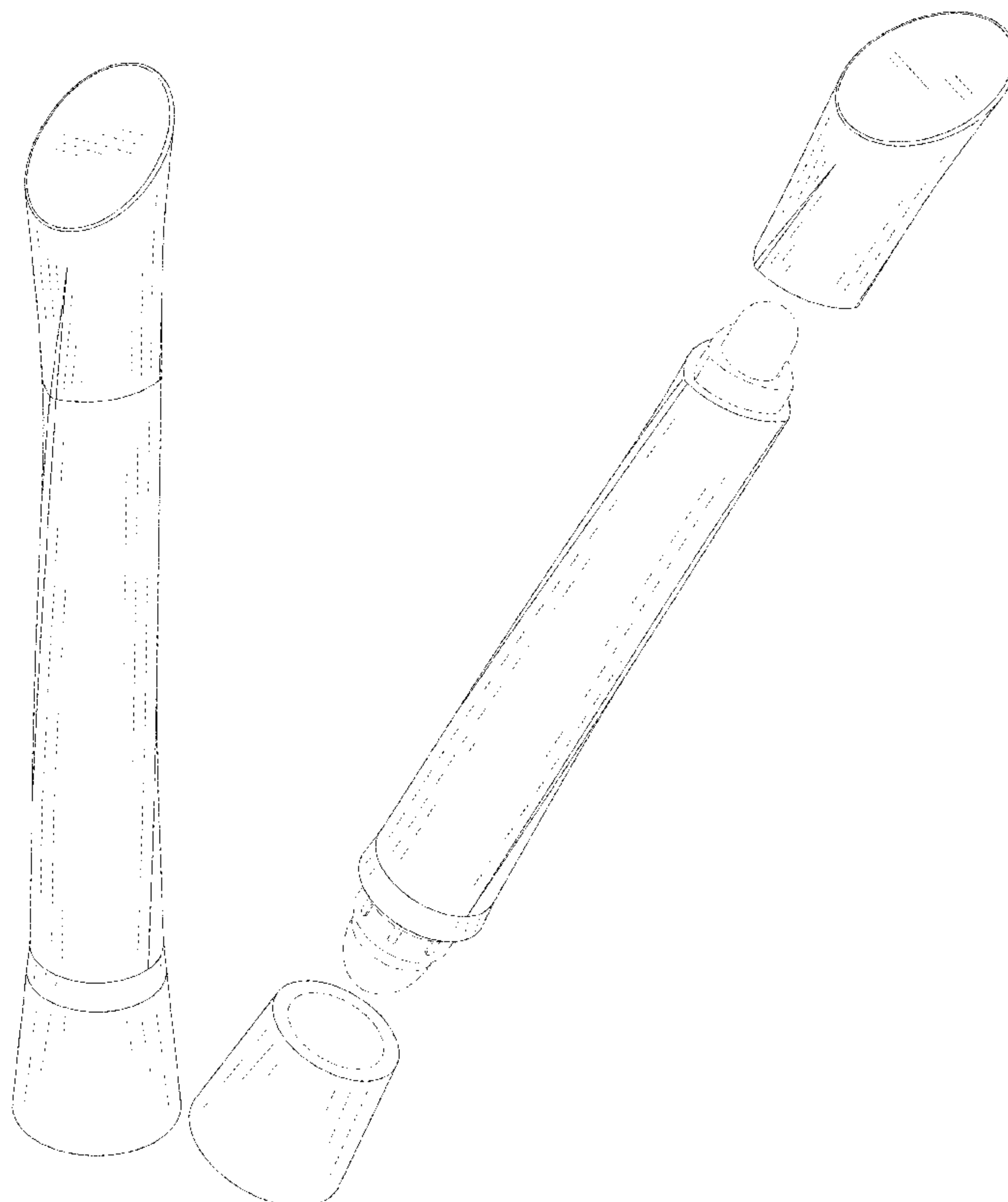
FIG. 1 is a perspective view of an eyeshadow stick showing my new design;

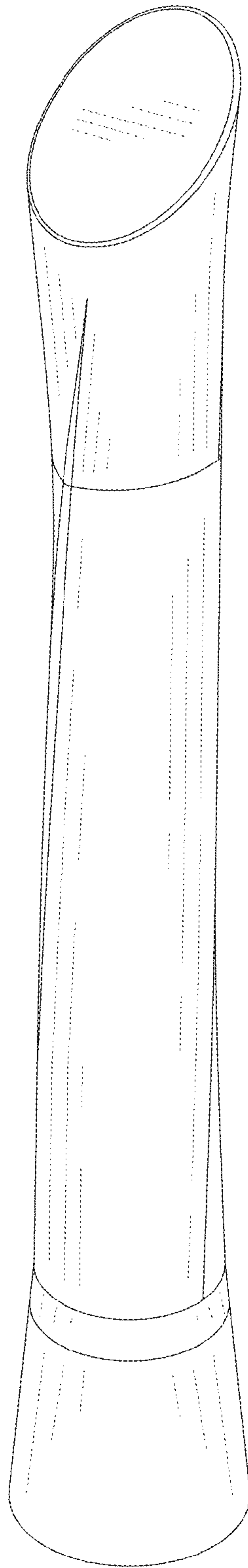

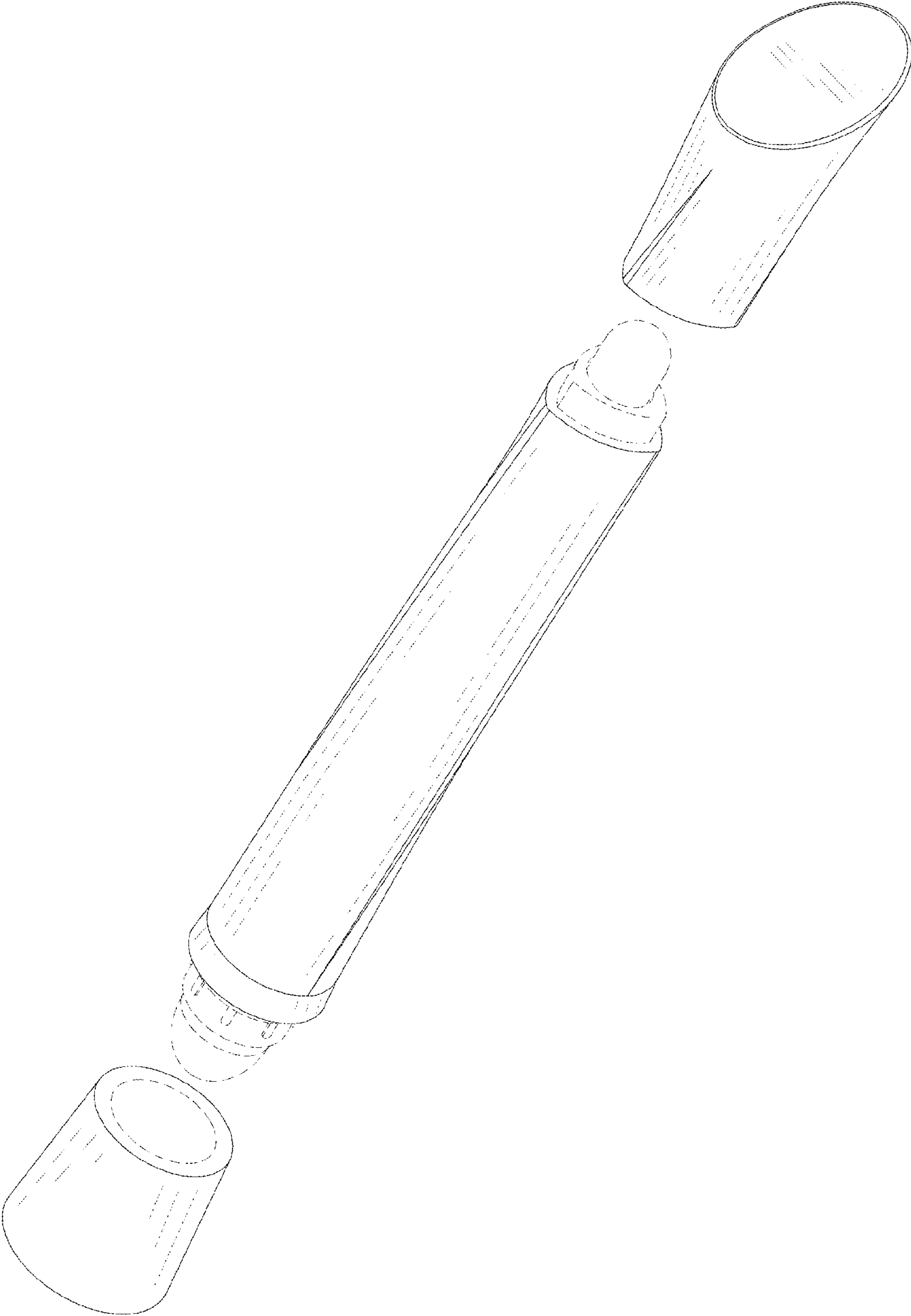

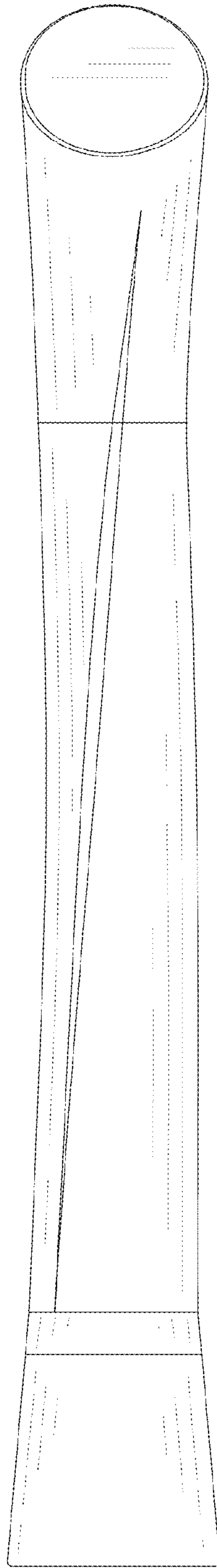

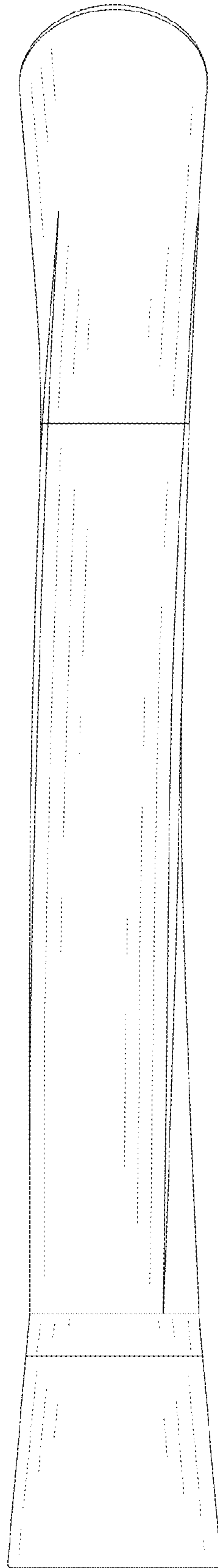

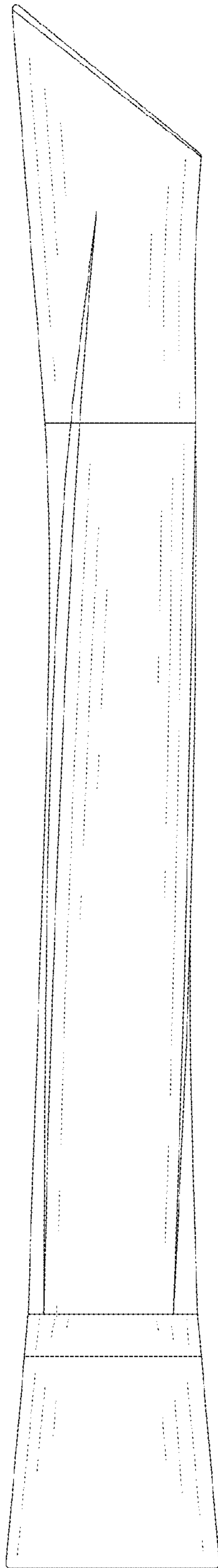

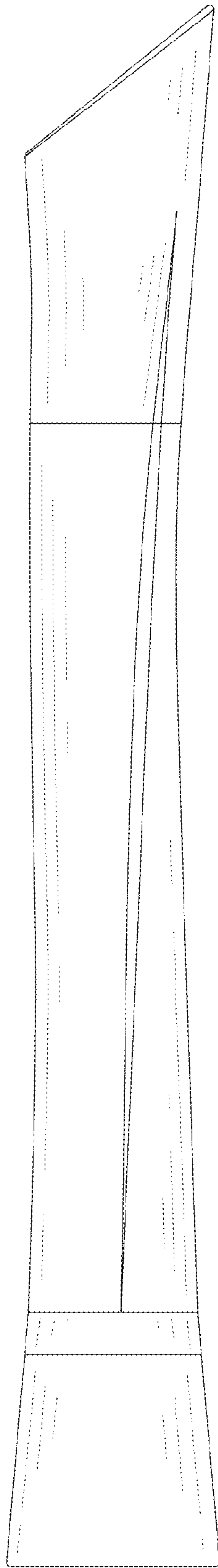

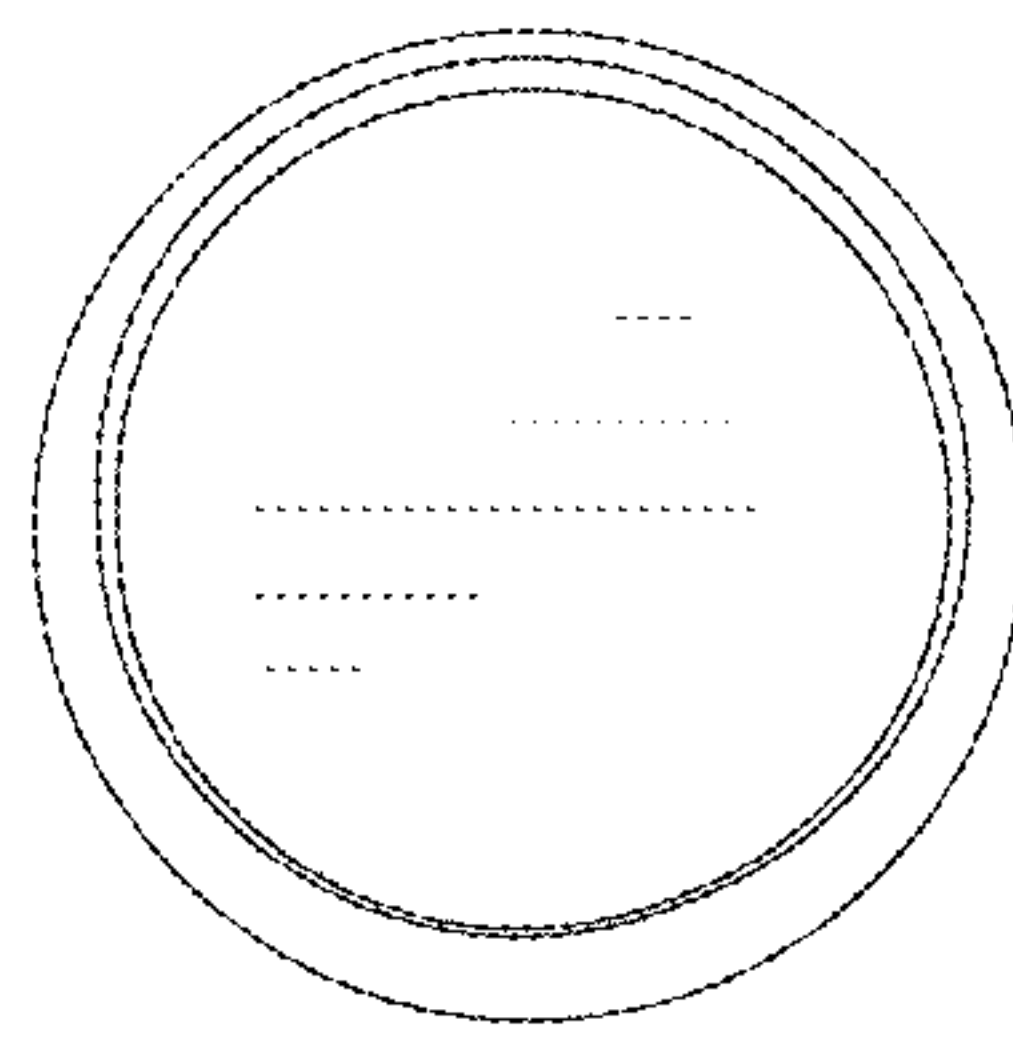

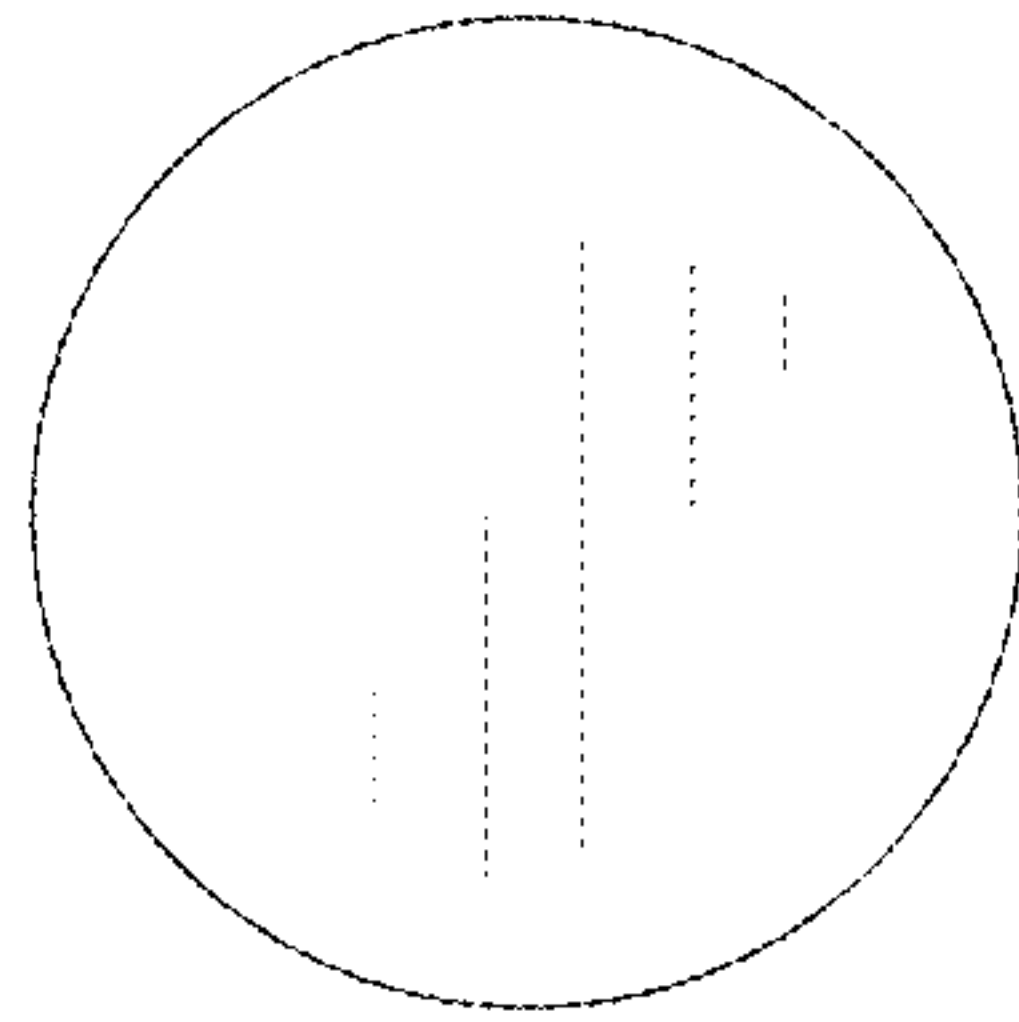
