The ornamental design for a shirt, as shown and described.

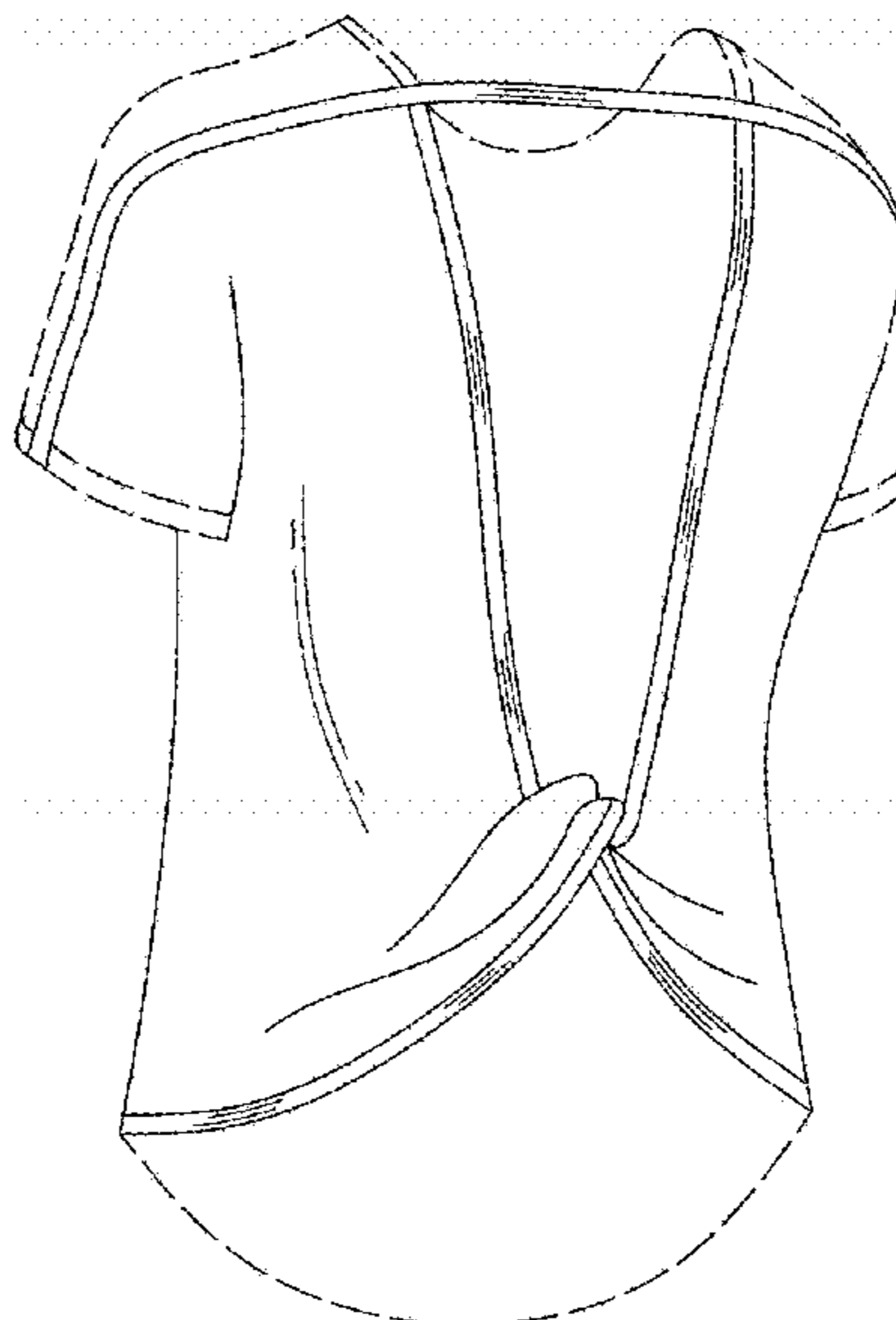
DESCRIPTION

FIG. 1 is a front view of a shirt according to the design;

FIG. 7 is a front view thereof shown in an environment of use; and,

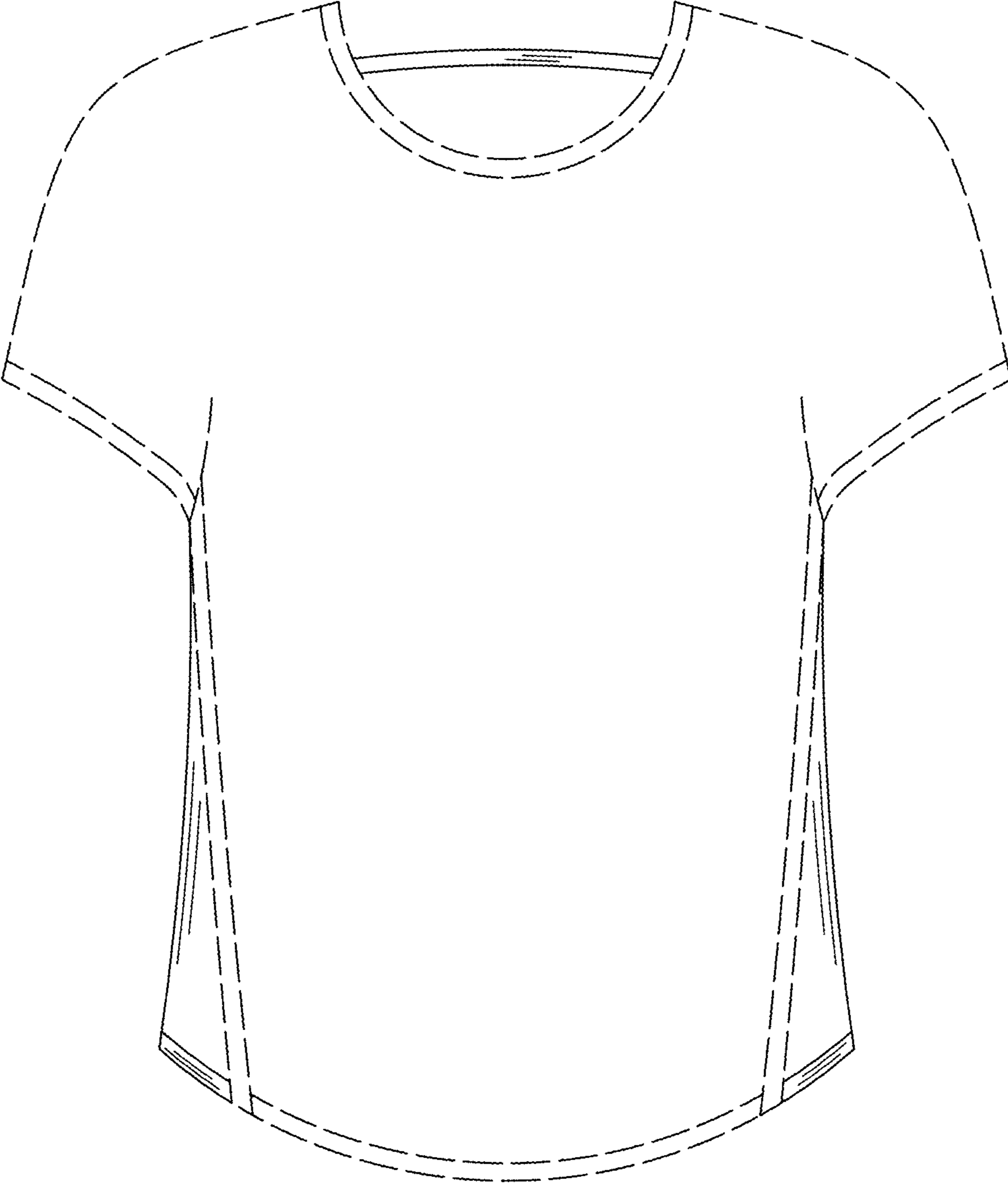

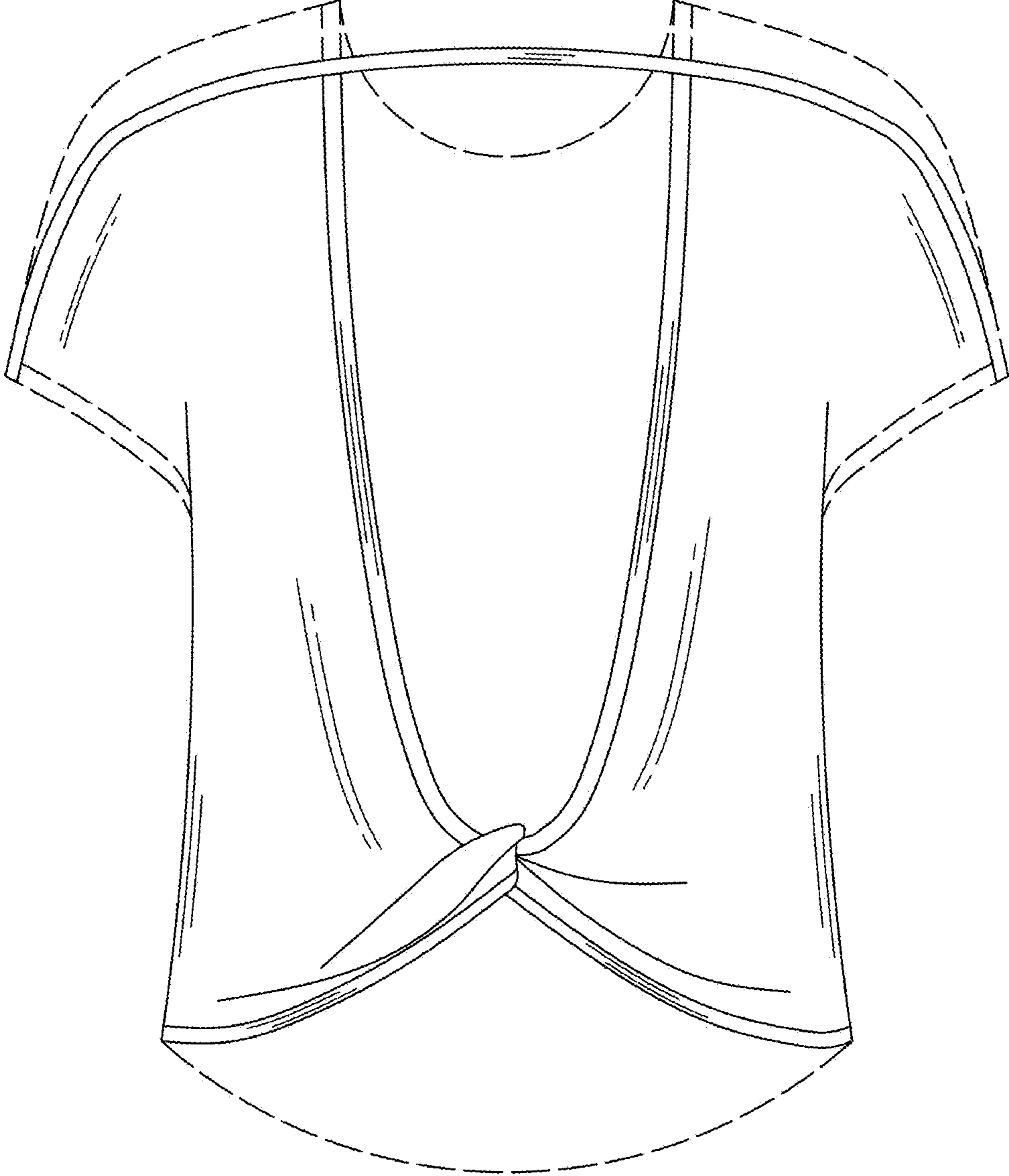

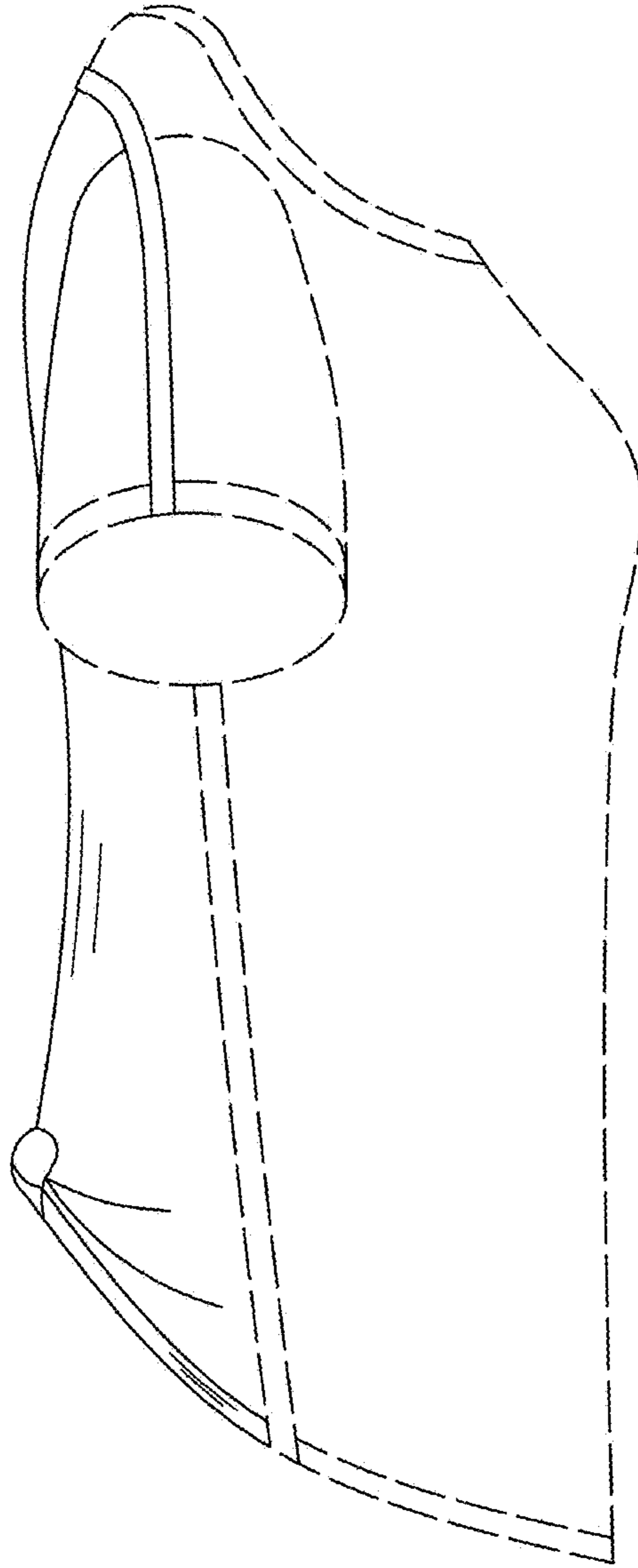

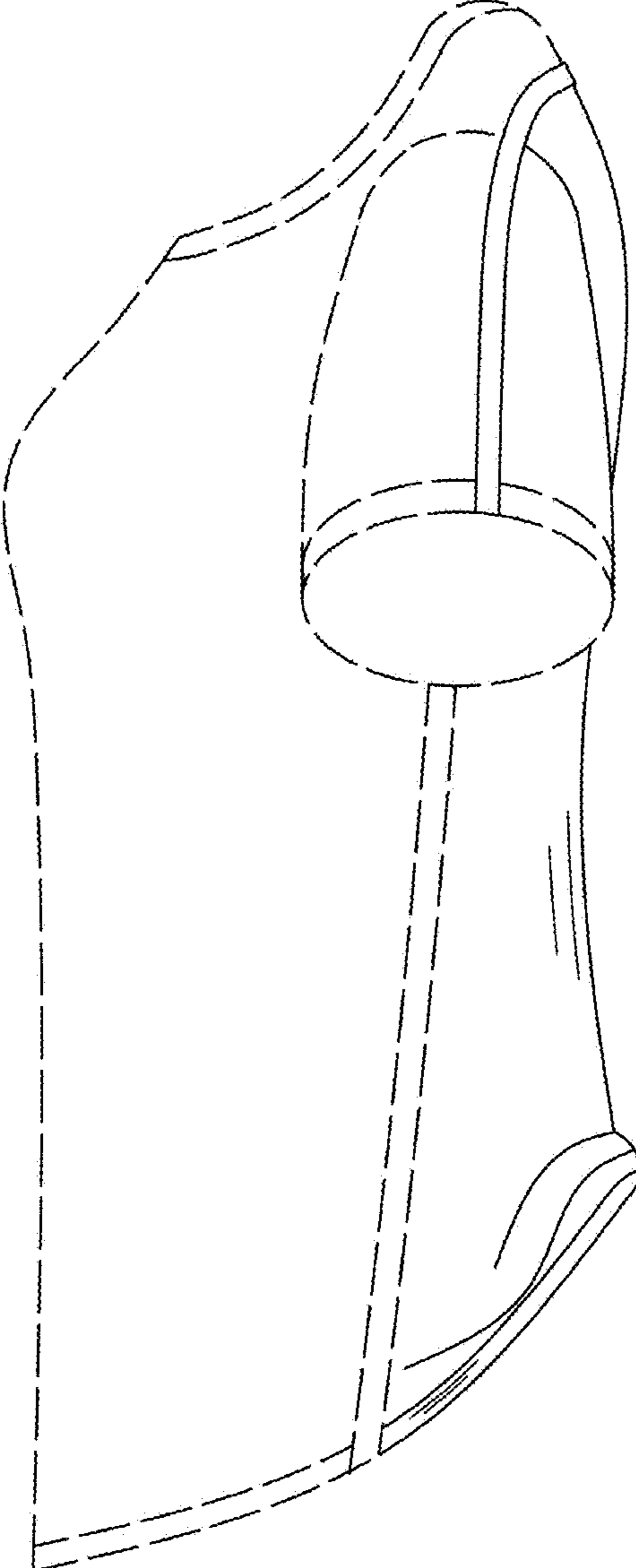

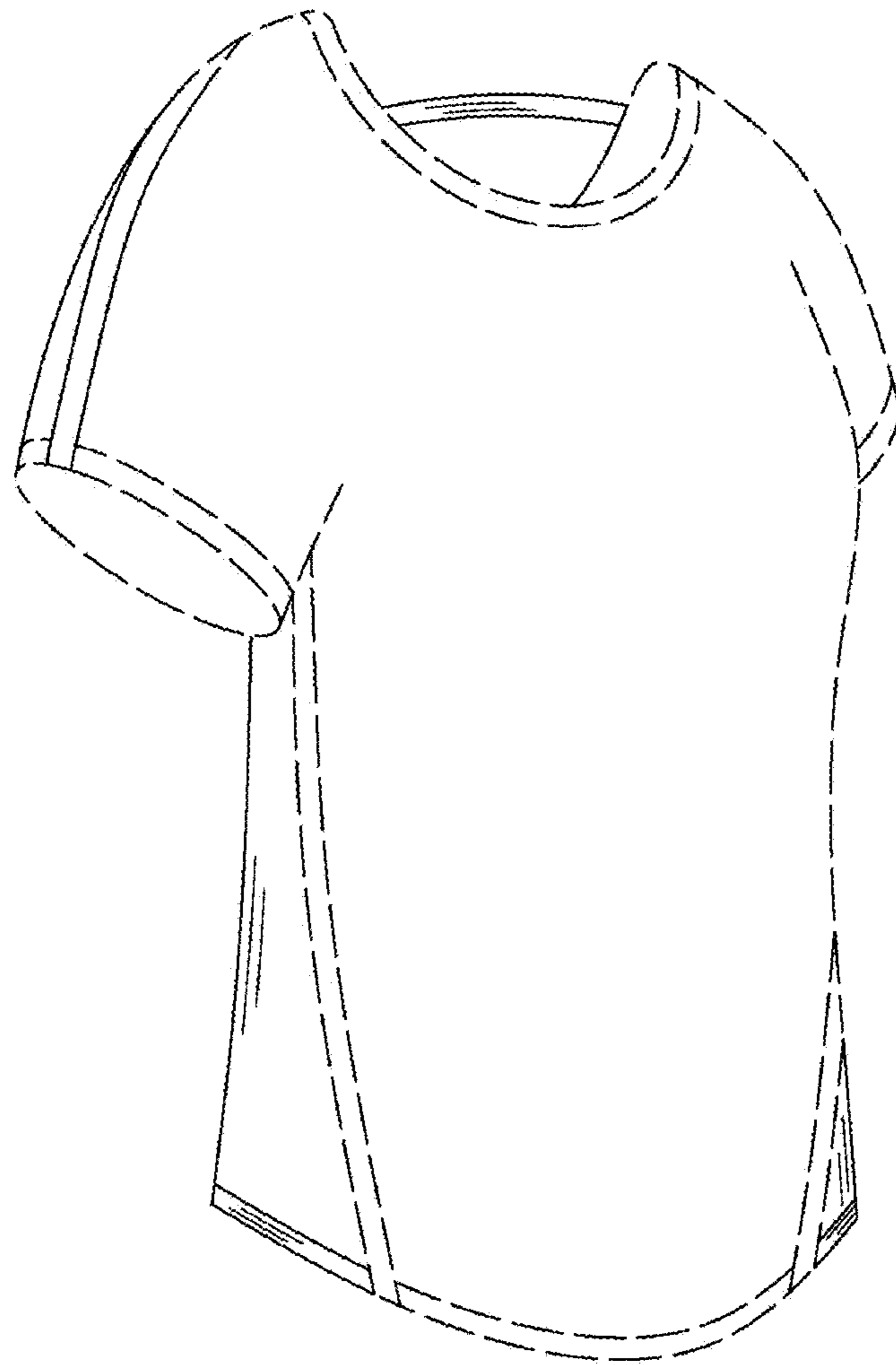

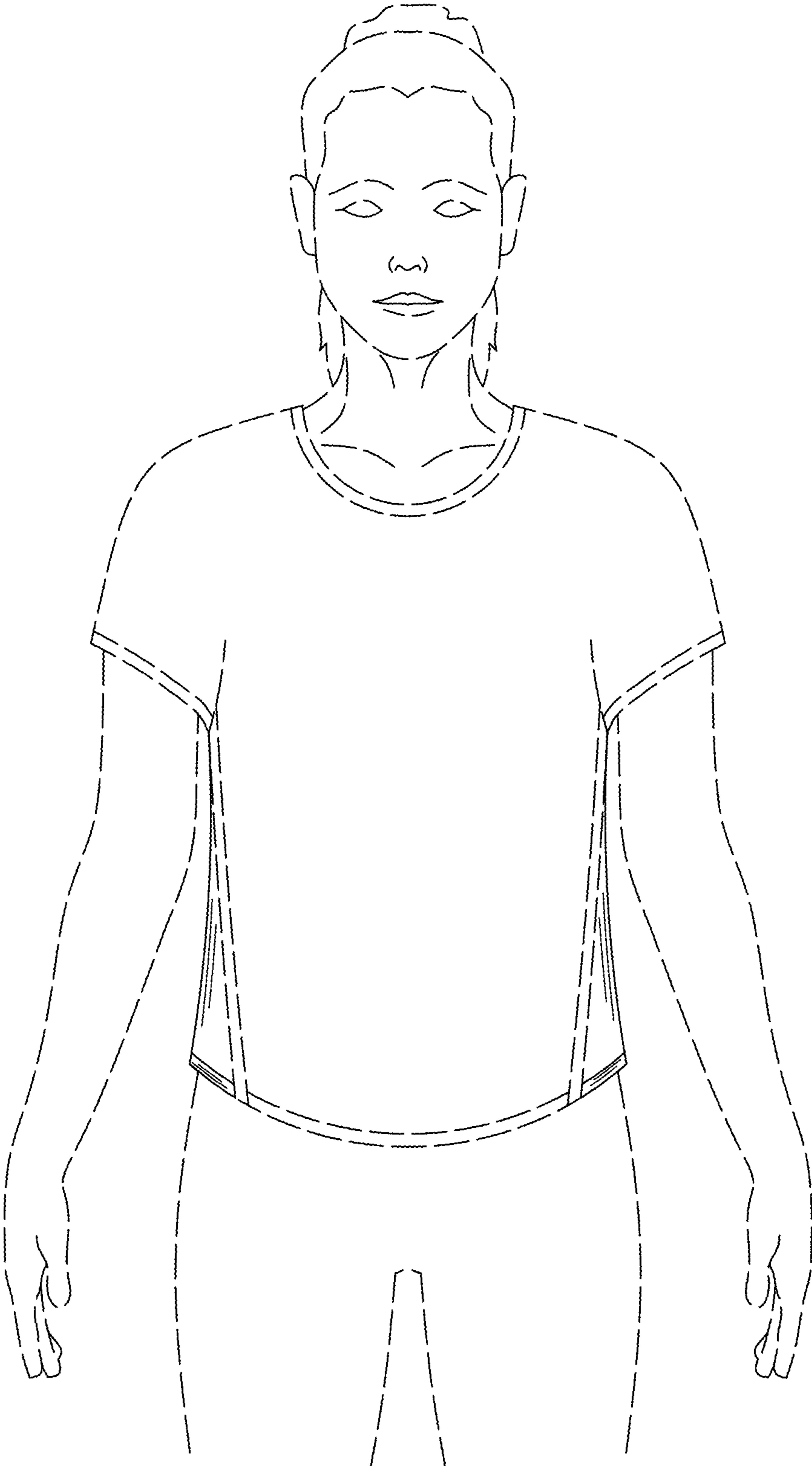

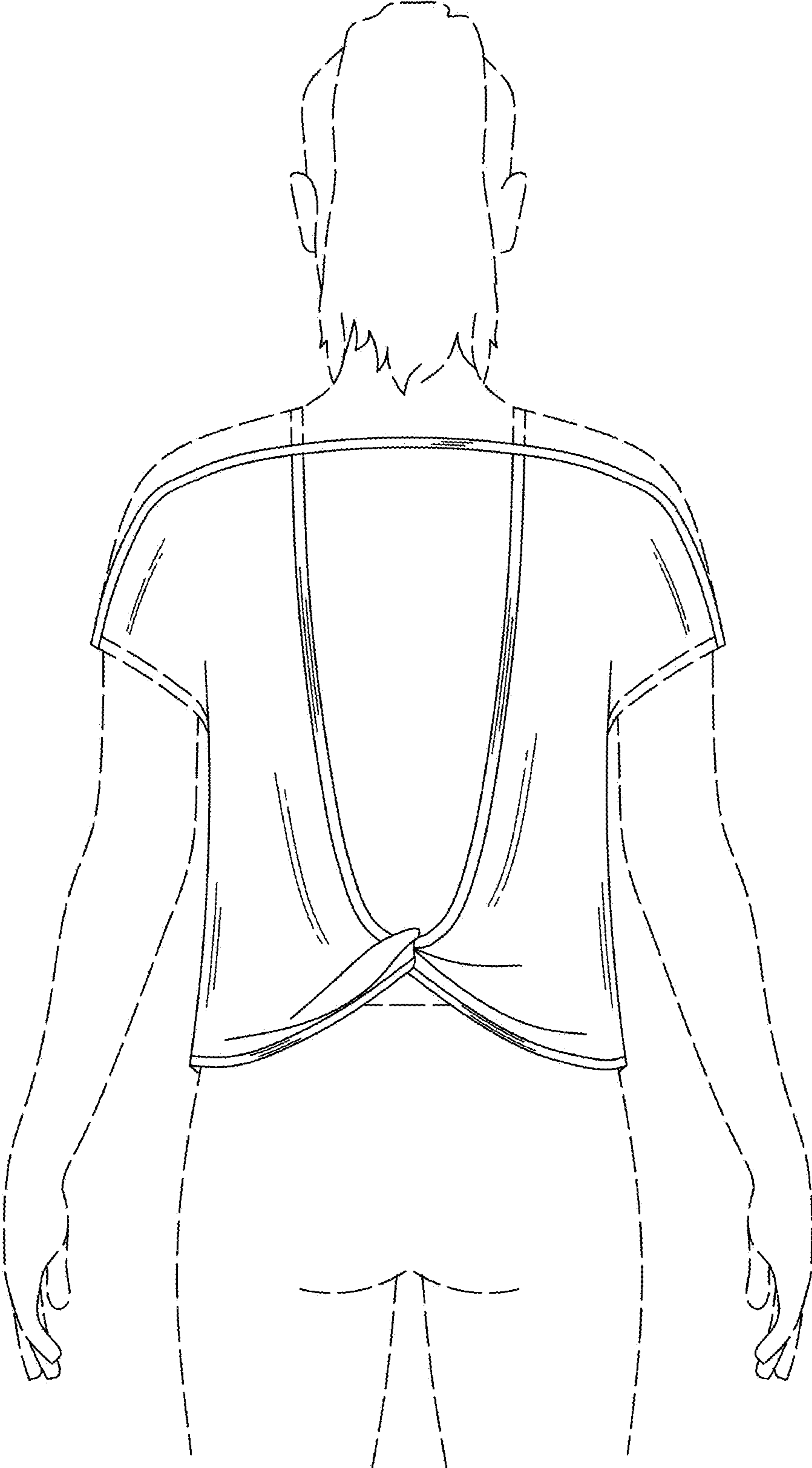
