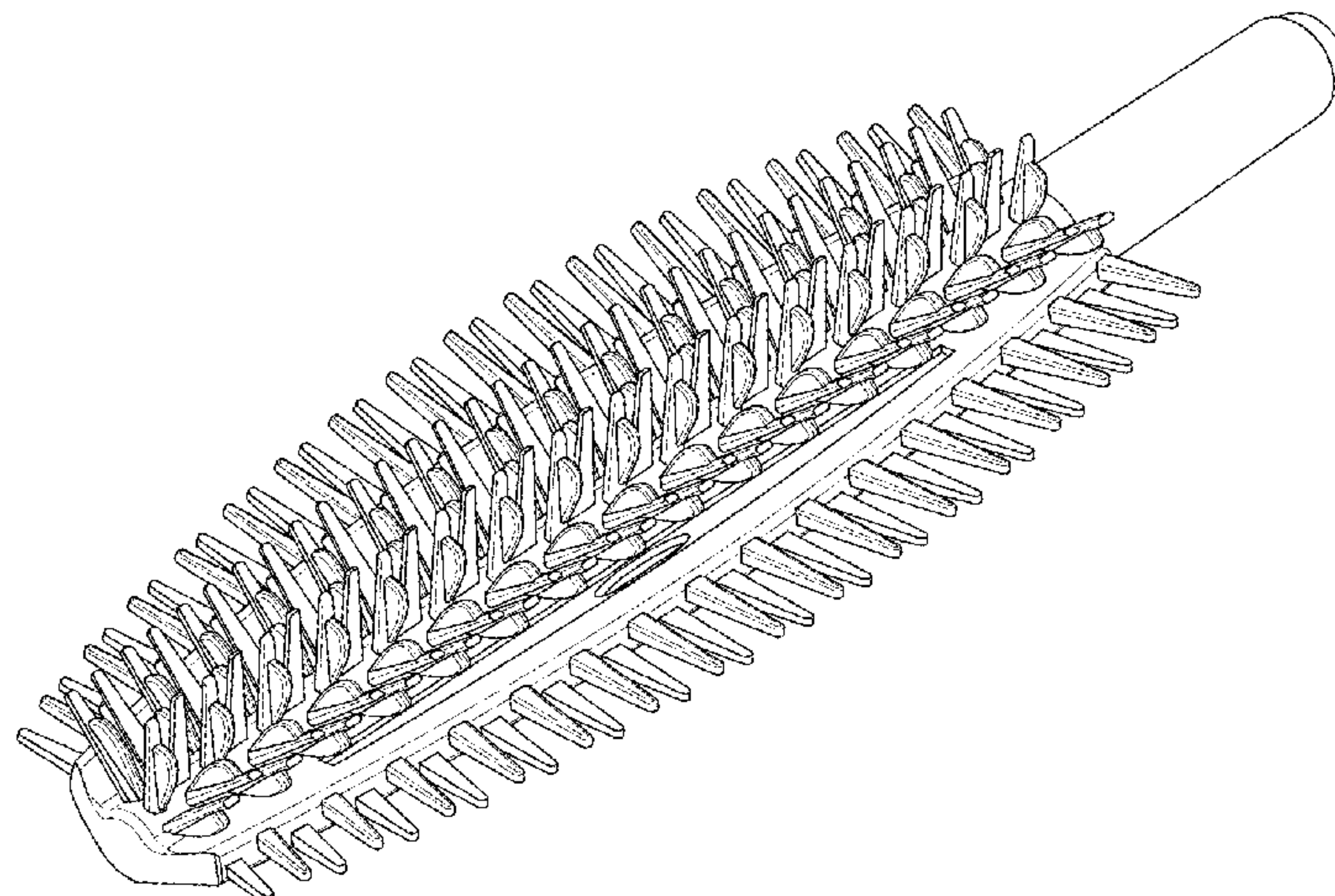
(57) **CLAIM**

The ornamental design for a cosmetic applicator, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cosmetic applicator; FIG. 2 is a top plan view of the cosmetic applicator of FIG. 1; FIG. 3 is a front view of the cosmetic applicator of FIG. 1; FIG. 4 is a bottom plan view of the cosmetic applicator of FIG. 1; and, FIG. 5 is a side view of the cosmetic applicator of FIG. 1 as the left side view and the right side view are the same. 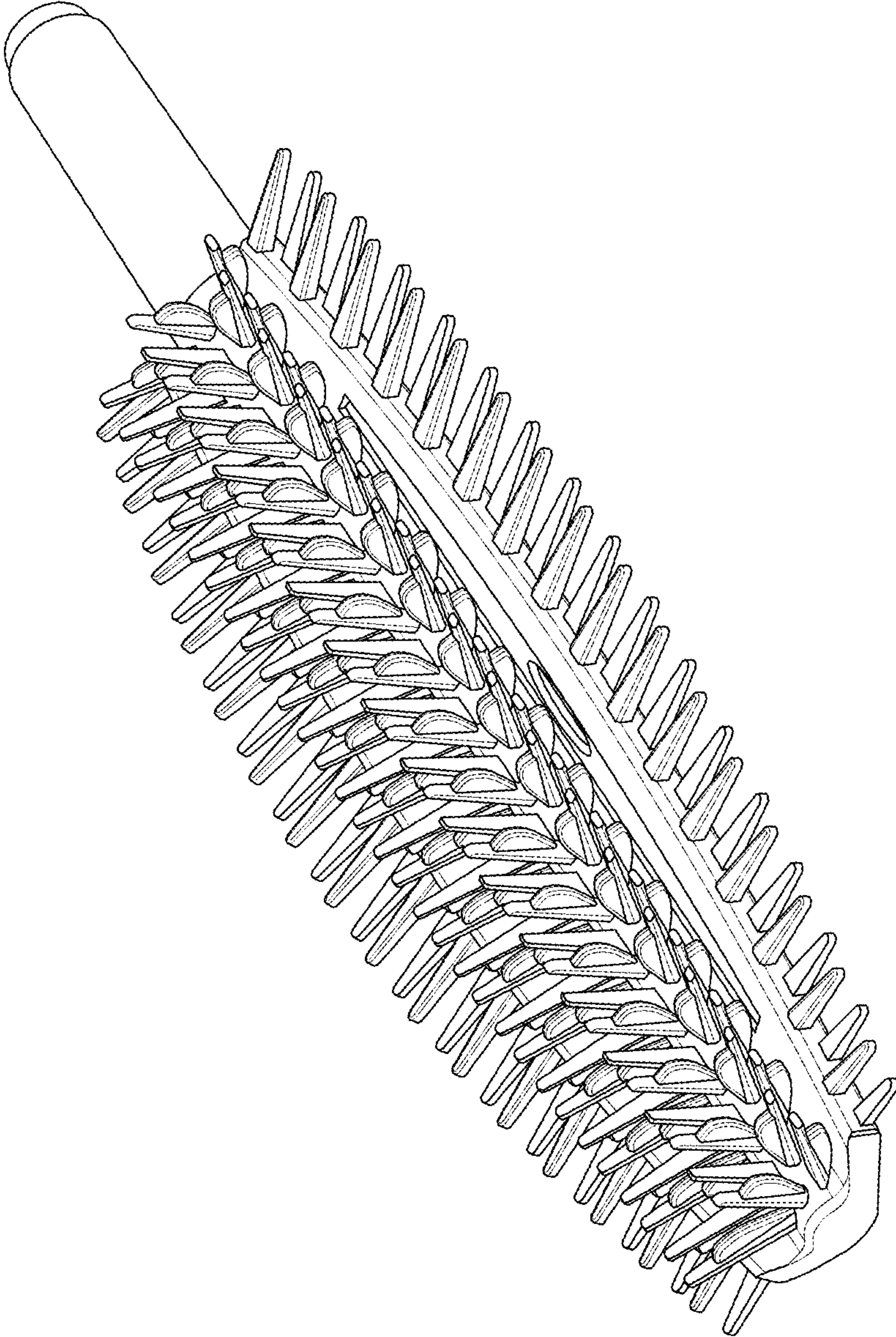

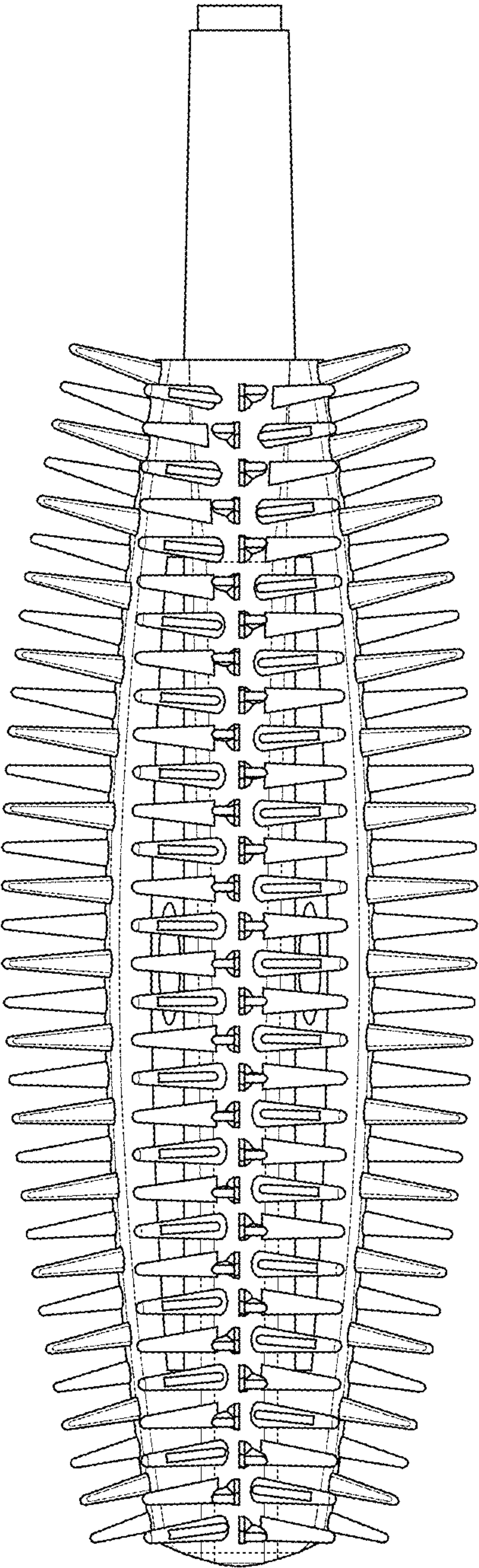

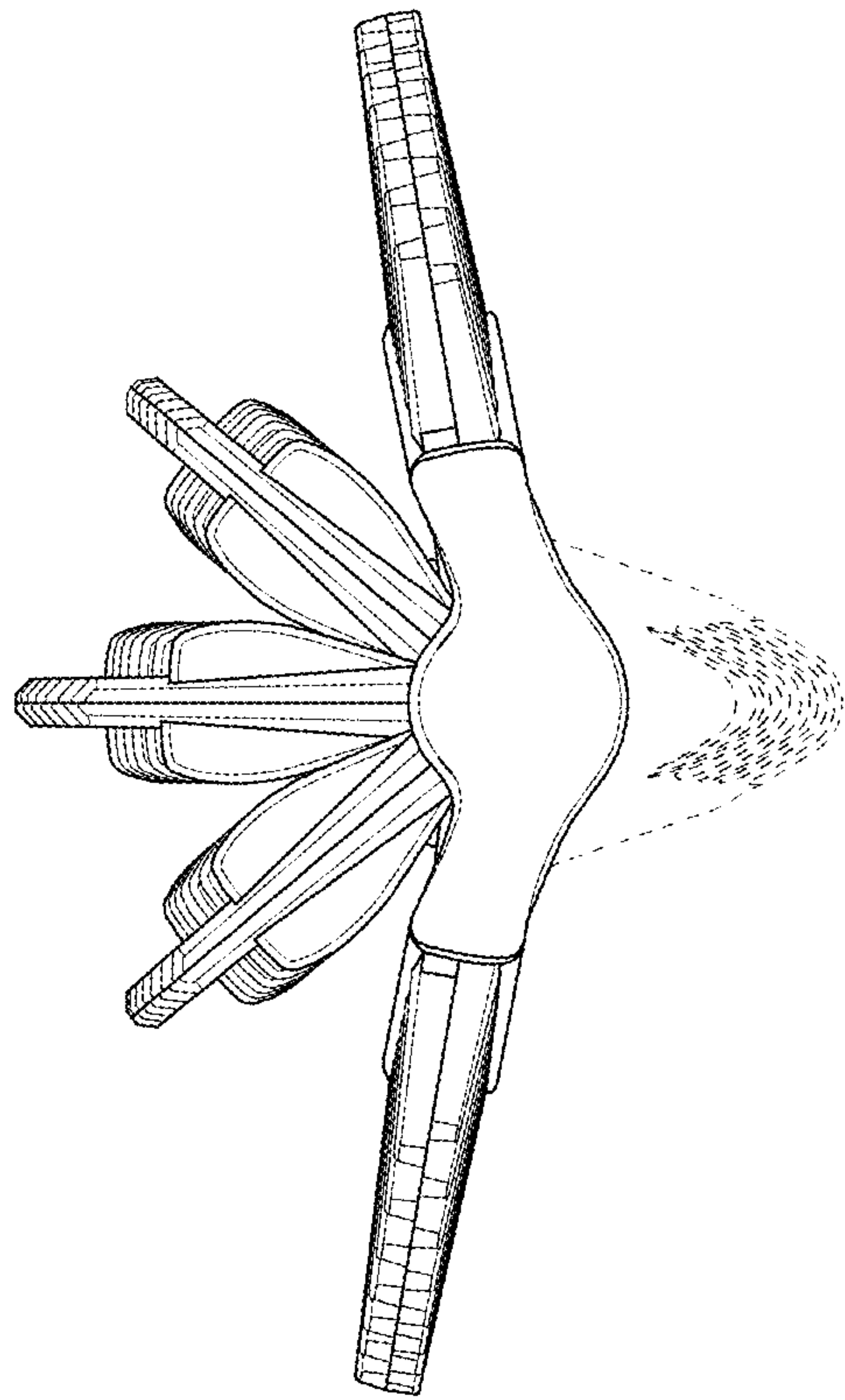

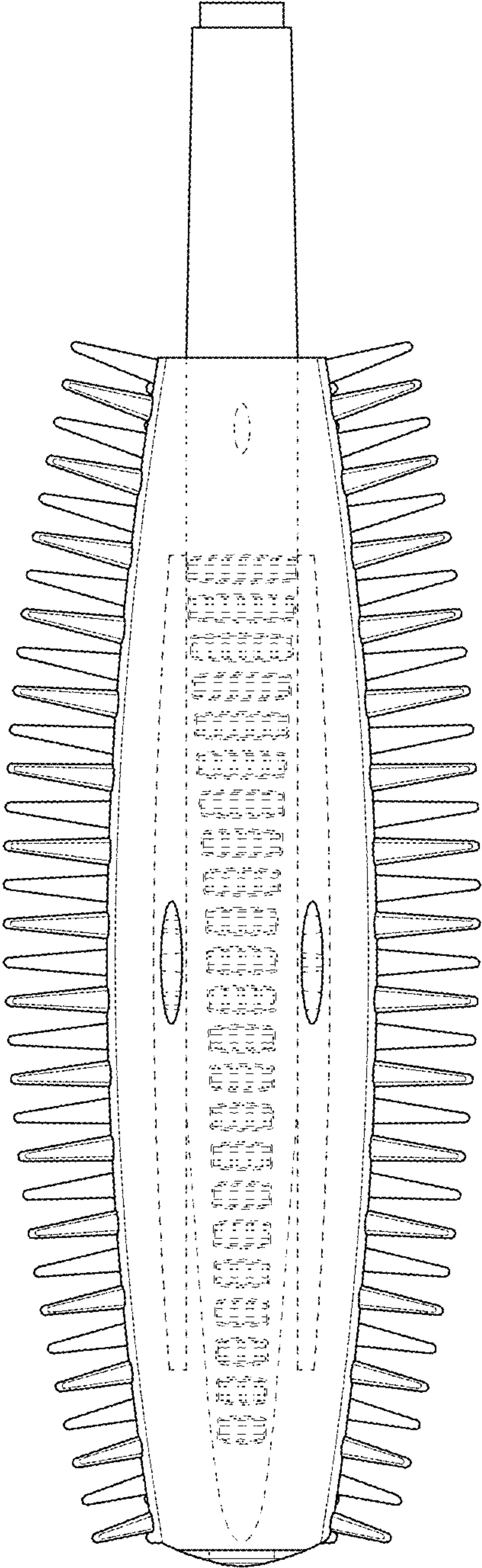

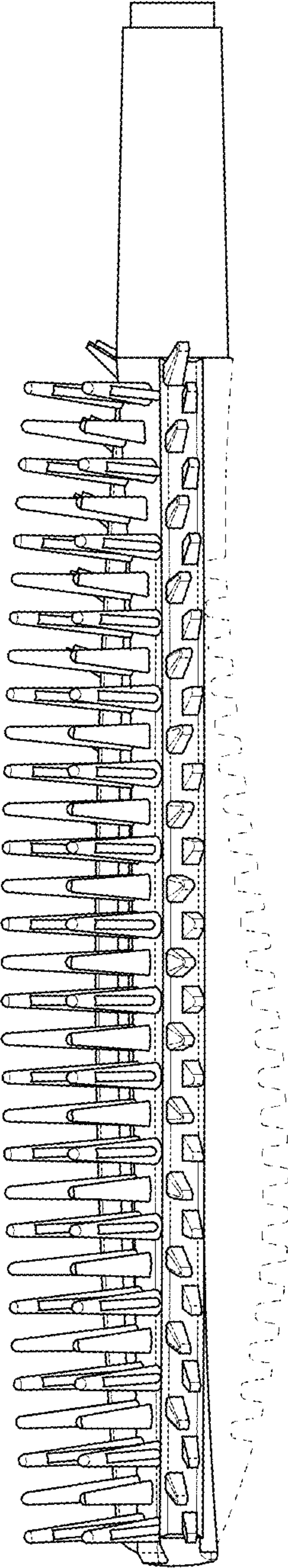
