(57) **CLAIM**

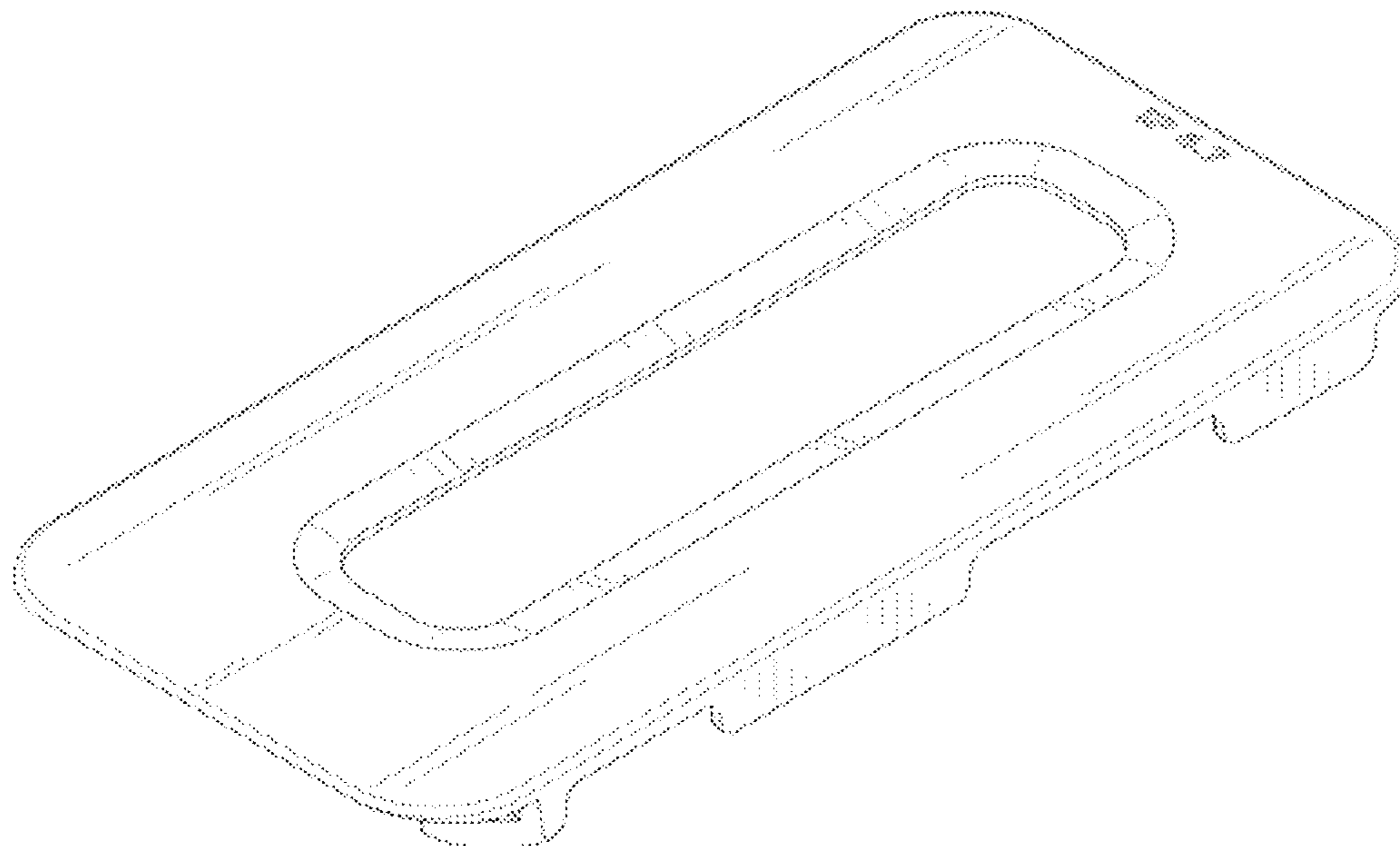
The ornamental design for a film applicator, as shown and described.

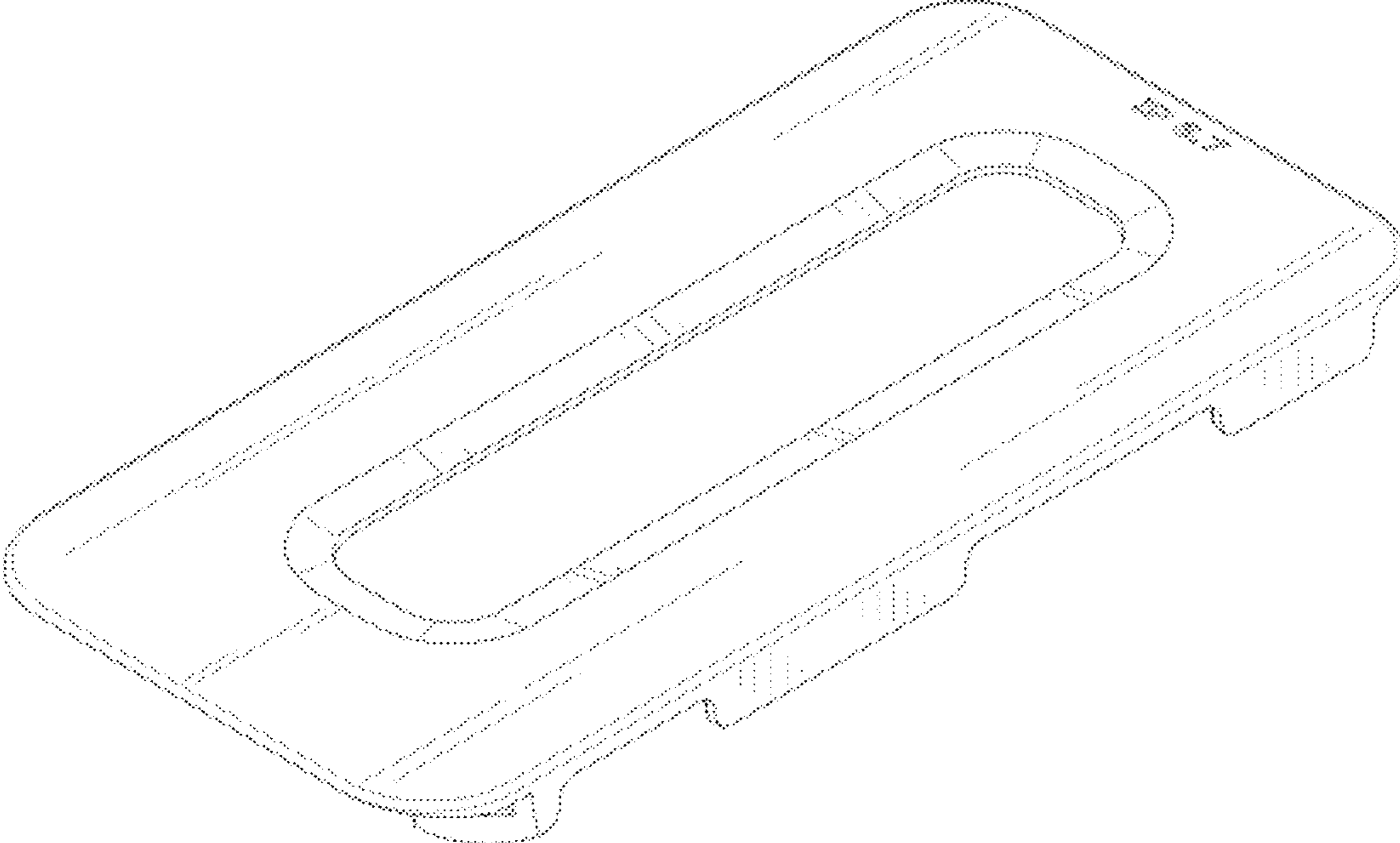

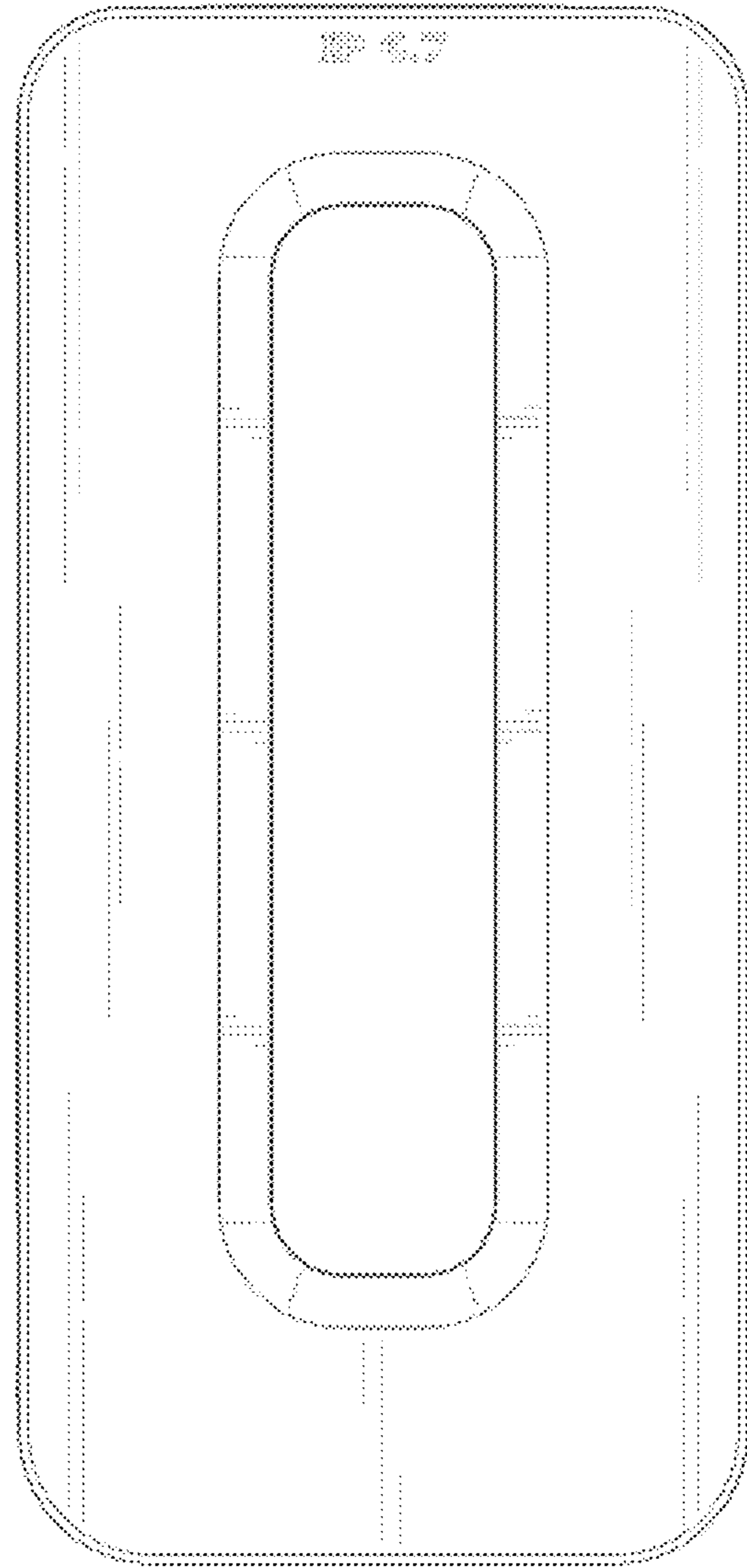

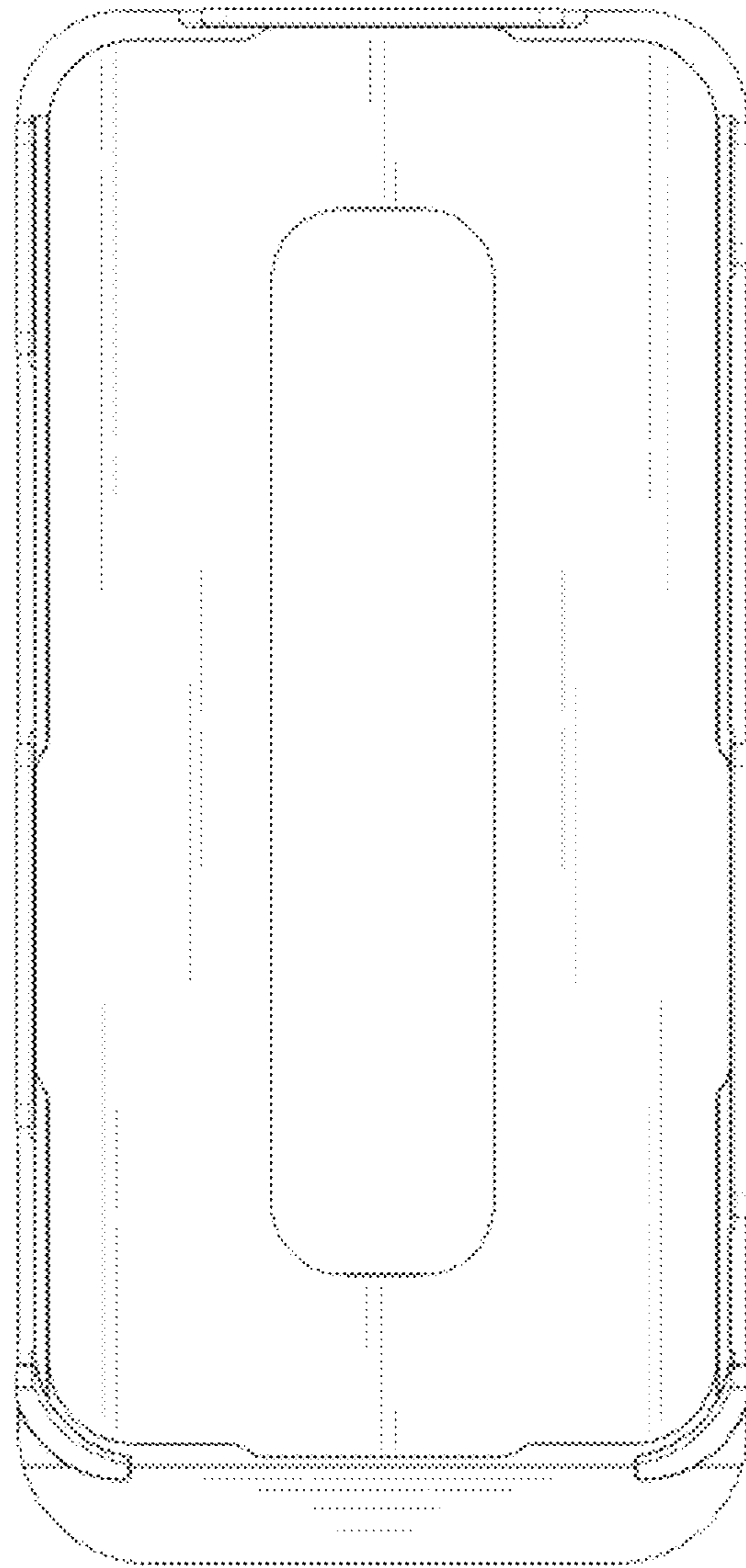

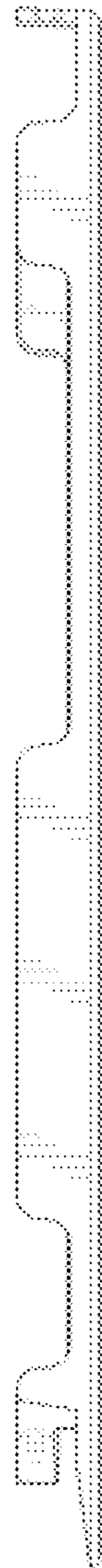

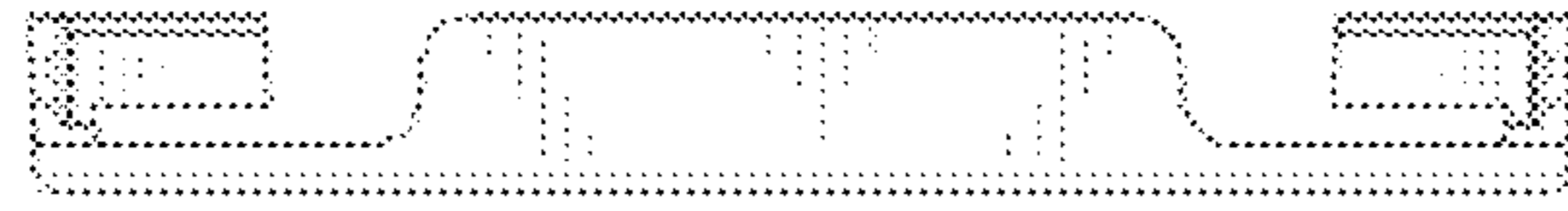
