The ornamental design for a cosmetics box, as shown and described.

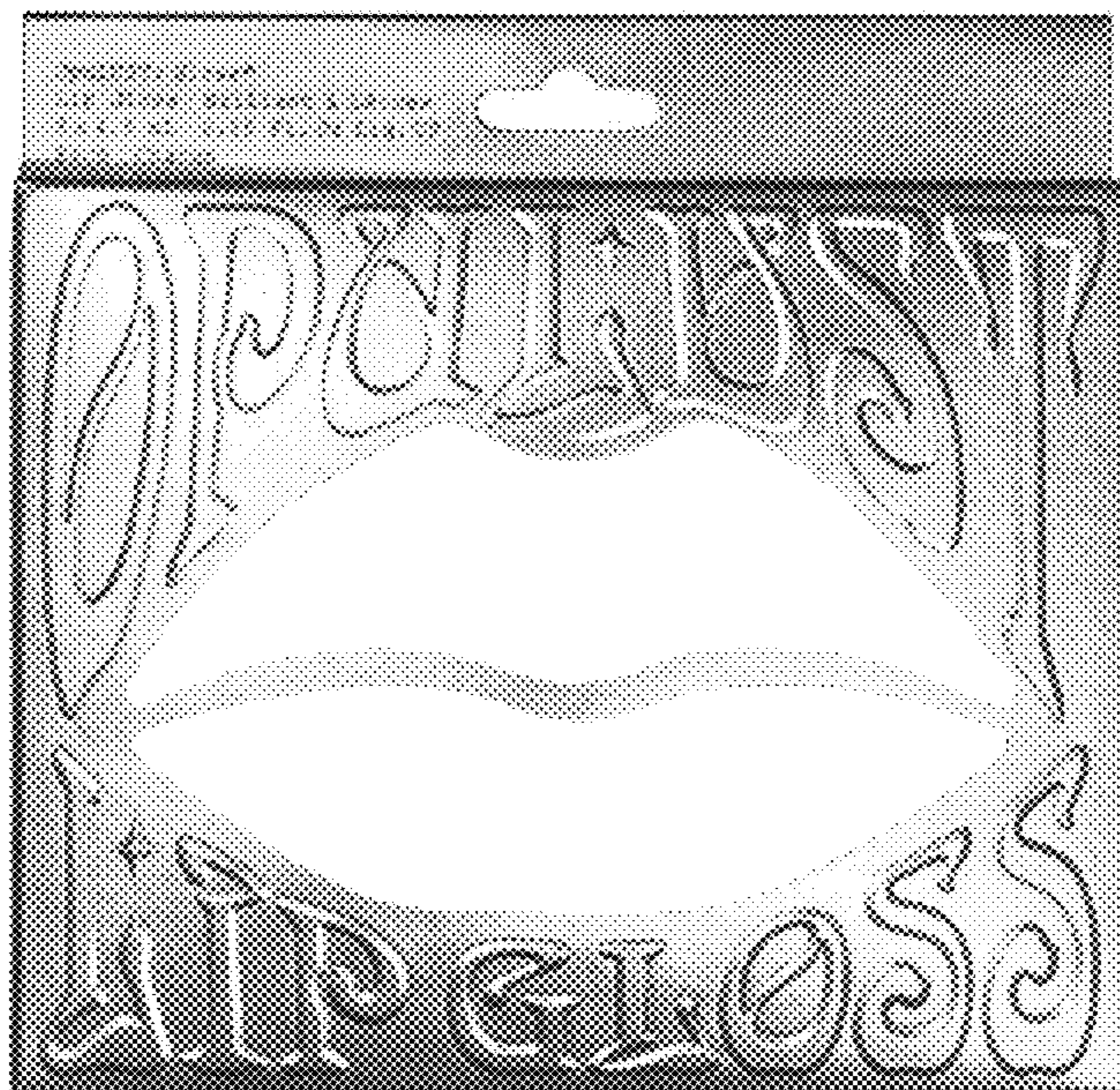
DESCRIPTION

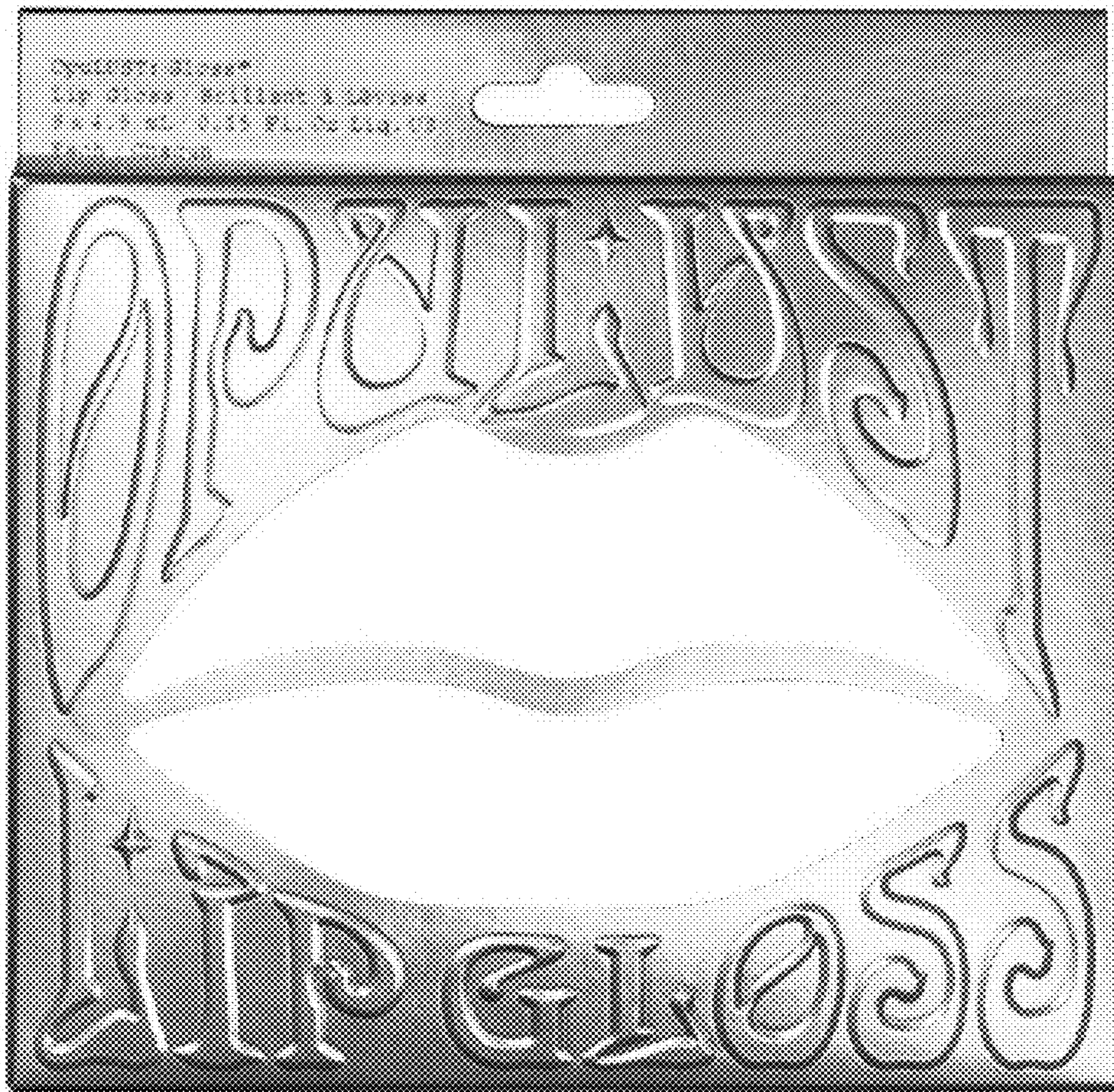
