**DESCRIPTION**

FIG. 1 is a front perspective view of a water bottle showing an embodiment of my new design;

FIG. 2 is a rear perspective view of the water bottle shown in FIG. 1;

FIG. 4 is a bottom view of the water bottle shown in FIG. 1;

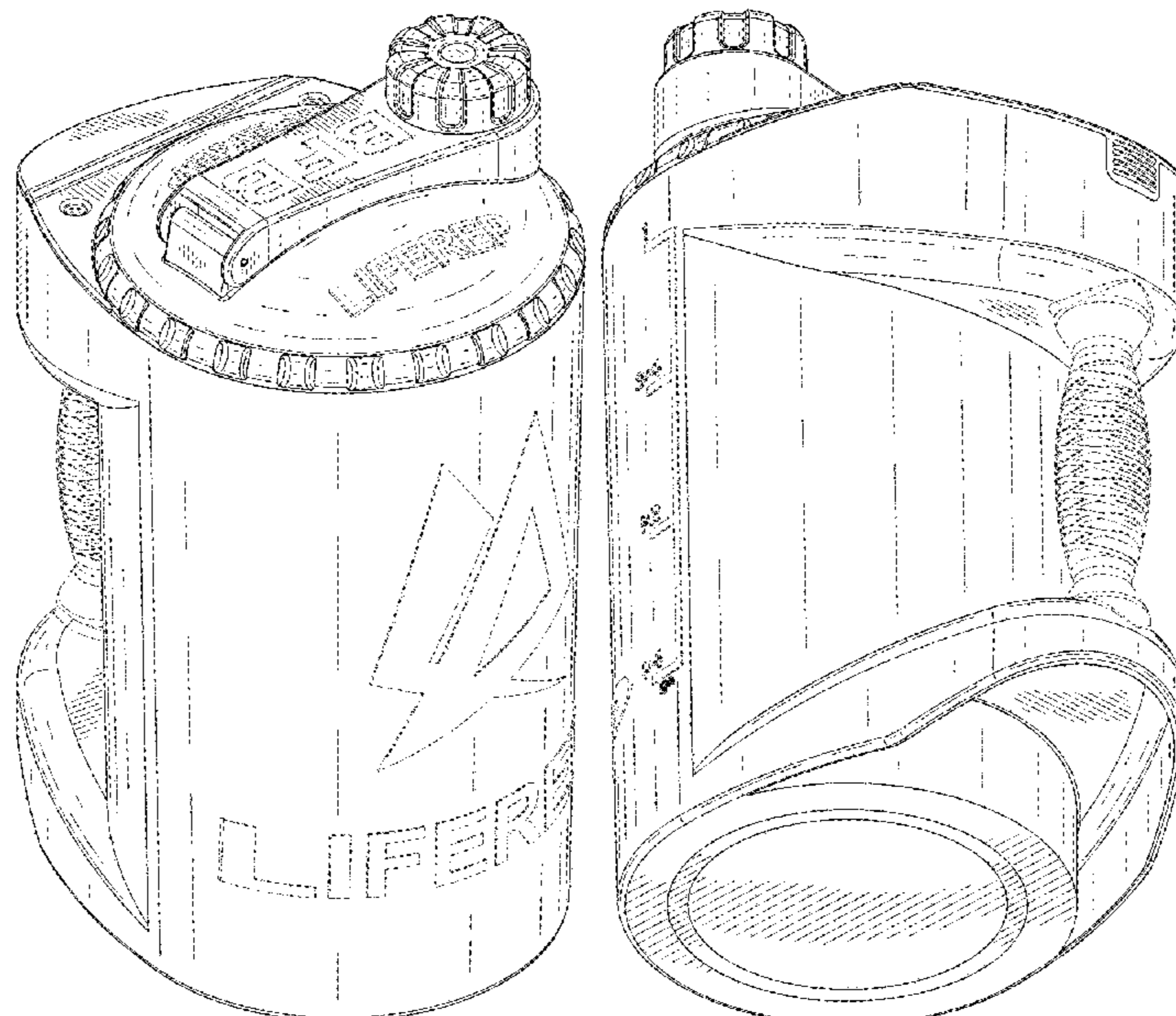
FIG. 5 is a right-side view of the water bottle shown in FIG. 1;

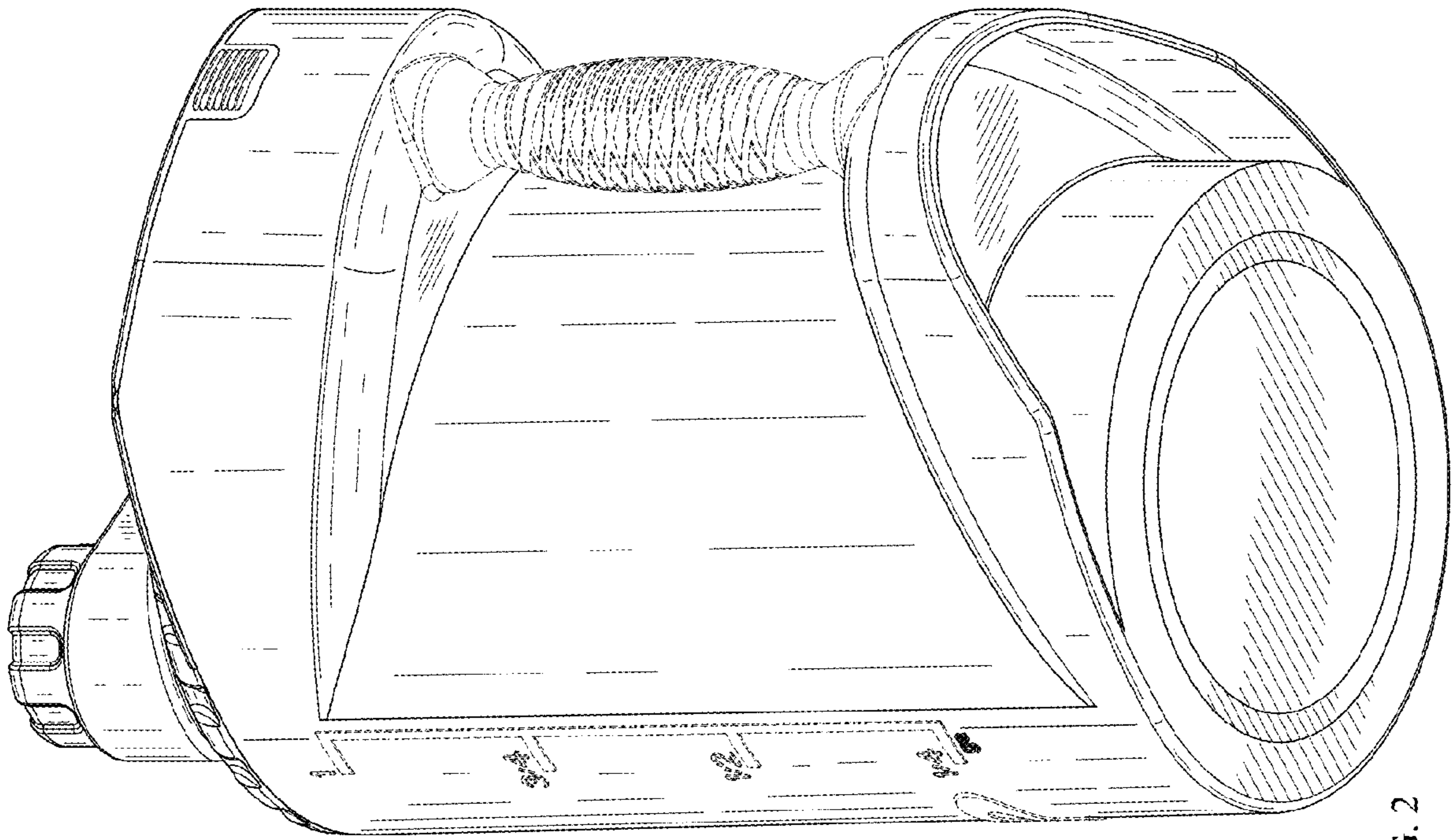

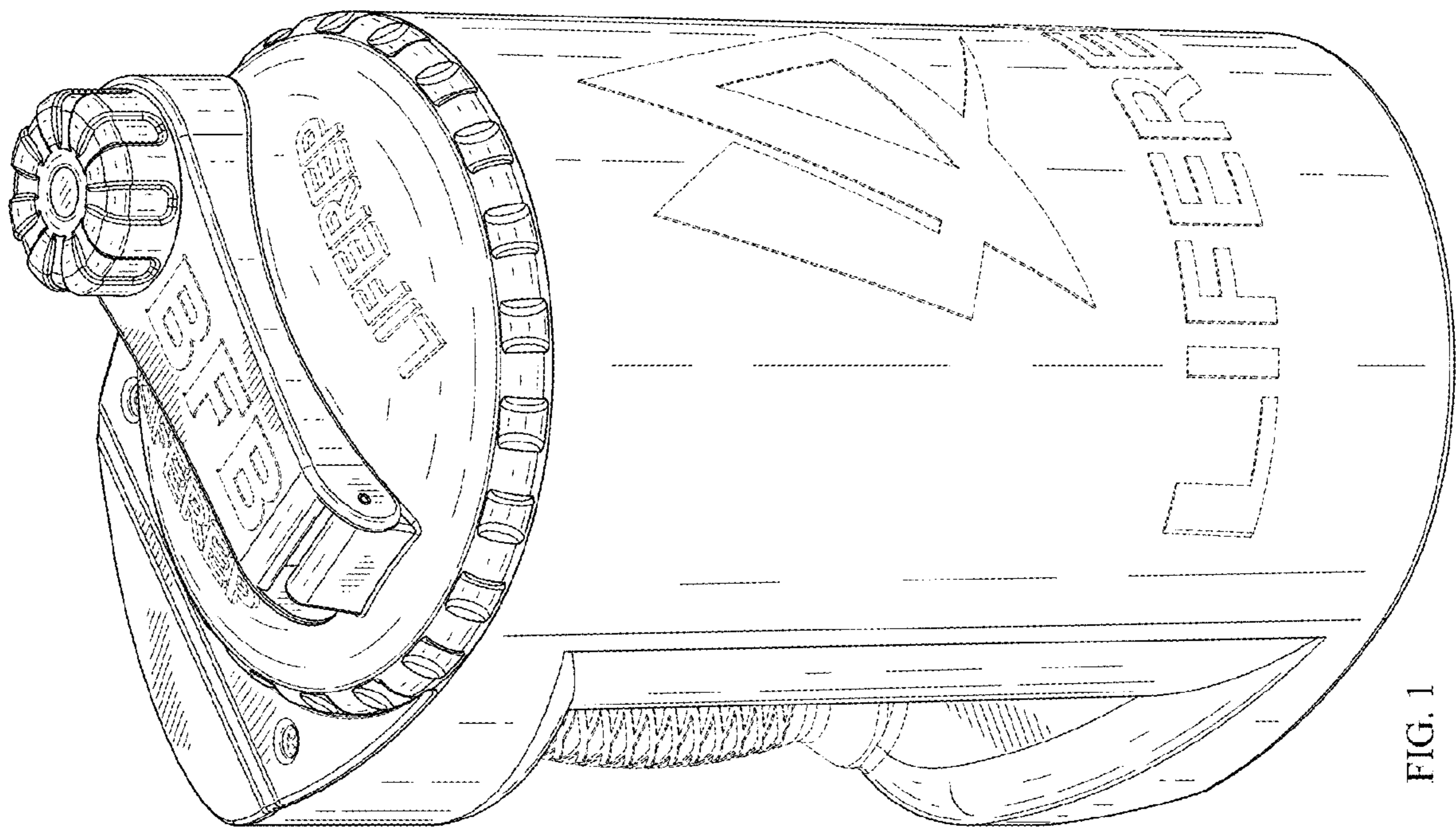

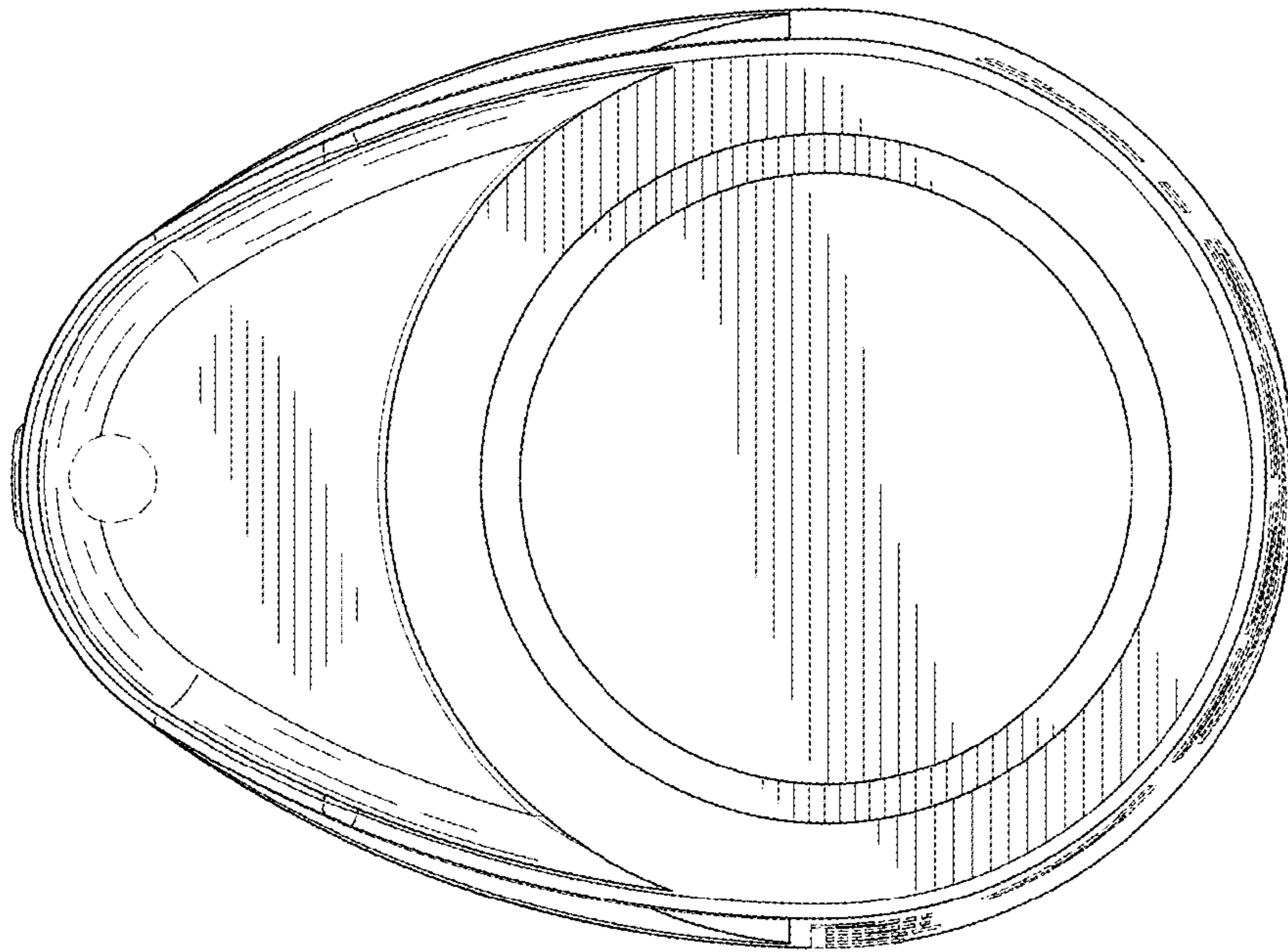

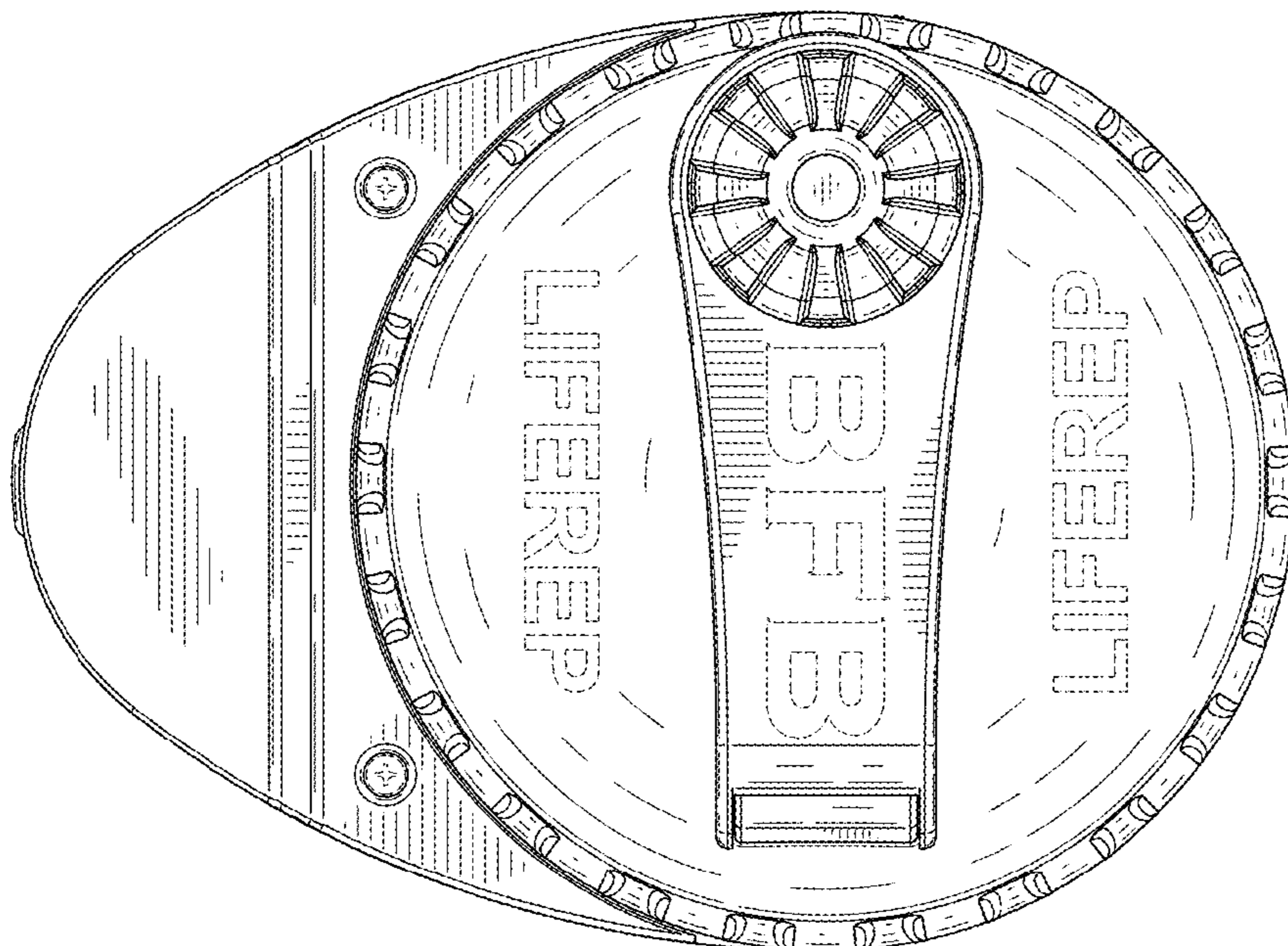
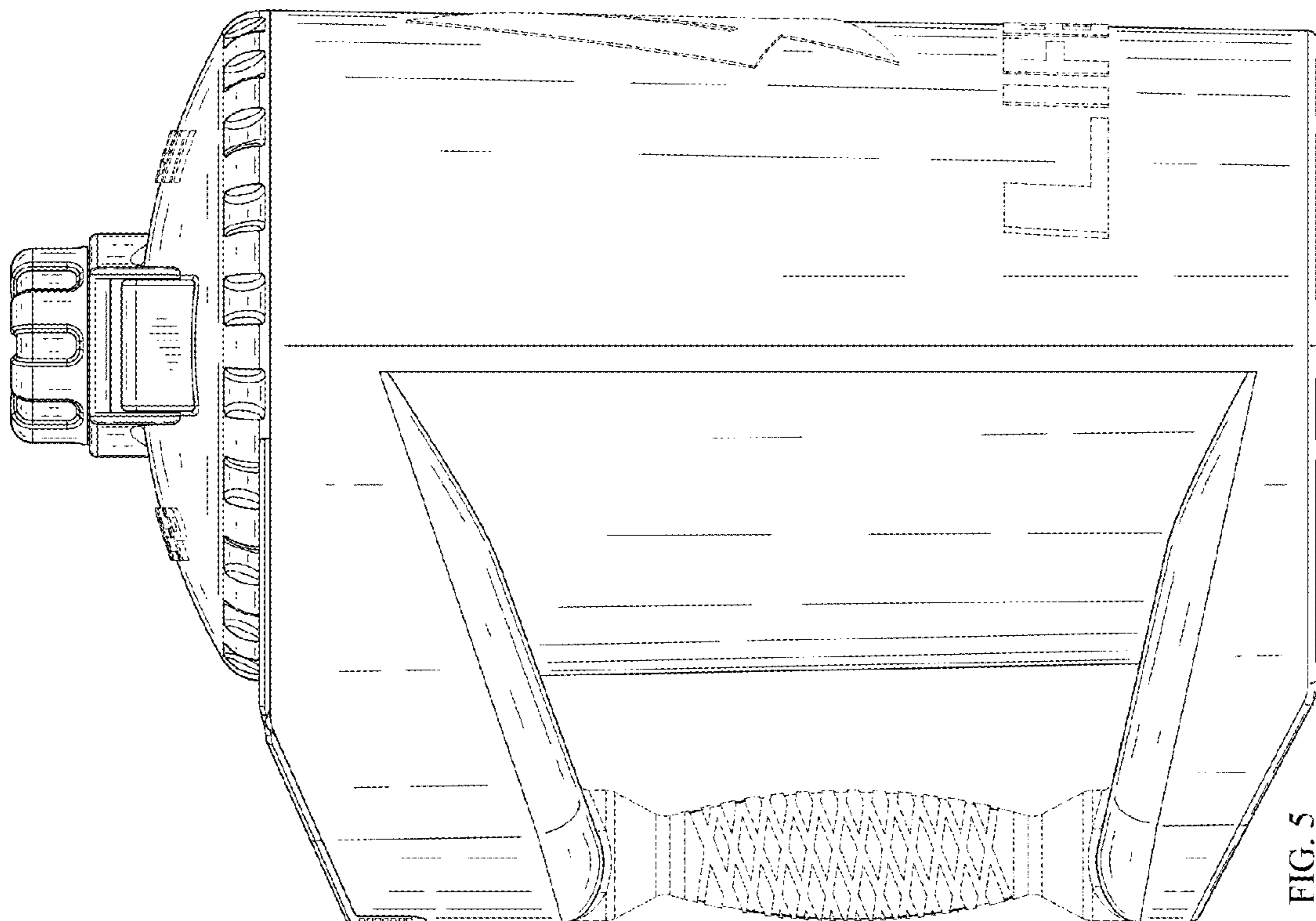
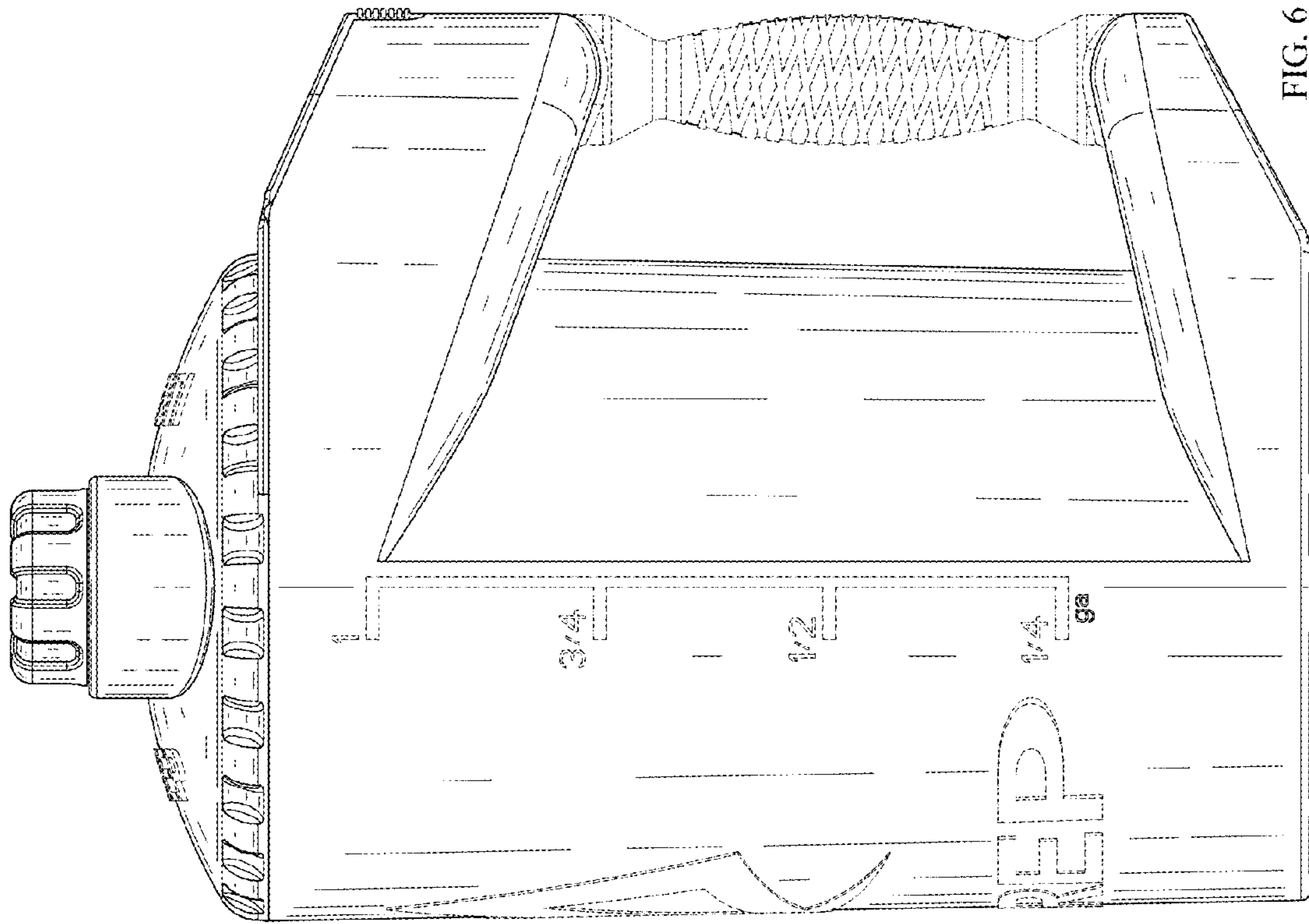

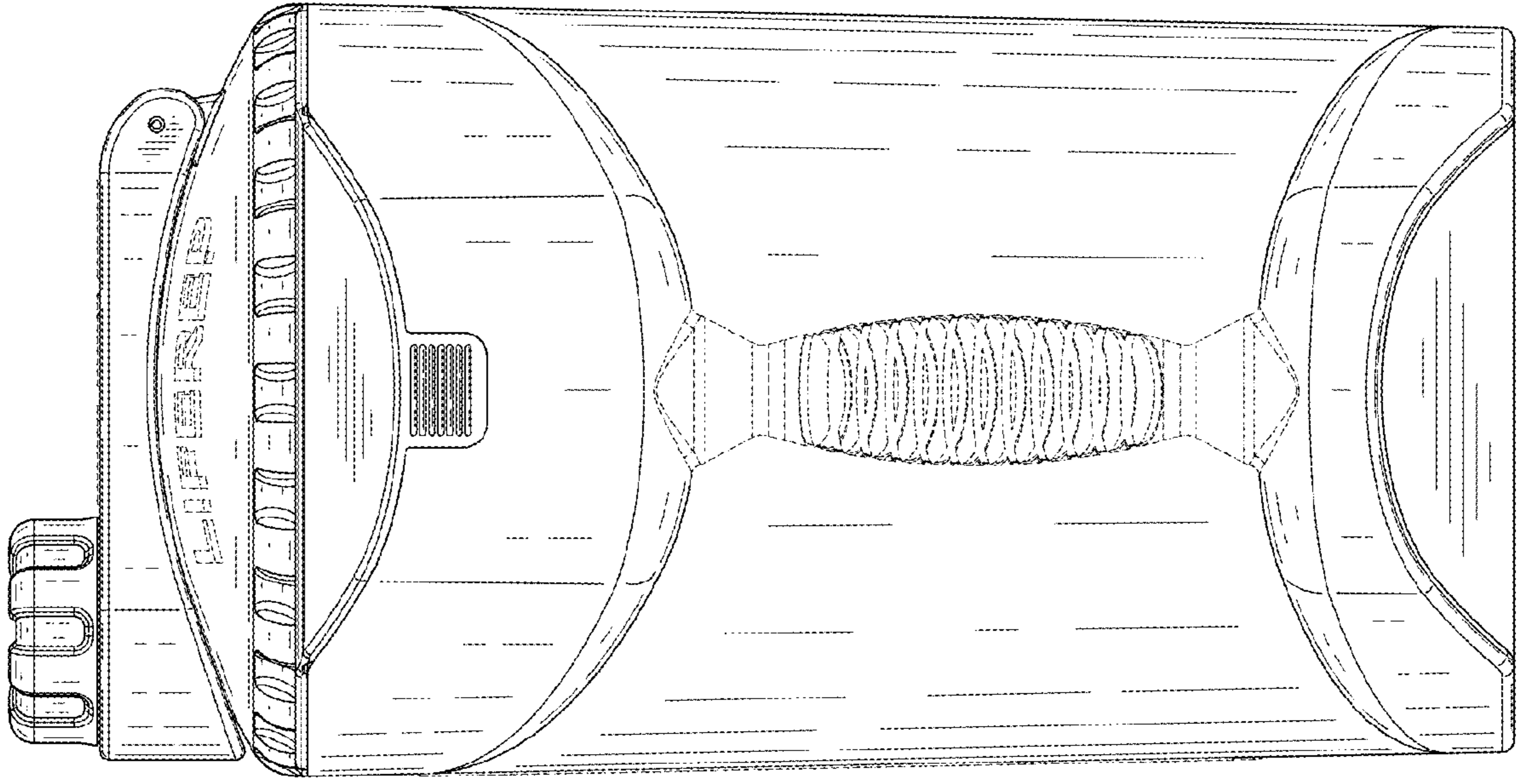

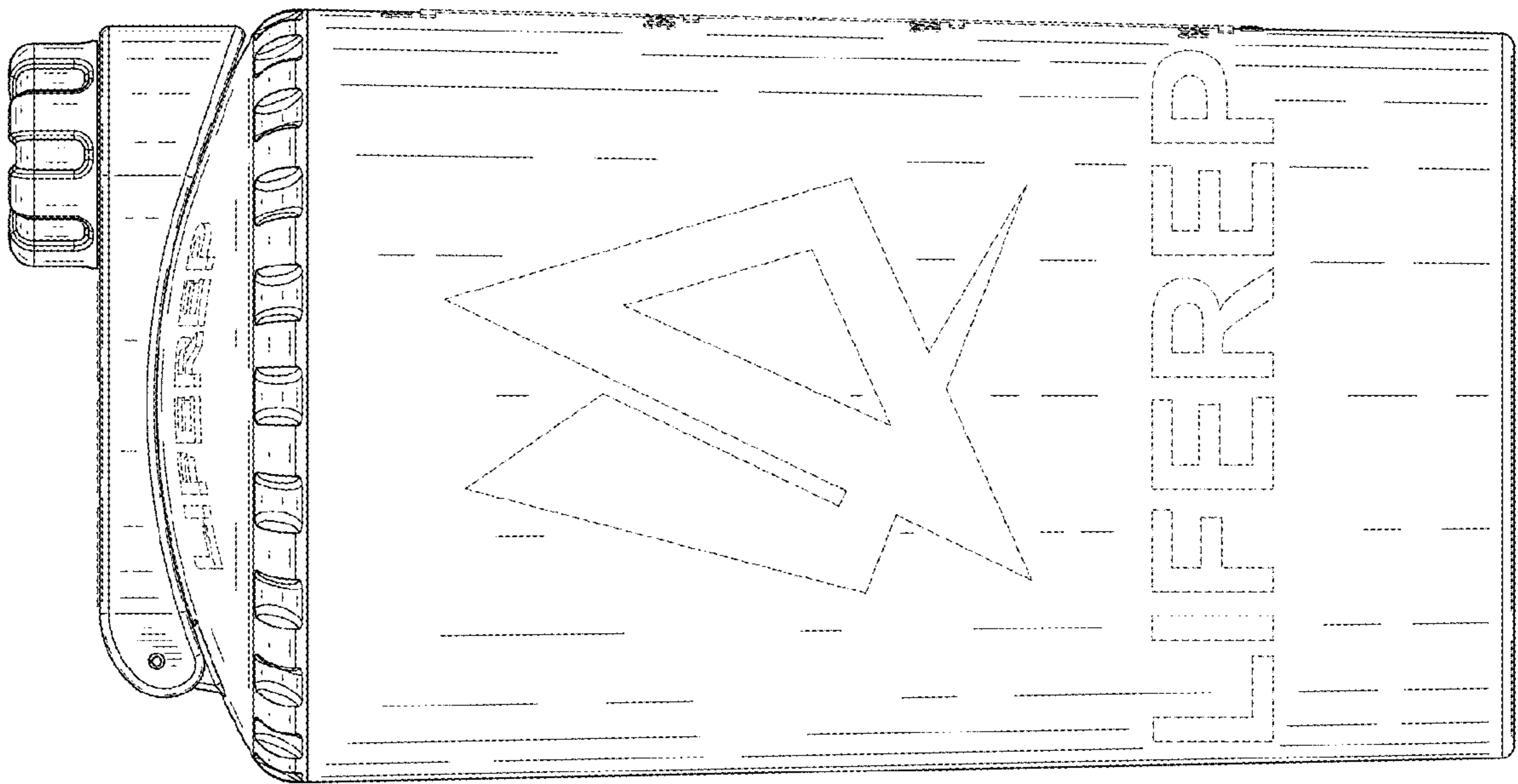
