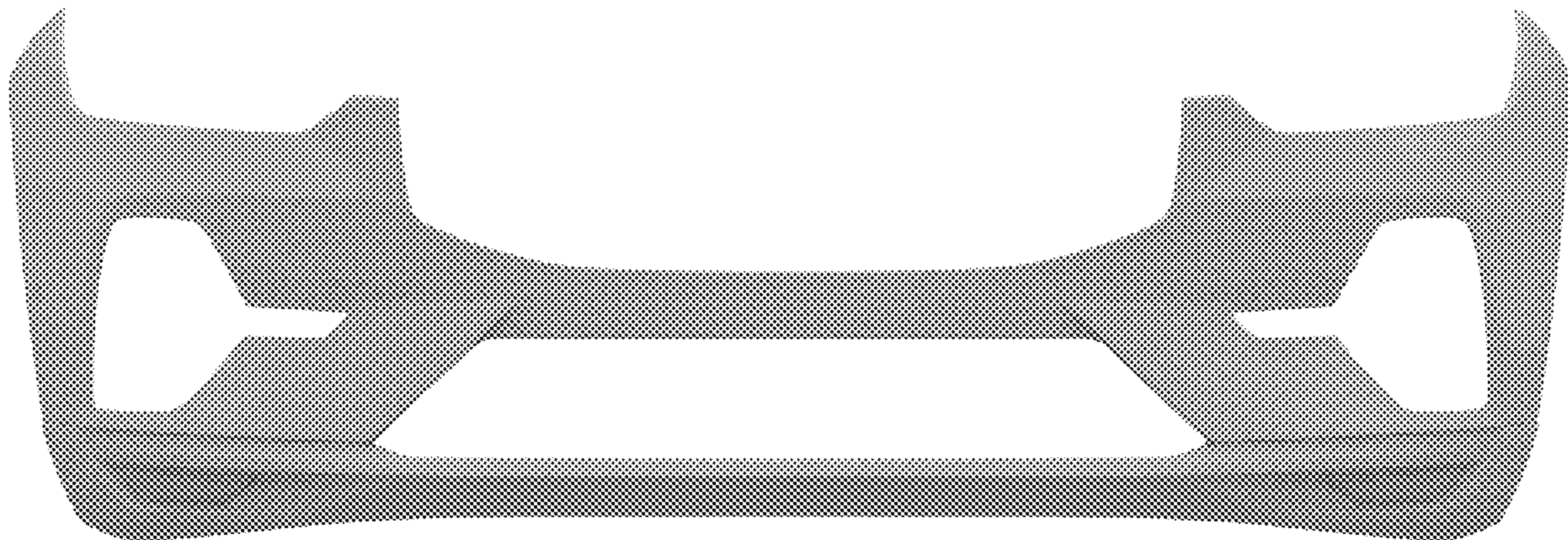
The ornamental design for a bumper for a vehicle, as shown and described.

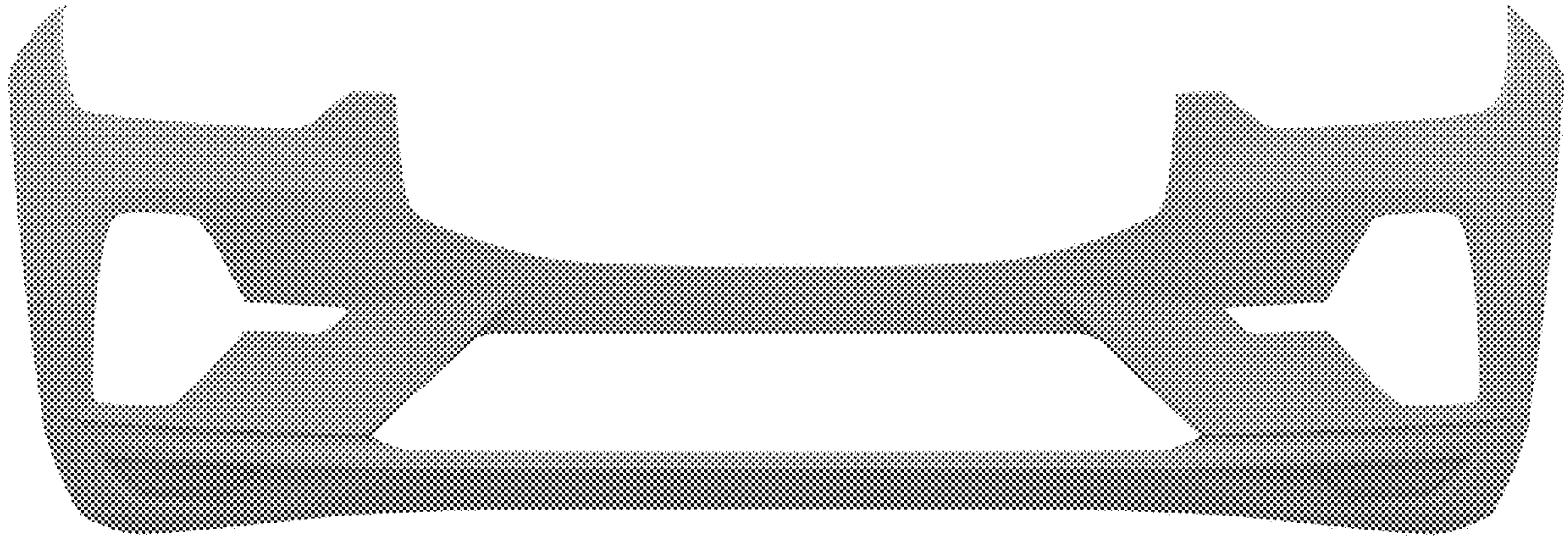

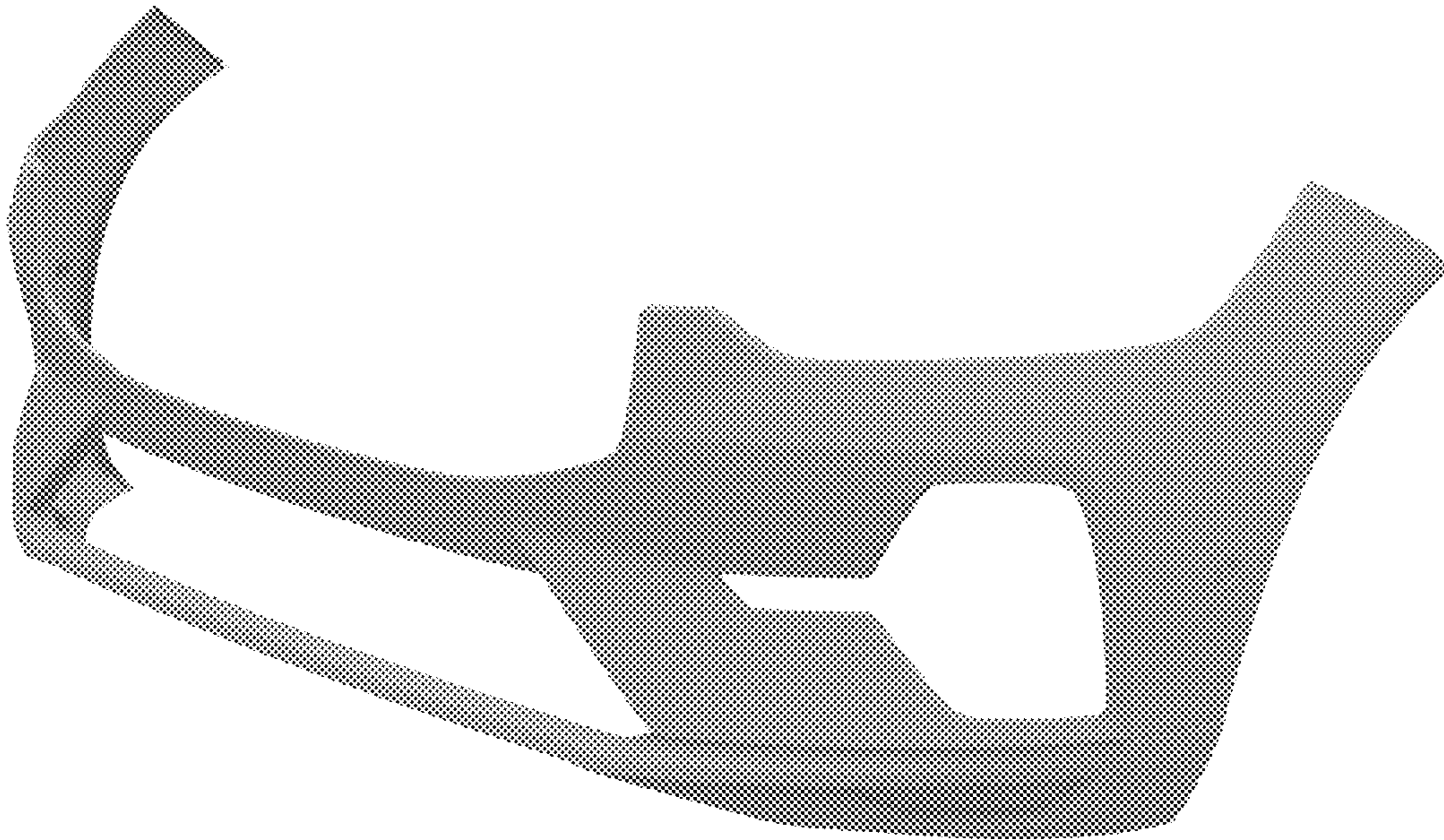

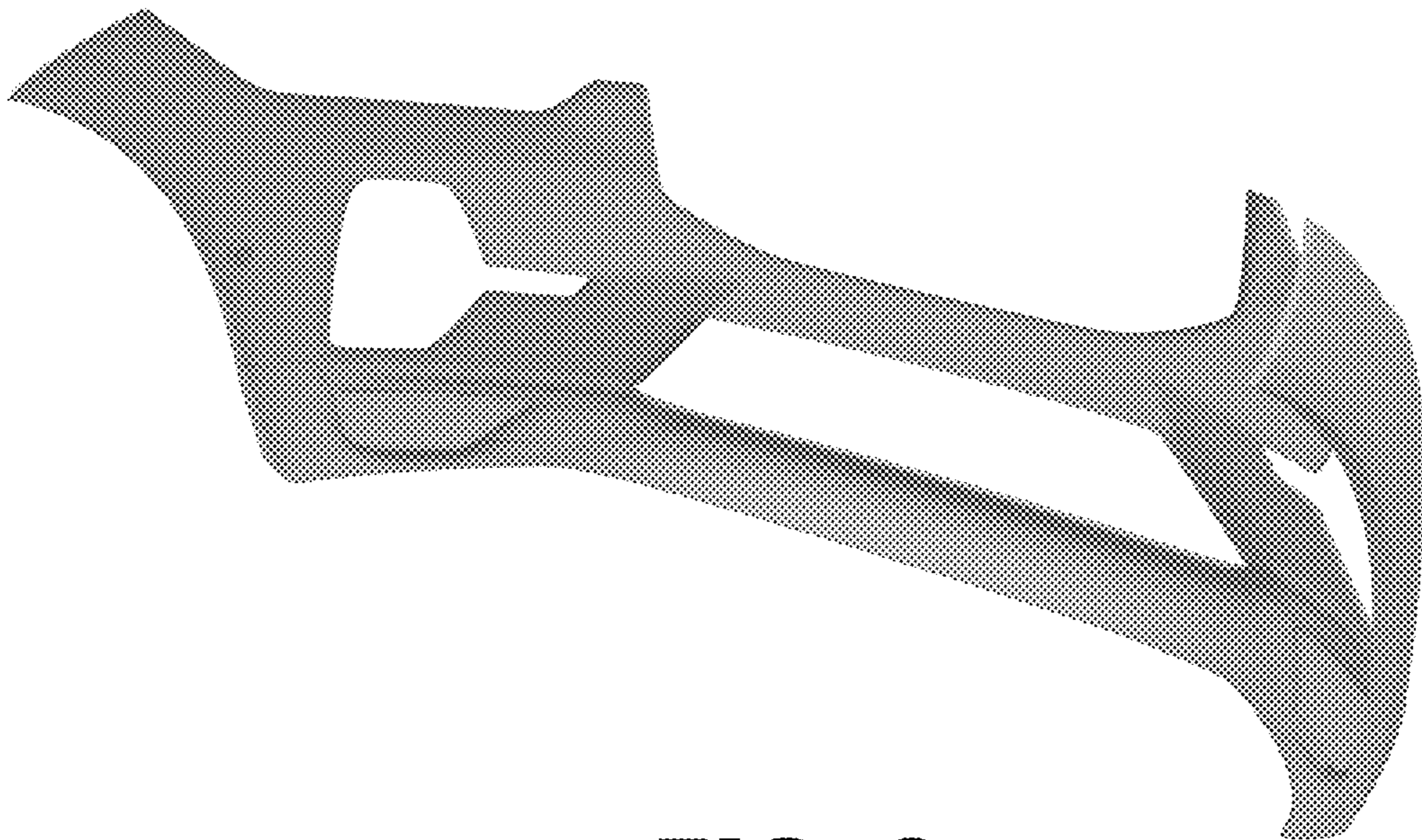

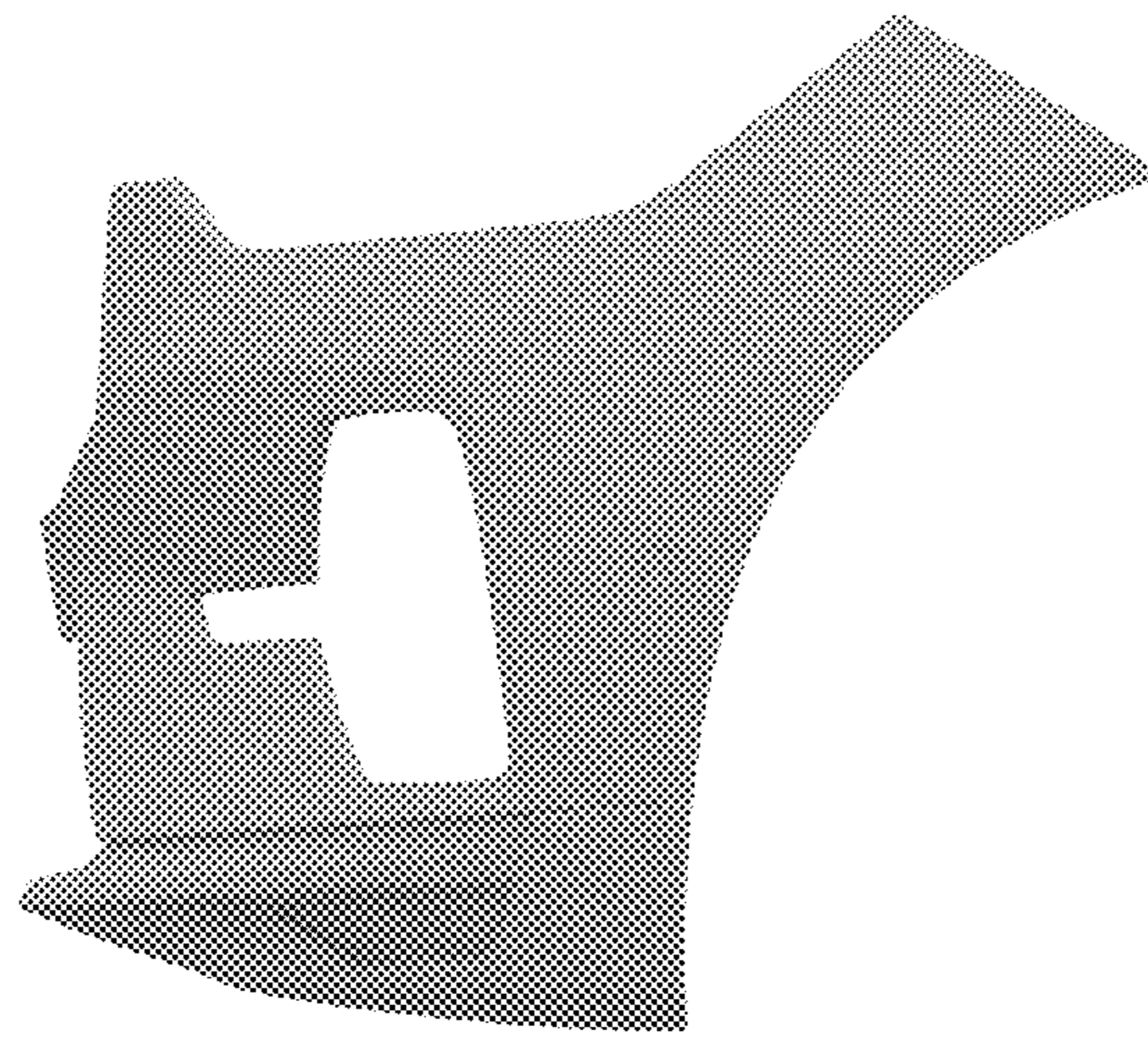

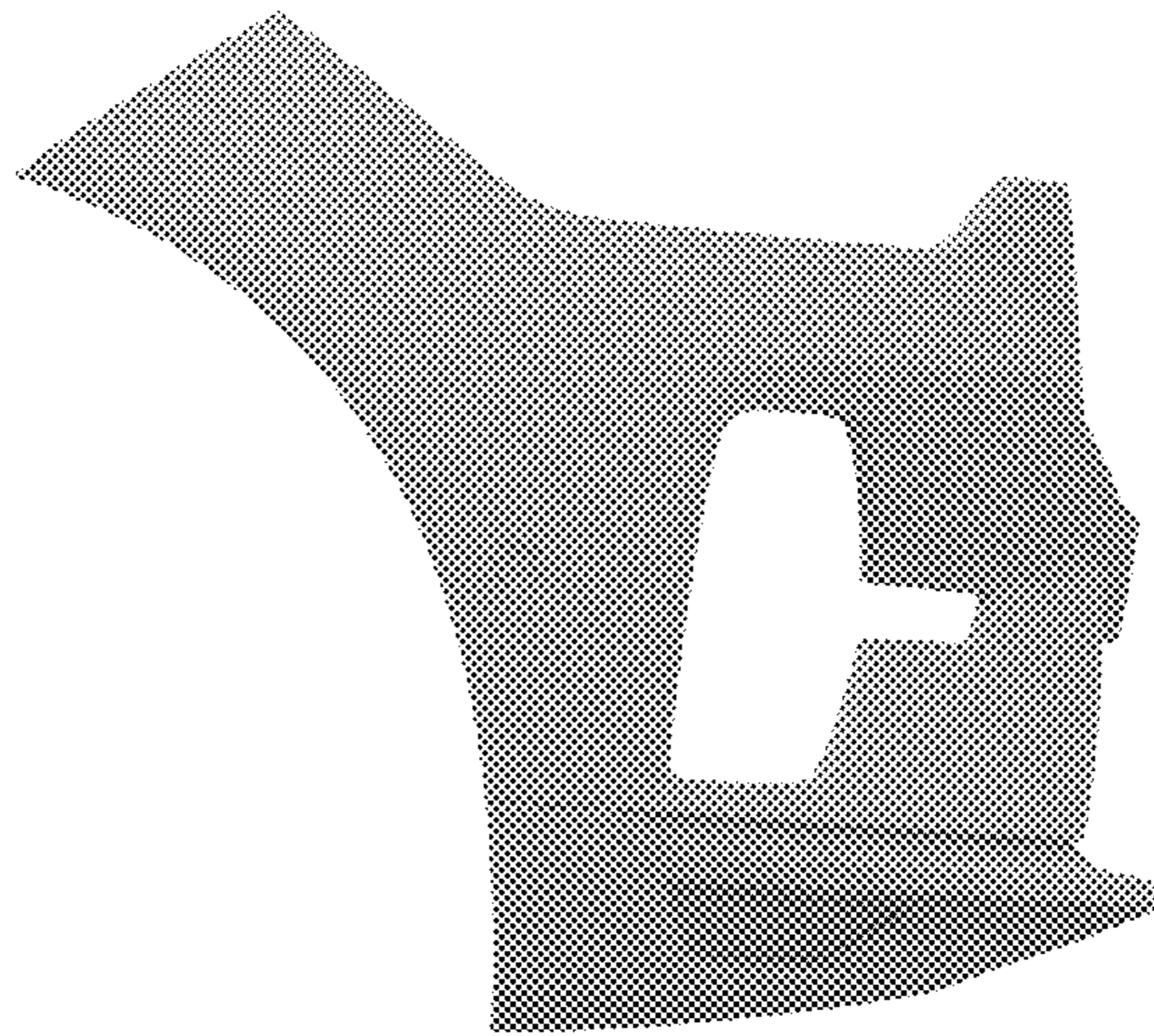

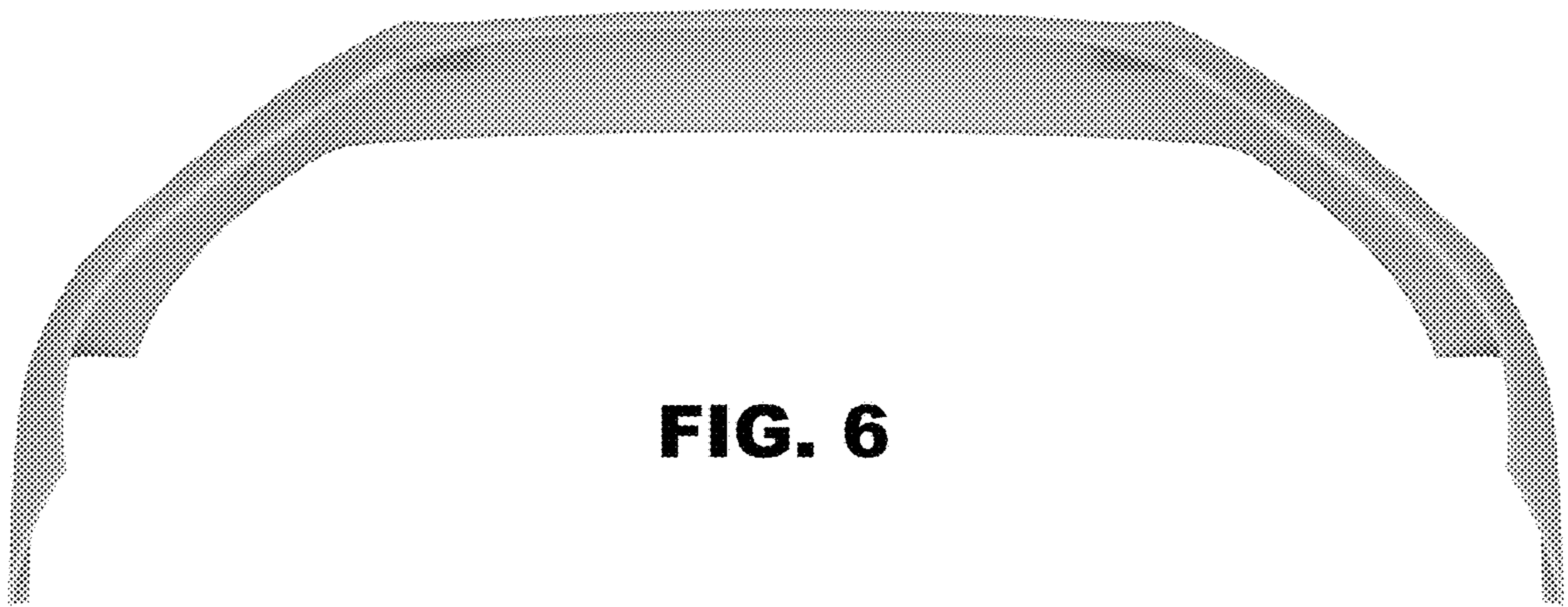

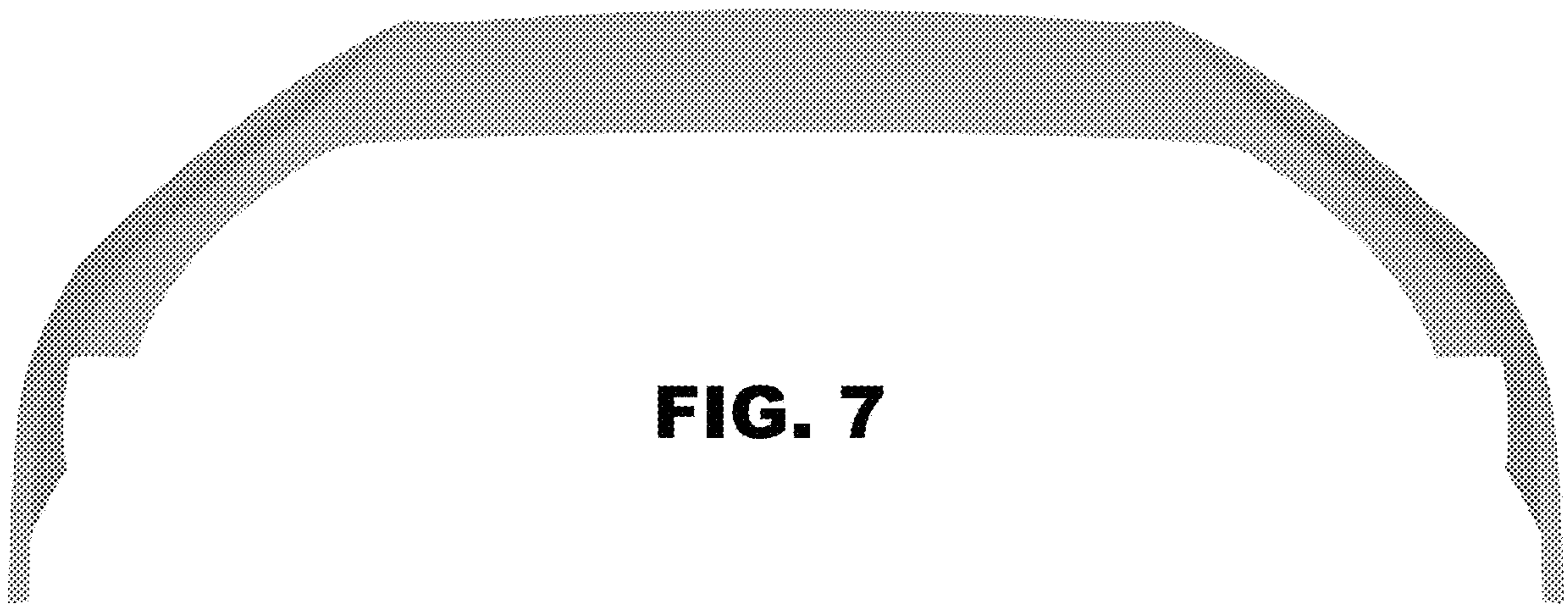

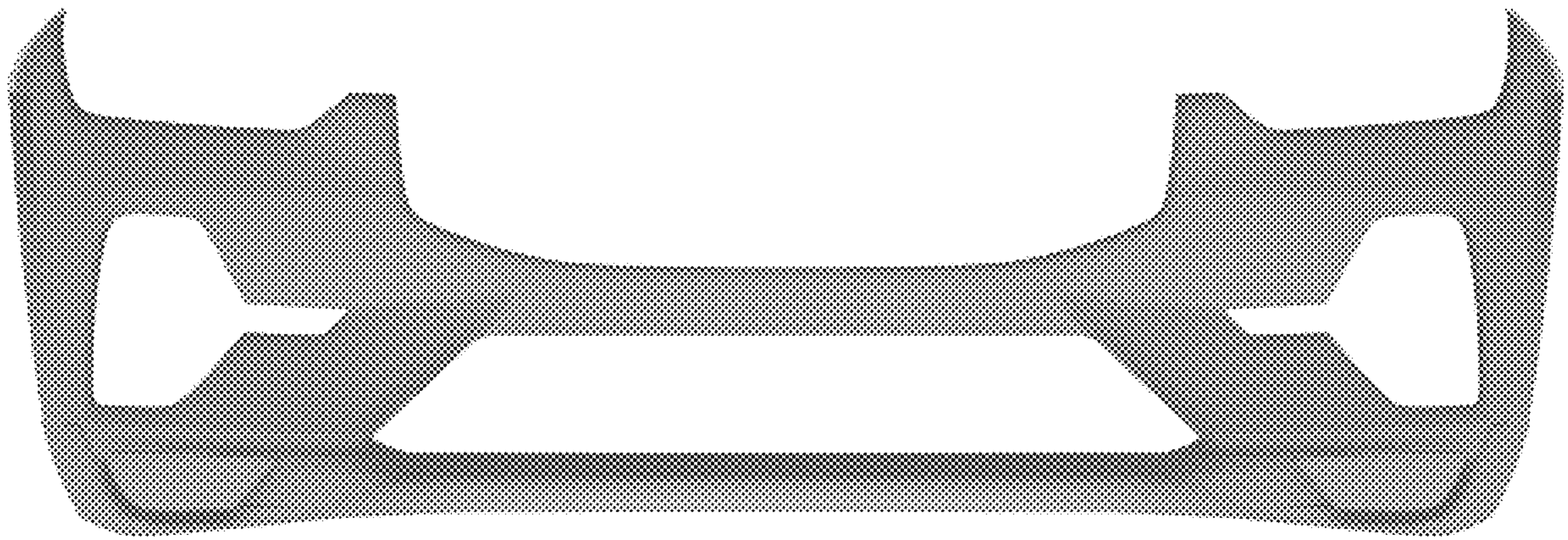
