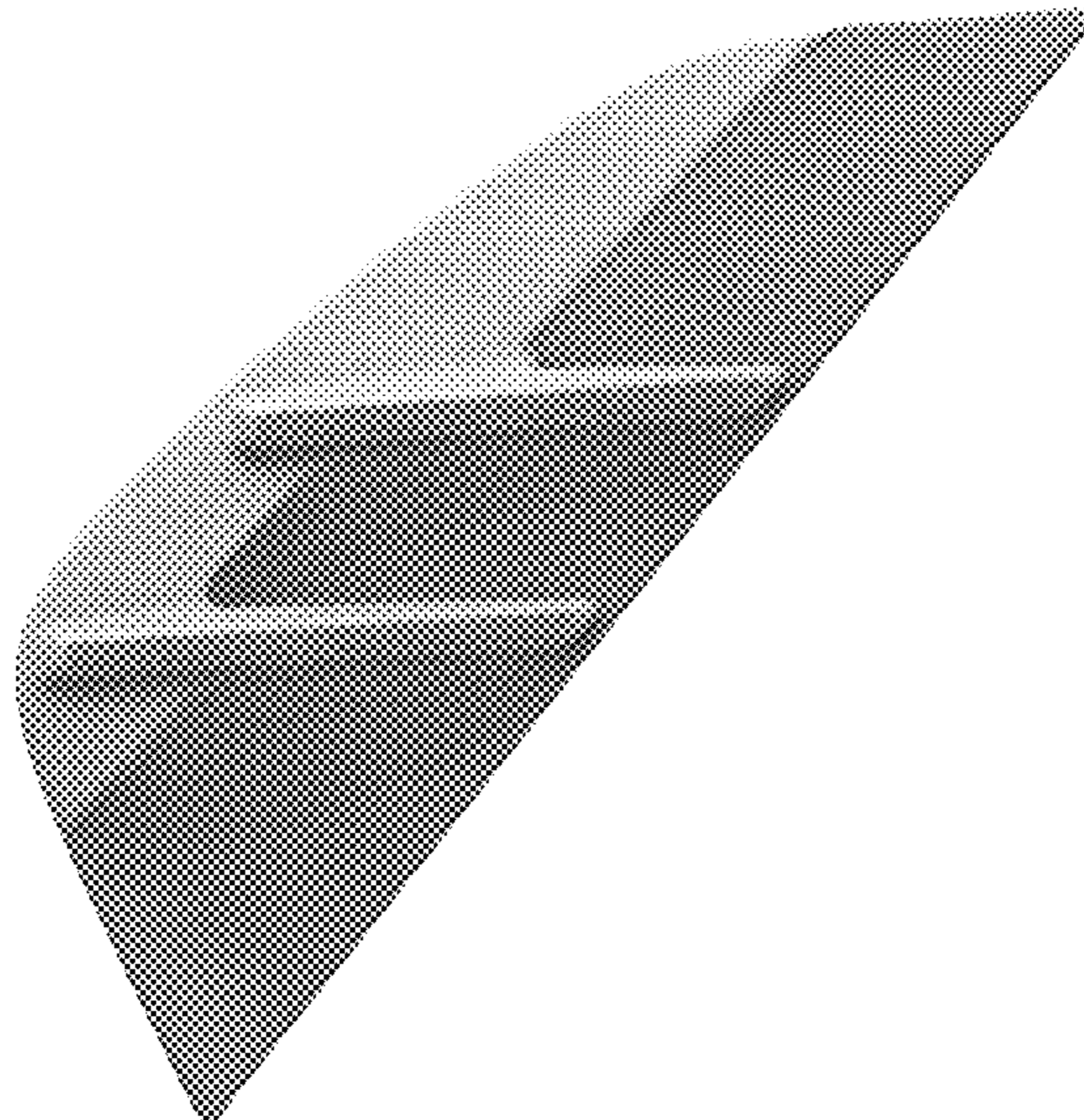
The broken lines in the drawings and the lightened areas within the broken lines illustrate portions of the decorative element for a vehicle body exterior that form no part of the claimed design.

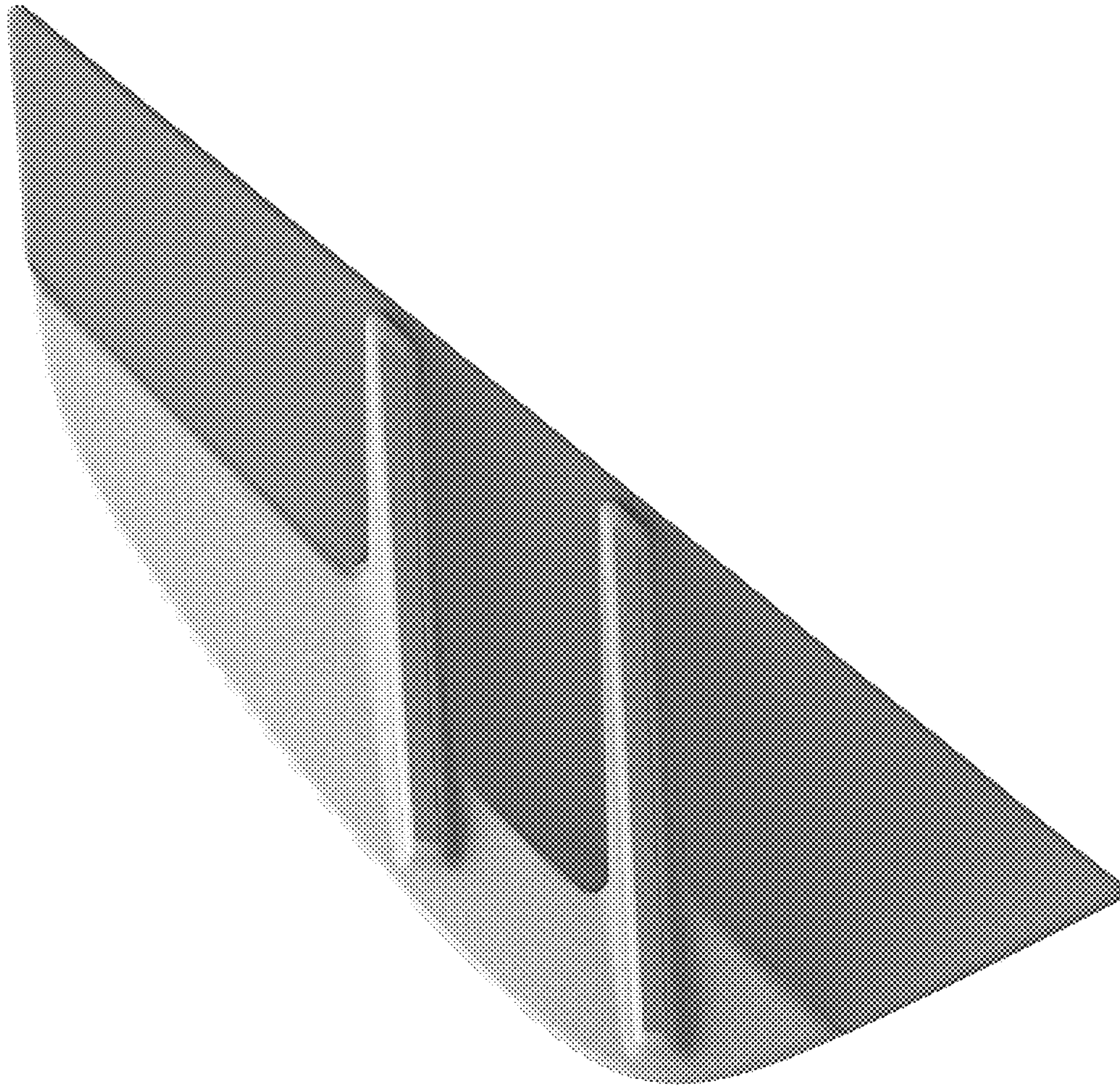

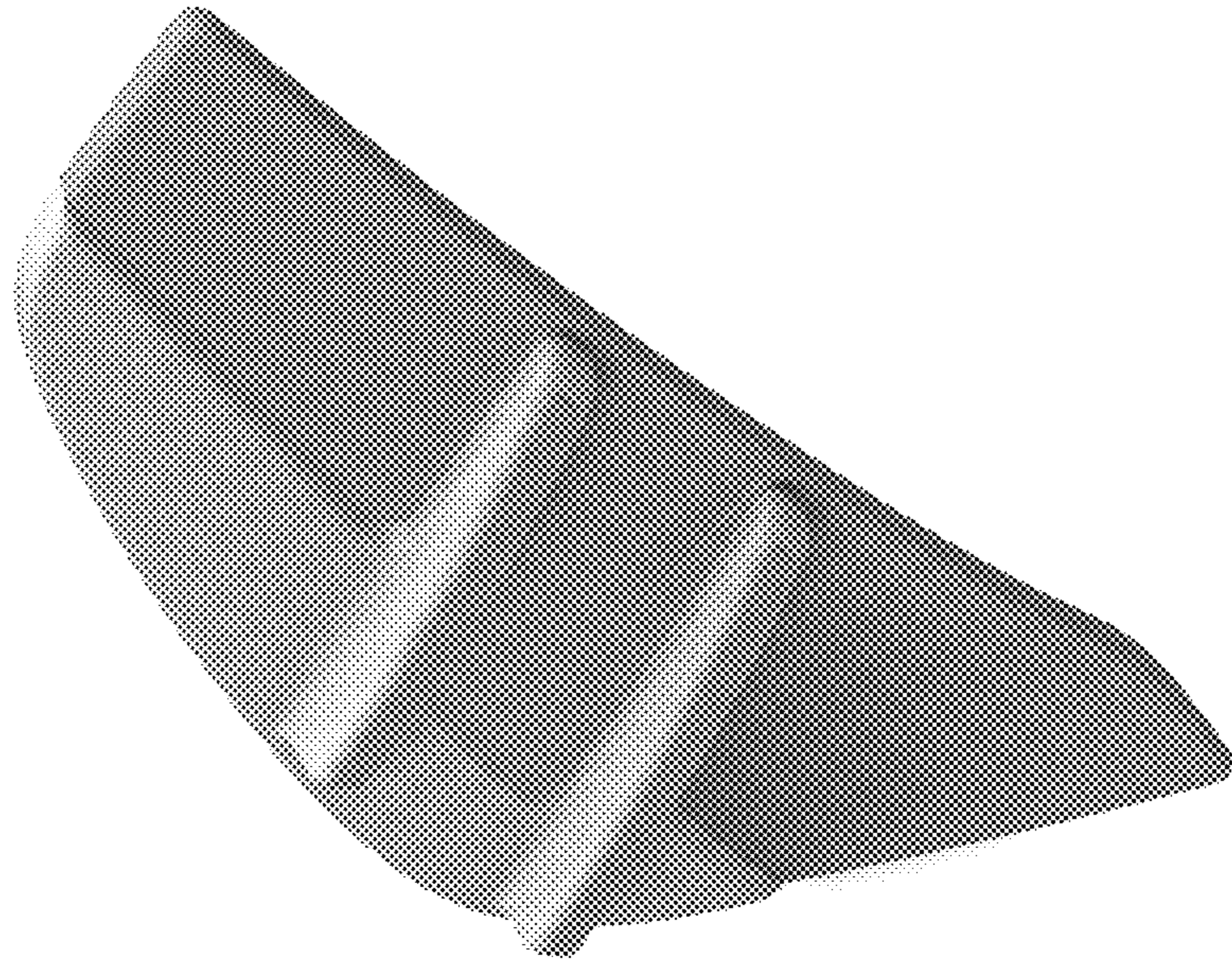

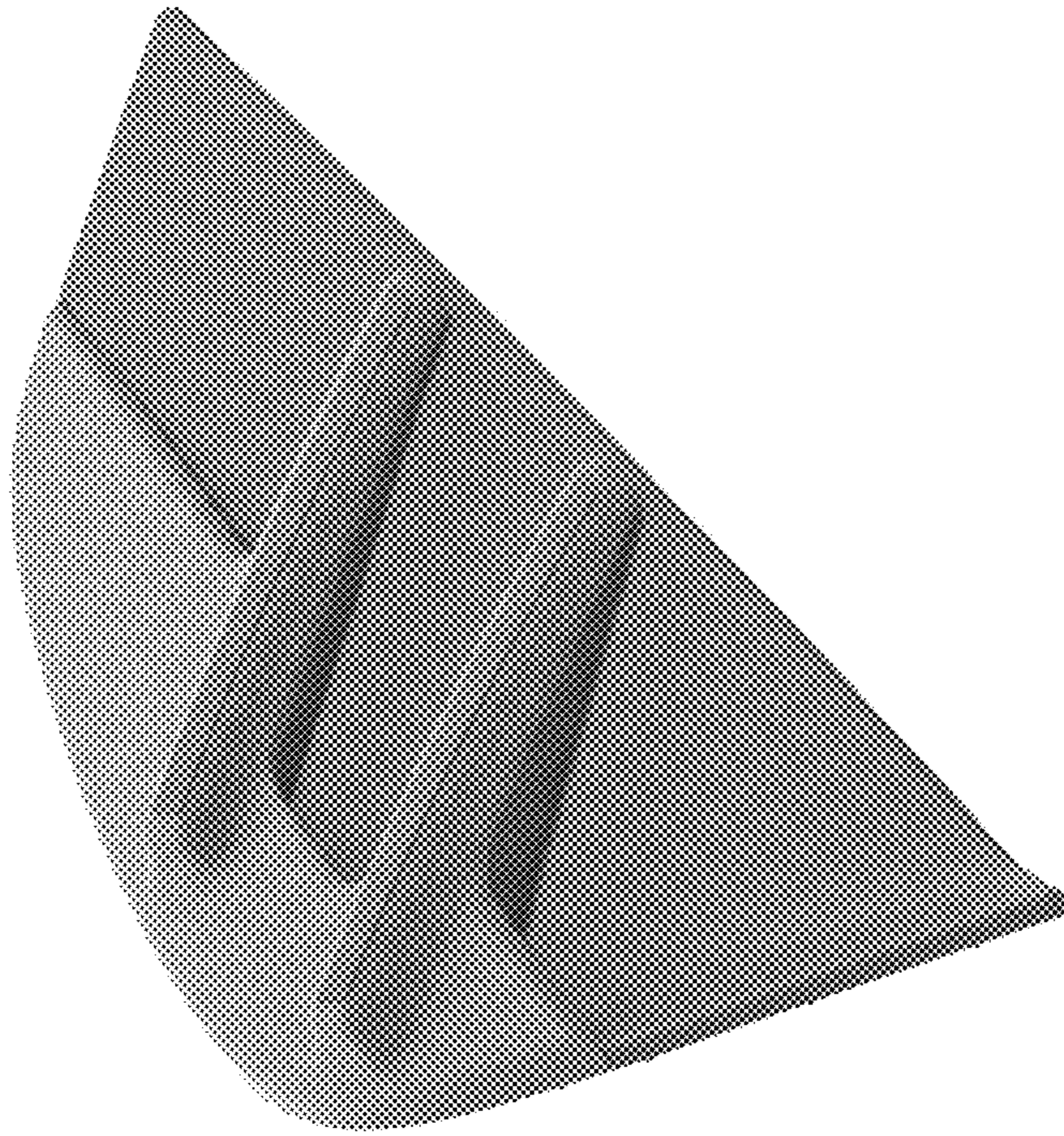

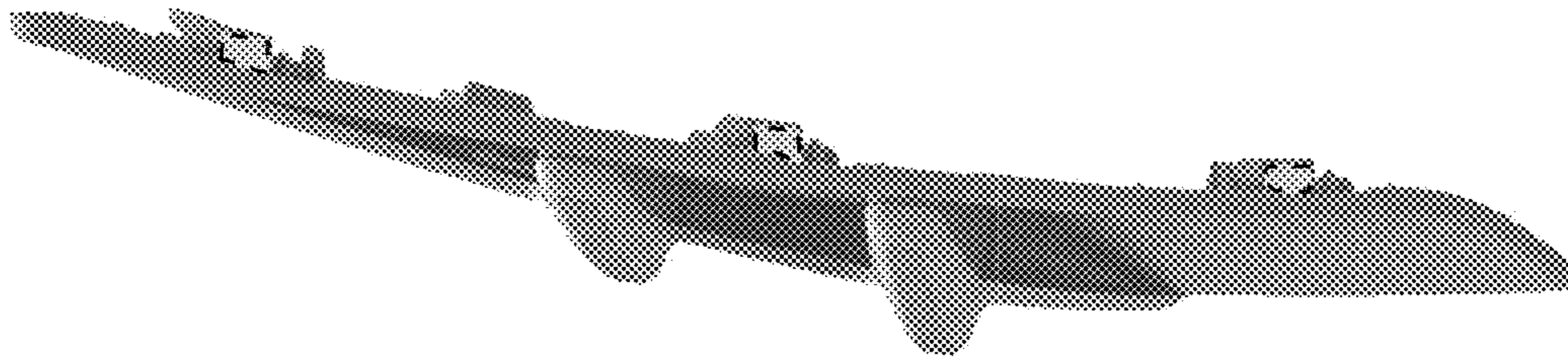




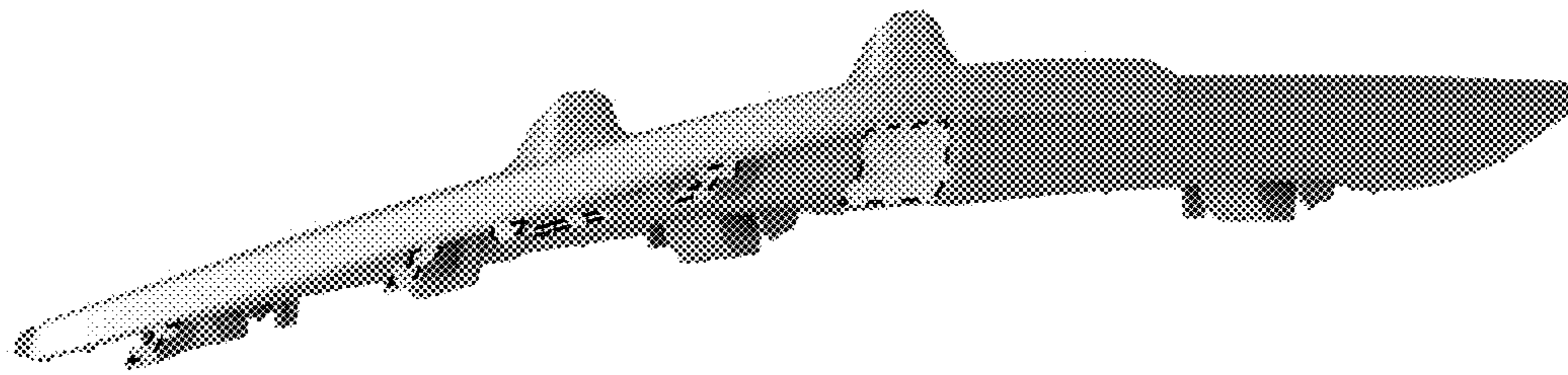

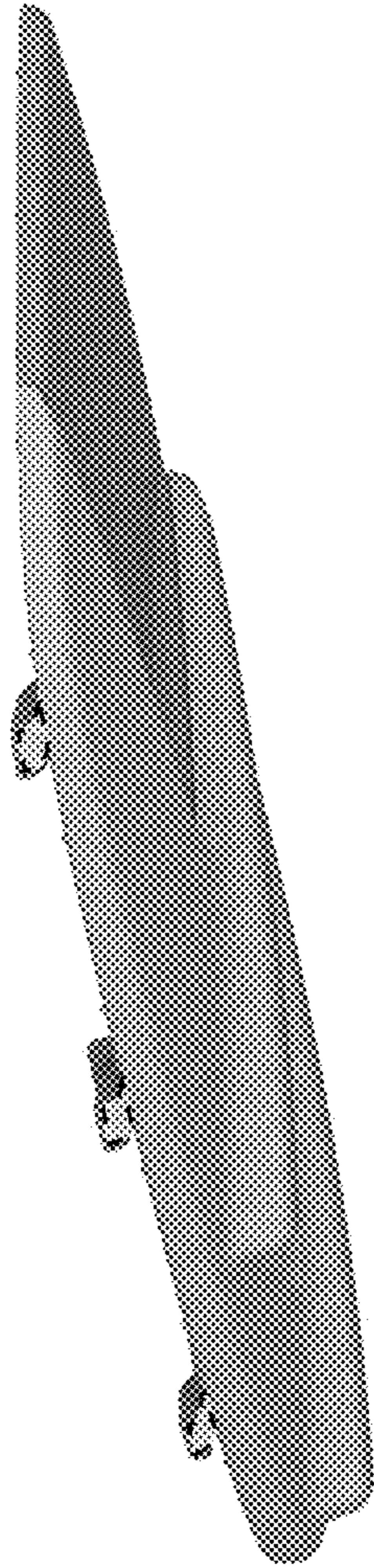

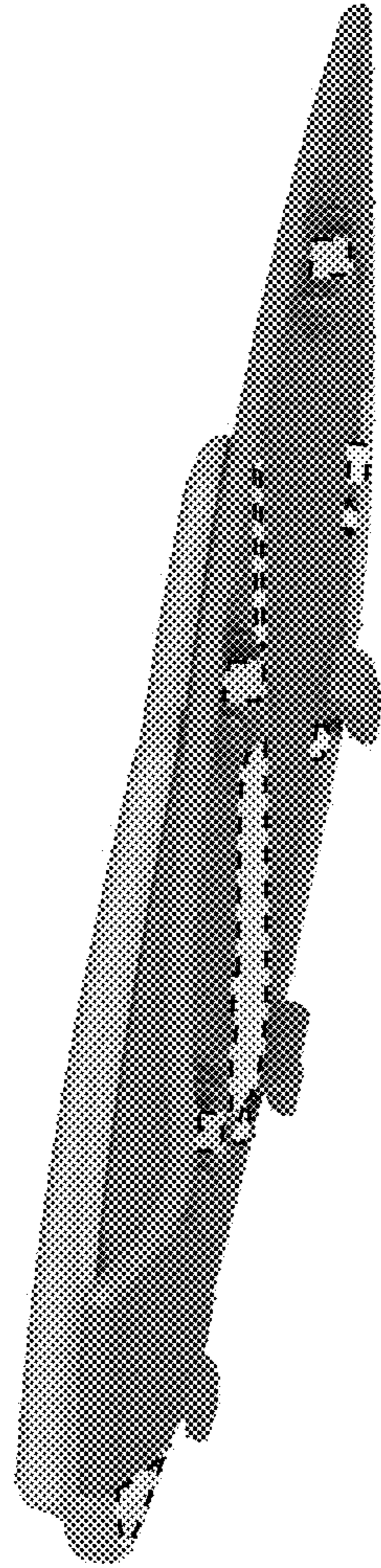

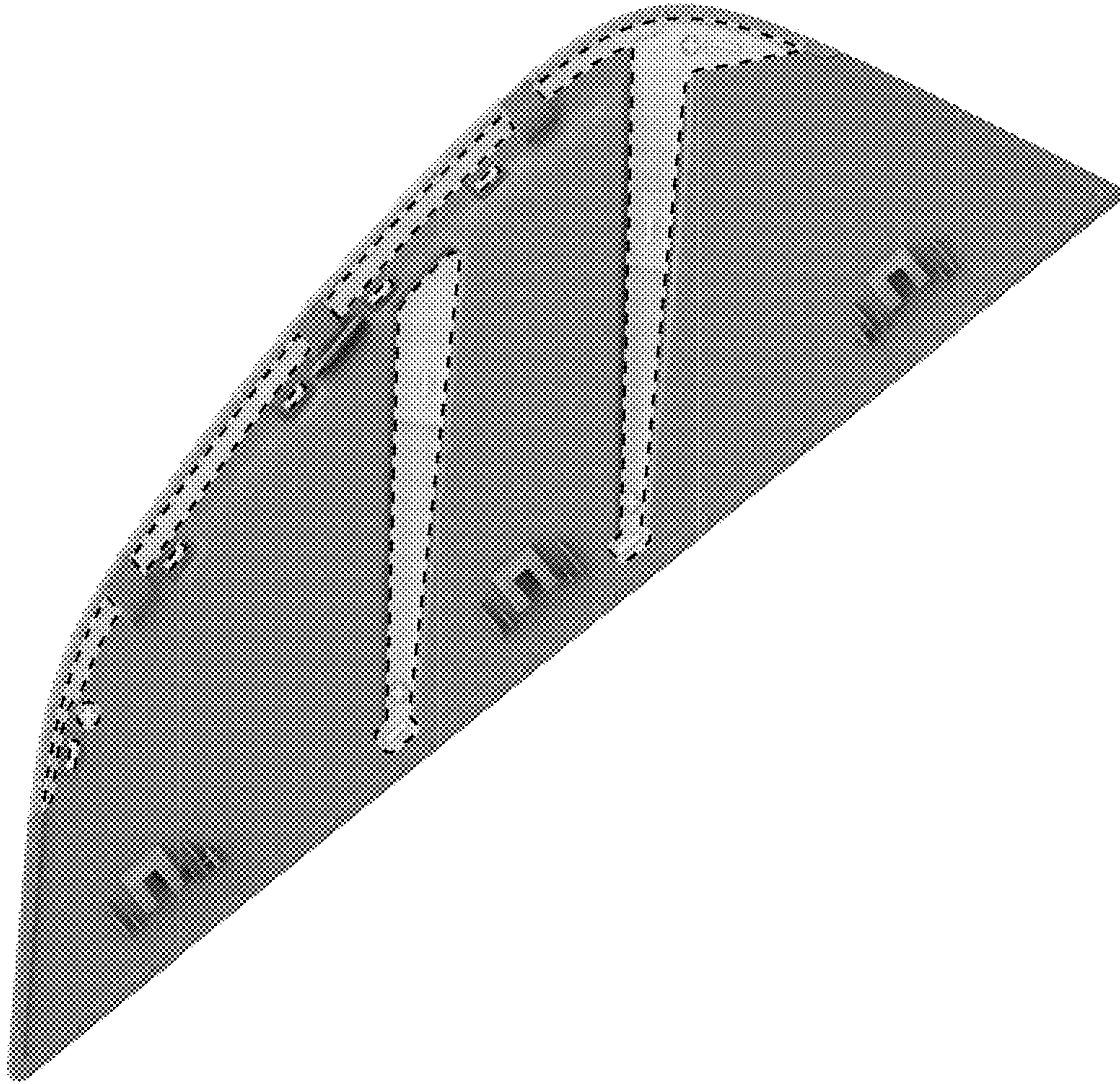
