(57) **CLAIM**

We claim the ornamental design for a case for electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right-side perspective view of a case for electronic device showing our new design according to a first, second, third, fourth, fifth, sixth, seventh and eighth embodiment;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view of the case for electronic device according to the first embodiment;

FIG. 4 is a left-side elevational view of the case for electronic device according to the first, second, third, fourth, fifth, sixth, seventh and eighth embodiments;

FIG. 5 is a right-side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a rear, left-side, and bottom perspective view of the case for electronic device according to the first embodiment;

FIG. 9 is a rear elevational view of the case for electronic device according to the second embodiment;

FIG. 10 is a rear, left-side, and bottom perspective view thereof;

FIG. 11 is a rear elevational view of the case for electronic device according to the third embodiment;

FIG. 12 is a rear, left-side, and bottom perspective view thereof;

FIG. 13 is a rear elevational view of the case for electronic device according to the fourth embodiment;

FIG. 14 is a rear, left-side, and bottom perspective view thereof;

FIG. 15 is a rear elevational view of the case for electronic device according to the fifth embodiment;

FIG. 16 is a rear, left-side, and bottom perspective view thereof;

FIG. 17 is a rear elevational view of the case for electronic device according to the sixth embodiment;

FIG. 18 is a rear, left-side, and bottom perspective view thereof;

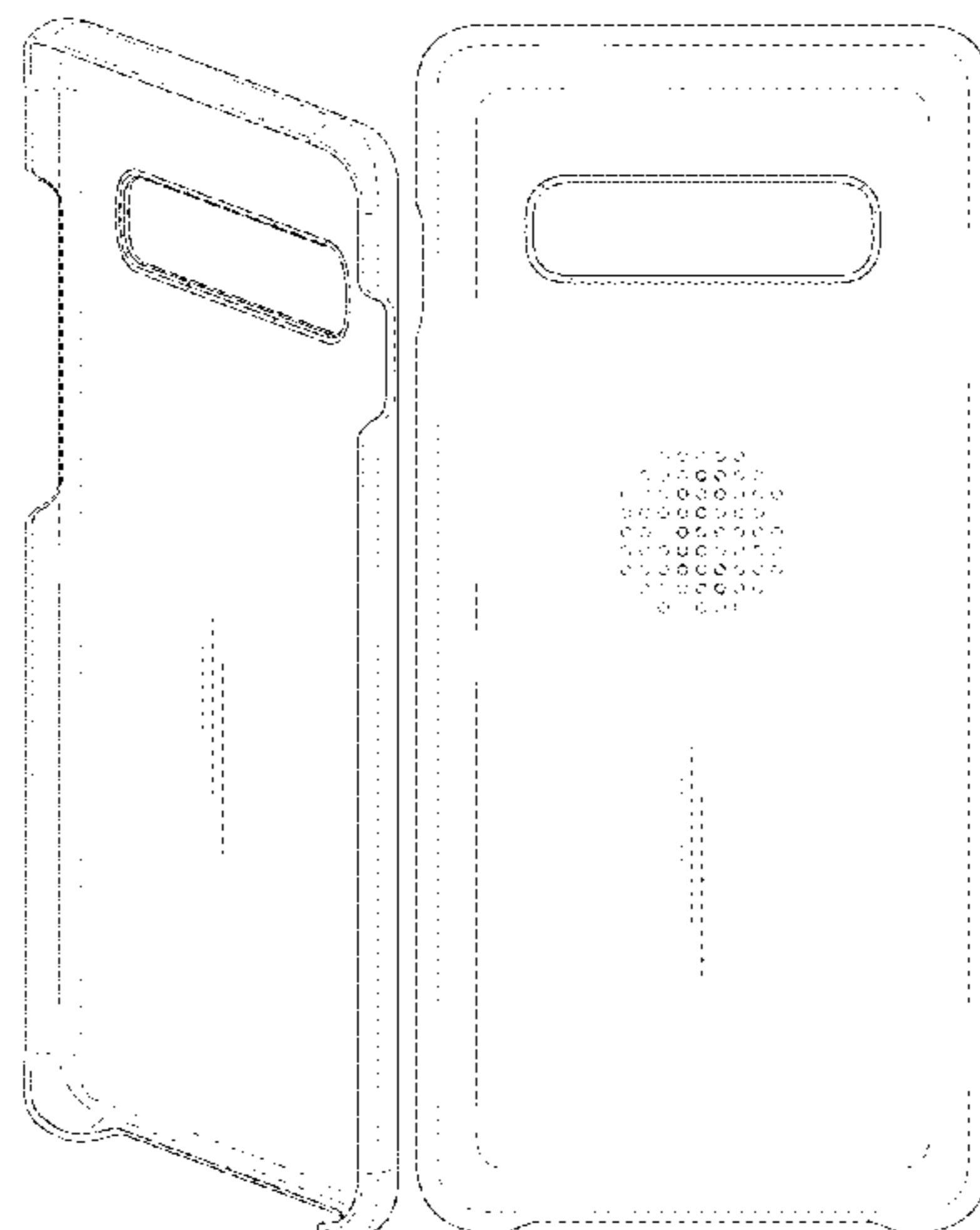


FIG. 19 is a rear elevational view of the case for electronic device according to the seventh embodiment;

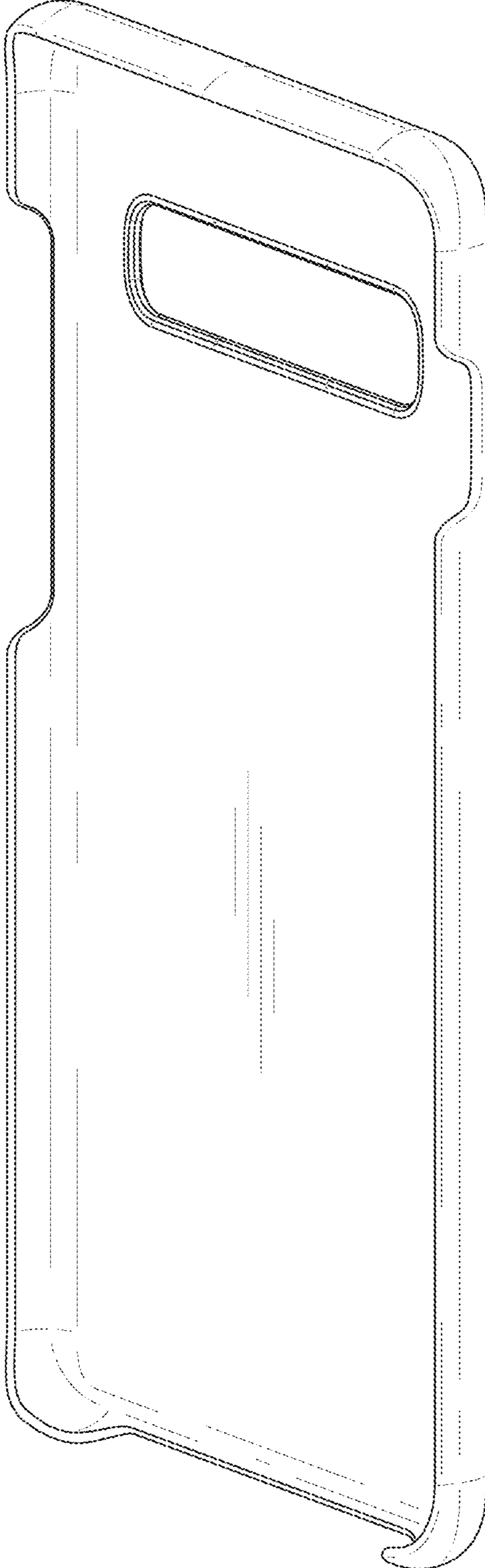

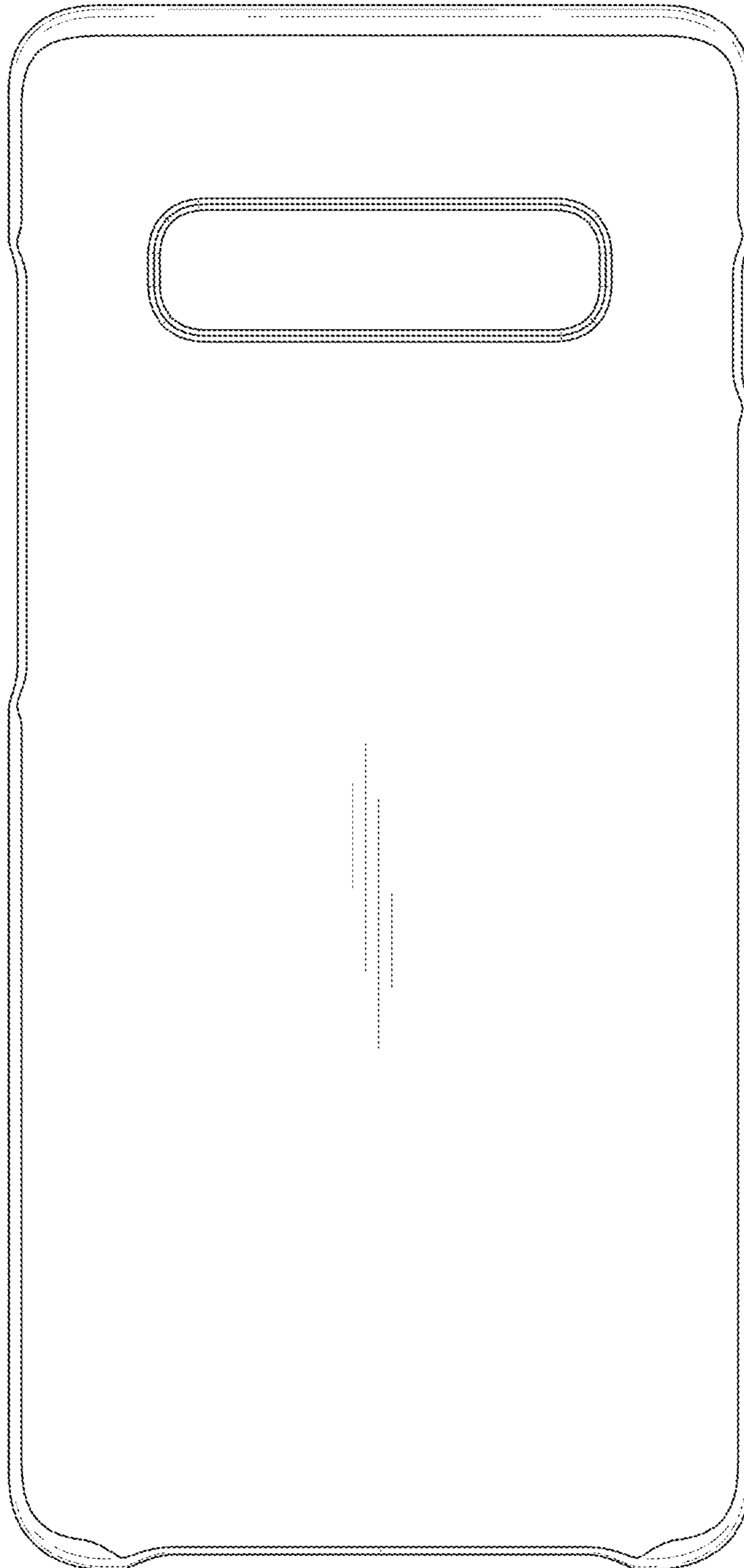

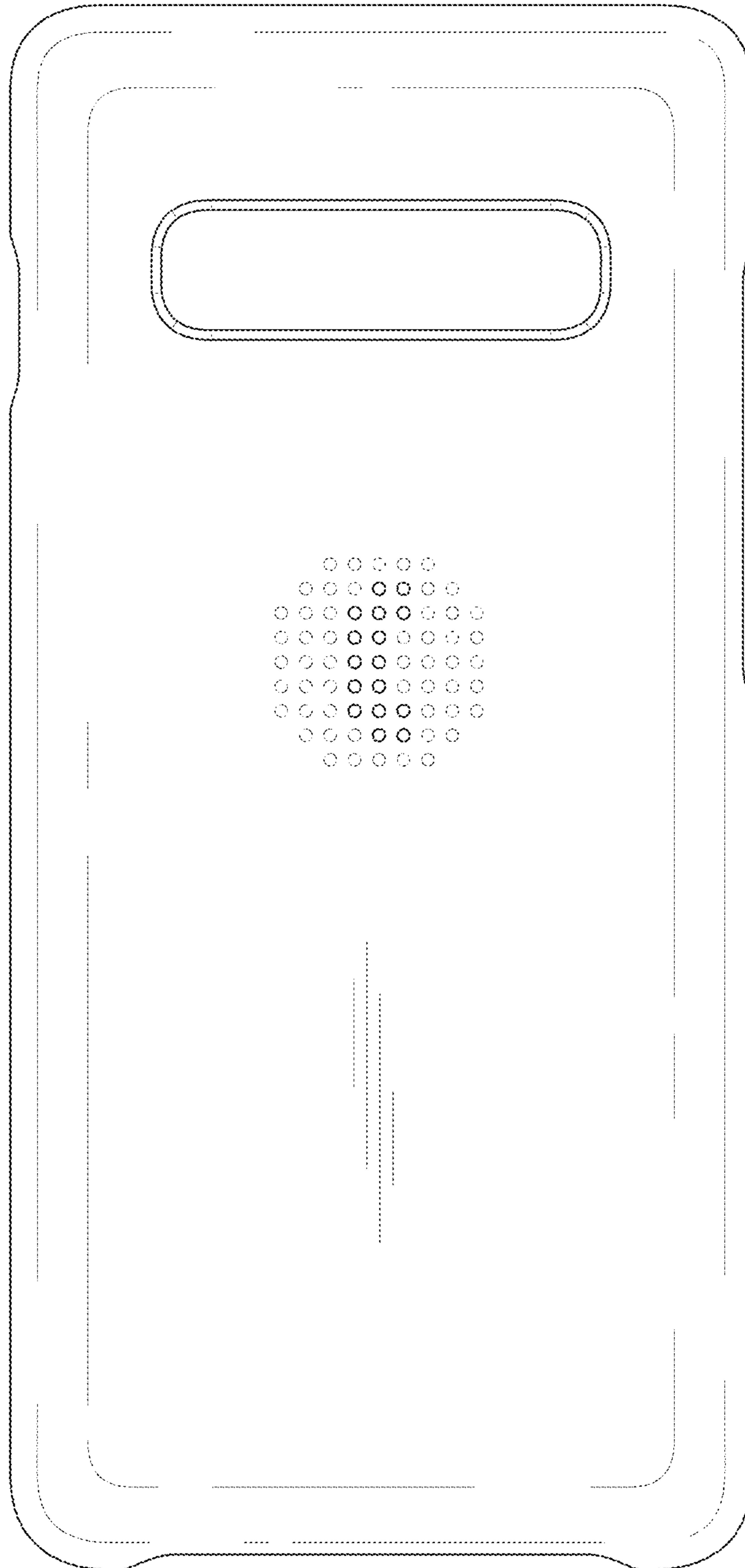

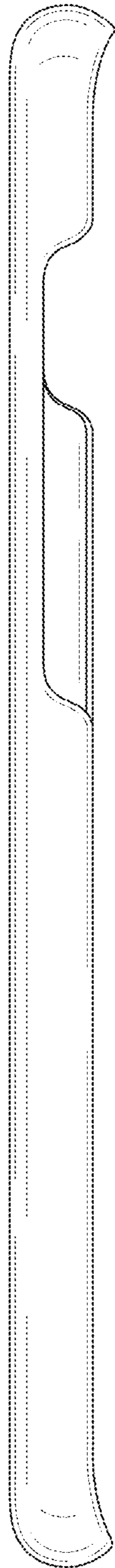

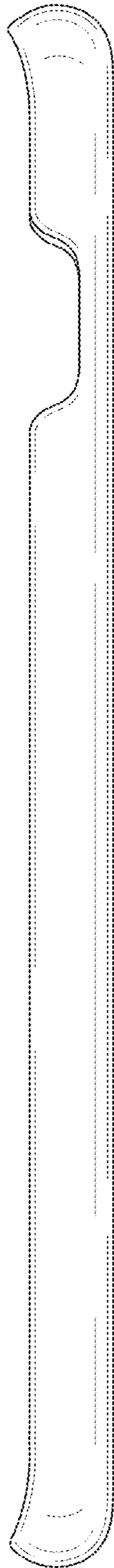

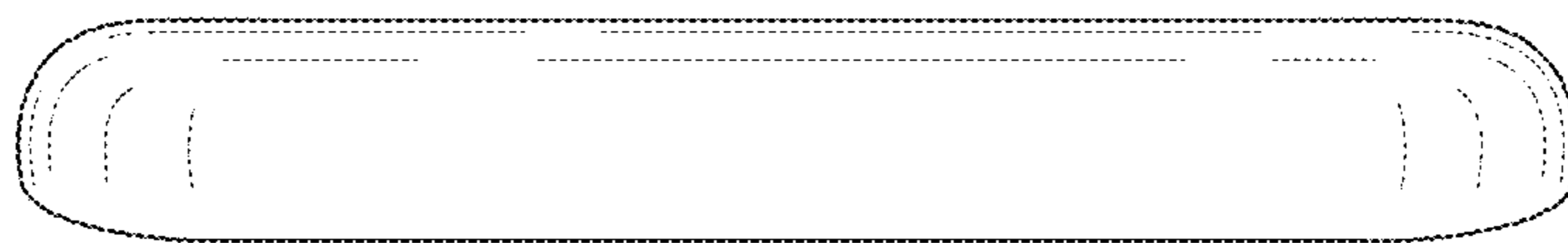

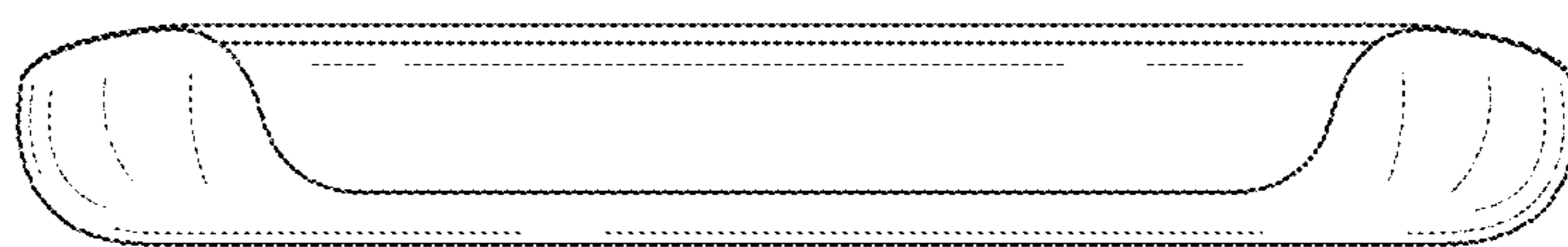

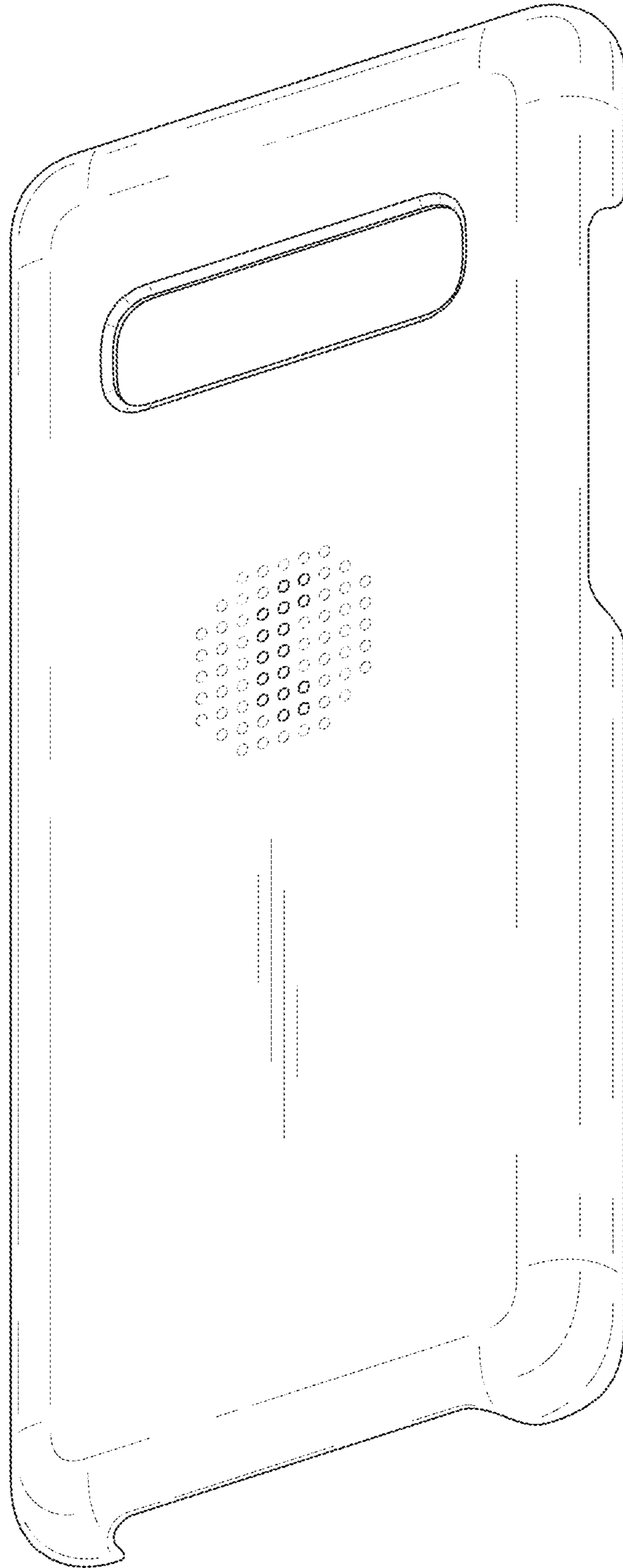

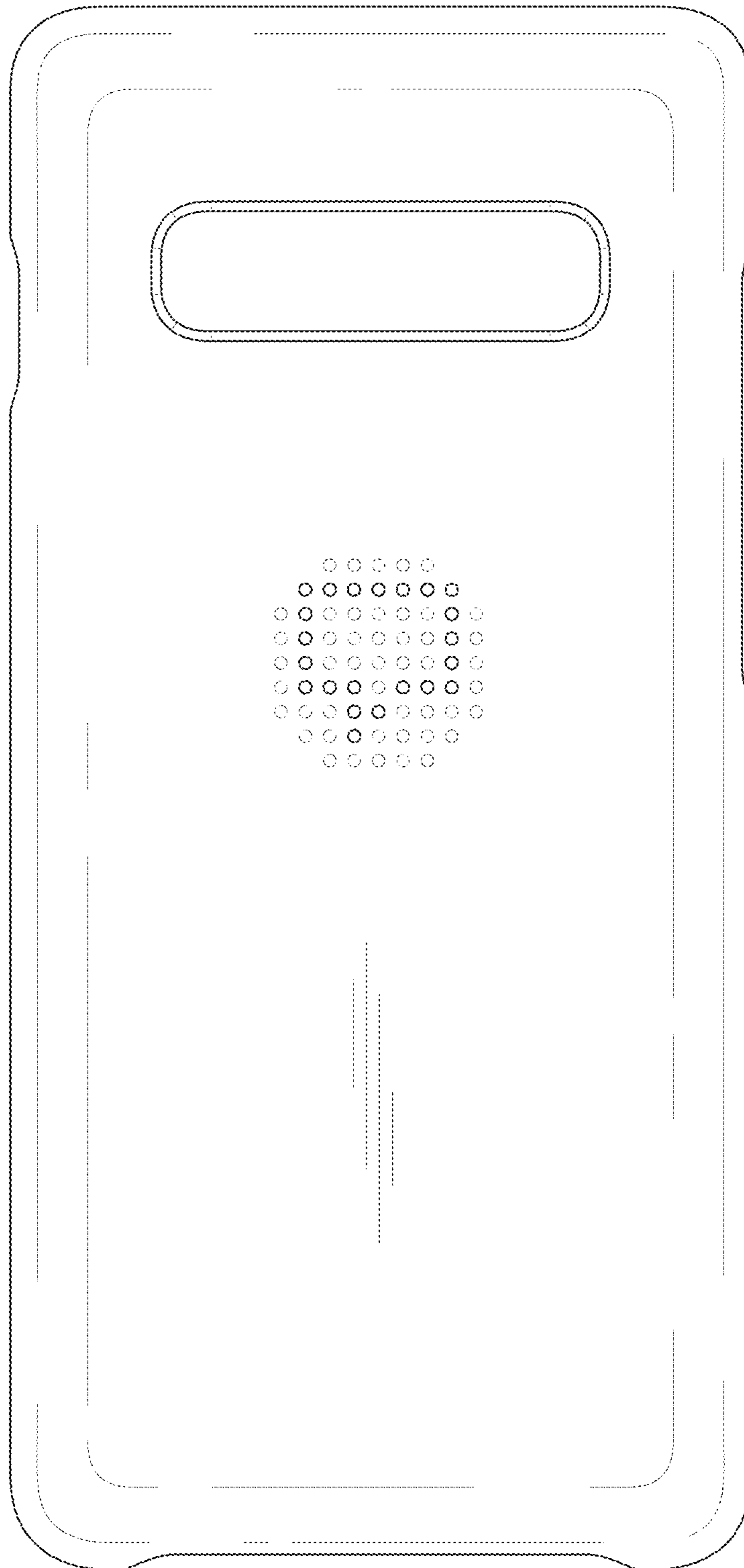

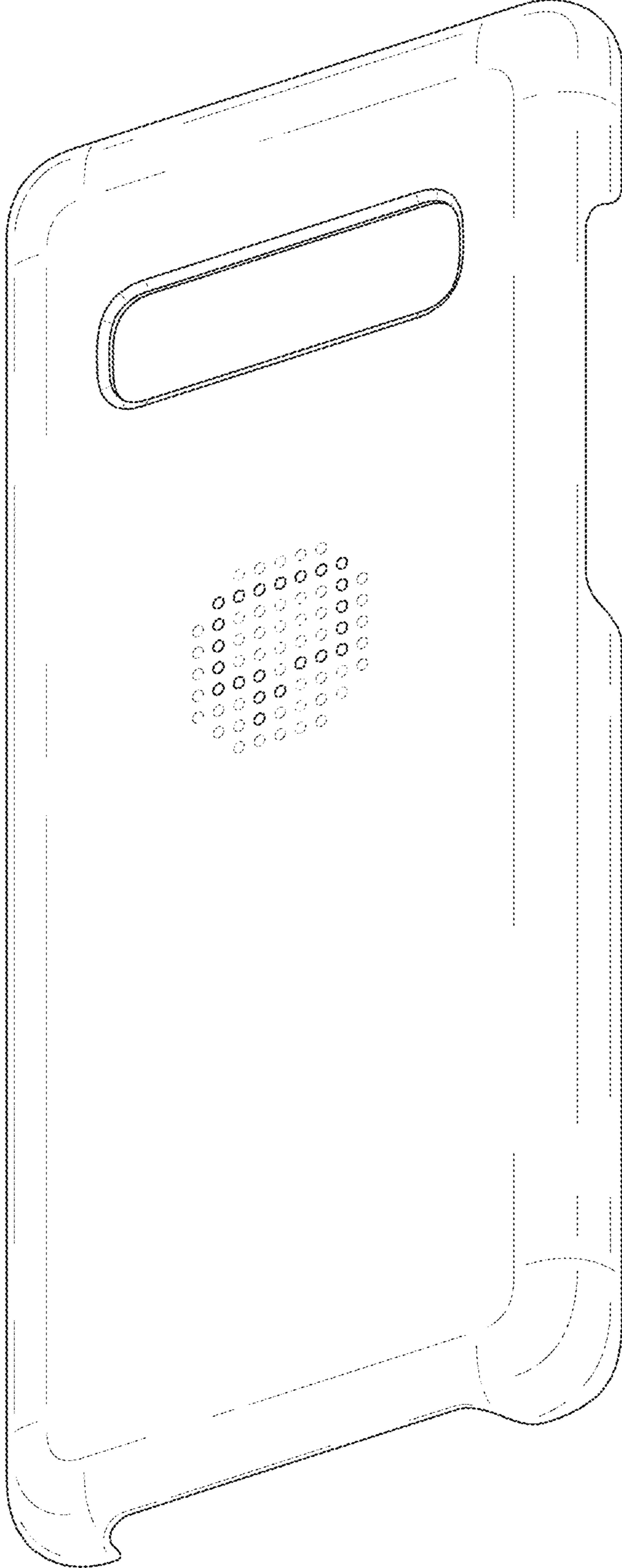

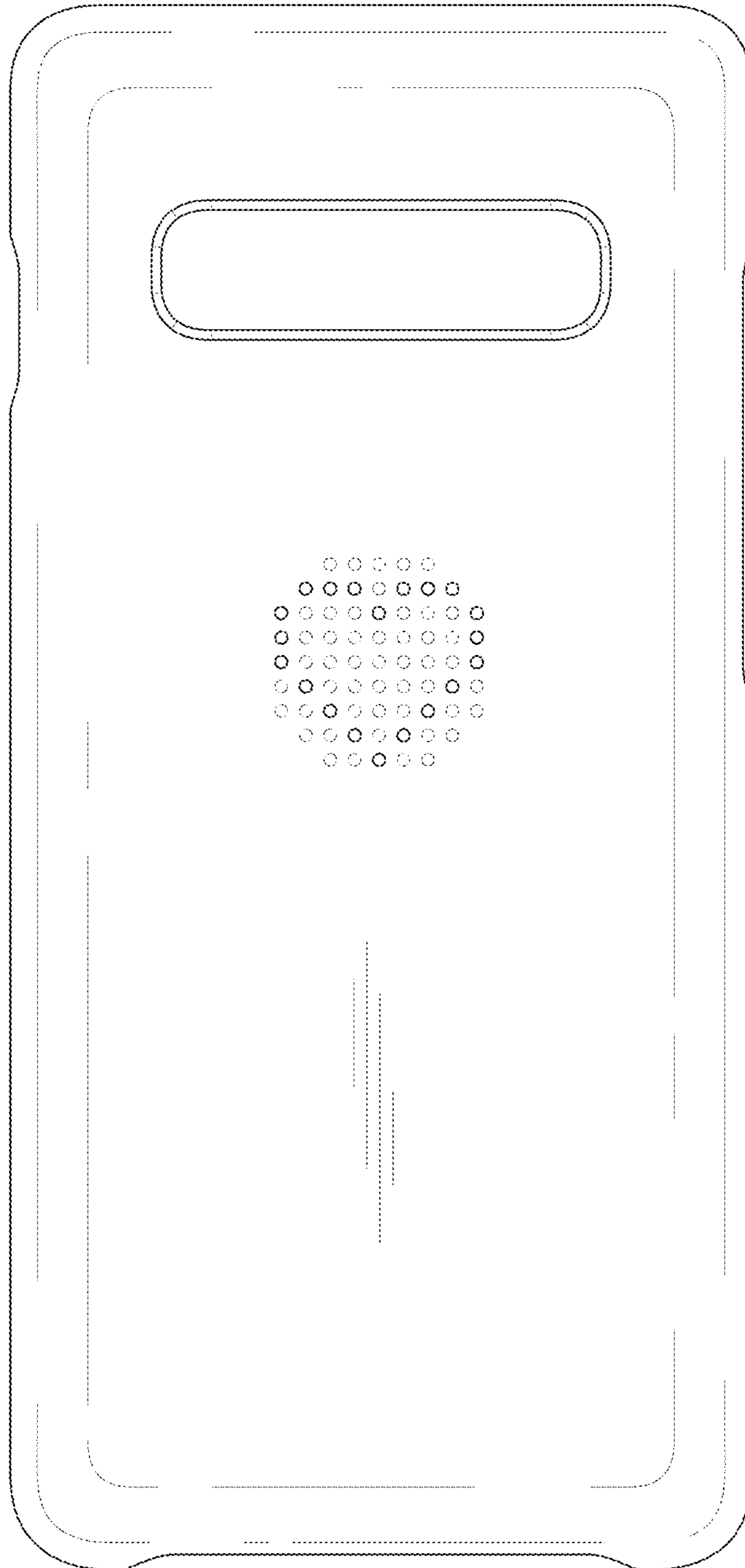

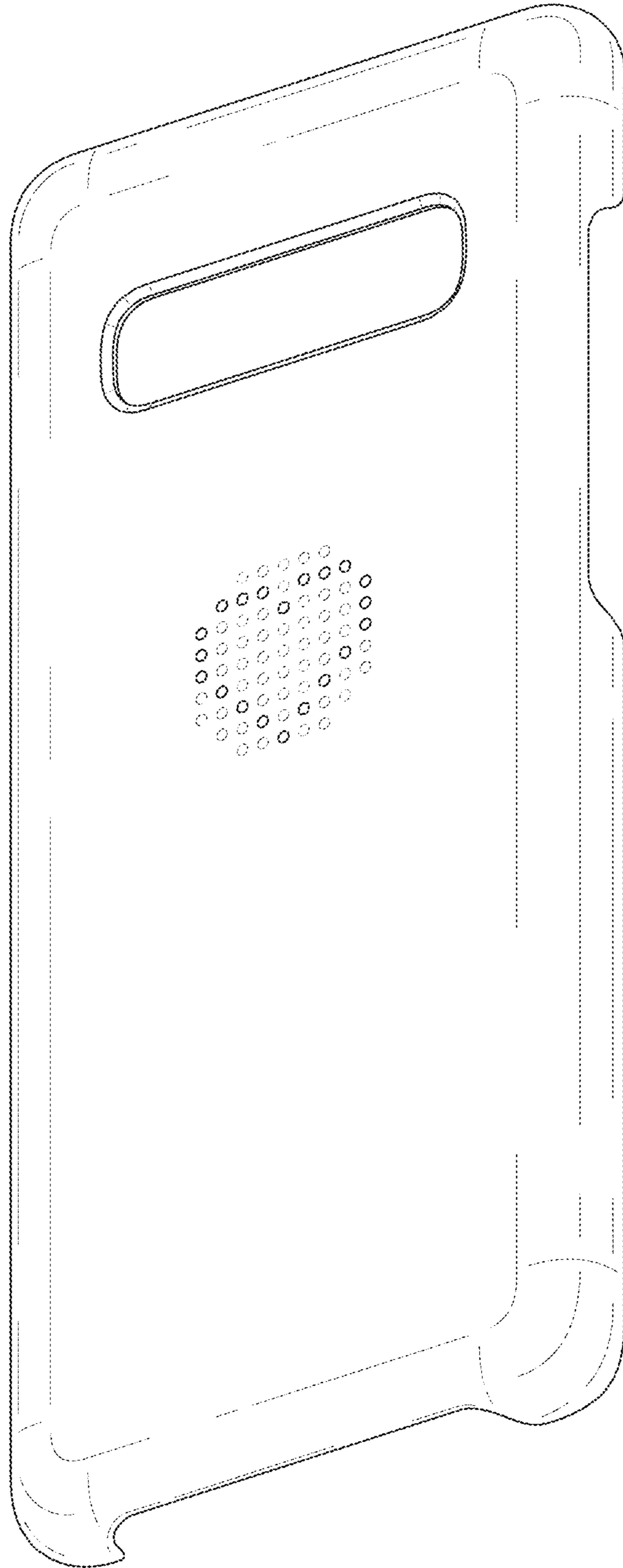

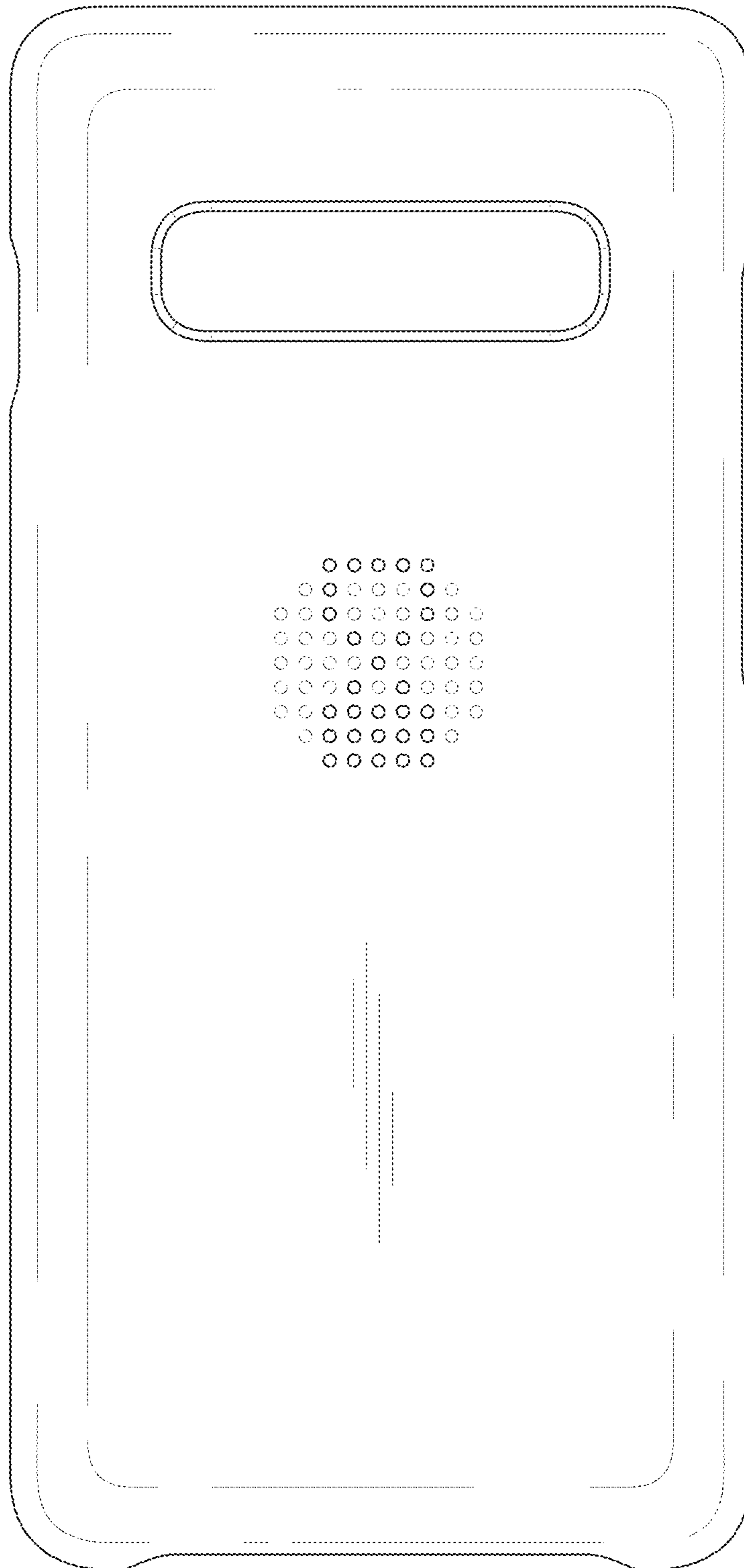

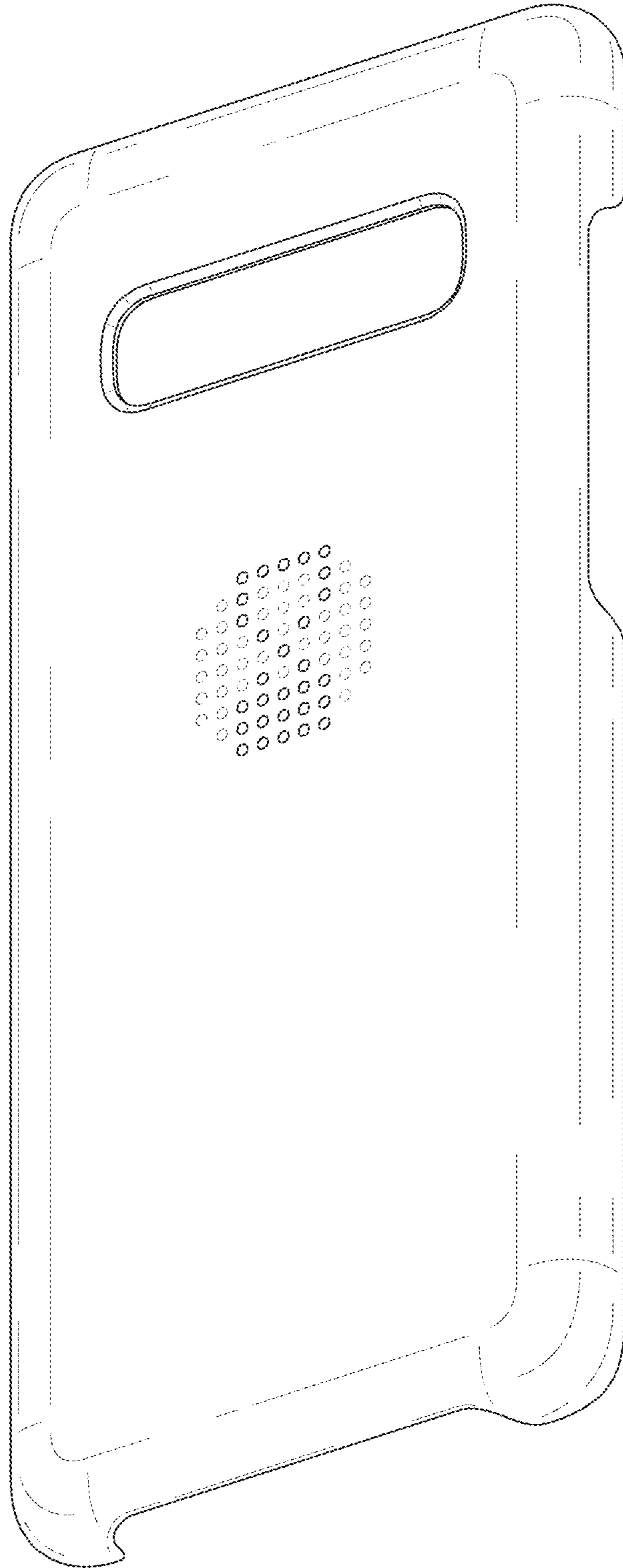

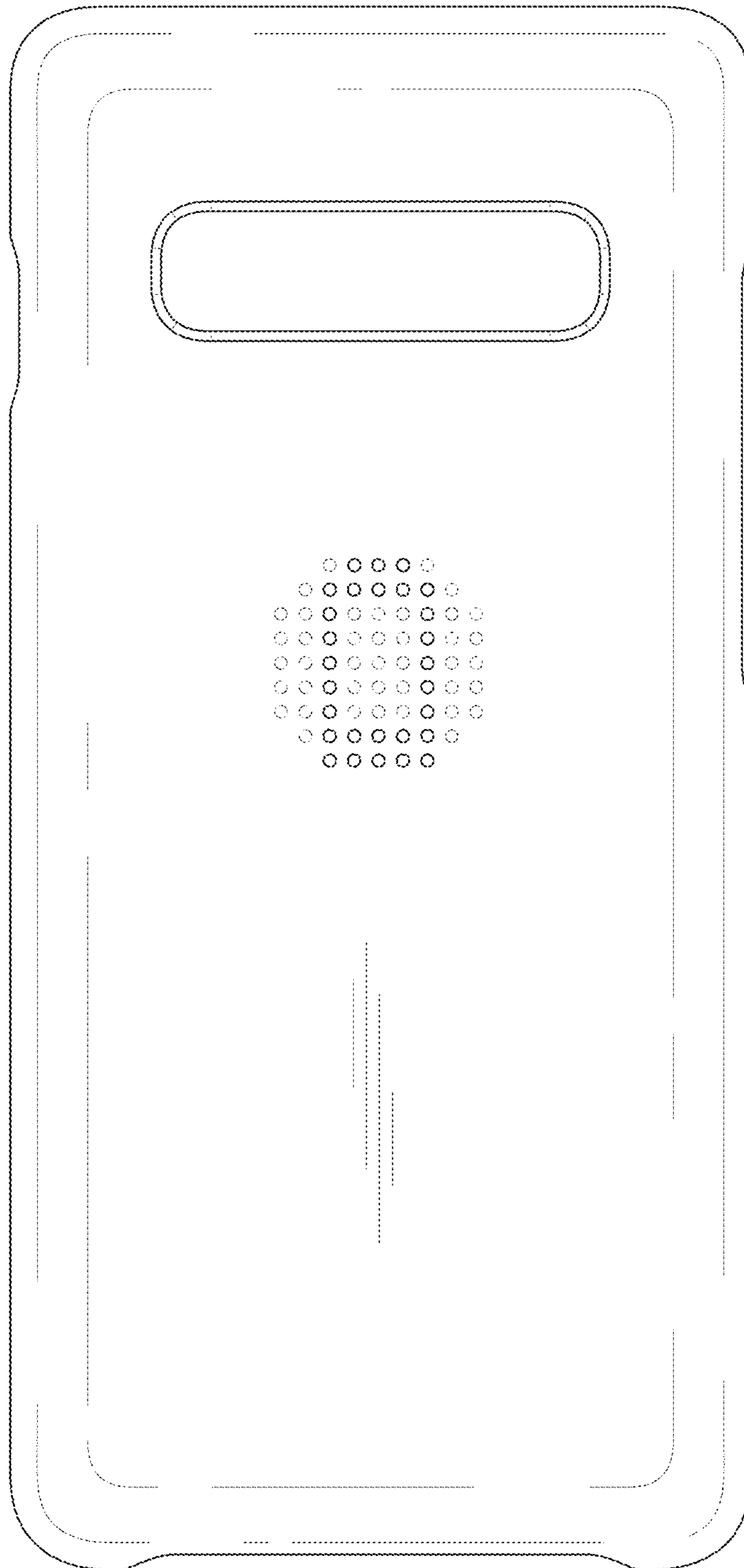

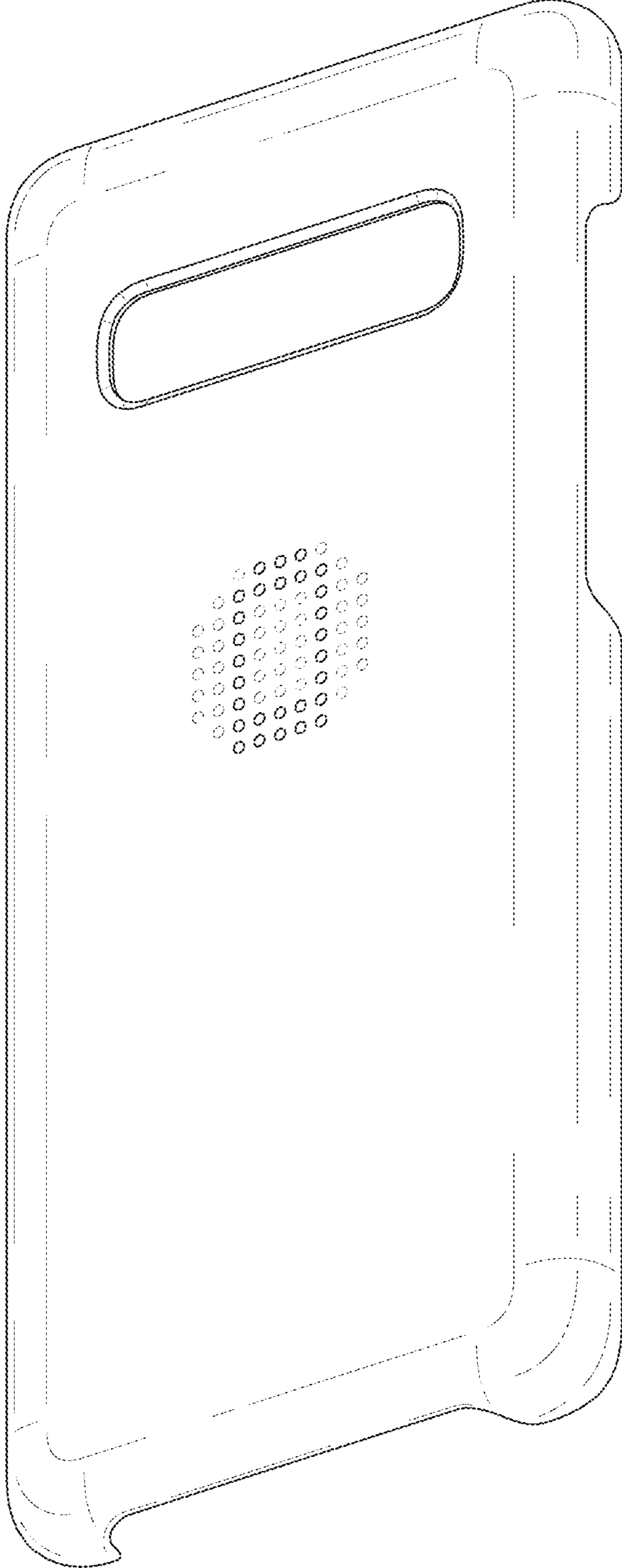

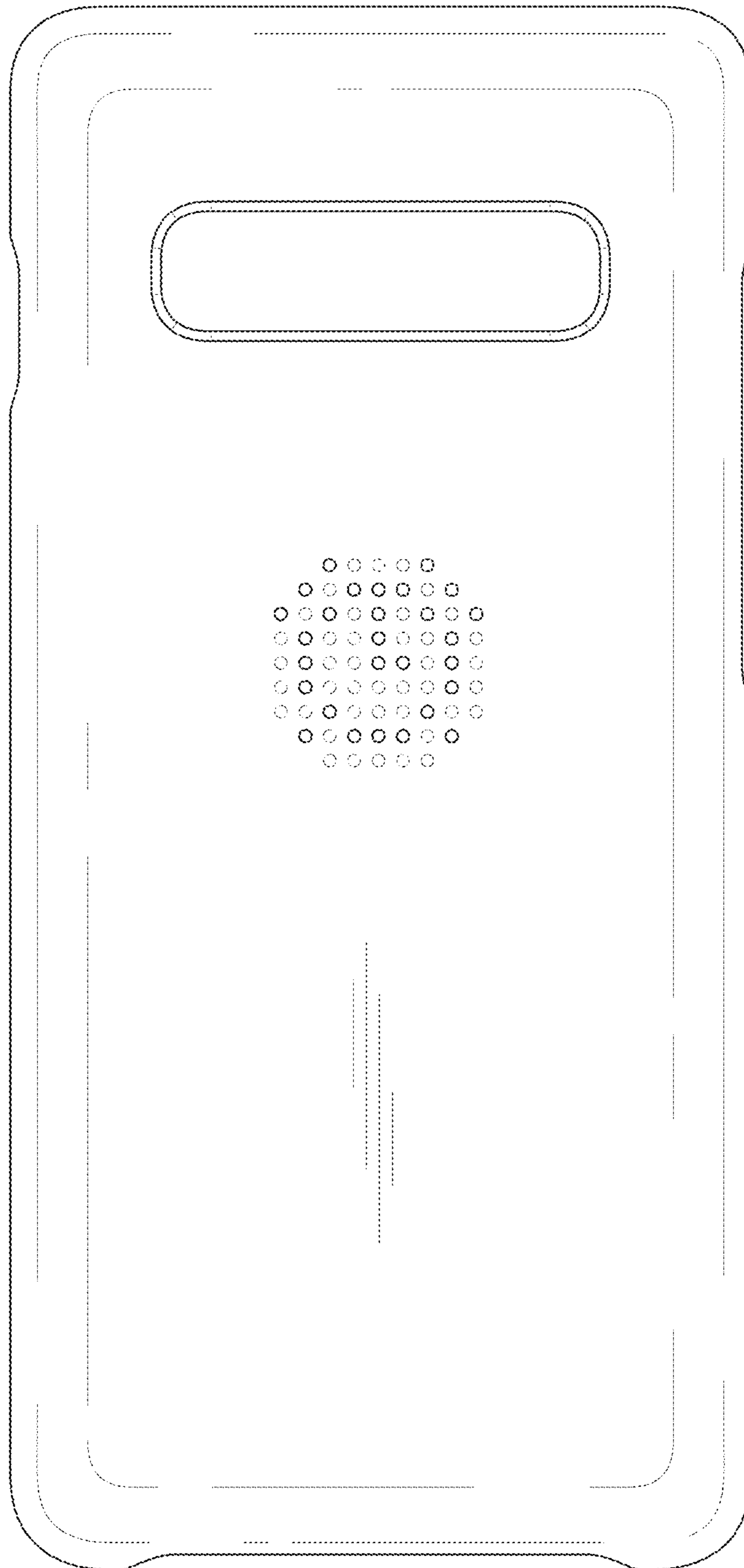

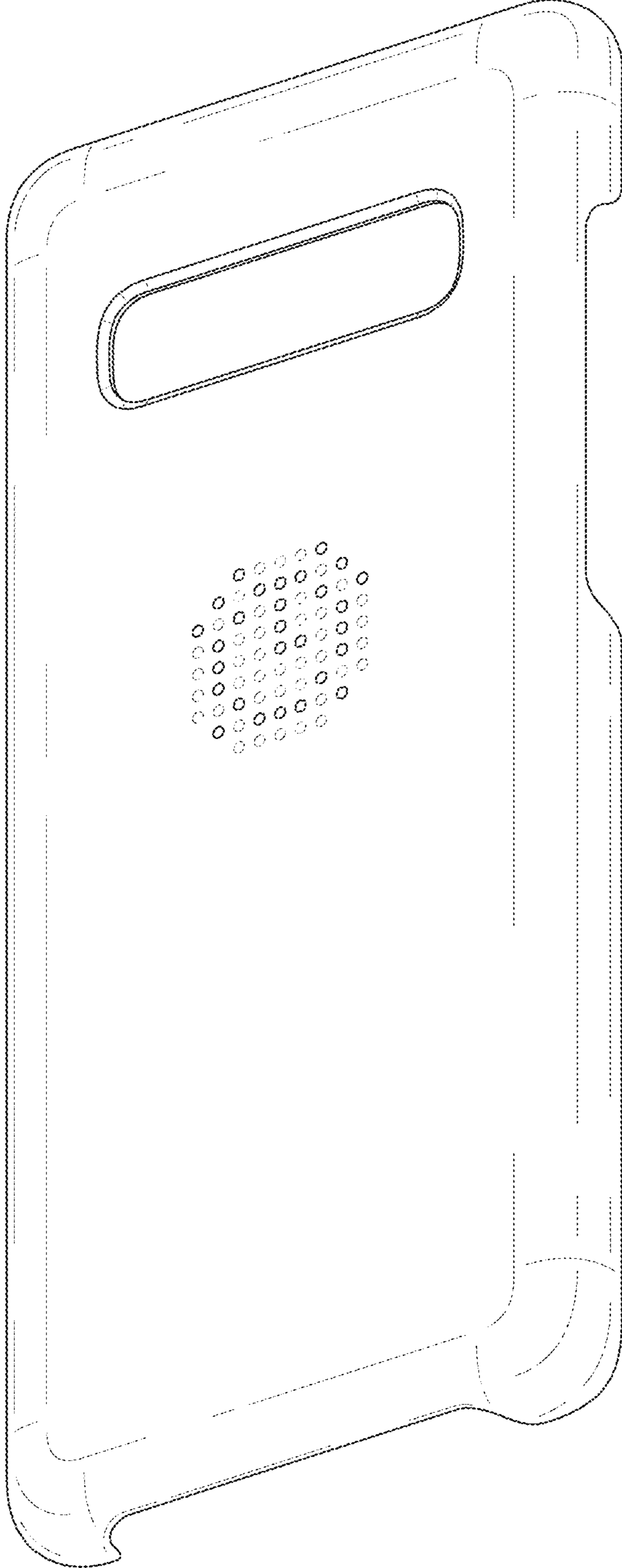

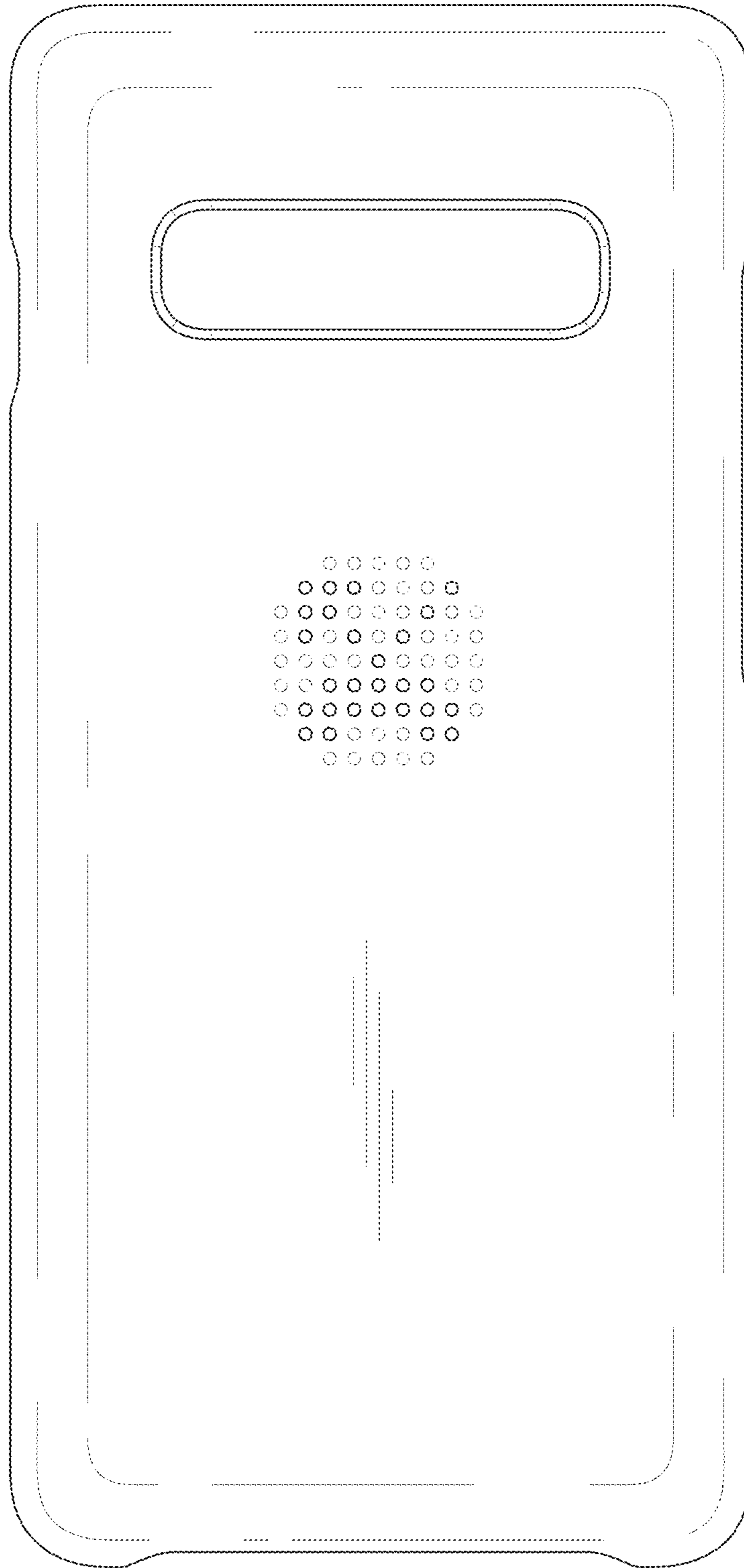

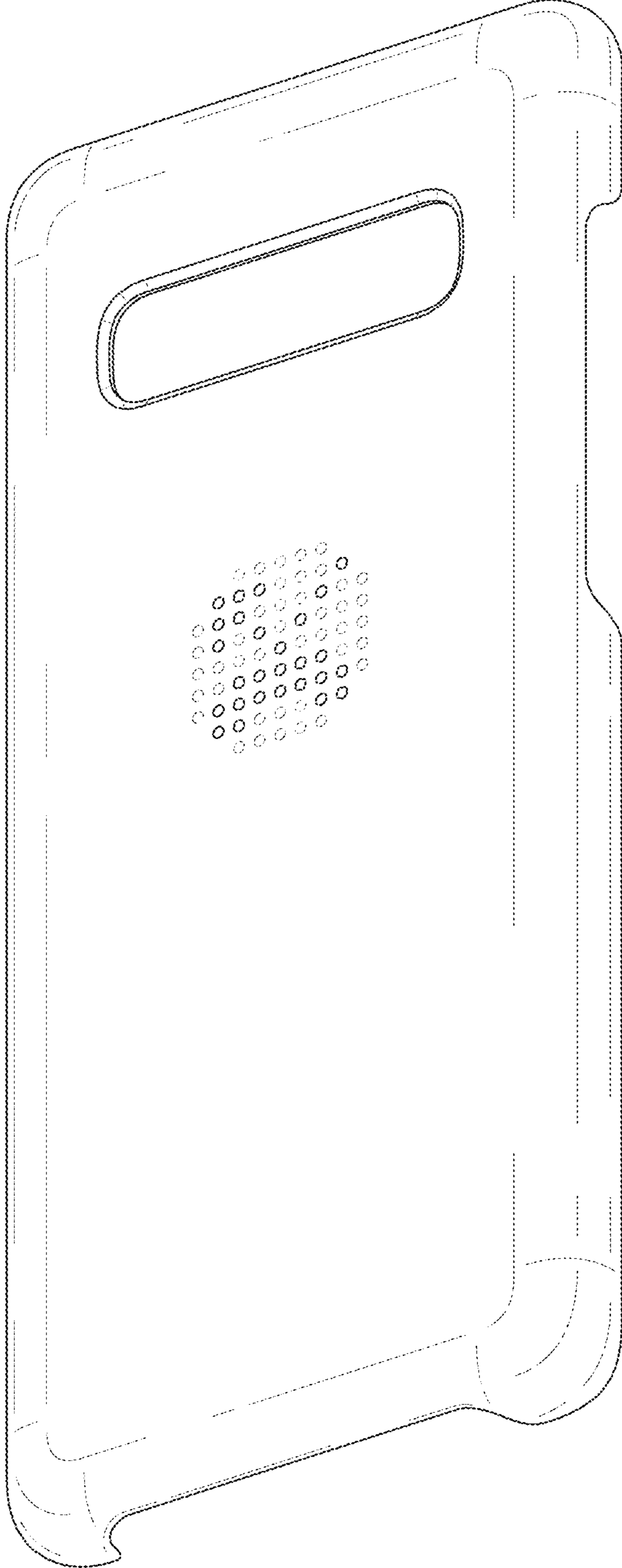

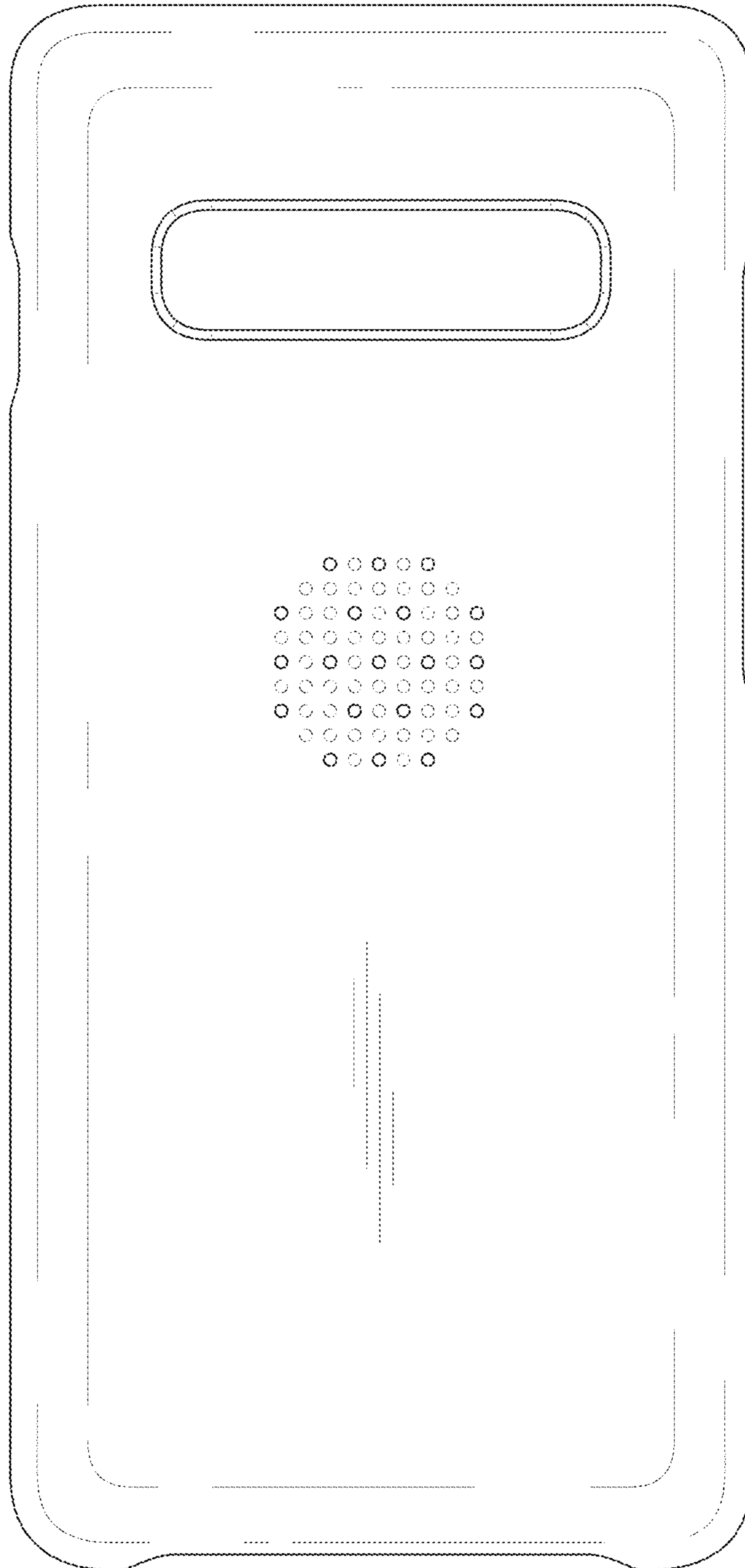
